I claim the ornamental design for cellular phone, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view of cellular phone showing the new design;
- FIG. 2 is a front elevation view thereof;
- FIG. 3 is a rear elevation view thereof;
- FIG. 4 is a left-side elevation view thereof;
- FIG. 5 is a right-side elevation view thereof;
- FIG. 6 is a top plan view thereof; and,
- FIG. 7 is a bottom plan view thereof.

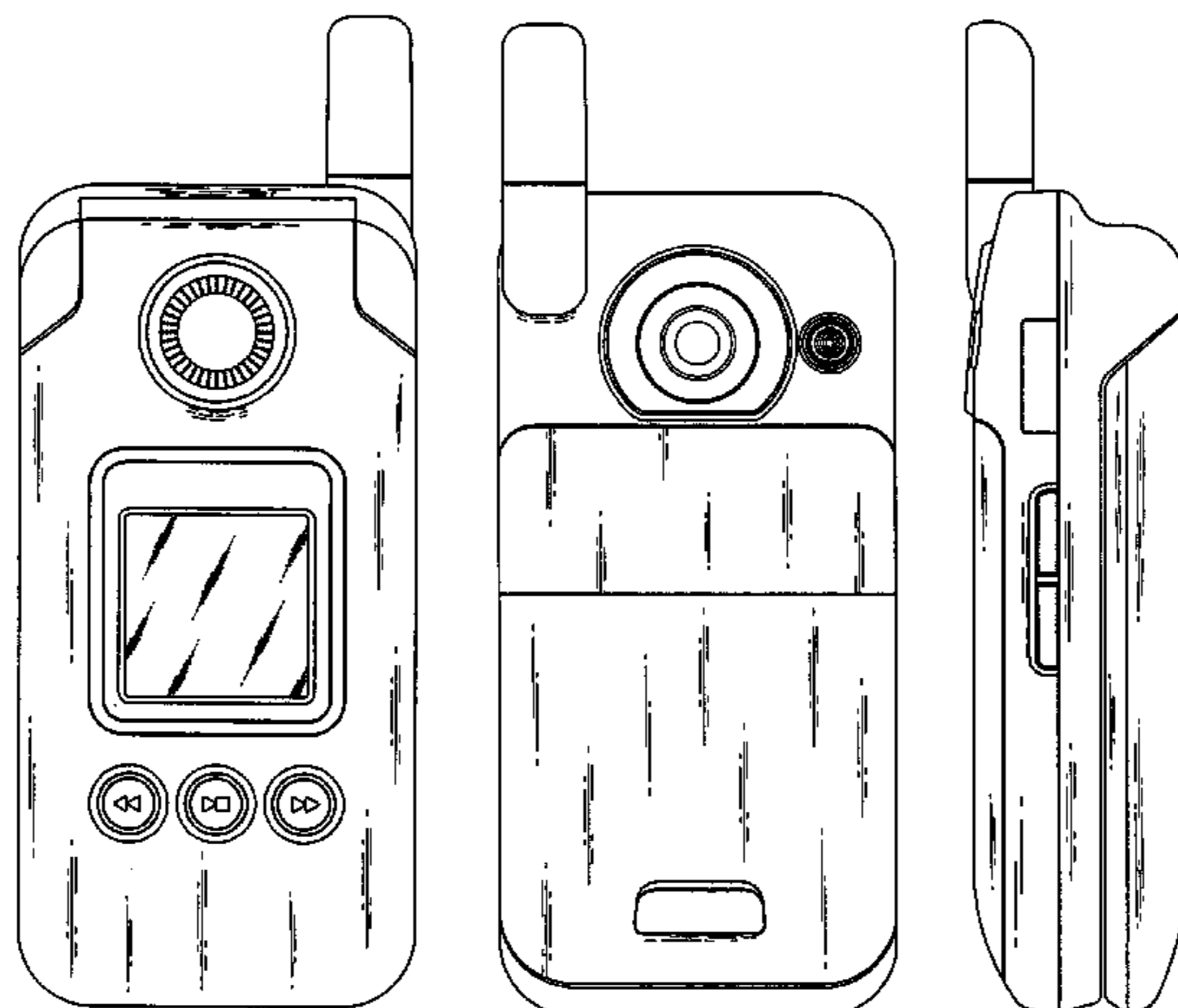

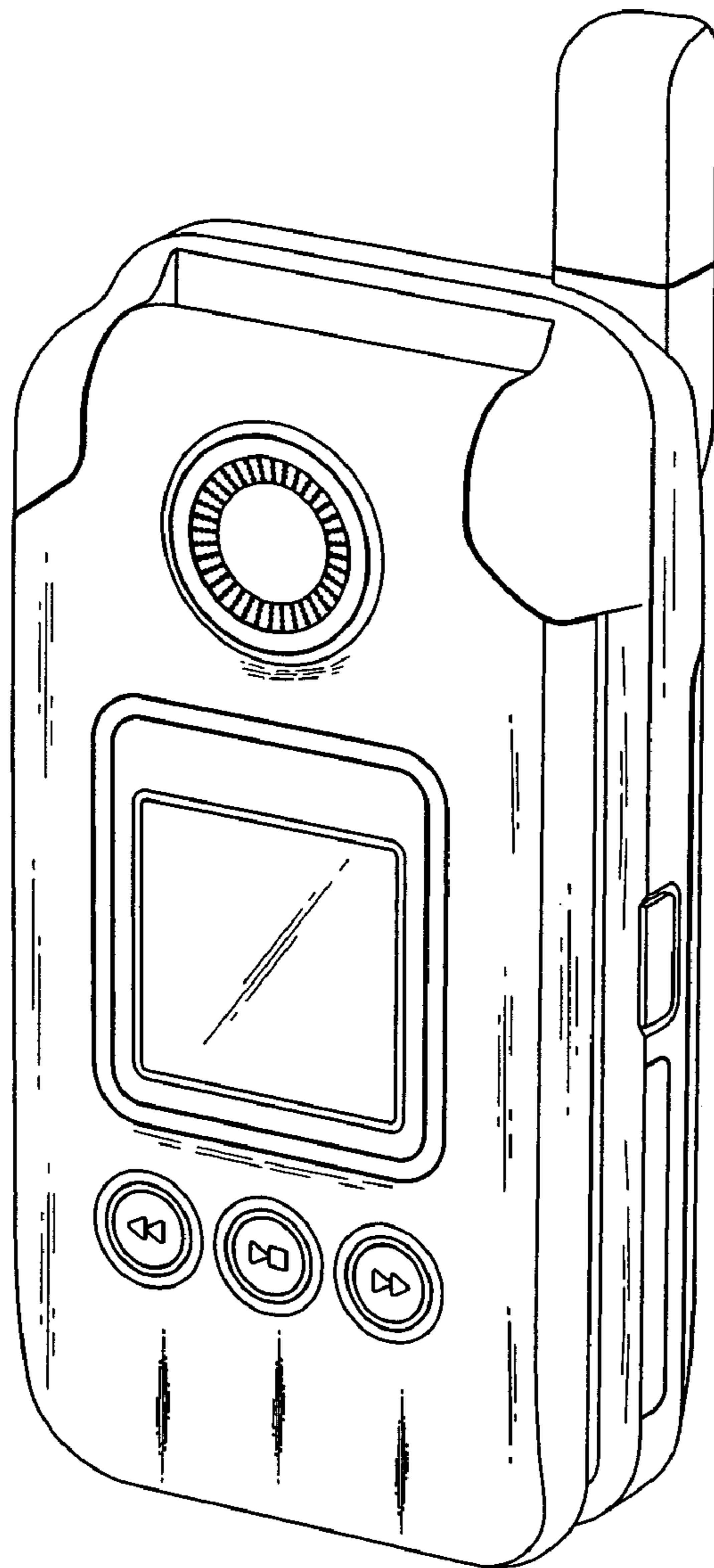

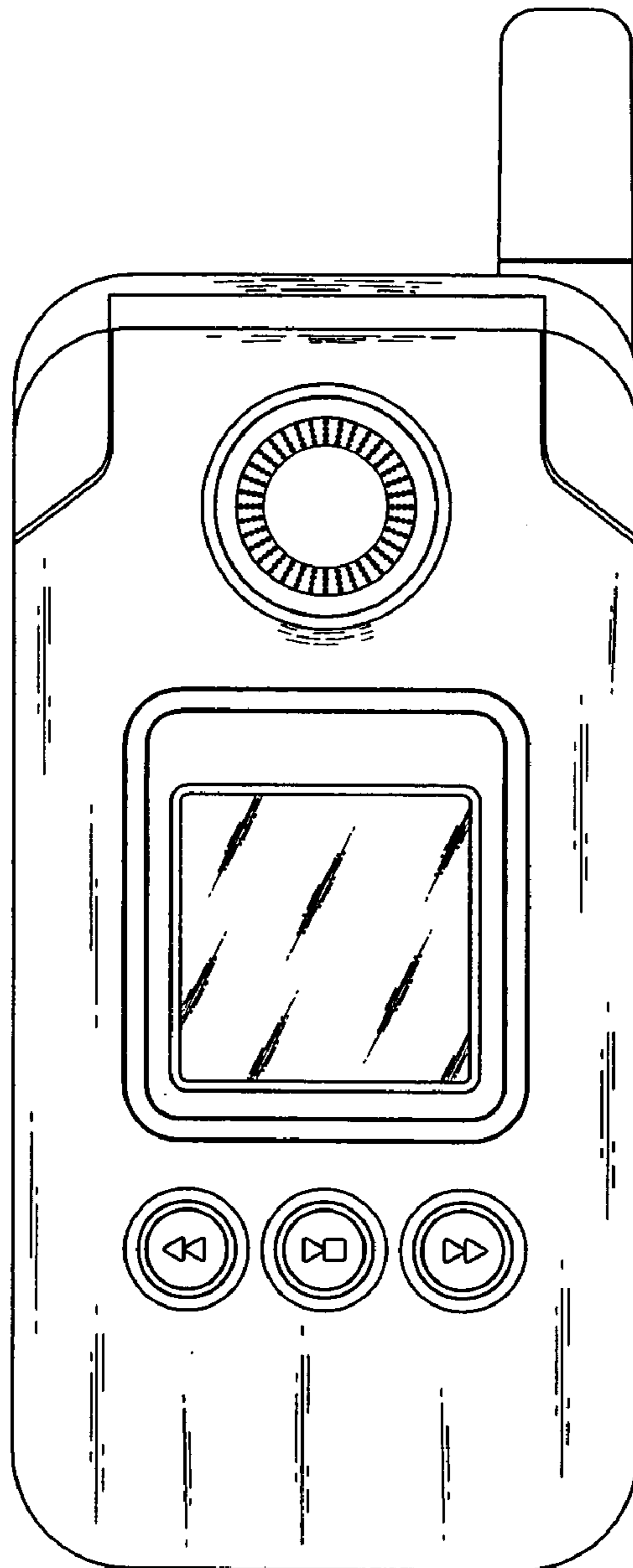

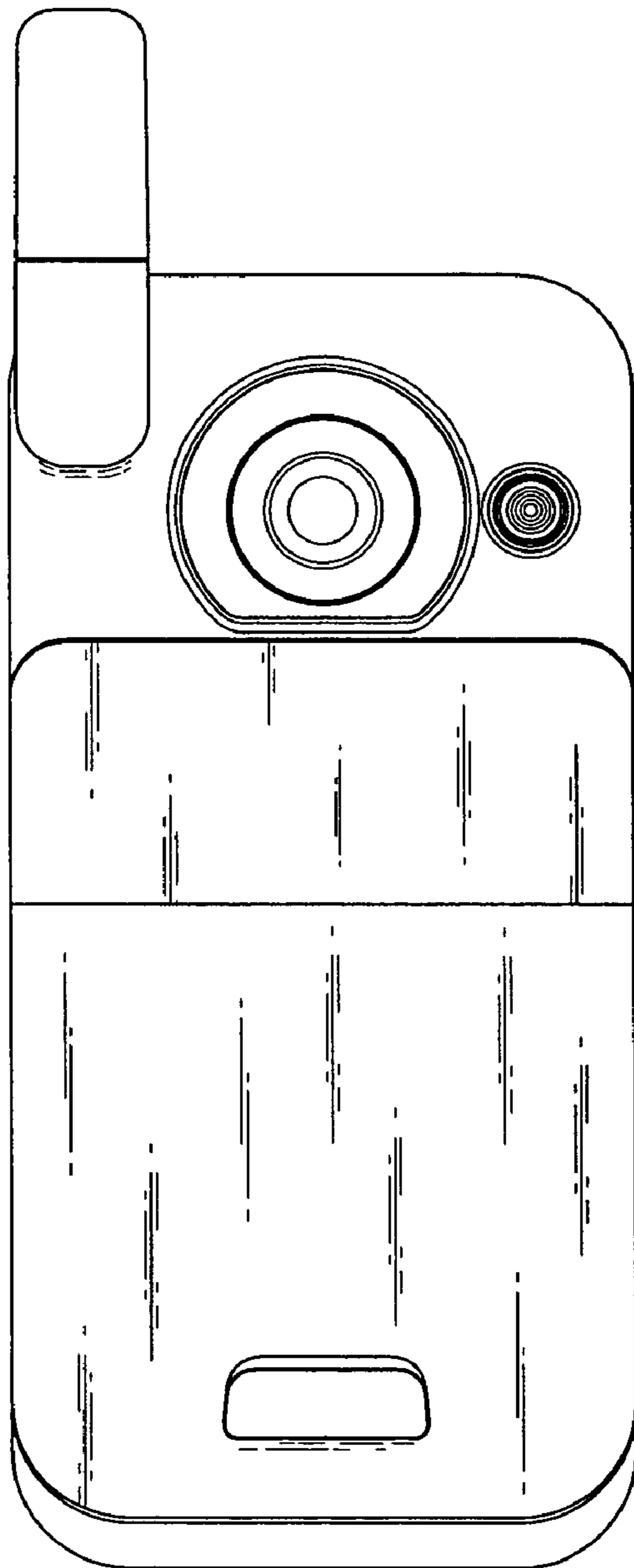

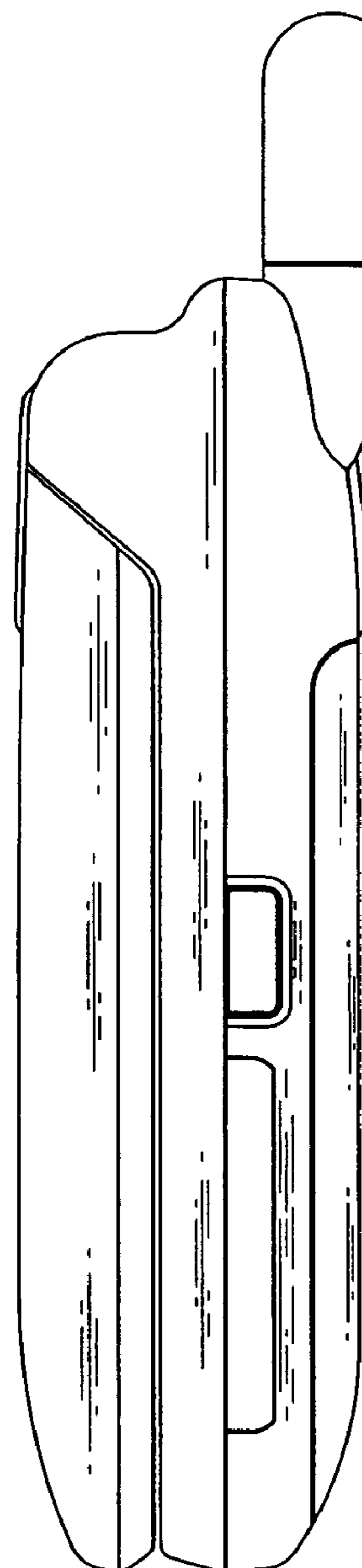
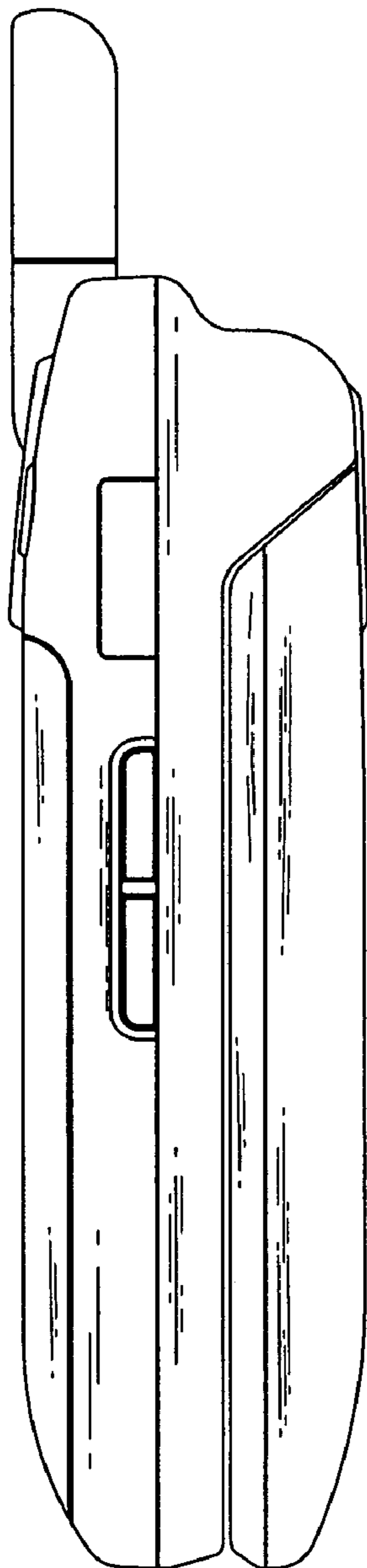

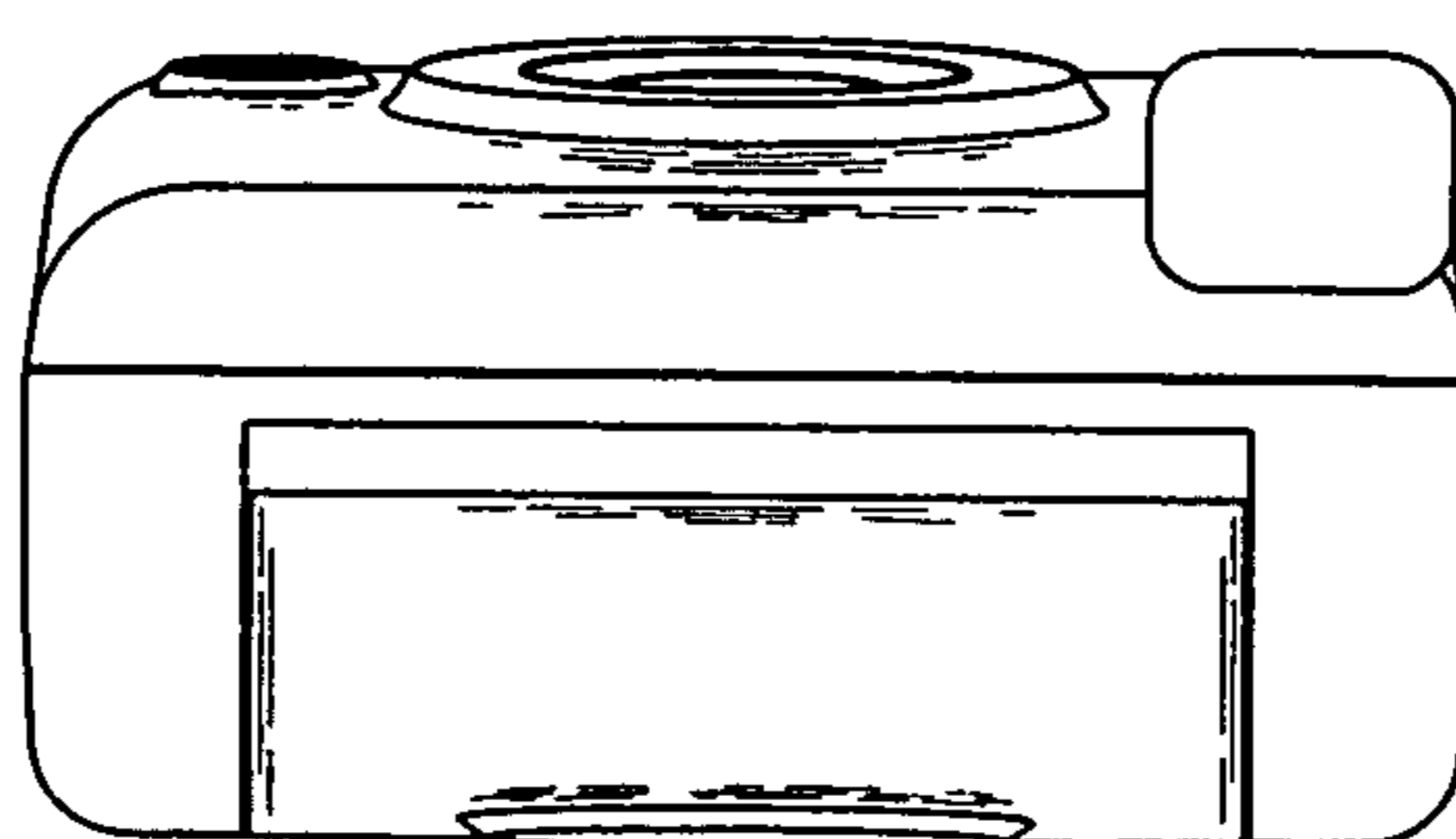
