(57) **CLAIM**

The ornamental design for an ear insert for a wireless headset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ear insert for a wireless headset showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof; a right side elevational view being the same;

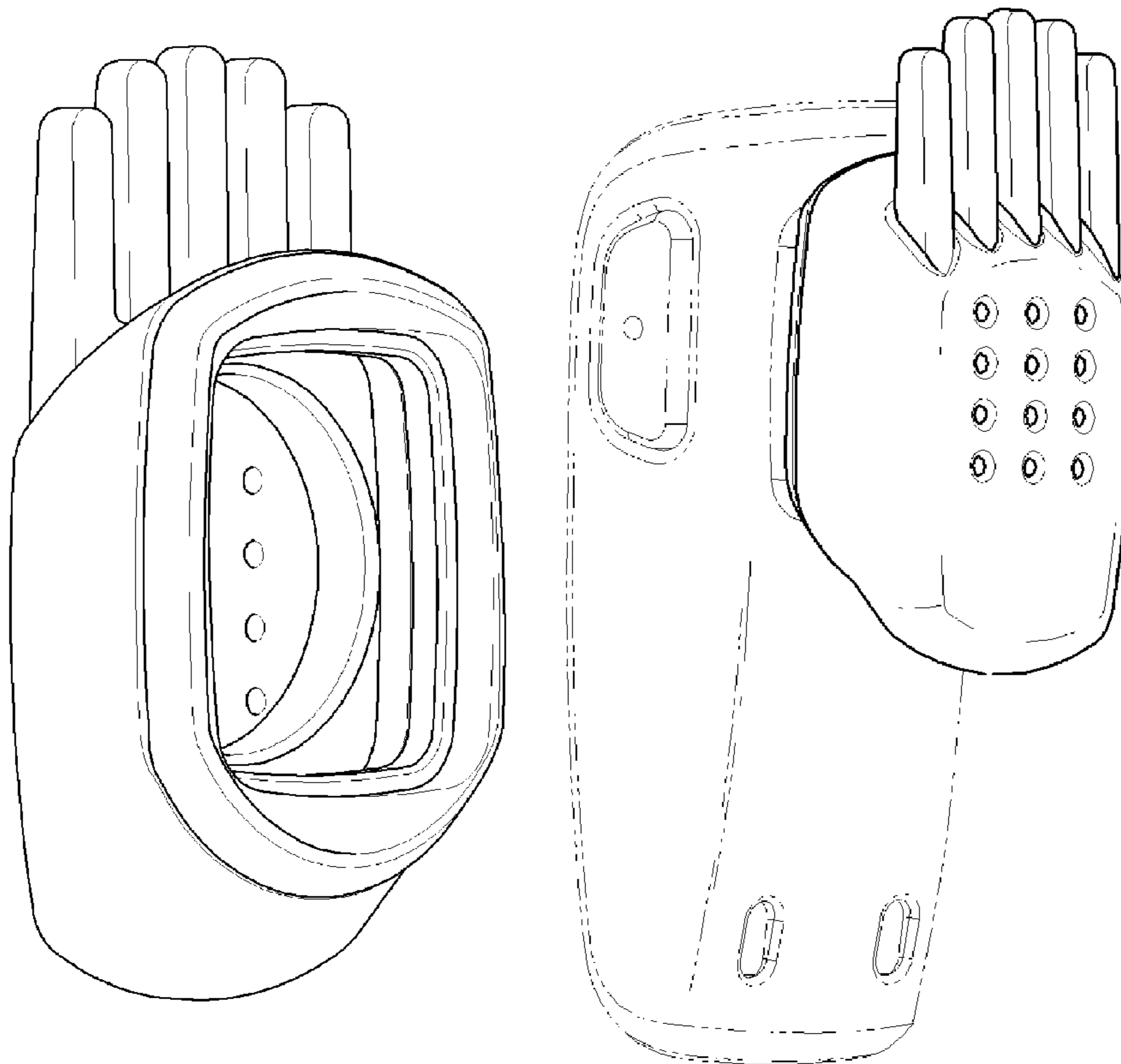
FIG. 5 is a top view thereof.

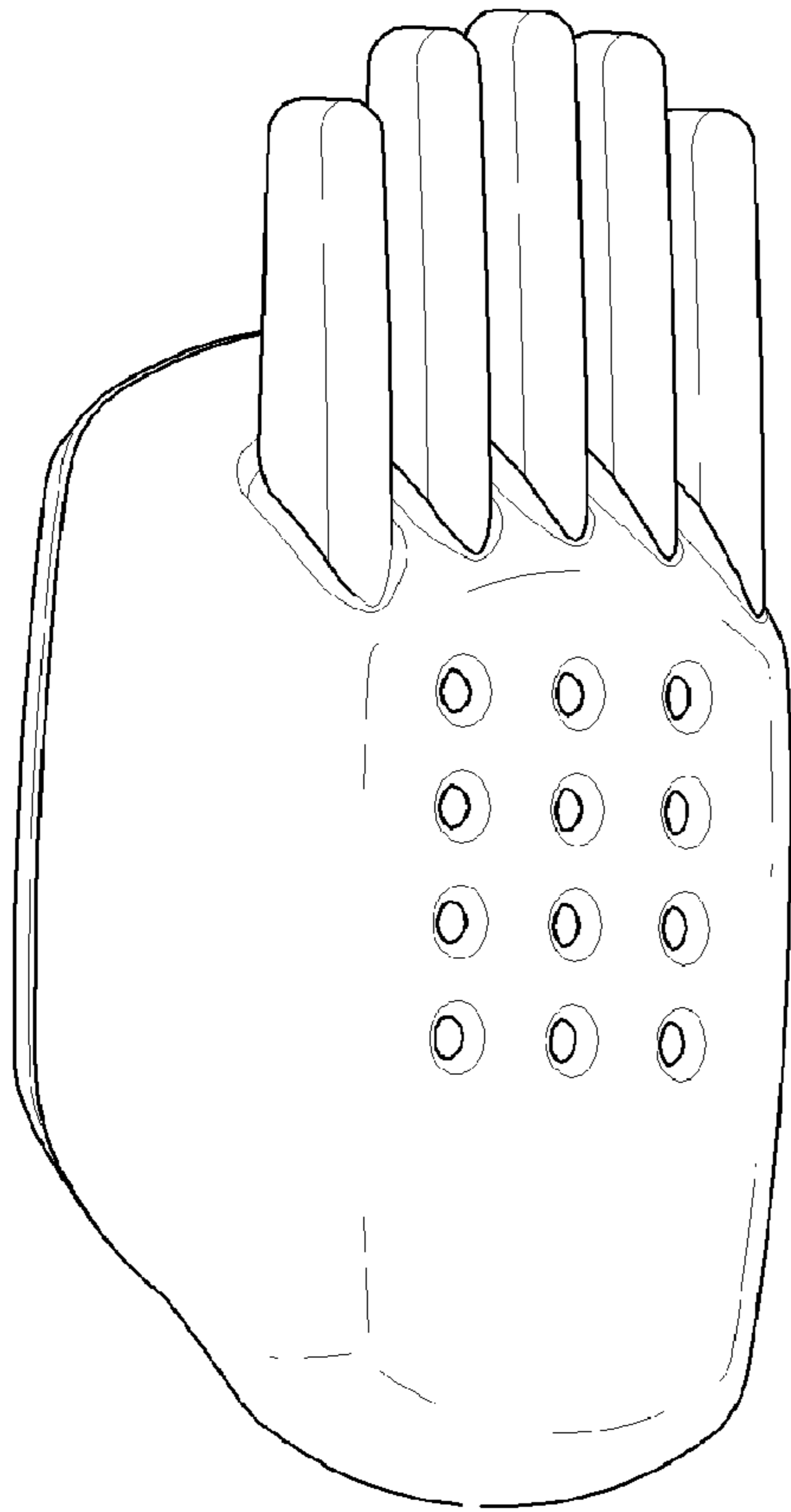

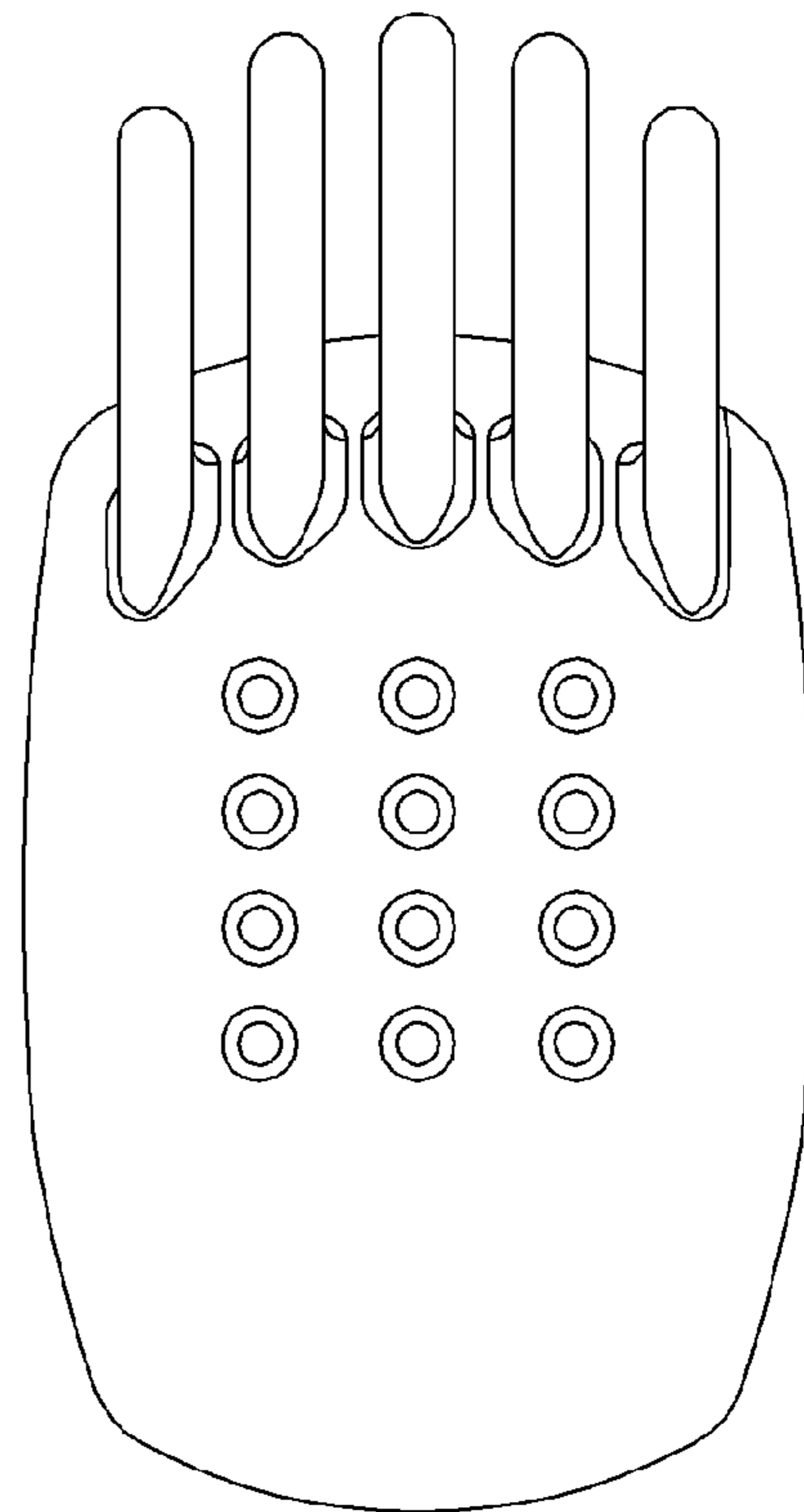

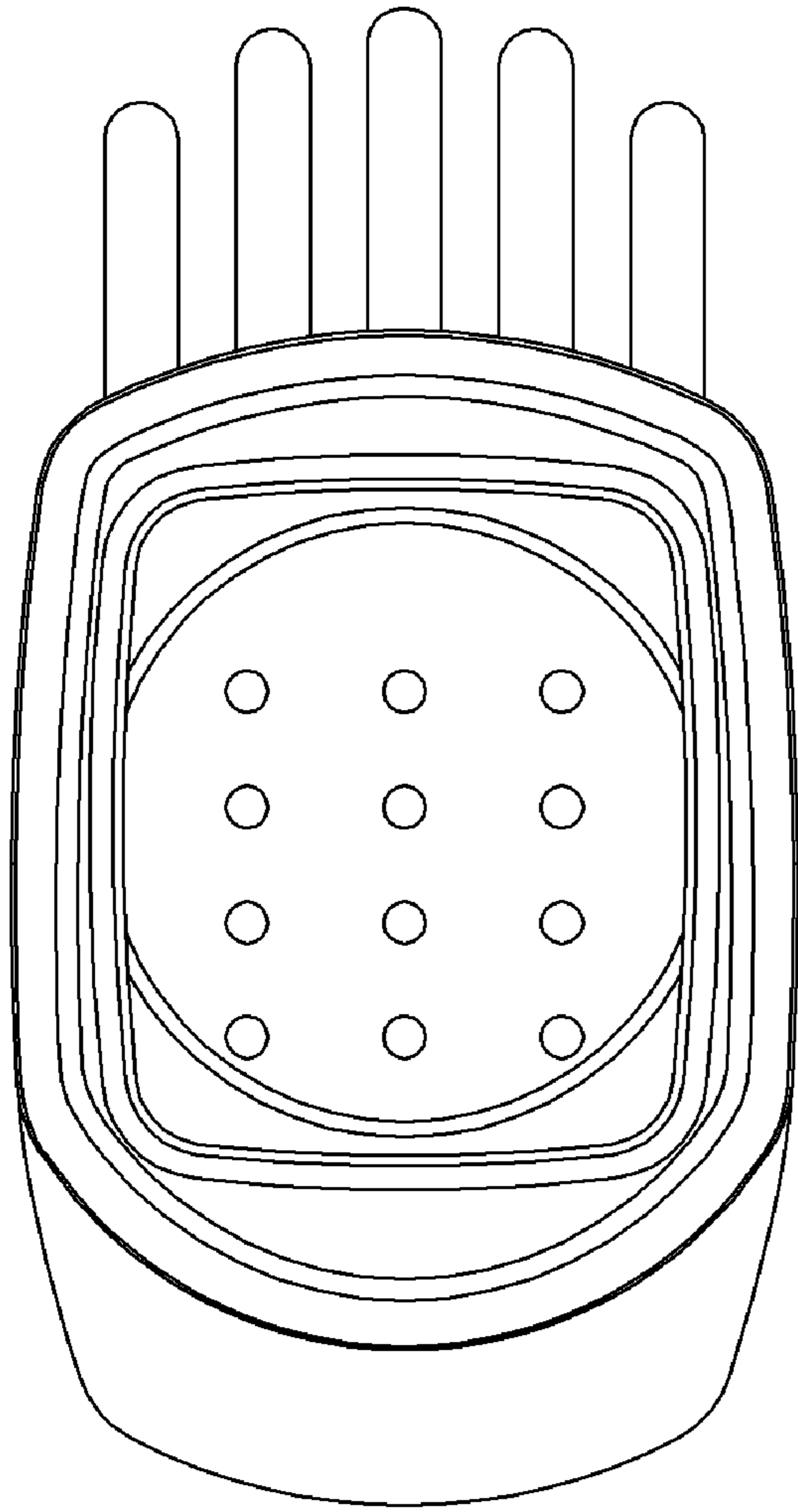

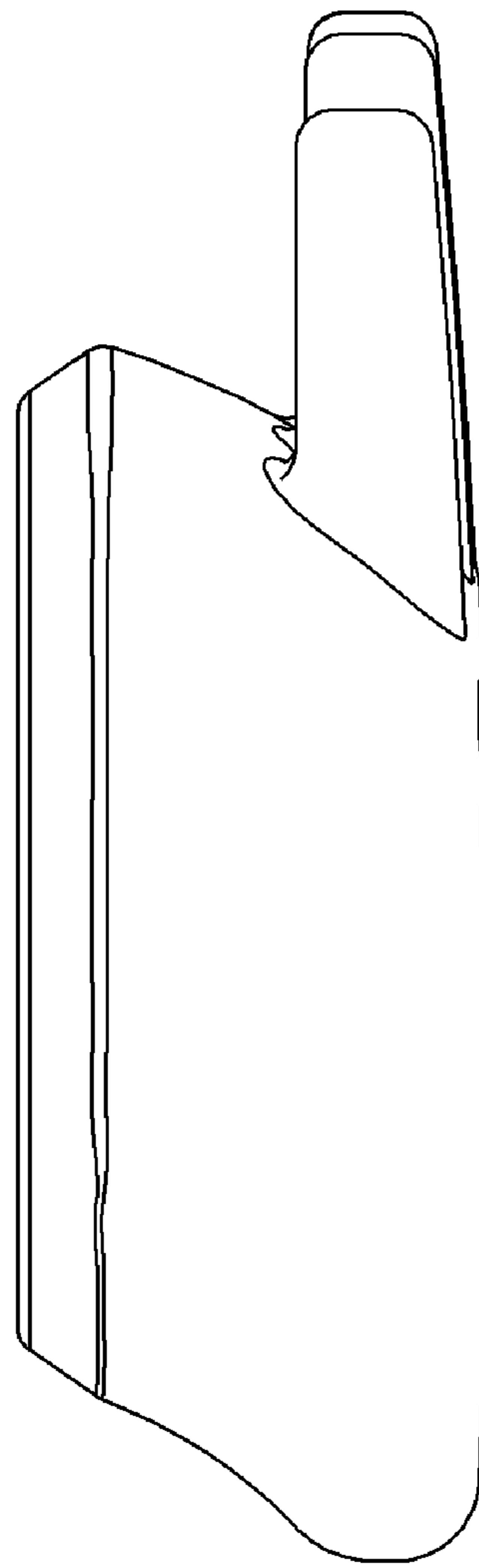

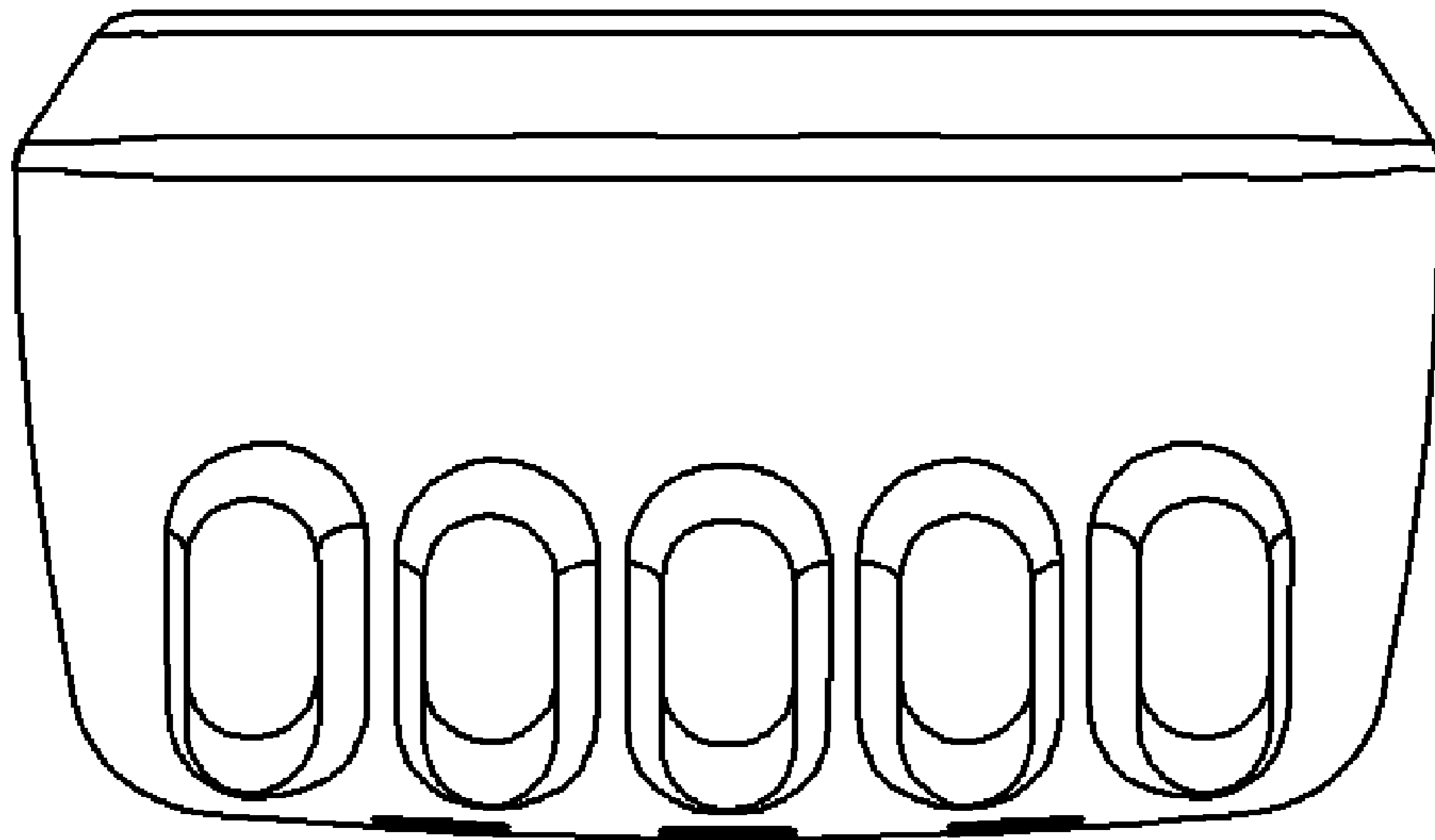

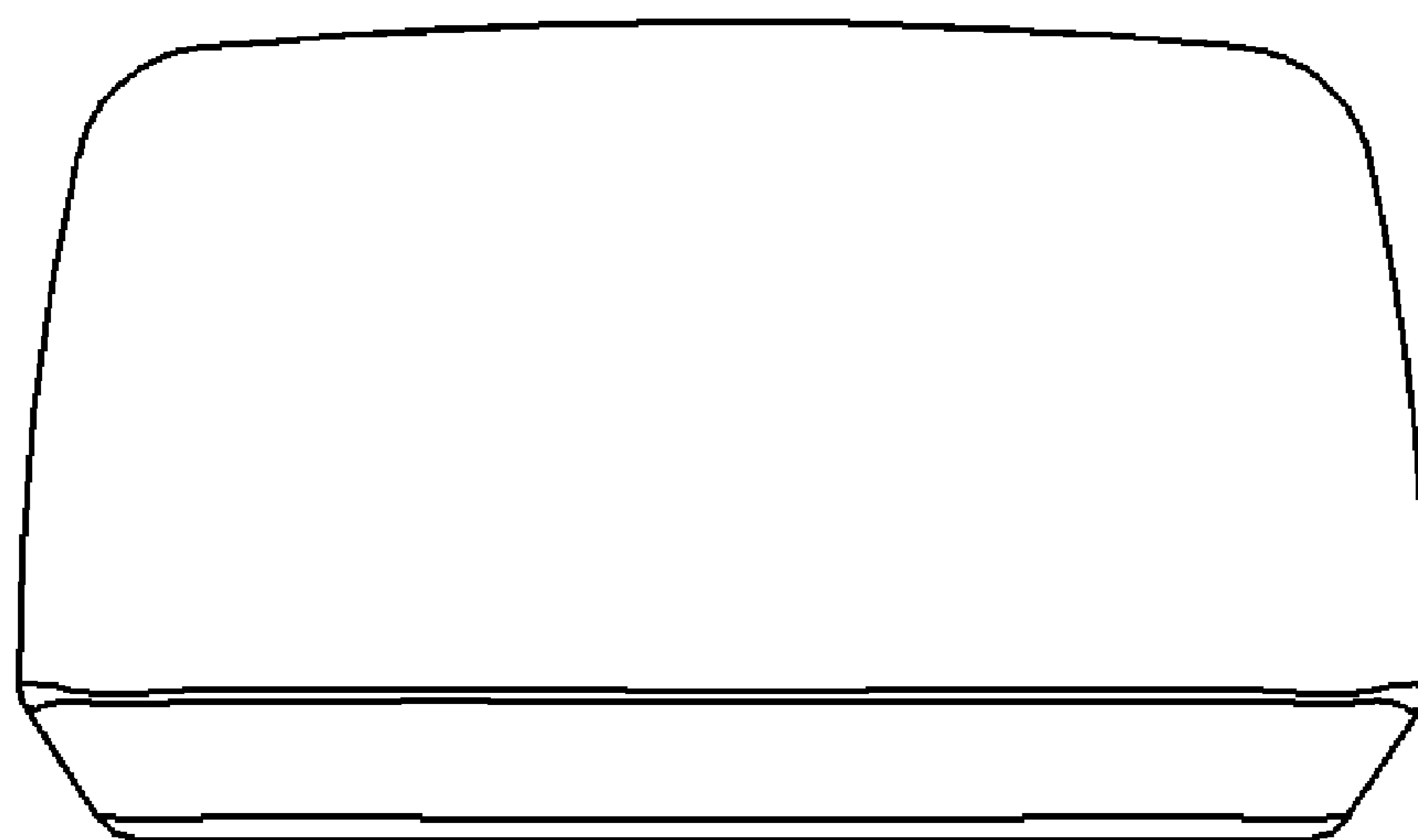

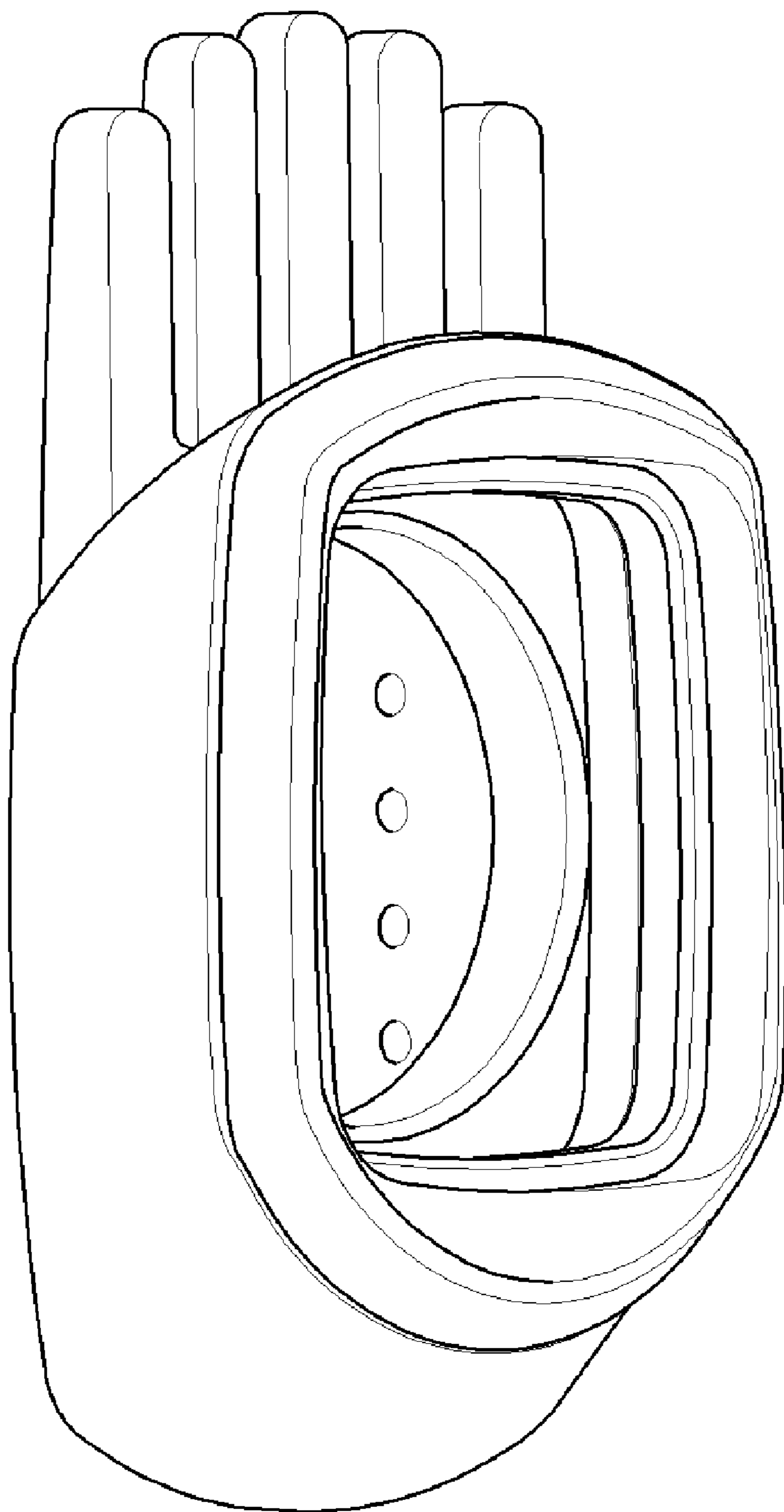

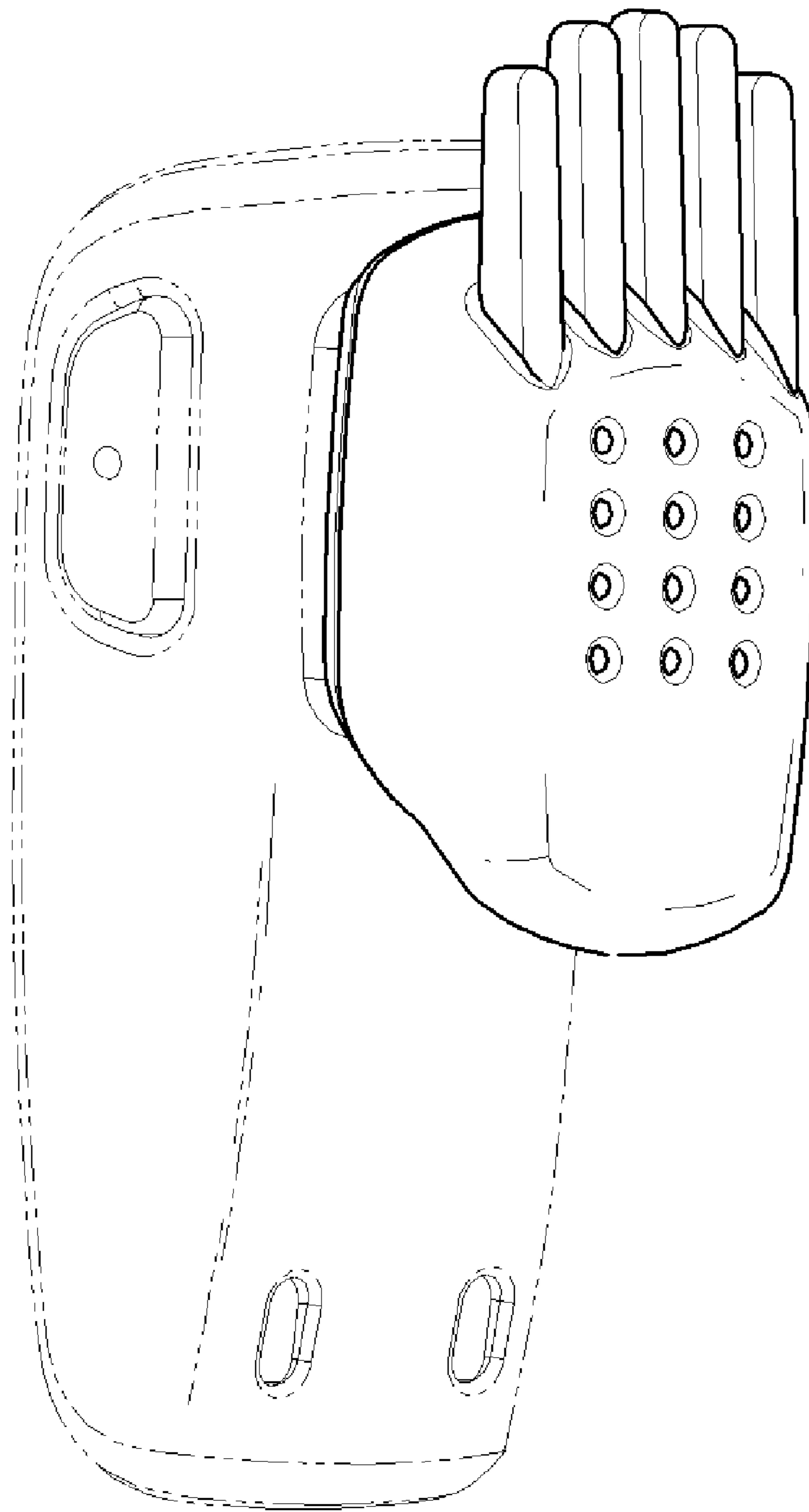
