FIG. 2 is front elevational view thereof;

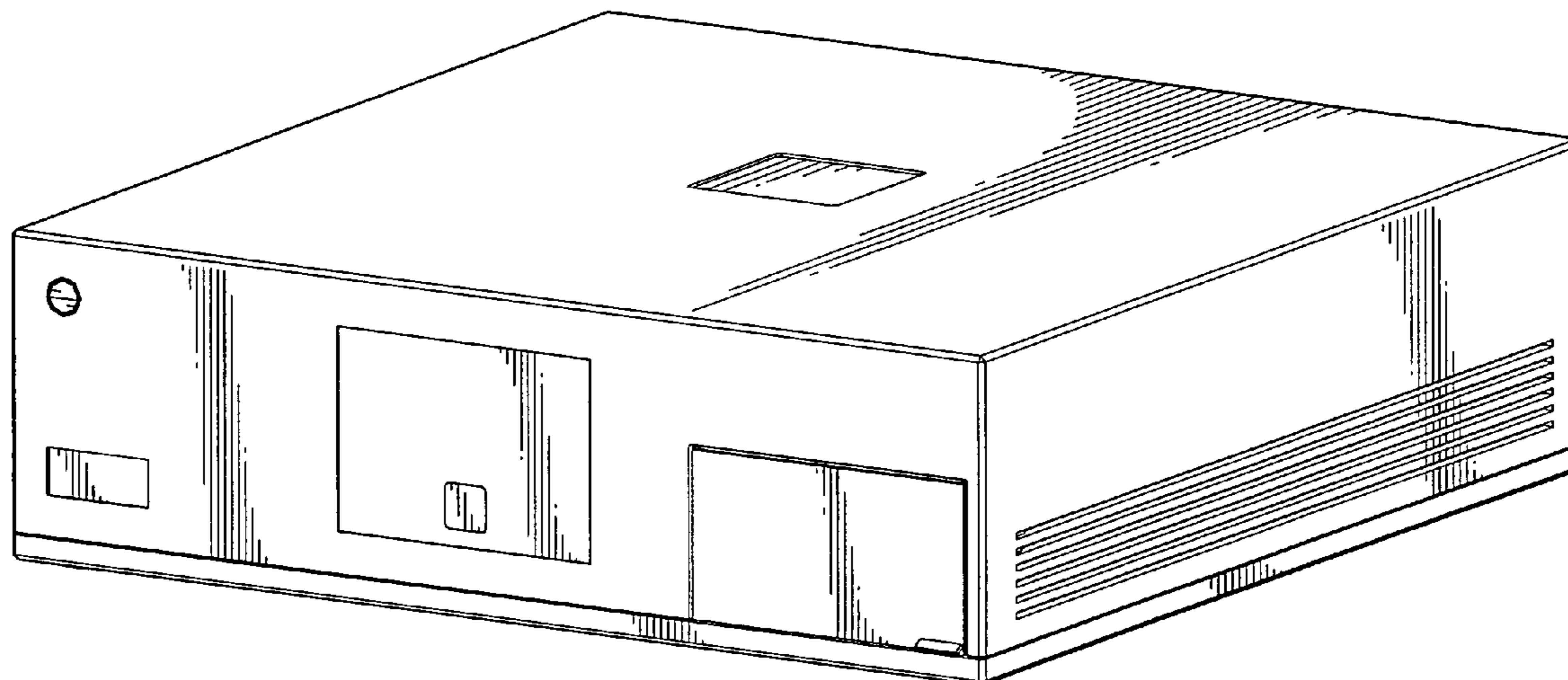
FIG. 3 is rear elevational view thereof;

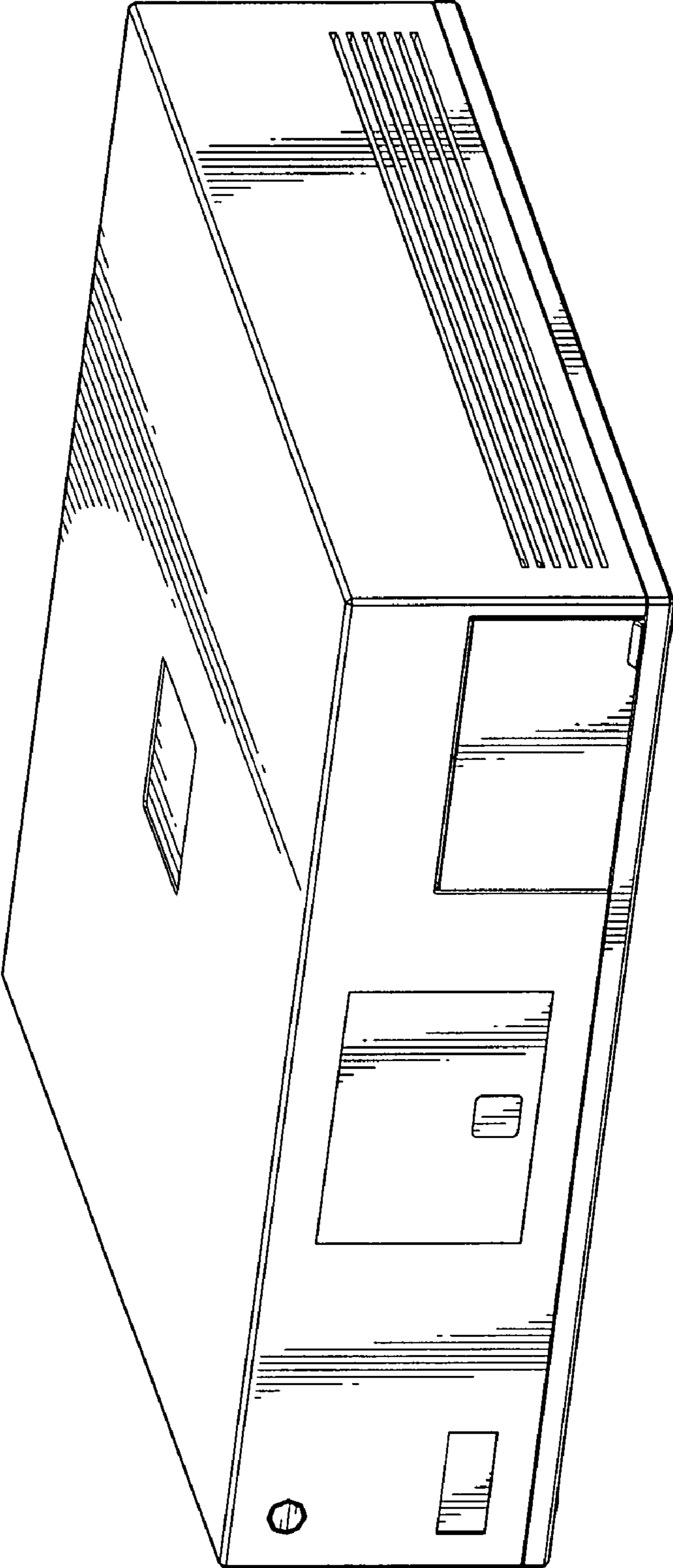

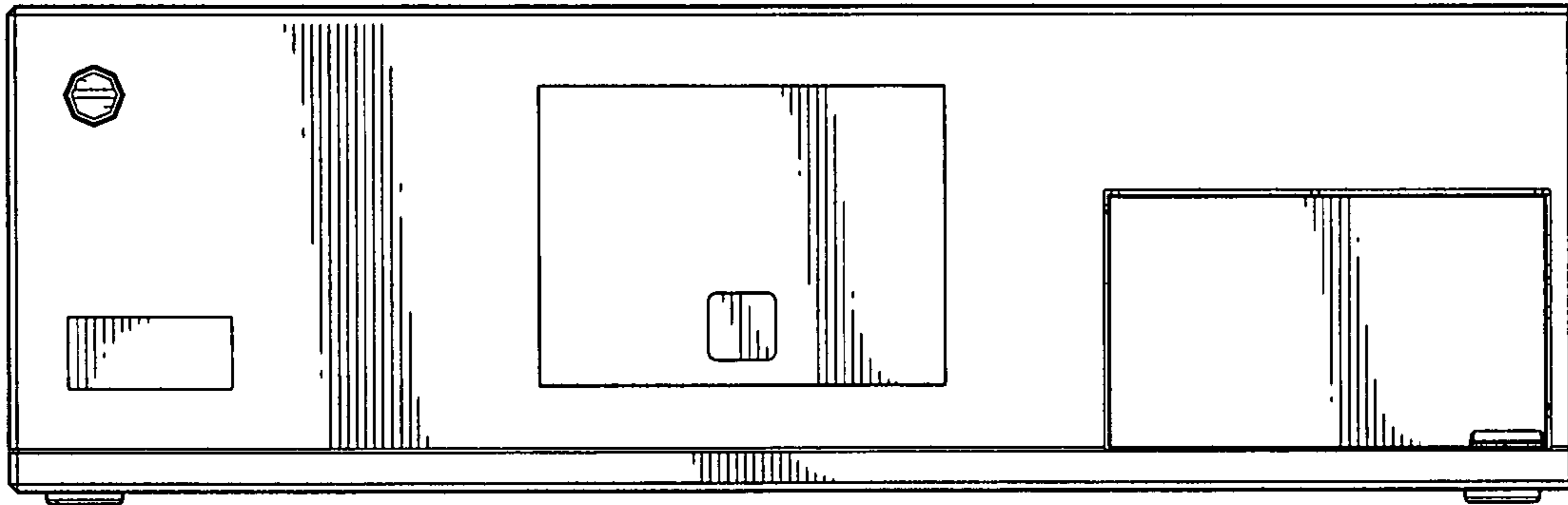

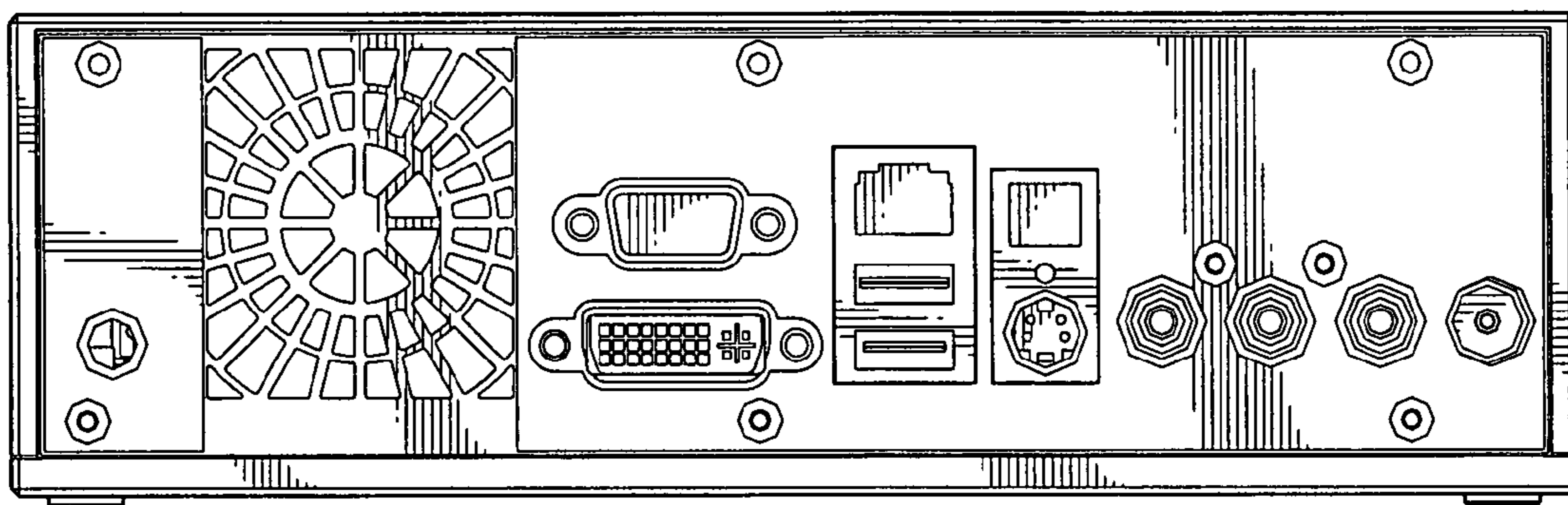

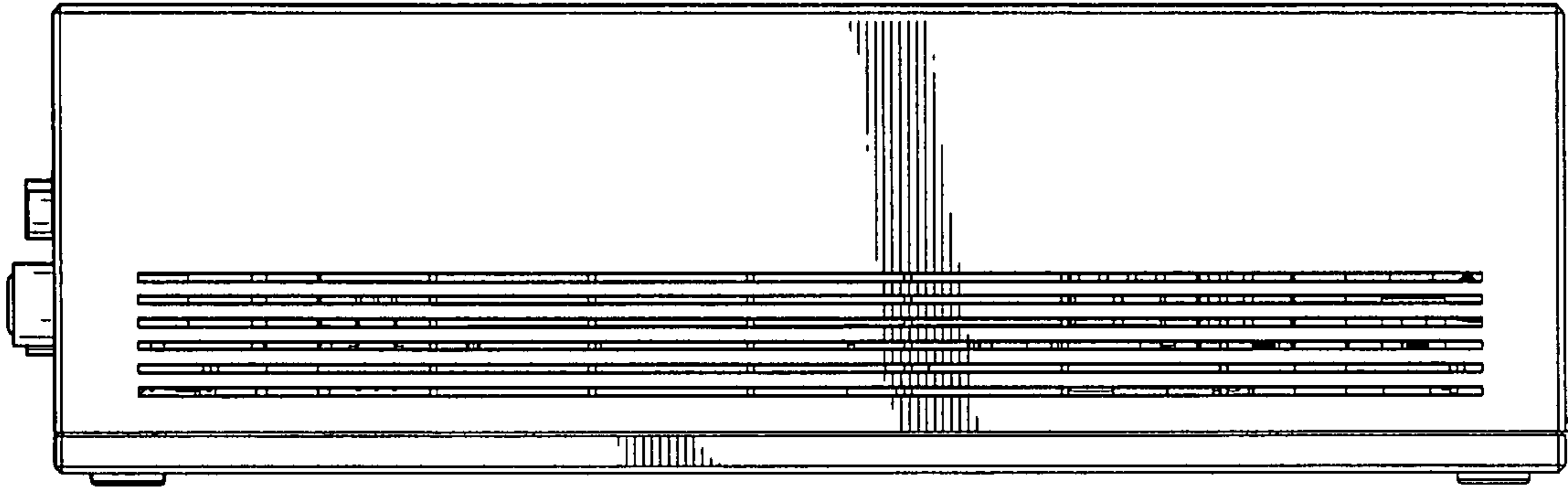

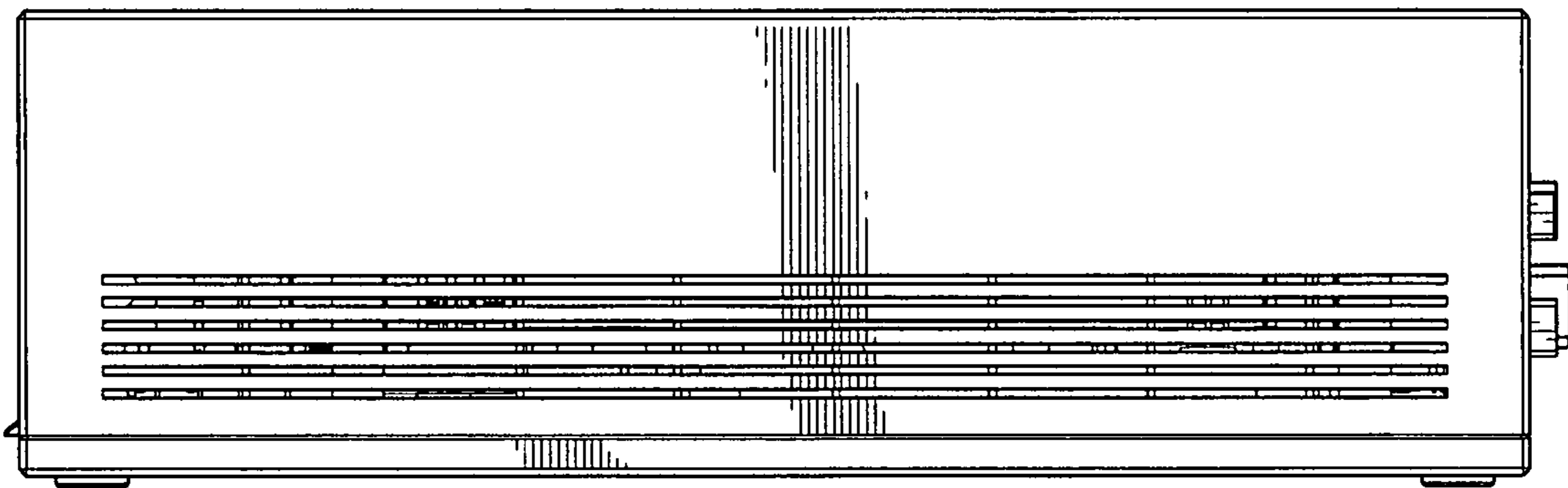

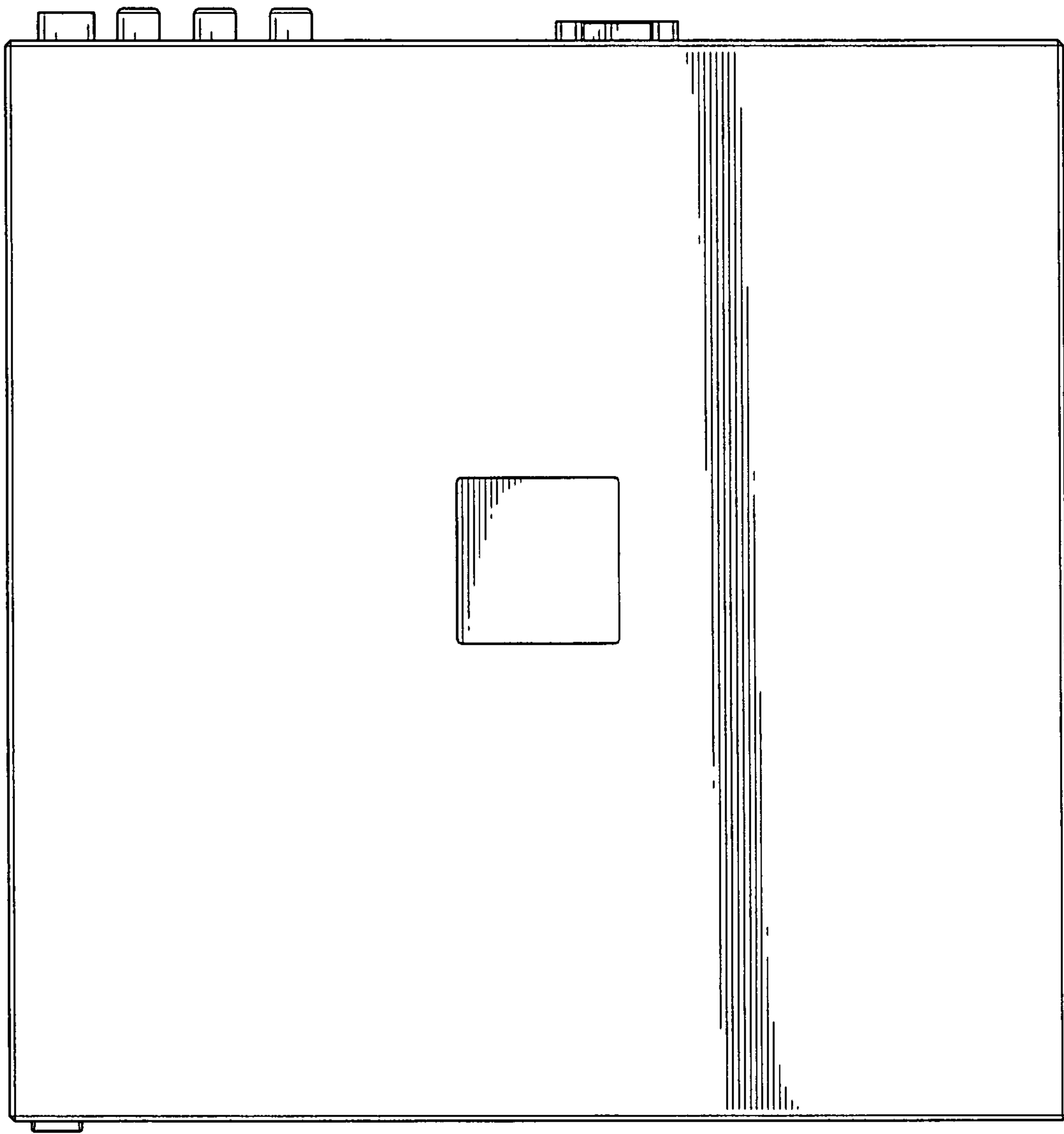
