DESCRIPTION

FIG. 1 is a perspective view of a video game console cooling mechanism showing our new design;

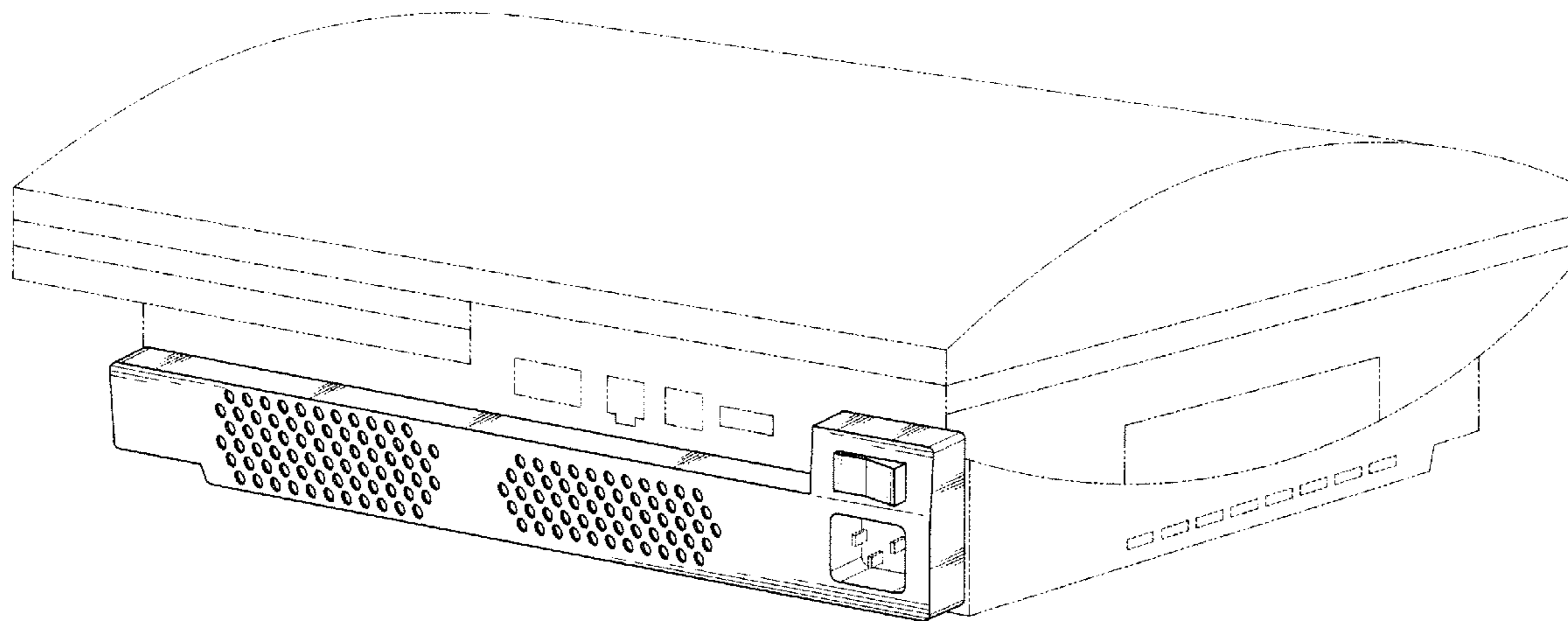
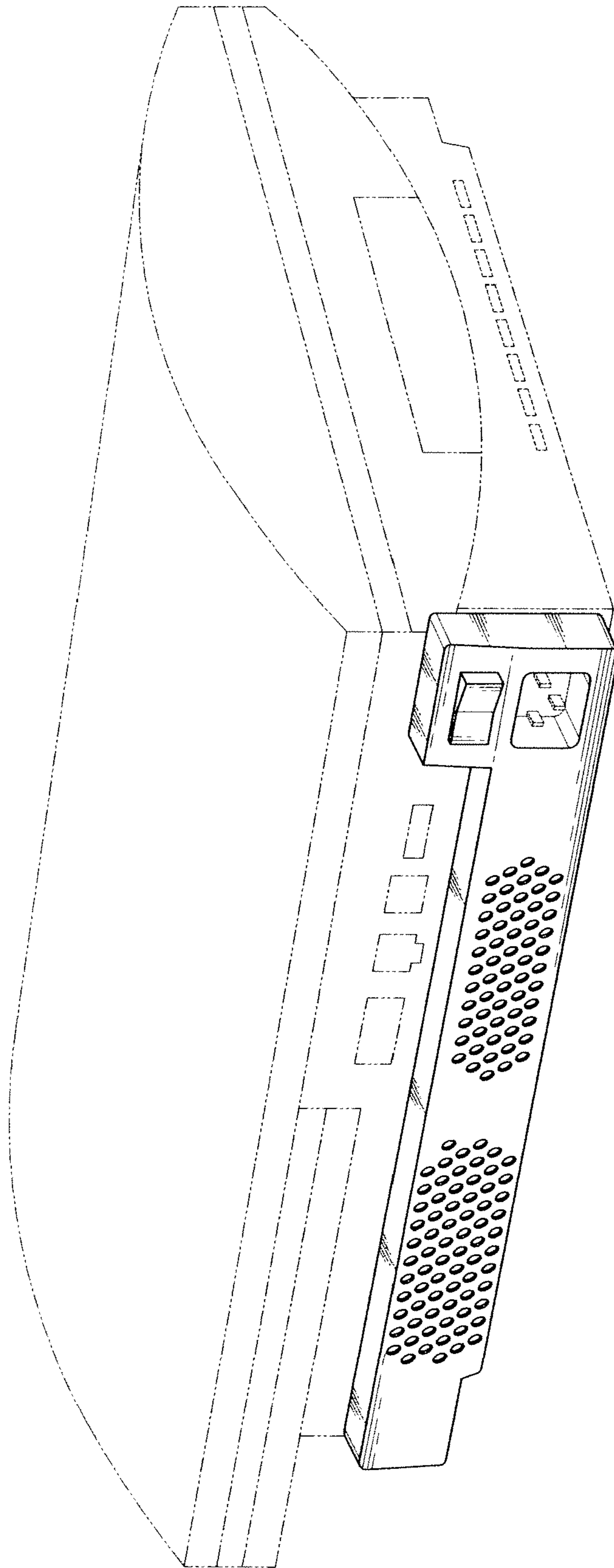

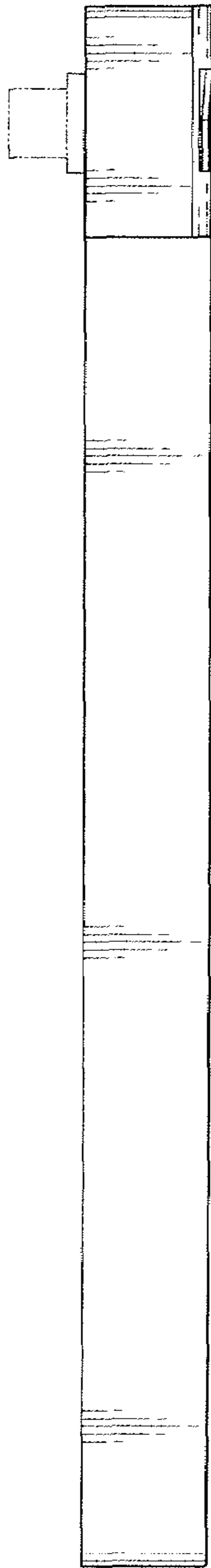

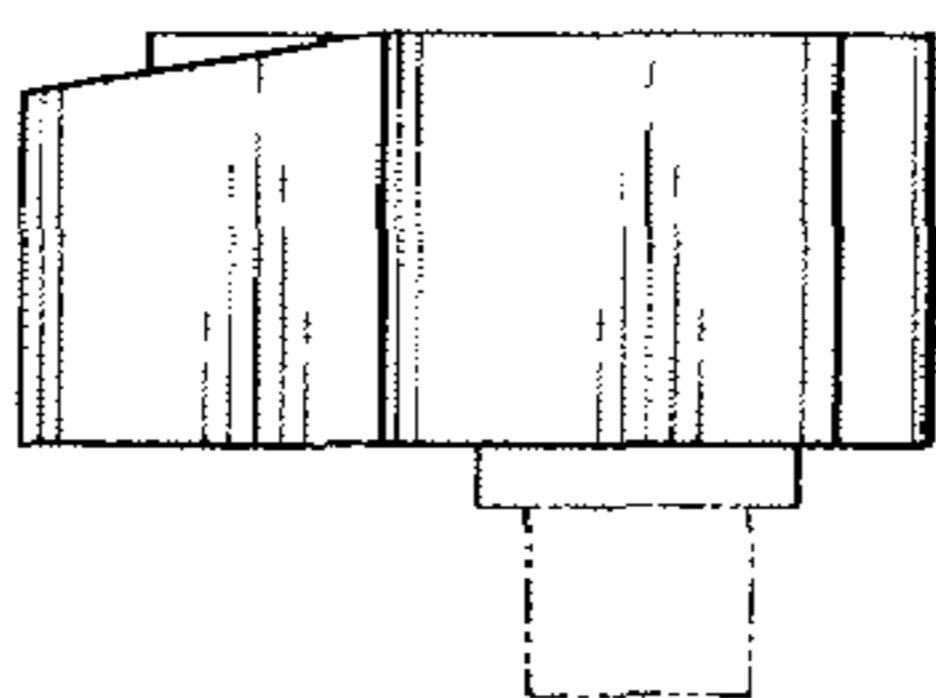

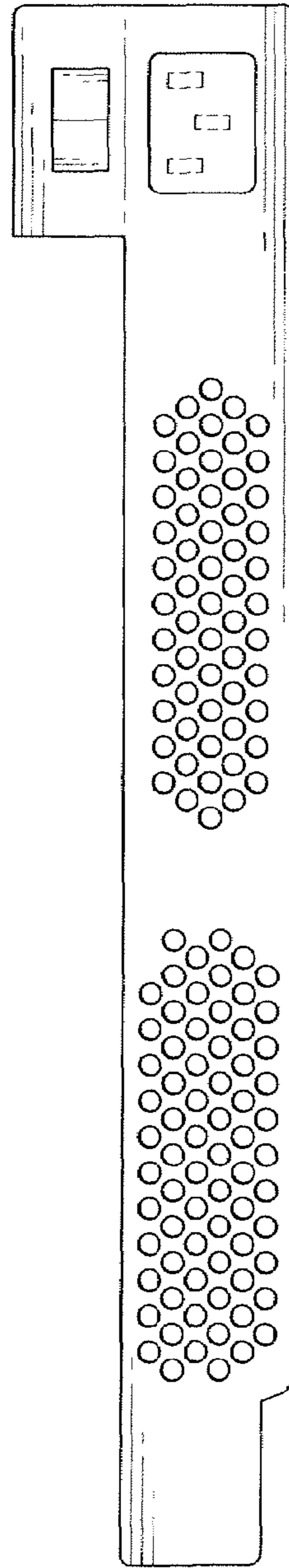

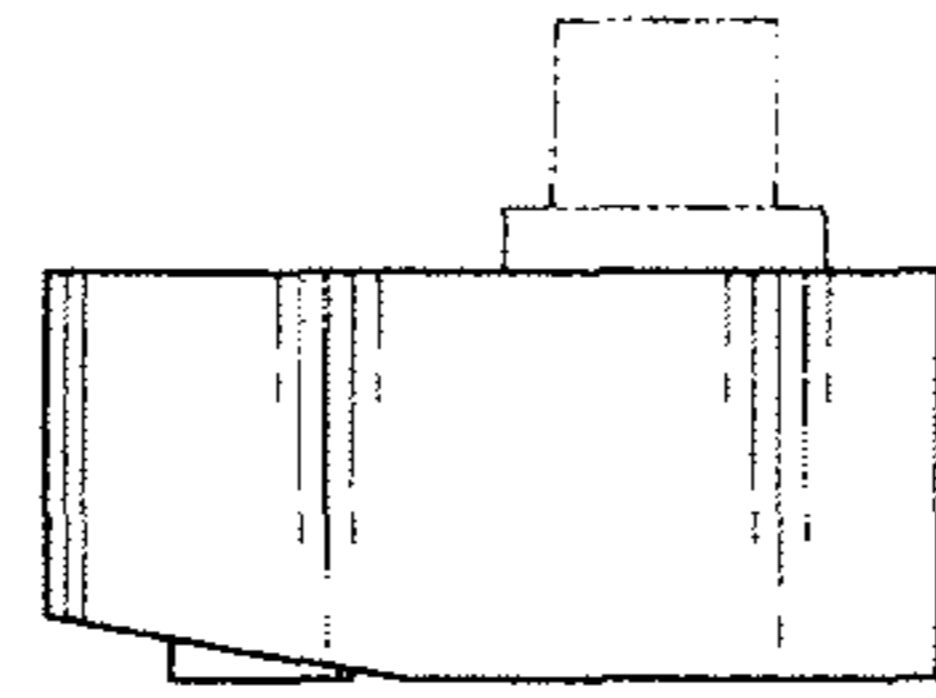

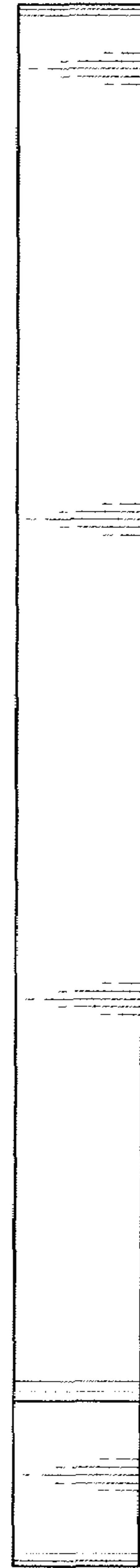

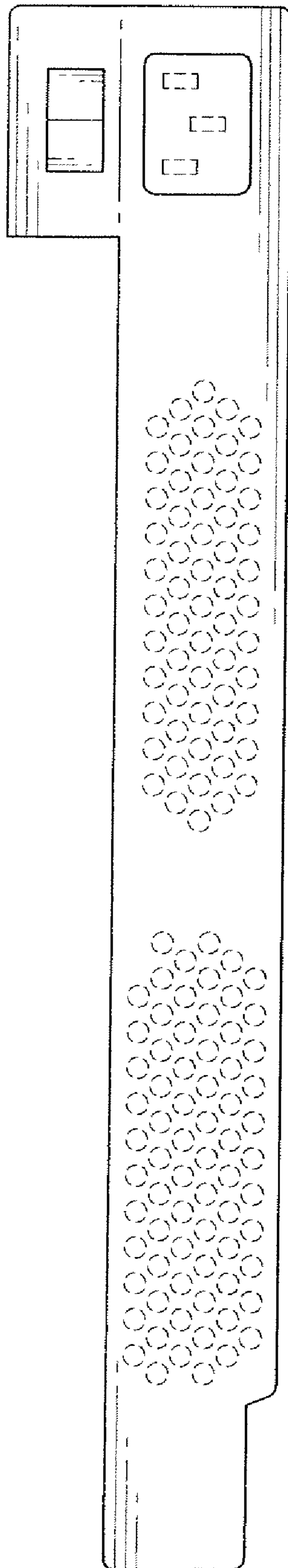
