FIG. 5 is an opposite side view thereof;

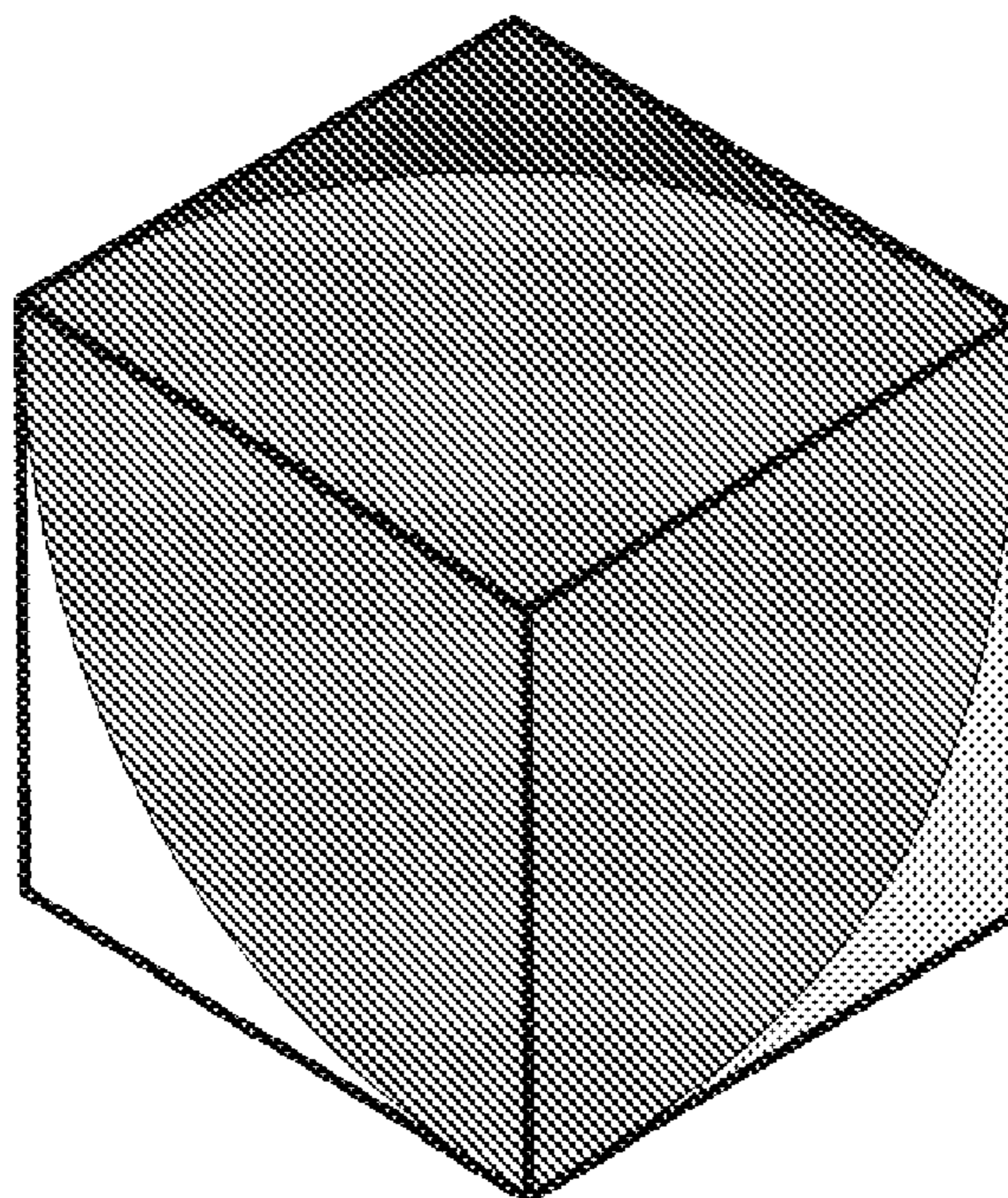
FIG. 6 is a rear view thereof;

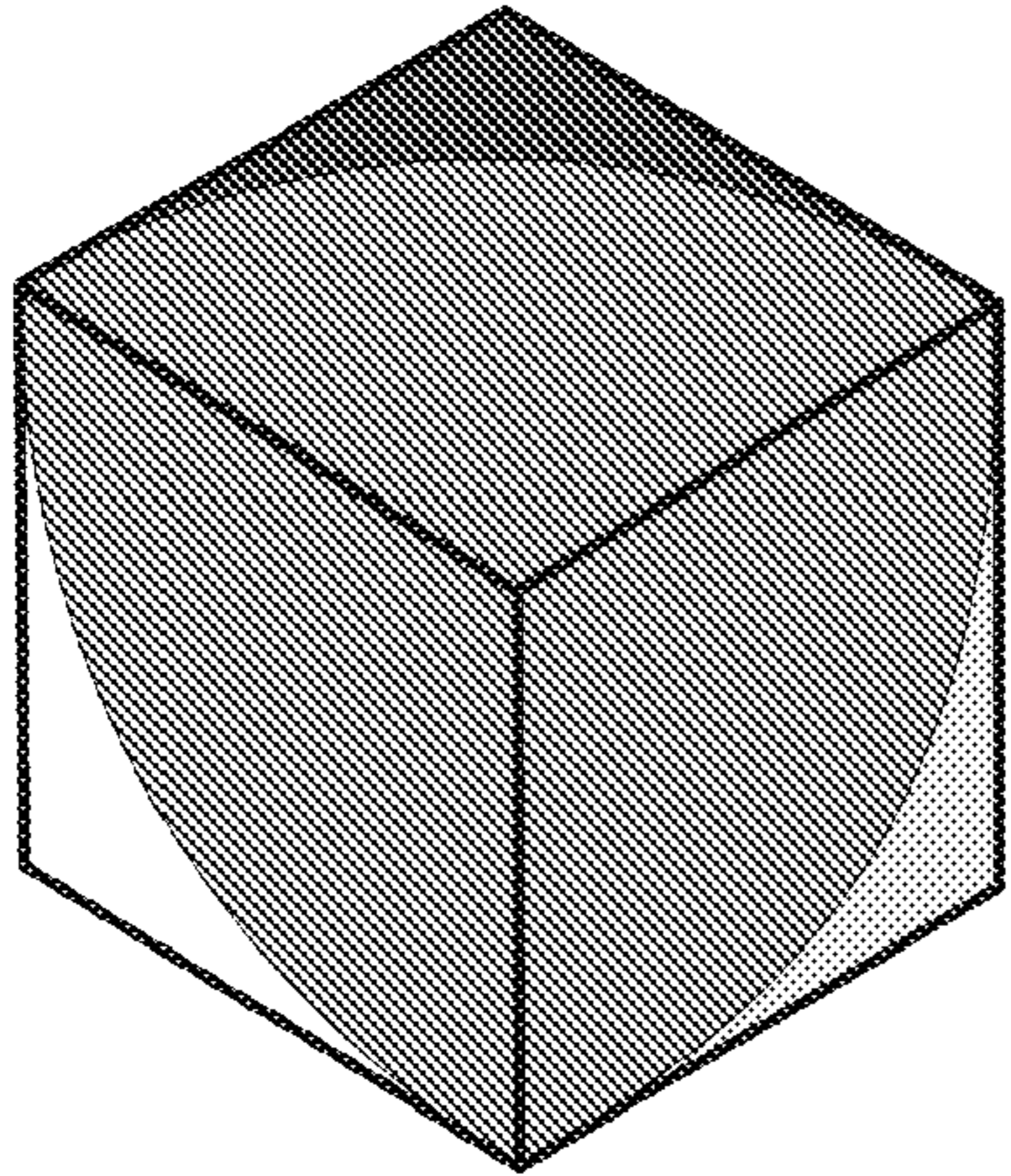

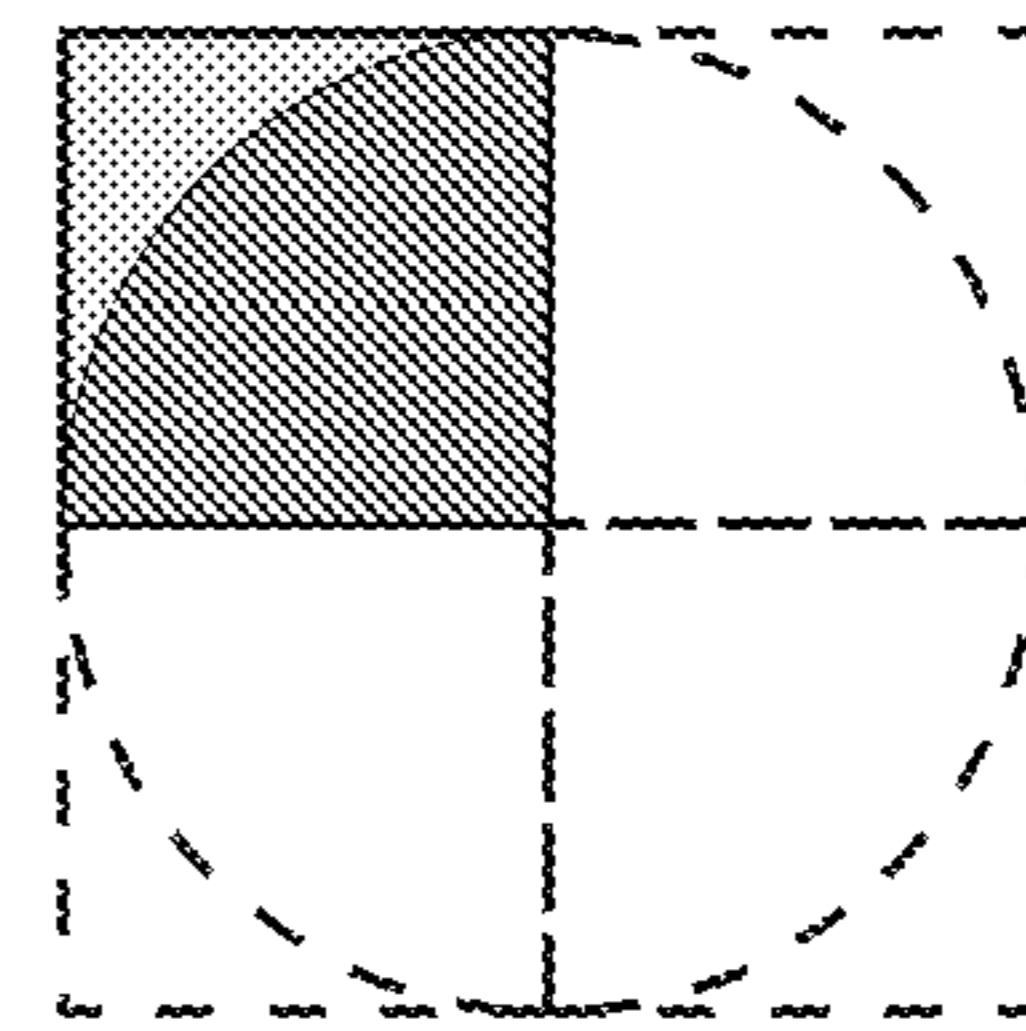

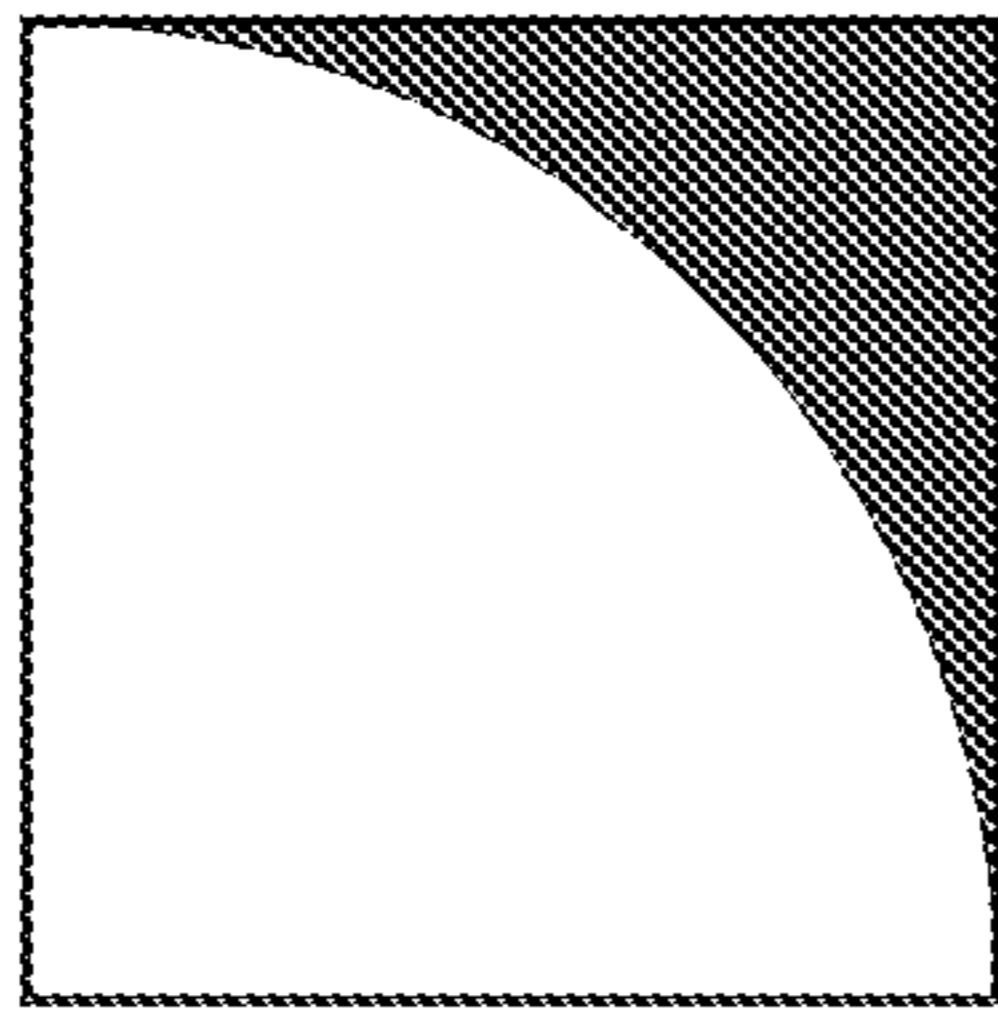

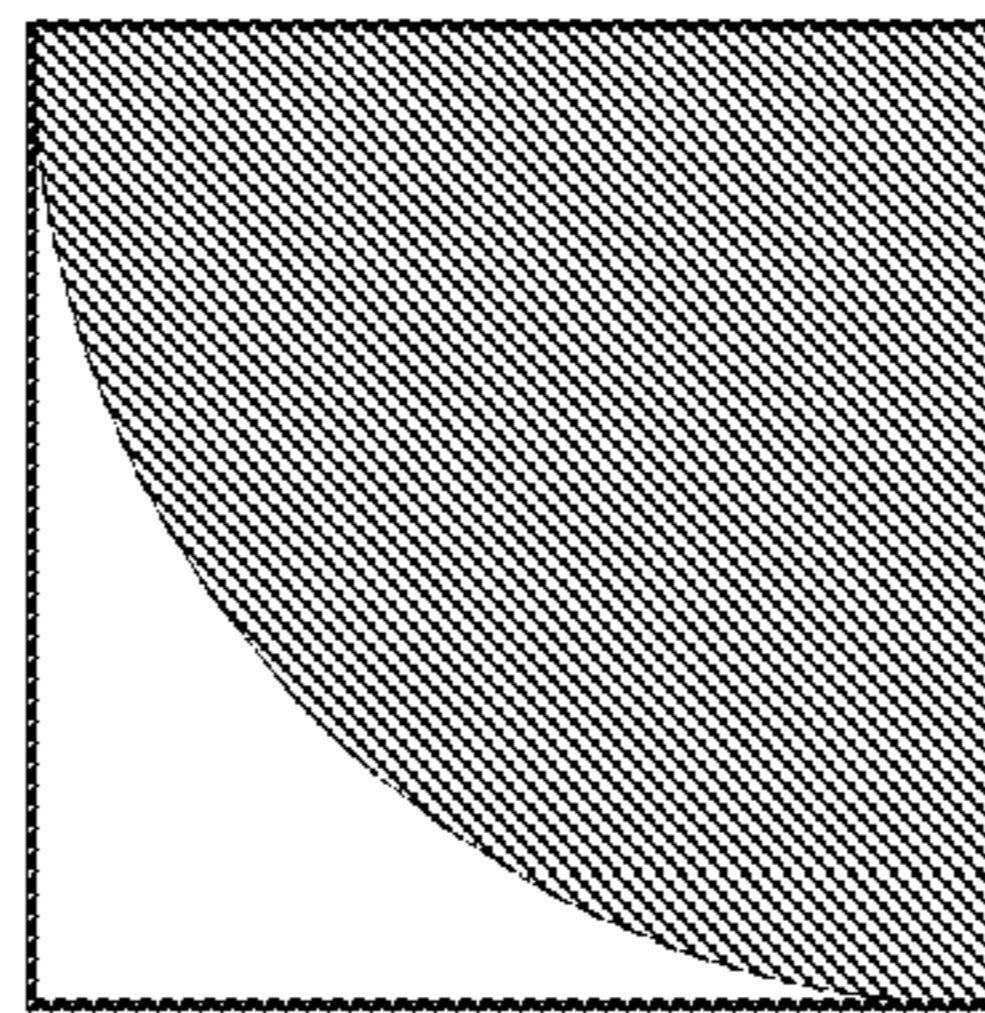

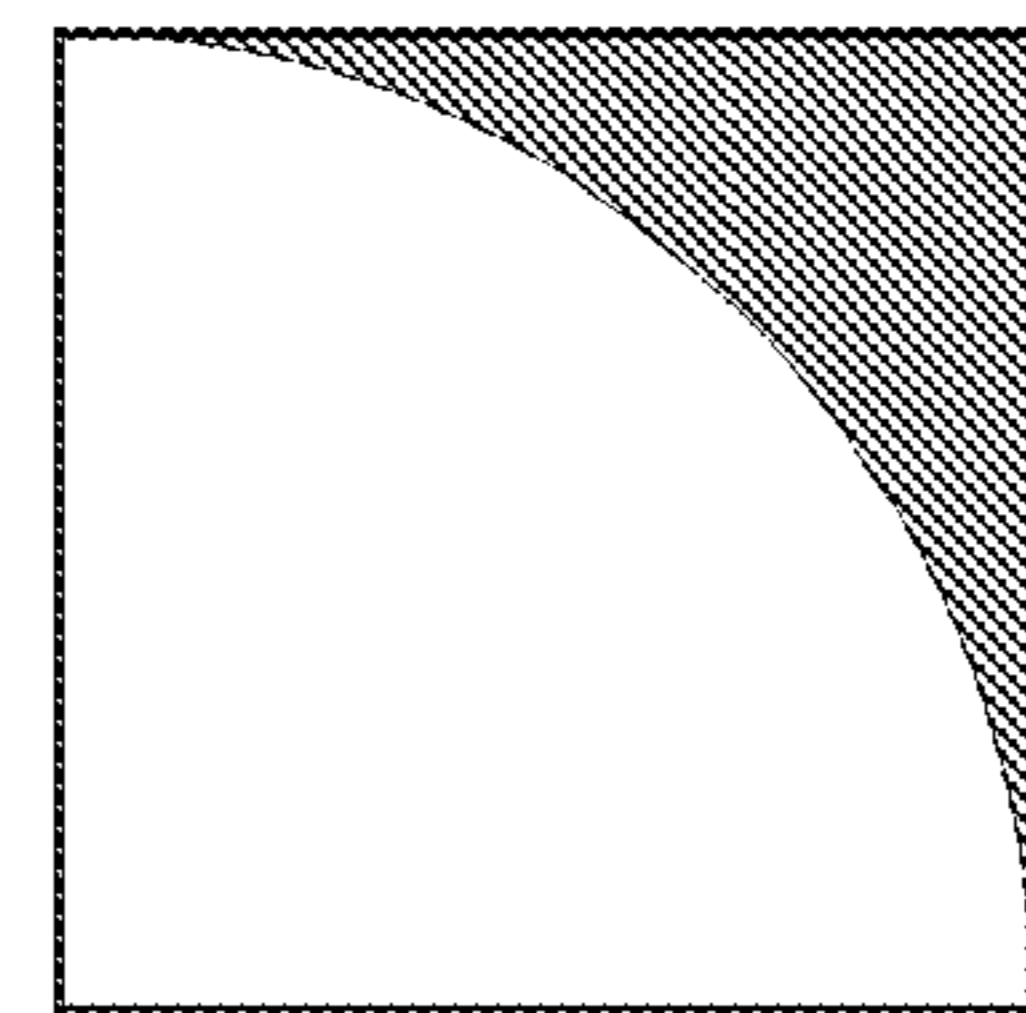

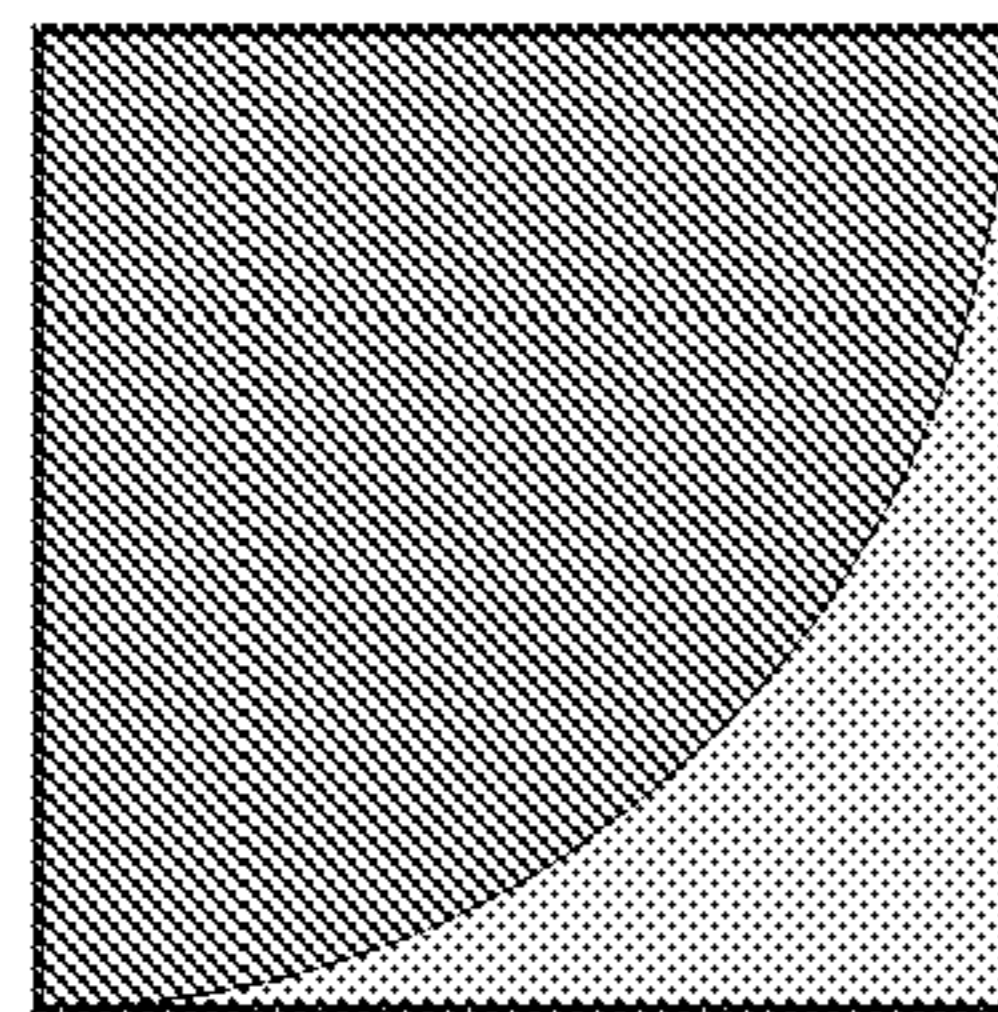

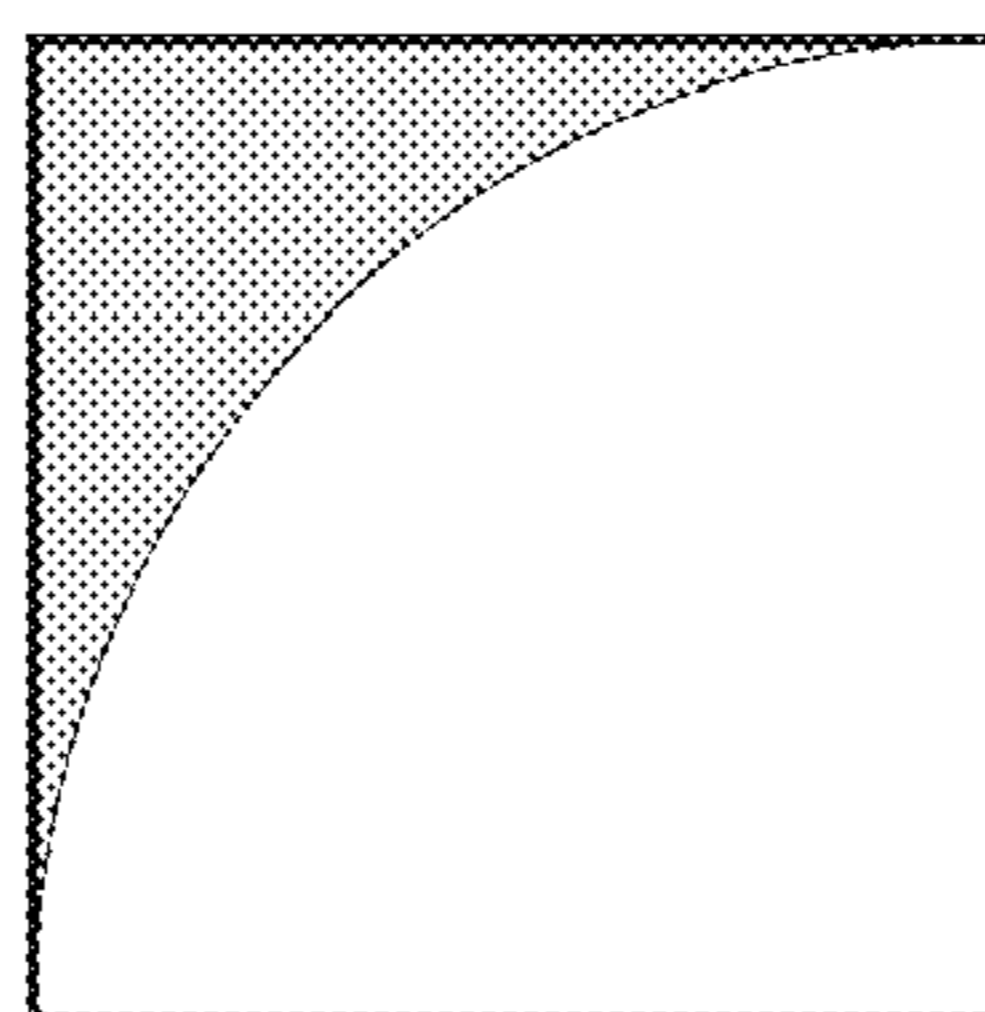

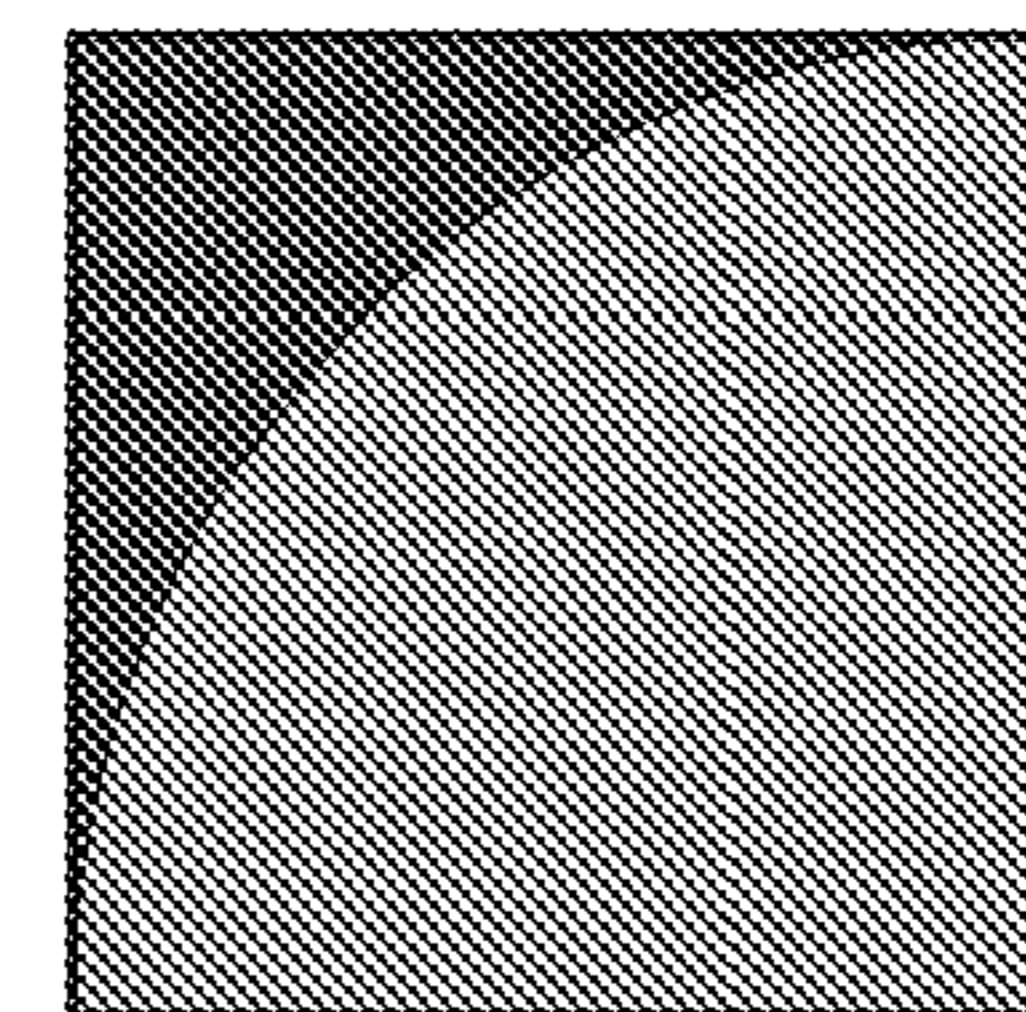
