**DESCRIPTION**

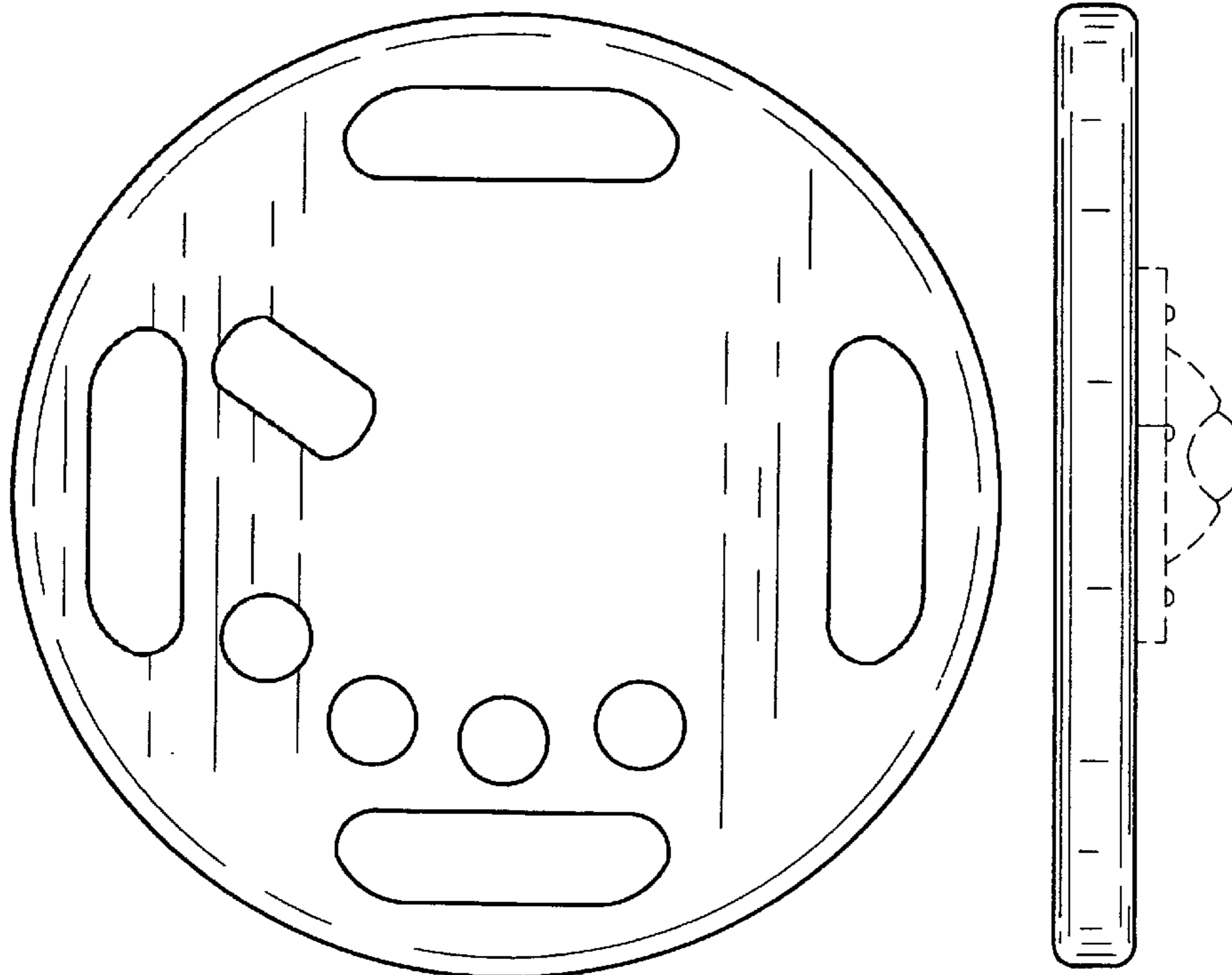
FIG. 1 is a top plan view of our new design showing thumb and finger slots;

FIG. 2 is a bottom plan view showing thumb and finger slots and (in broken line form) bearing placement; and,

FIG. 3 is a side view with the bearing unit shown in broken line form.

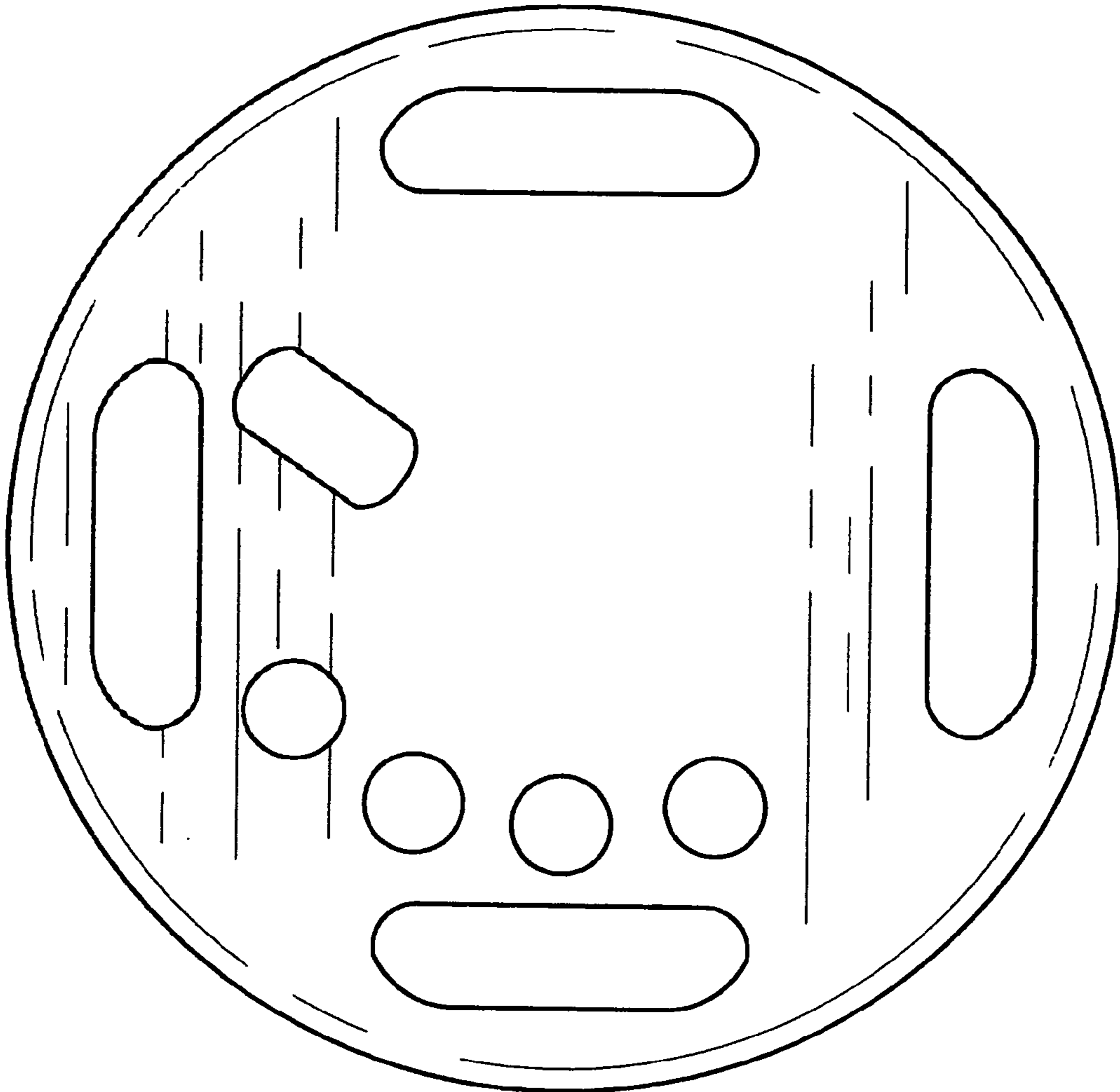

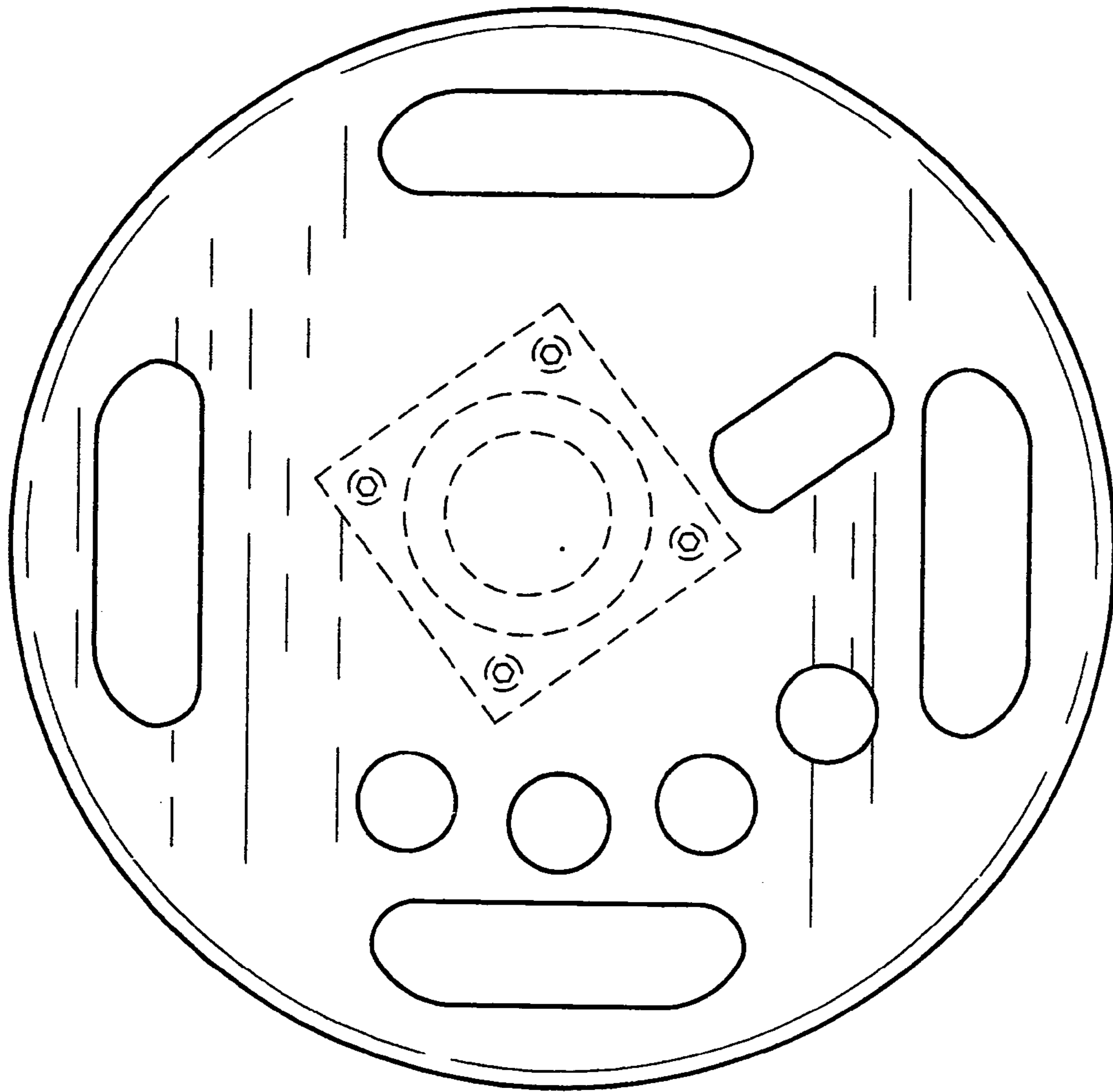

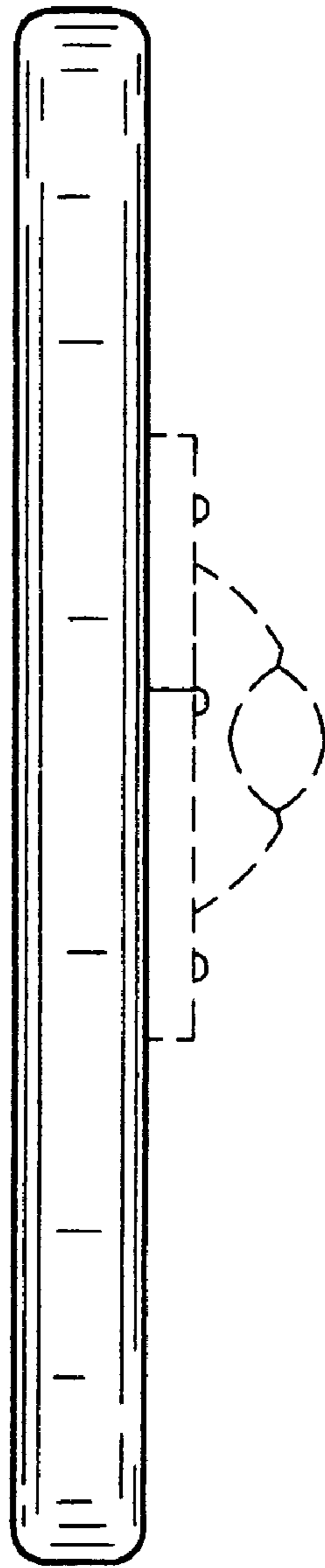
