upper position; and,

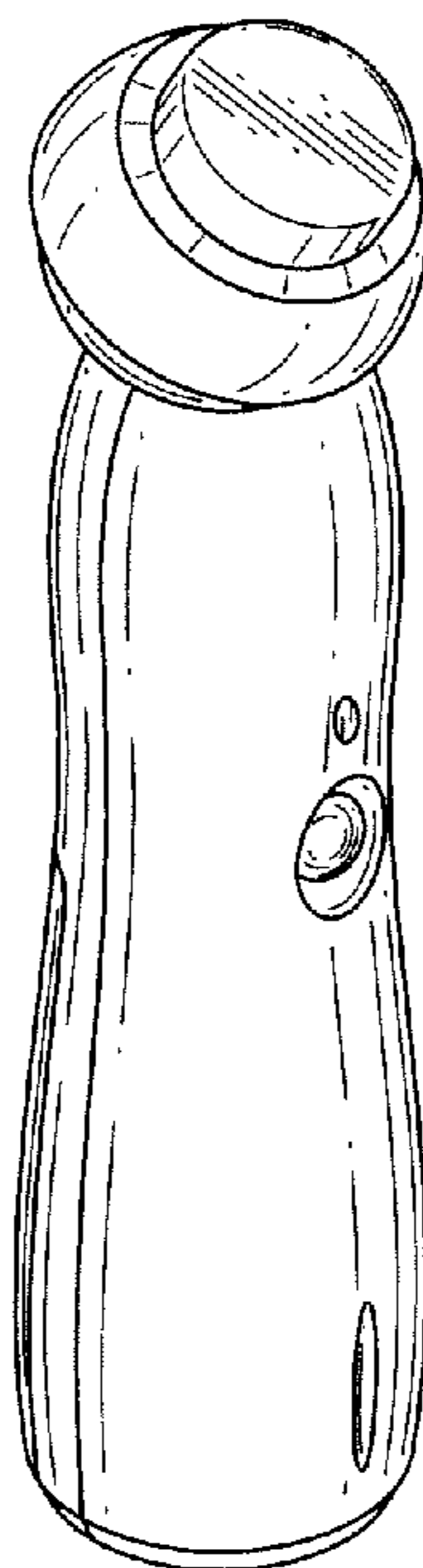
FIG. 11 is a side view thereof, having the head portion in the

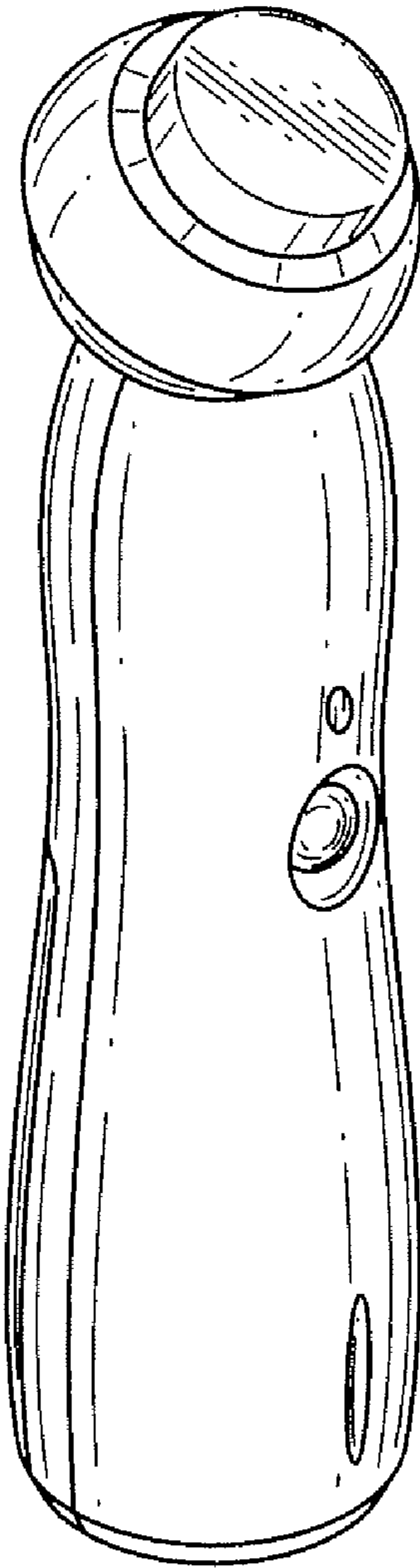

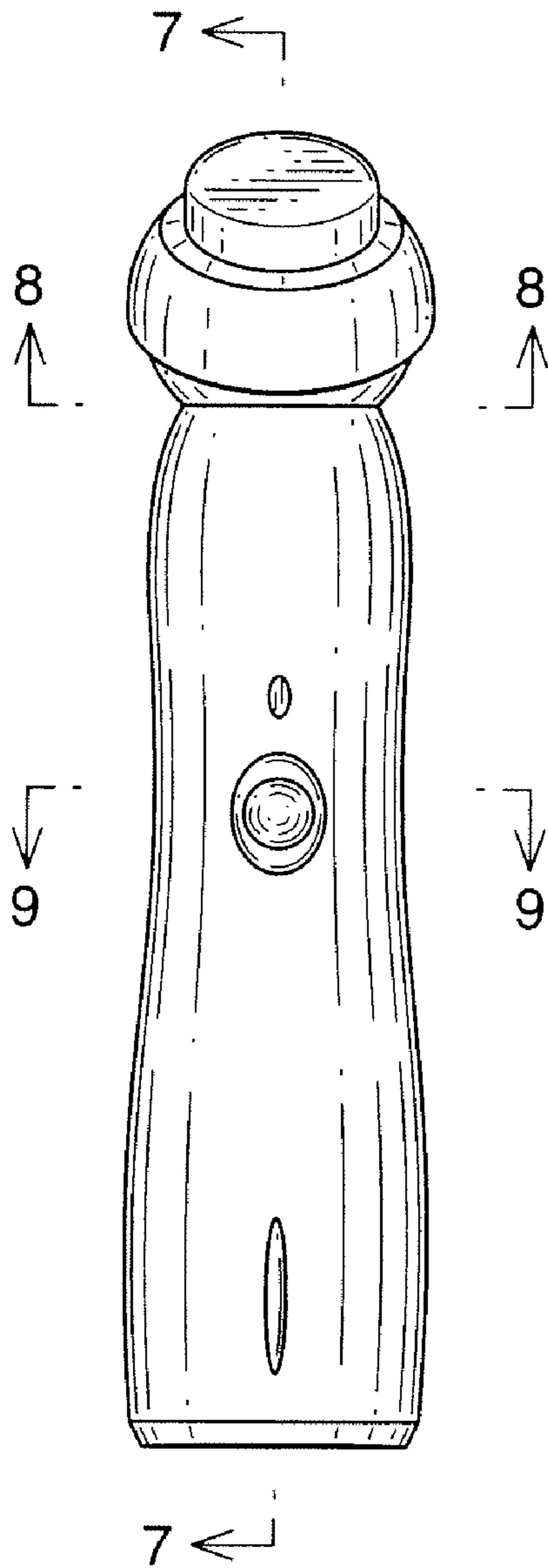

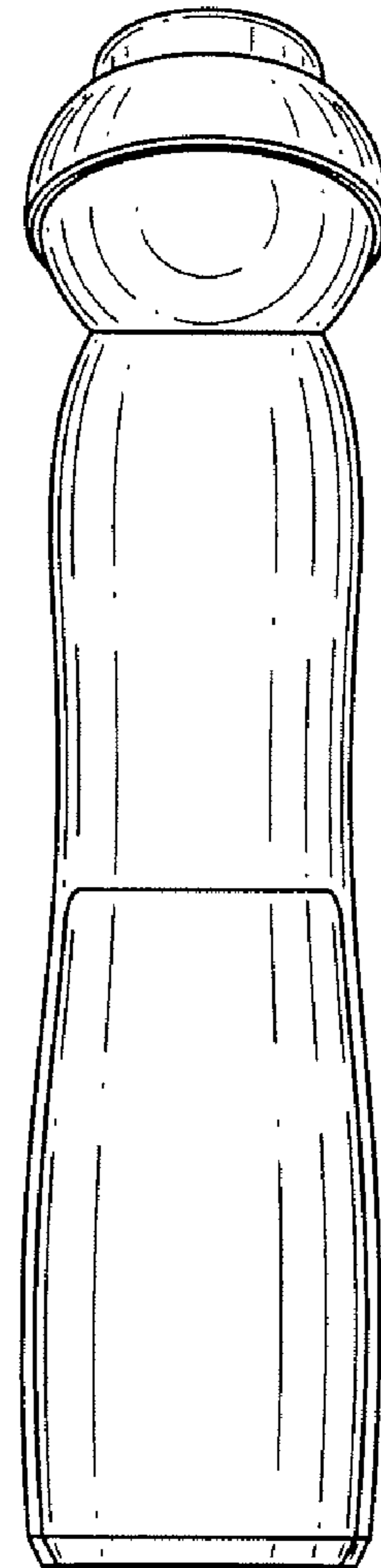

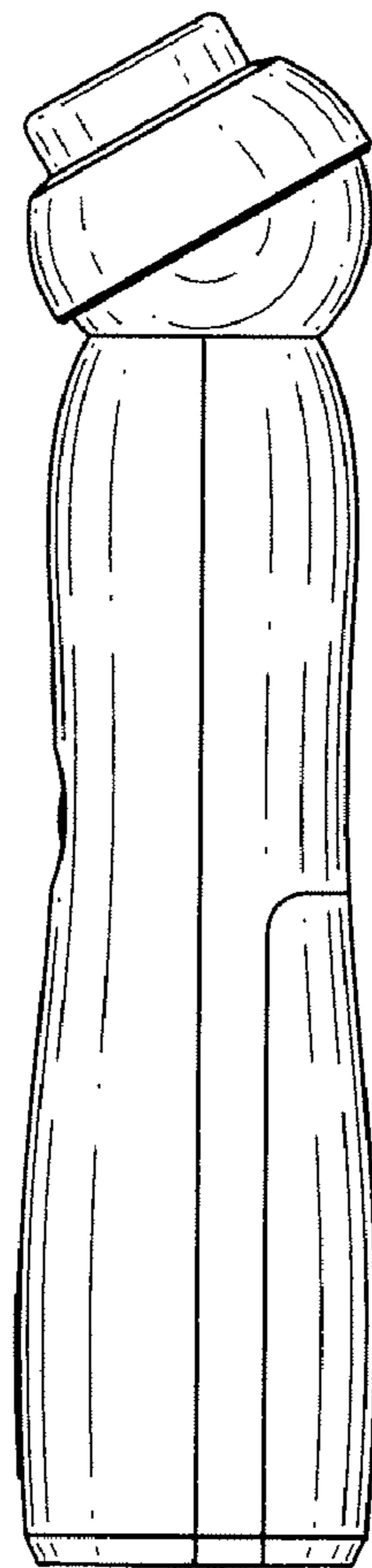

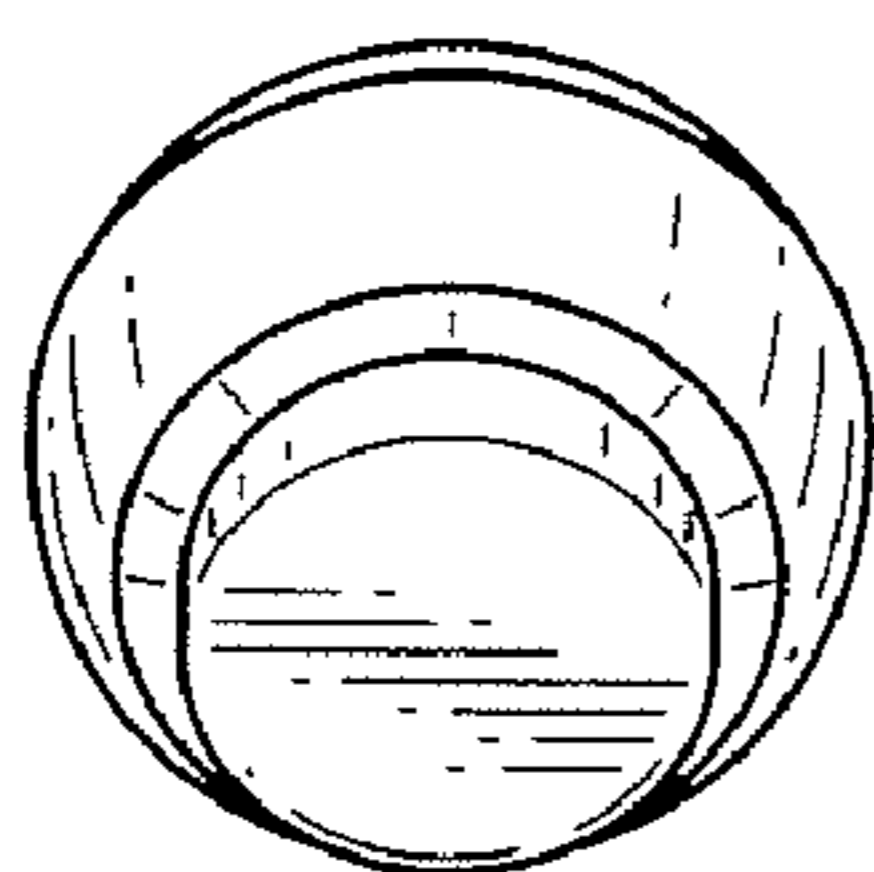

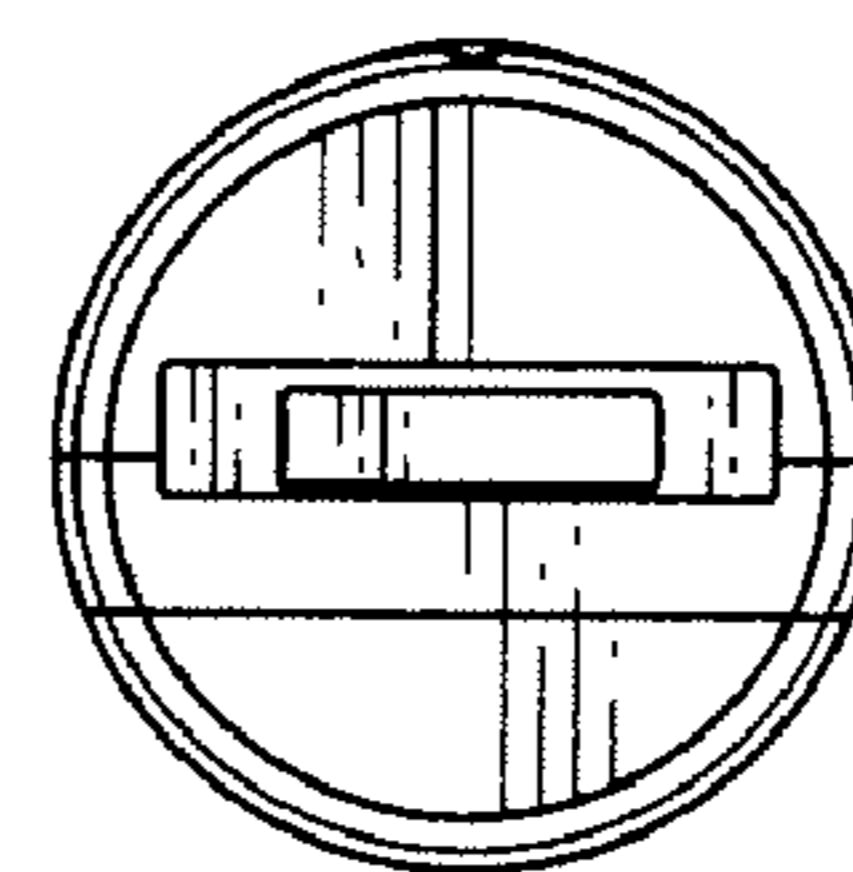

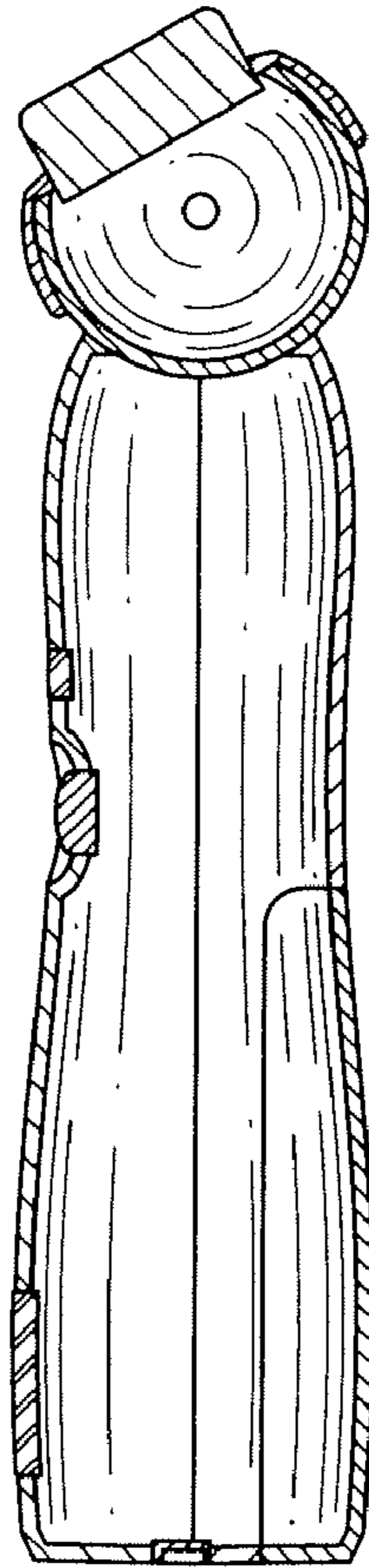

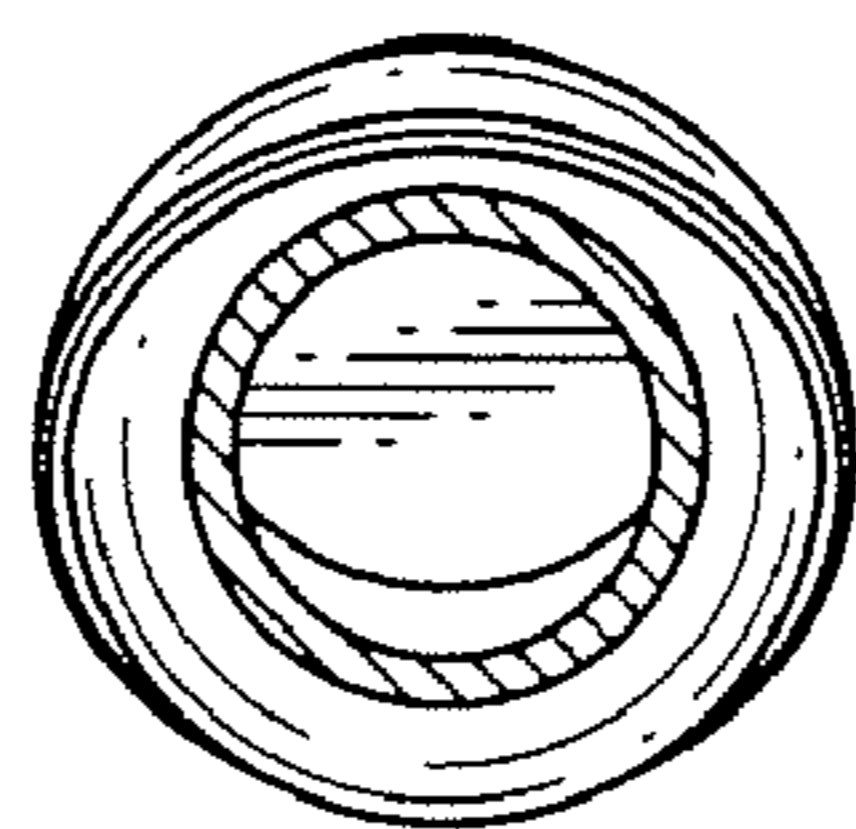

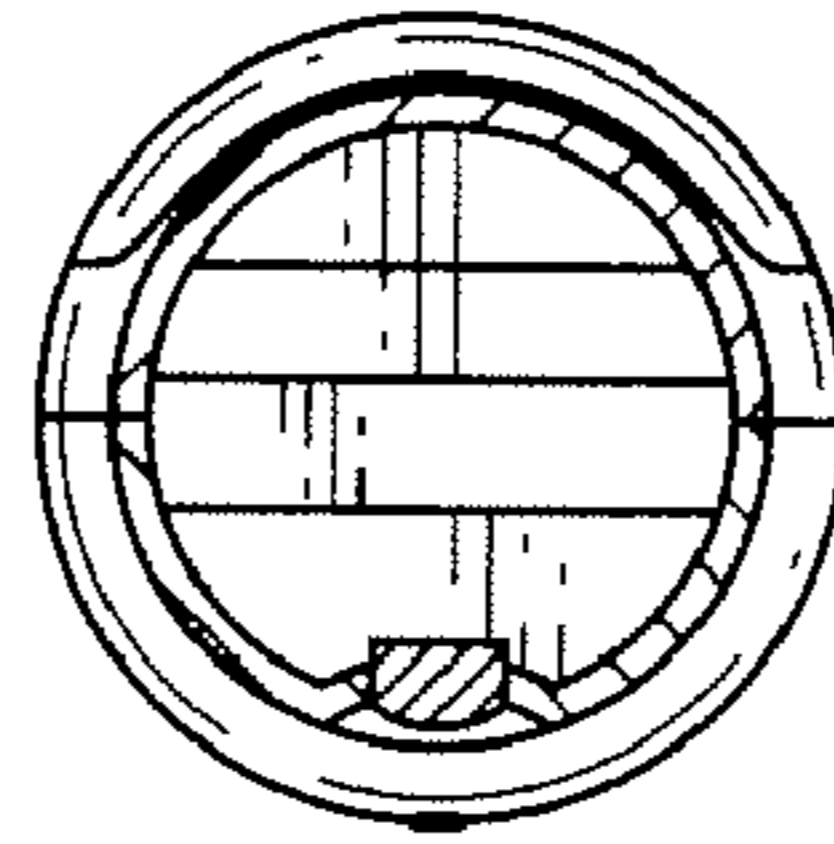

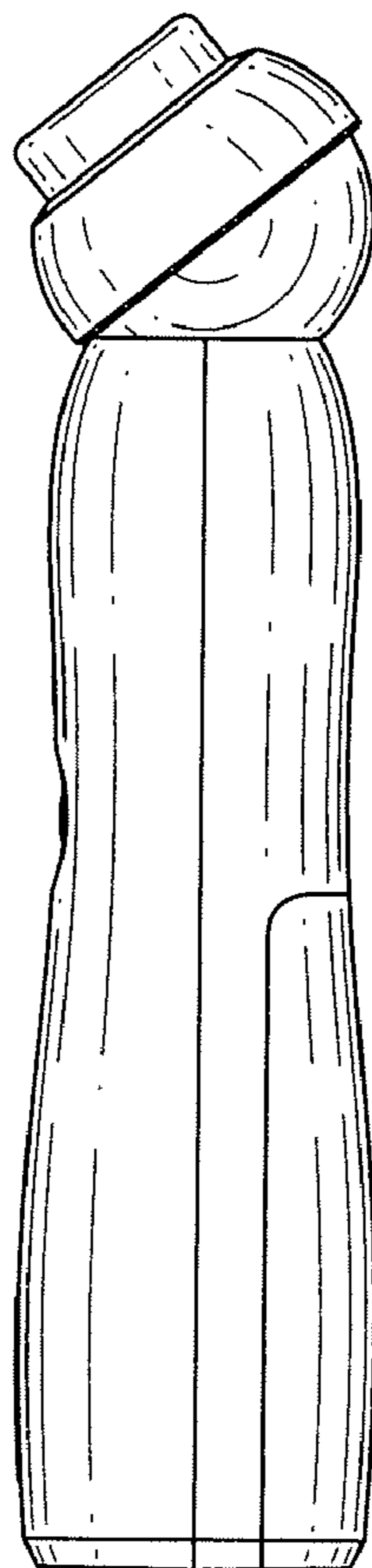

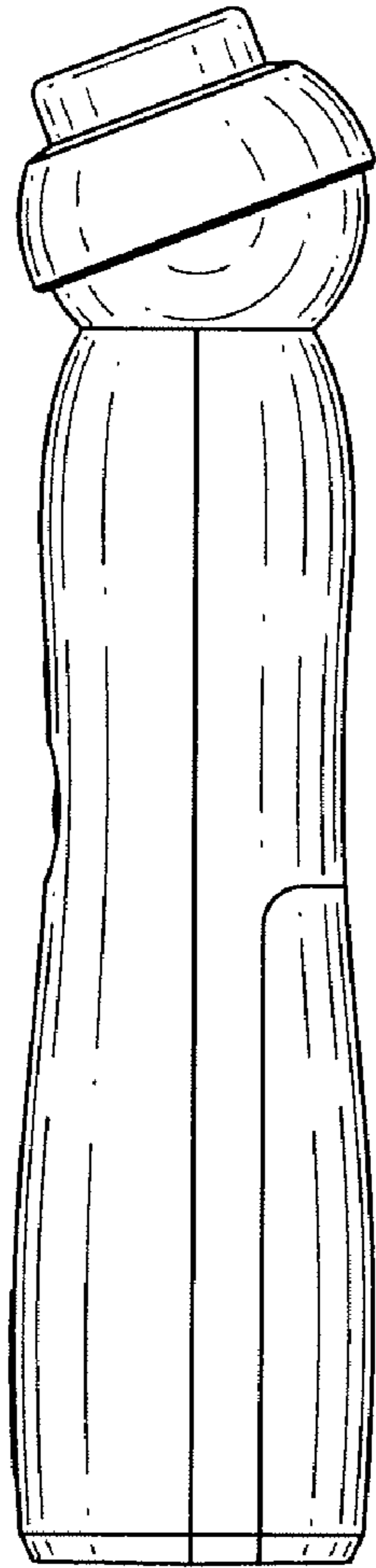
