FIG. 1 is a perspective view of a shoe showing my new design.

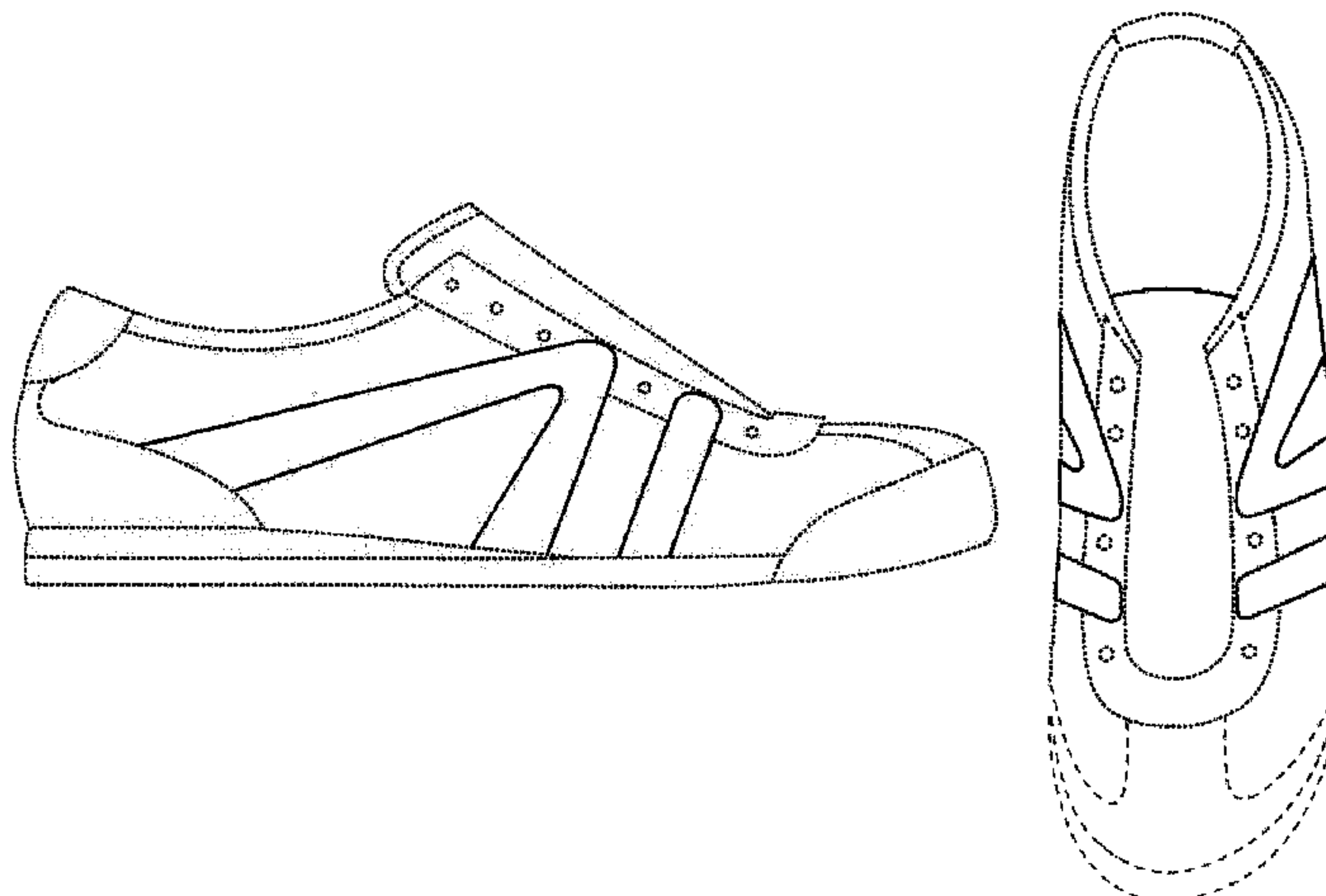
FIG. 2 is a left side elevational view thereof.

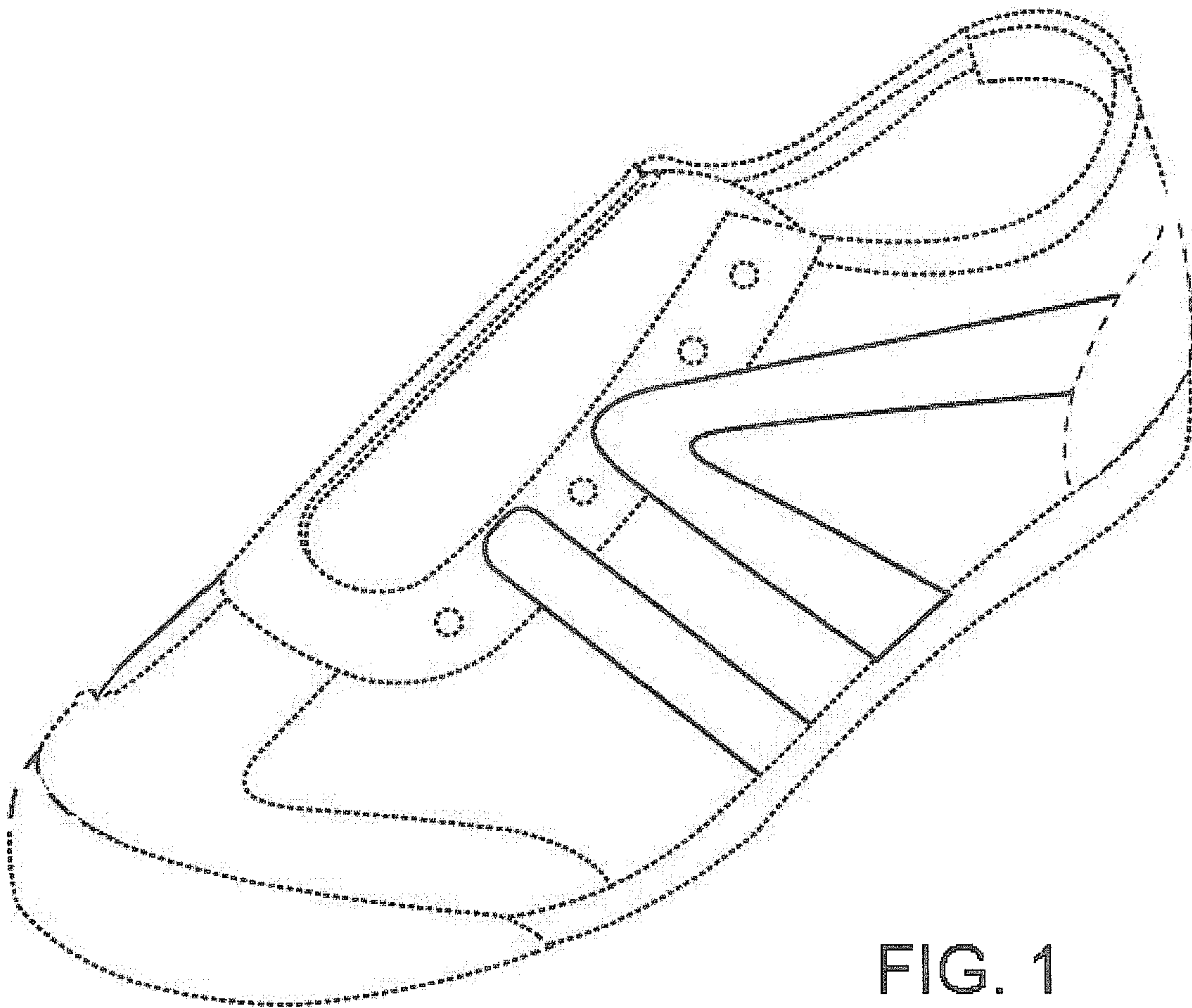
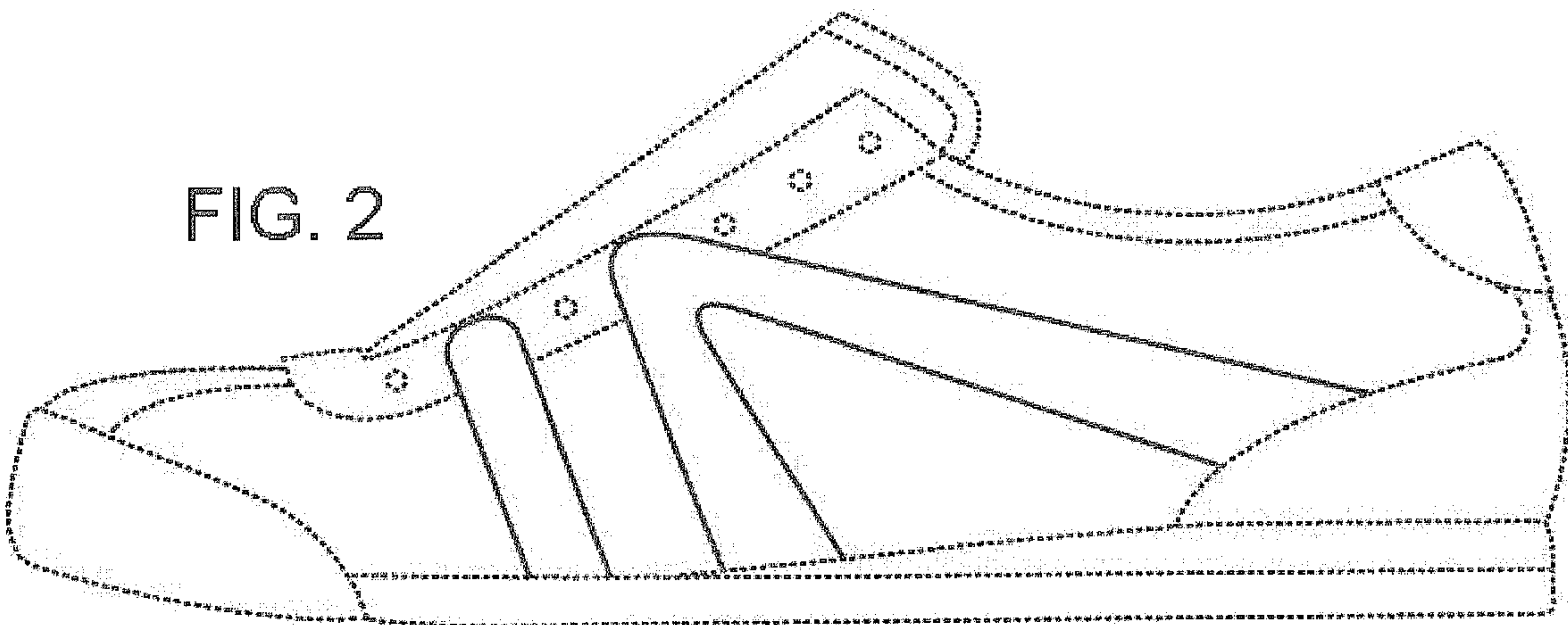
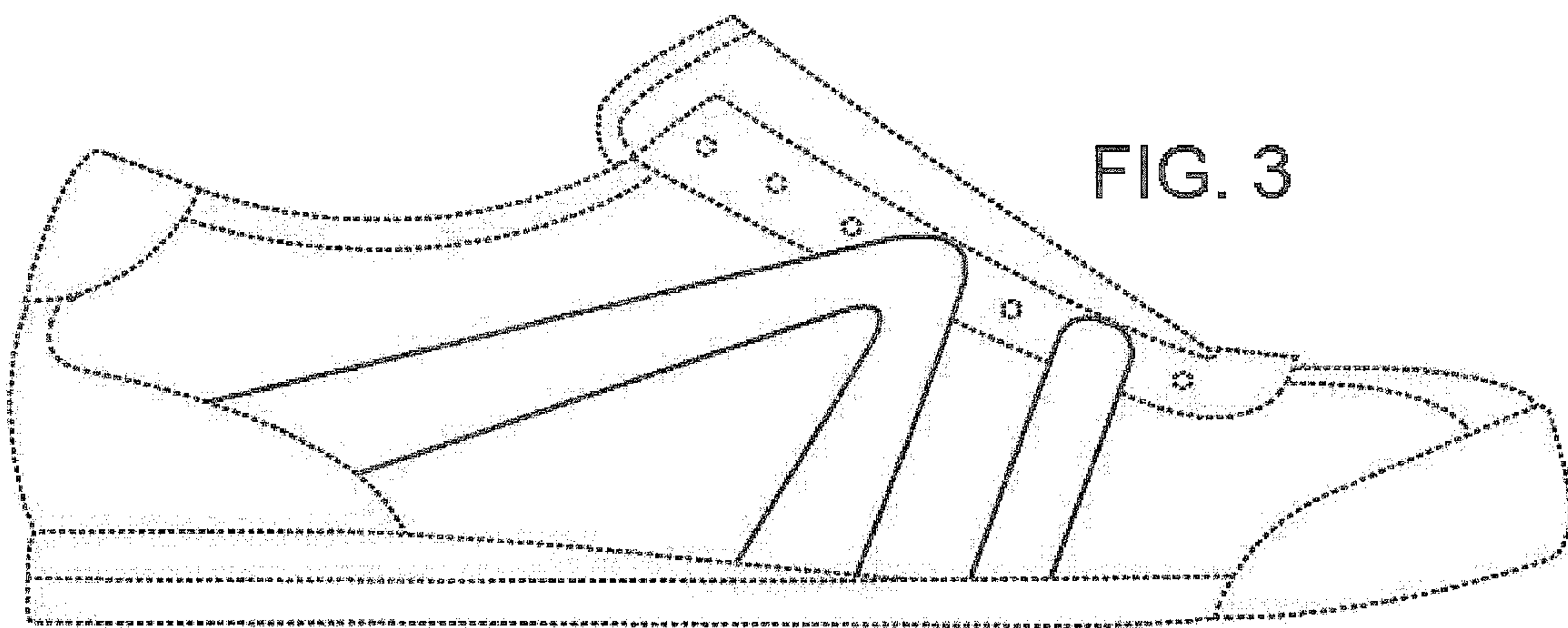

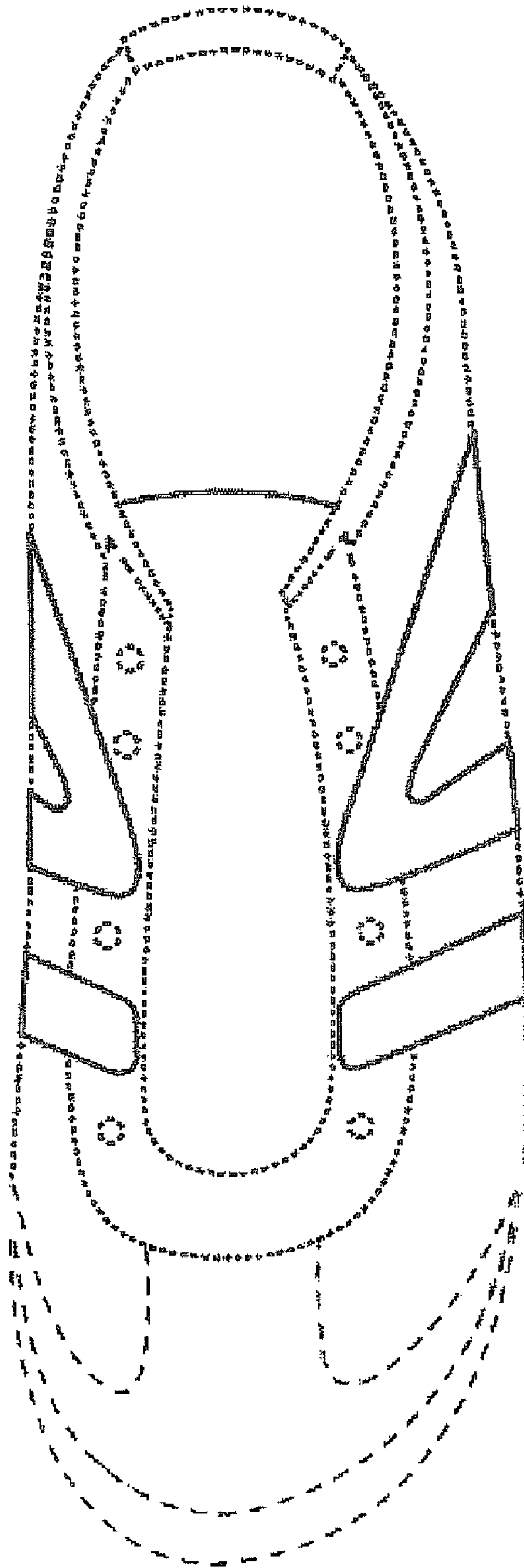
