**DESCRIPTION**

FIG. 1 is a perspective view of the wardrobe according to my claimed design; the door pulls and drawer pulls are not part of the claimed design and are shown in phantom;

FIG. 2 is a top plan view thereof;

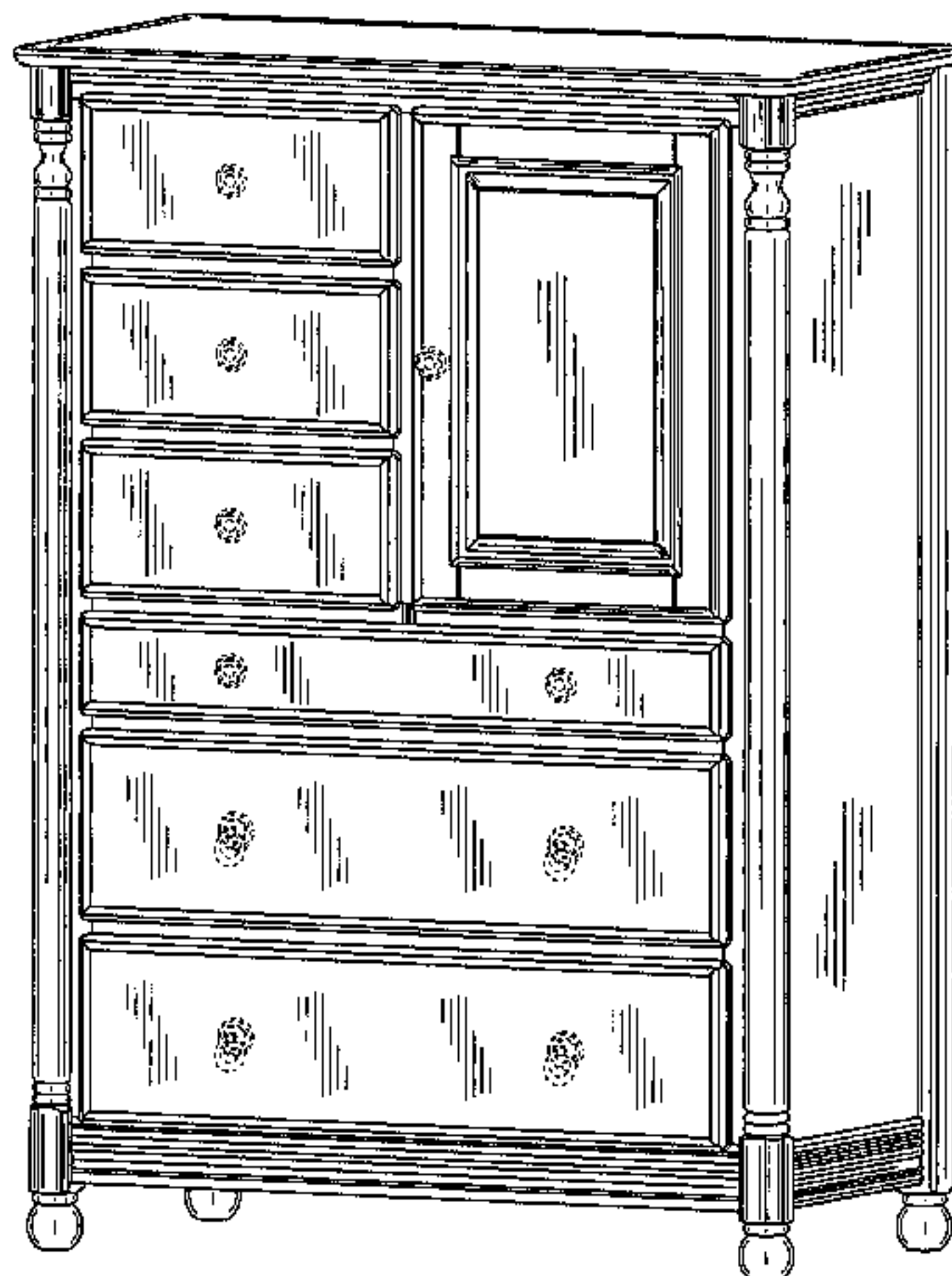
FIG. 3 is a front elevation view thereof;

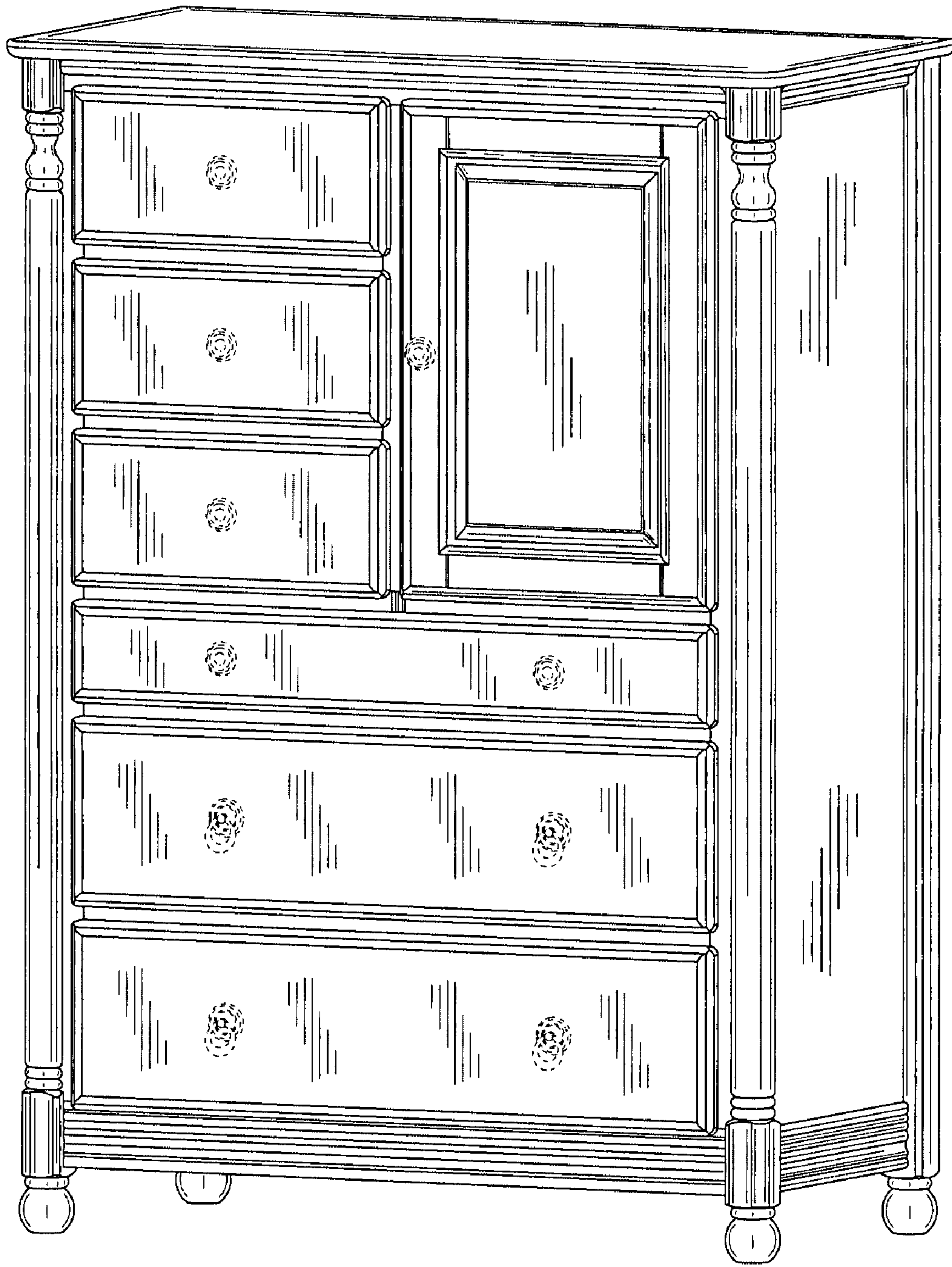

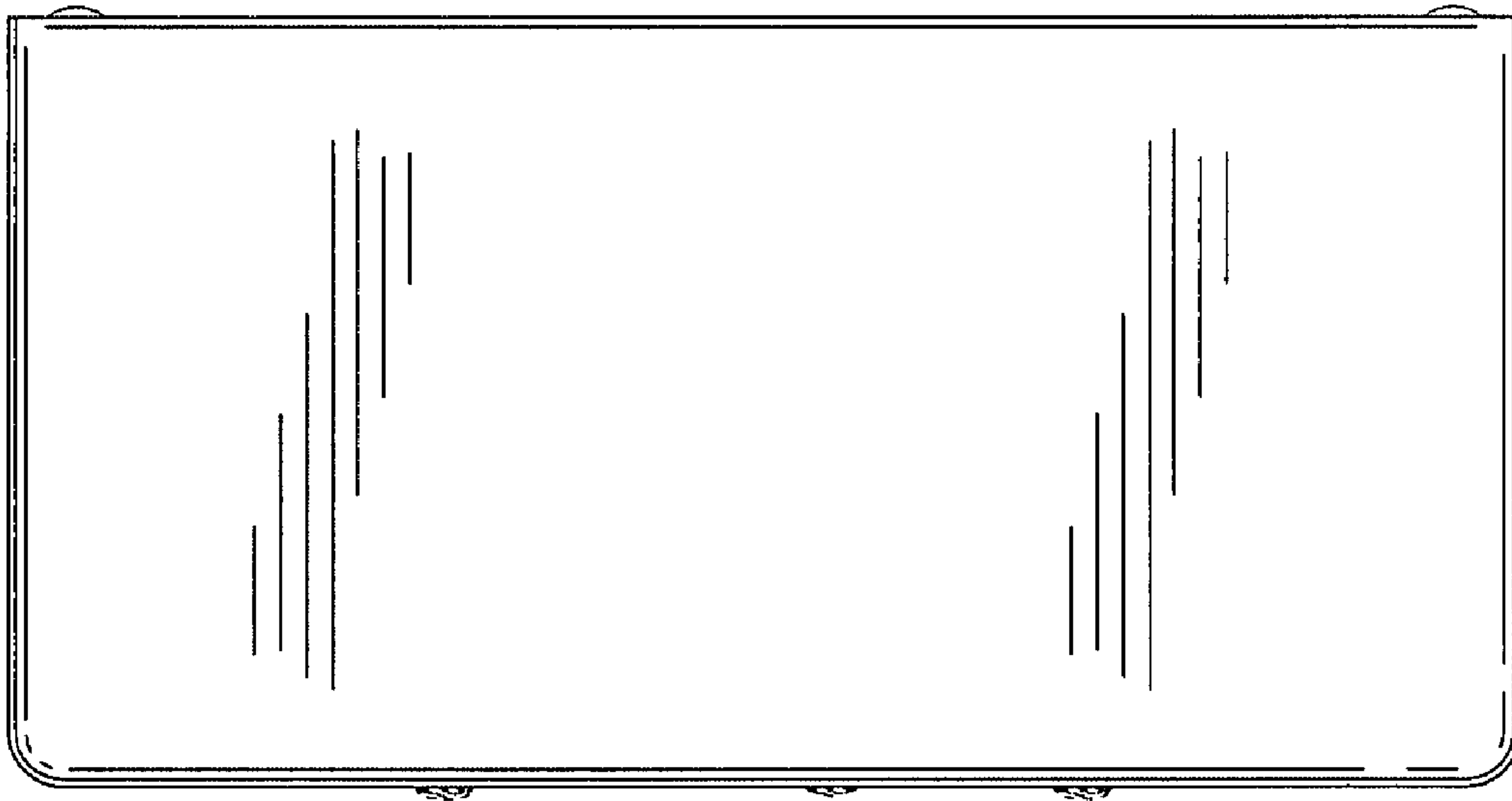

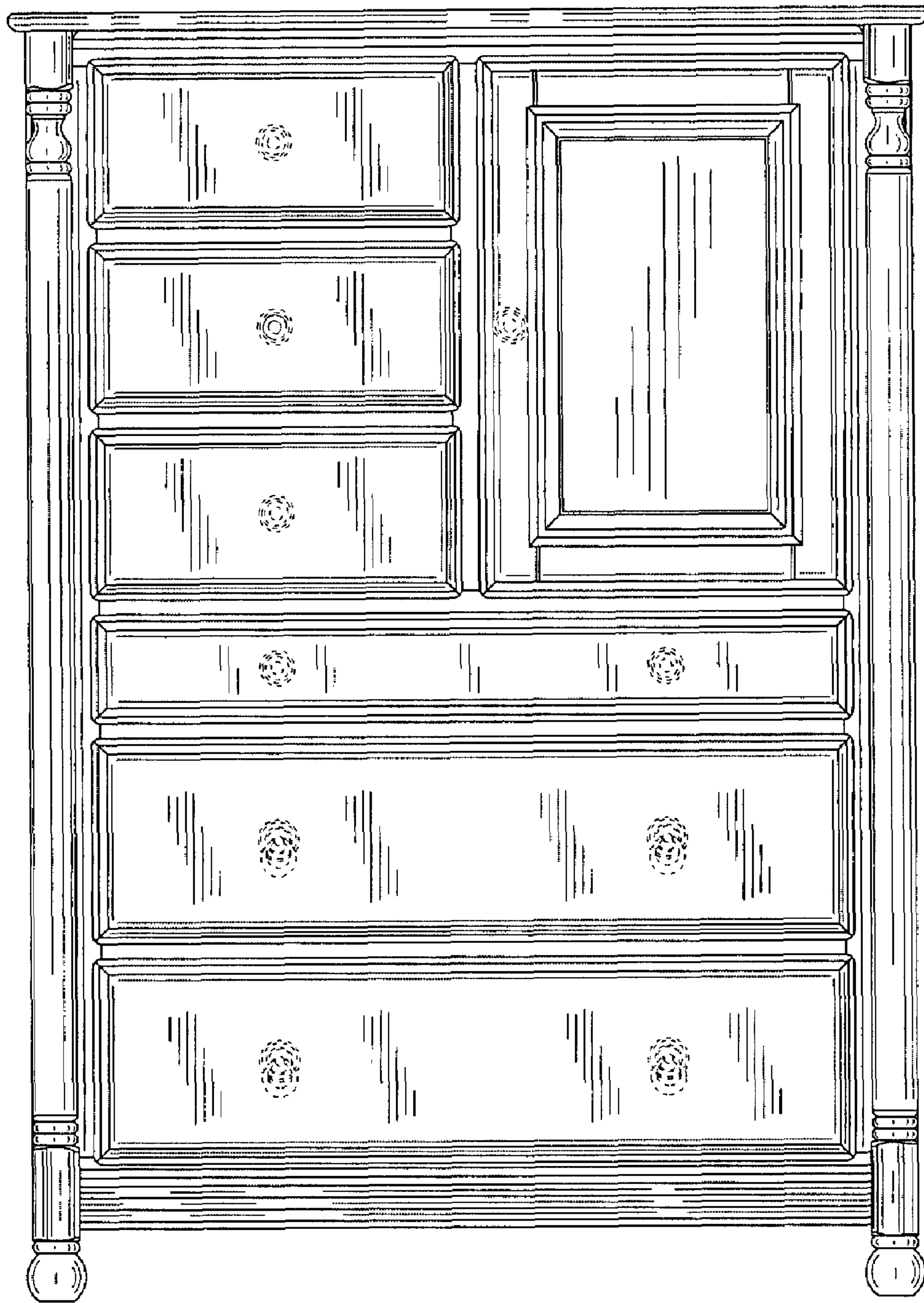

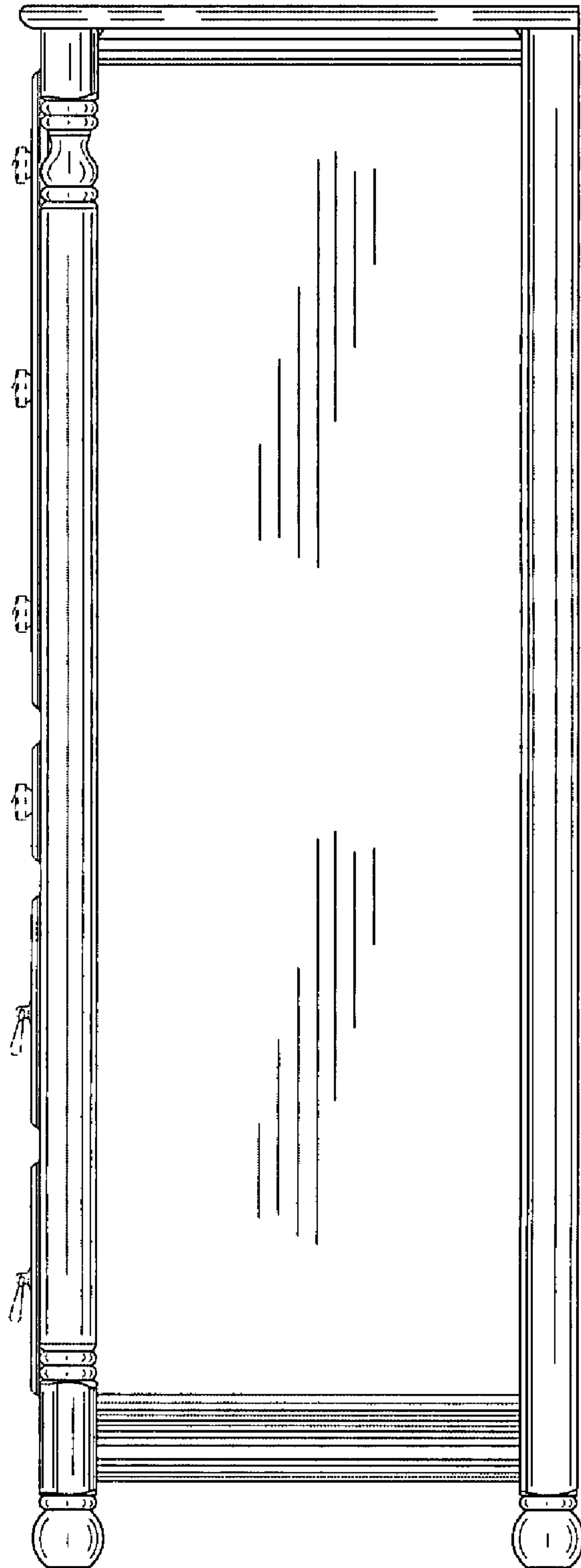
