FIG. 3 is a rear view of the present invention cooking device shown in FIG. 1 above;

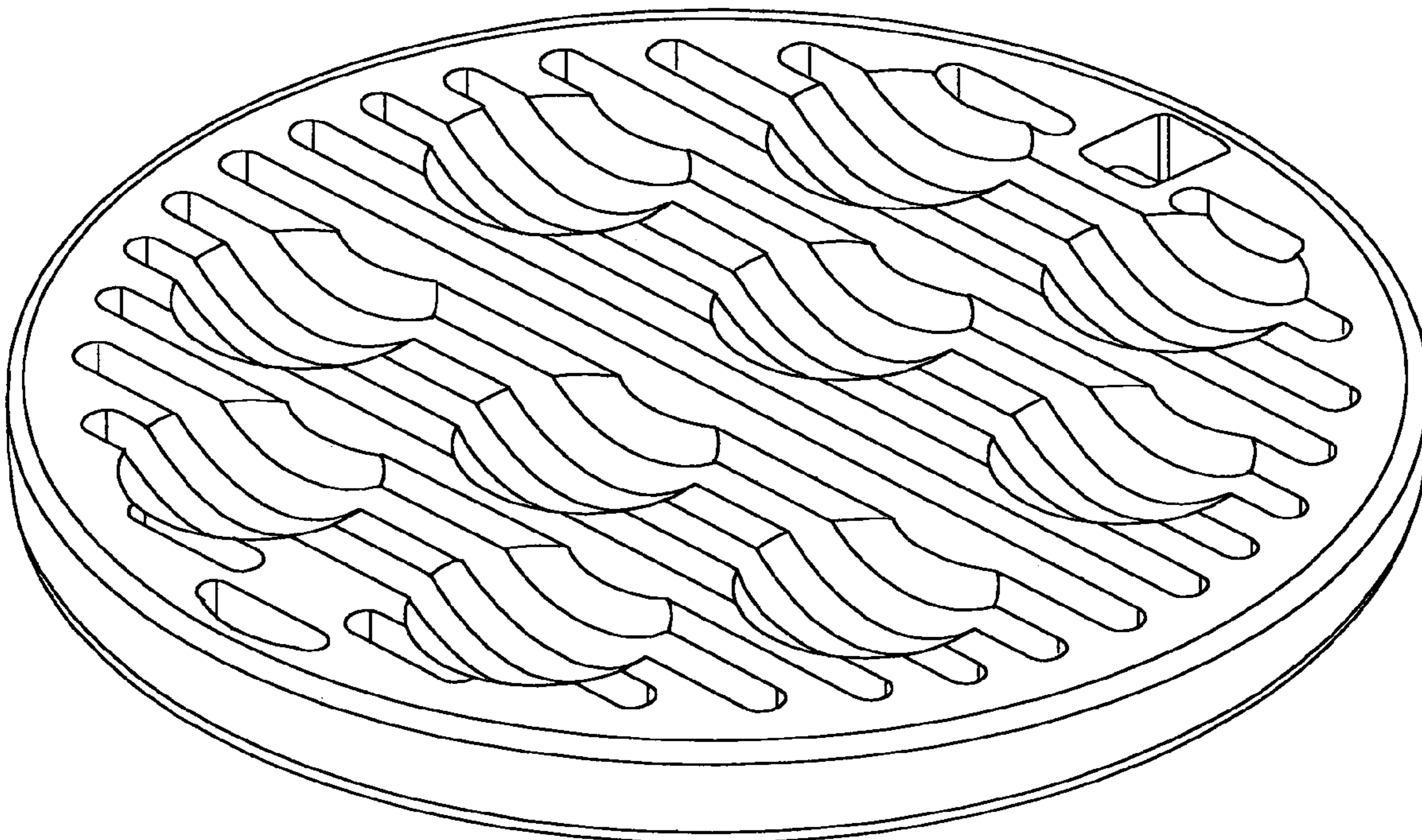
FIG. 4 is a right side view of the present invention cooking device shown in FIG. 1 above;

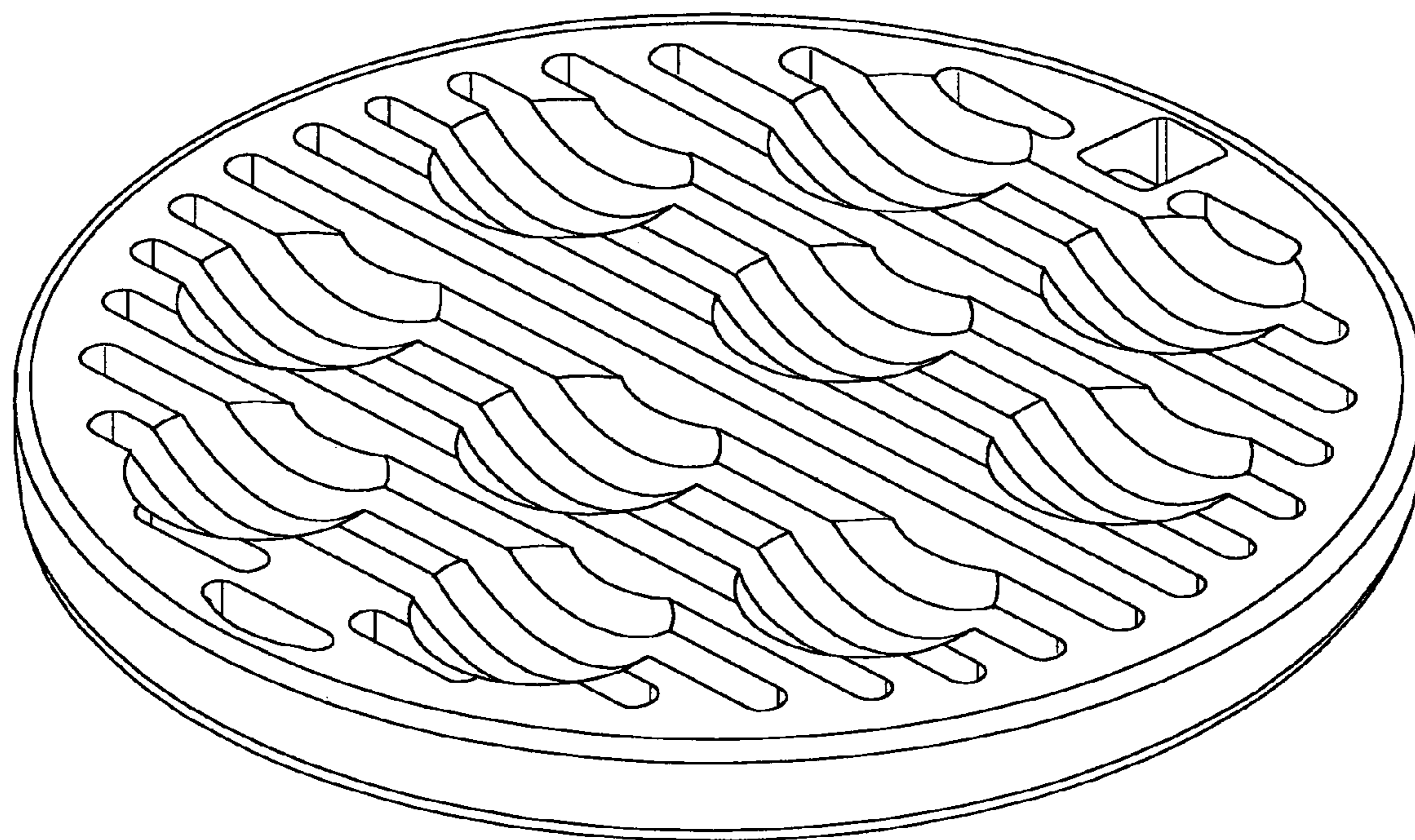
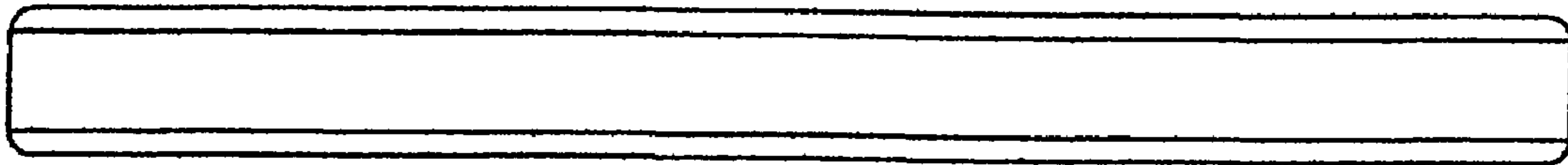
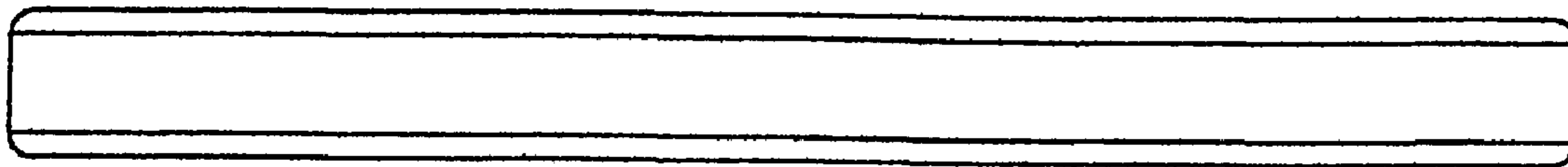


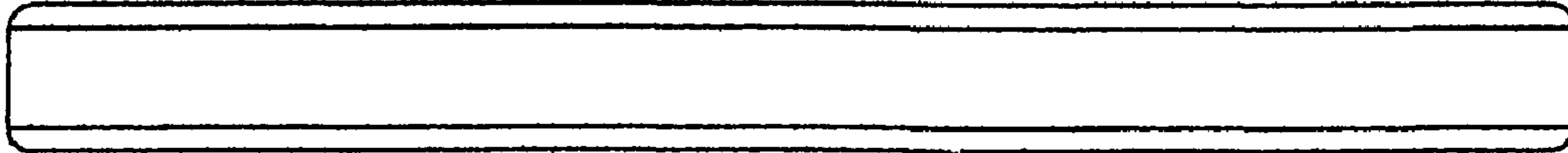

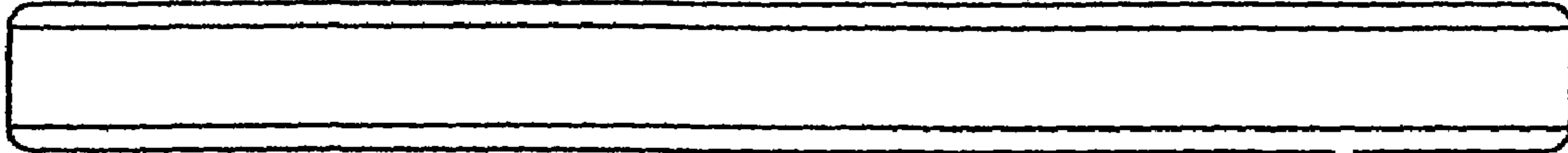

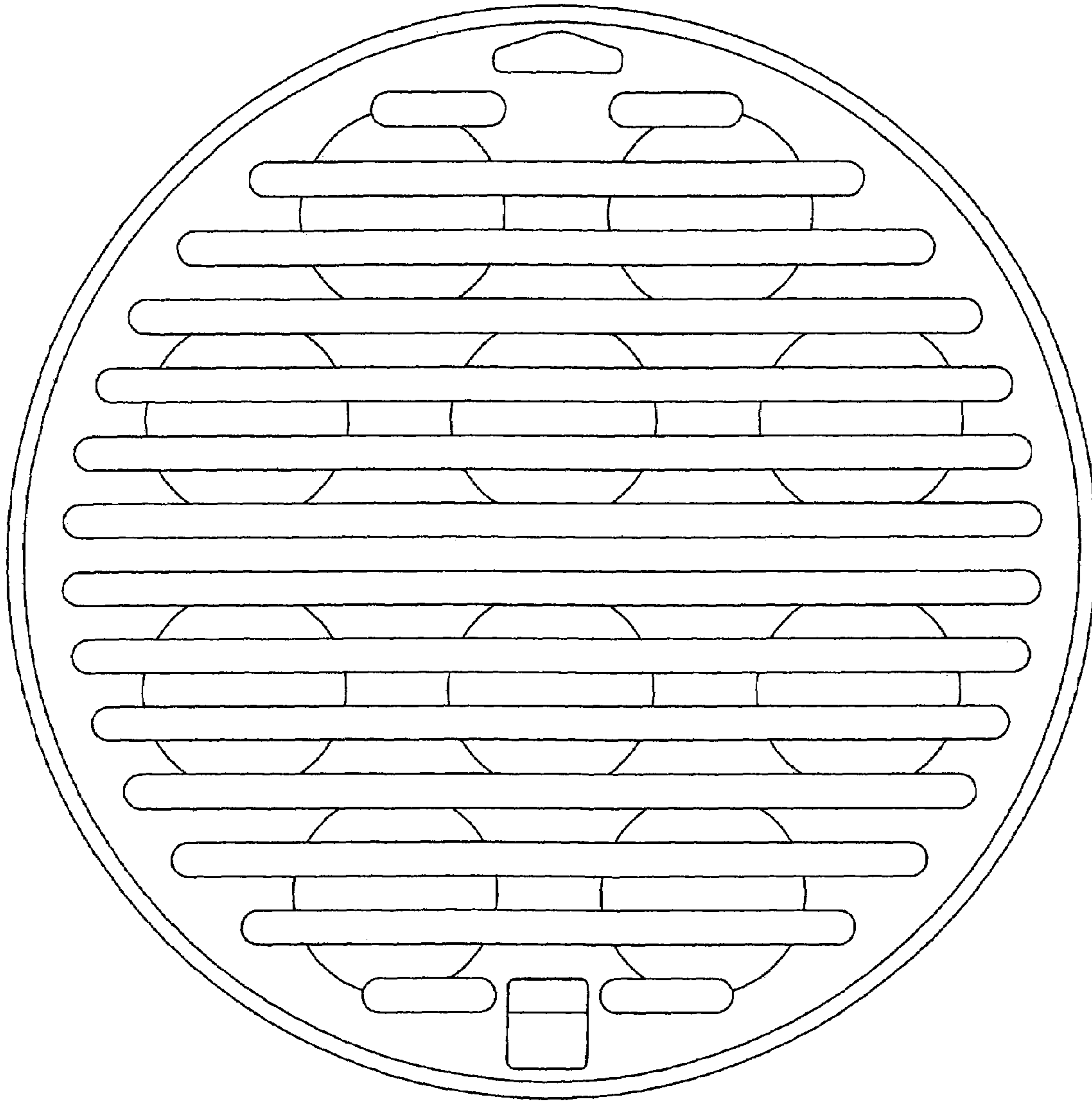

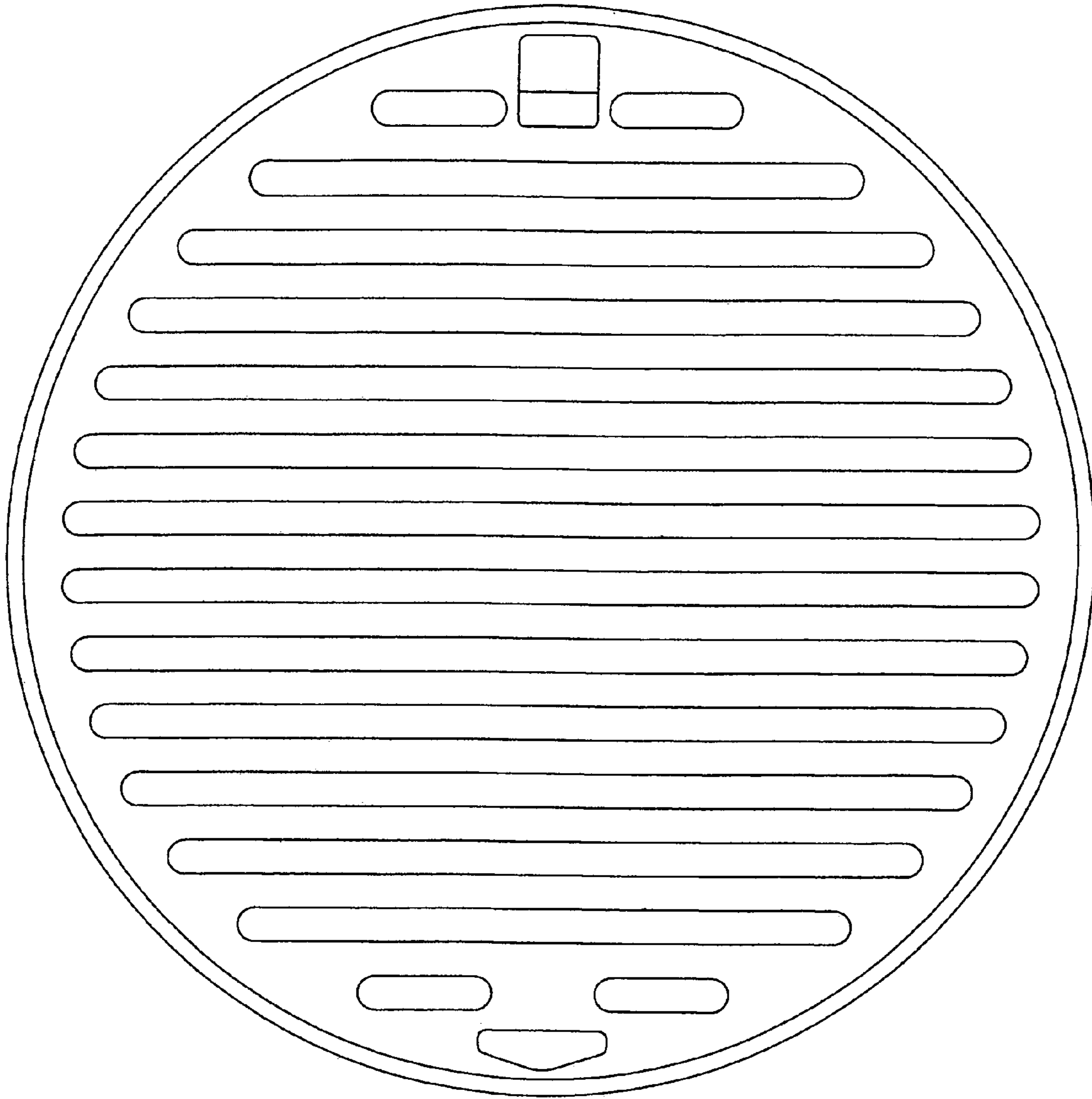
