FIG. 1 is a top view of a fork according to my new and ornamental design,

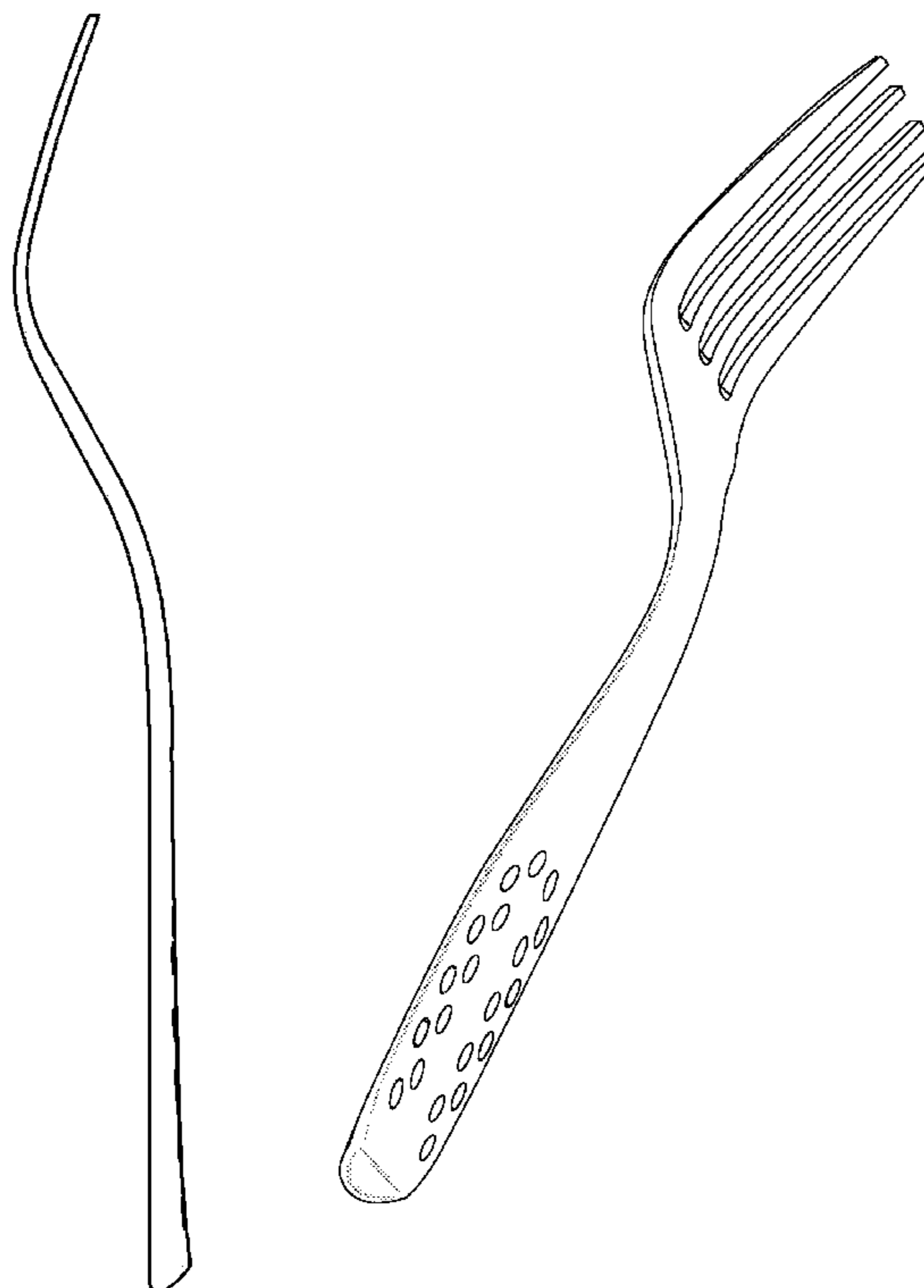
FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image,

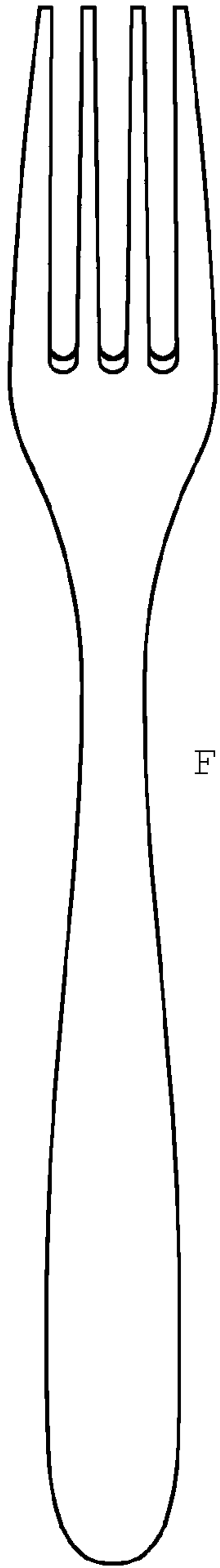

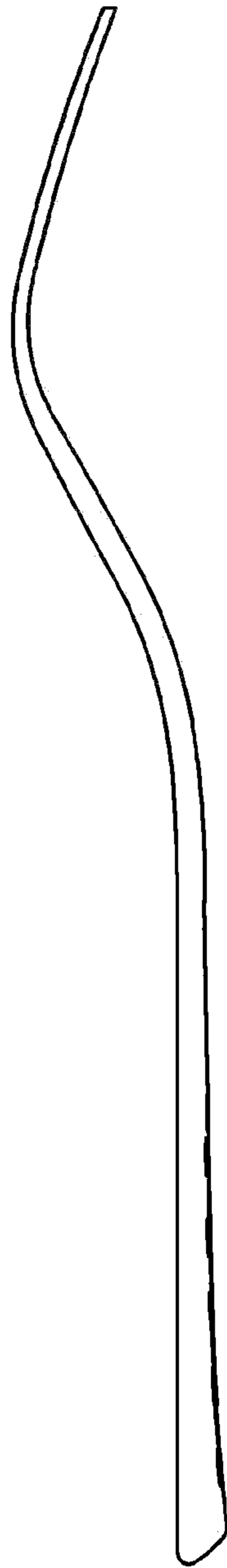

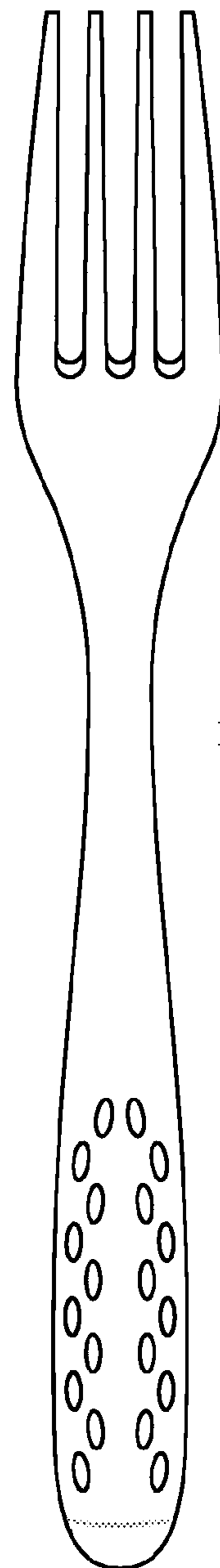

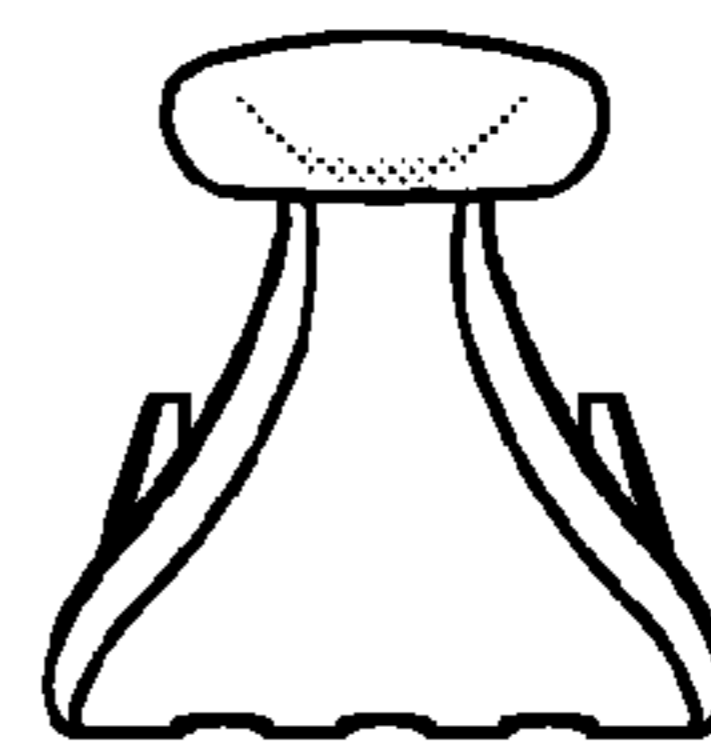

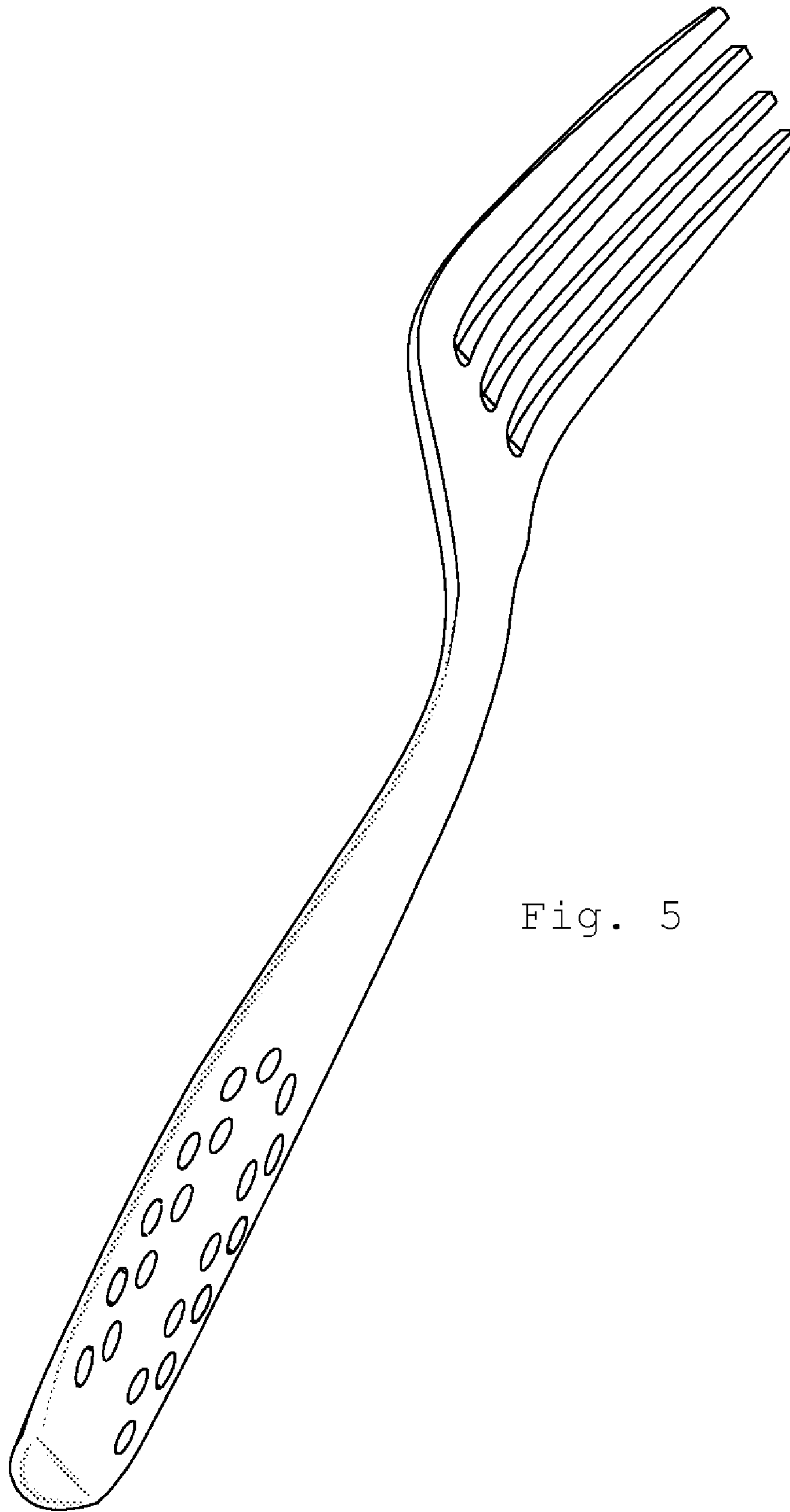
