The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a first embodiment of a bottle, showing my new design;

FIG. 2 is a right side elevational view thereof, the left, front and back side elevational views being identical;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a top, front, and right side perspective view of a second embodiment of a bottle, showing my new design; and

FIG. 6 is a right side elevational view thereof, the left, front and back side elevational views being identical;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

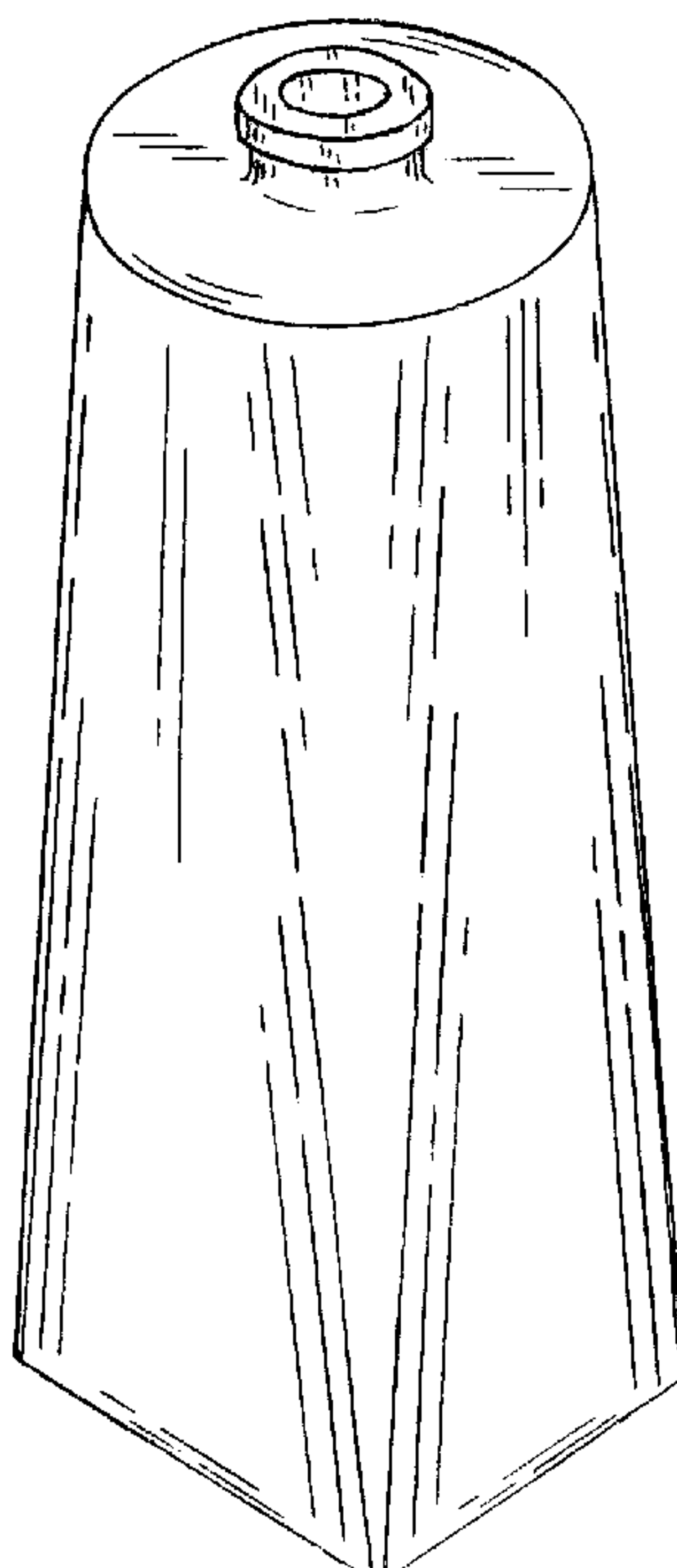

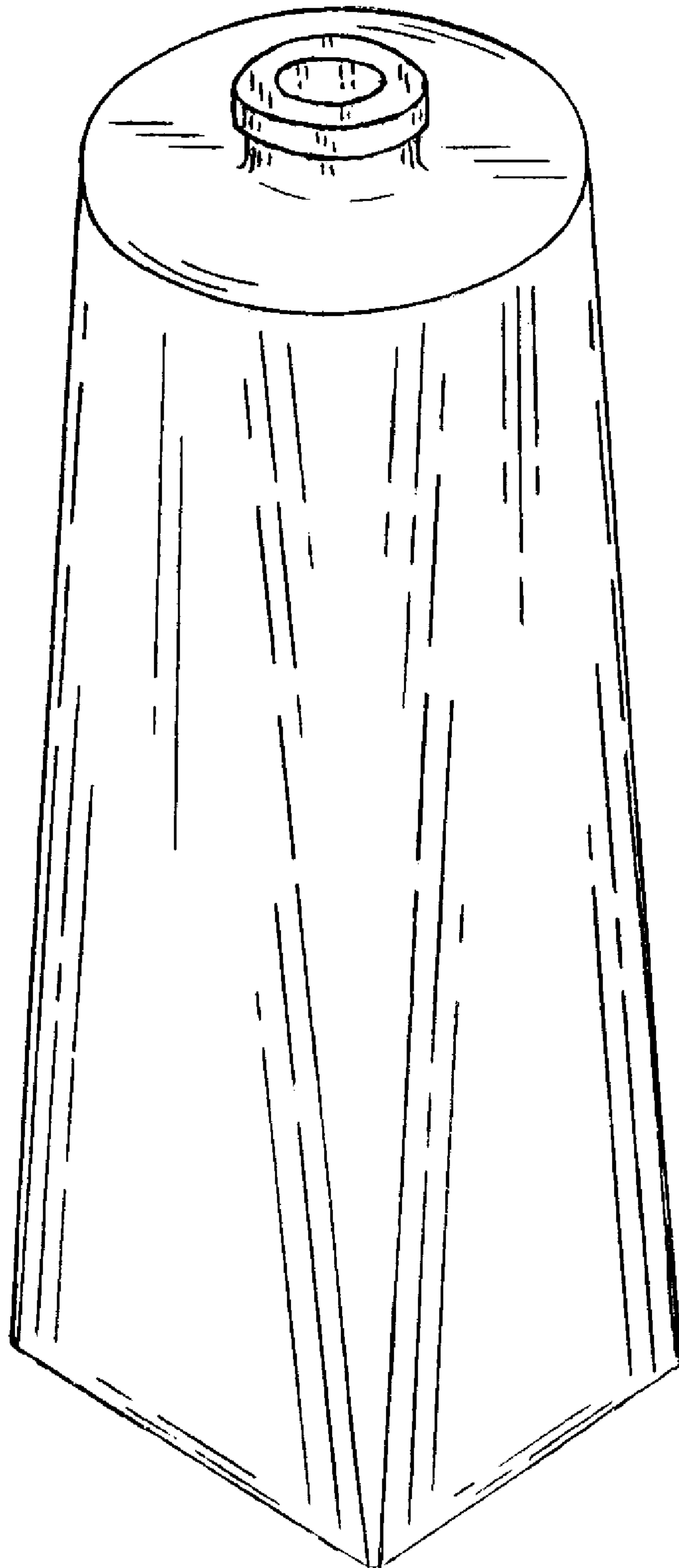

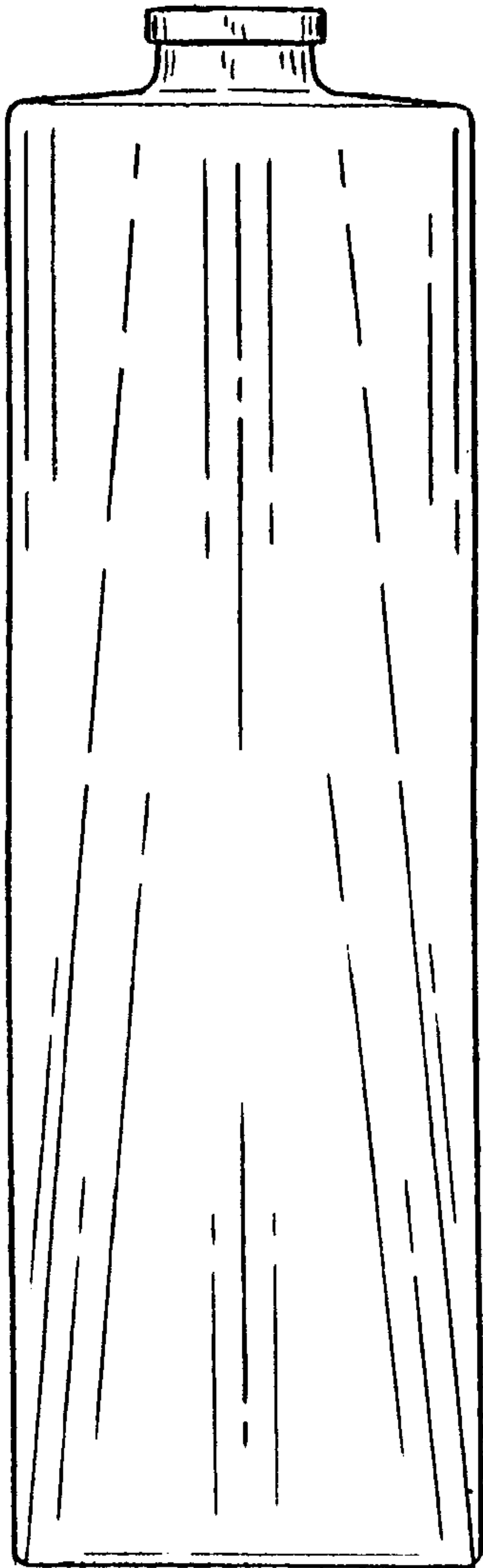

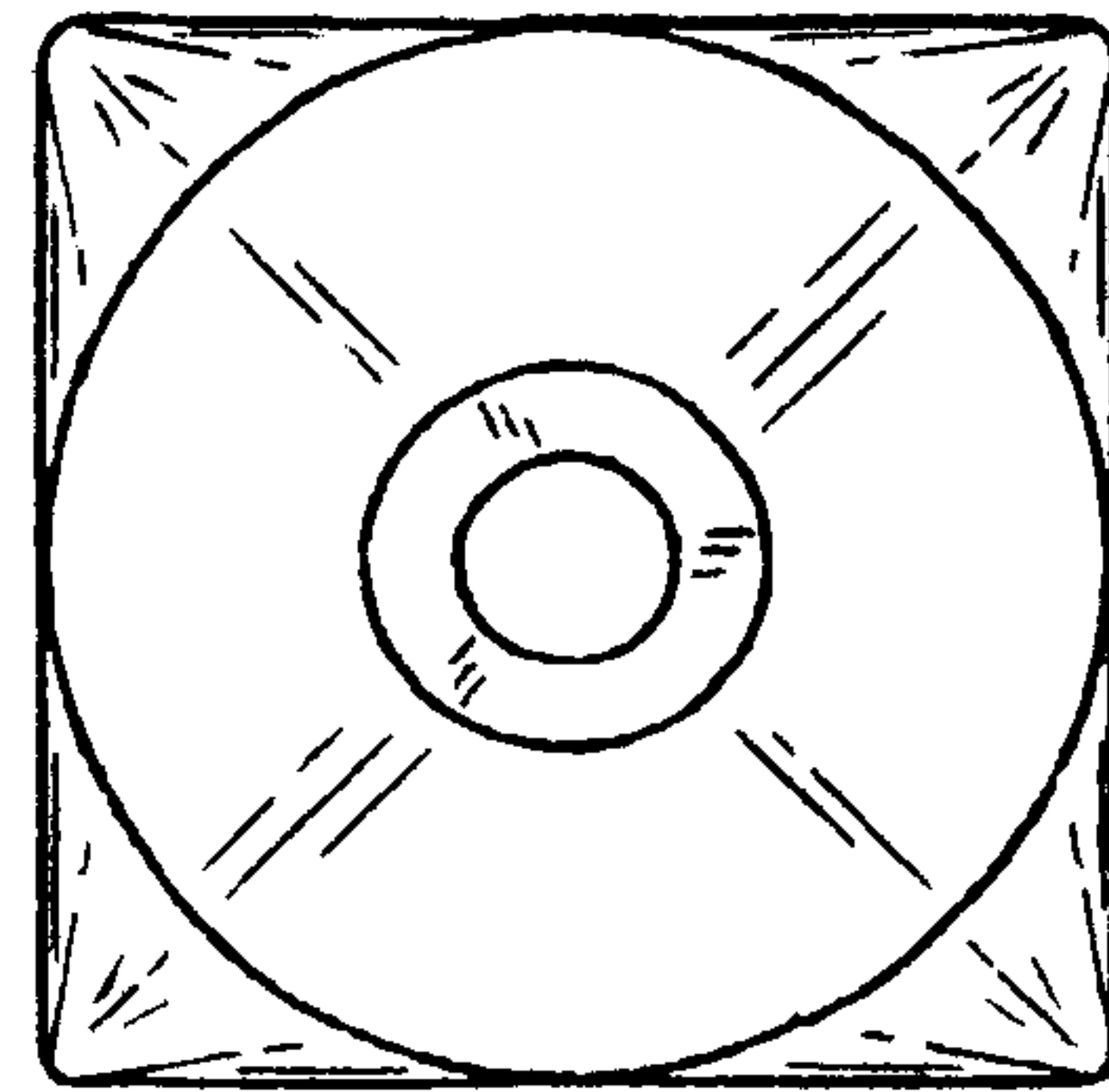

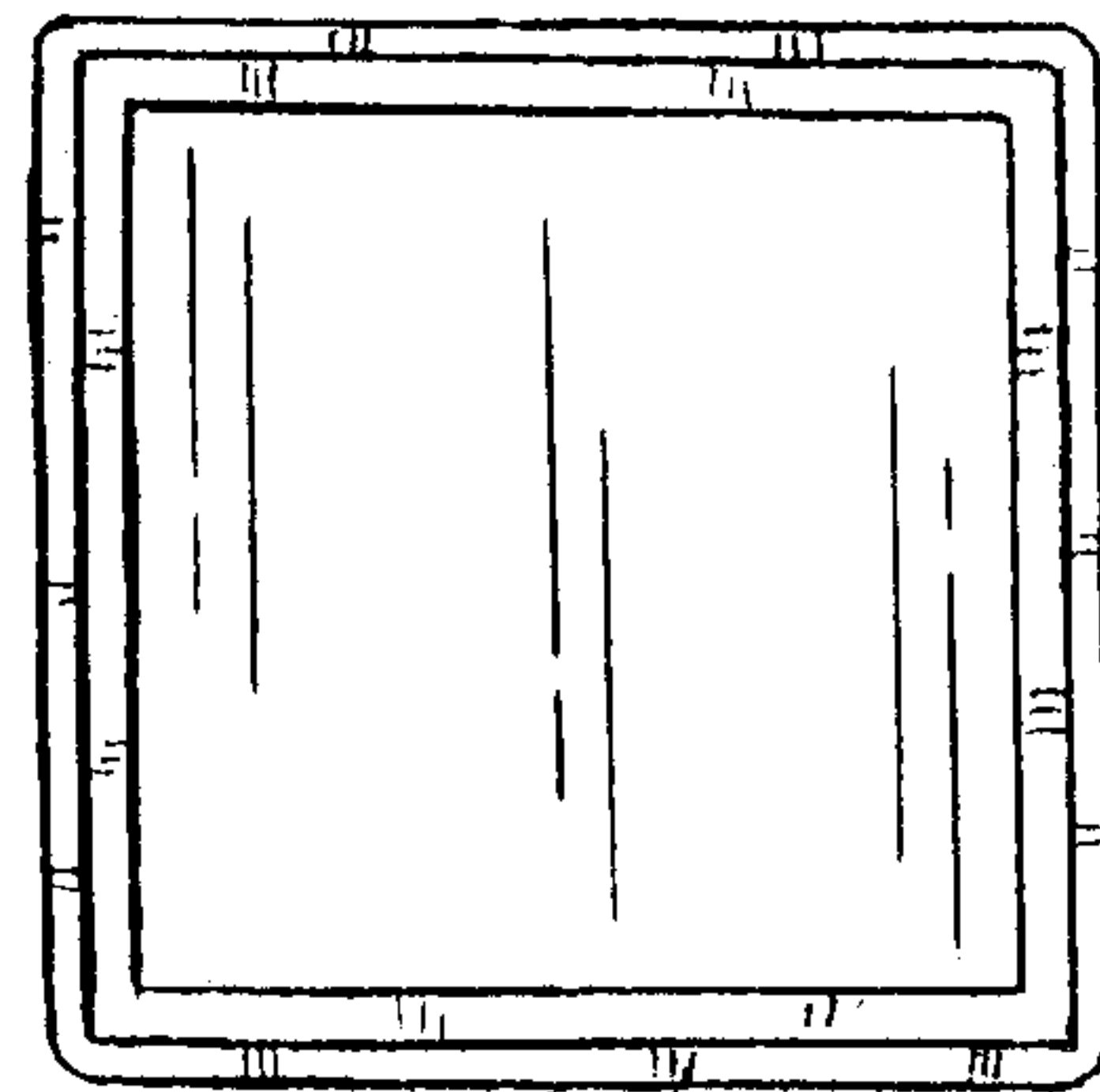

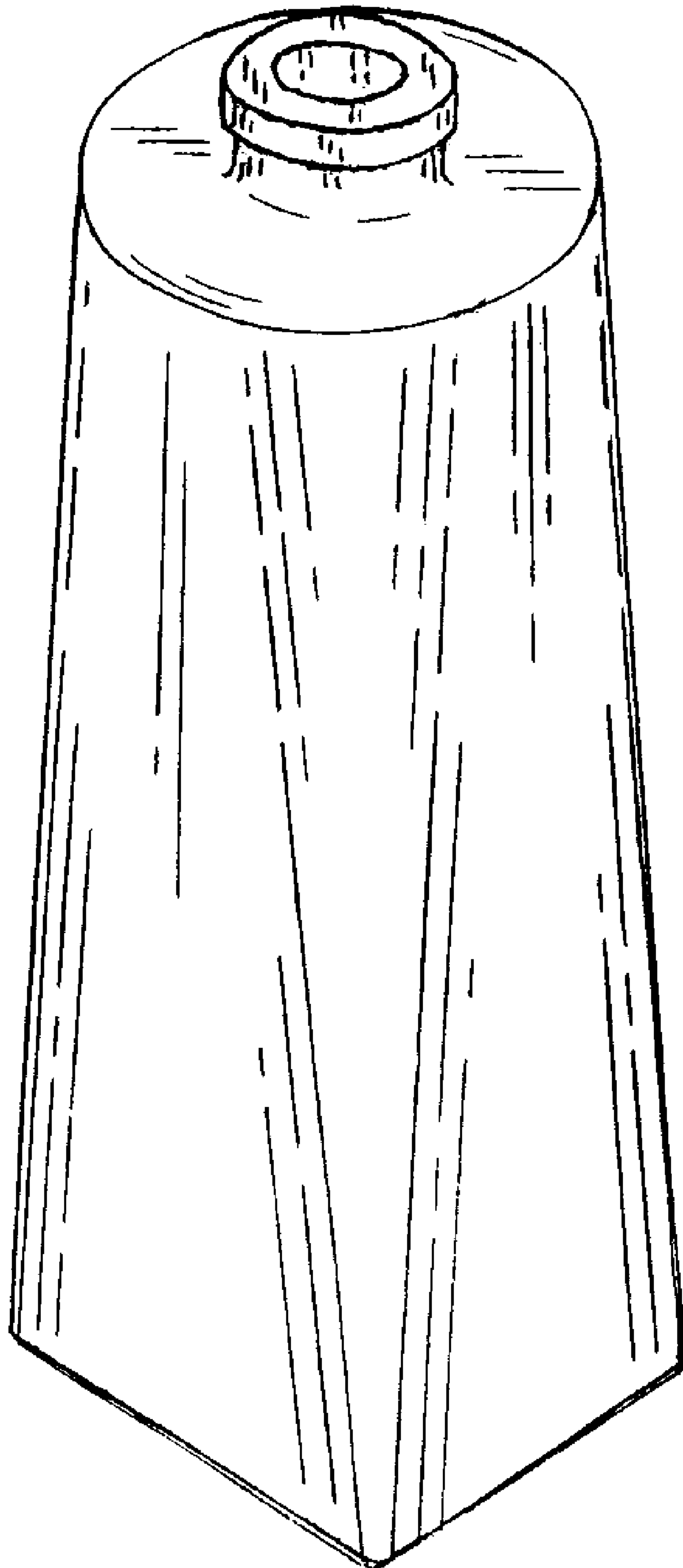

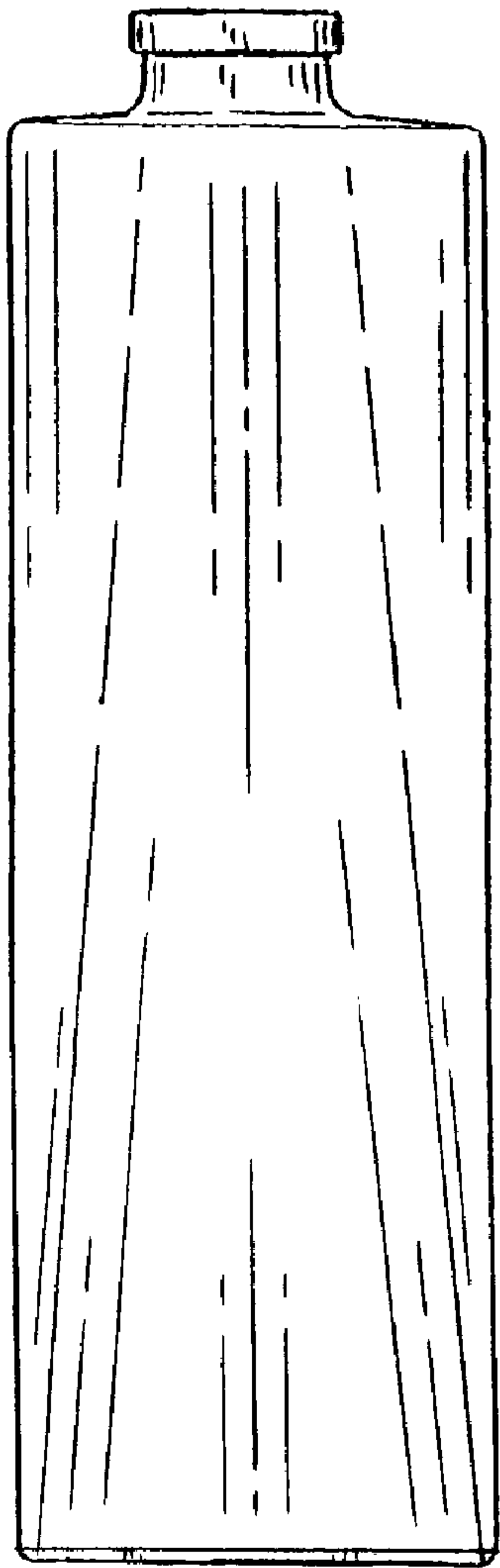

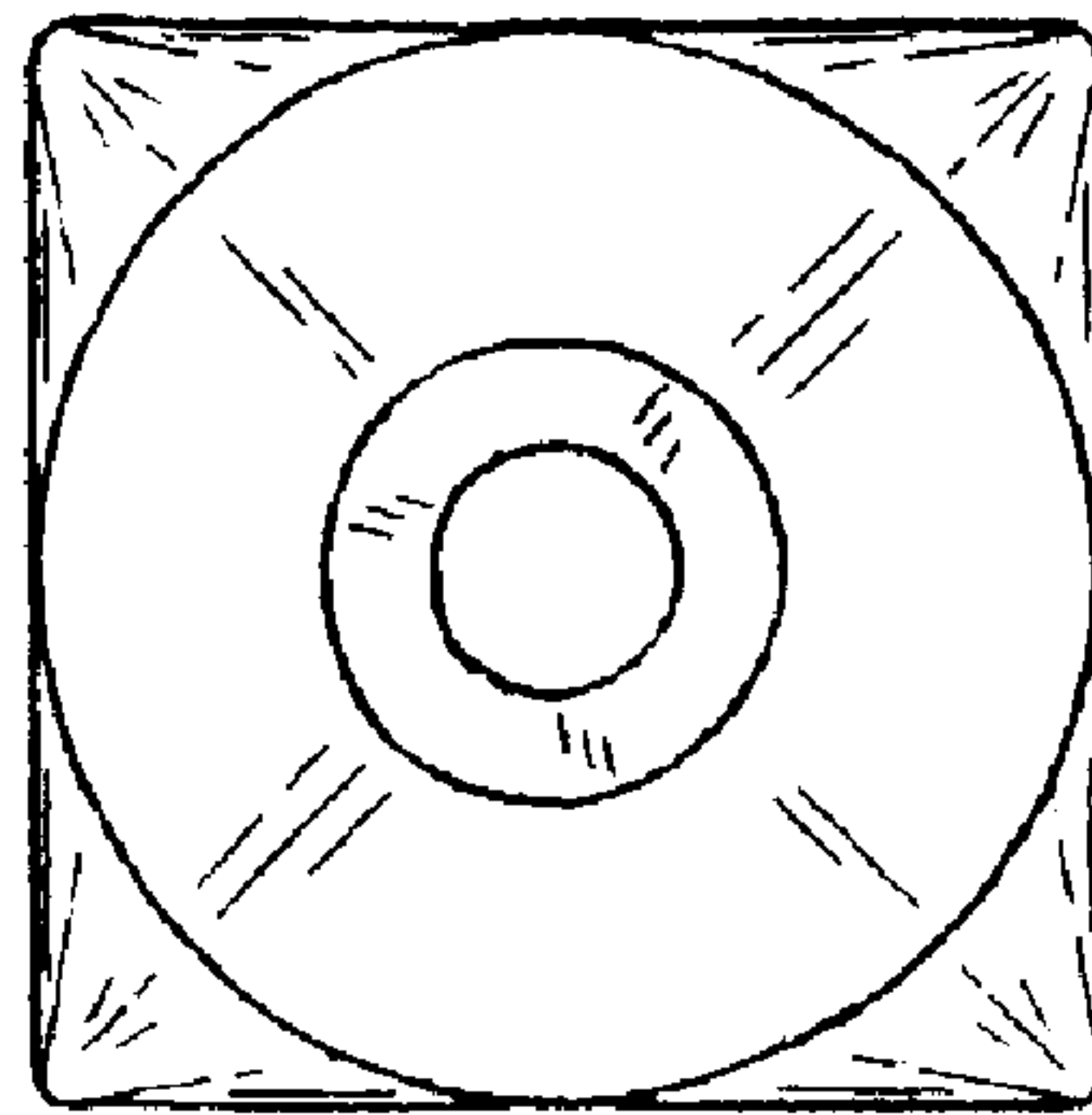
