The ornamental design for a gauge, as shown and described.

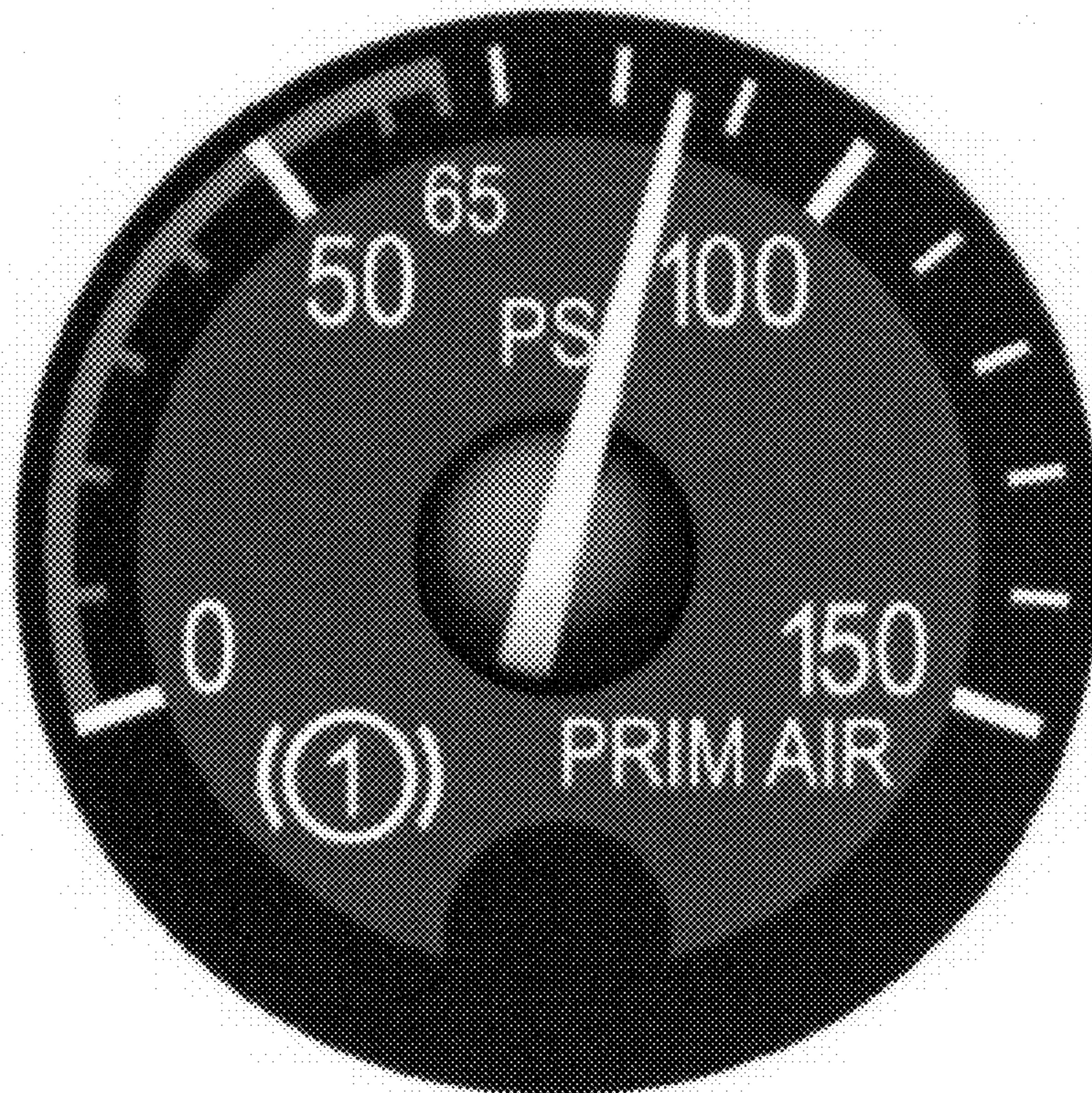
DESCRIPTION

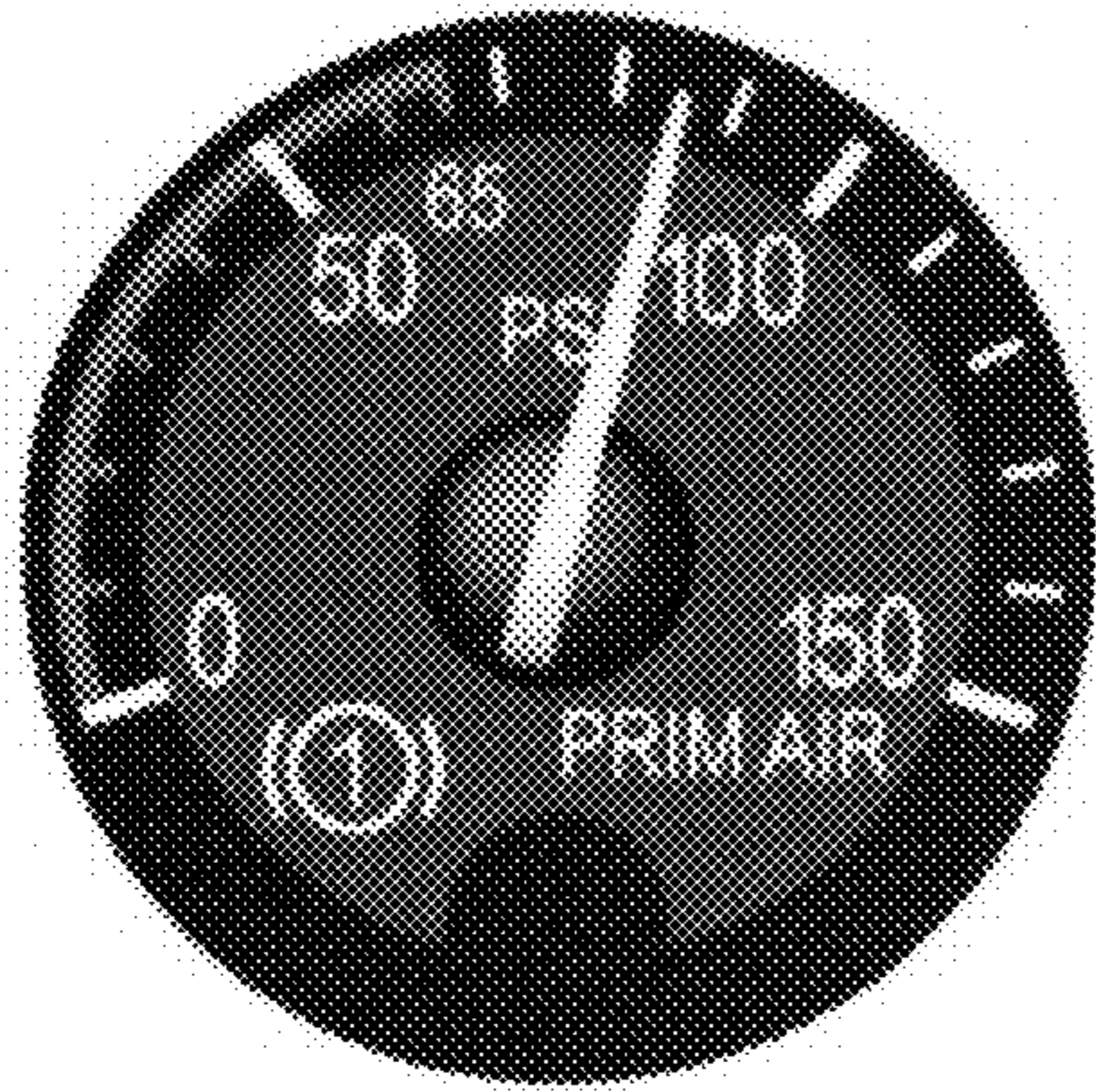

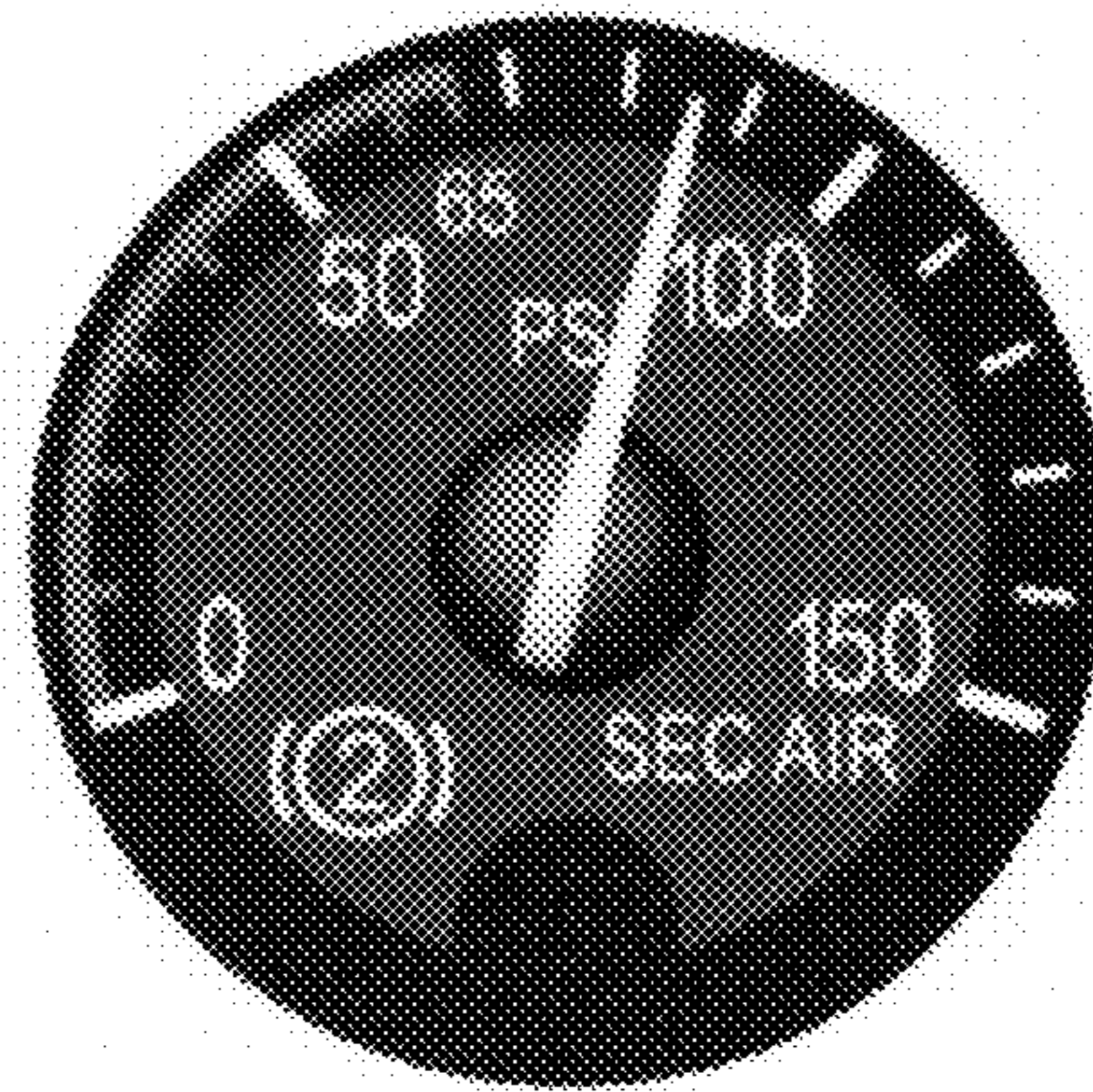

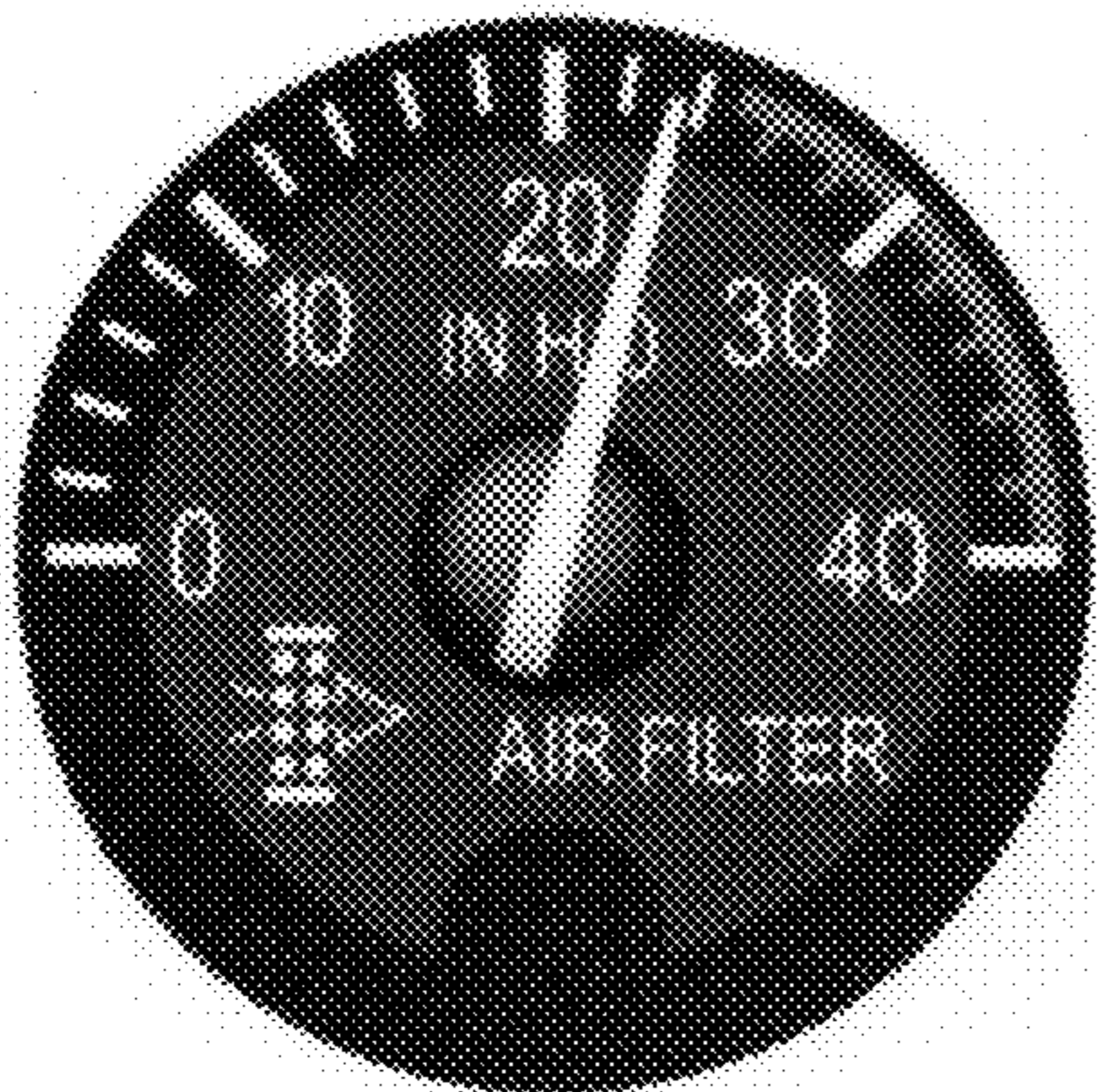

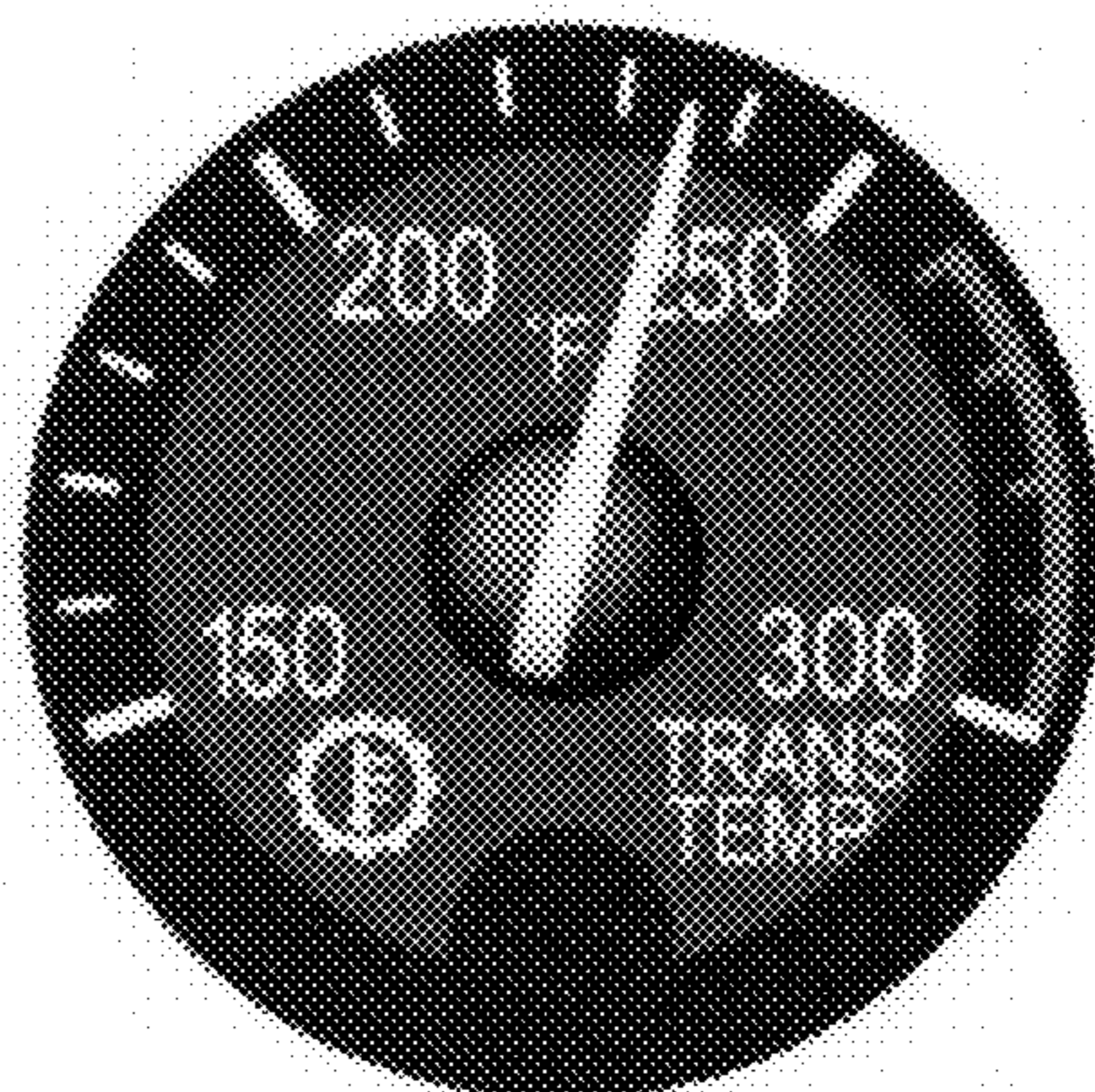

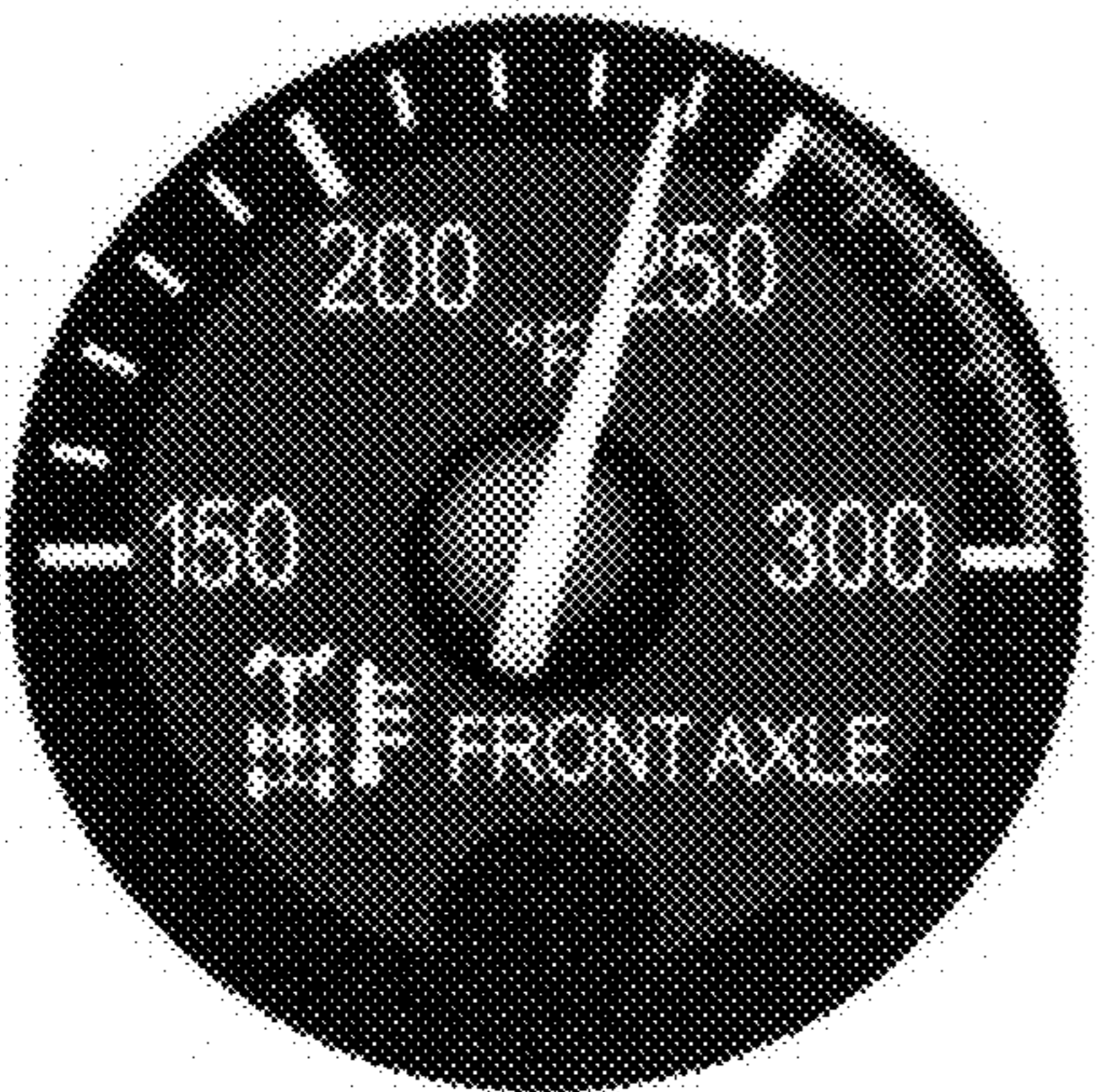

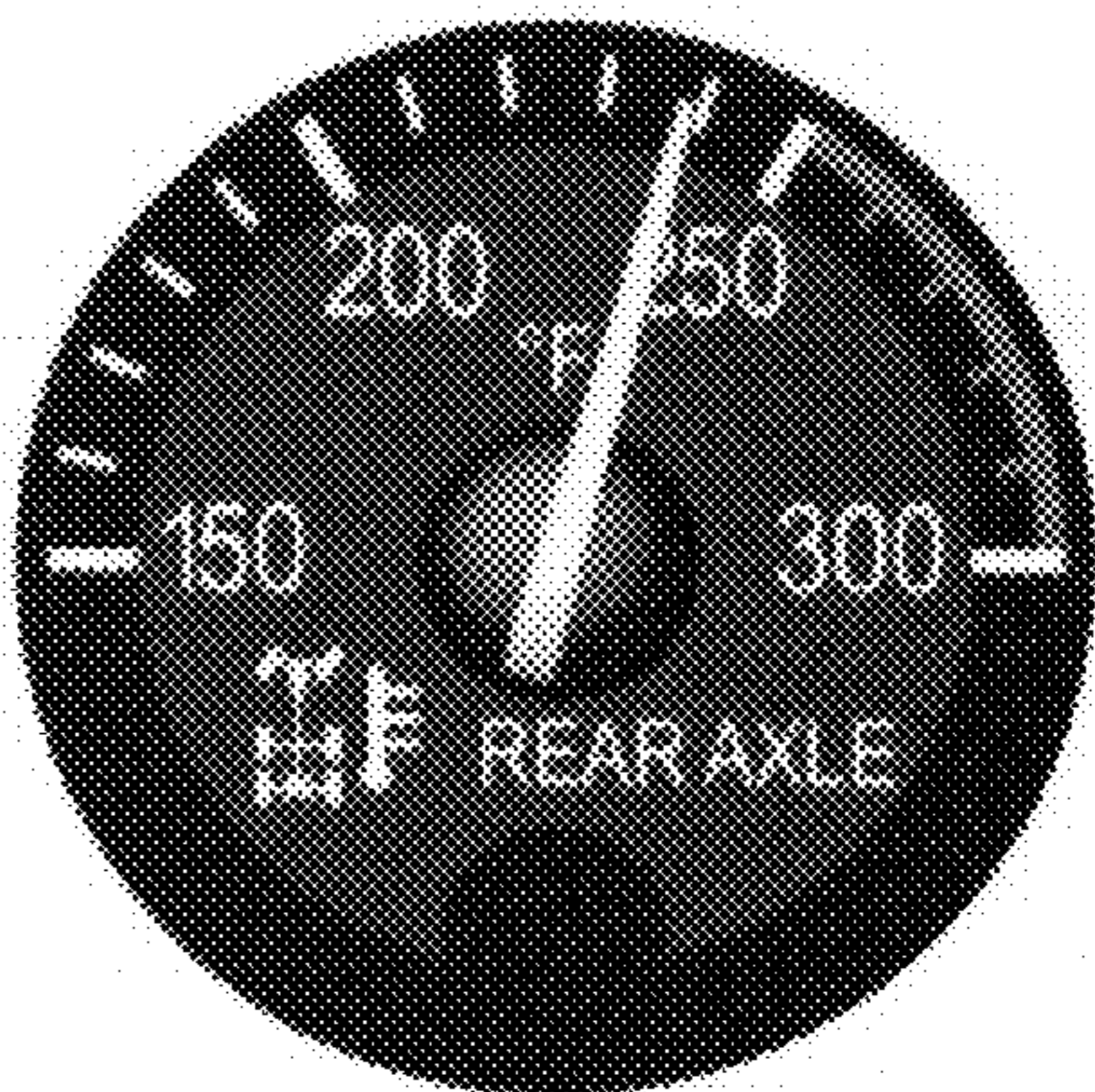

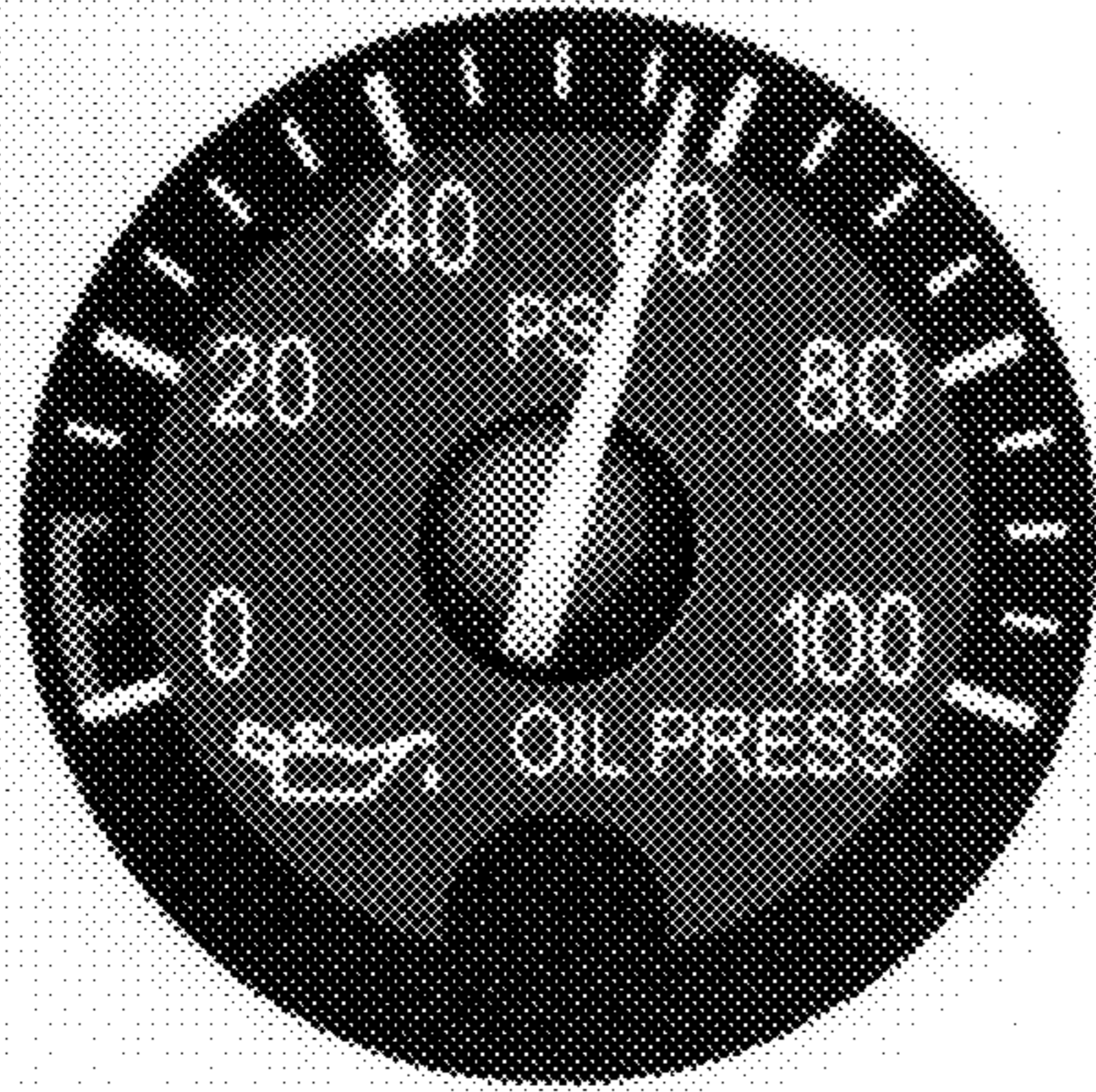

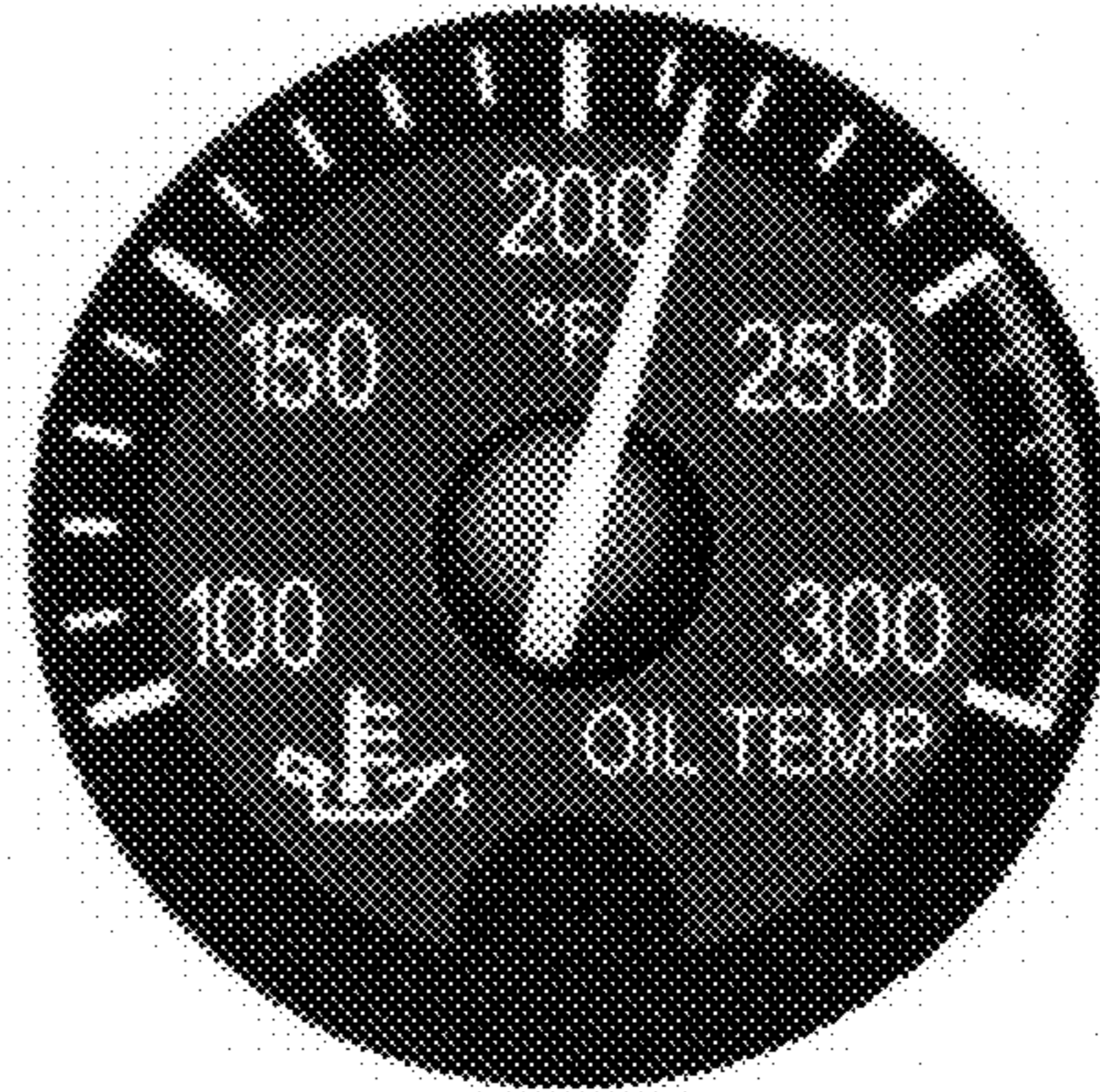

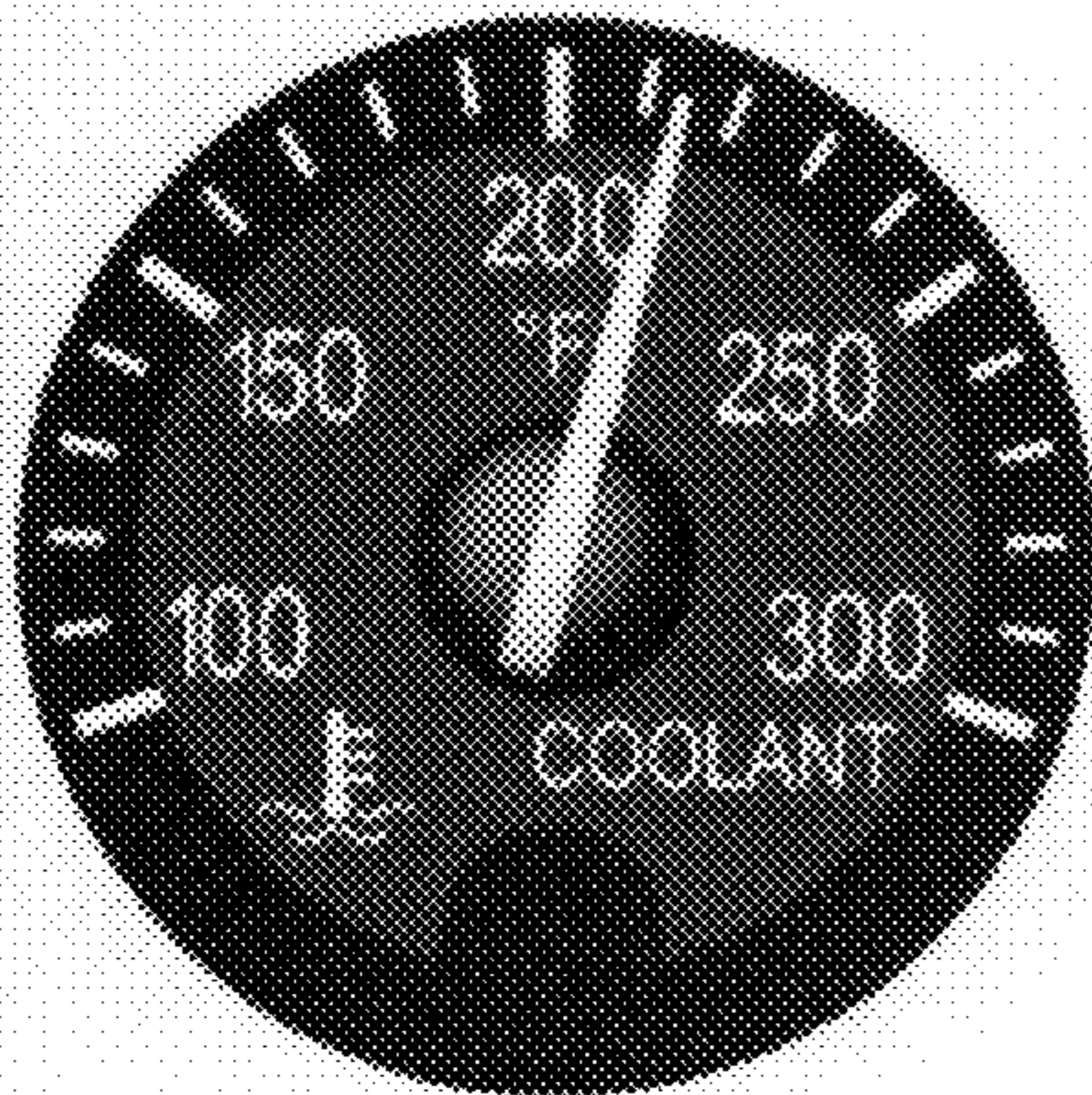

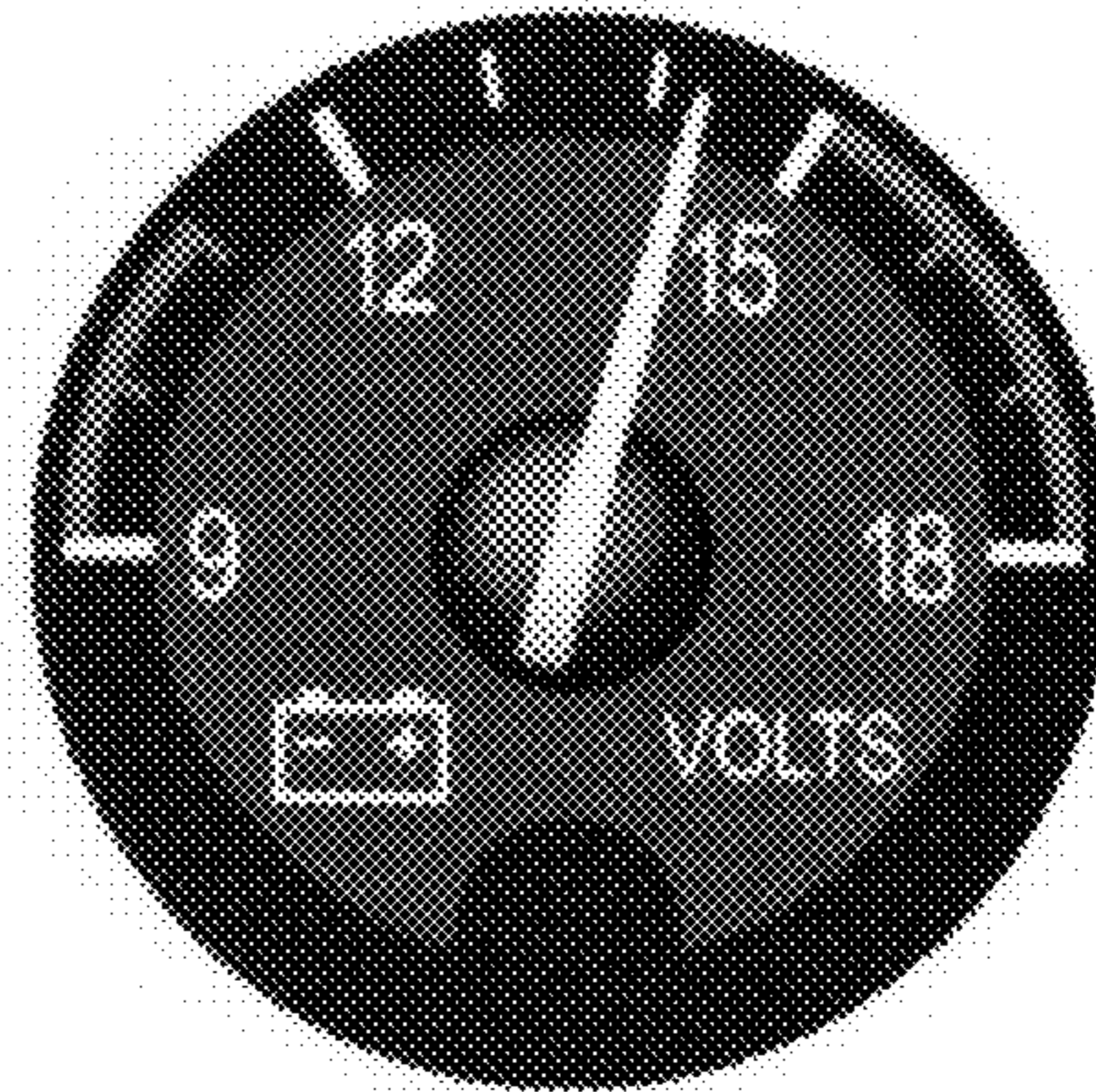

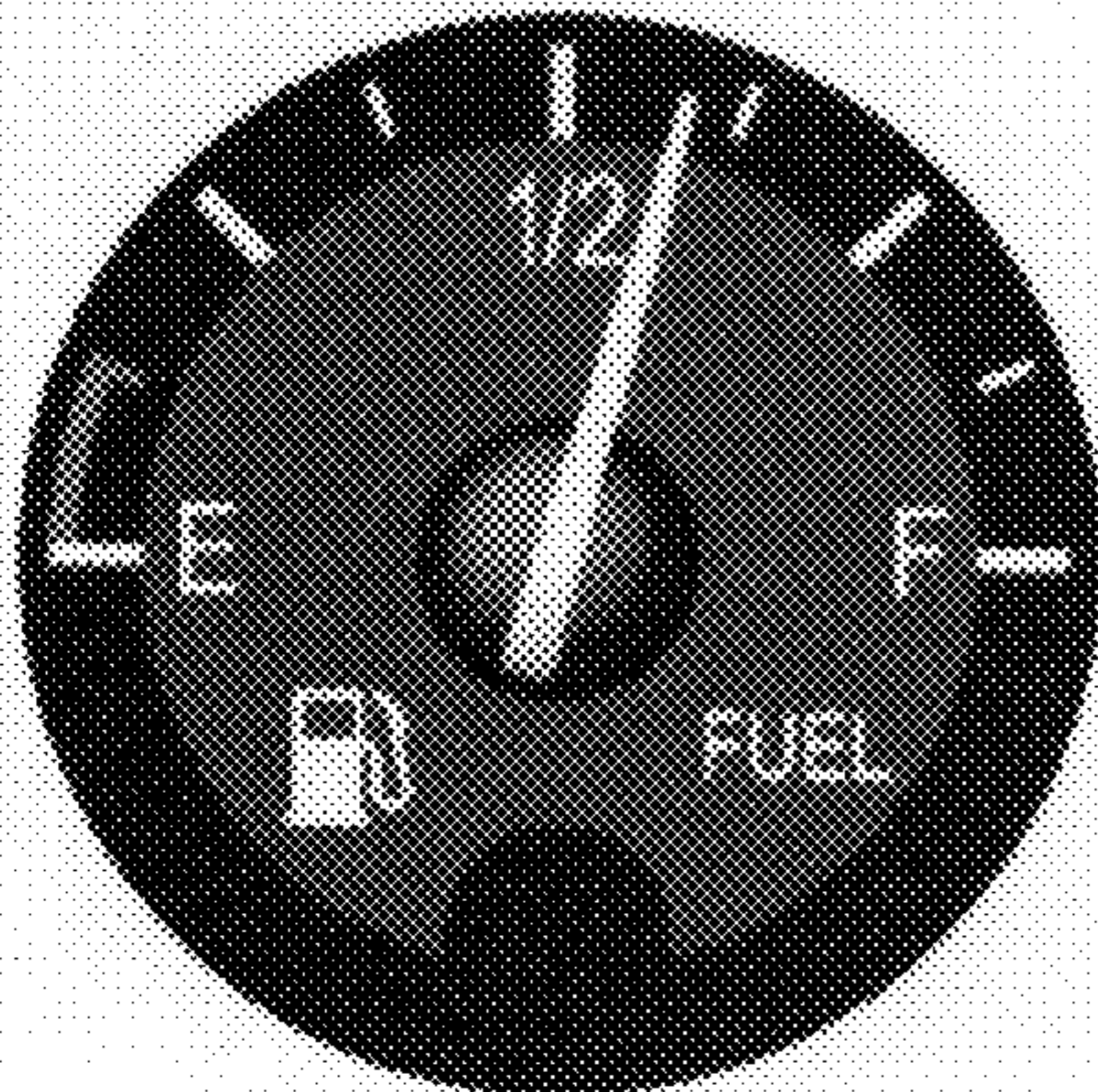

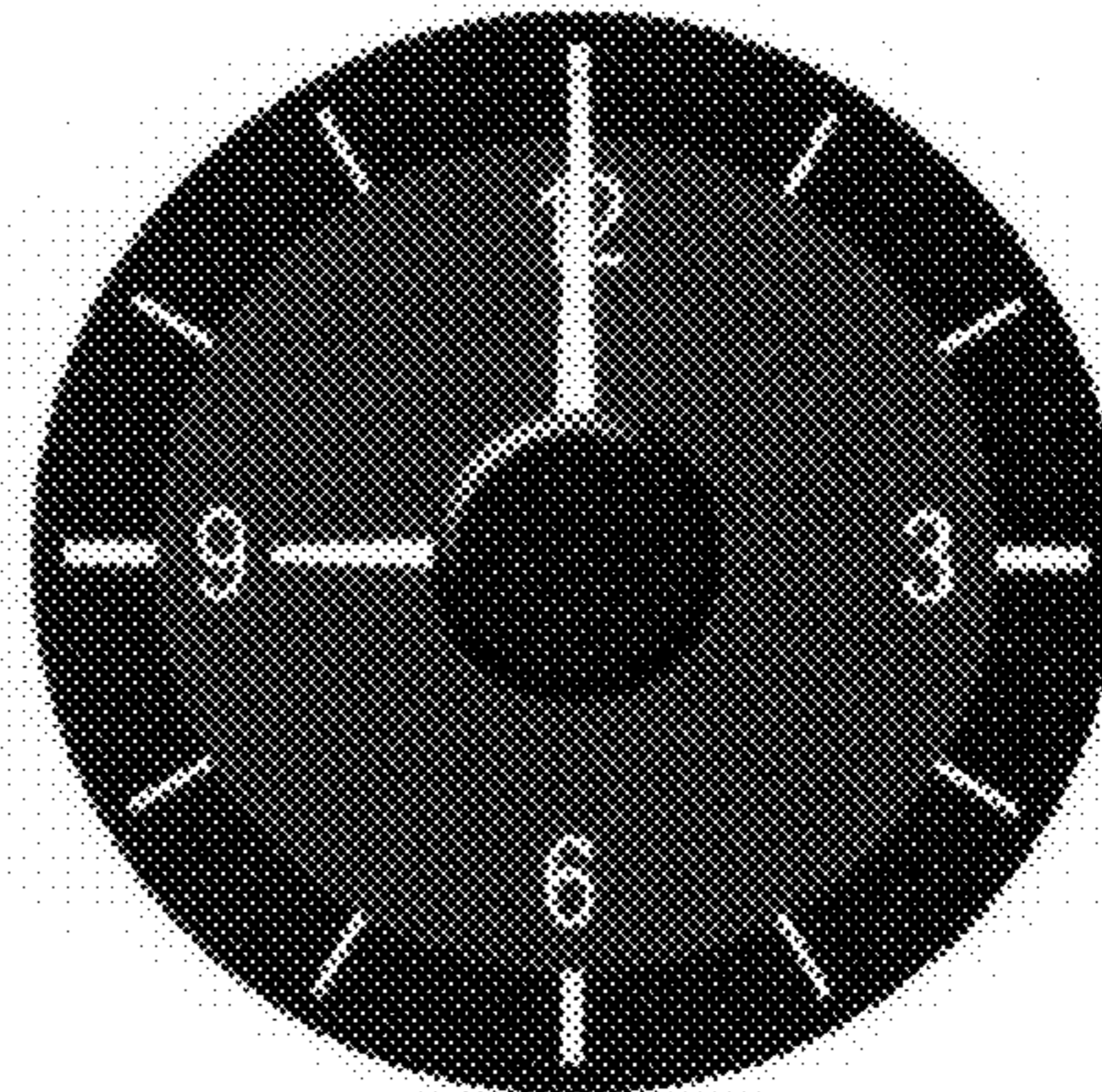

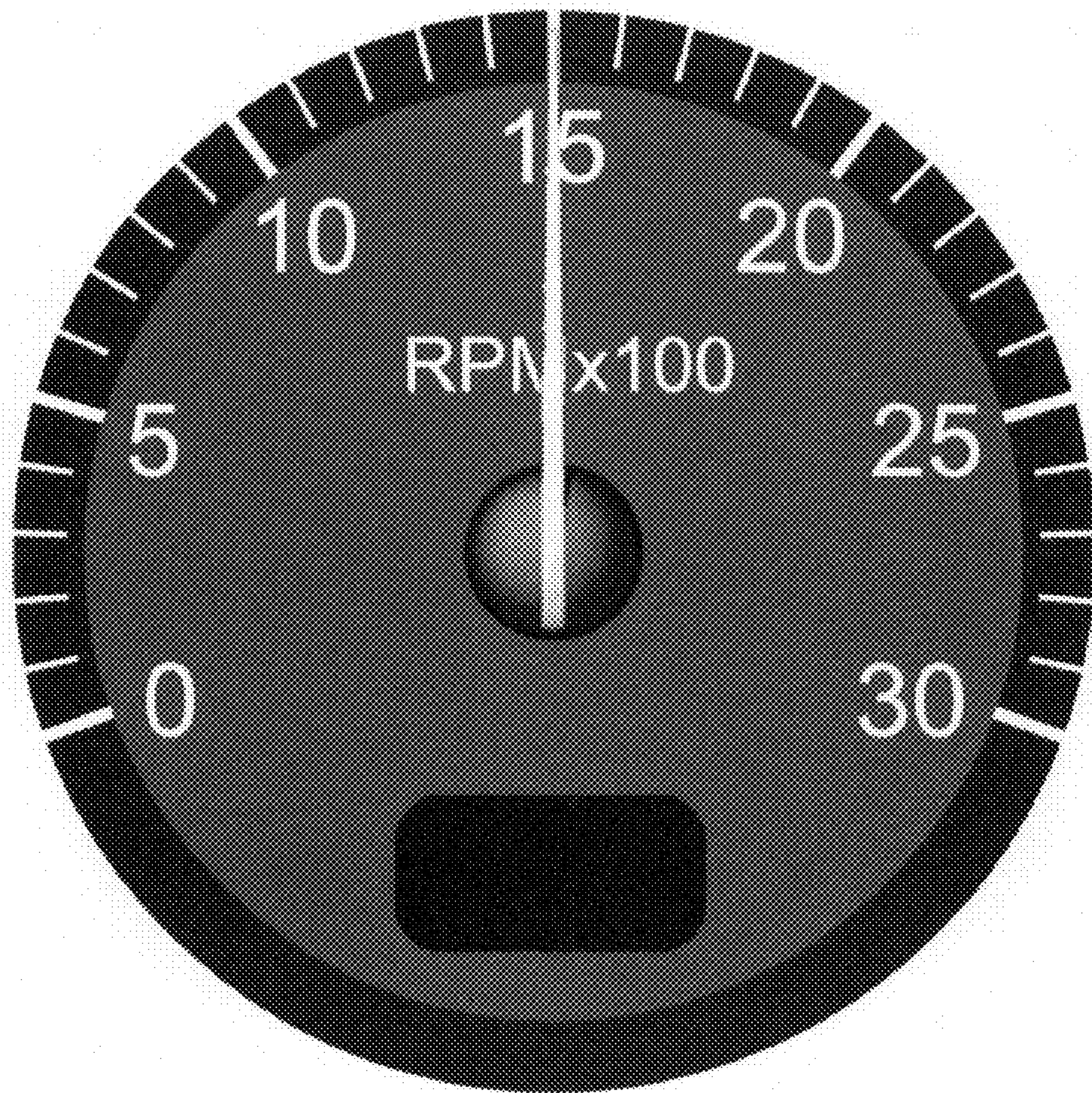

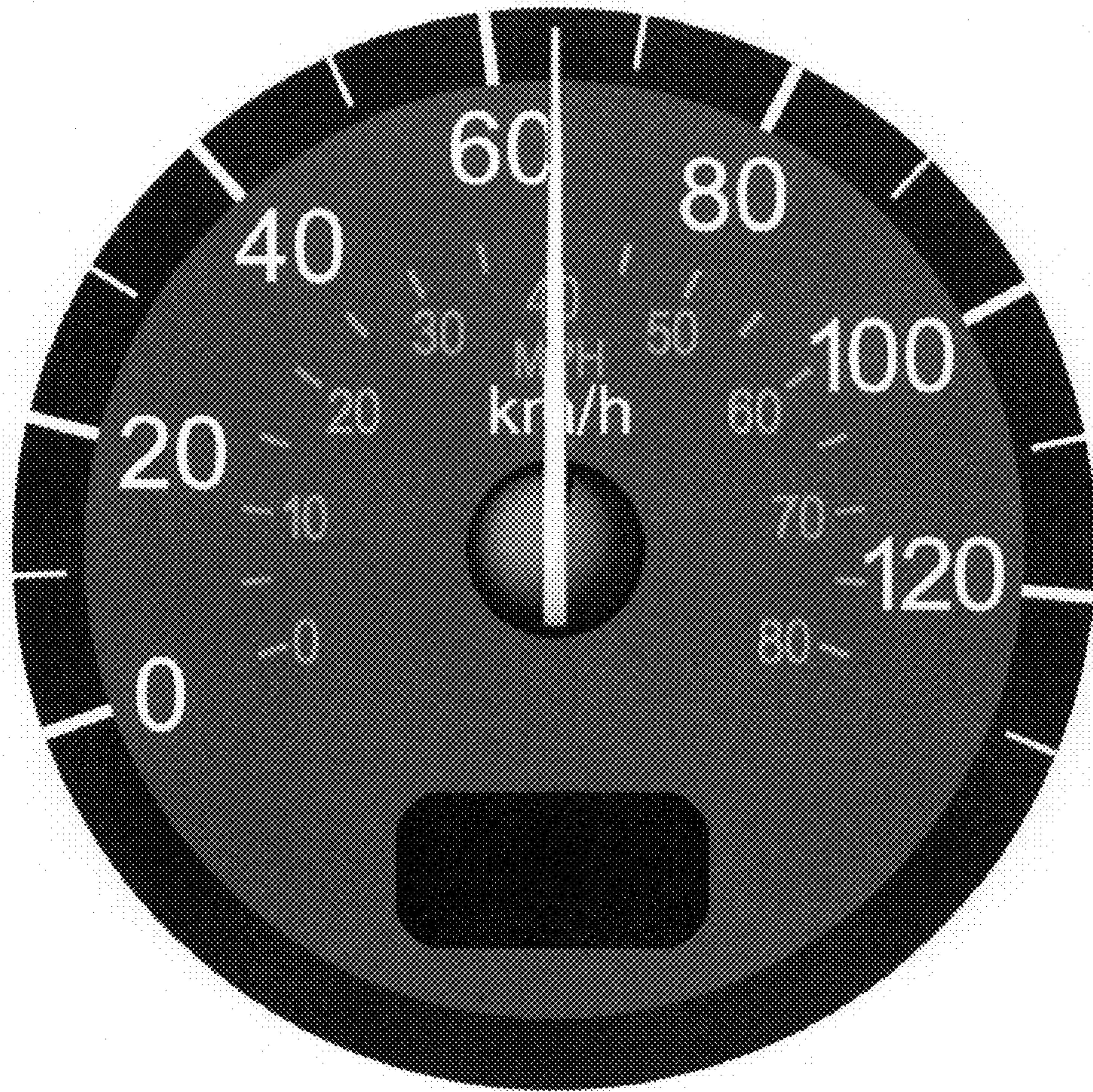

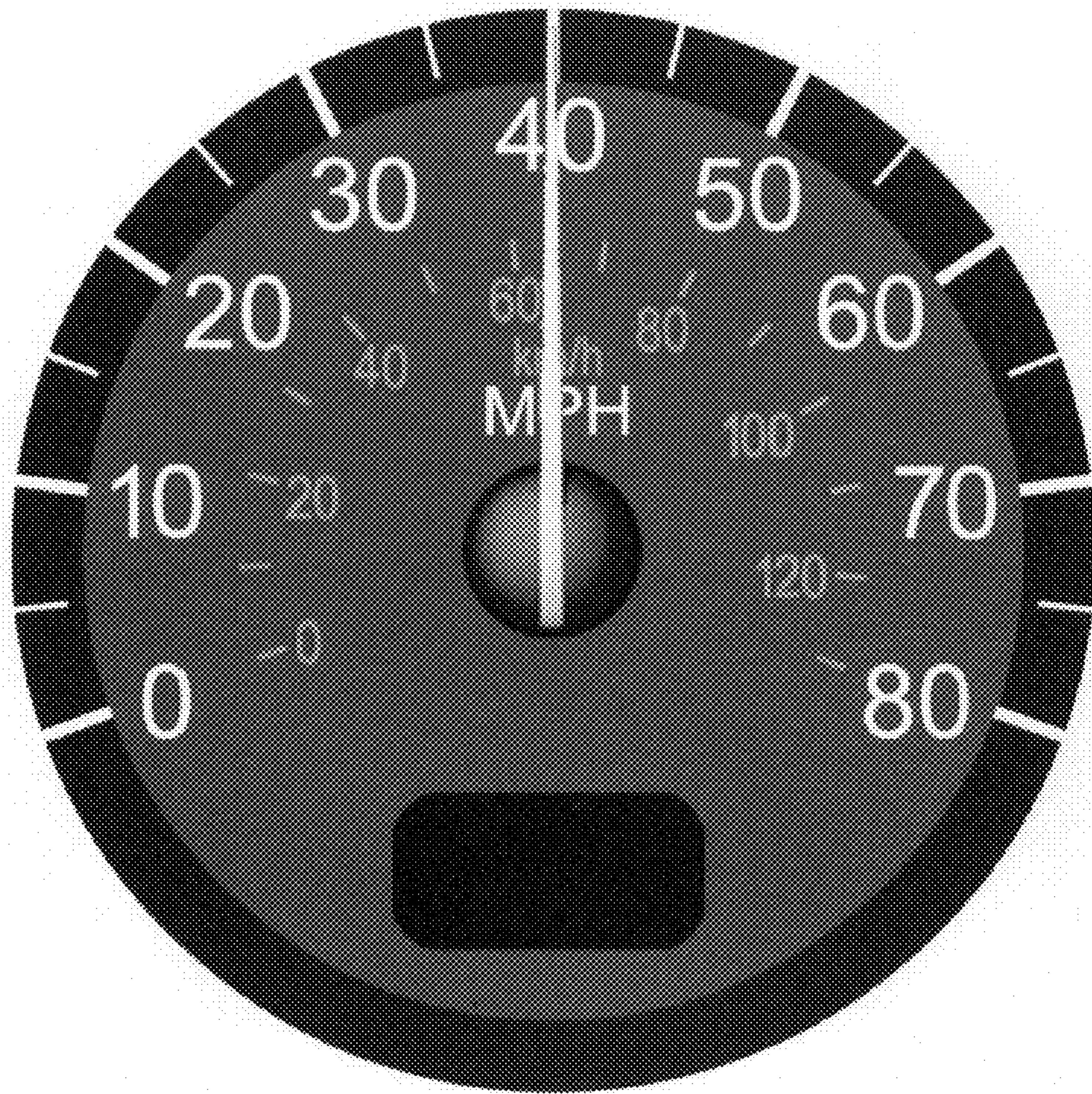
