FIG. 3 is a rear elevation view thereof;

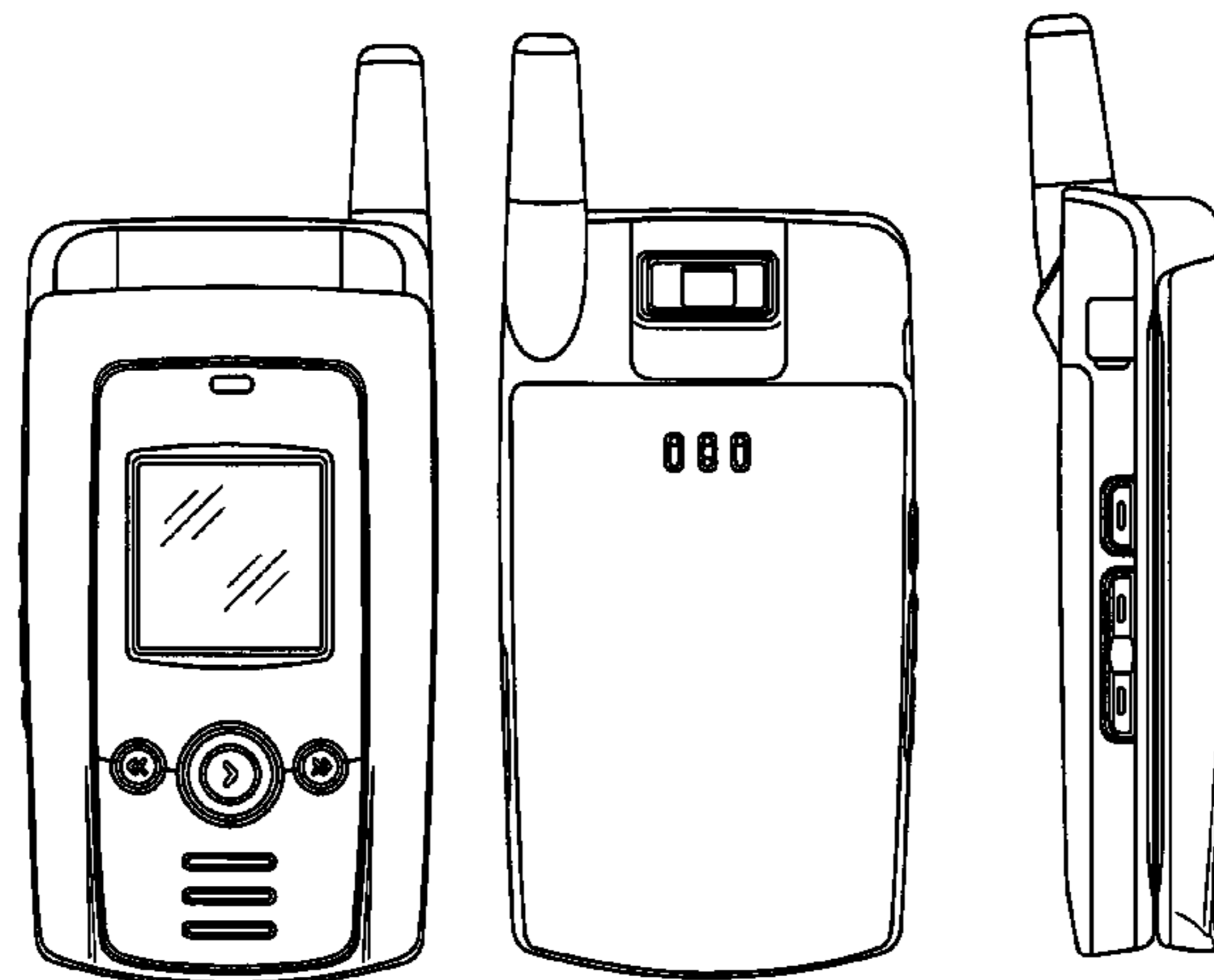
FIG. 4 is a left-side elevation view thereof;

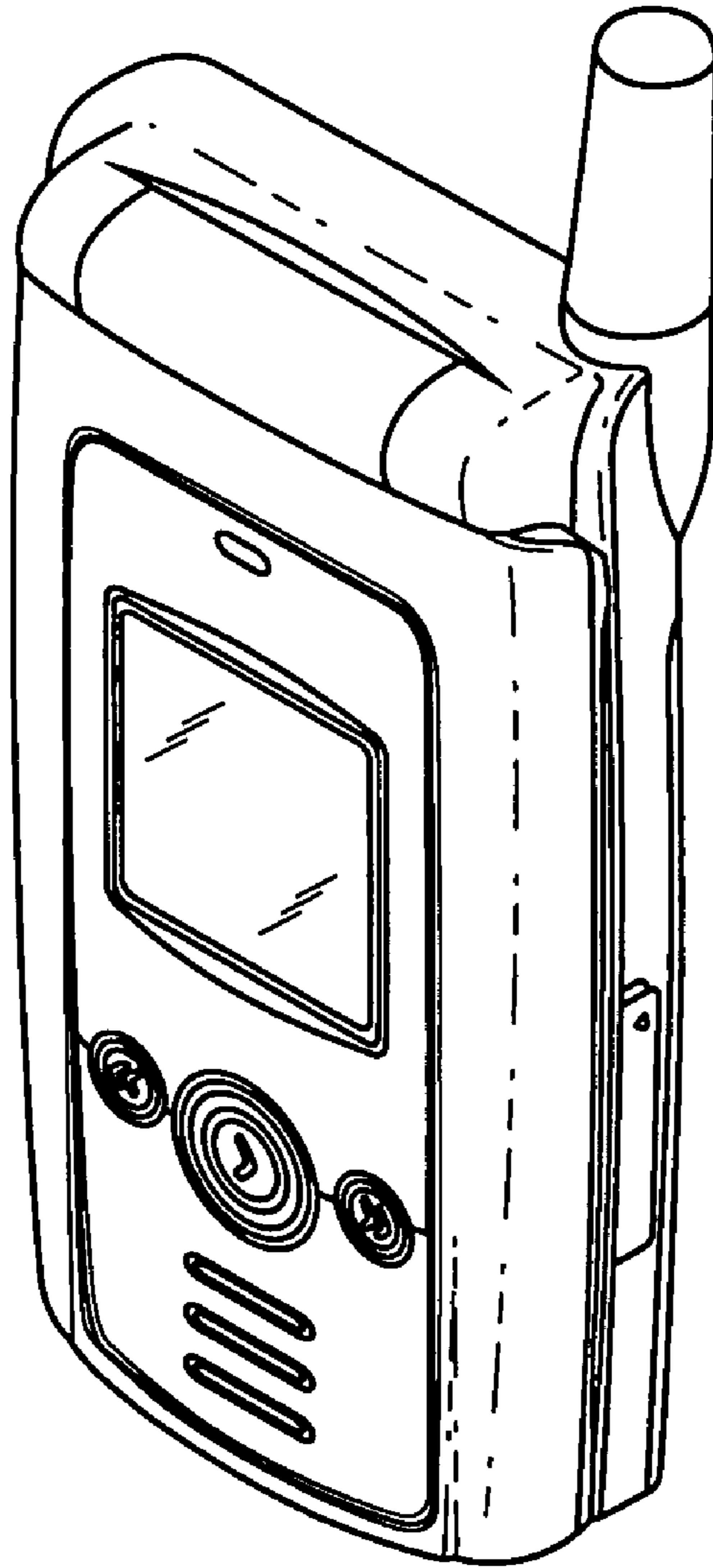

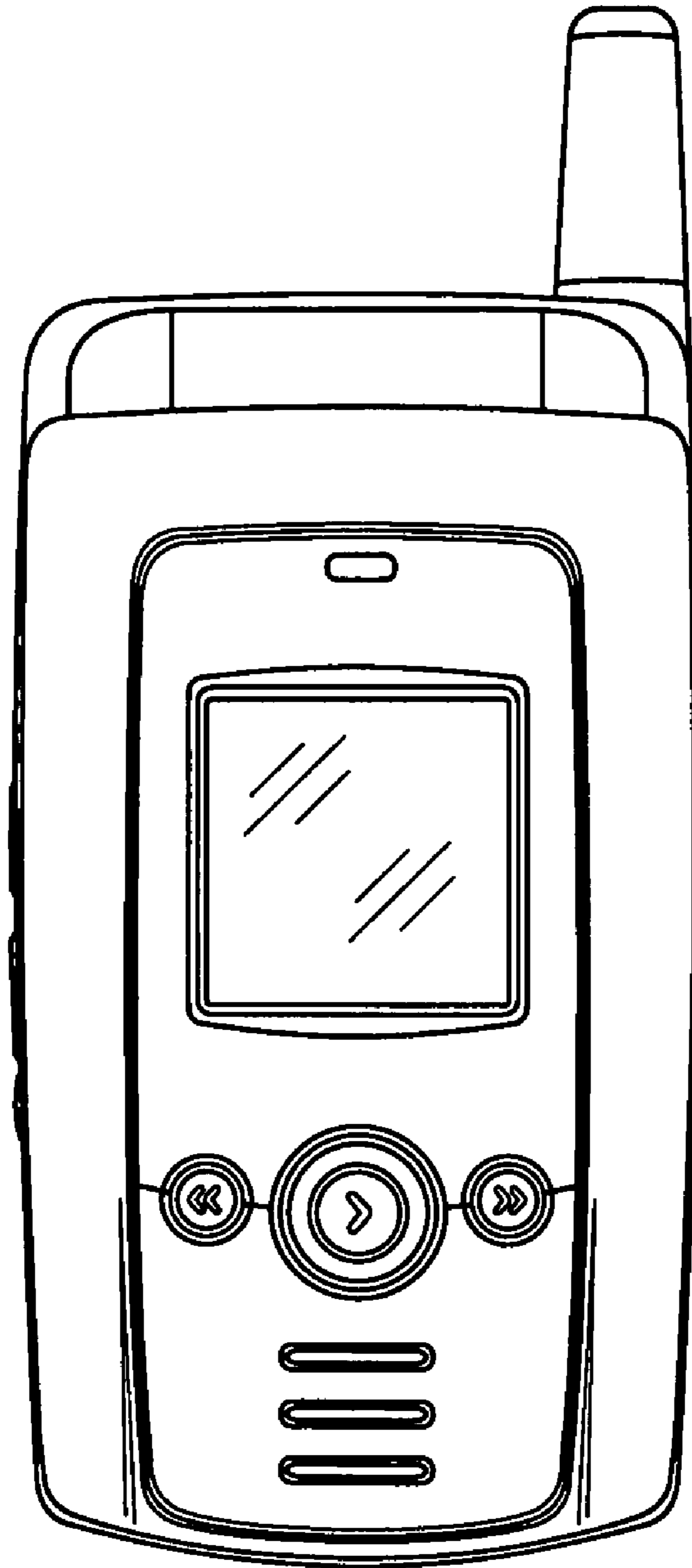

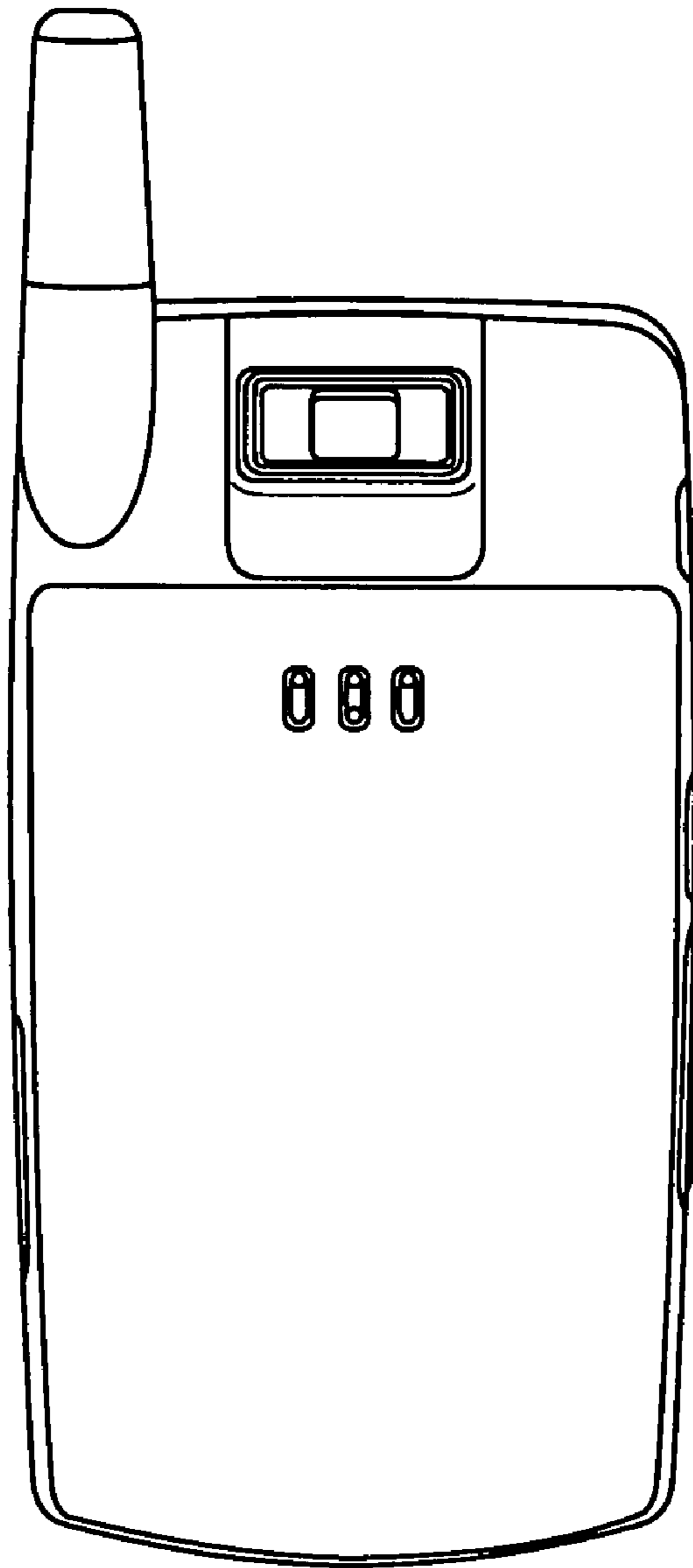

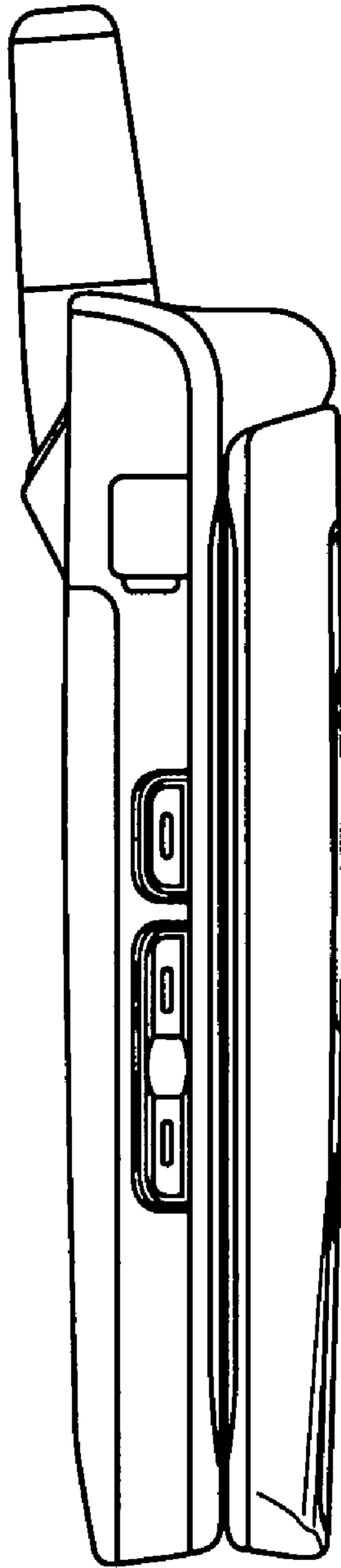

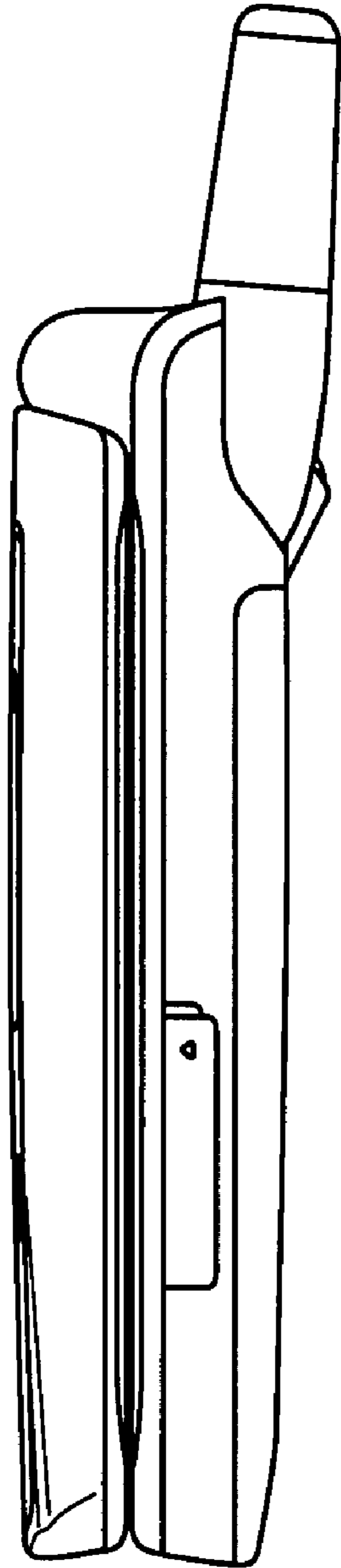

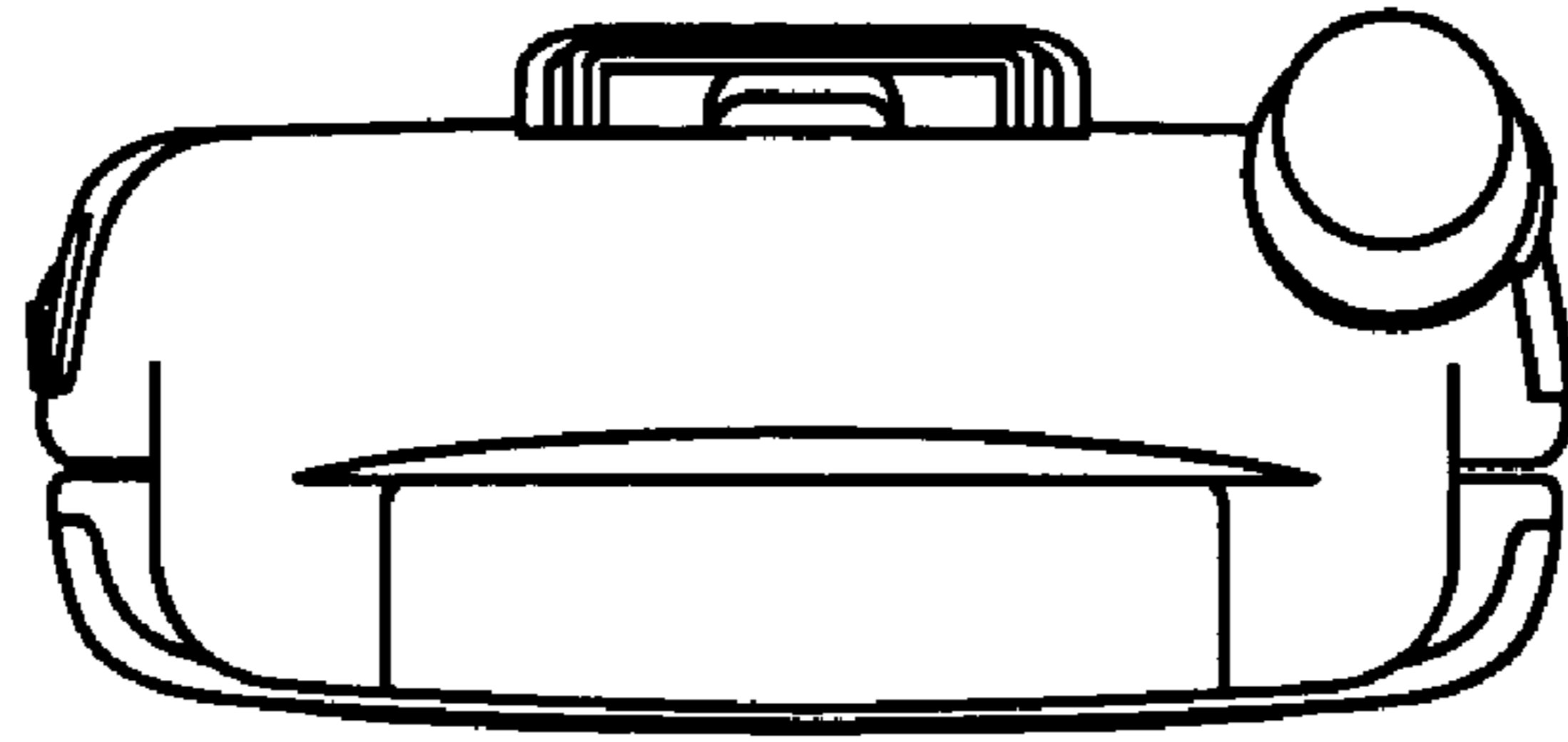

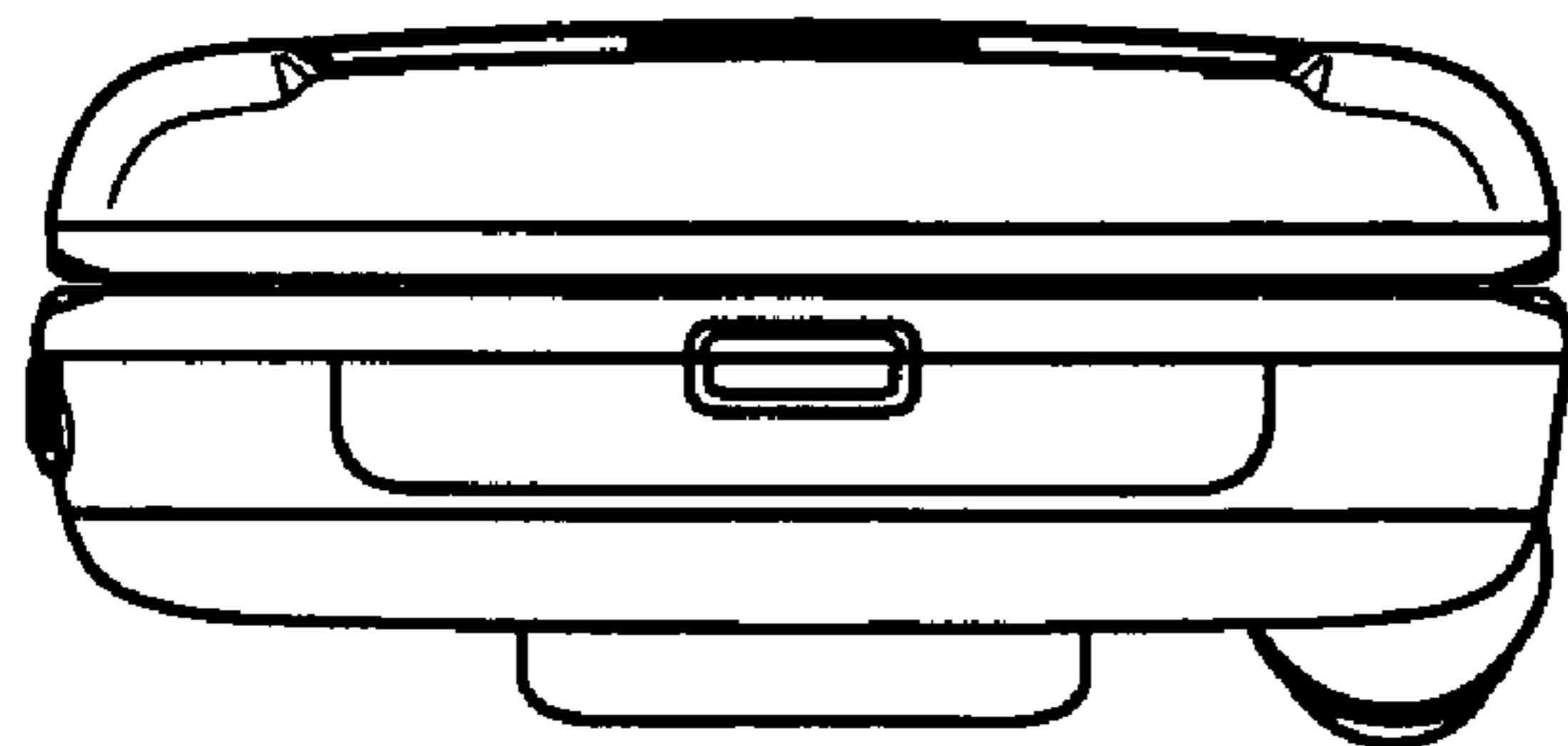
