FIG. 2 is a side elevational view, the opposite side elevational view being a mirror image thereof;

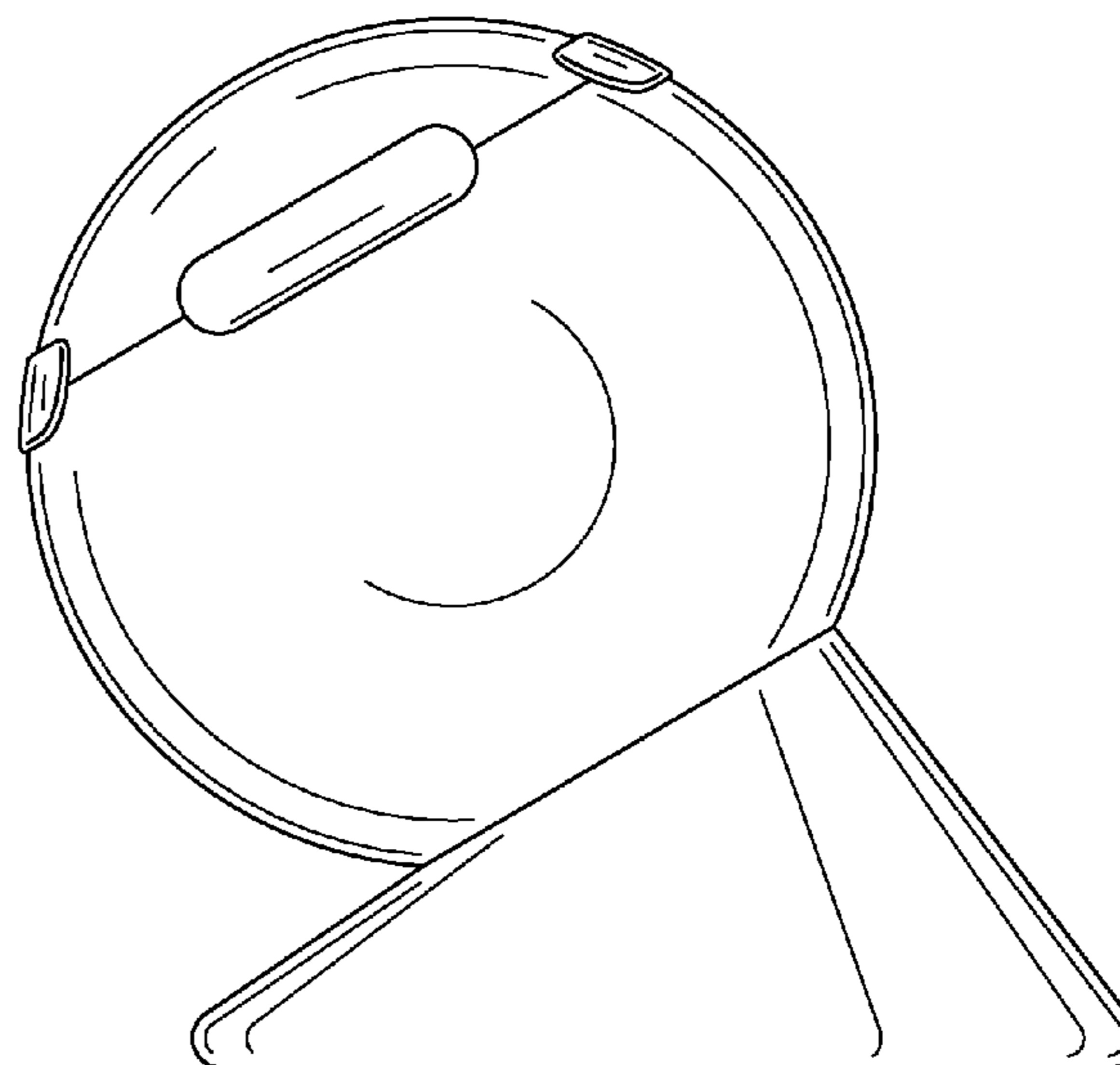
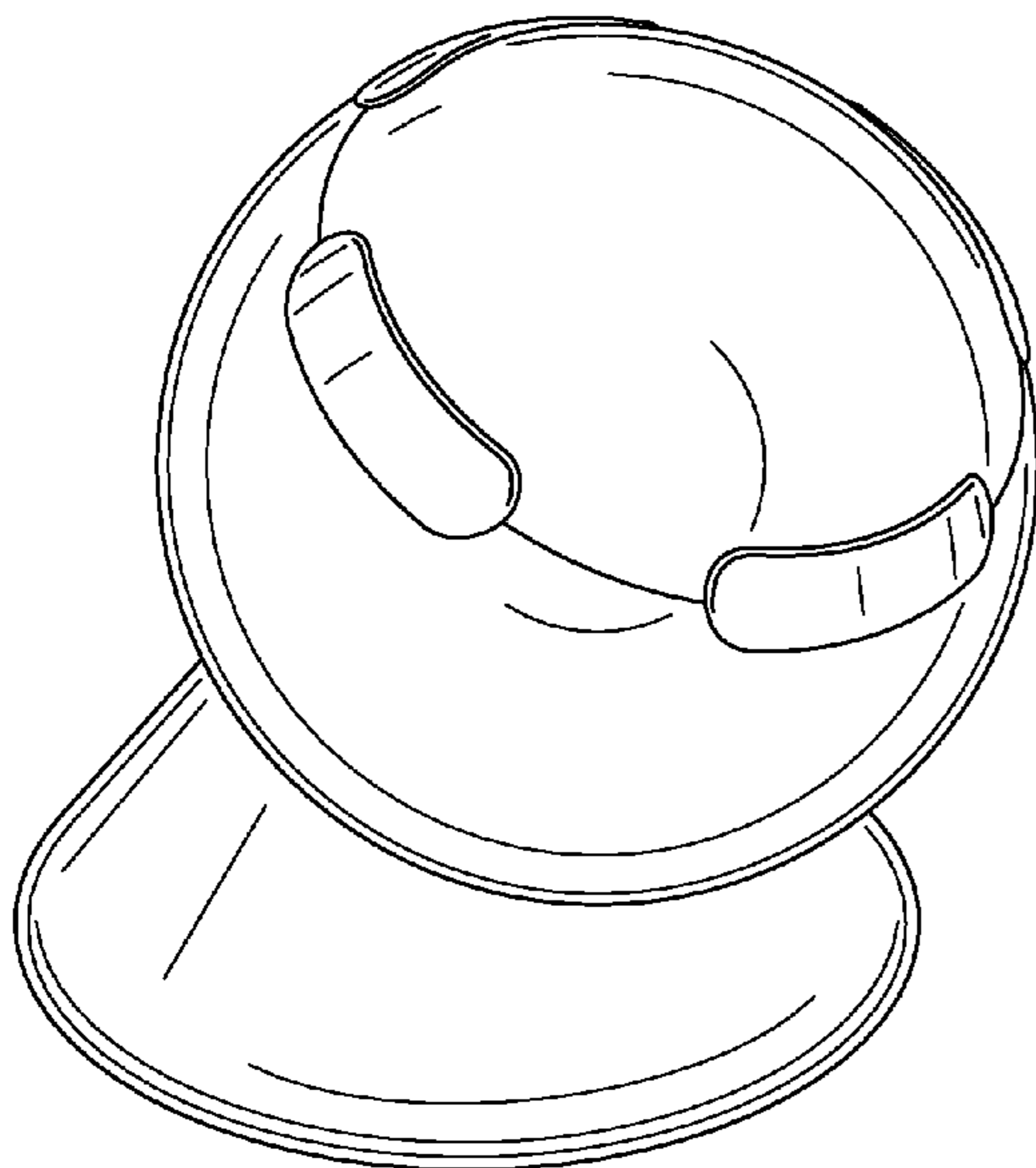
FIG. 3 is a top plan view thereof;

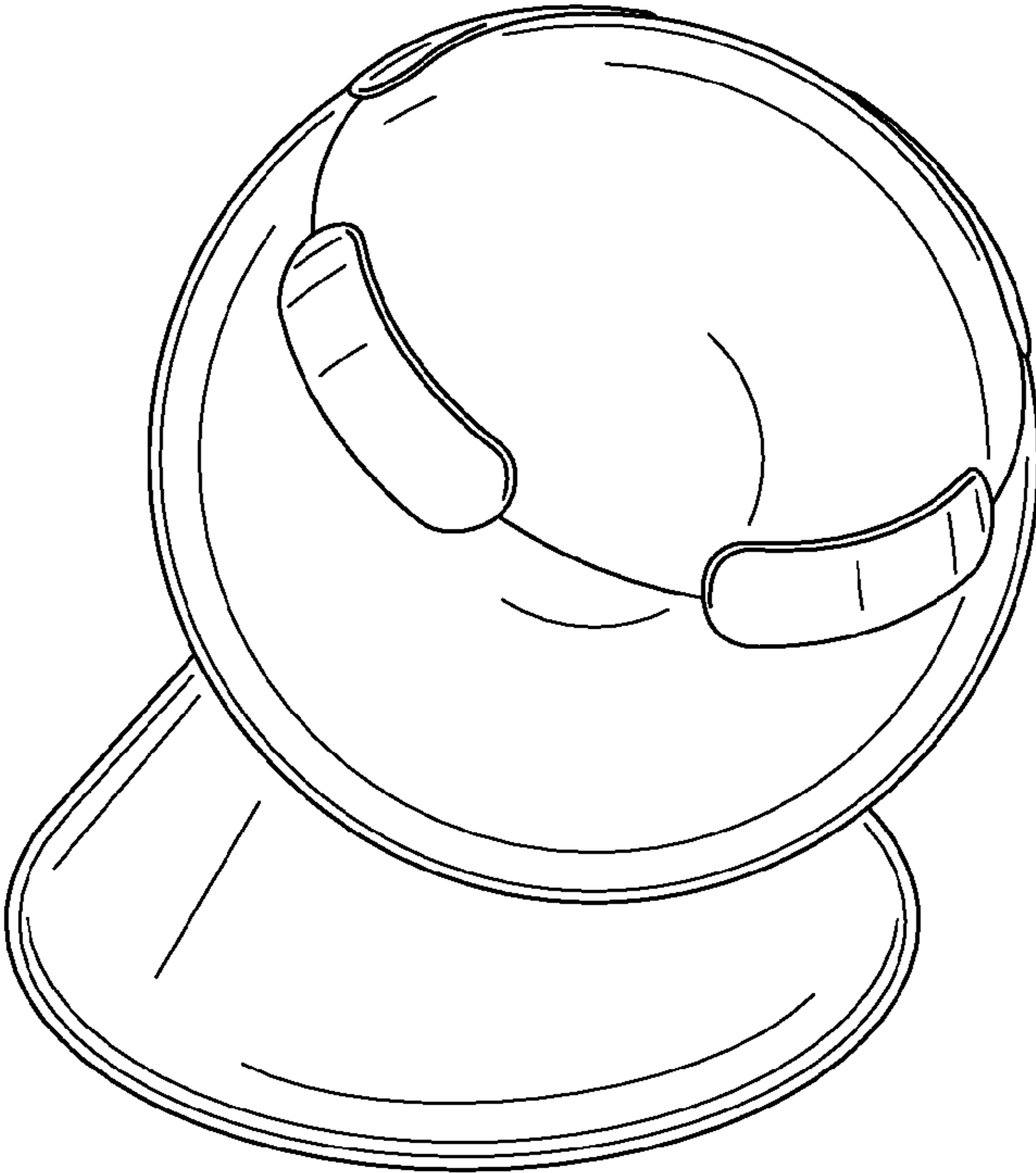

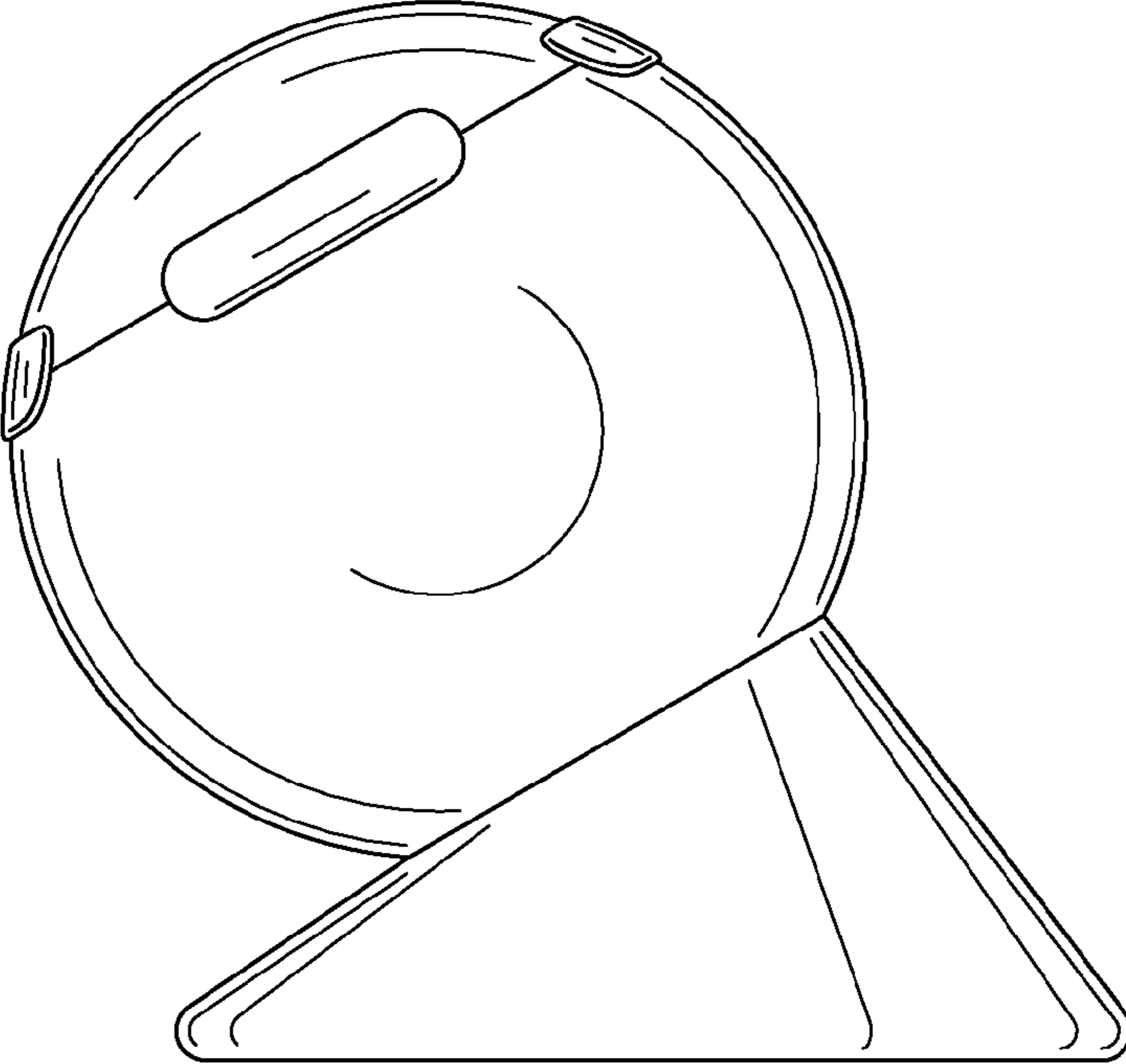

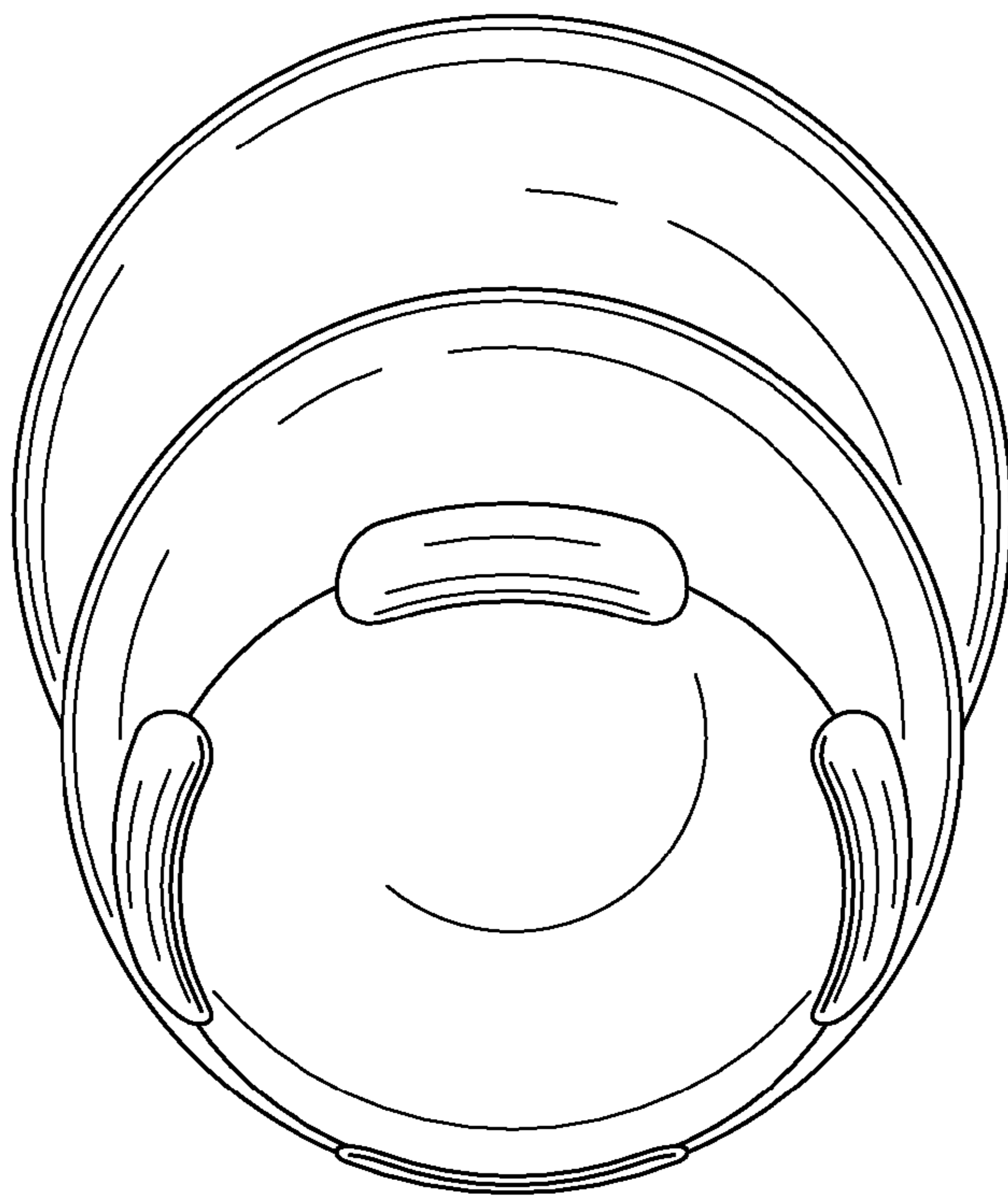

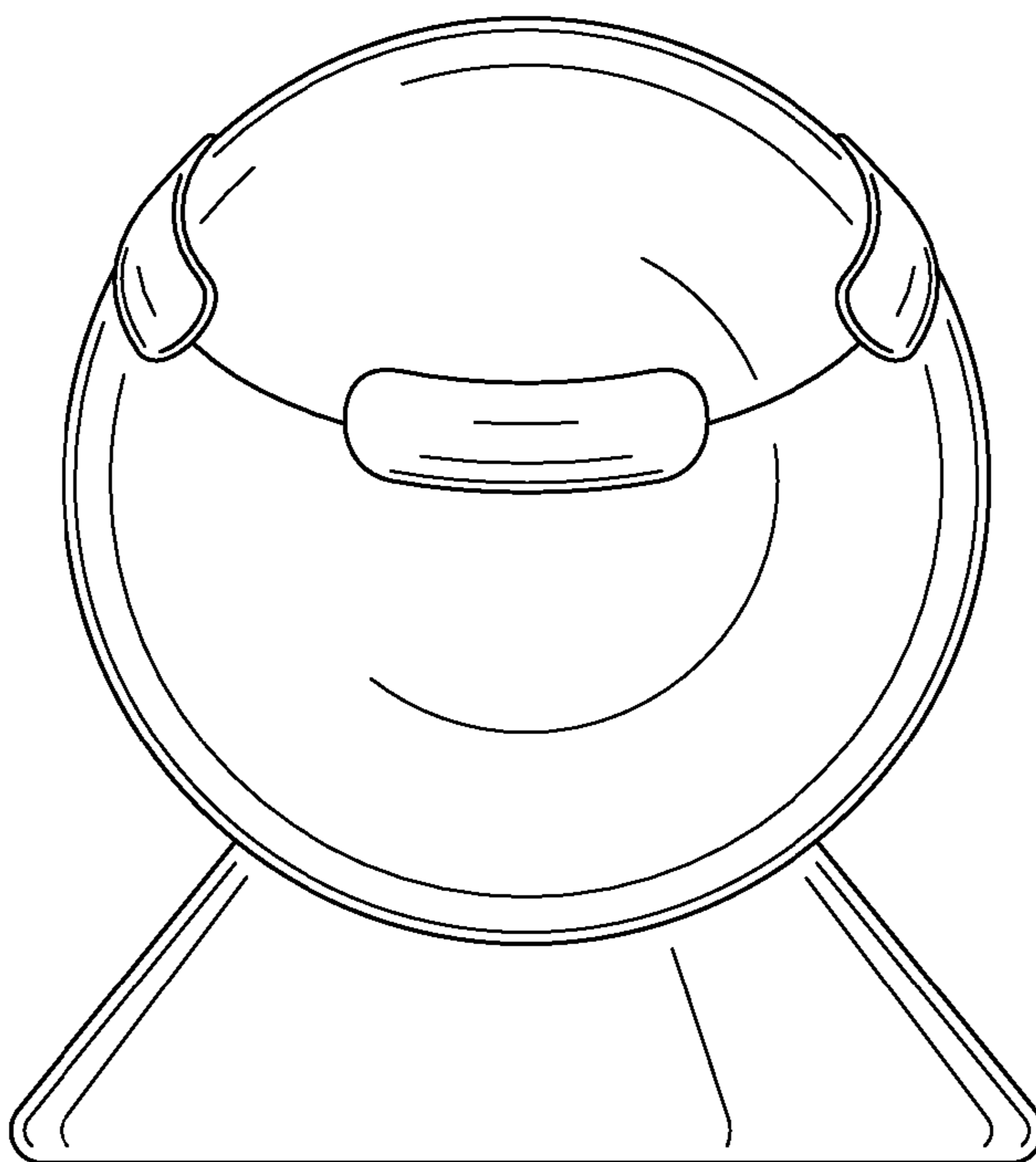

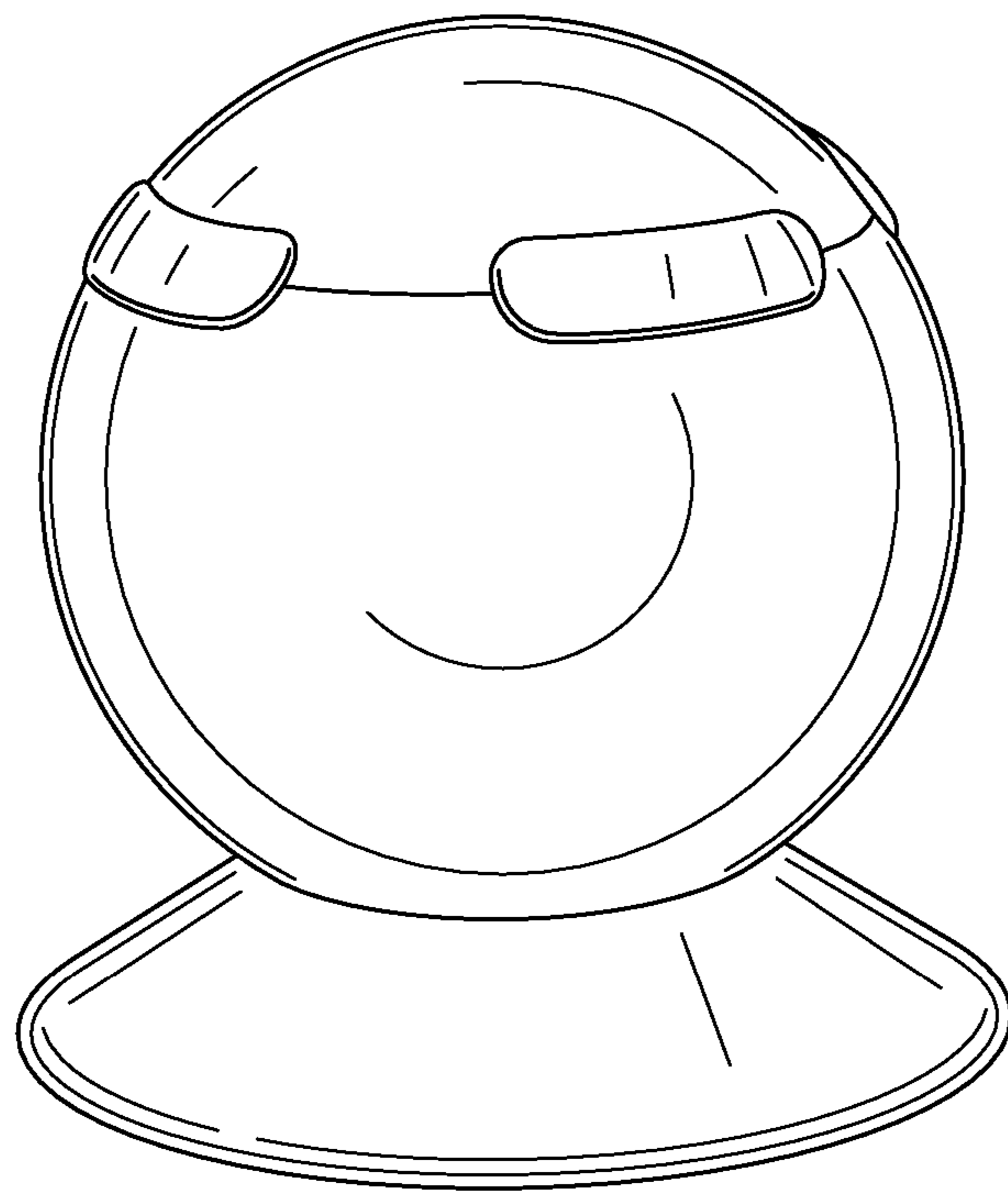

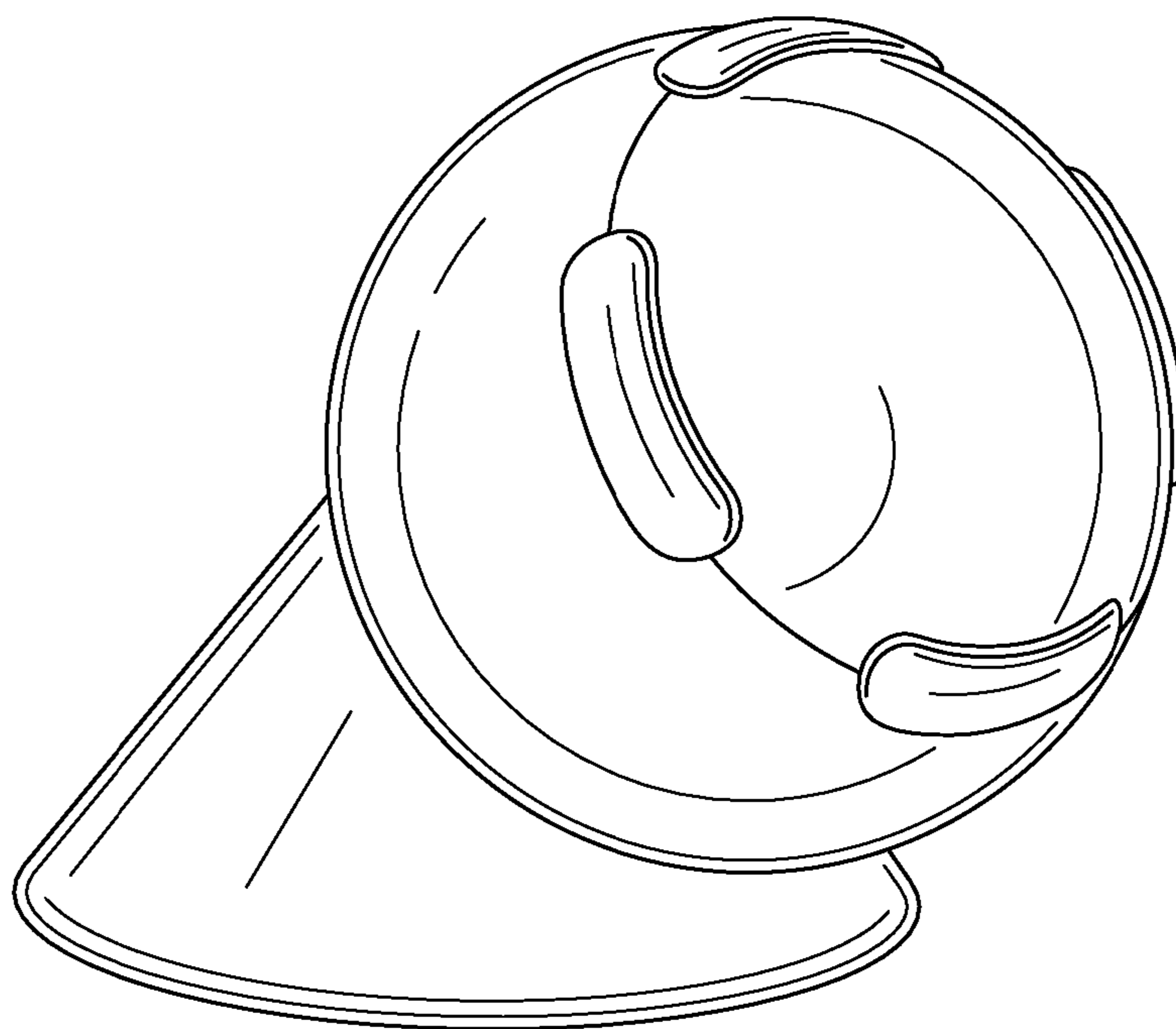
