The ornamental design for a monitor and printer stand, as shown and described.

DESCRIPTION

FIG. 1 is perspective view our new design for a monitor and printer stand;

FIG. 2 is a front view of the stand of FIG. 1;

FIG. 3 is a side view of the stand of FIG. 1, the opposite side view being a mirror image thereof;

FIG. 4 is a top plan view of the stand of FIG. 1;

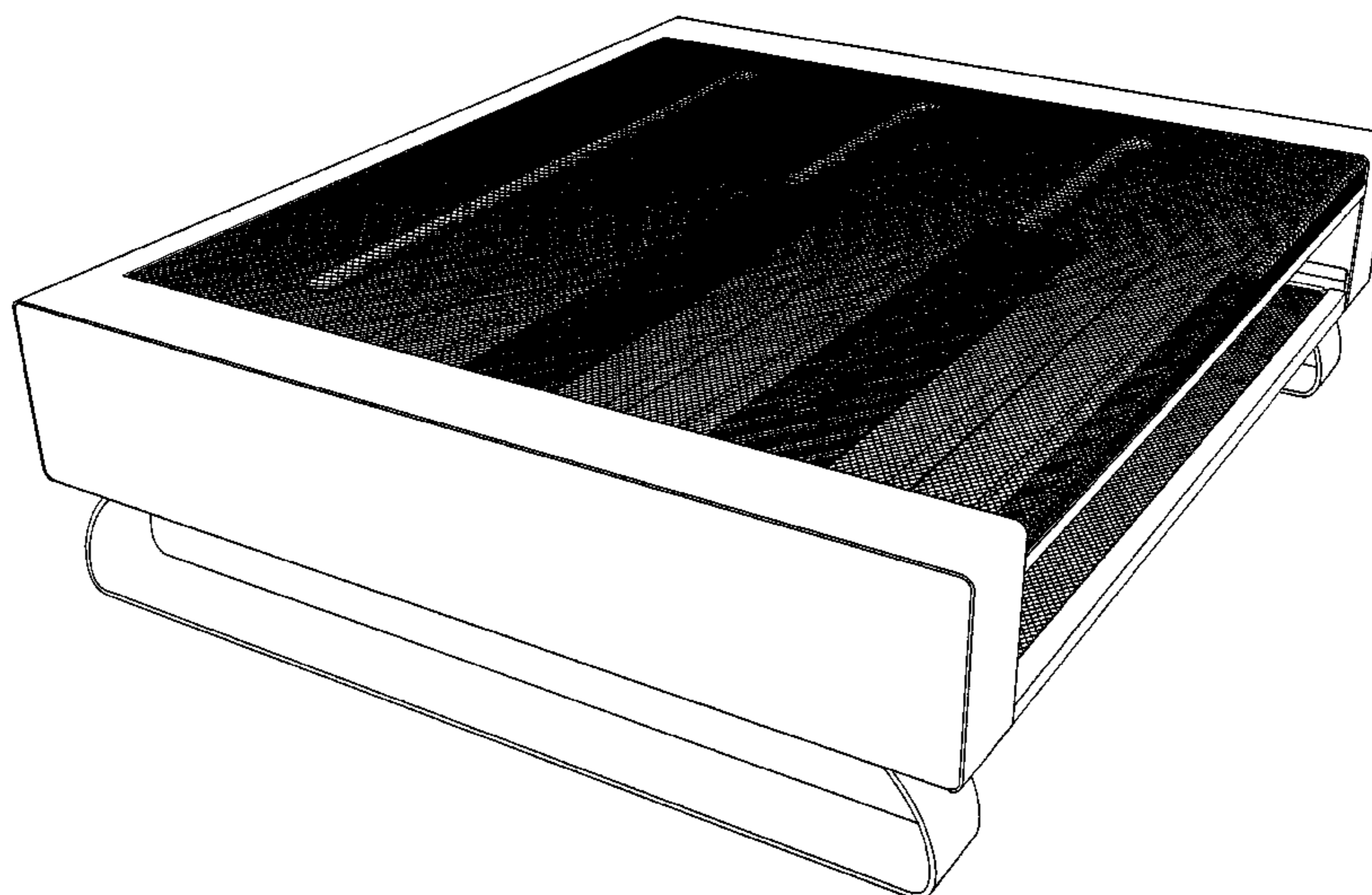
FIG. 5 is a bottom plan view of the stand of FIG. 1;

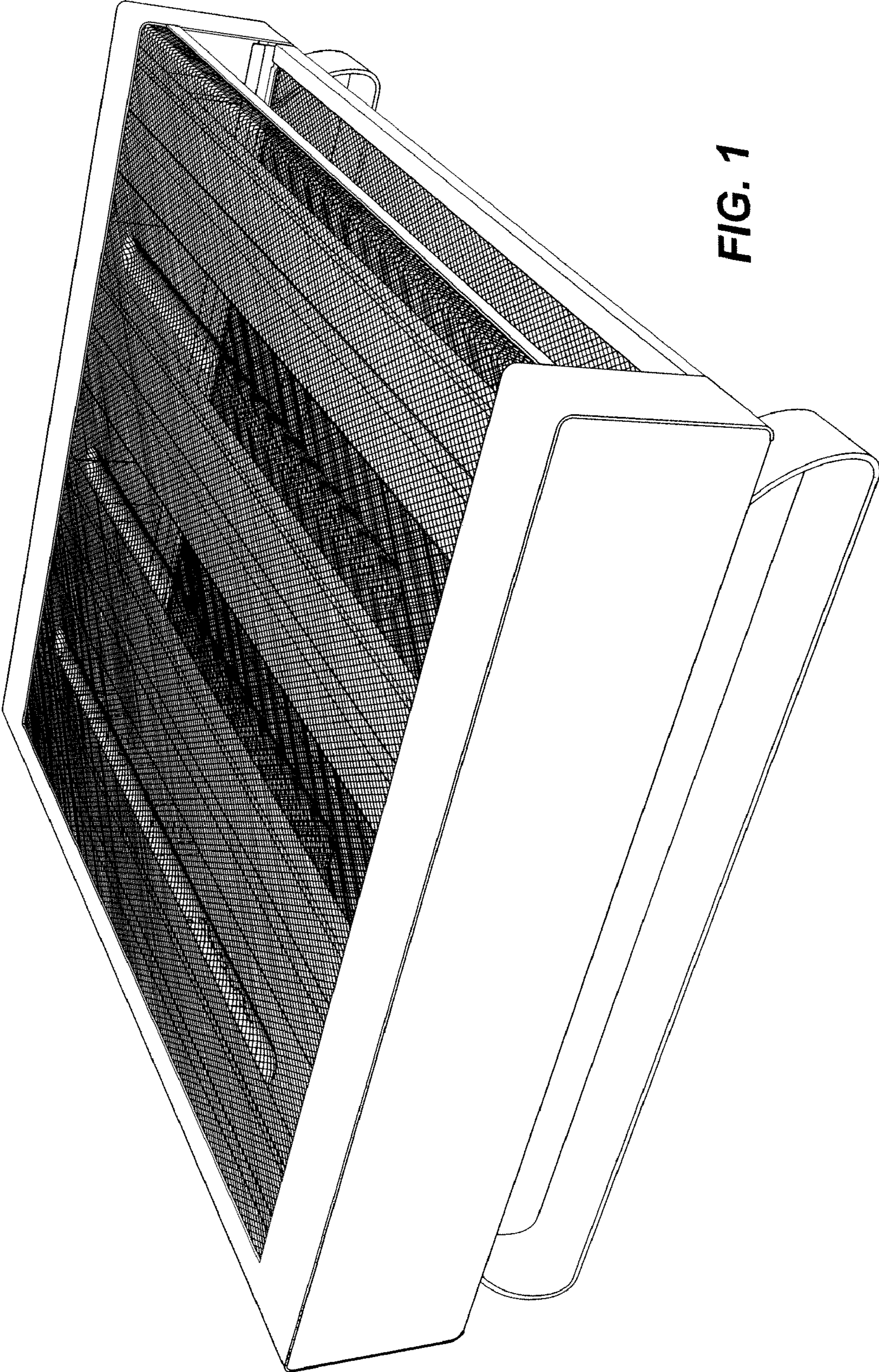

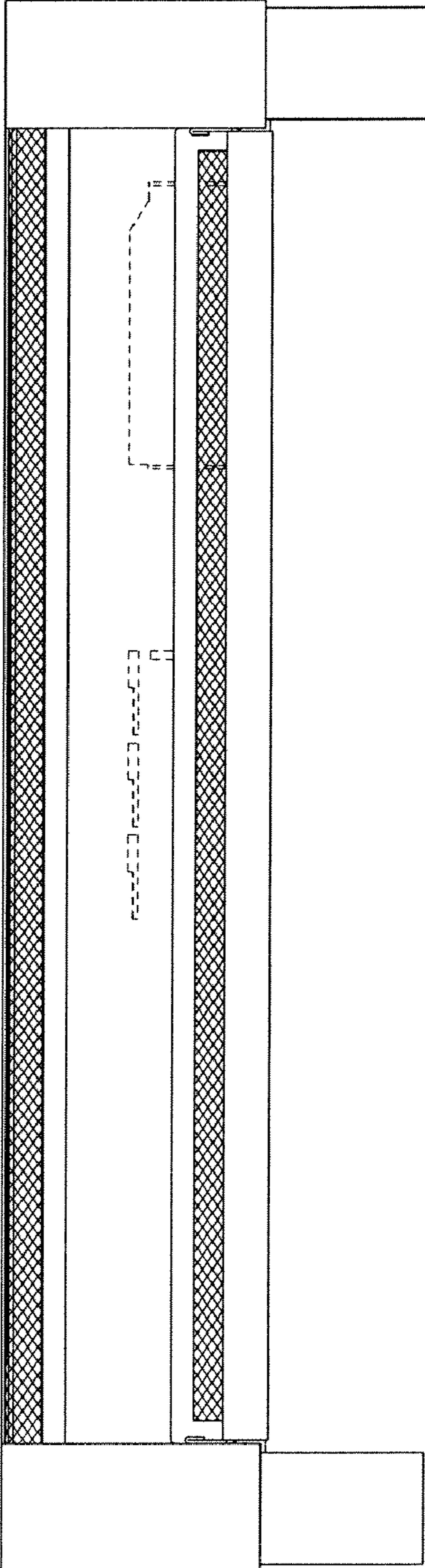
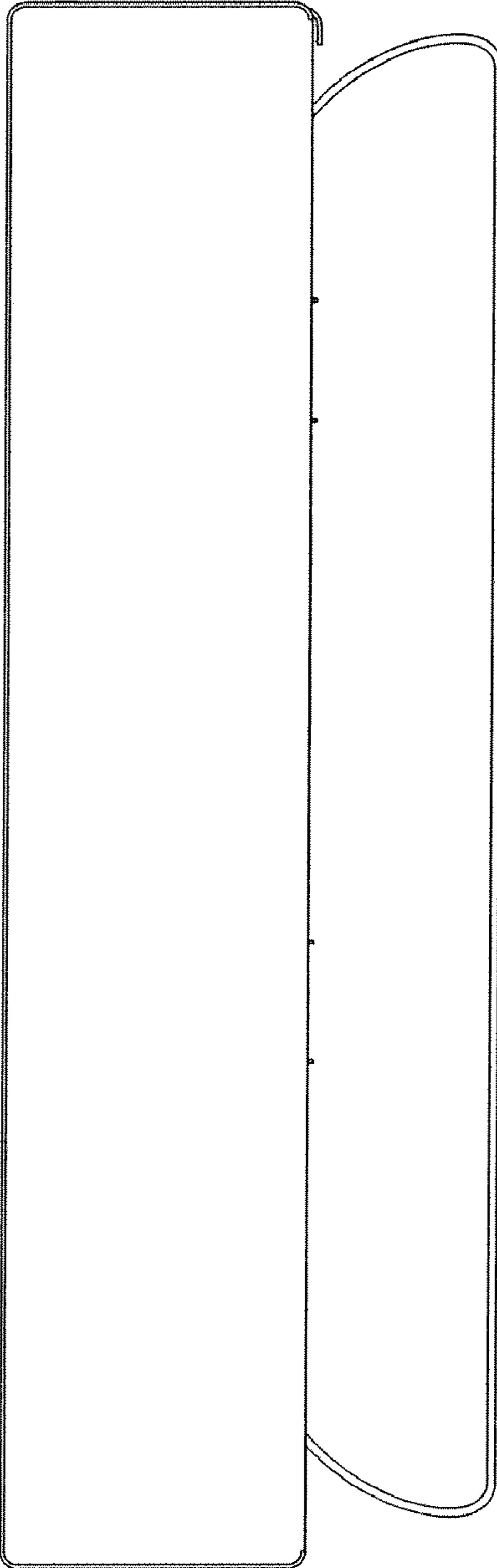

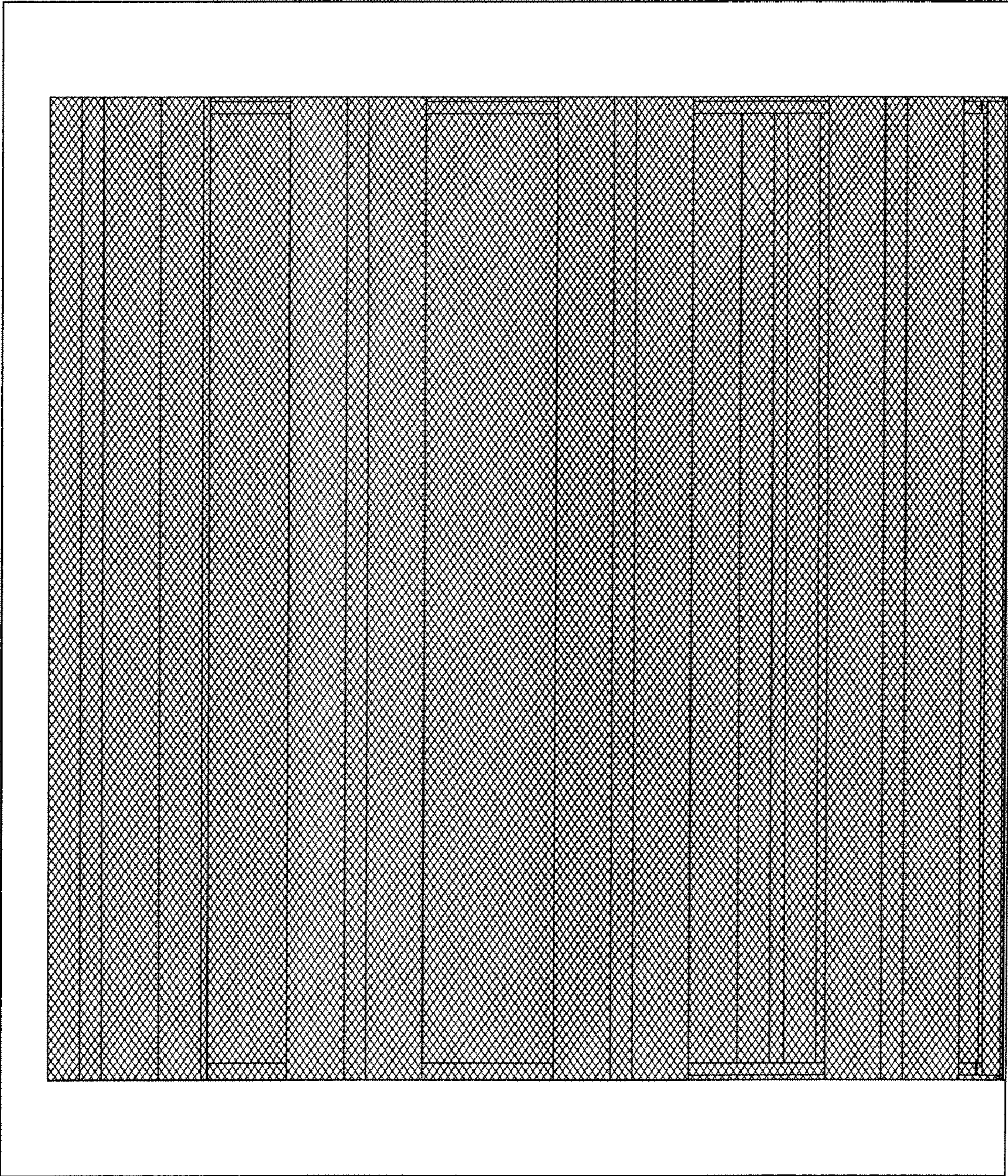

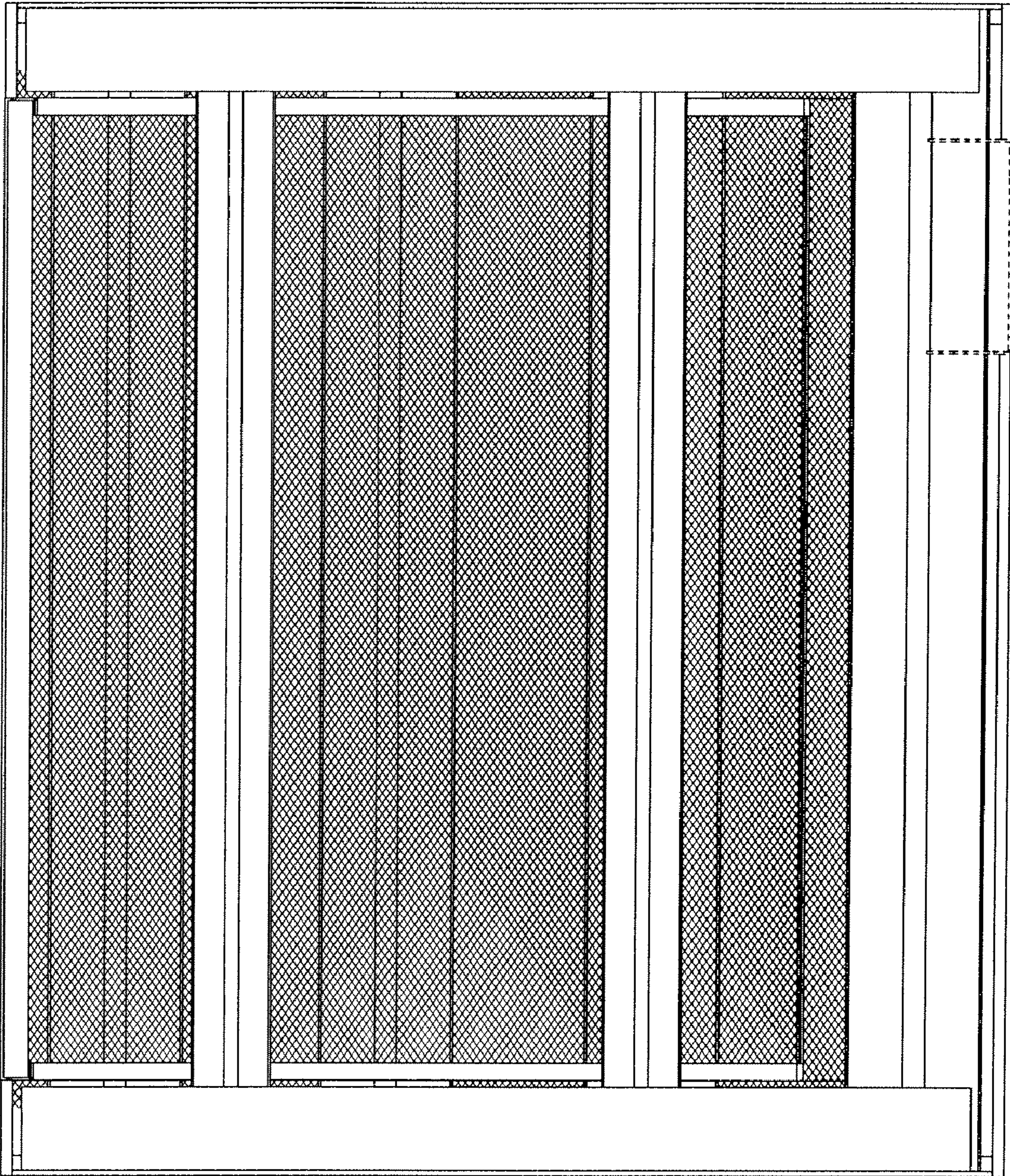

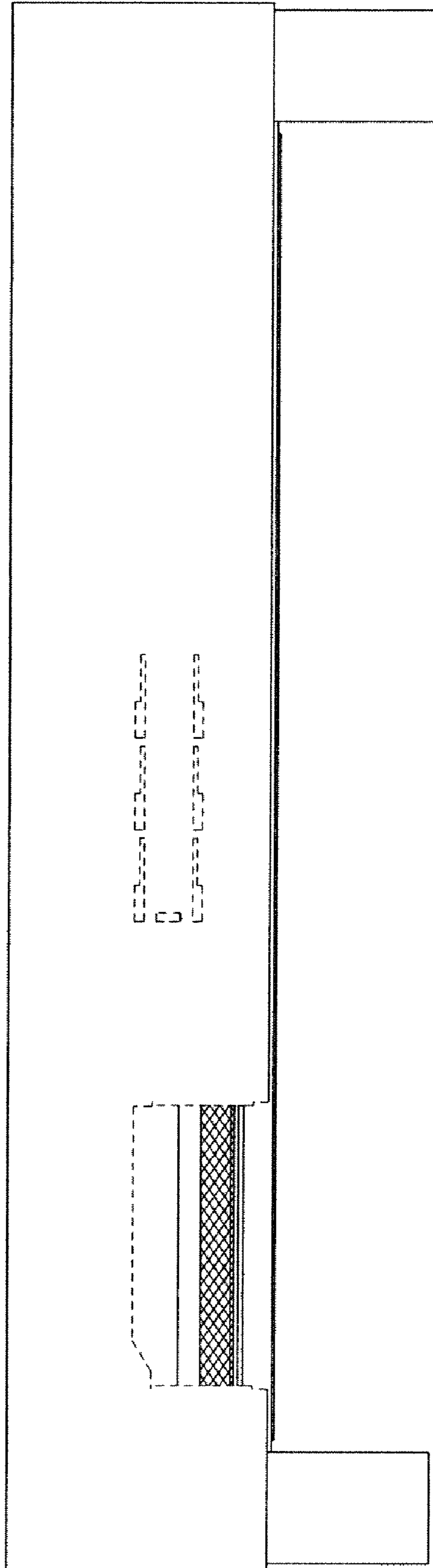
