(57) **CLAIM**

The ornamental design for a graphic user interface for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a graphic user interface according to our new design displayed on a cellular phone; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is an enlarged view of a portion of the image of FIG. 2.

The broken line showing of a cellular phone is included for the purpose of illustrating portions of the article and forms no part of the claimed design.

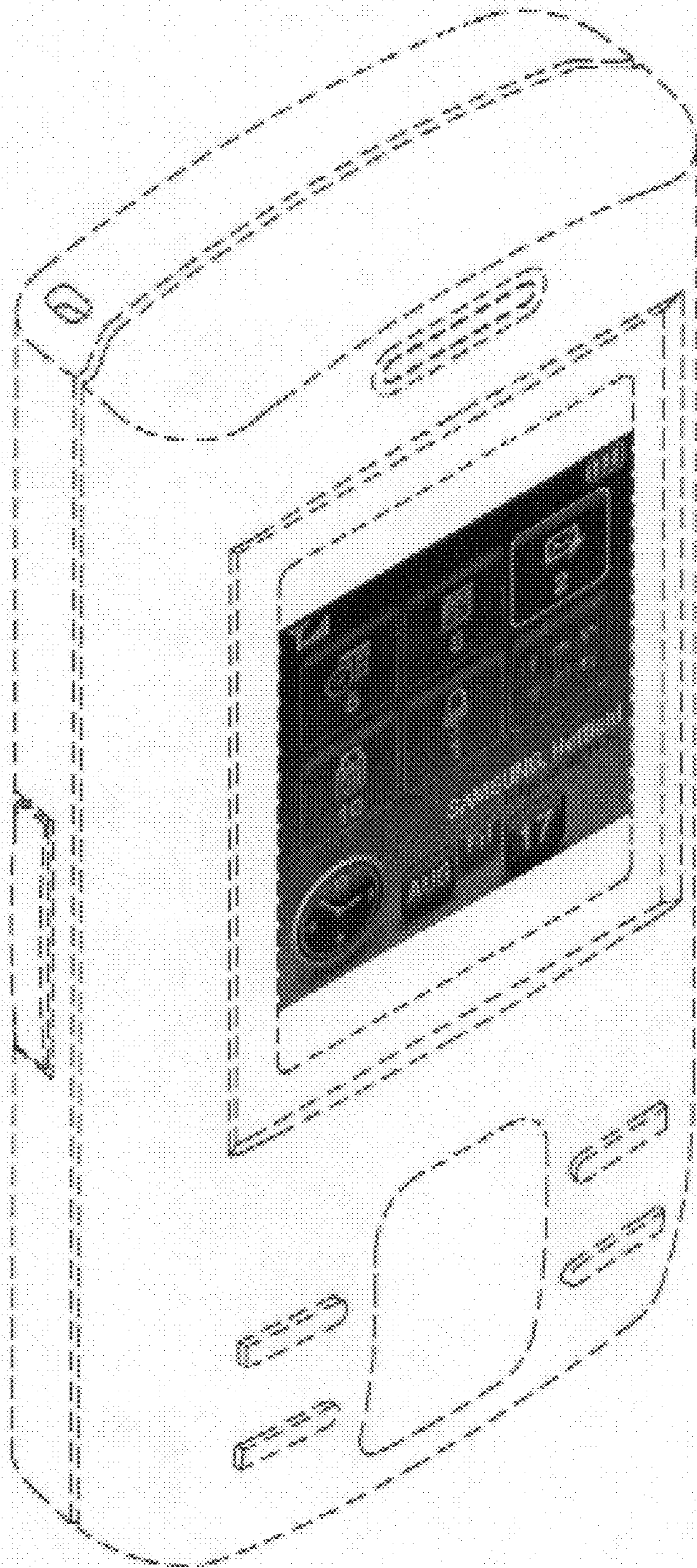

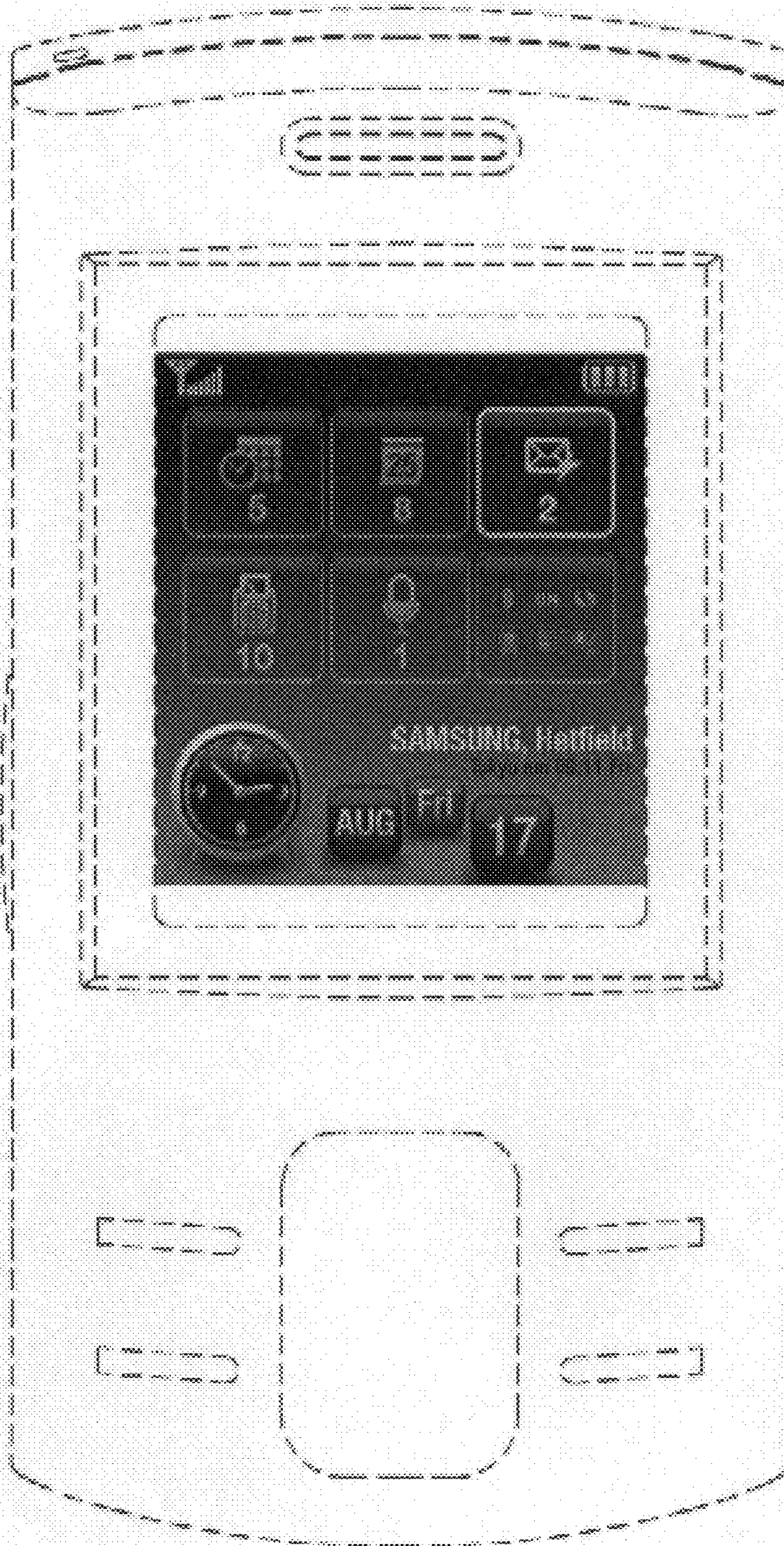

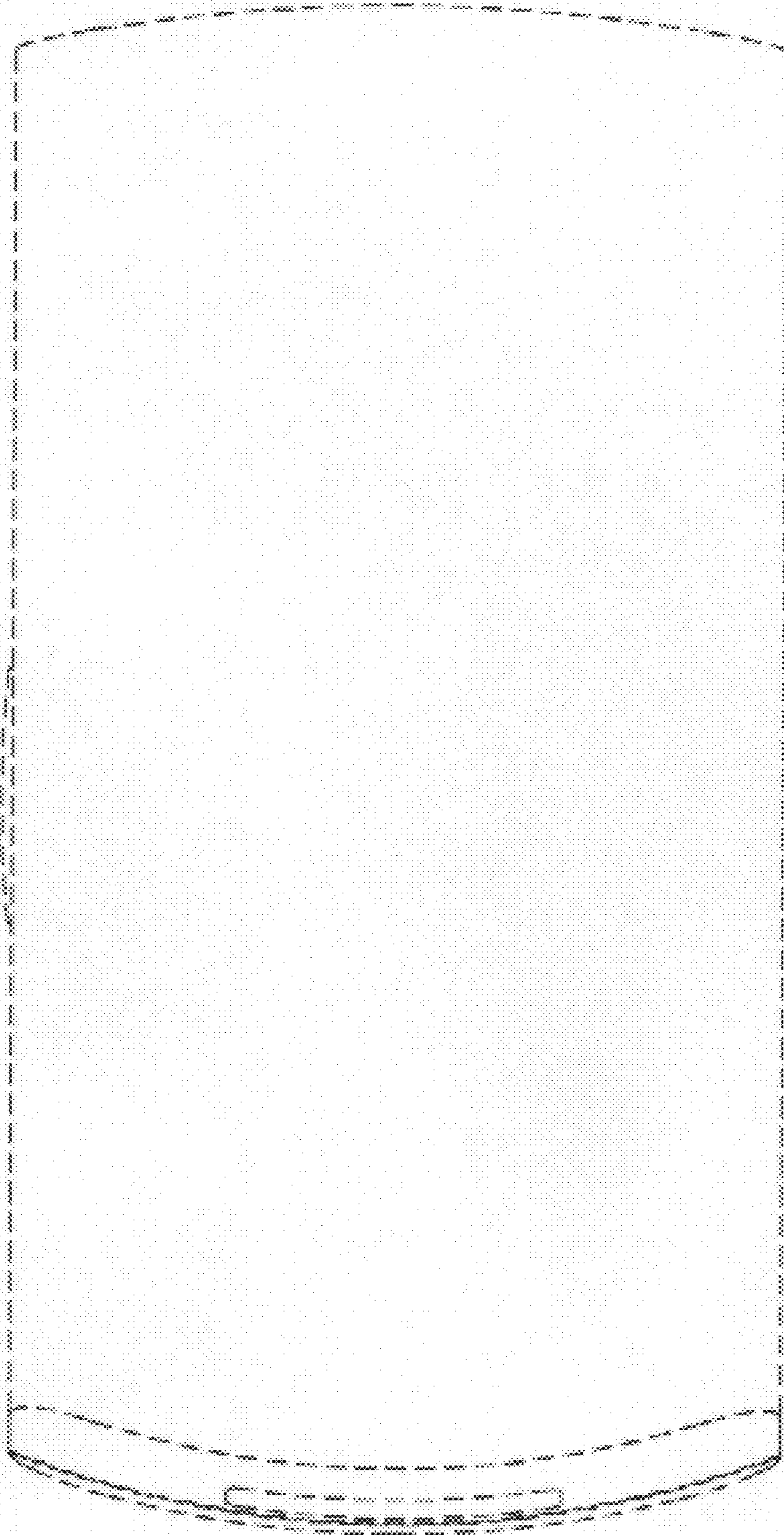

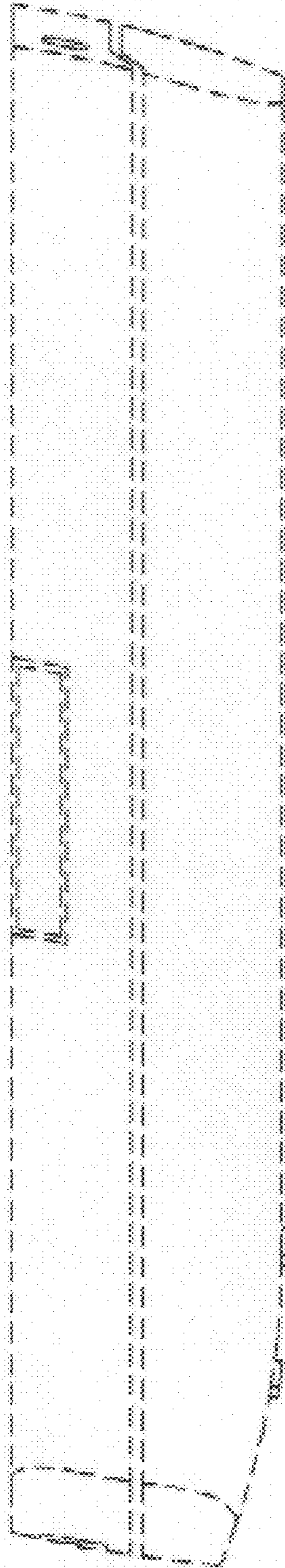

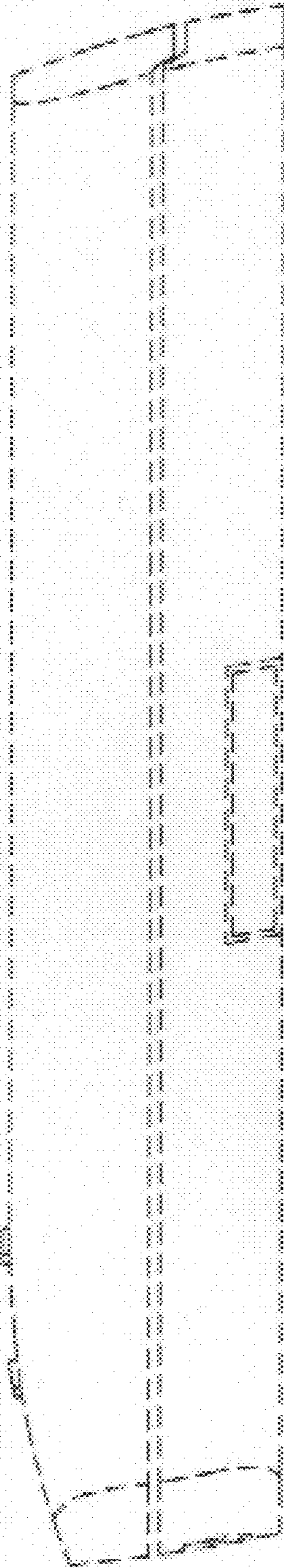

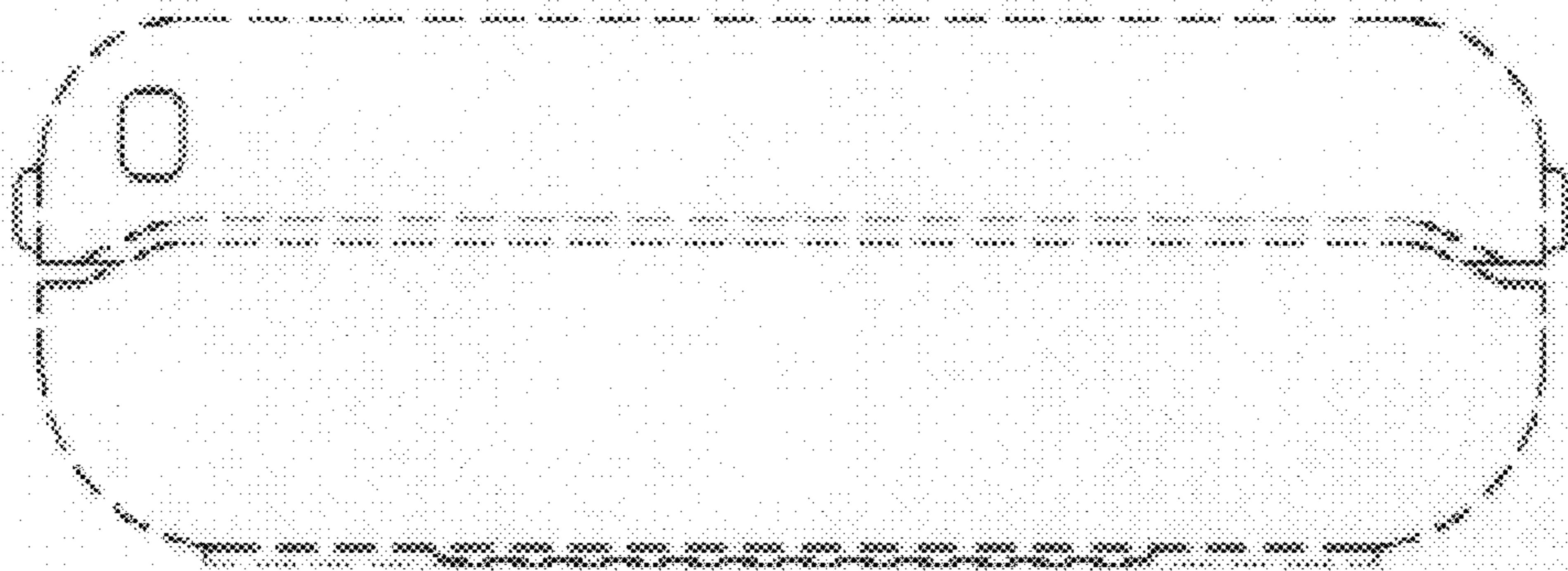

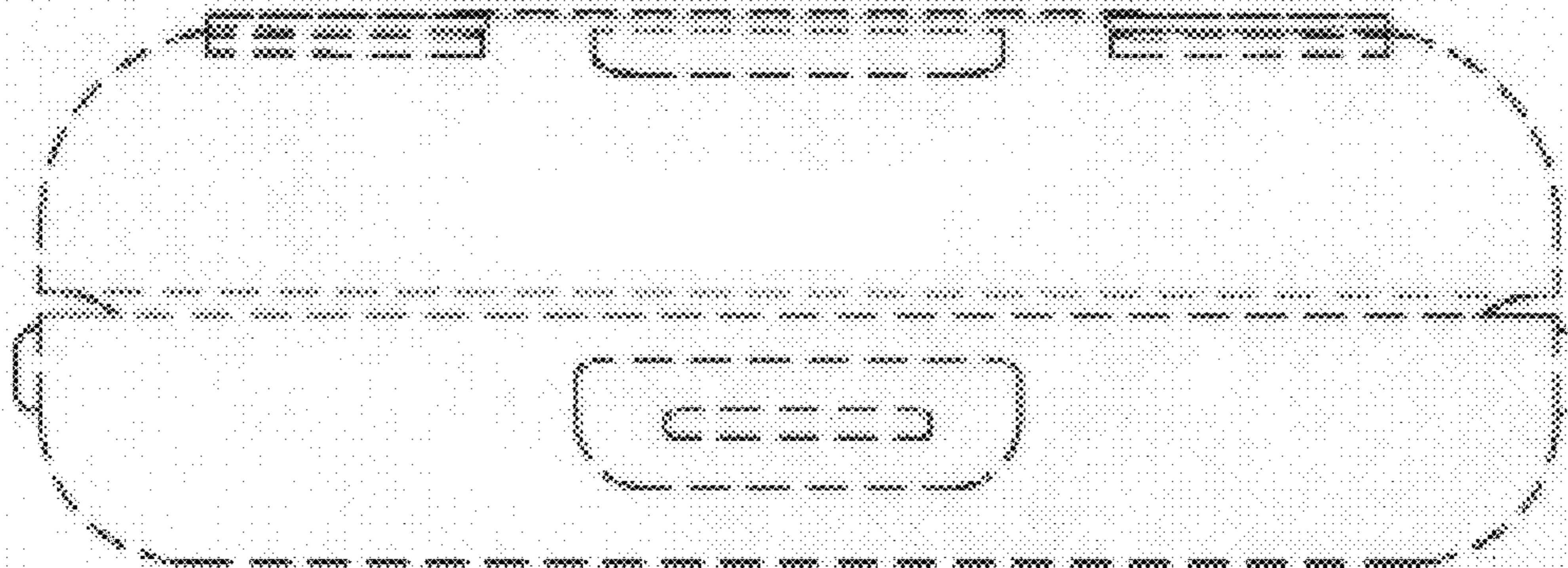
