DESCRIPTION

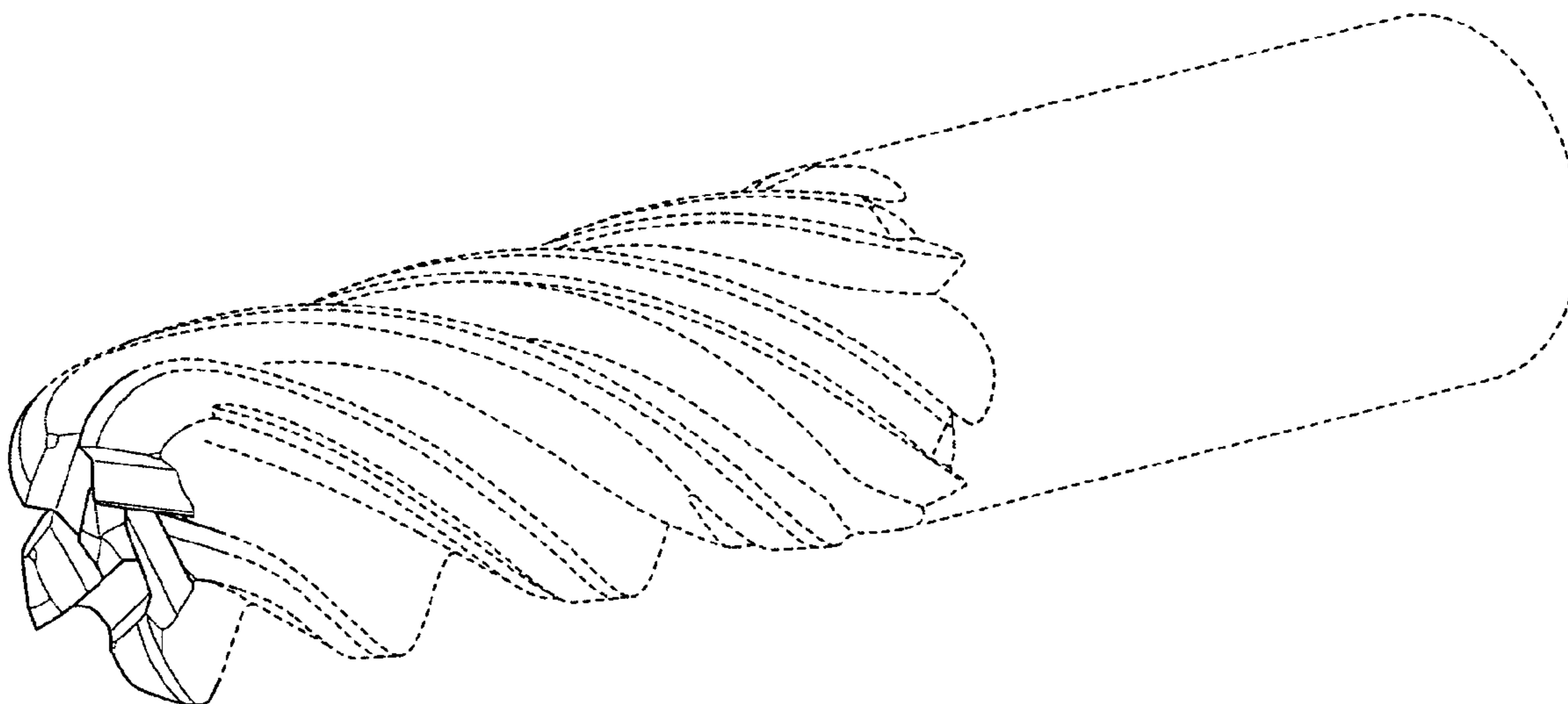
FIG. 1 is a front perspective view of a first embodiment of the present new design of an end mill face;

FIG. 2 is a top view of the end mill face of FIG. 1; and,

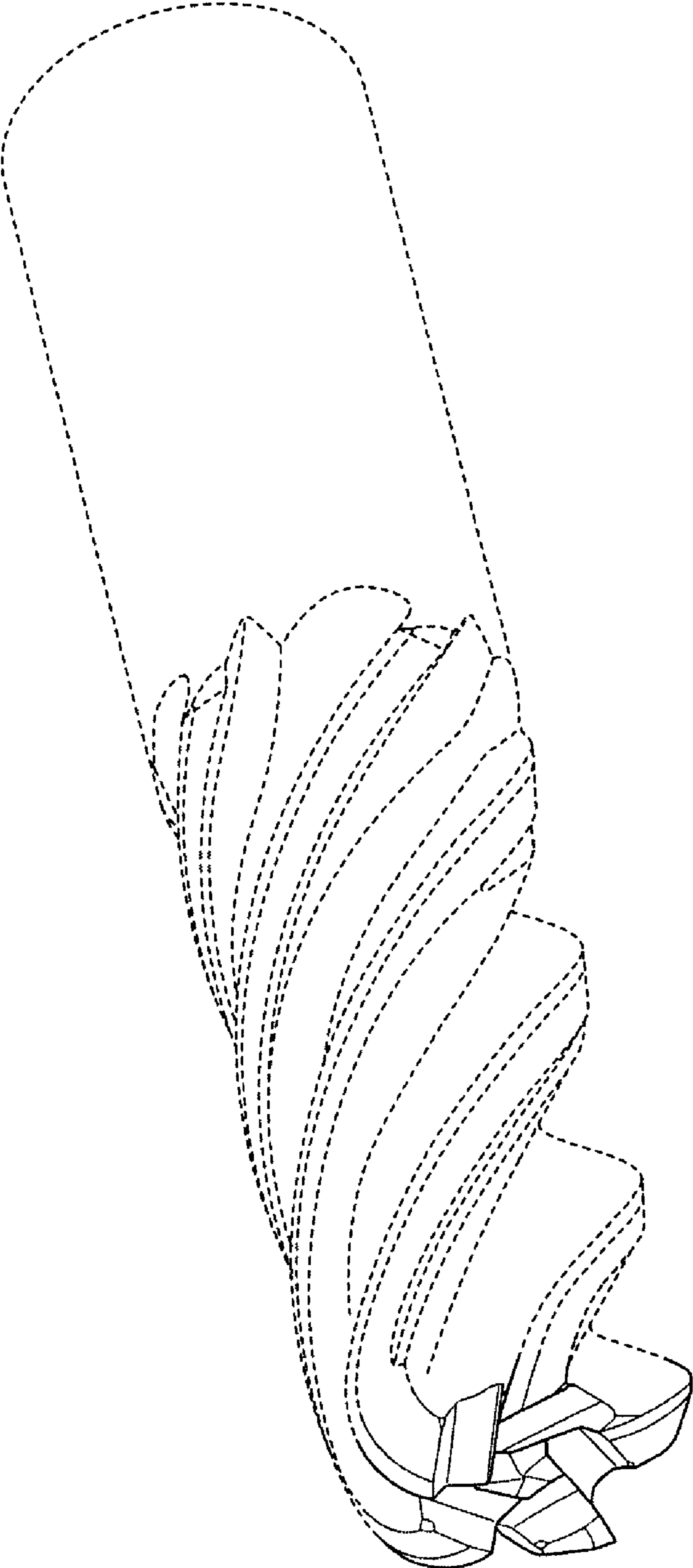

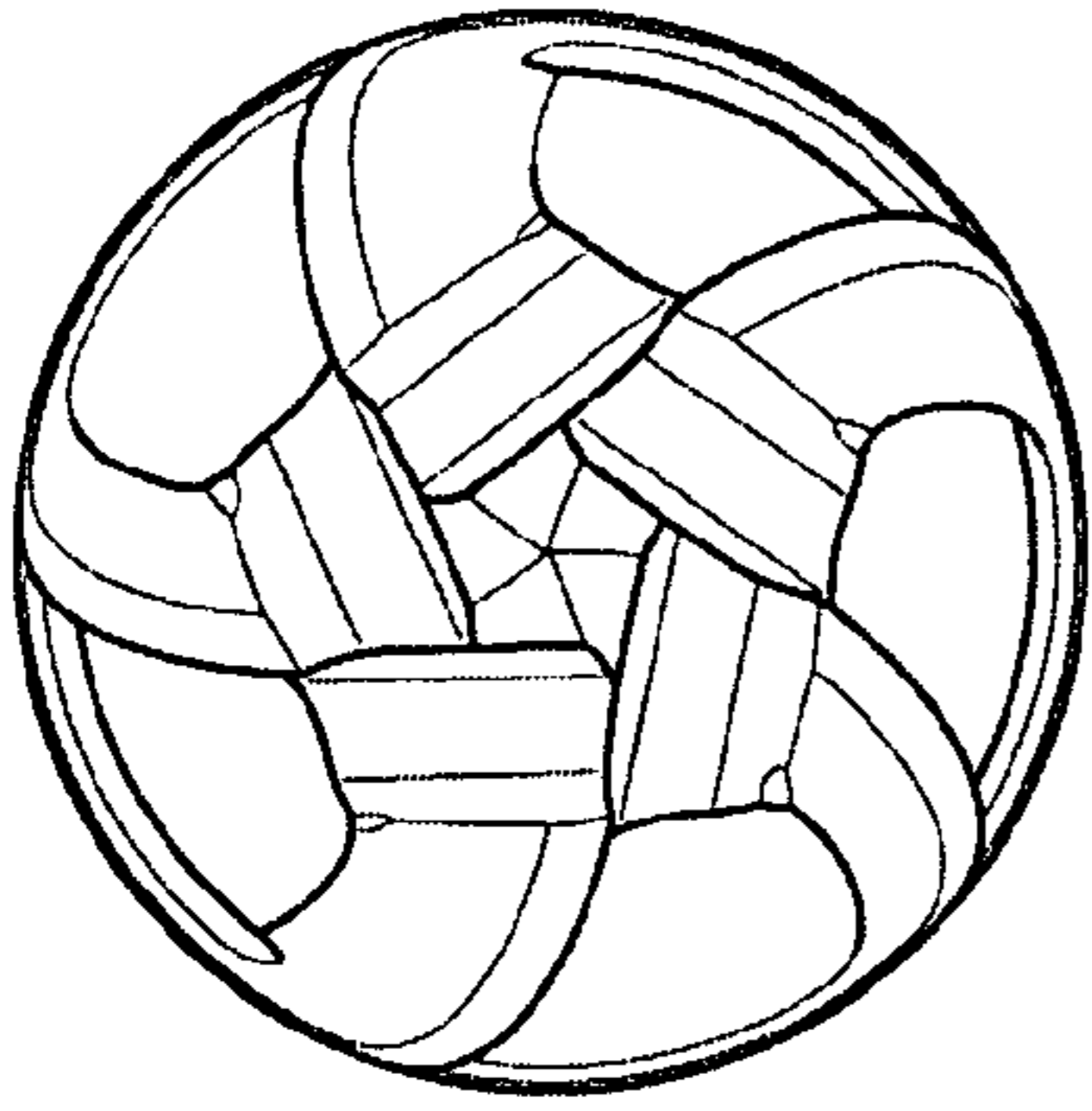

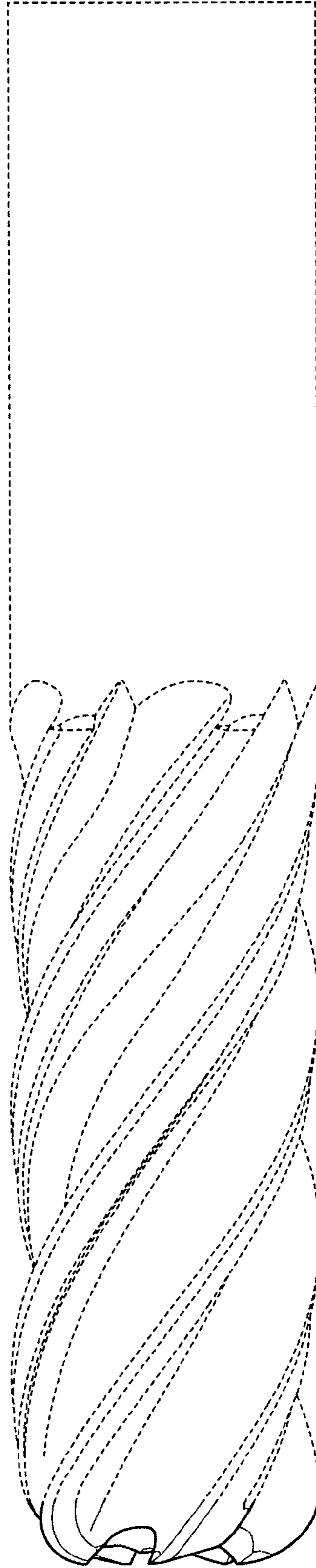
