(57) **CLAIM**

The ornamental design for a guitar, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a guitar showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is an enlarged fragmentary view of the guitar headstock thereof; the neck and body of the guitar omitted for ease of illustration.

The broken lines shown in FIGS. 1 and 3-7 are included for the purpose of illustrating environmental structure and form no part of the claimed design.

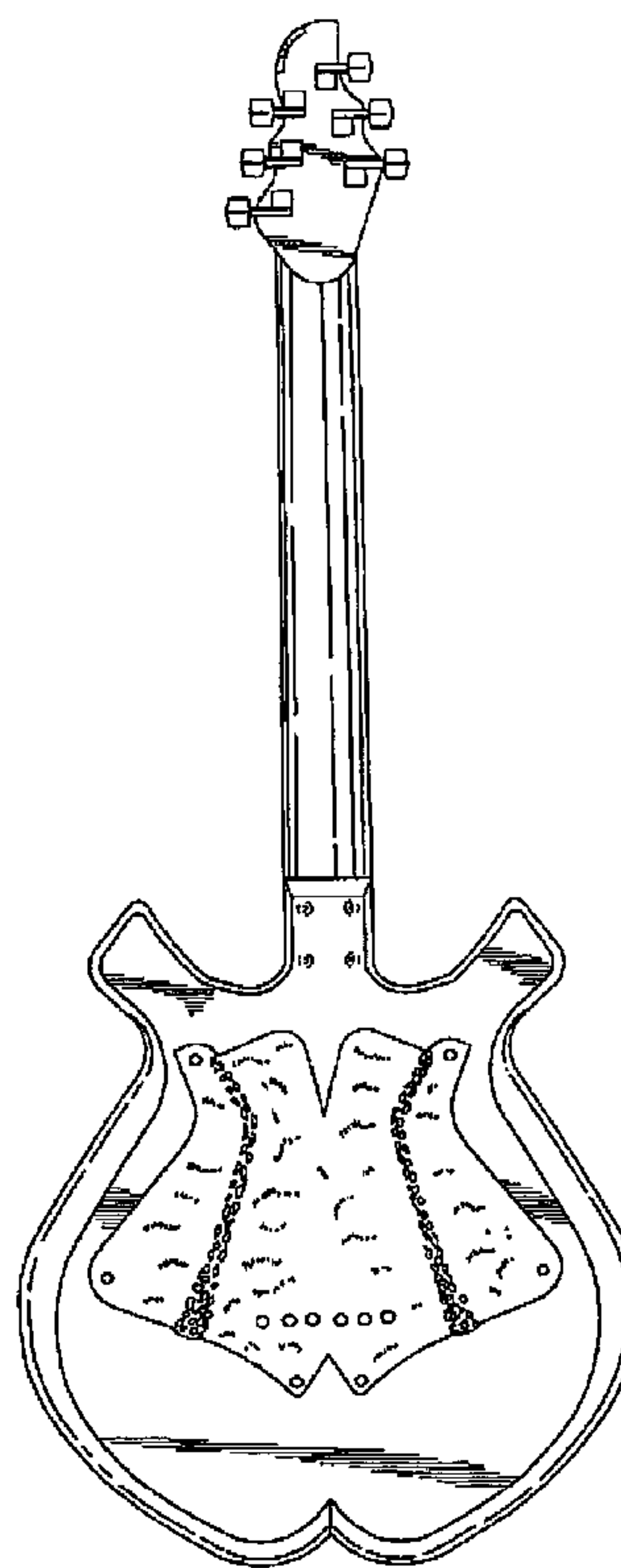
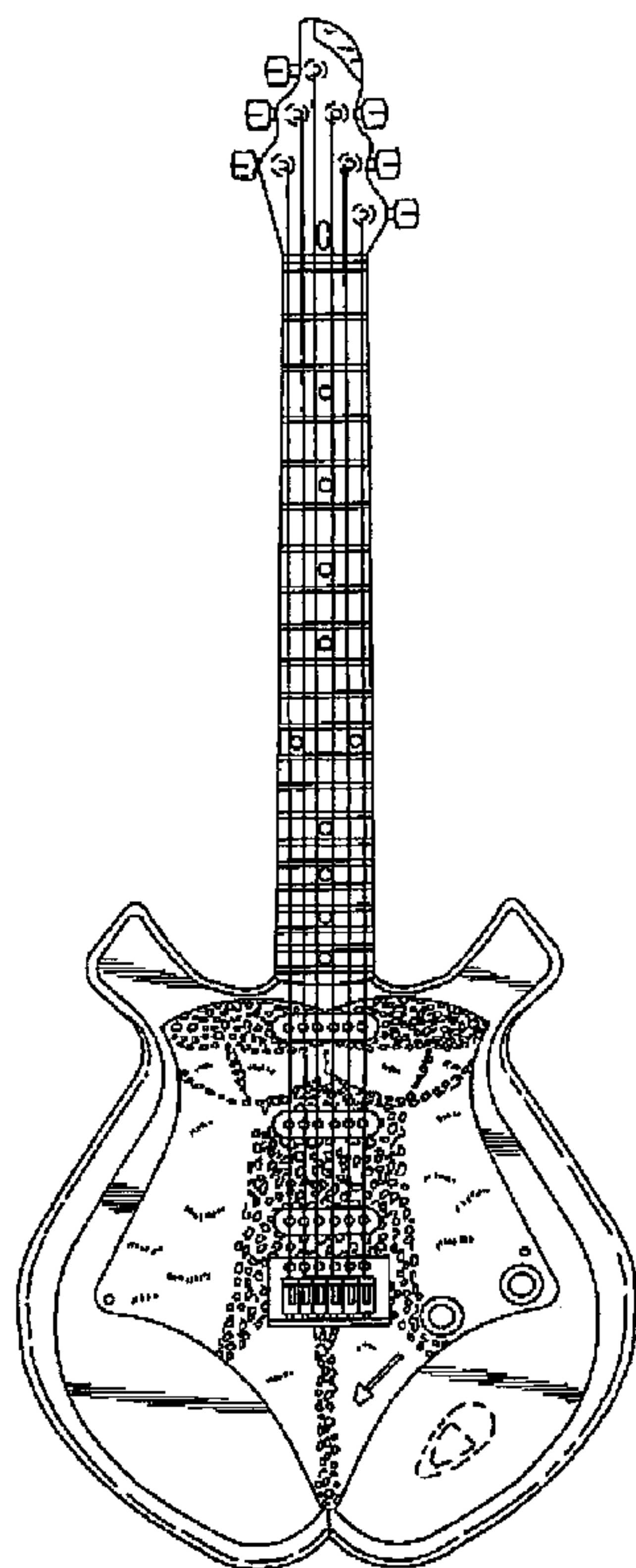

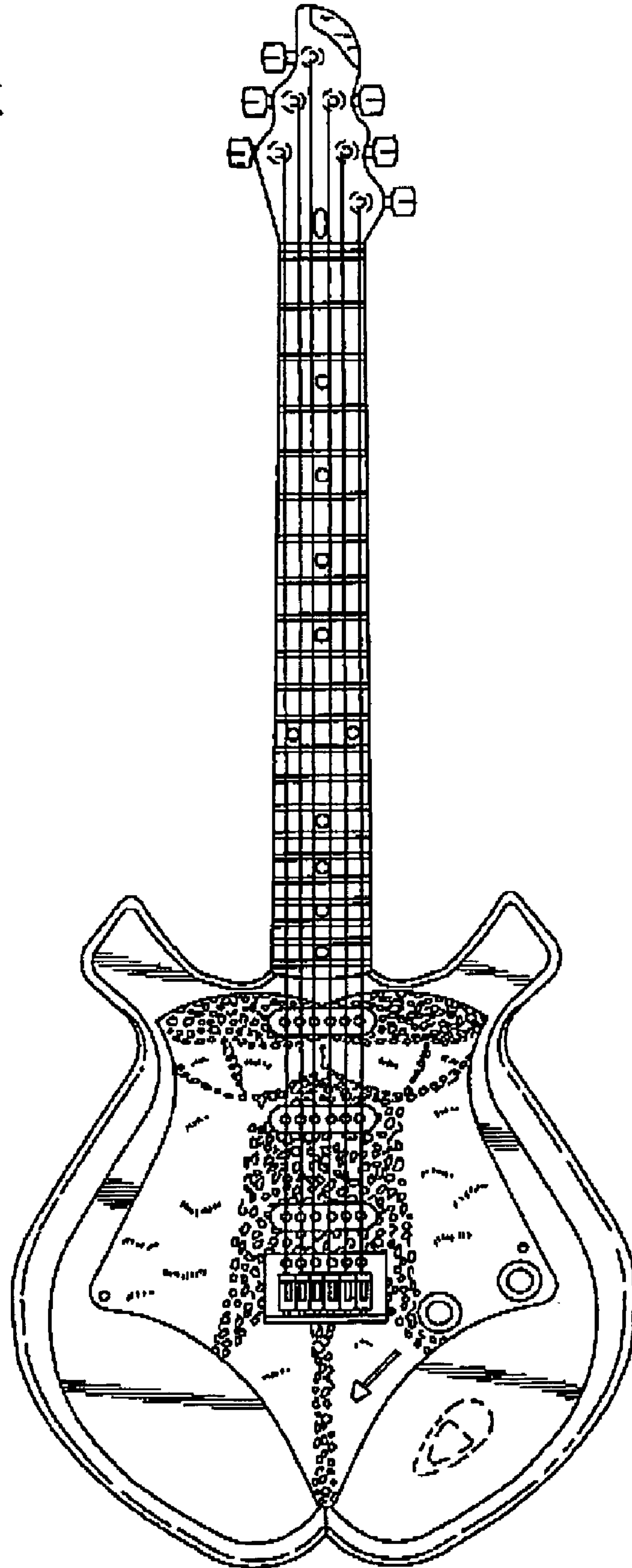

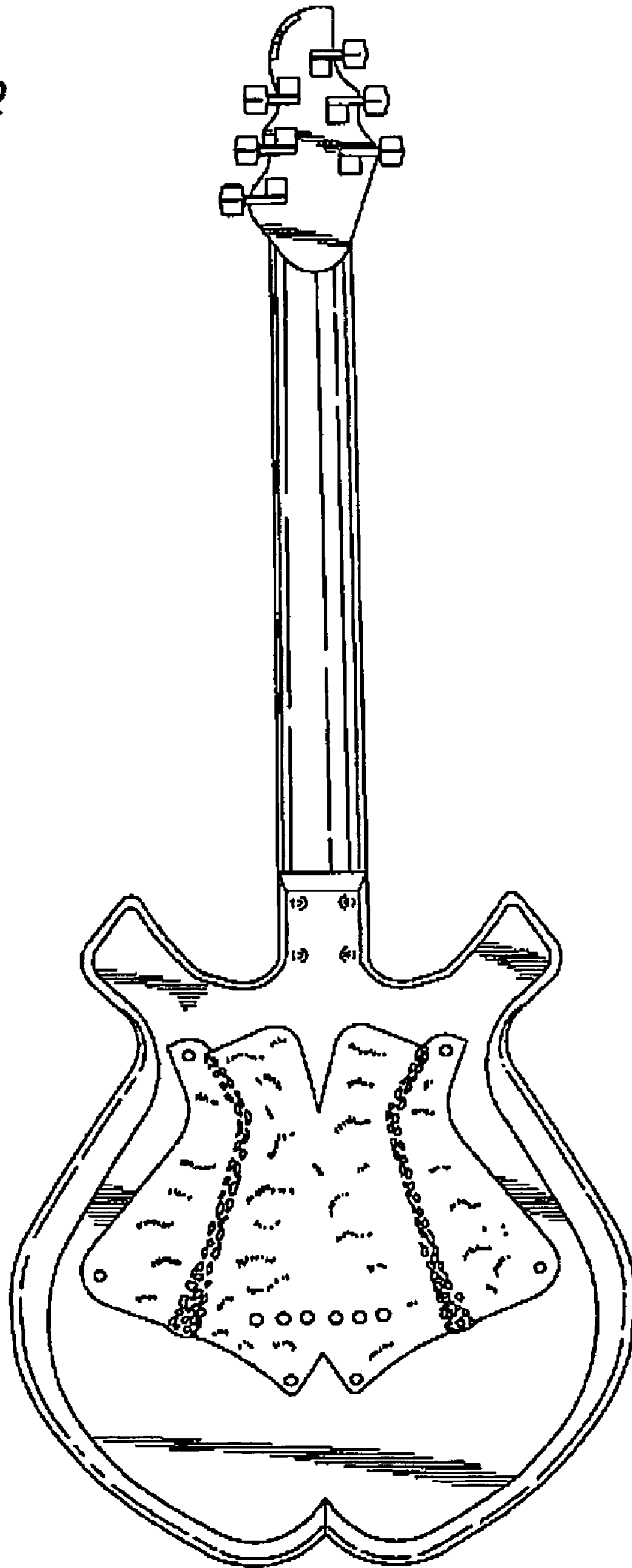

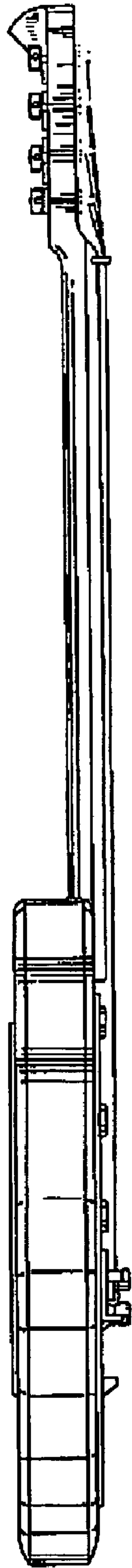

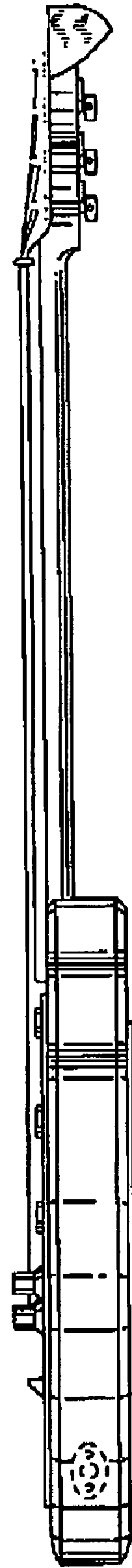

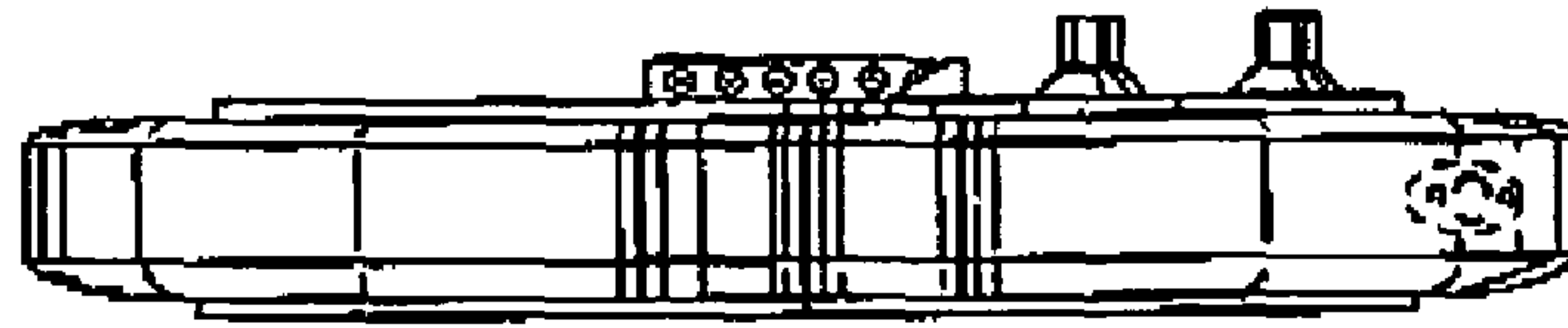

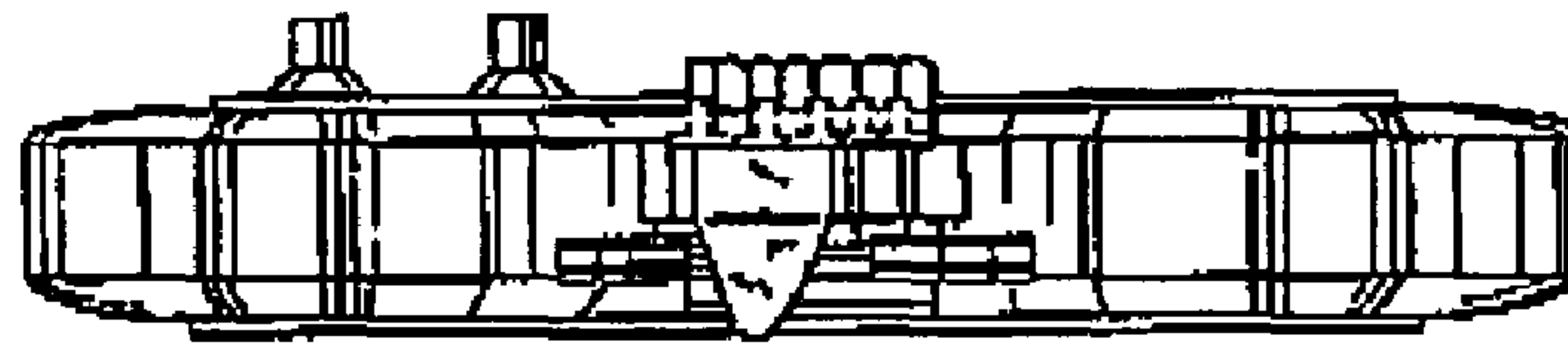
