(57) **CLAIM**

The ornamental design for an insert for a wire-bound notebook, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my insert for a wire-bound notebook;

FIG. 2 is a rear perspective view of my insert for a wire-bound notebook of FIG. 1; and,

FIG. 3 is a top plan view of my insert for a wire-bound notebook of FIG. 1 in use on a wire-bound notebook.
