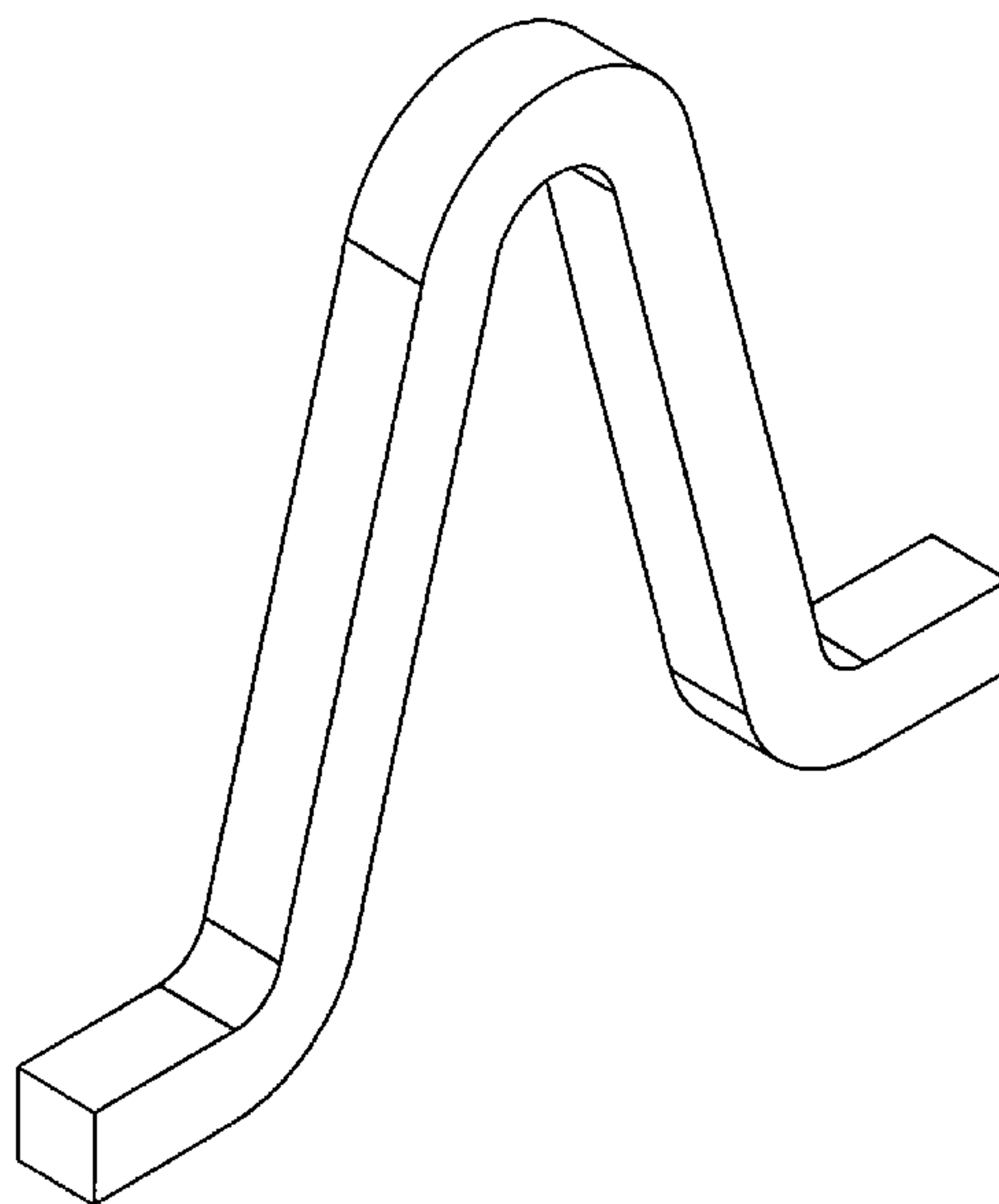
(57) **CLAIM**

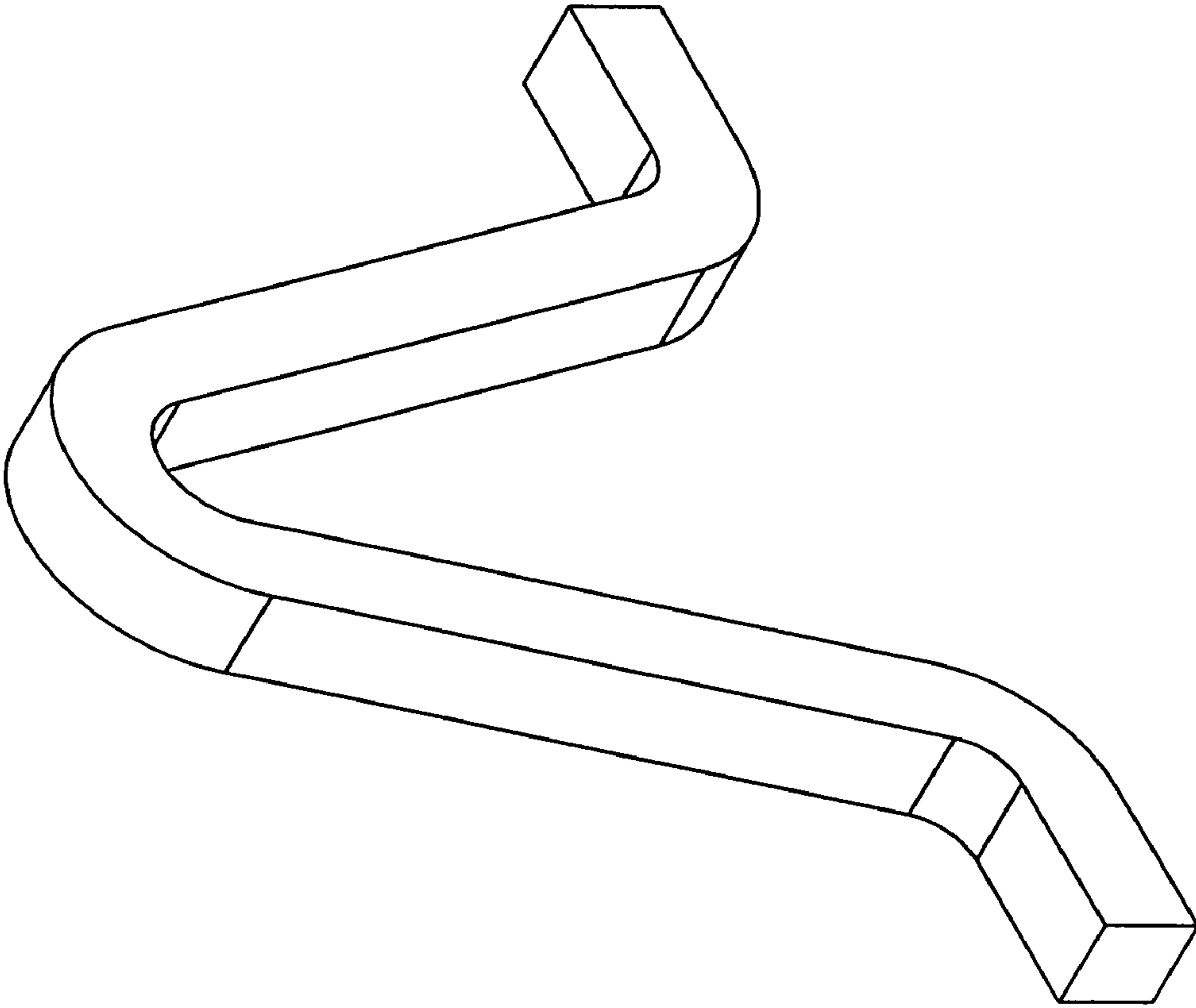
The ornamental design for a flat anchor for tilt-up concrete slabs, as shown and described.

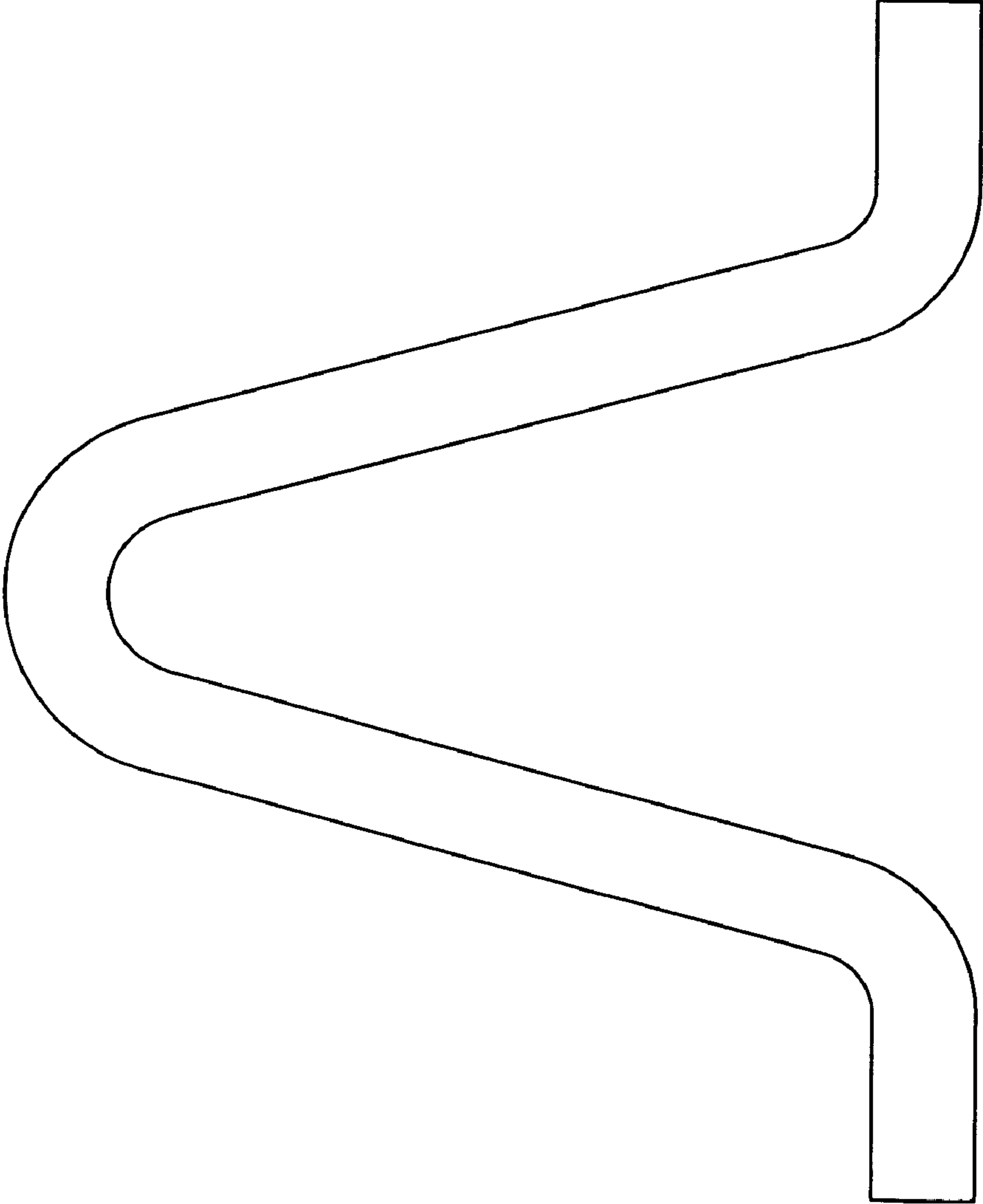
