The ornamental design for a cone sleeve, as shown and described.

DESCRIPTION

FIG. 1 illustrates a top perspective view of the cone sleeve; FIG. 2 illustrates a front view of the cone sleeve of FIG. 1; FIG. 3 illustrates a rear view of the cone sleeve of FIG. 1; FIG. 4 illustrates a right side view of the cone sleeve of FIG. 1; FIG. 5 illustrates a left side view of the cone sleeve of FIG. 1; FIG. 6 illustrates a top view of the cone sleeve of FIG. 1; and, FIG. 7 illustrates a bottom view of the cone sleeve of FIG. 1.

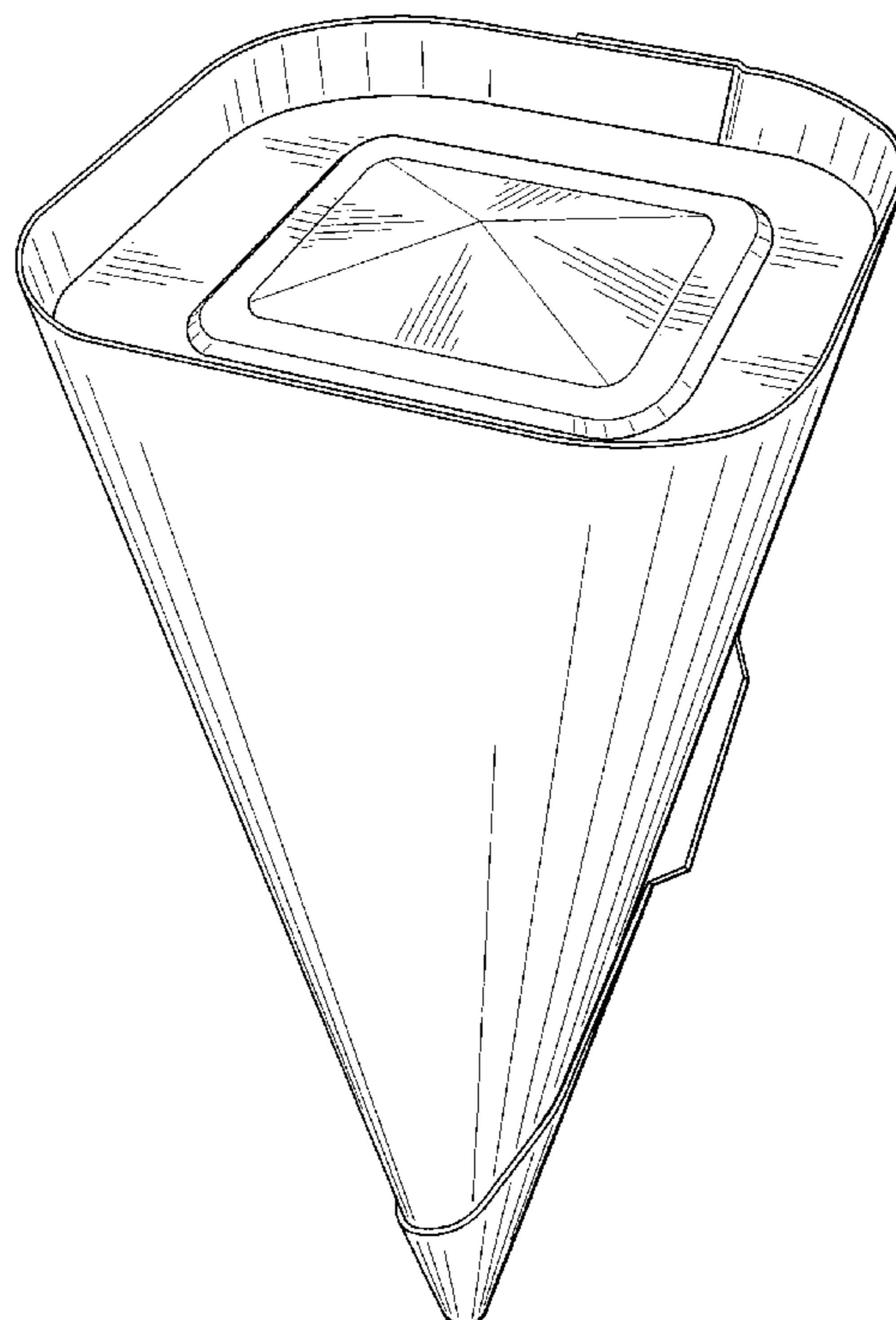

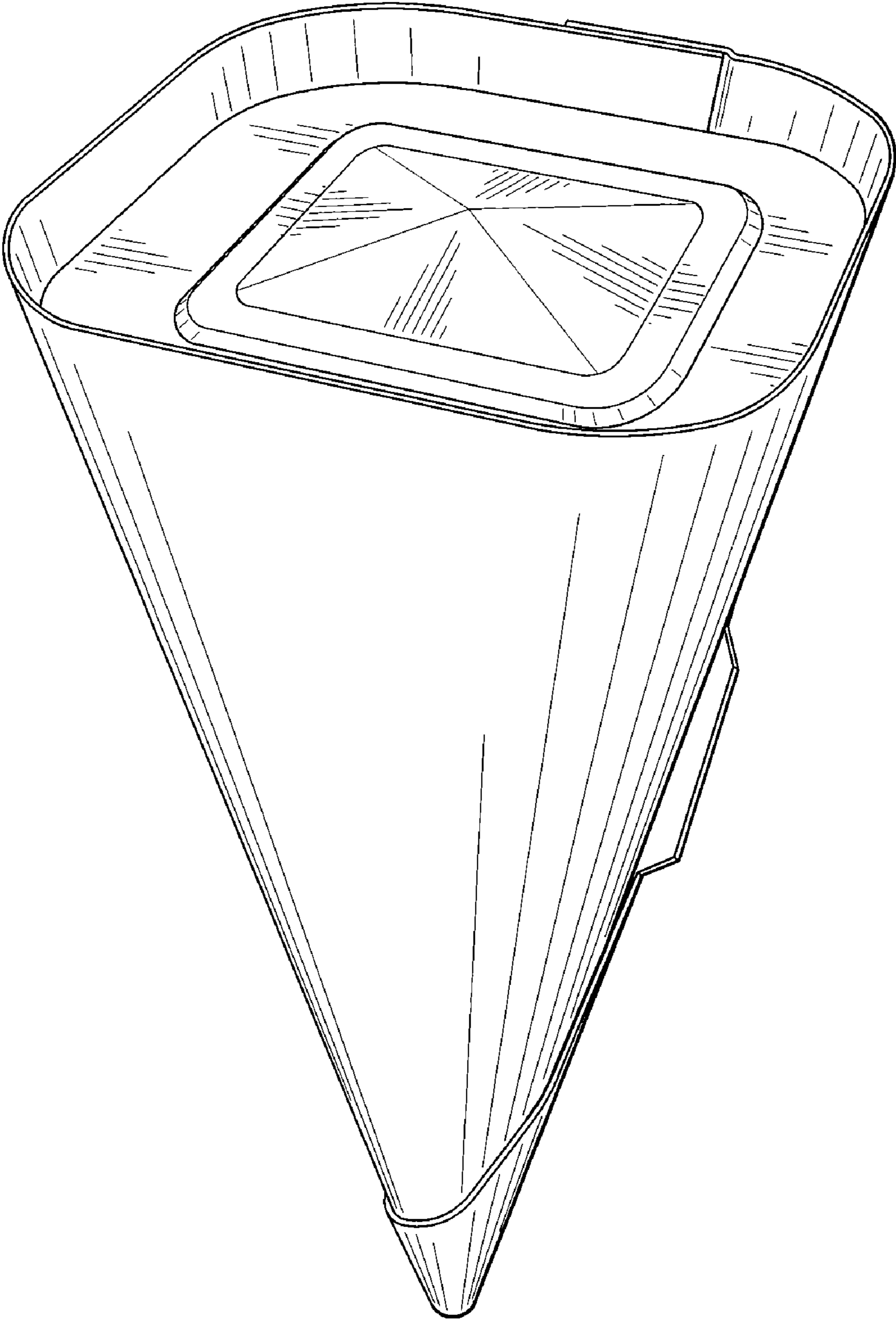

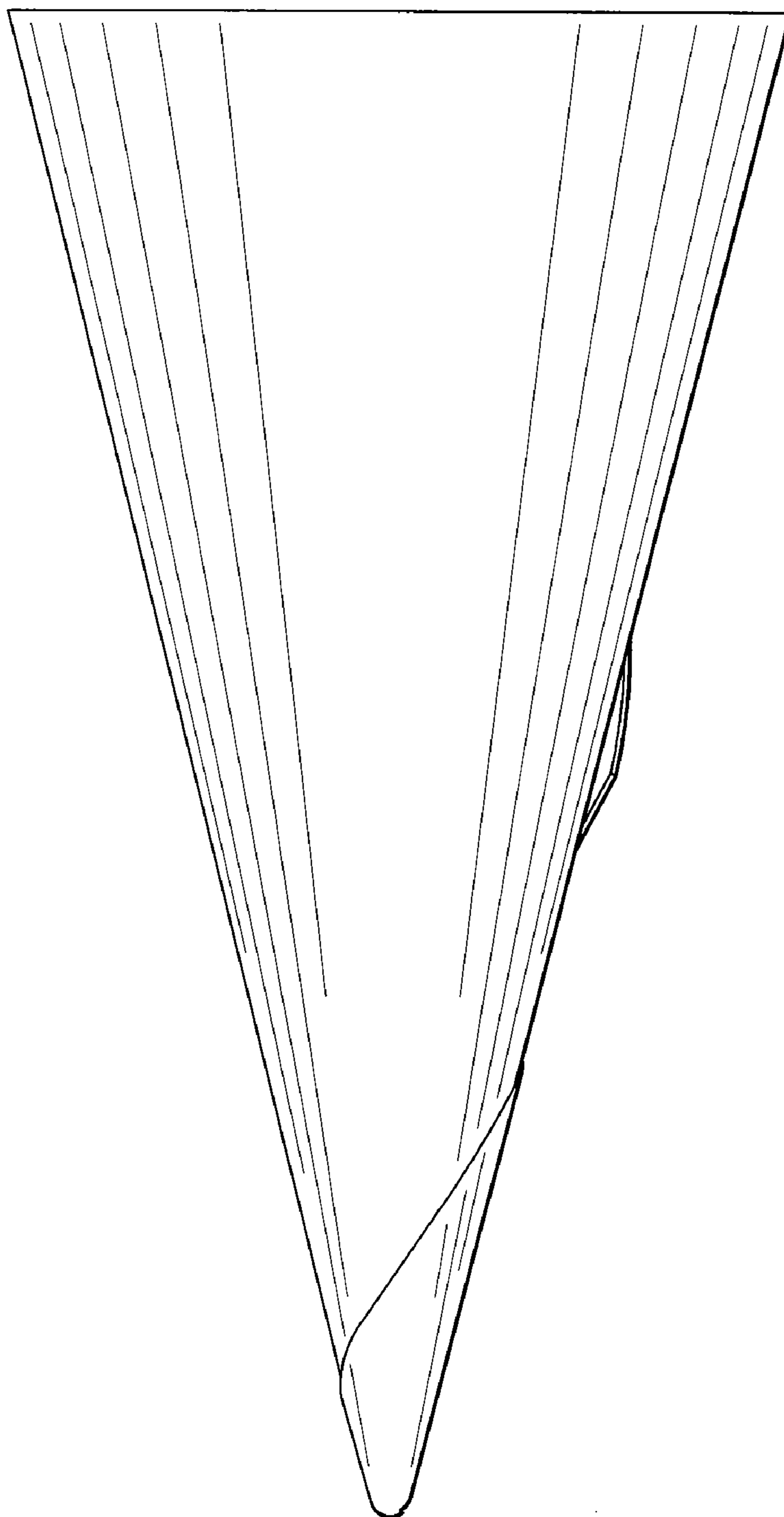

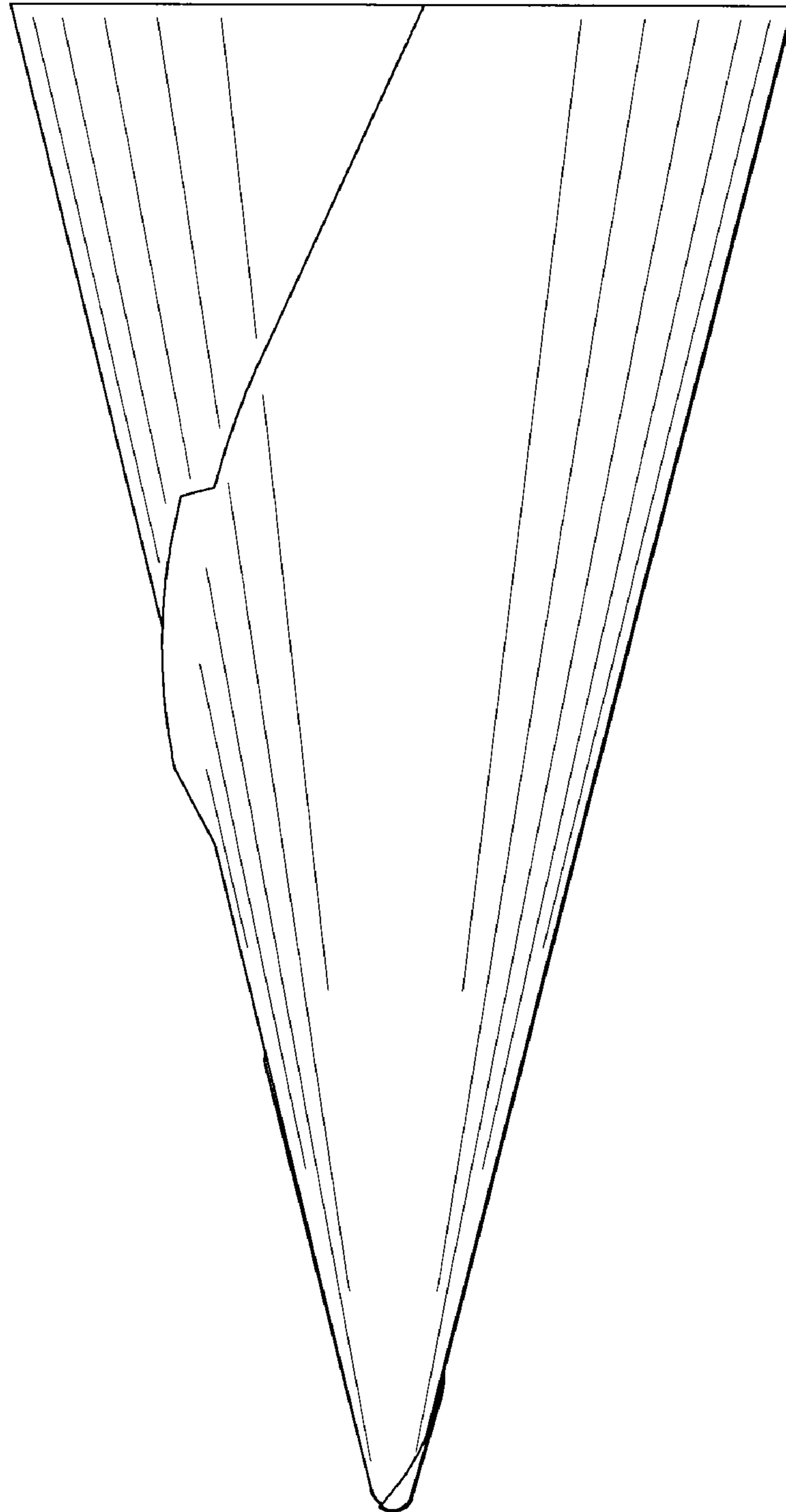

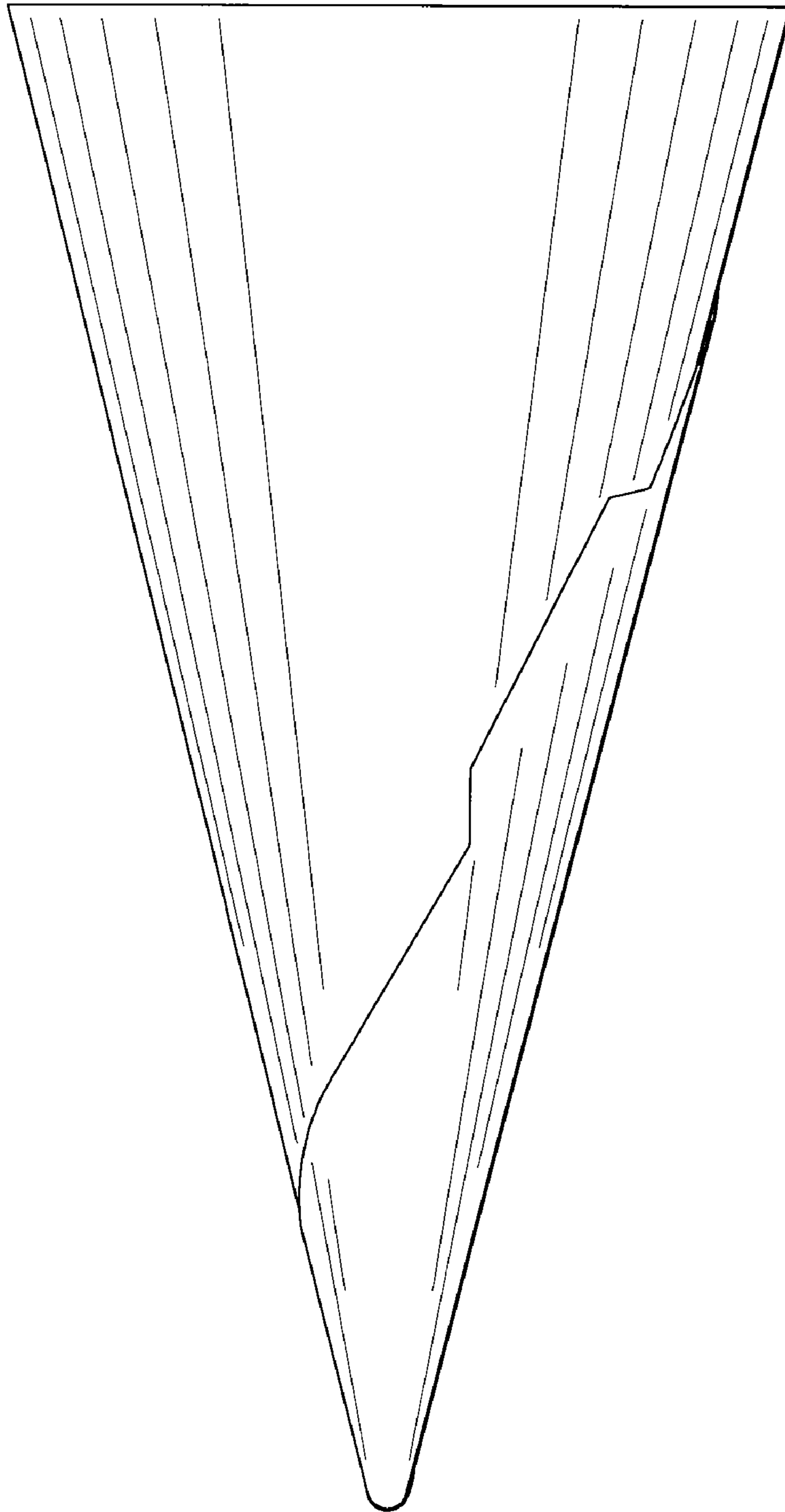

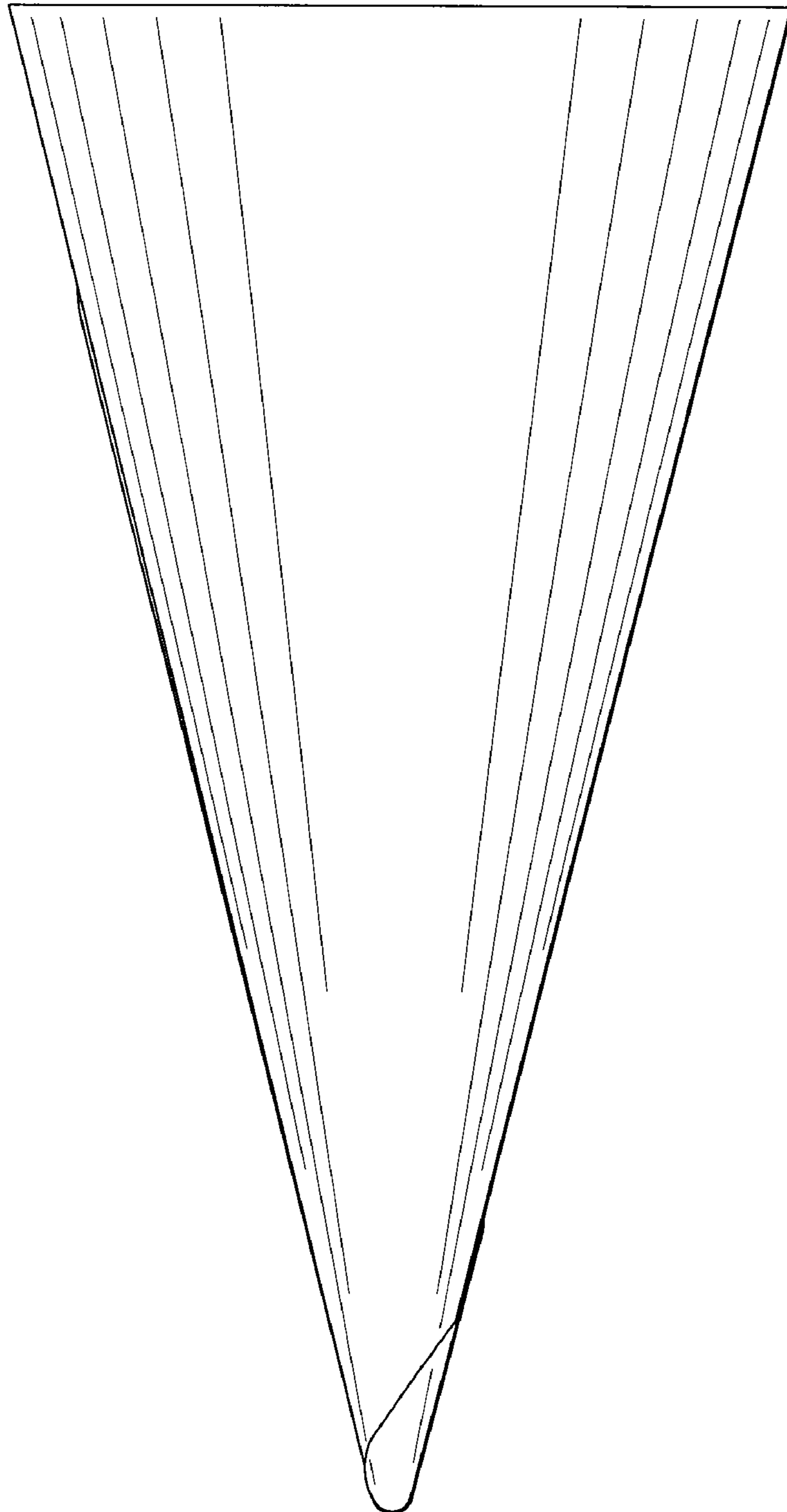

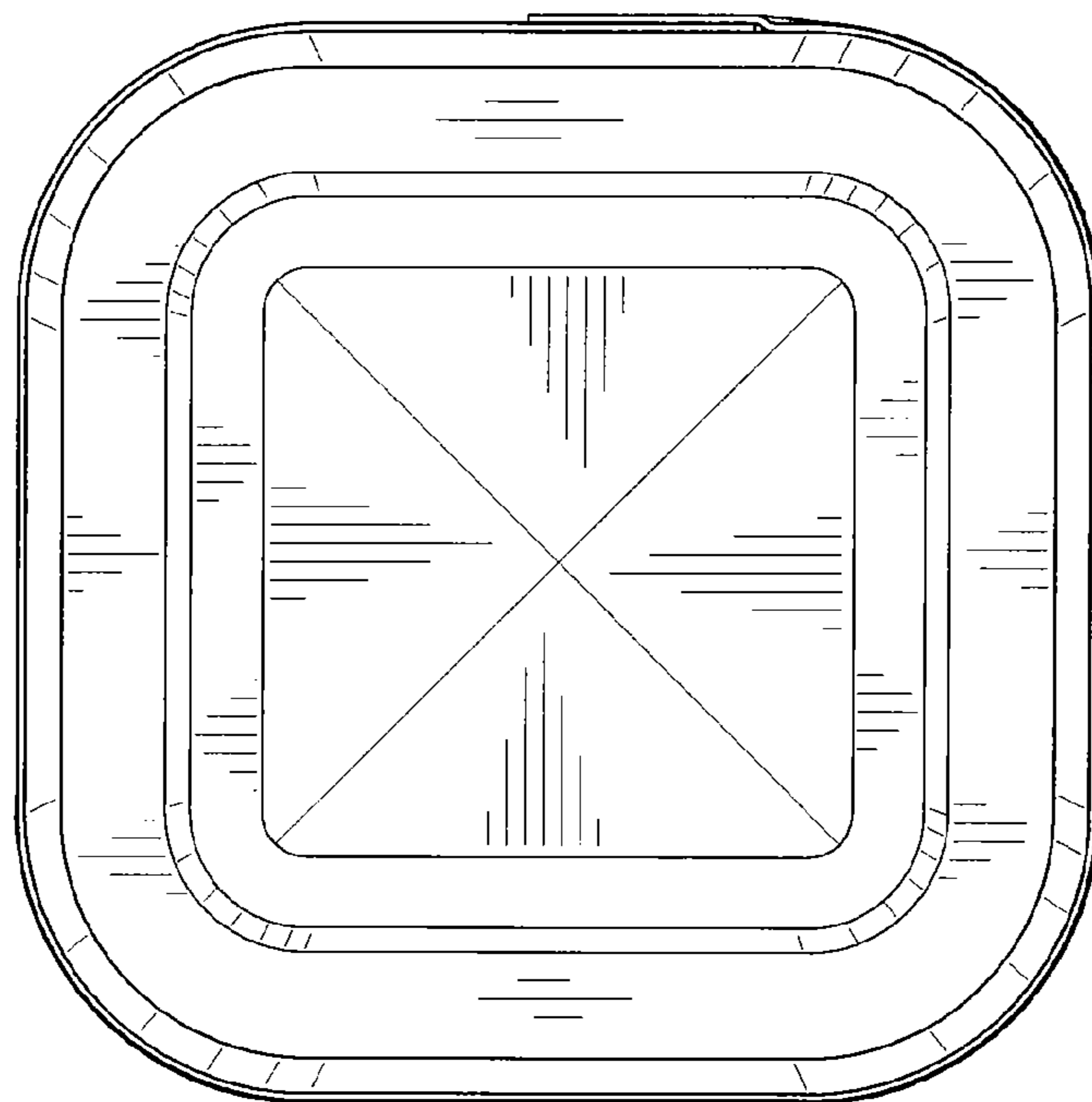
