The ornamental design for a backpack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of the backpack;

FIG. 2 front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a back perspective view thereof;

FIG. 5 is a left side elevational view thereof;

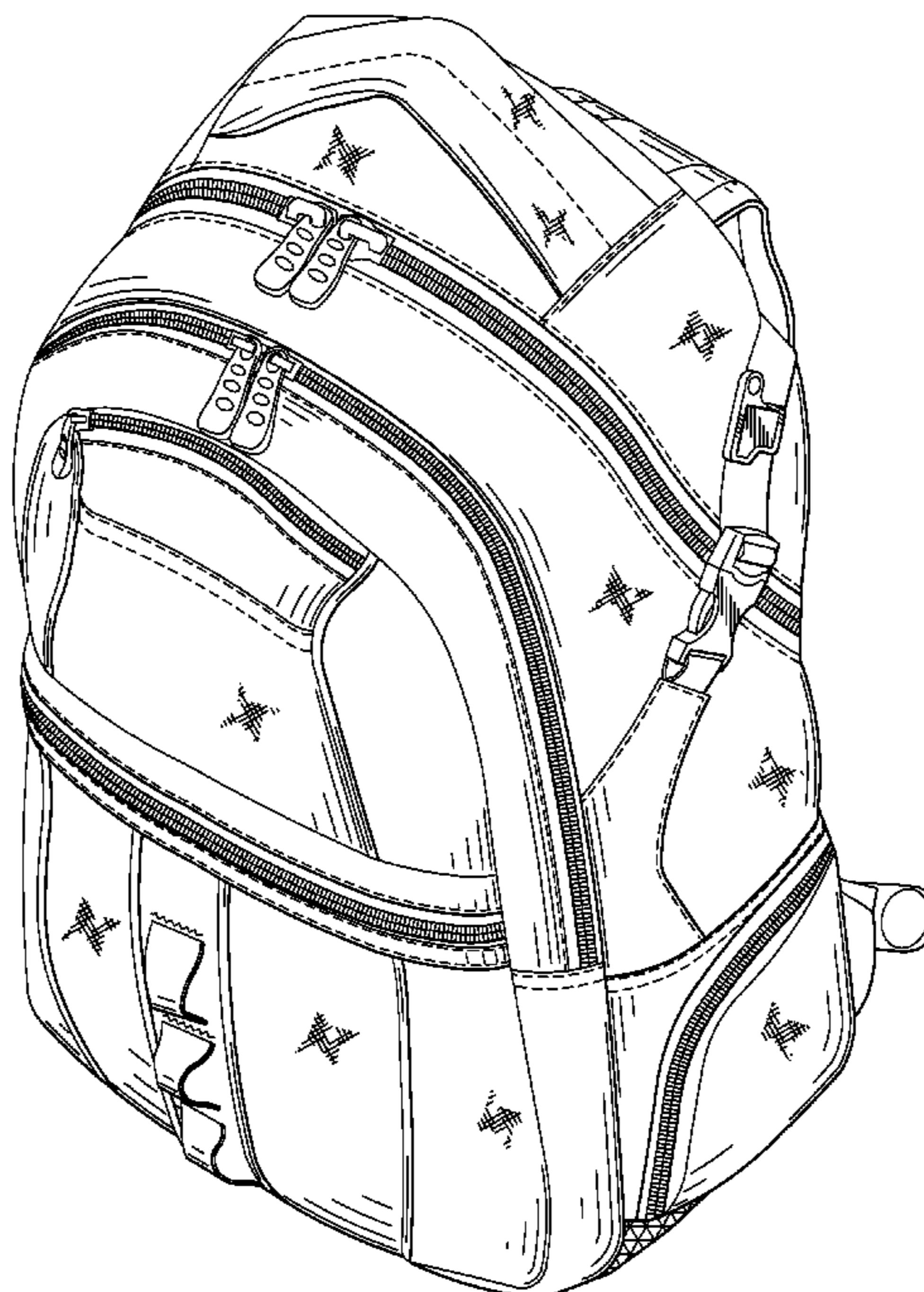
FIG. 6 is a top plan view thereof;

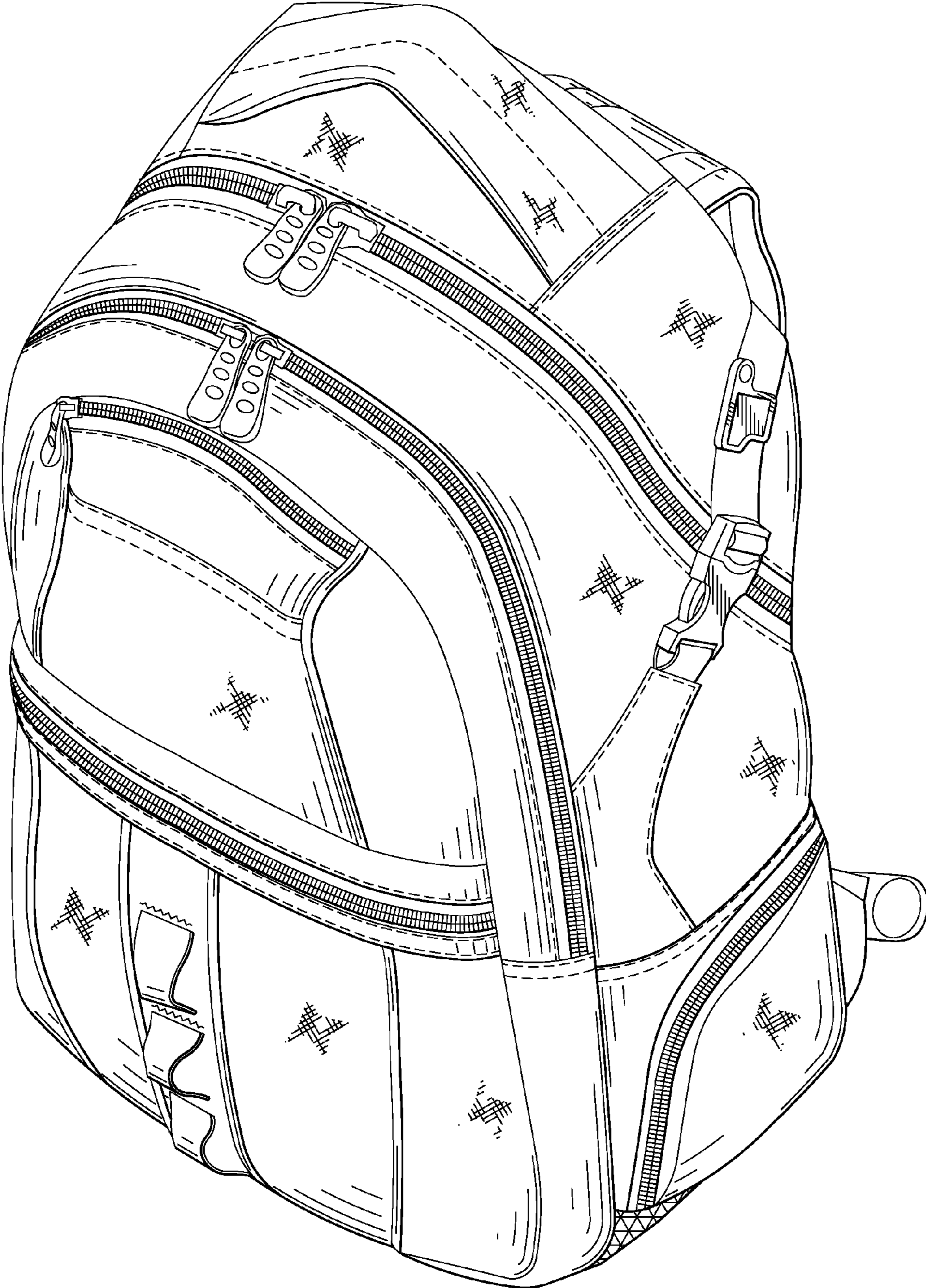

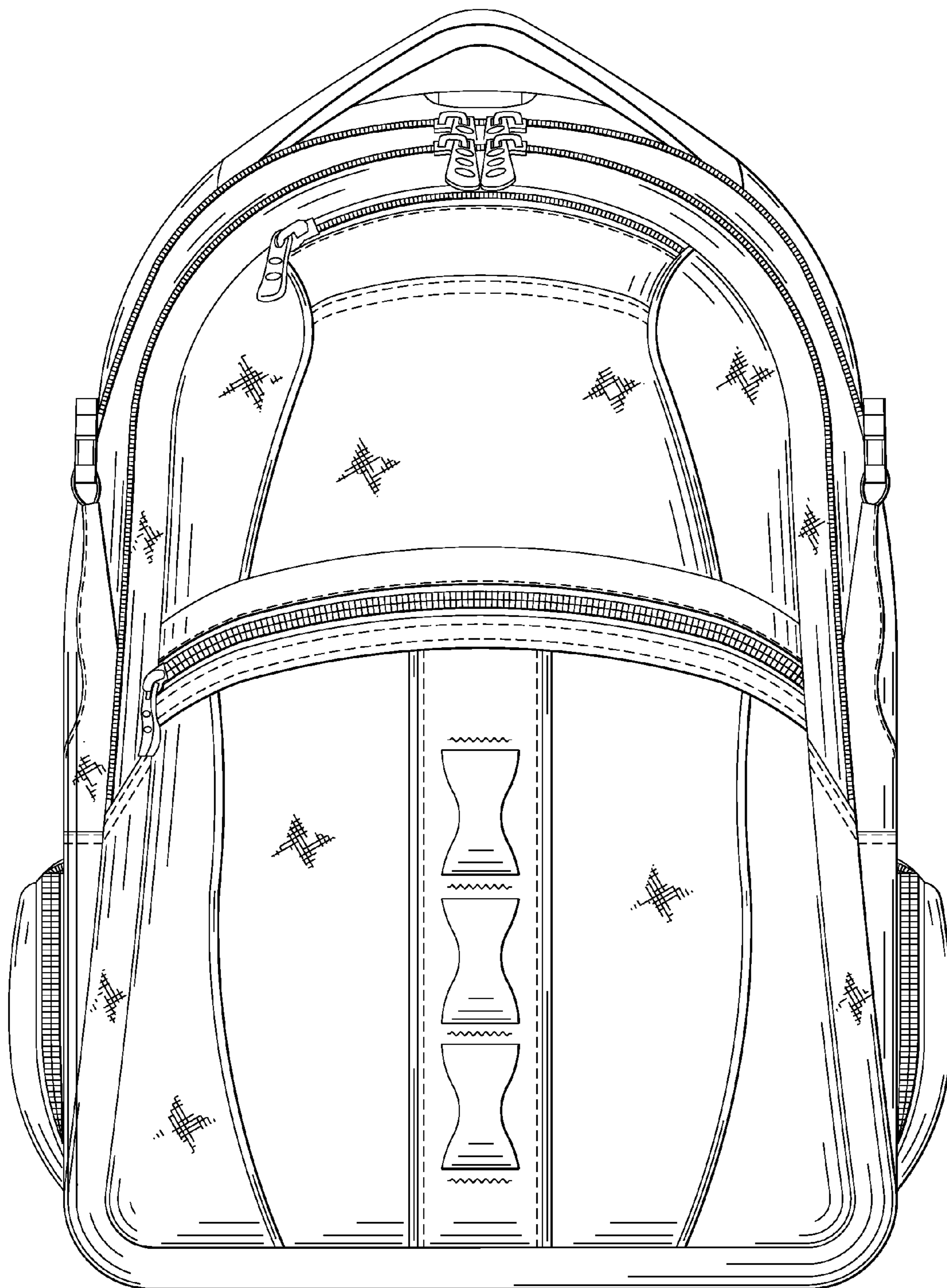

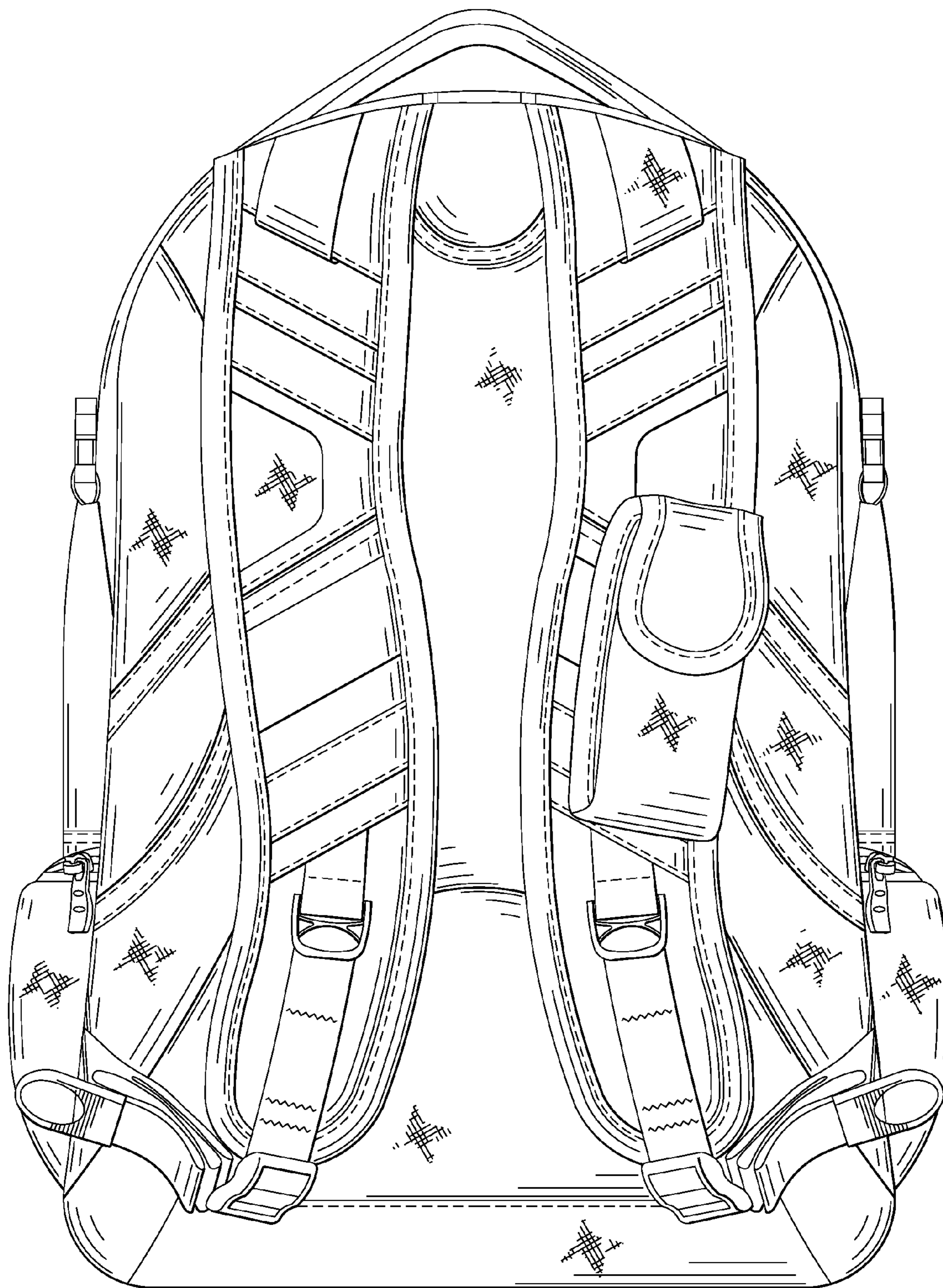

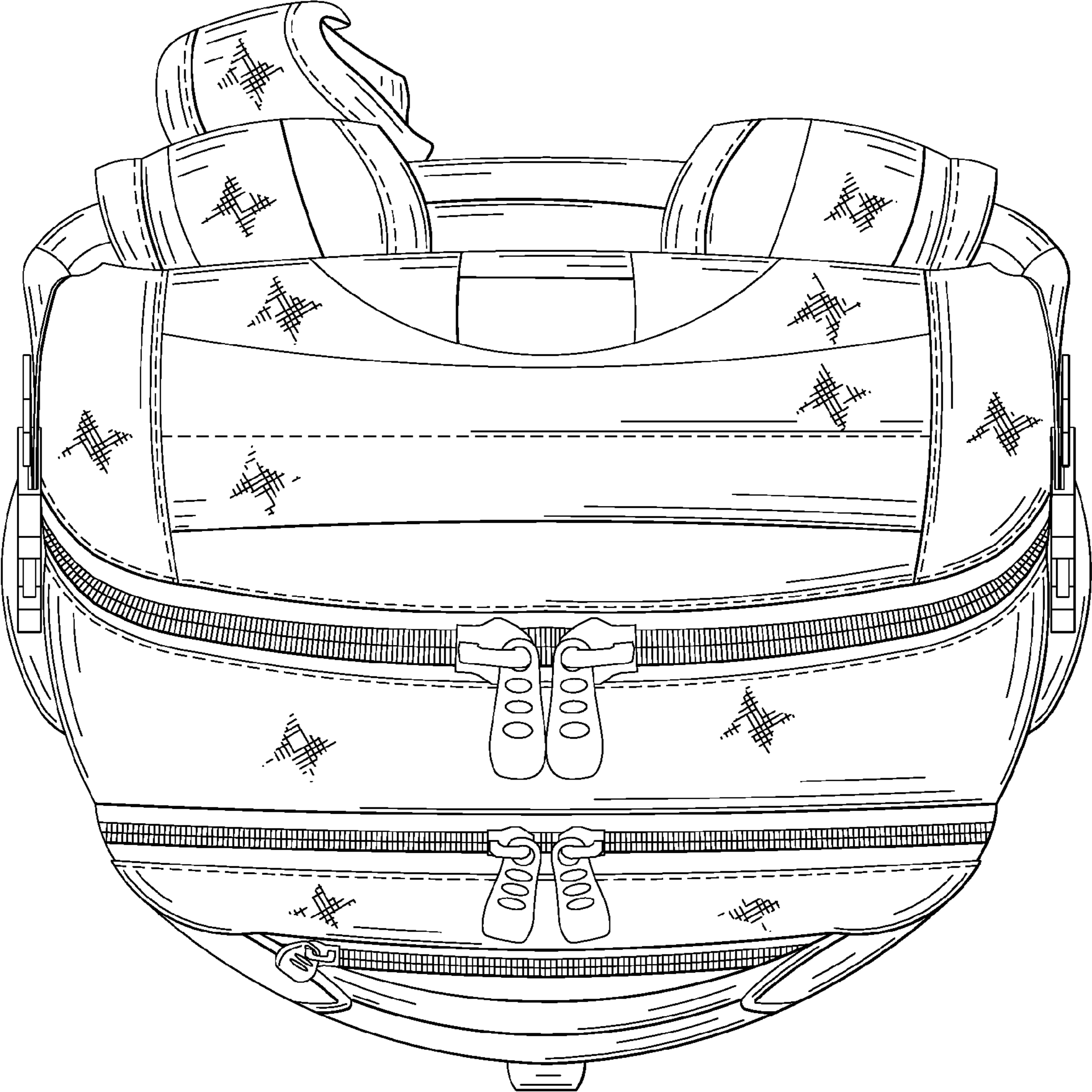

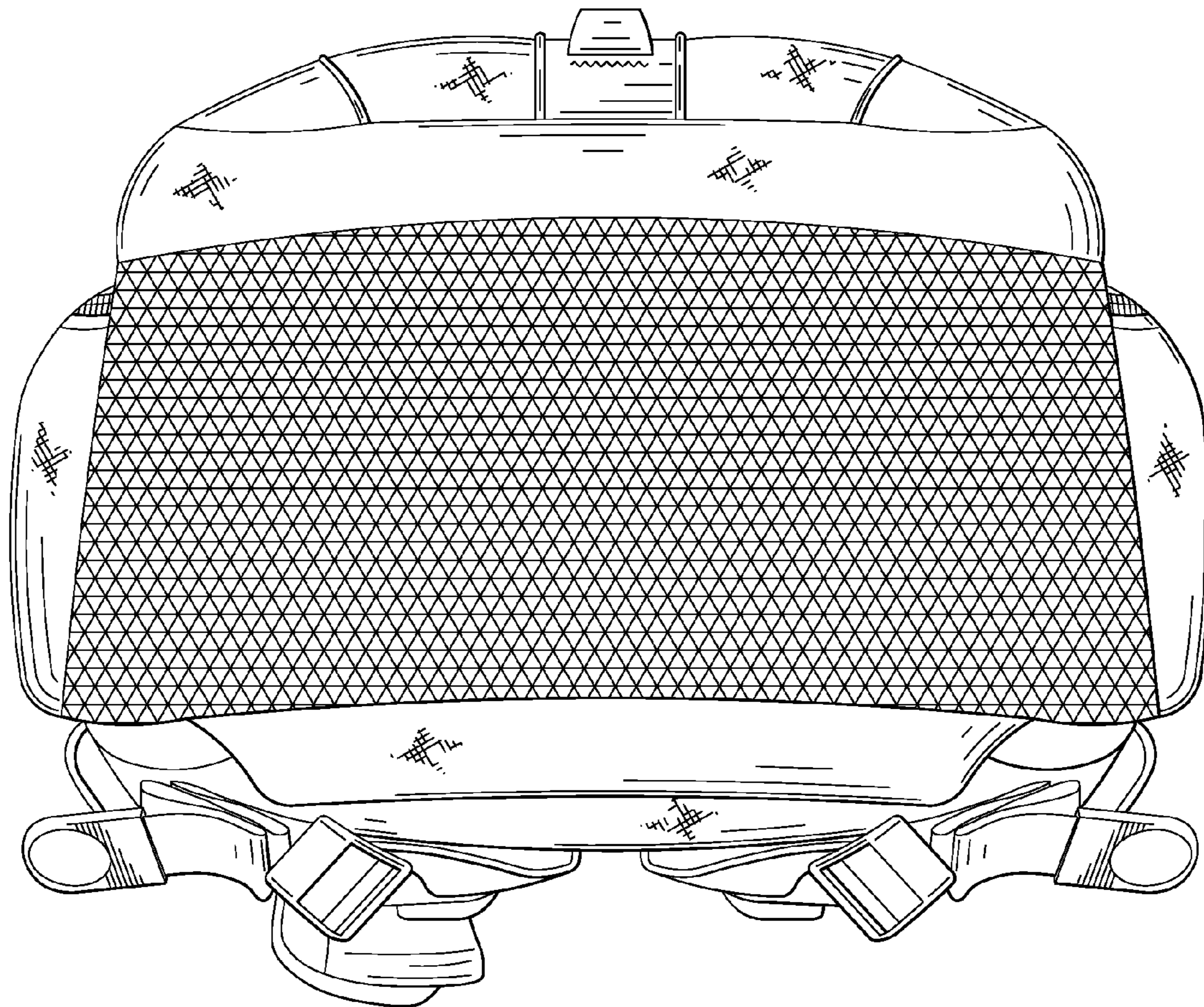

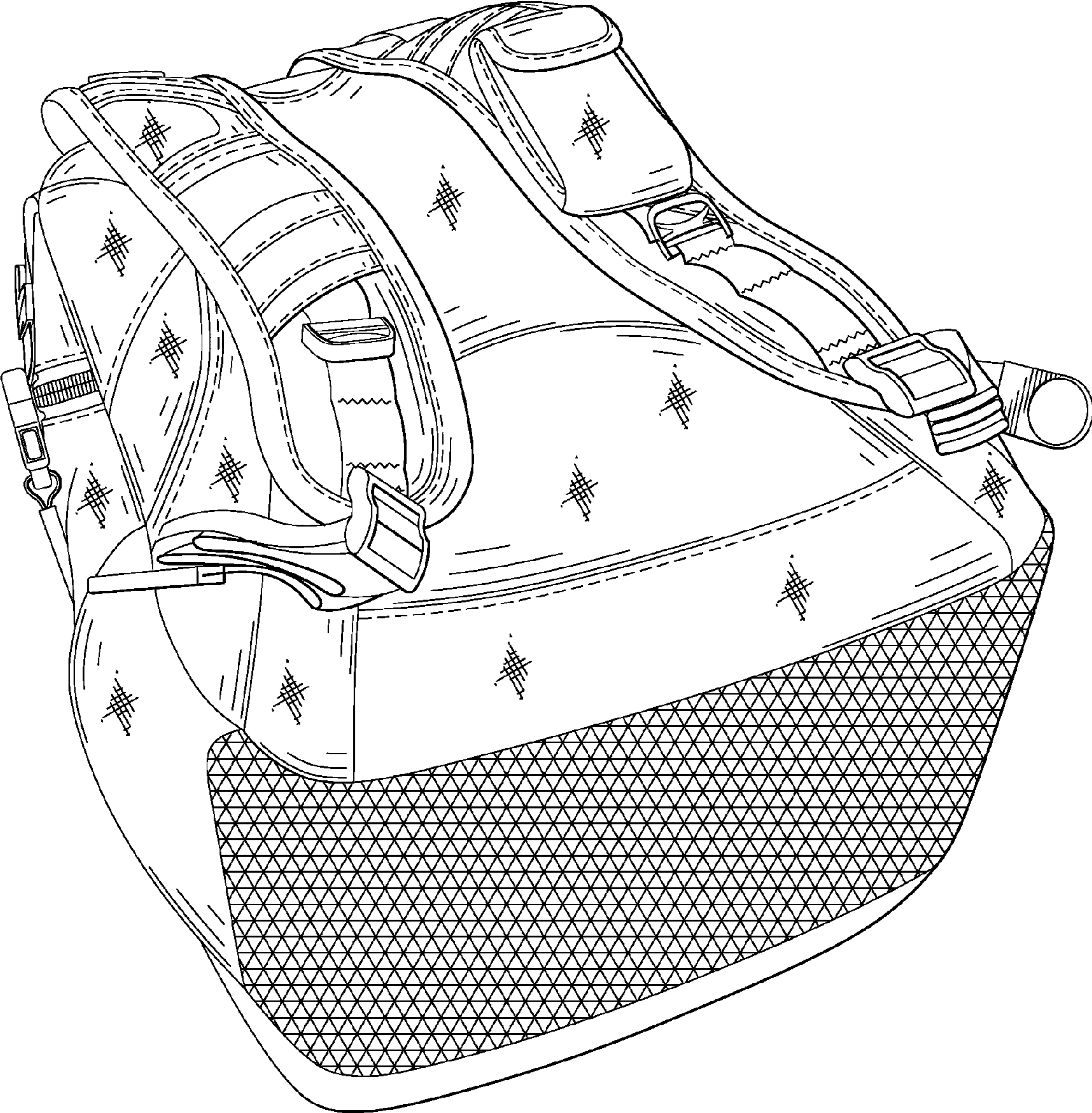
