(57) **CLAIM**

The ornamental design for a finger-shaped container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective left side view of a finger-shaped container showing my new design.

FIG. 2 is a top plan view of the container of FIG. 1.

FIG. 3 is a bottom plan view of the container shown in FIG. 1.

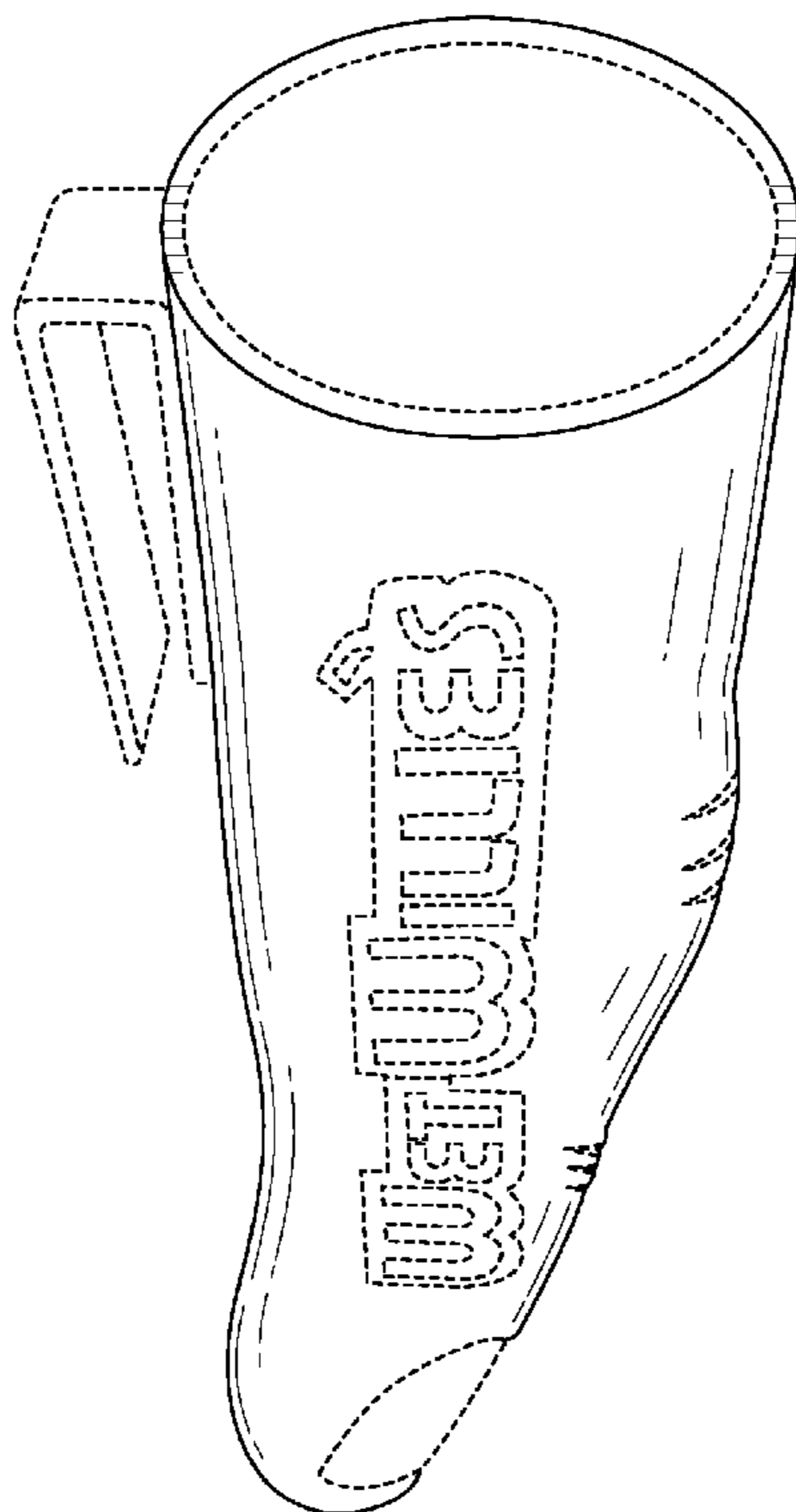
FIG. 4 is an elevational view of the right side of the container shown in FIG. 1.

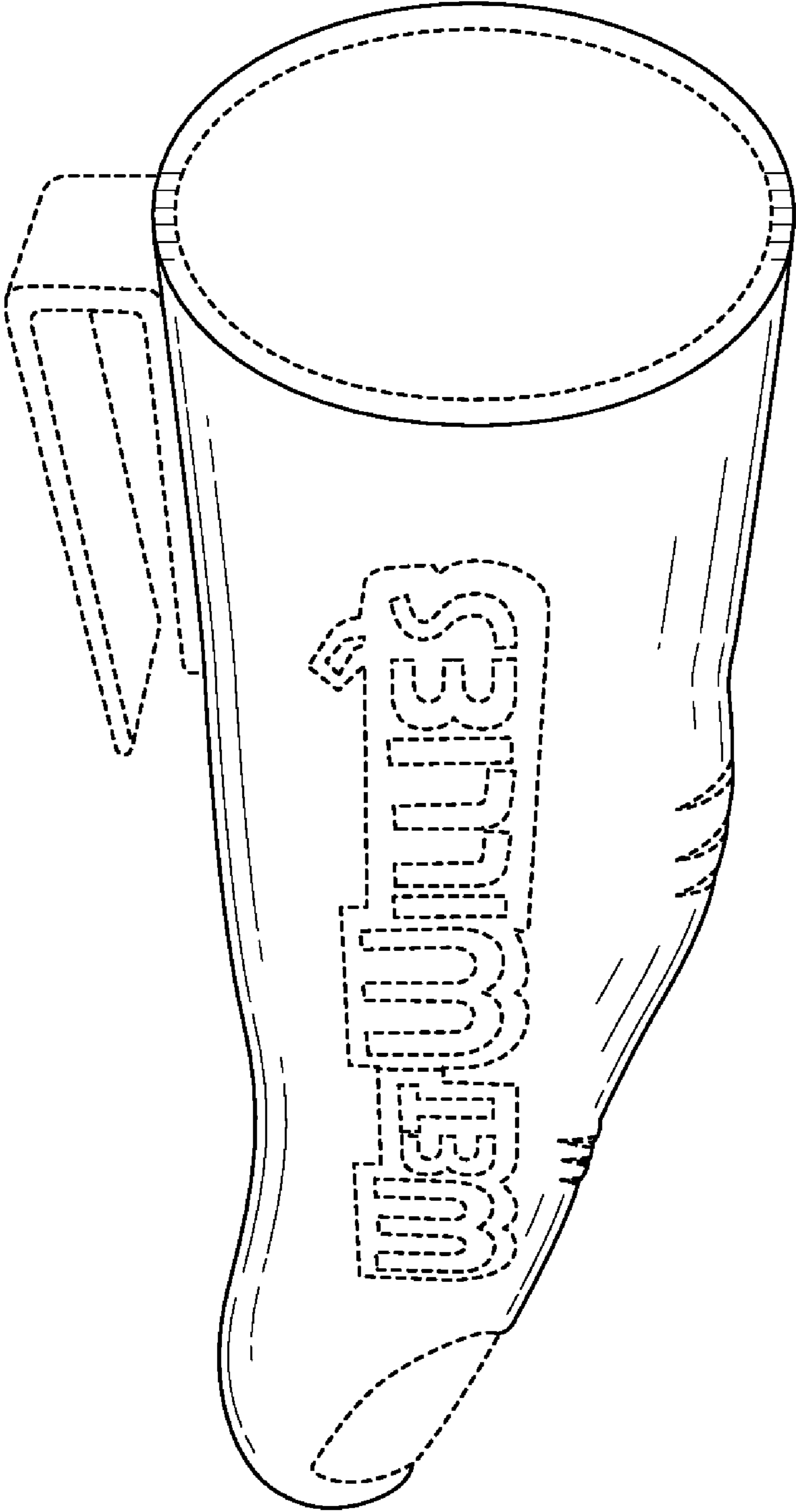

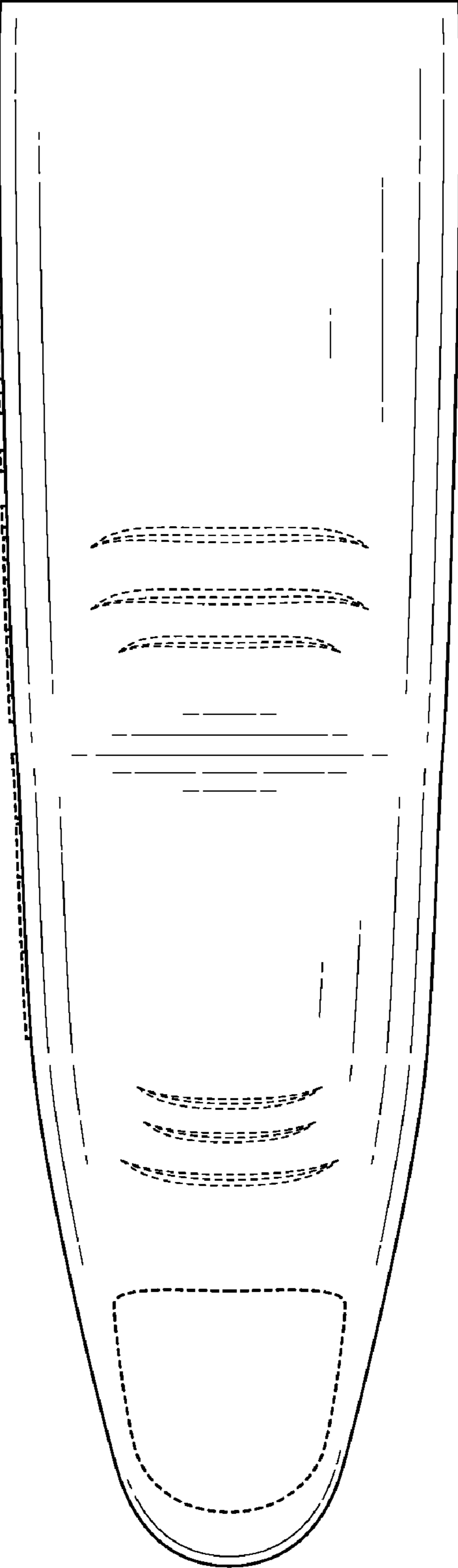

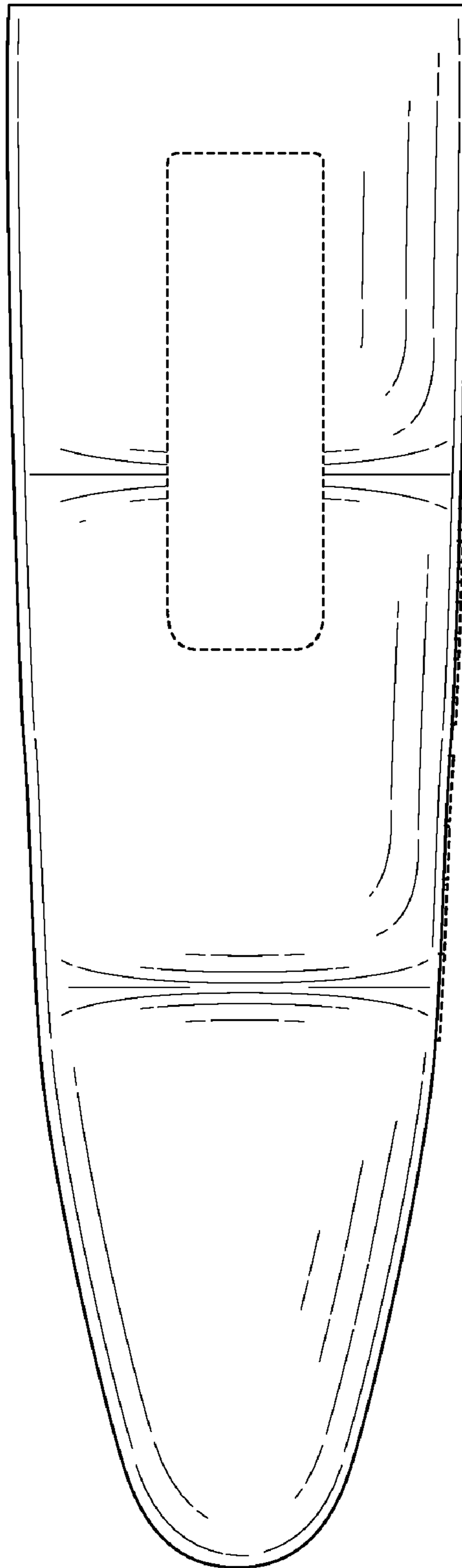

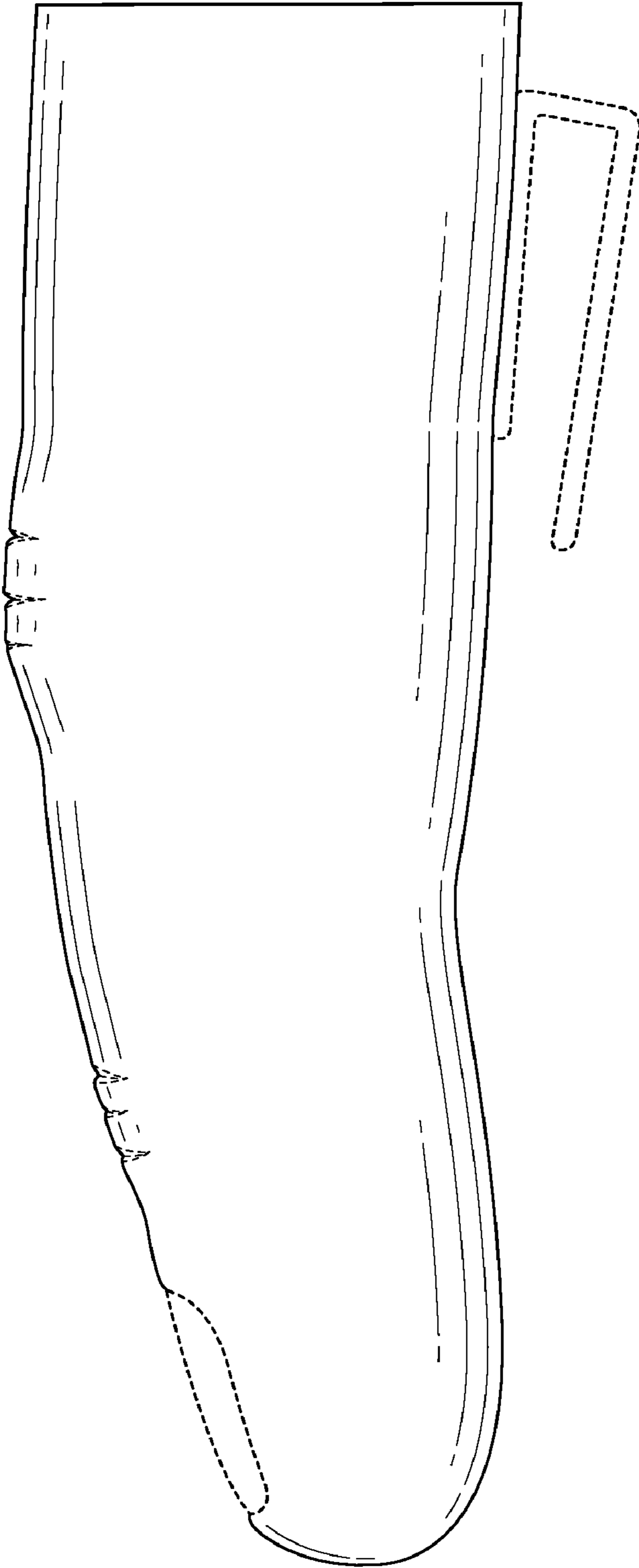

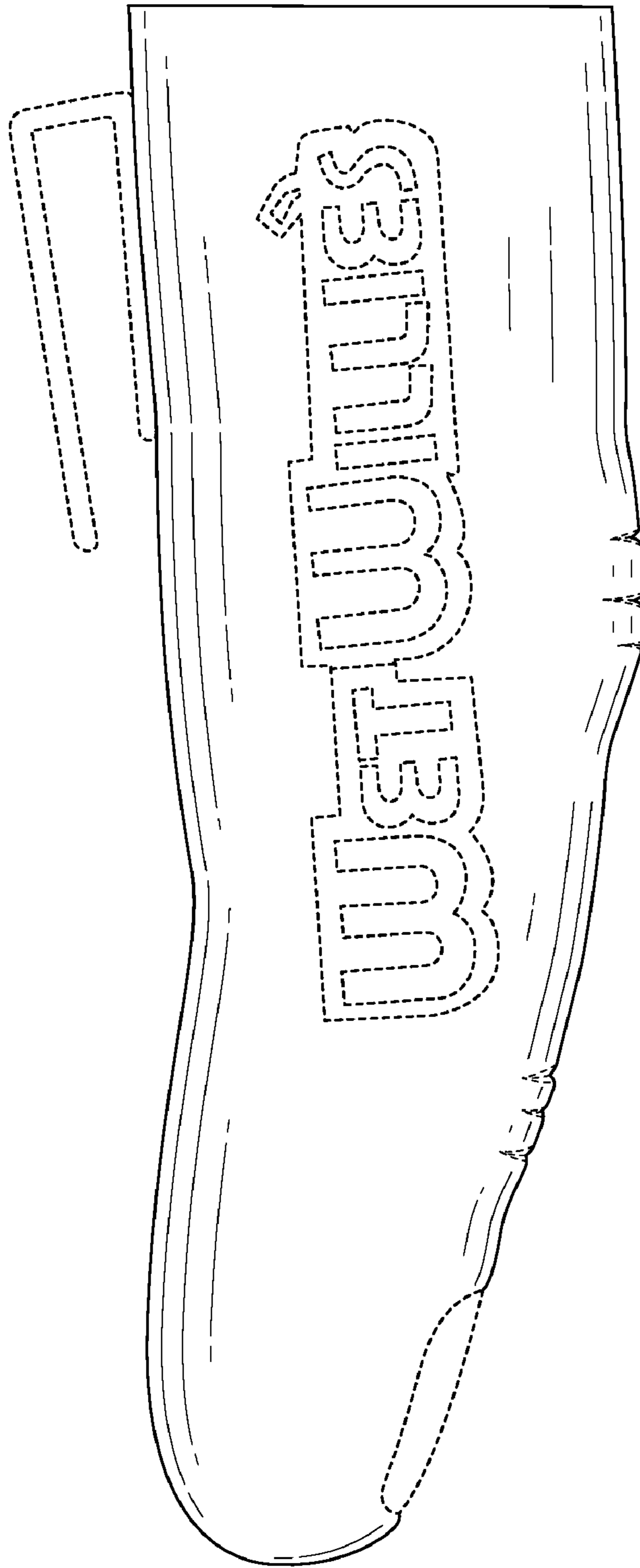

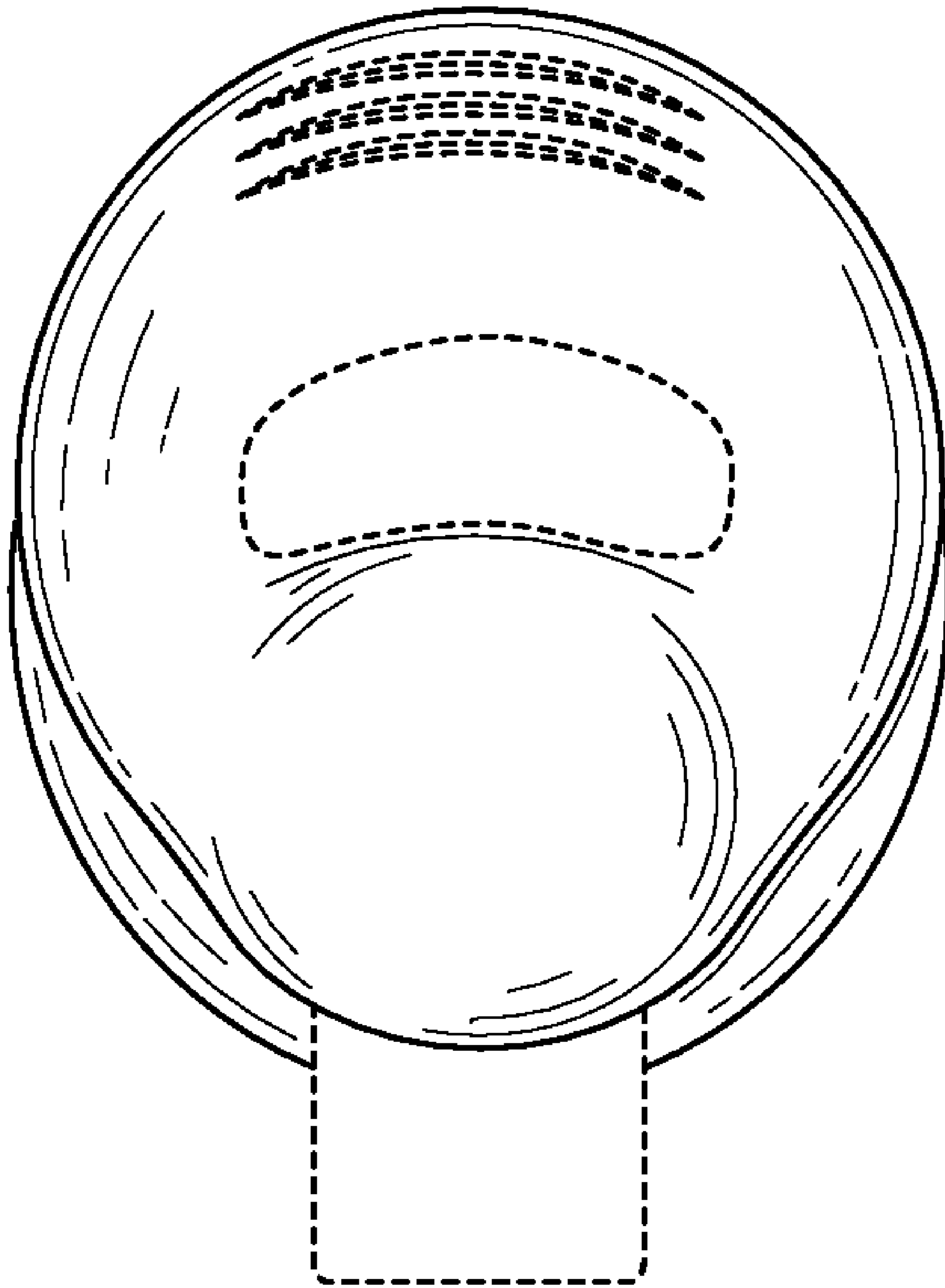
