The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage container;

FIG. 4 is a right-hand side view of the beverage container of FIG. 1;

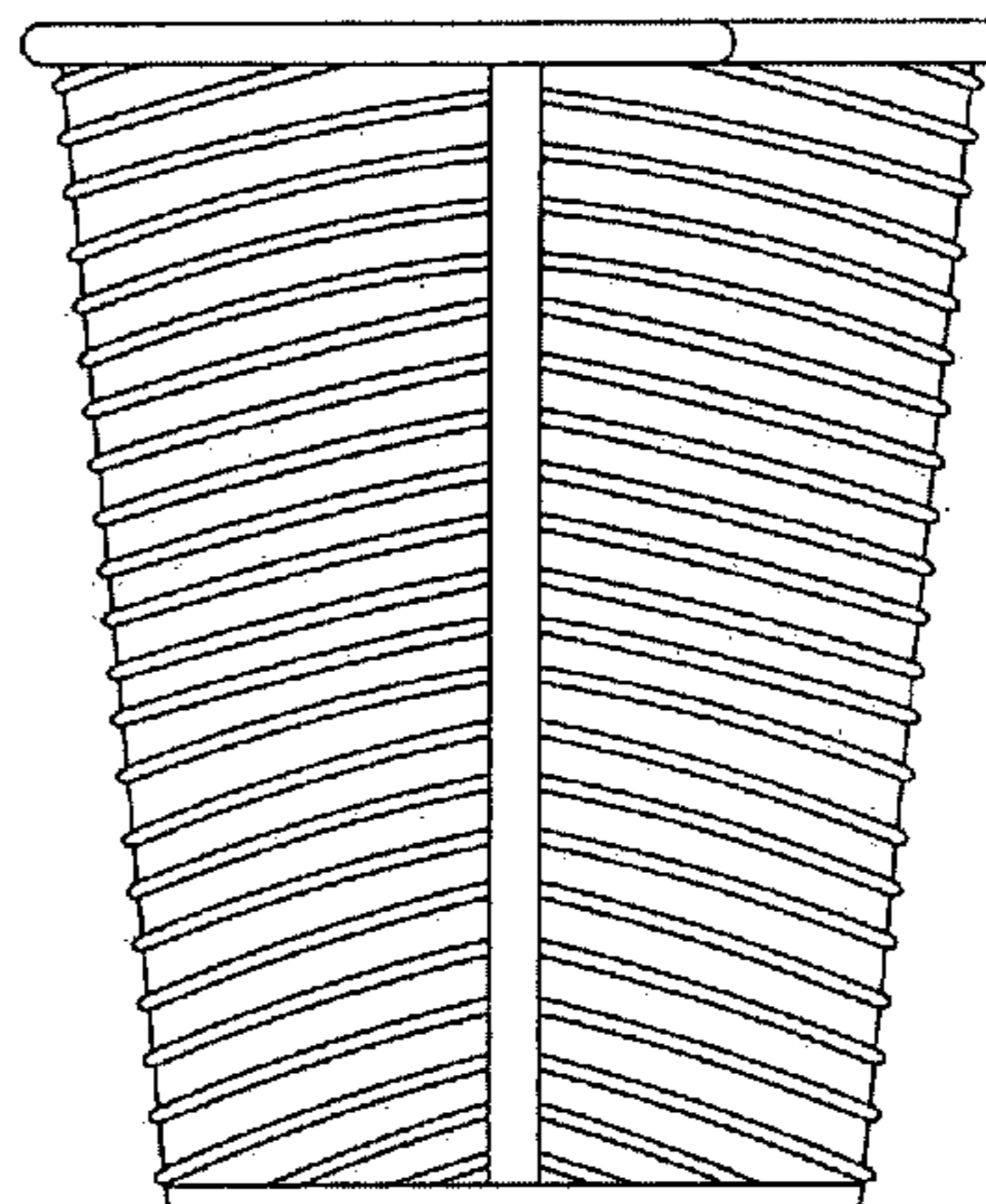
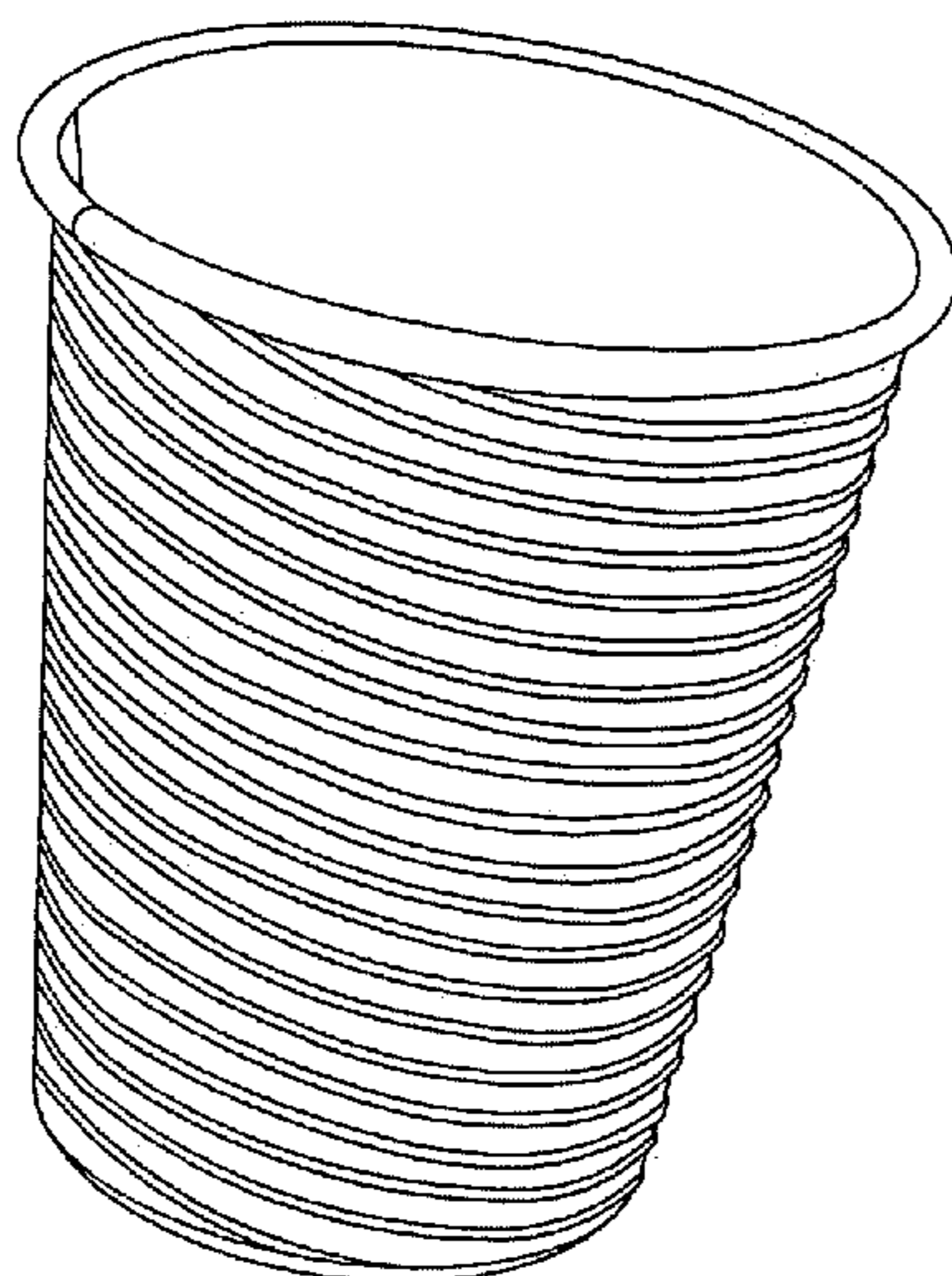
FIG. 5 is a left-hand side view of the beverage container of FIG. 1;

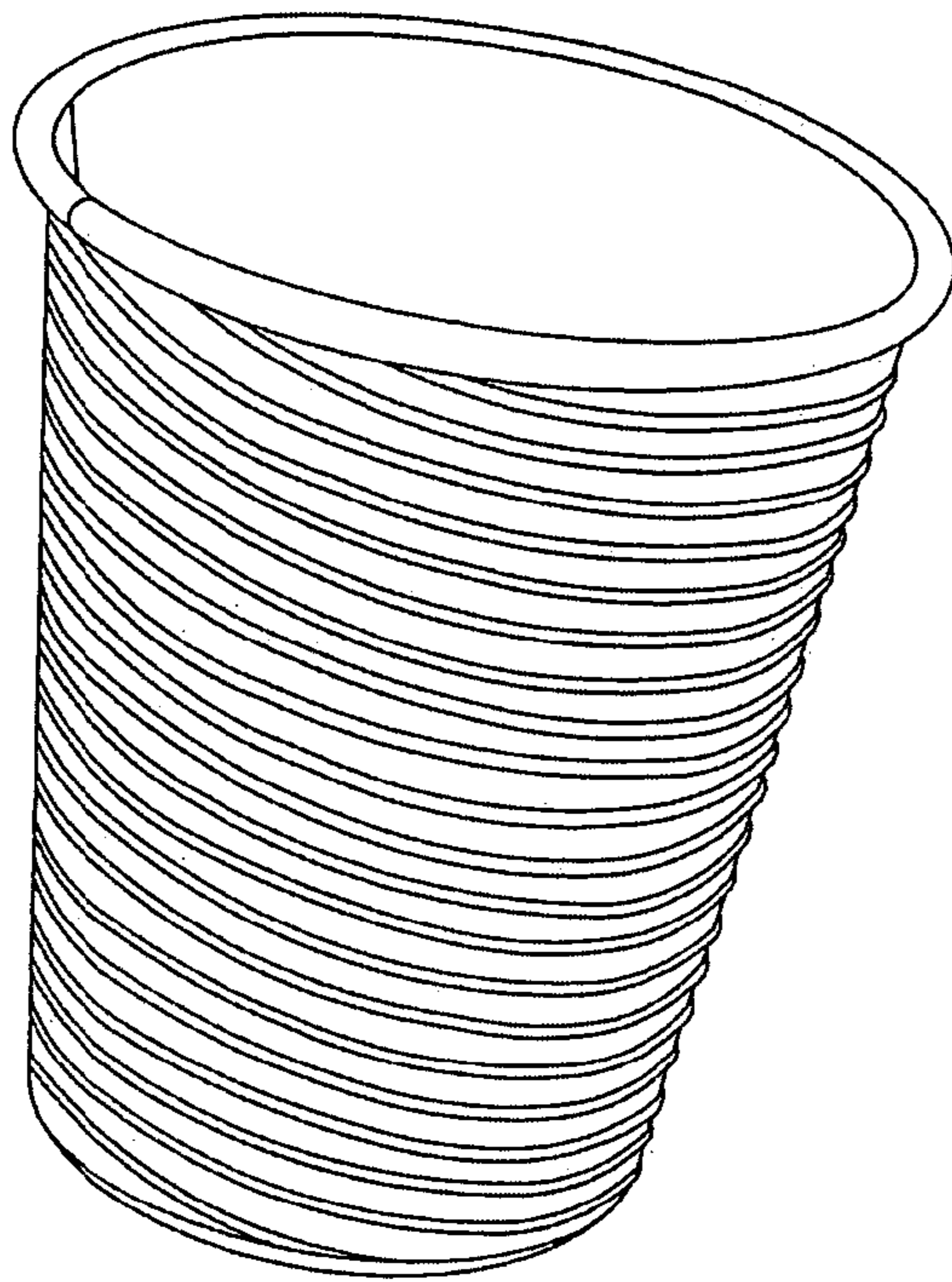
FIG. 6 is a rear view of the beverage container of FIG. 1; and,

FIG. 7 is a bottom plan view of the beverage container of FIG. 1.

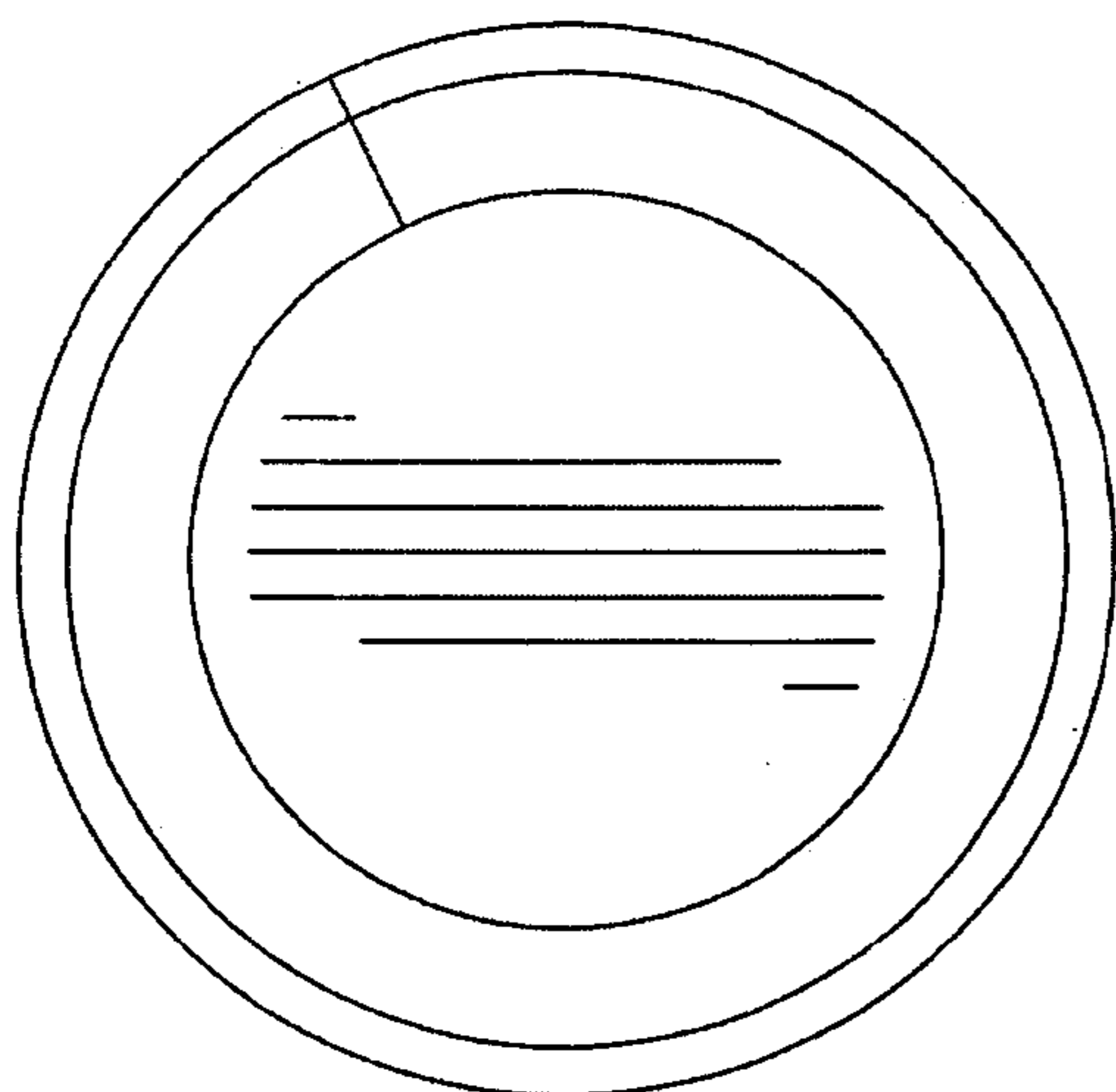

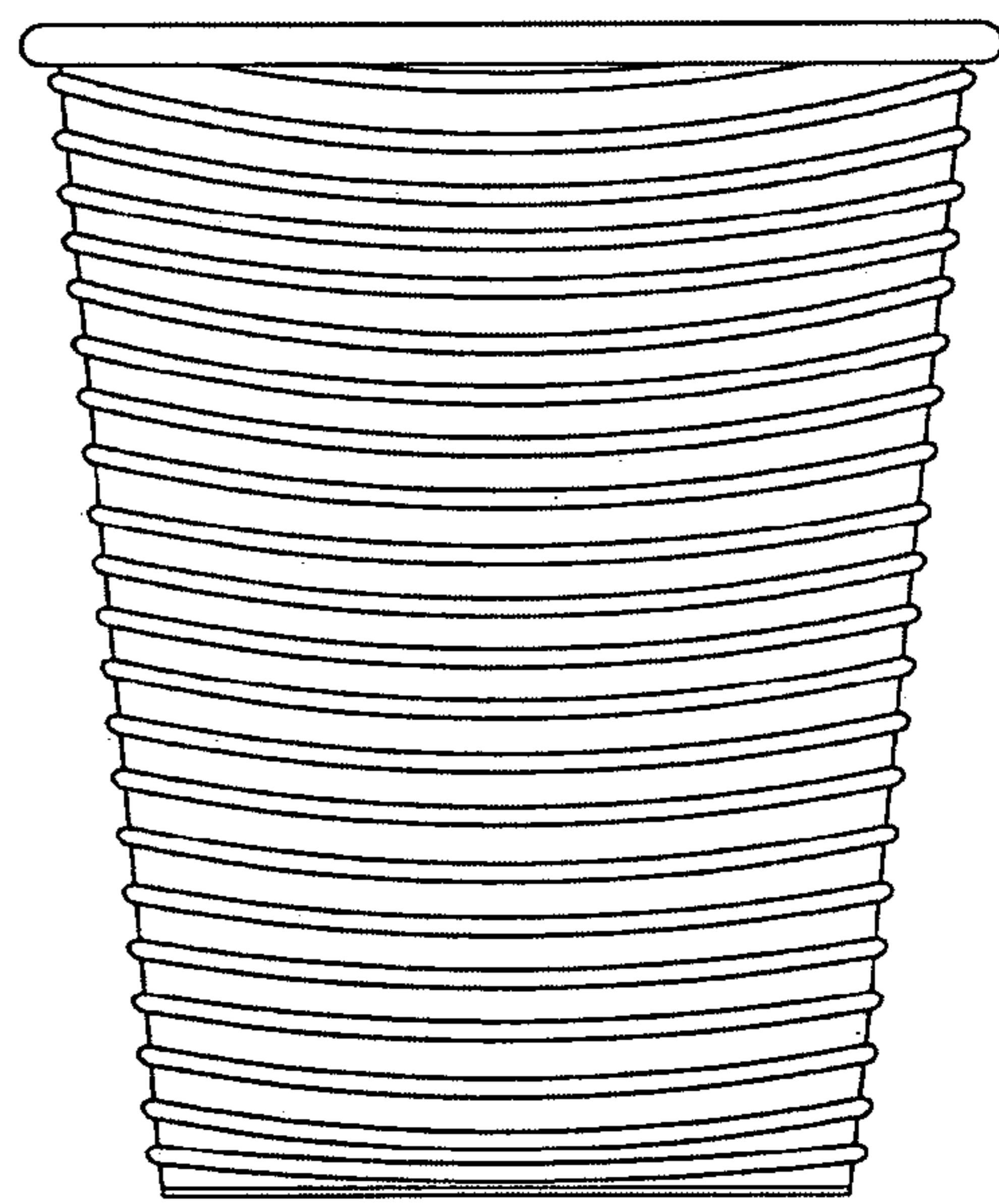




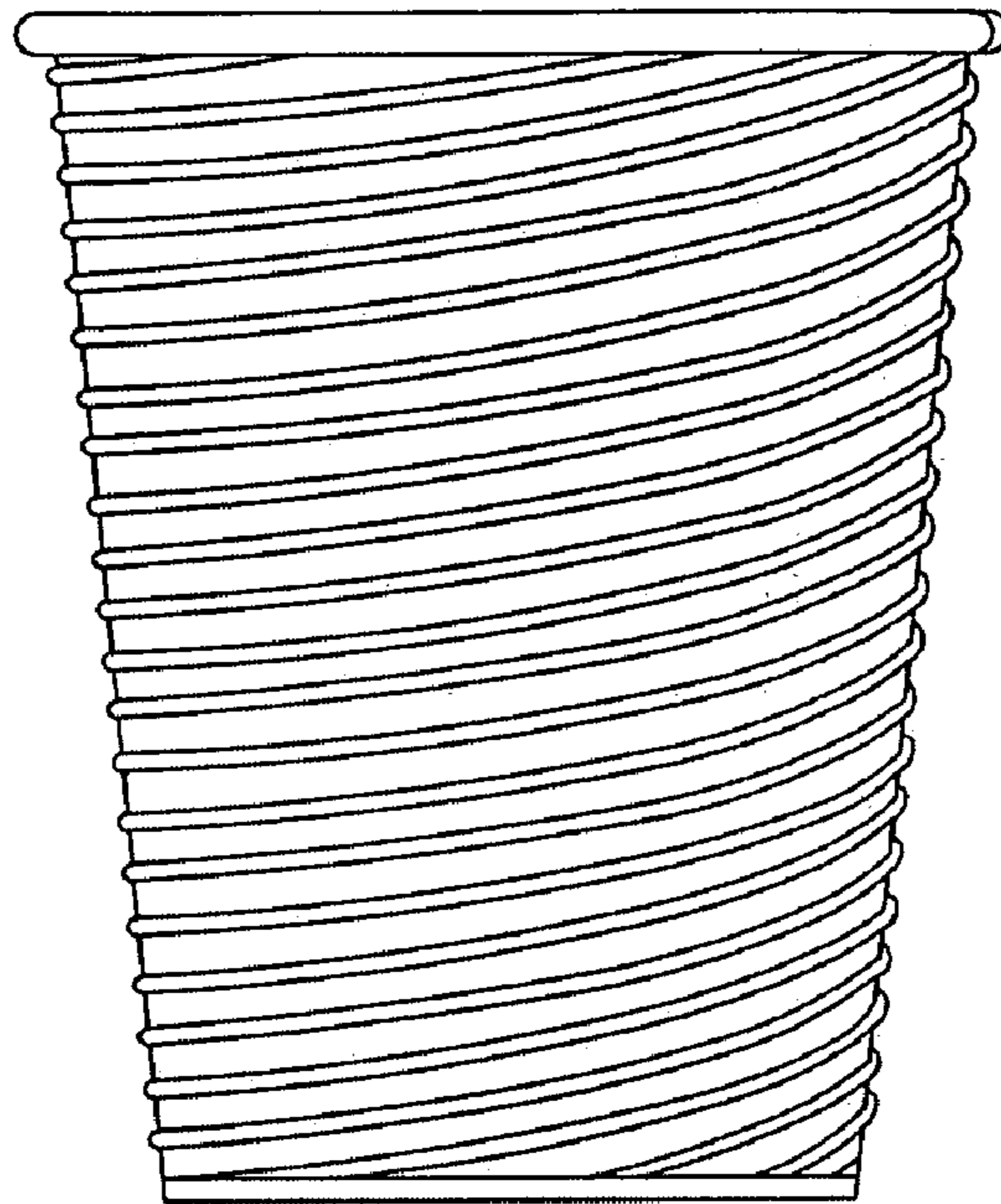

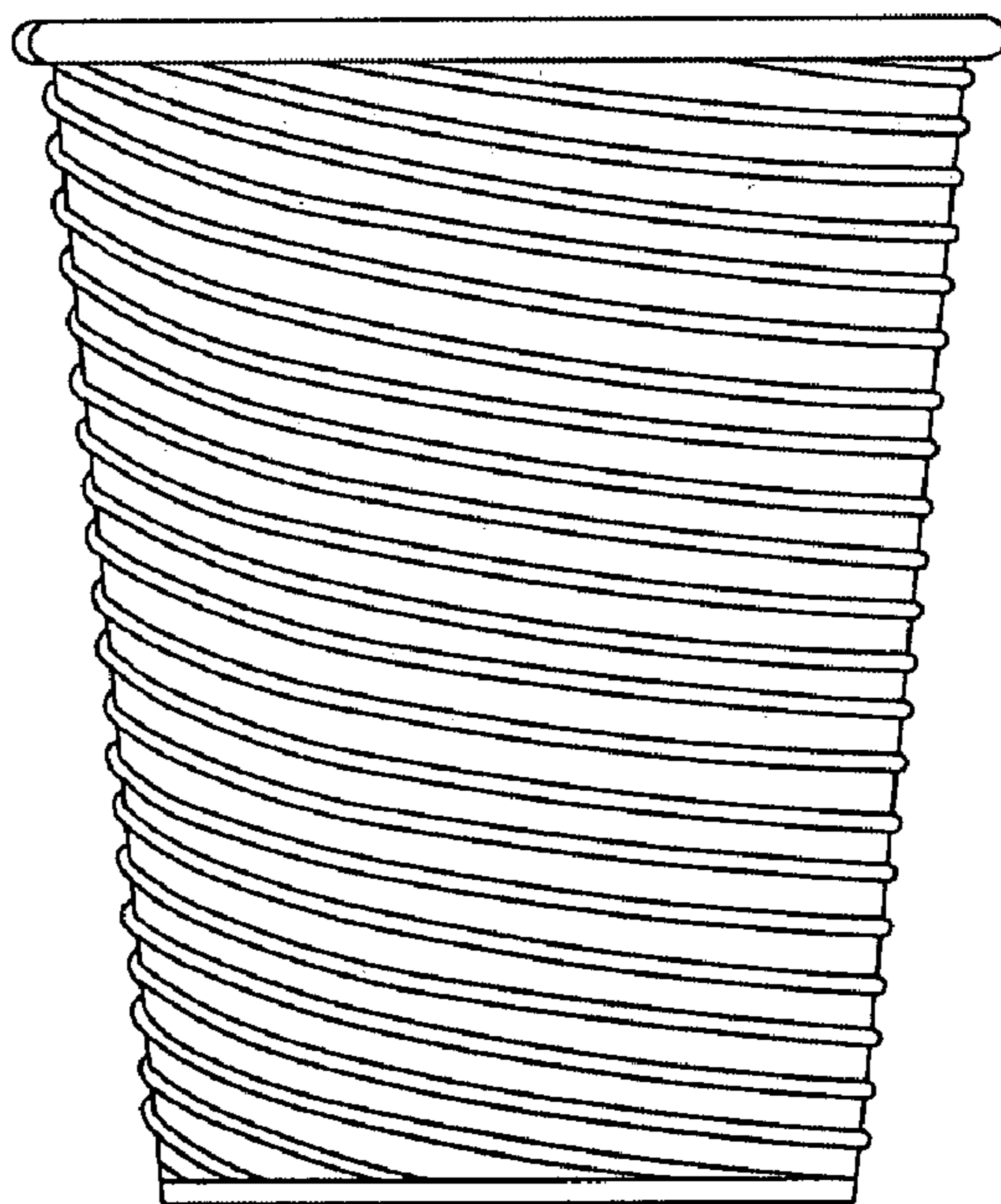

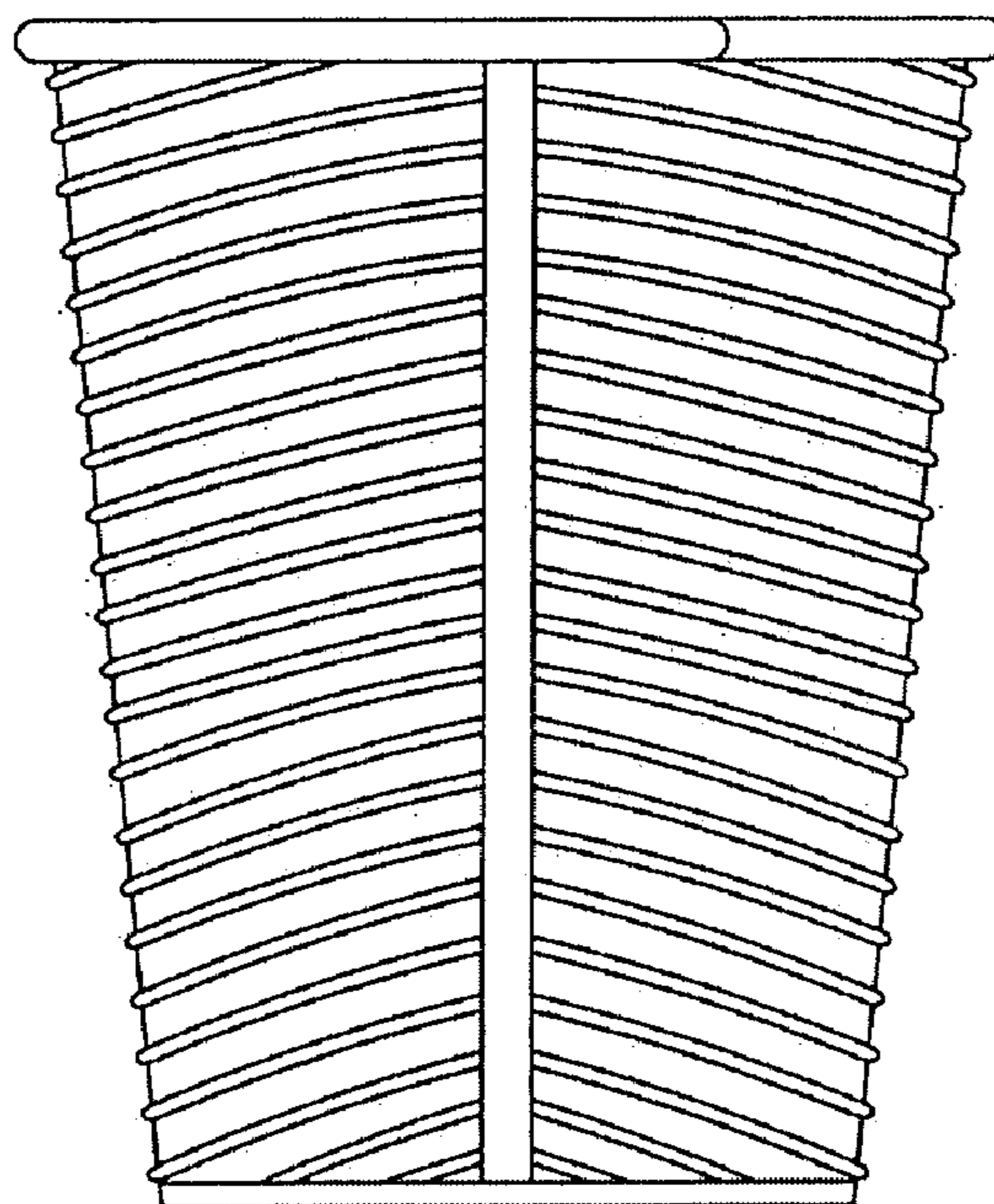

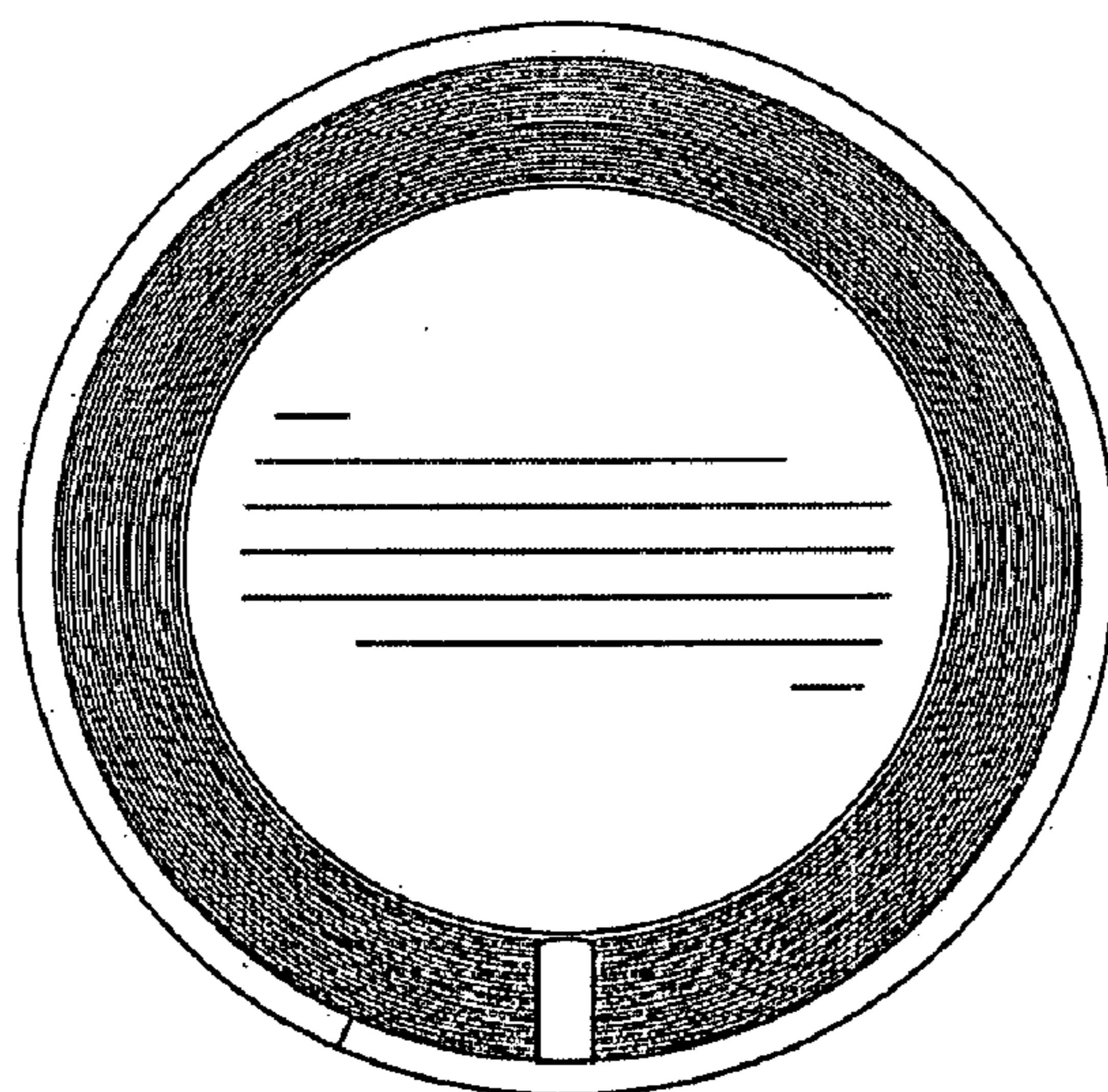
