FIG. 2 is a side view thereof.

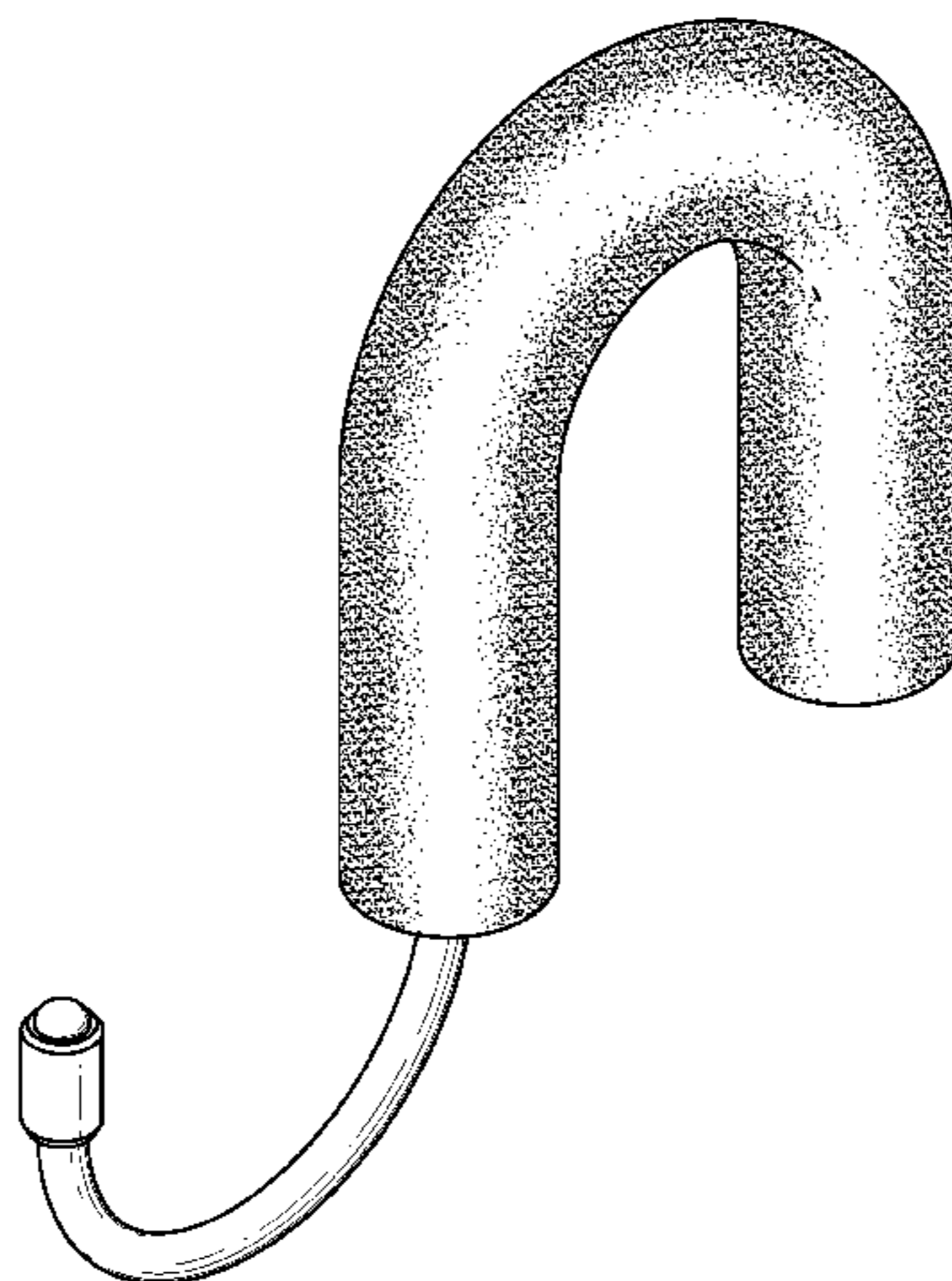
FIG. 3 is a front view thereof.

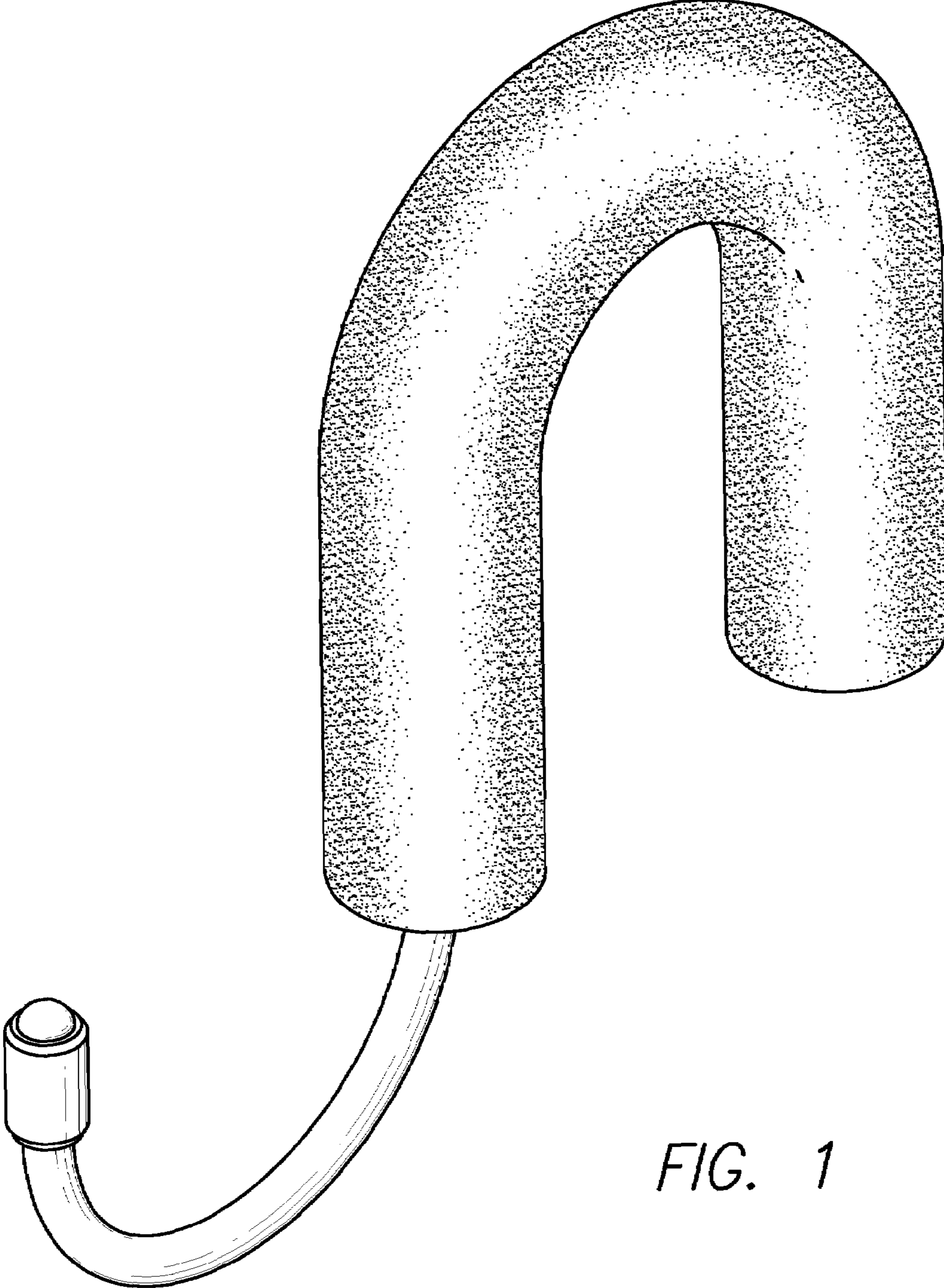

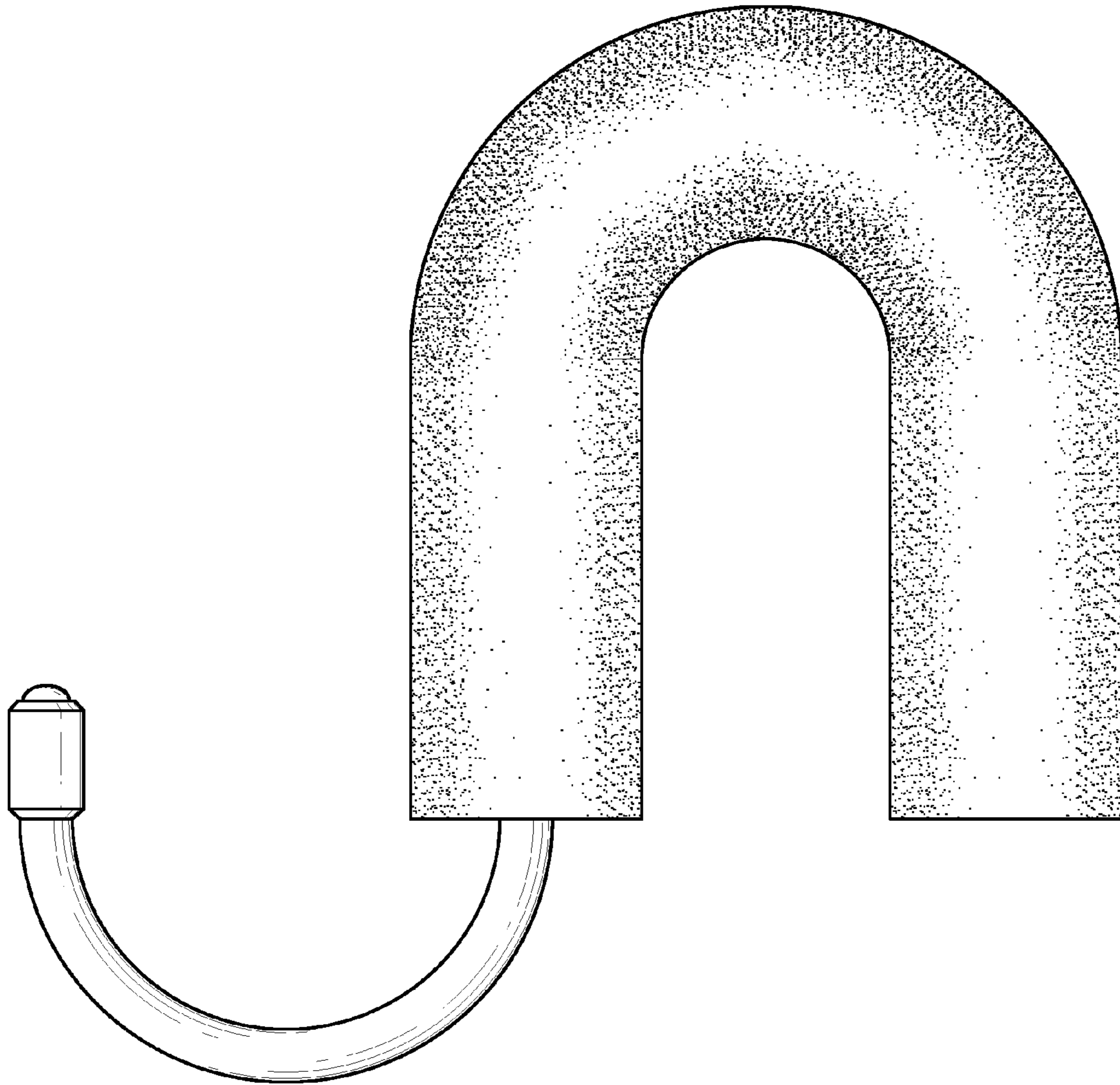

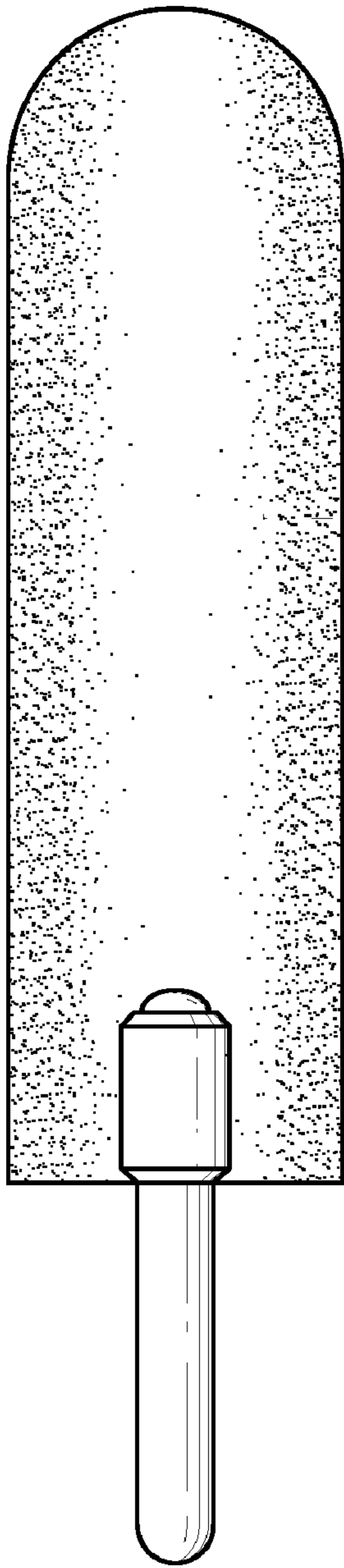

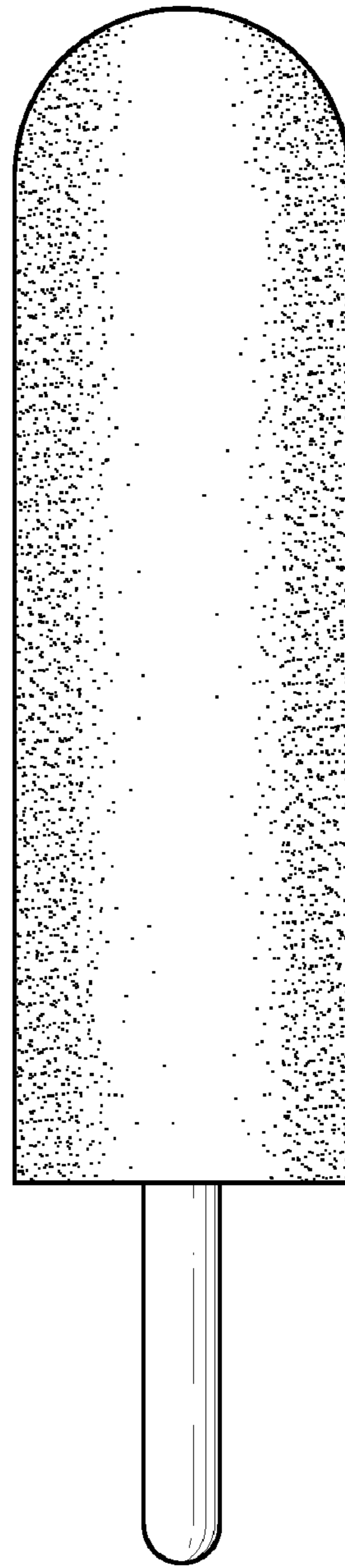

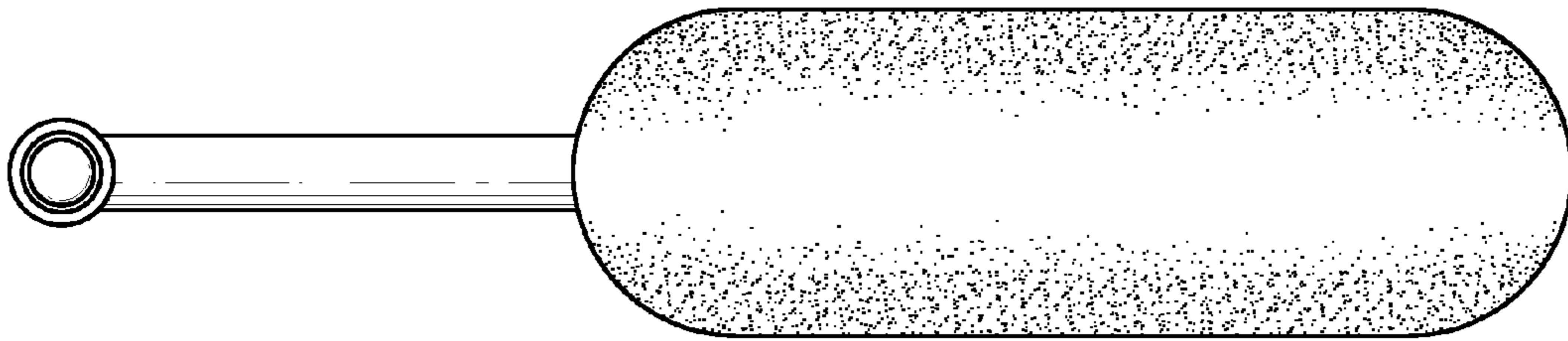

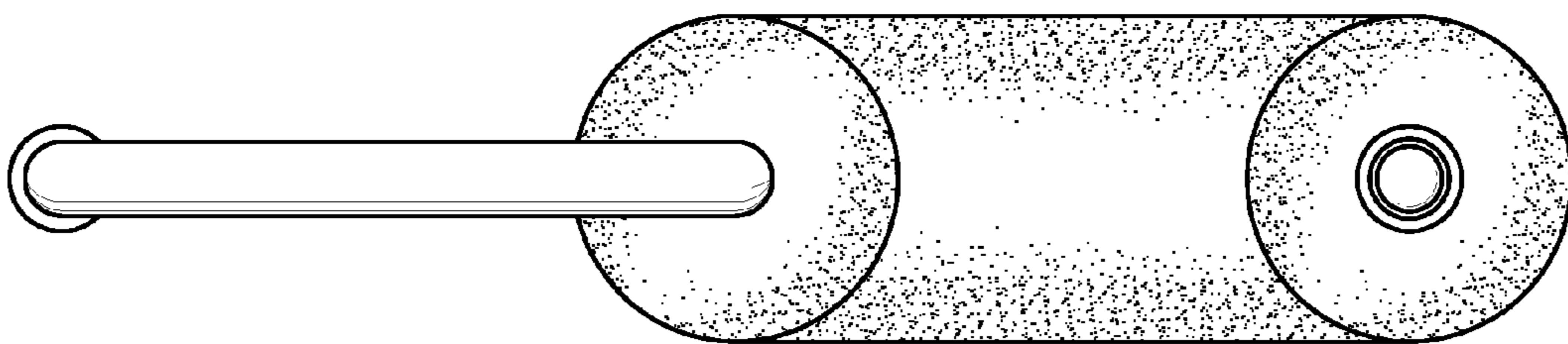
