DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a button for a watch showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side view thereof;

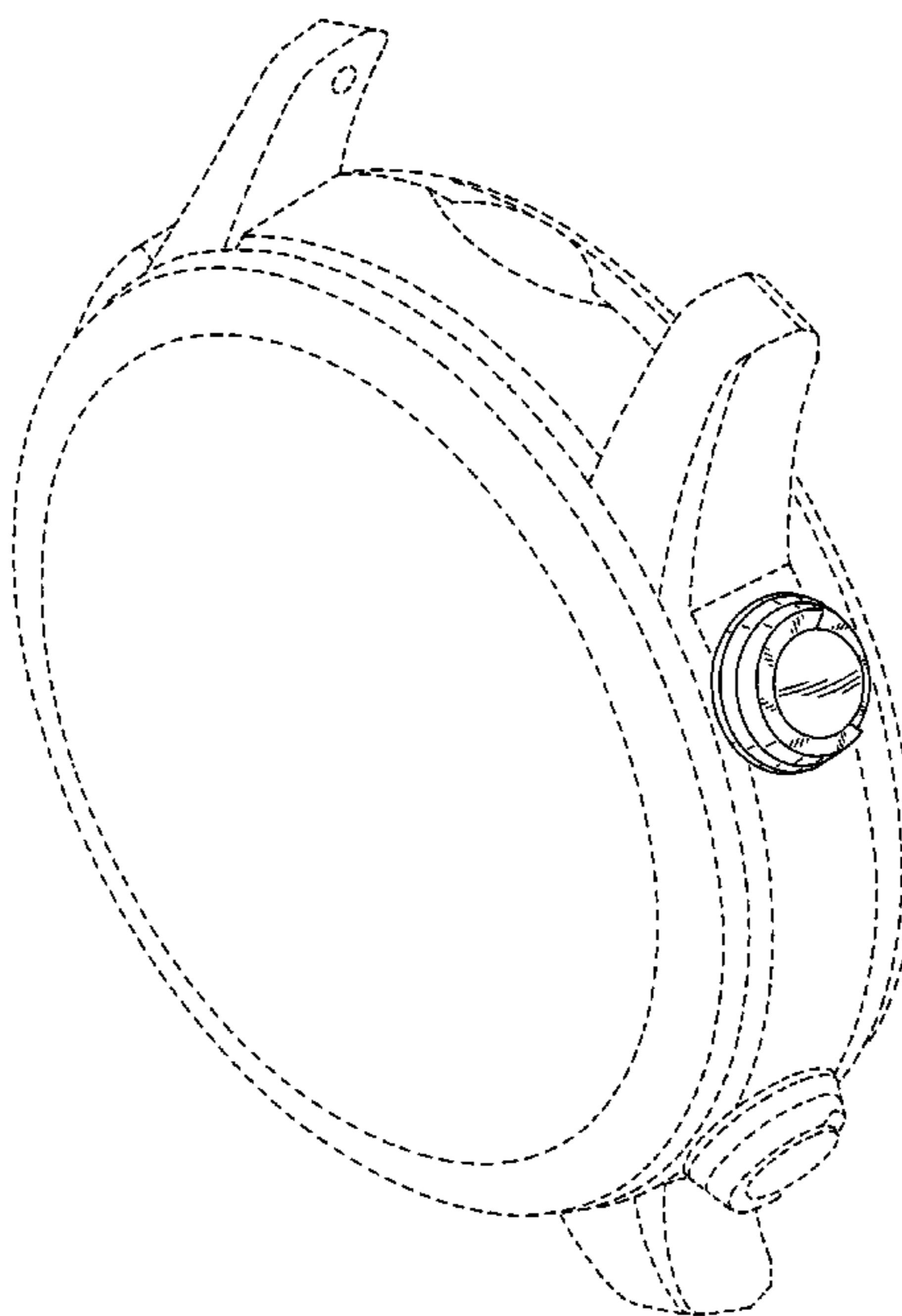
FIG. 5 is a right side view thereof;

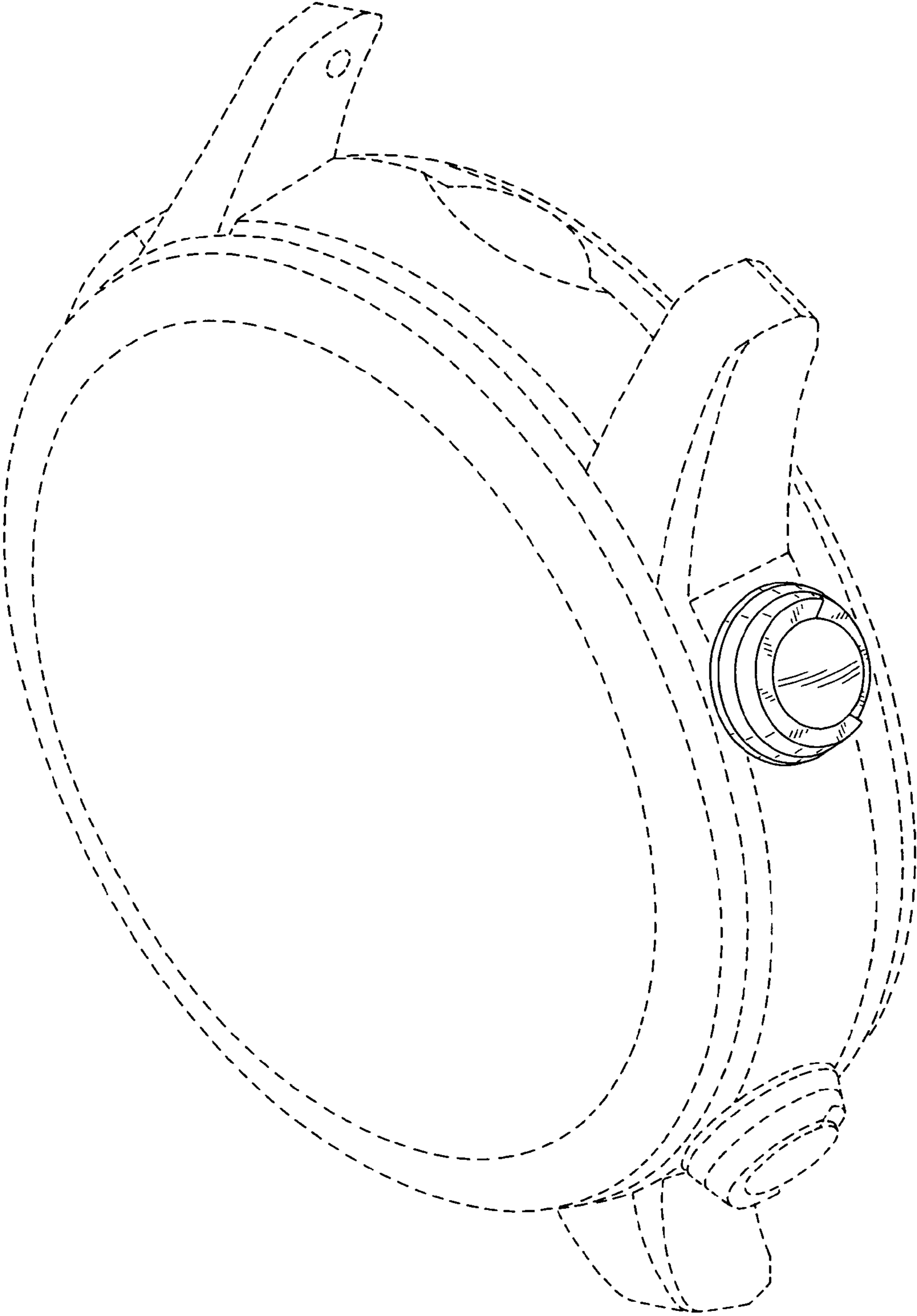

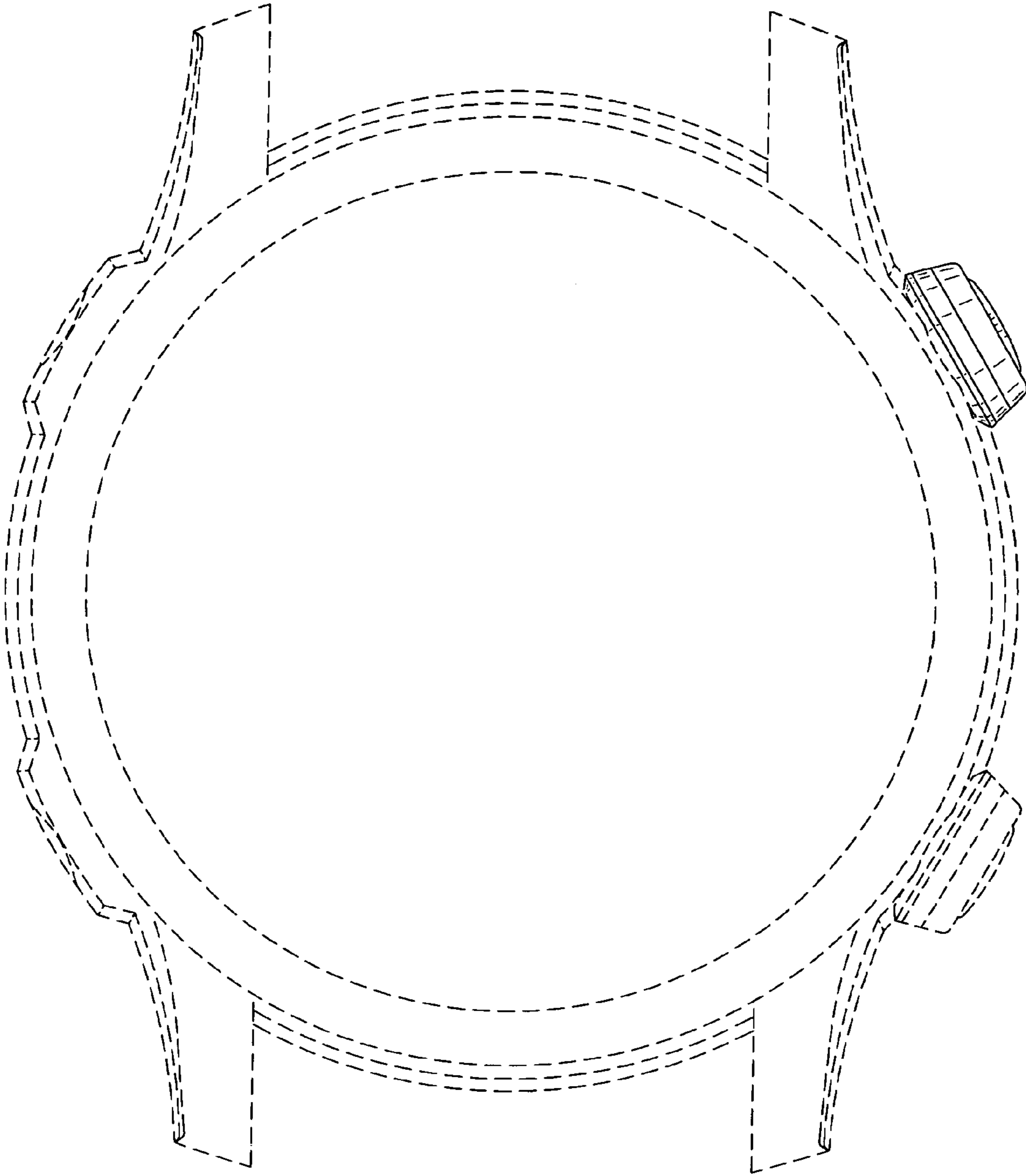

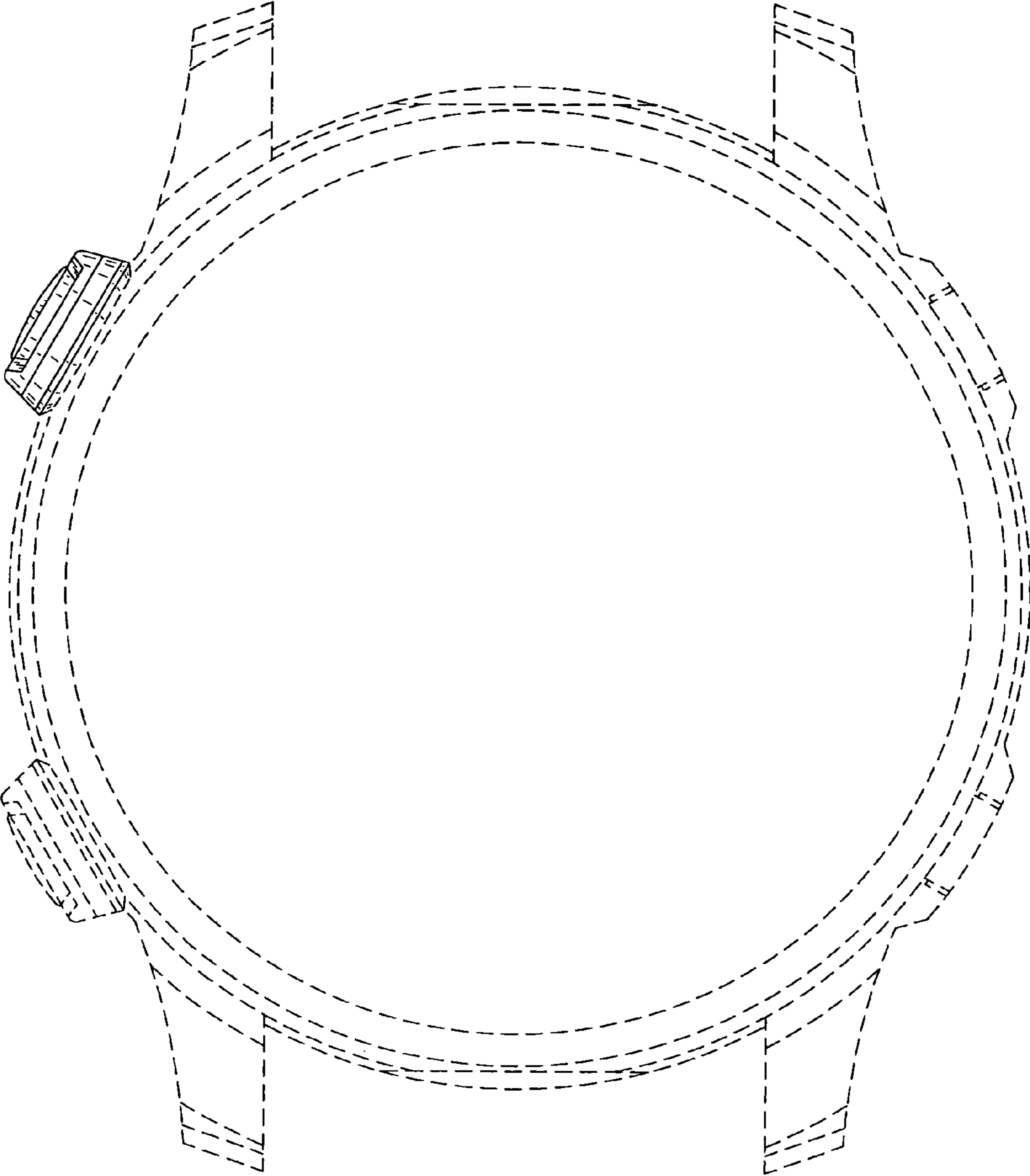

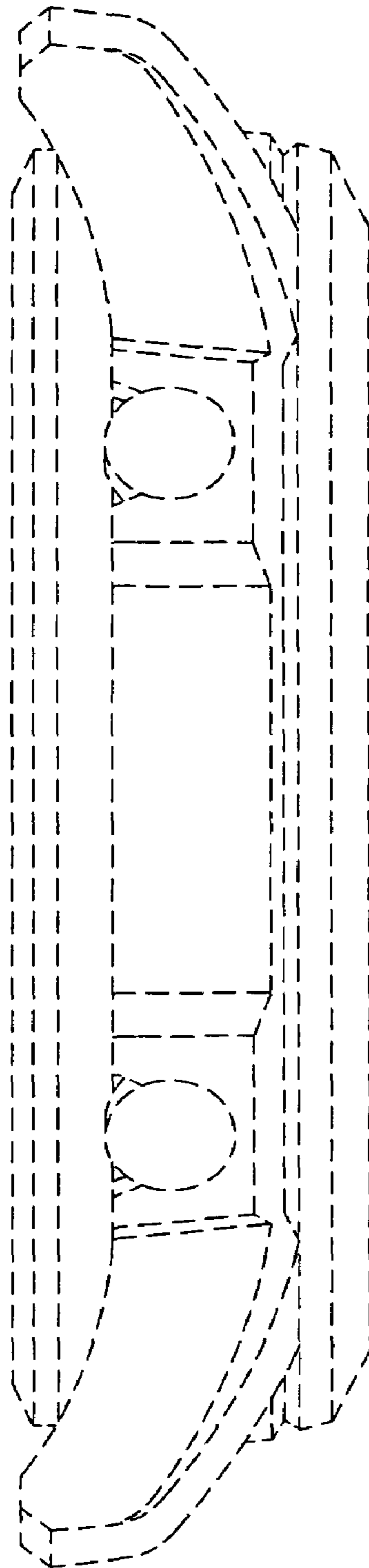

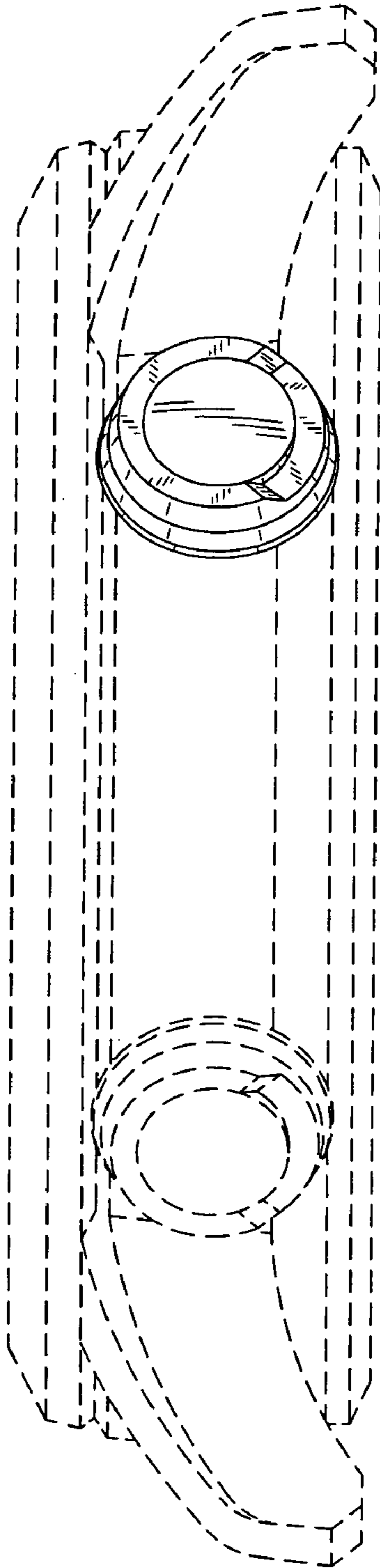

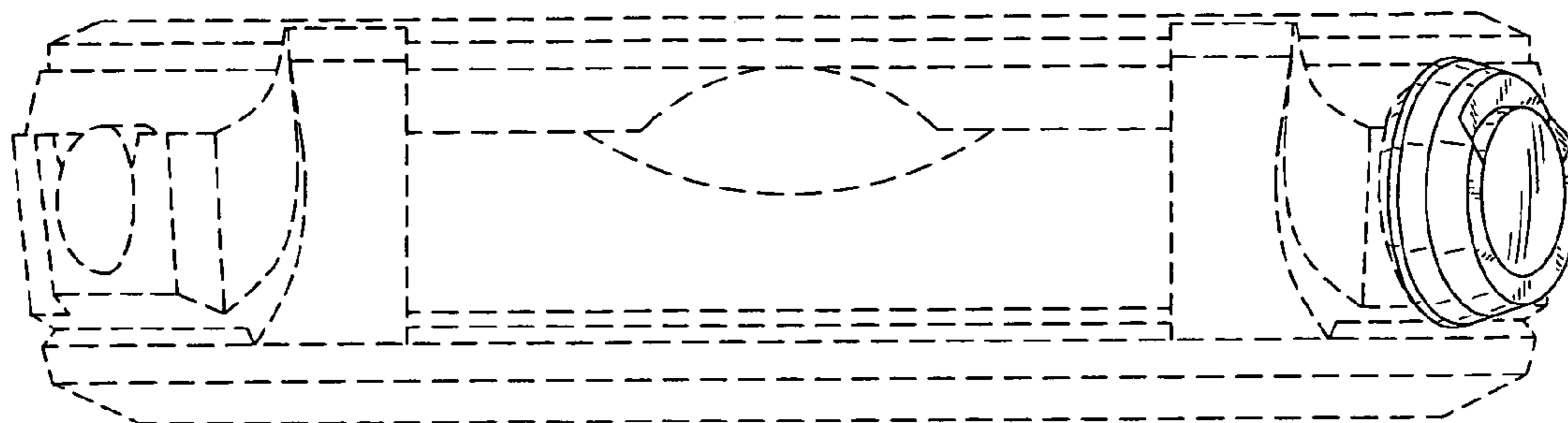

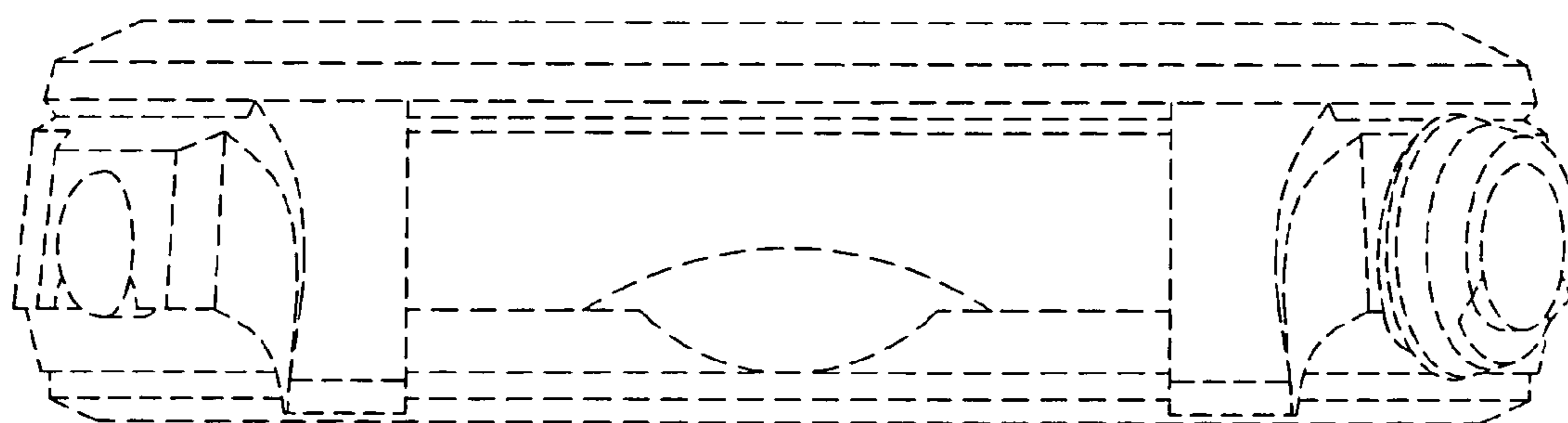
