DESCRIPTION

FIG. 1 is a perspective view of a nozzle of the new design; FIG. 2 is a front elevational view of the nozzle of FIG. 1; FIG. 3 is a left side elevational view of the nozzle of FIG. 1;

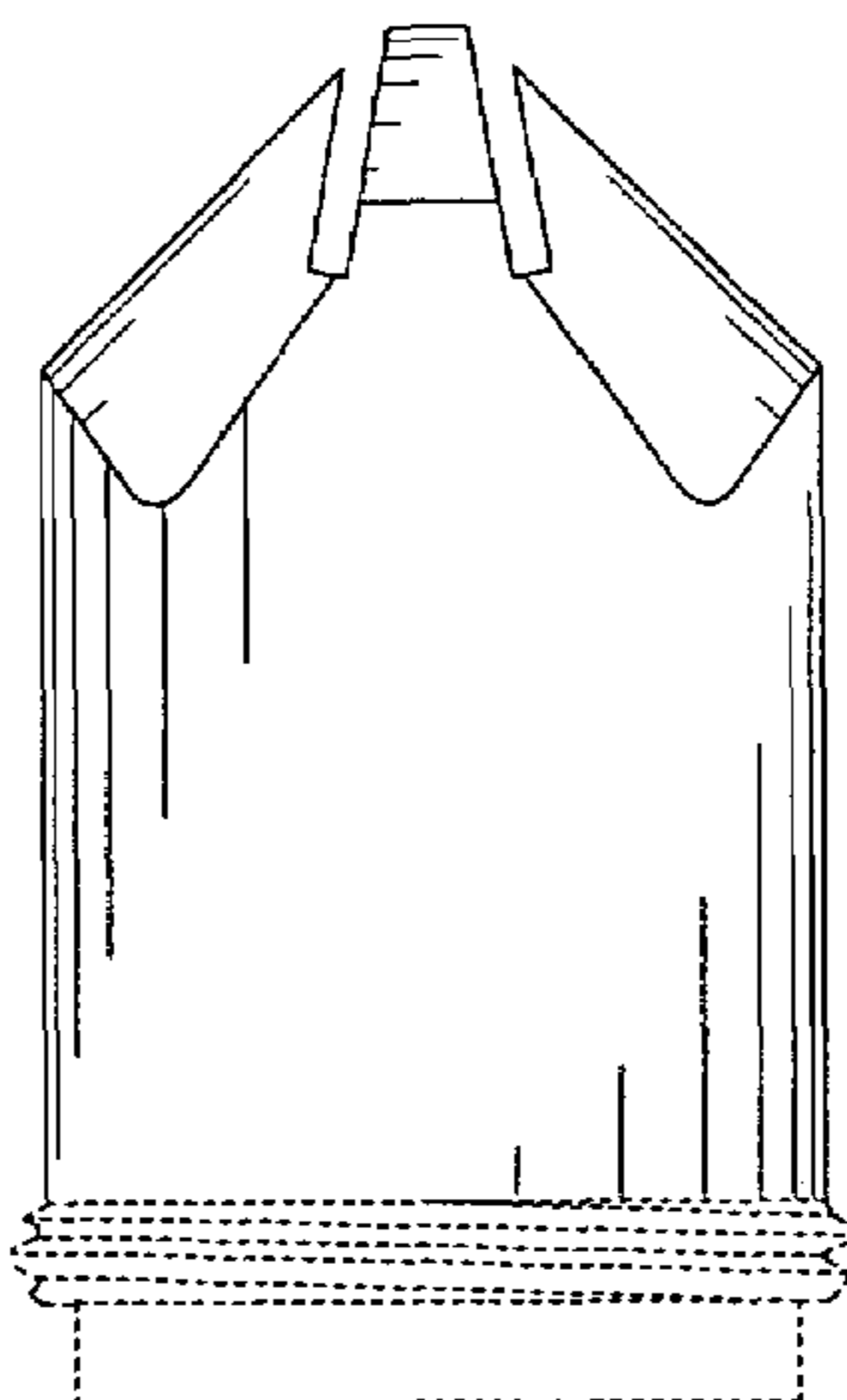
FIG. 4 is a right side elevational view of the nozzle of FIG. 1;

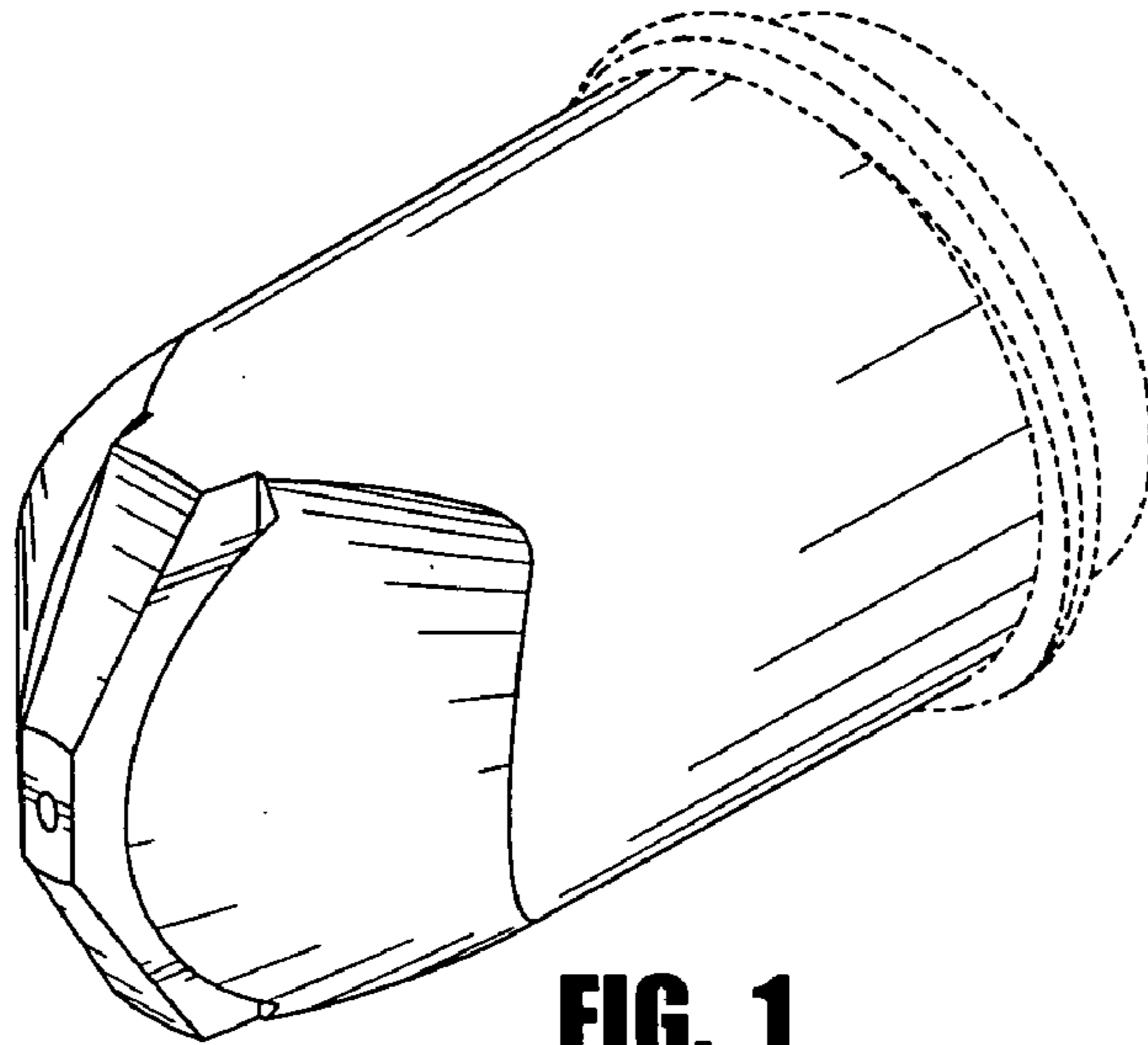

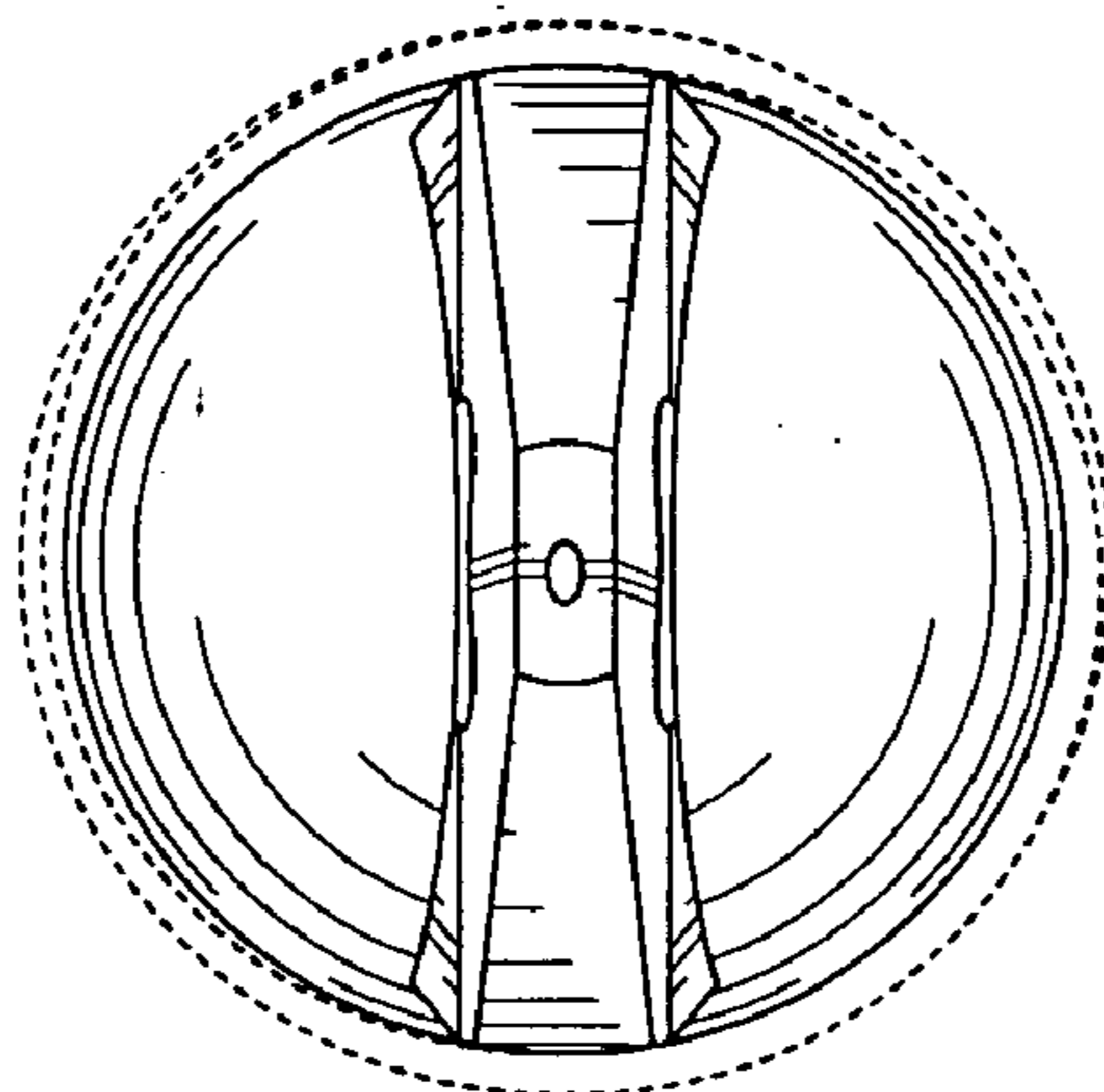

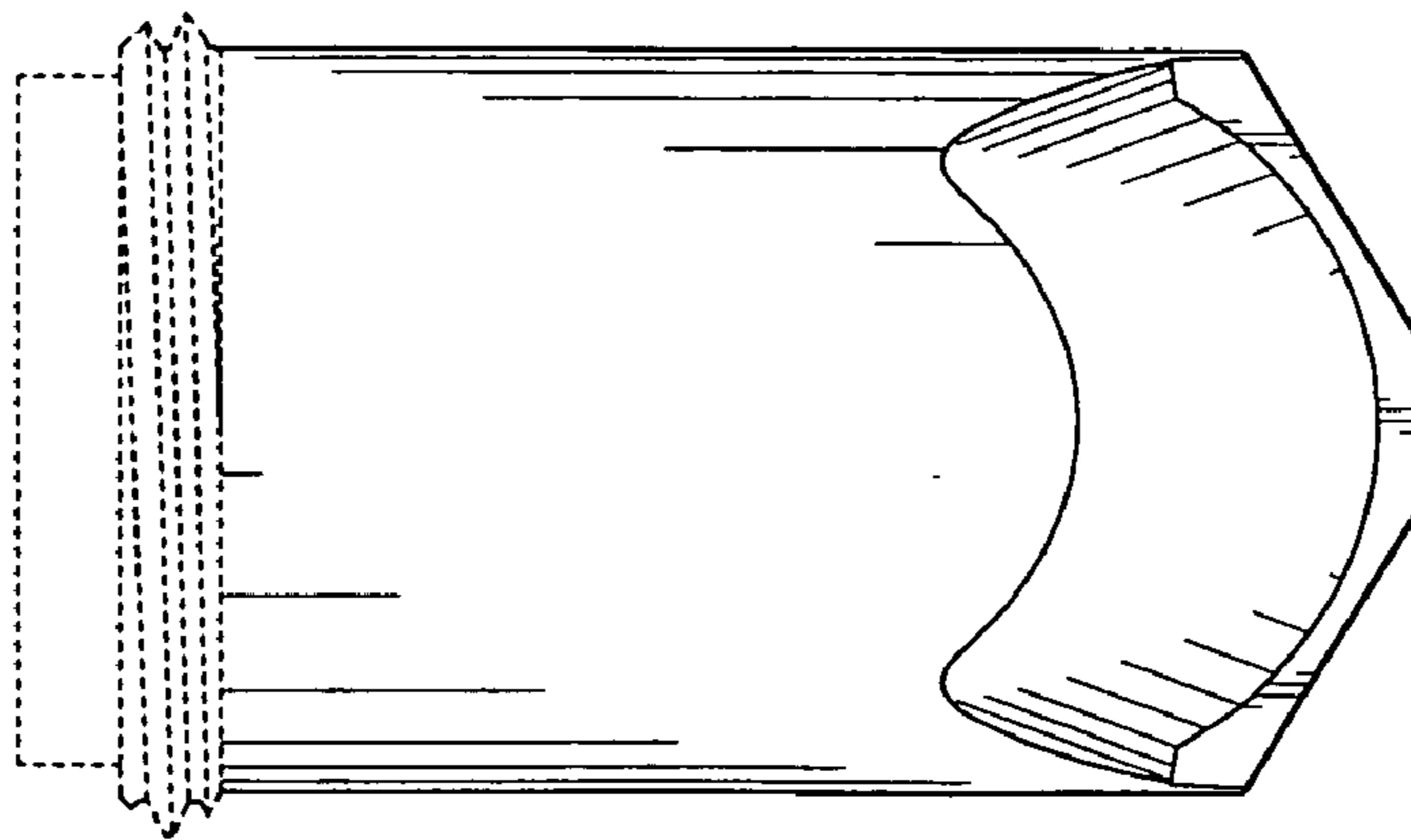

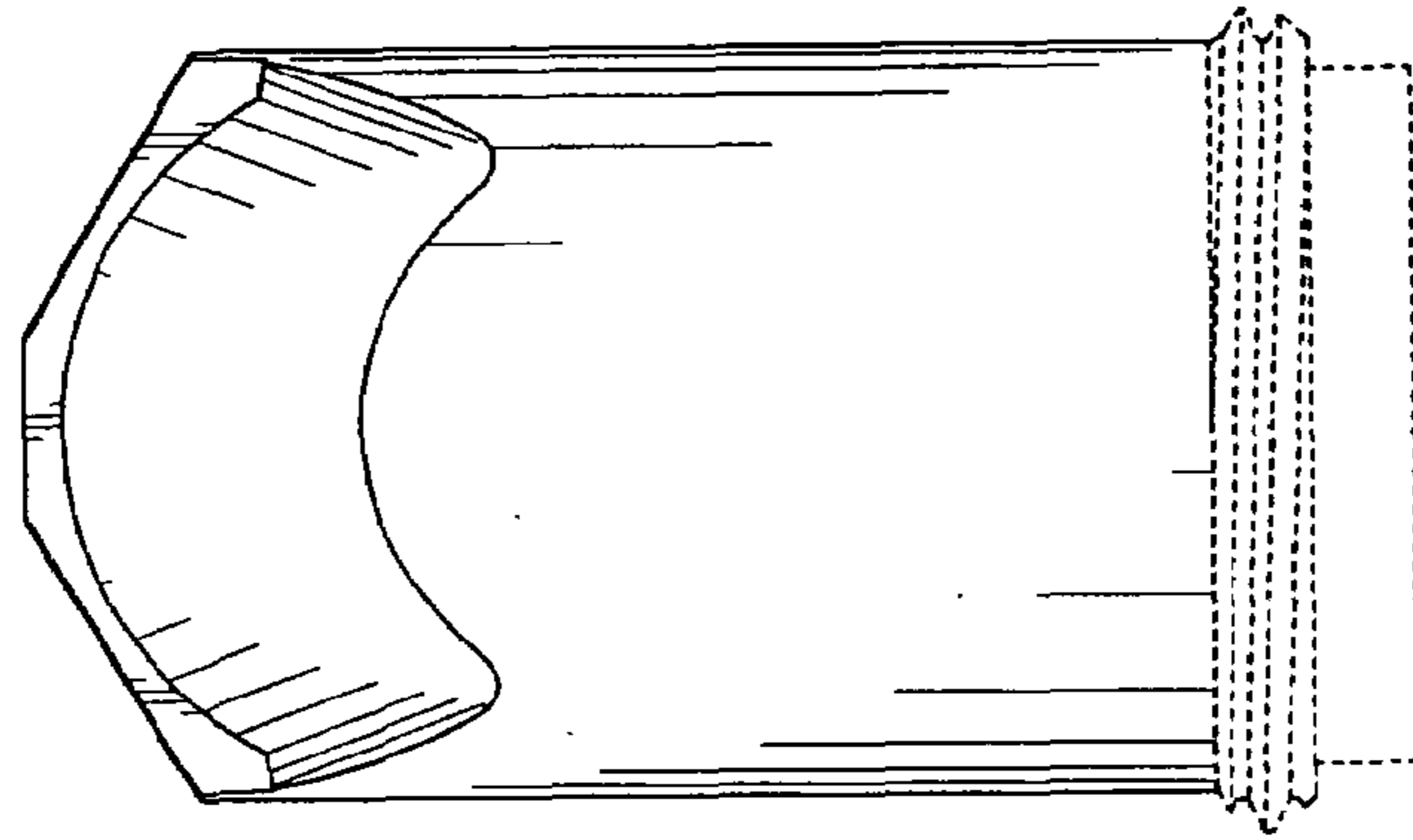

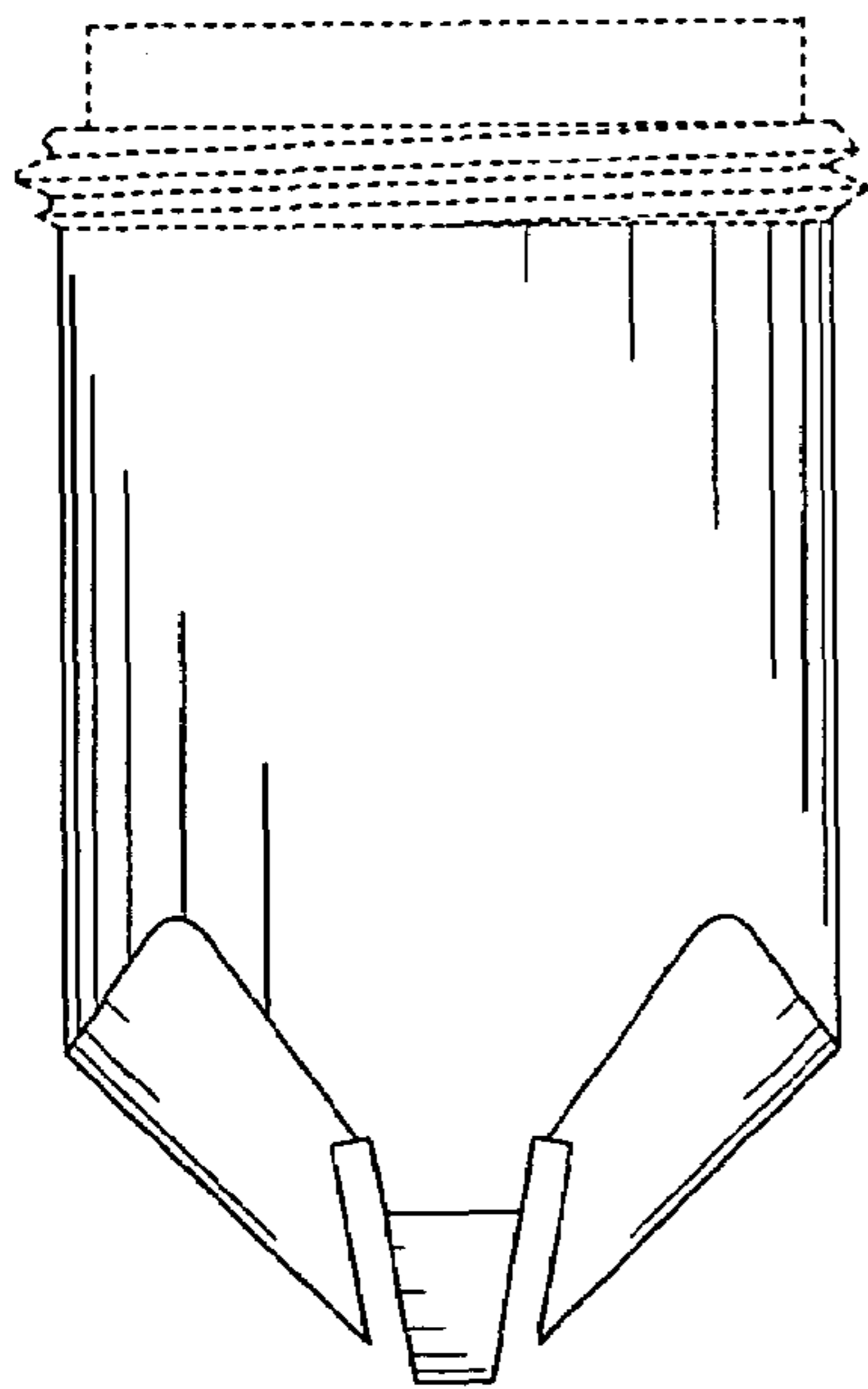

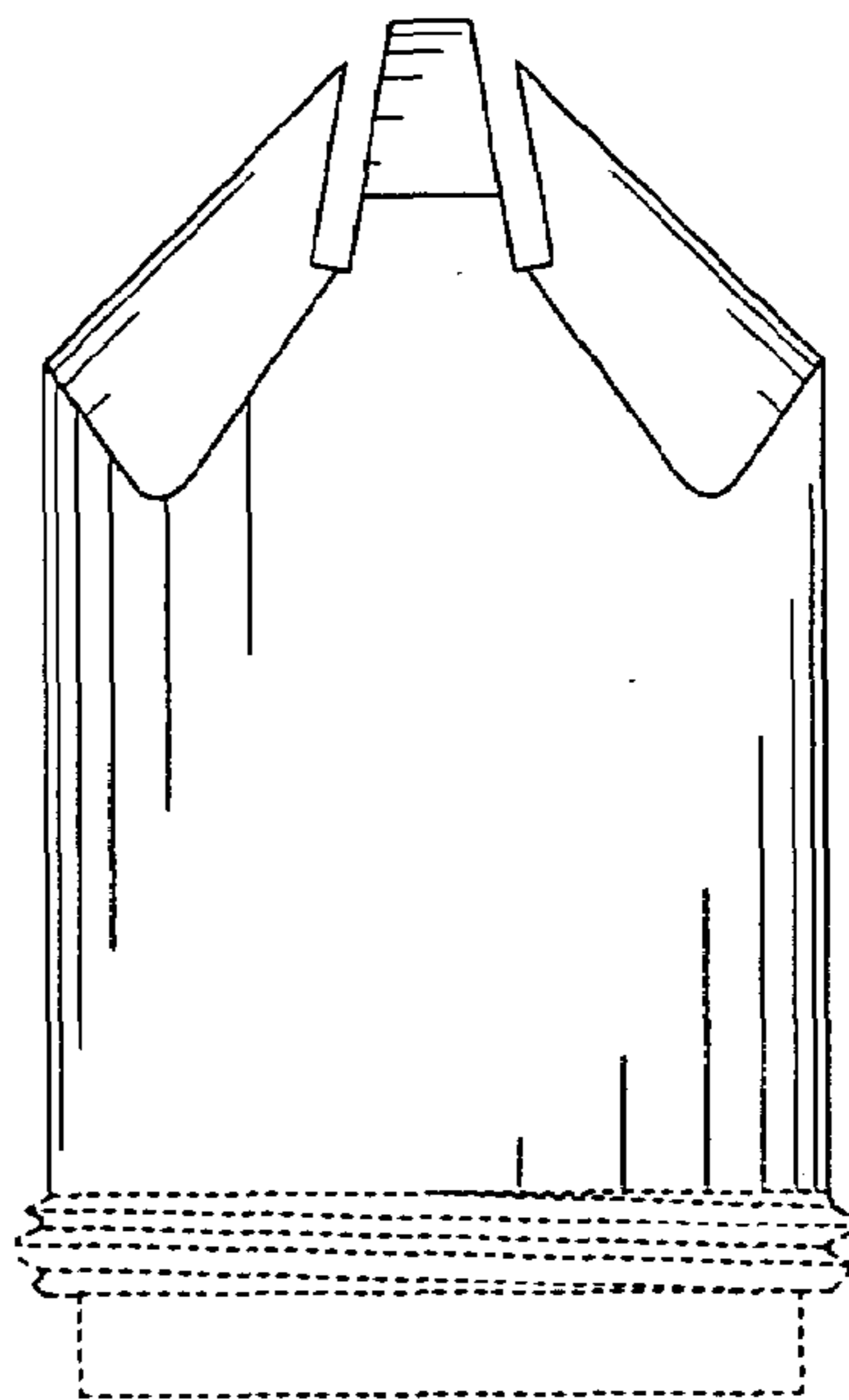
