DESCRIPTION

FIG. 1 is a front perspective view of a faucet assembly showing our new design;

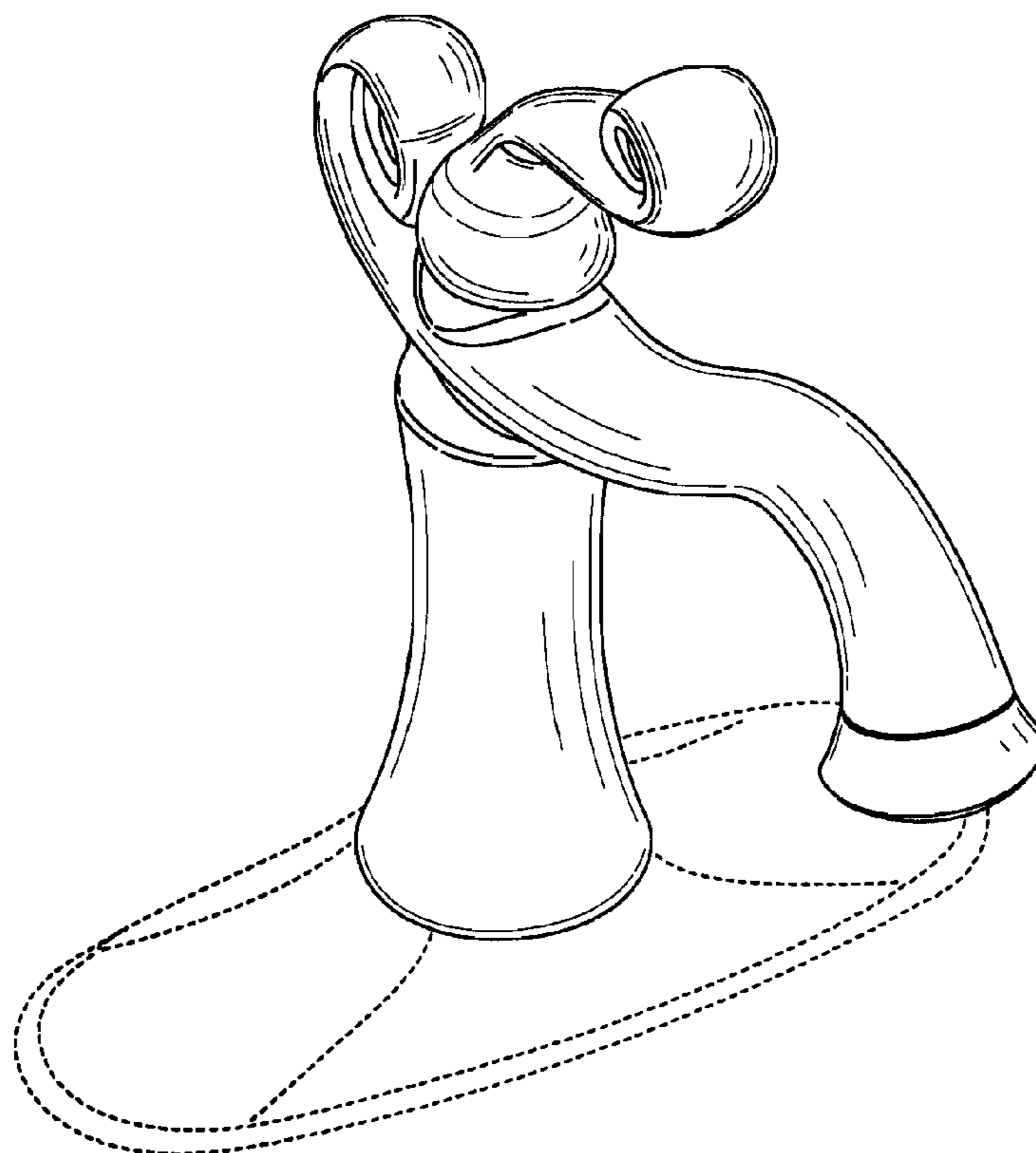

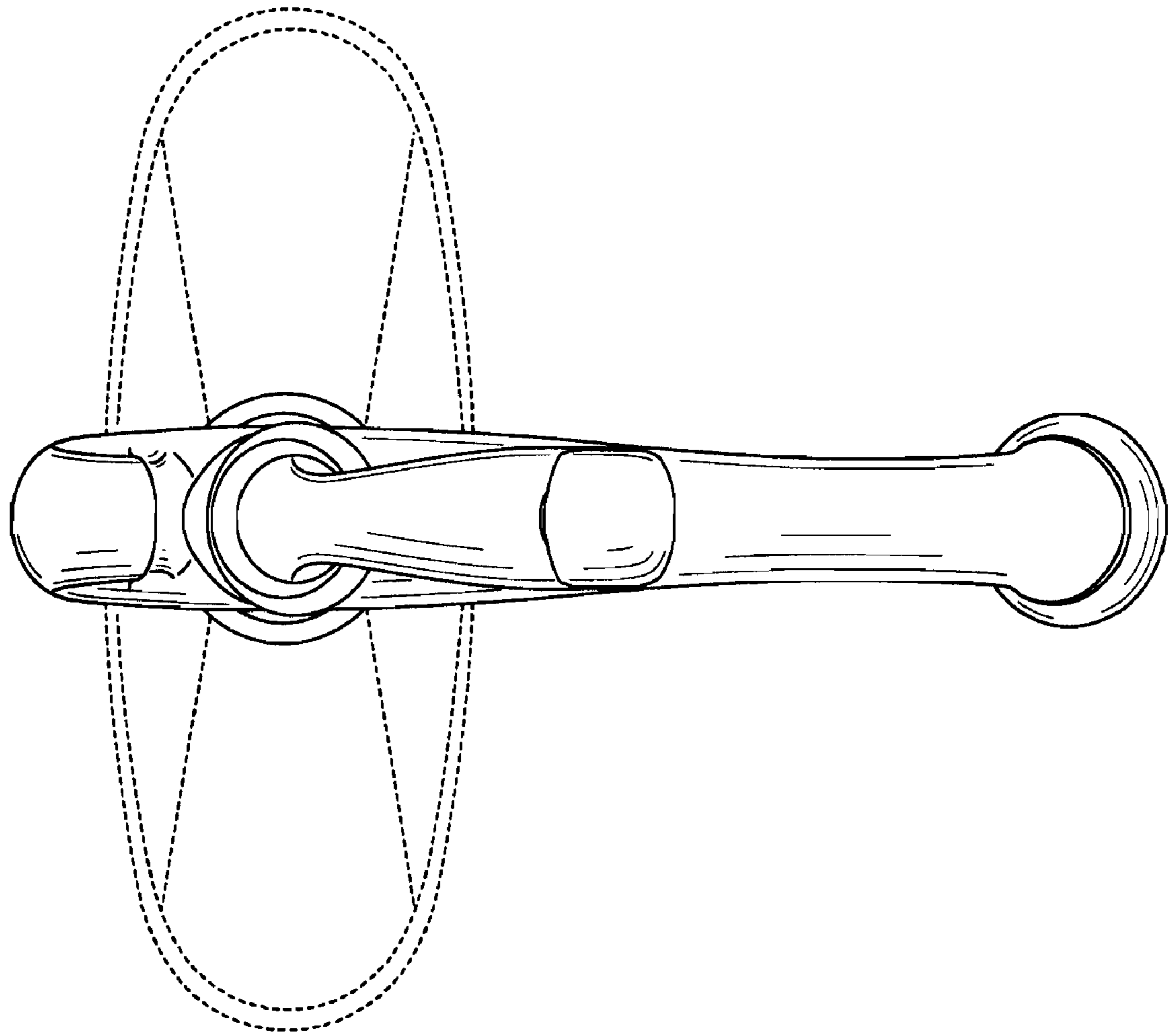

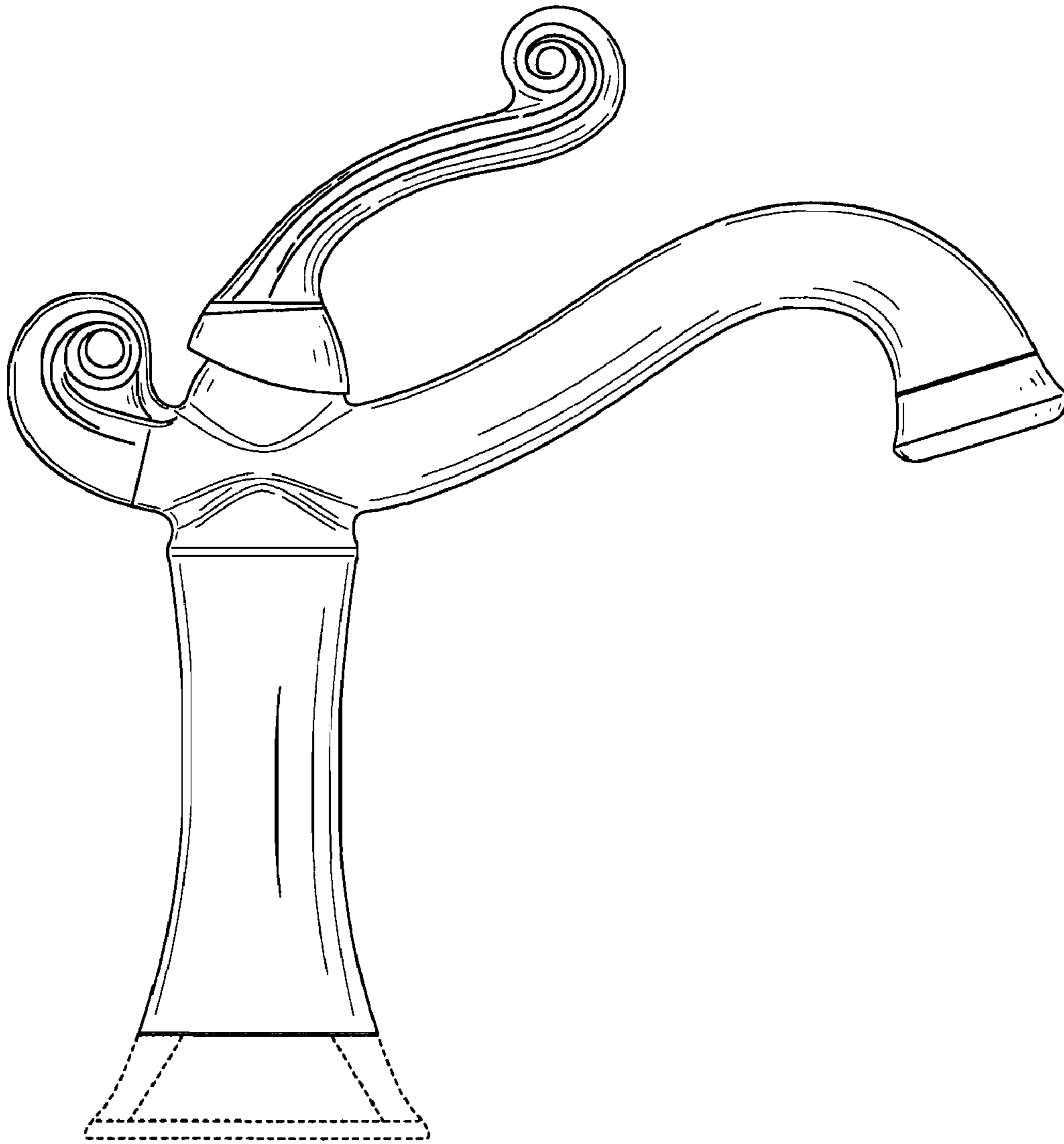

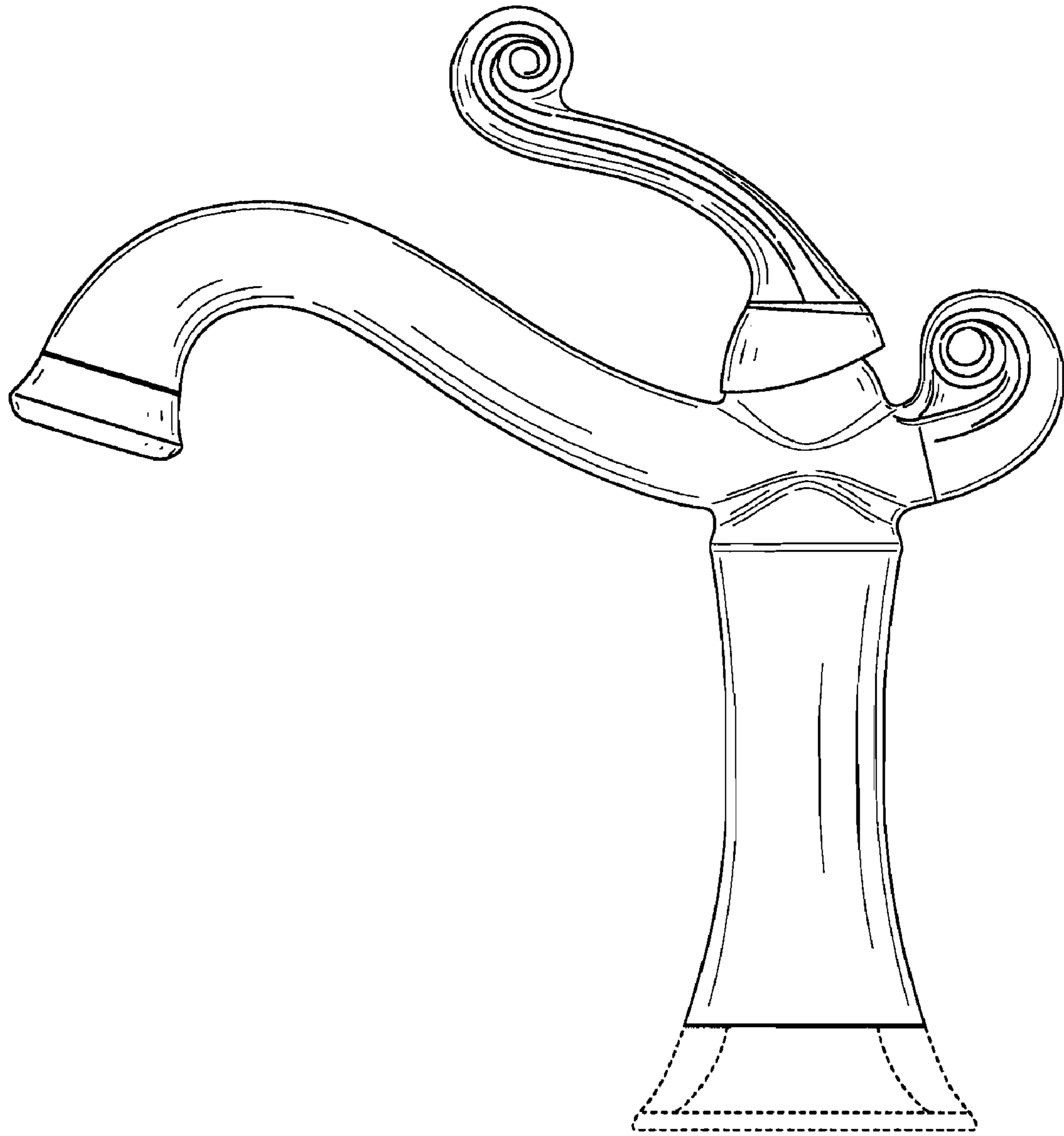

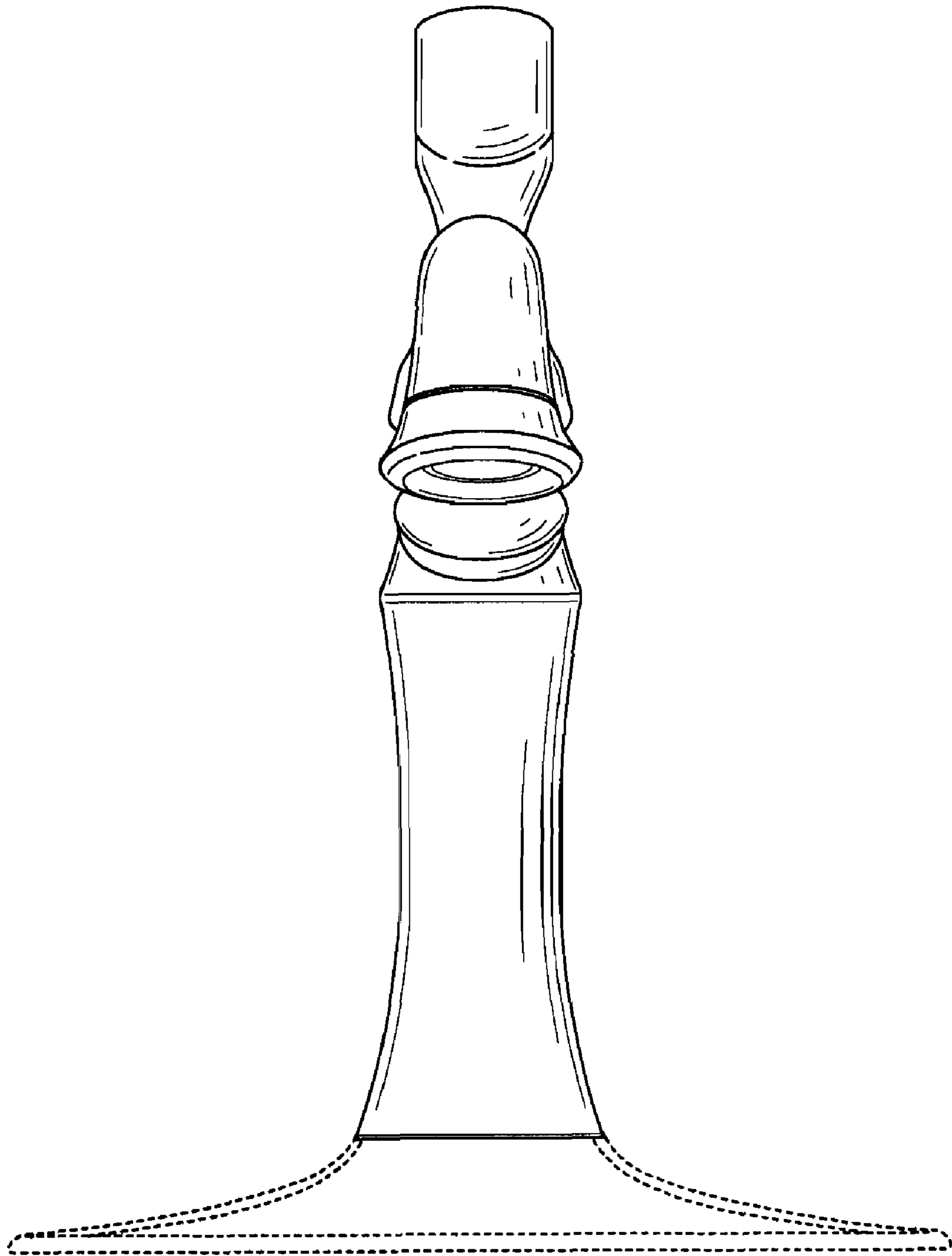
