FIG. 7 is a view of the left side of the decorative ostomy cover.

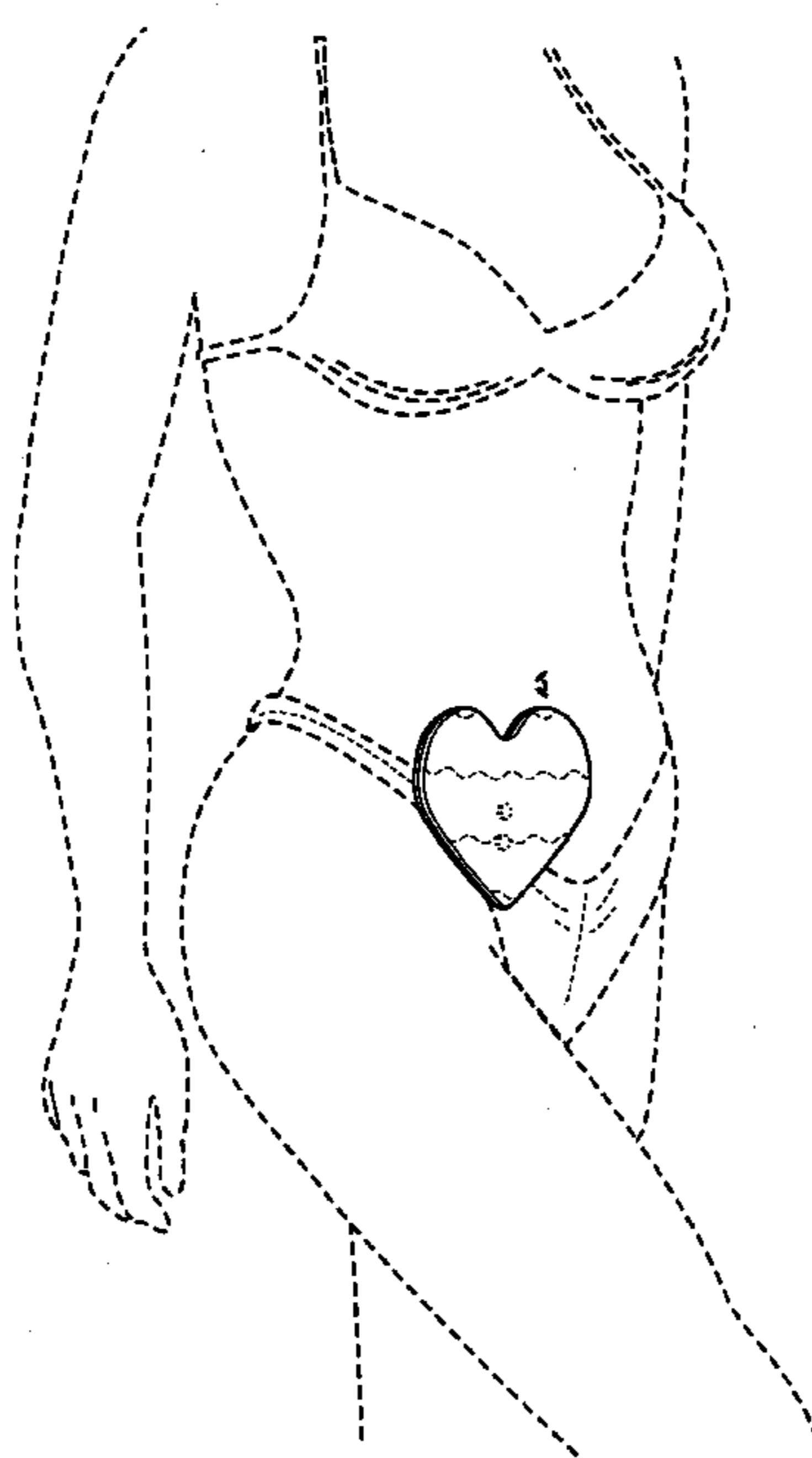

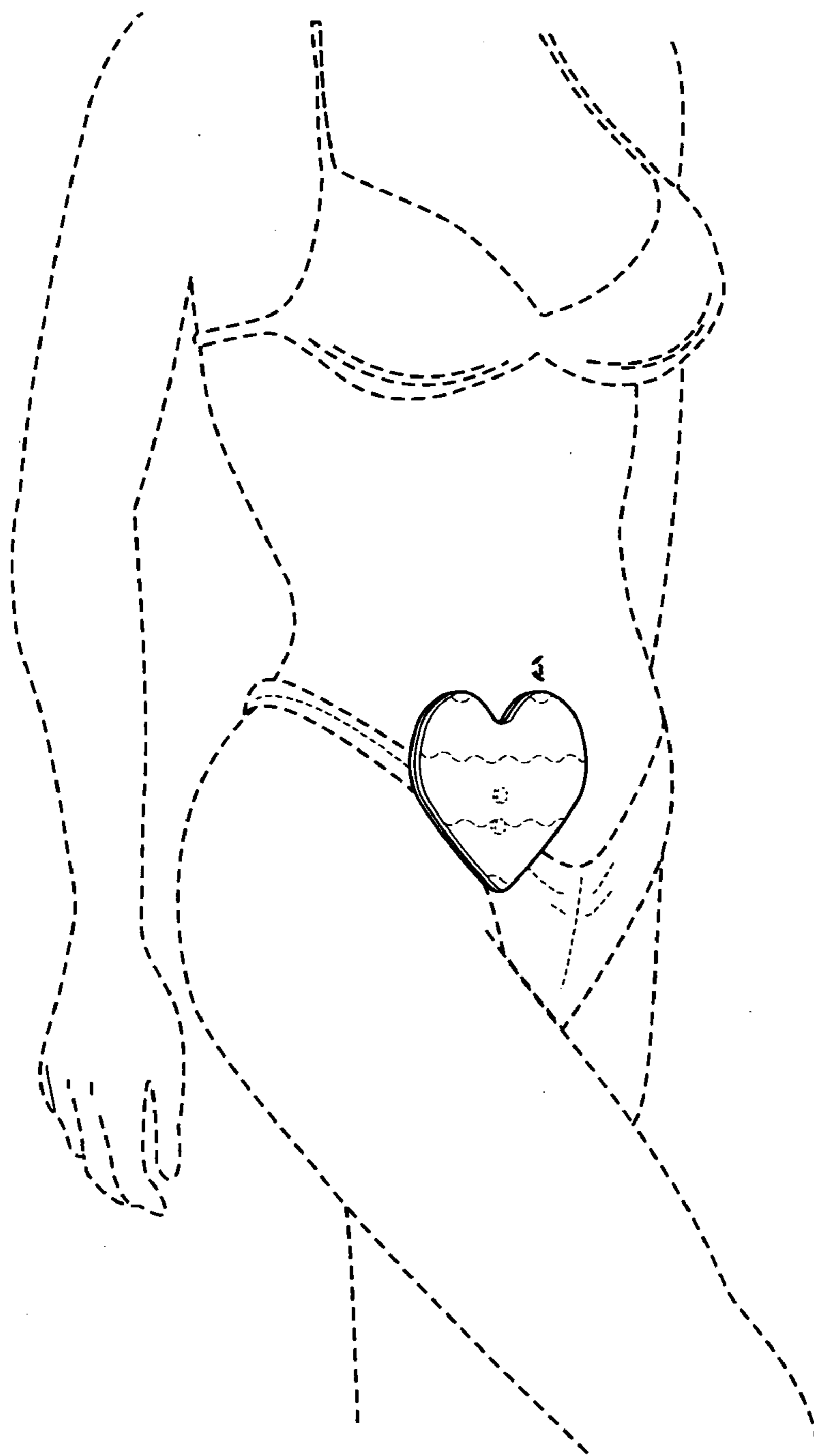

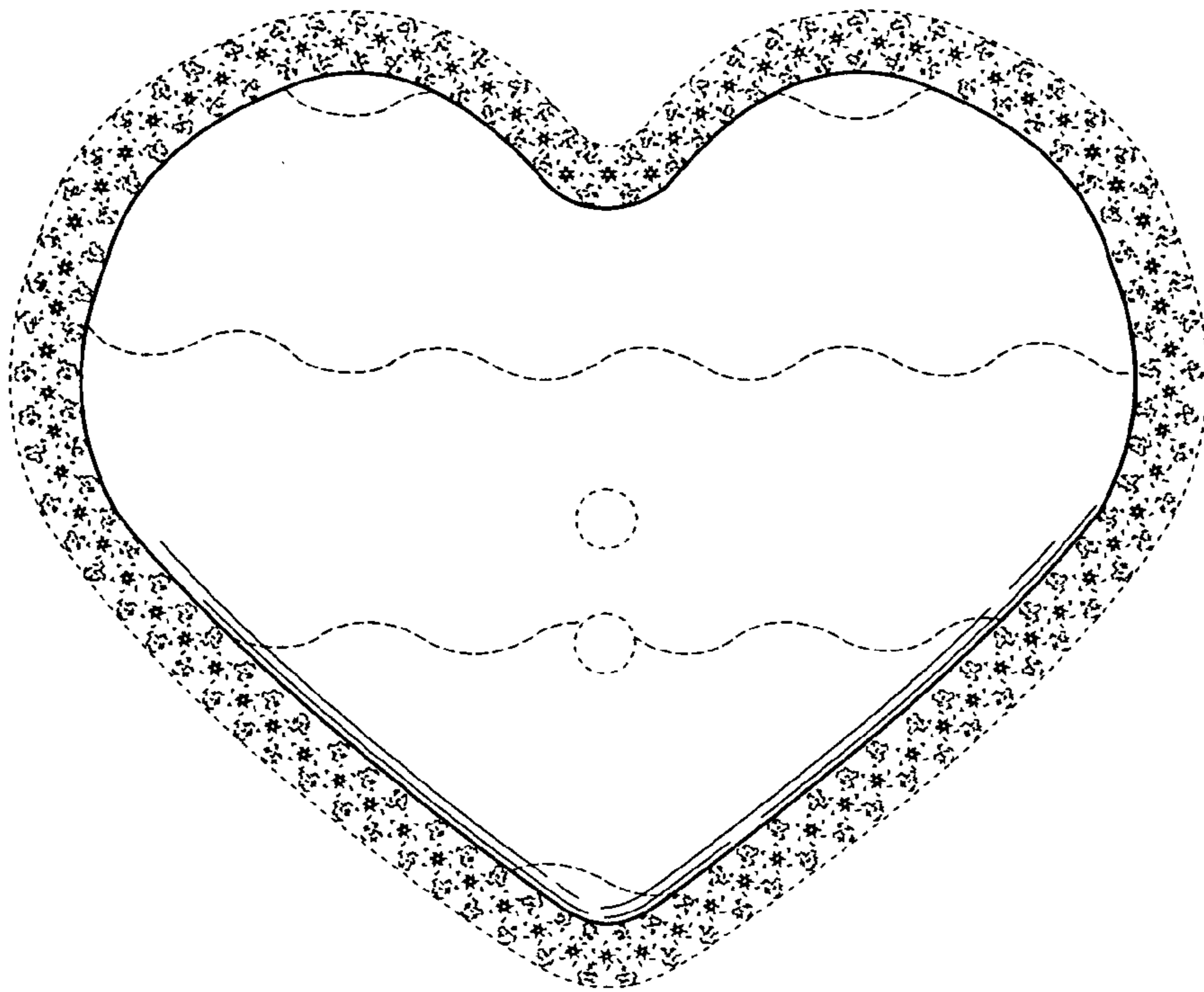

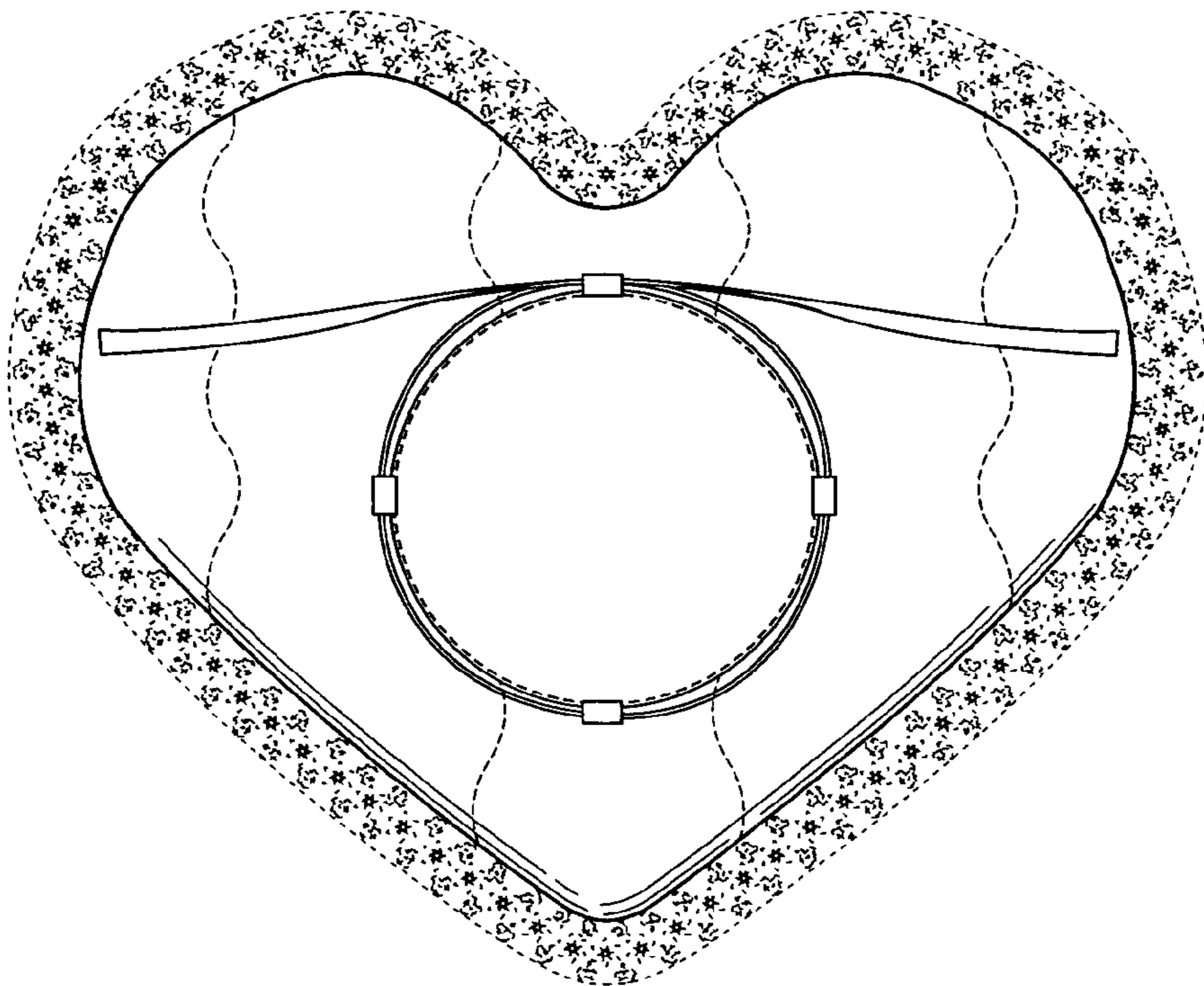

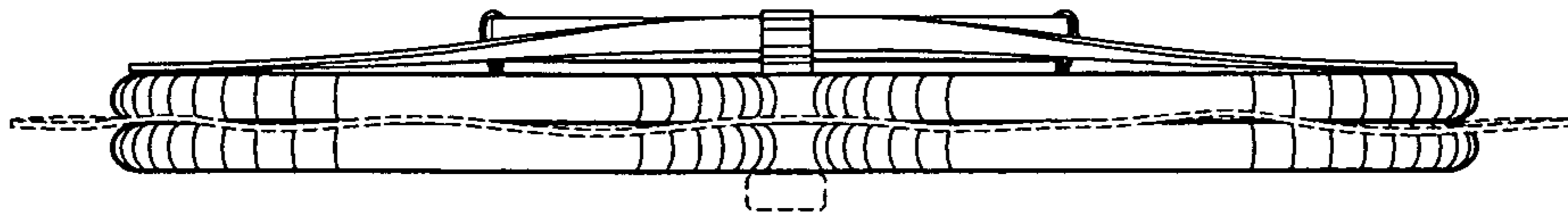

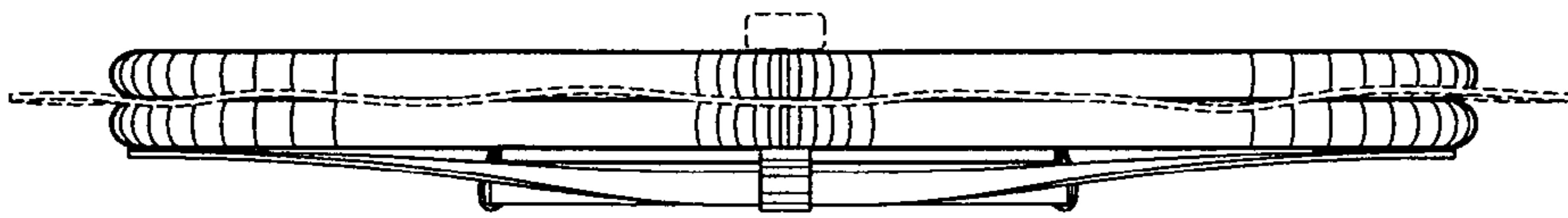

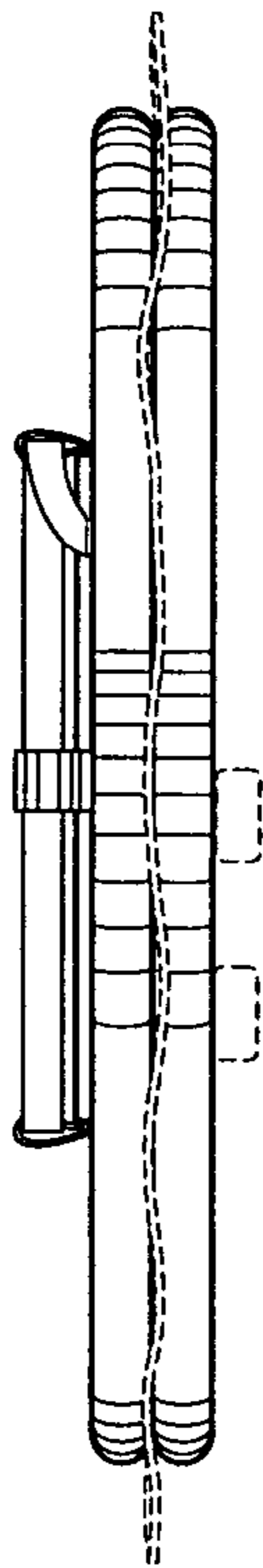

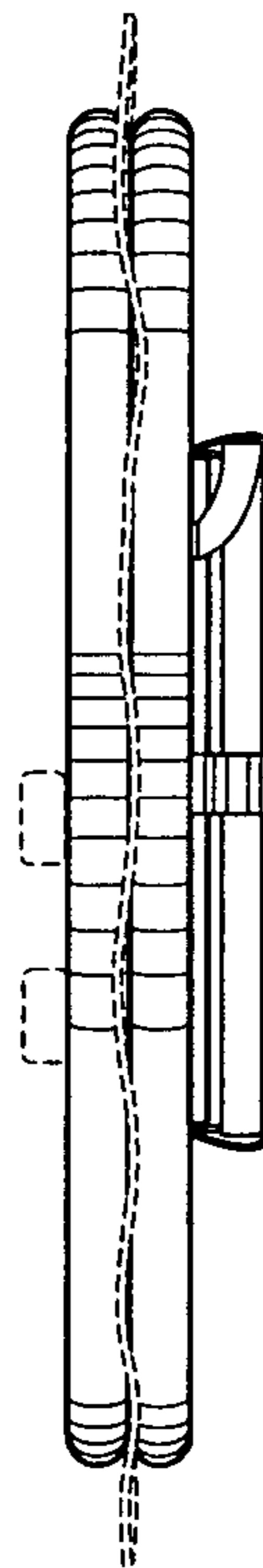
