FIG. 3 is a right side view of the biopsy device;

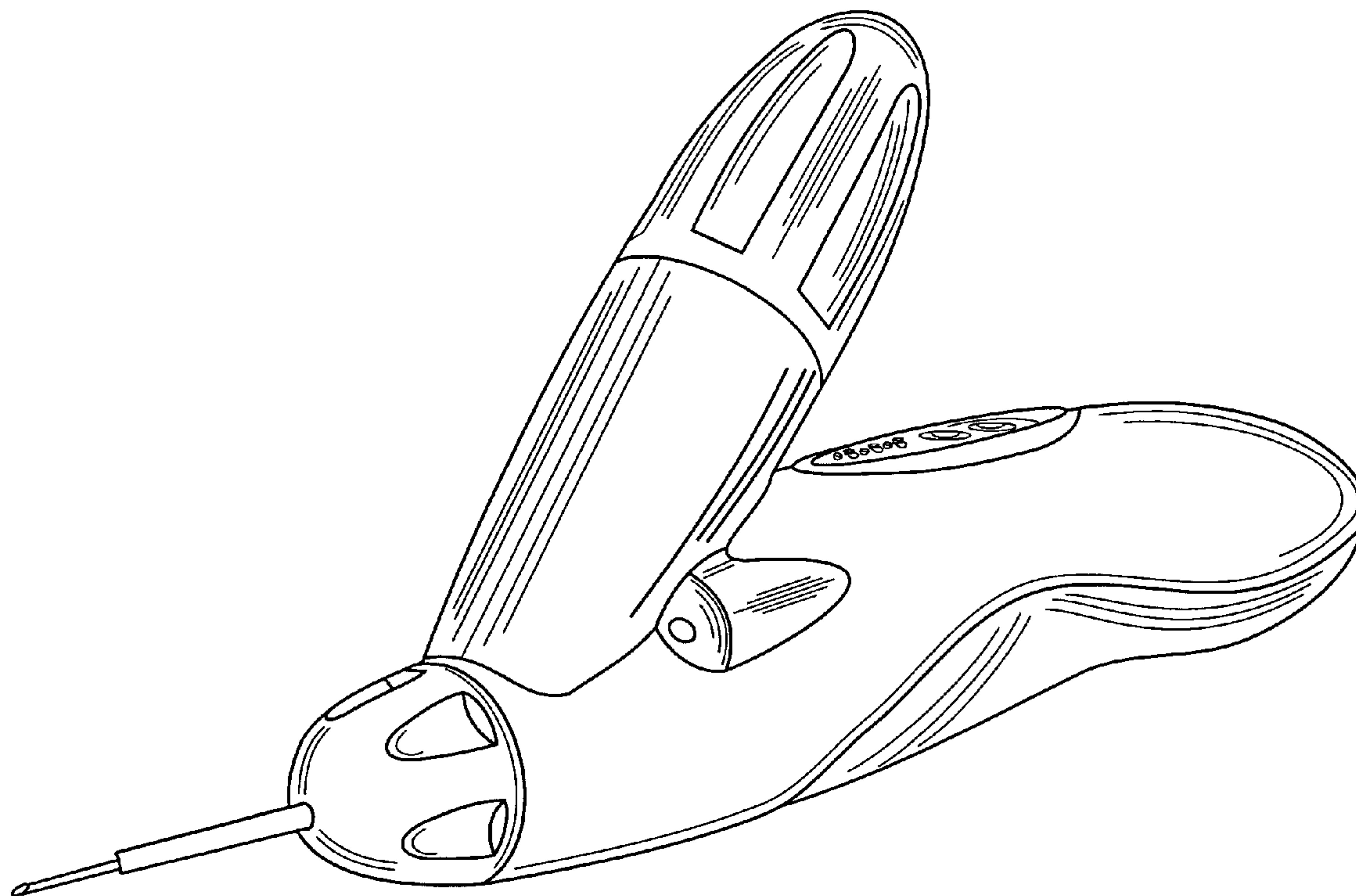
FIG. 4 is a top elevation view of the biopsy device;

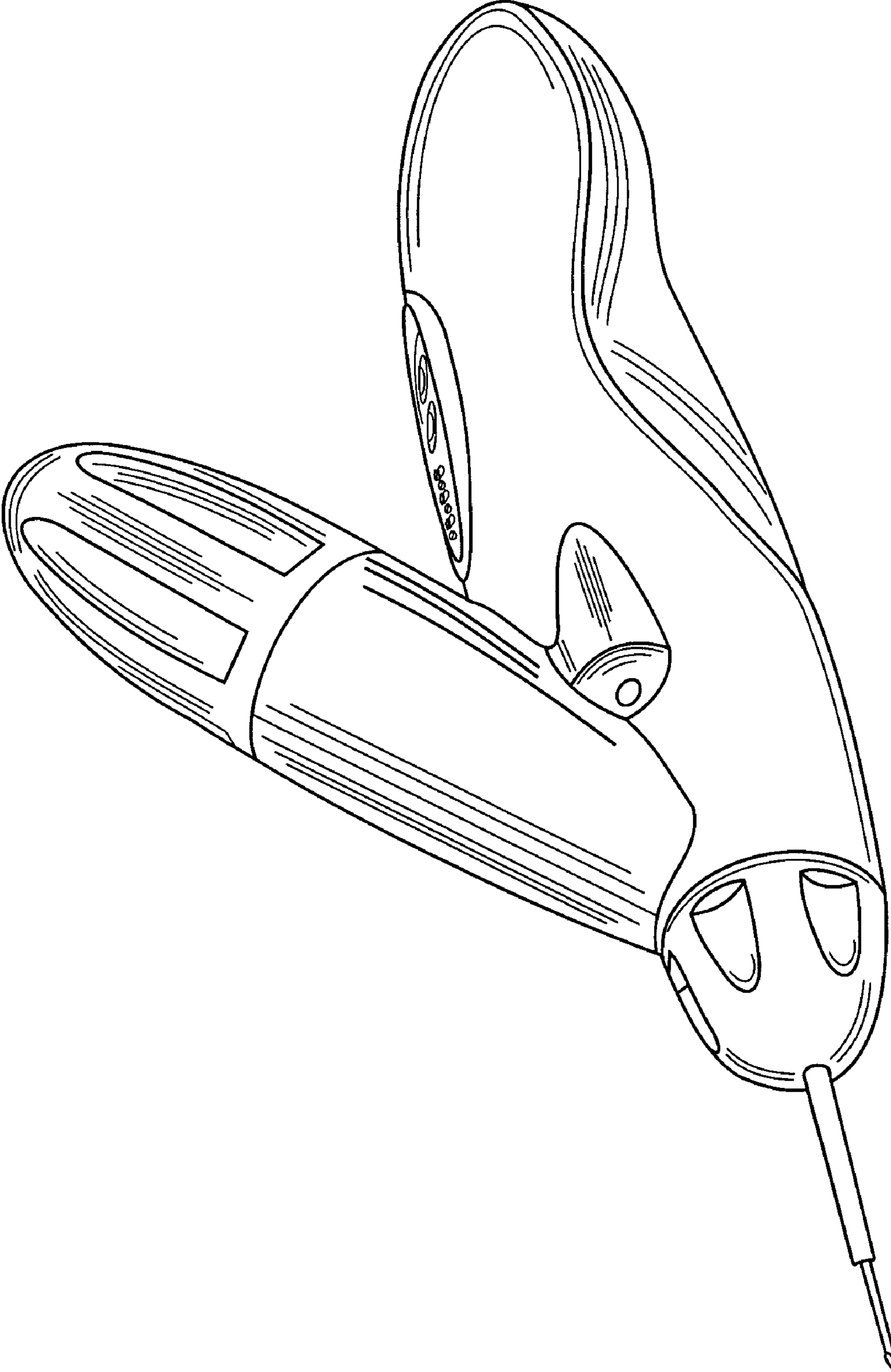

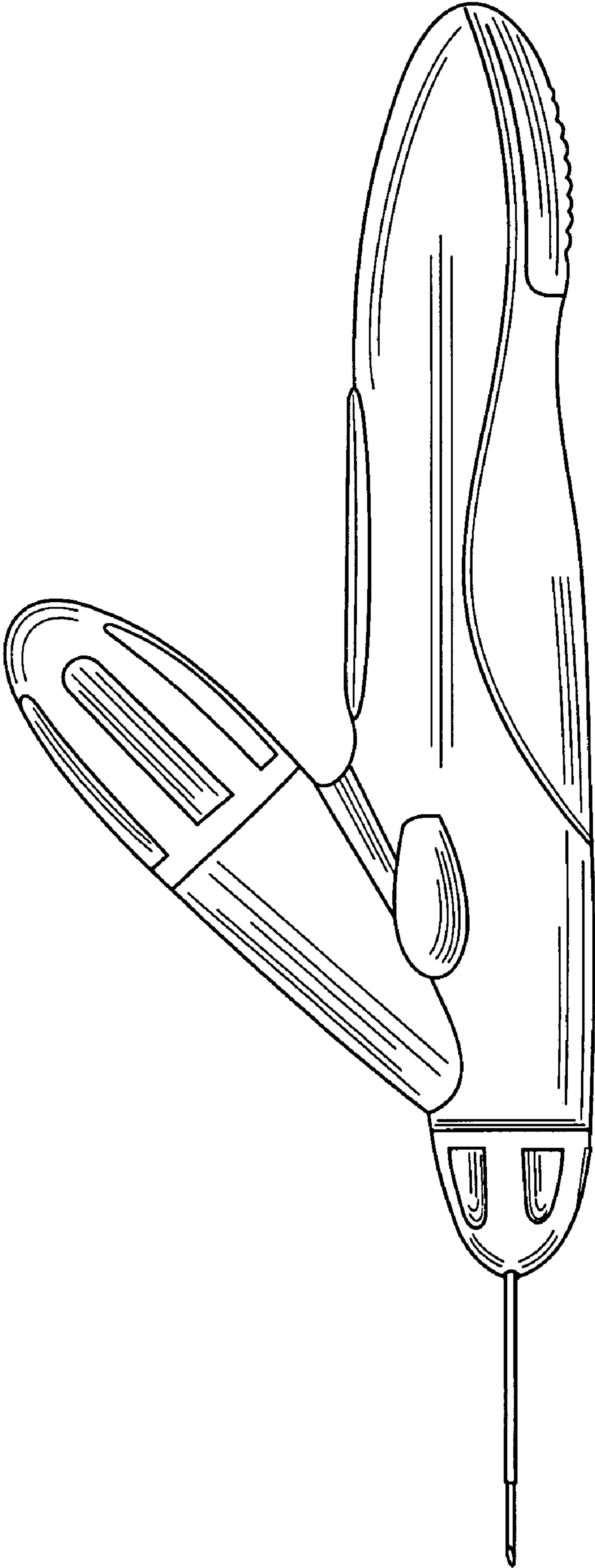

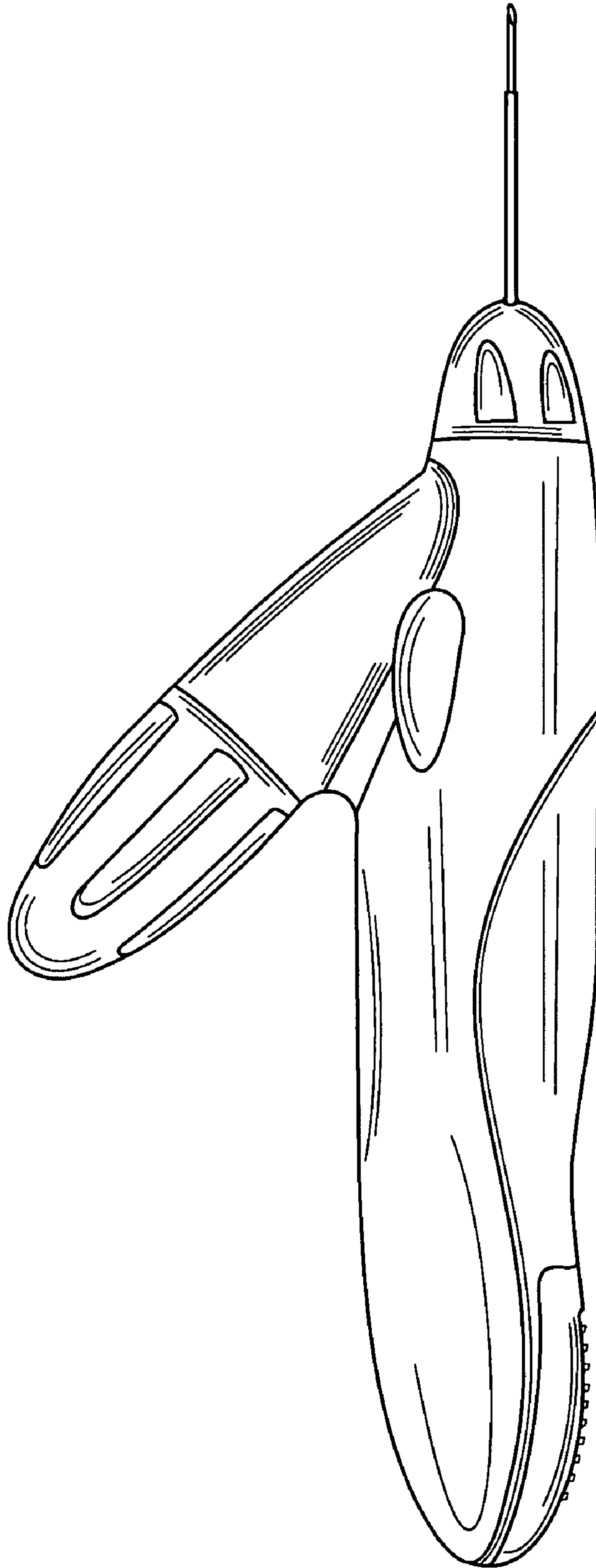

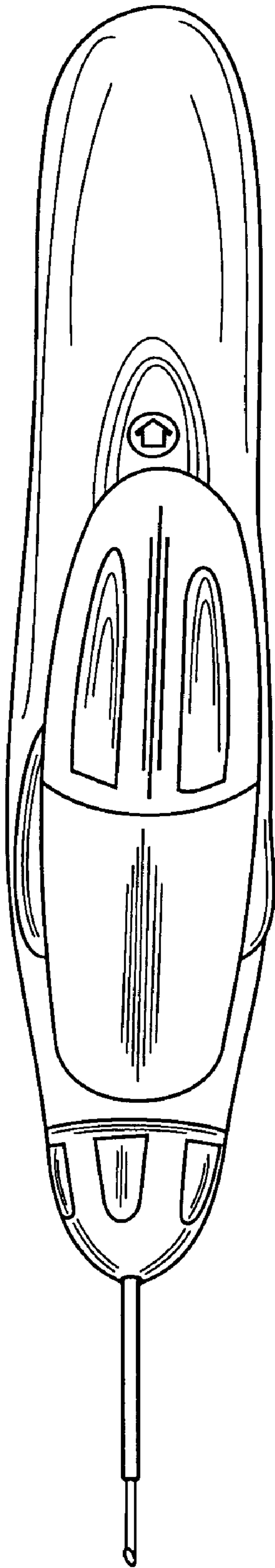

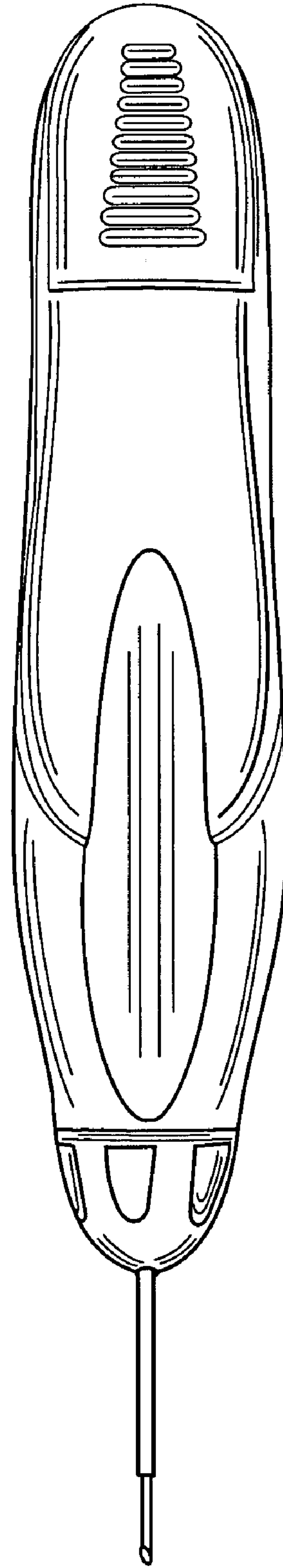

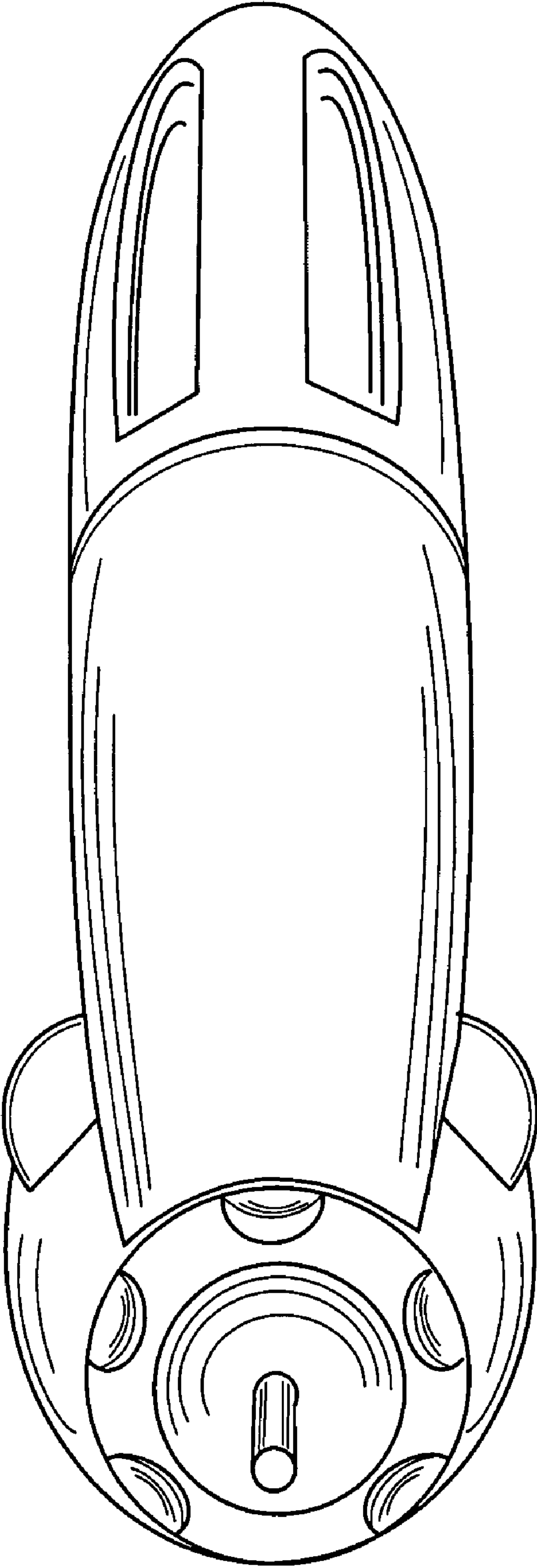

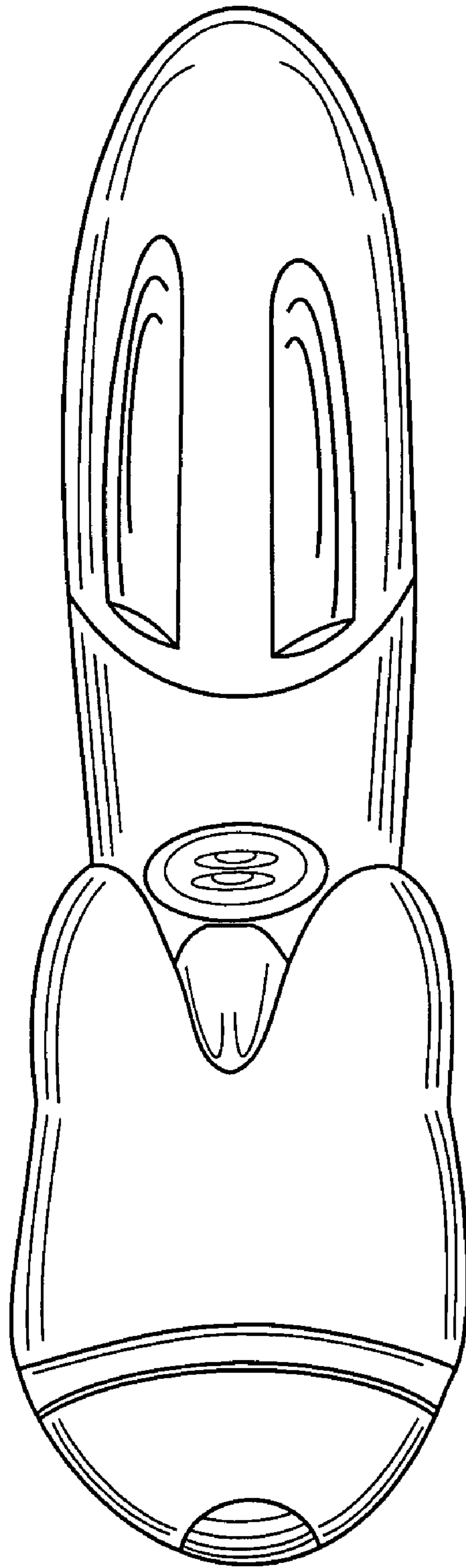
