**DESCRIPTION**

FIG. 1 is a top perspective view of a quick release mecha-  
nism of a flashlight of the present design;

FIG. 2 is a bottom perspective view of the quick release  
mechanism of the flashlight of FIG. 1;

FIG. 3 is a side elevation view of the quick release mecha-  
nism of the flashlight of FIG. 1;

FIG. 4 is a side elevation view from a second angle of the  
quick release mechanism in FIG. 1;

FIG. 5 is a top plan view of the quick release mechanism of  
the flashlight of FIG. 1; and,

FIG. 6 is a bottom plan view of the quick release mechanism  
of the flashlight of FIG. 1.

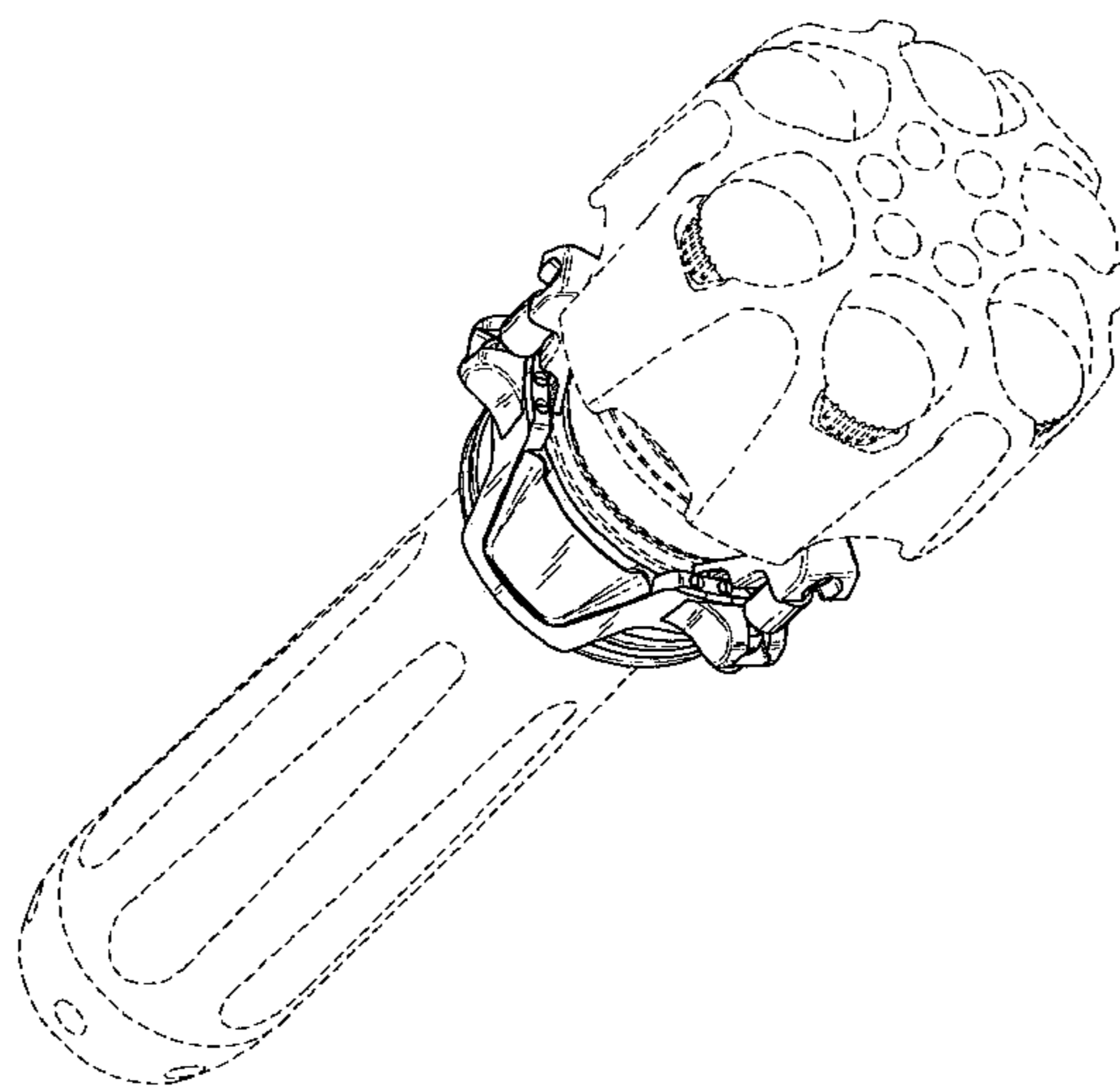

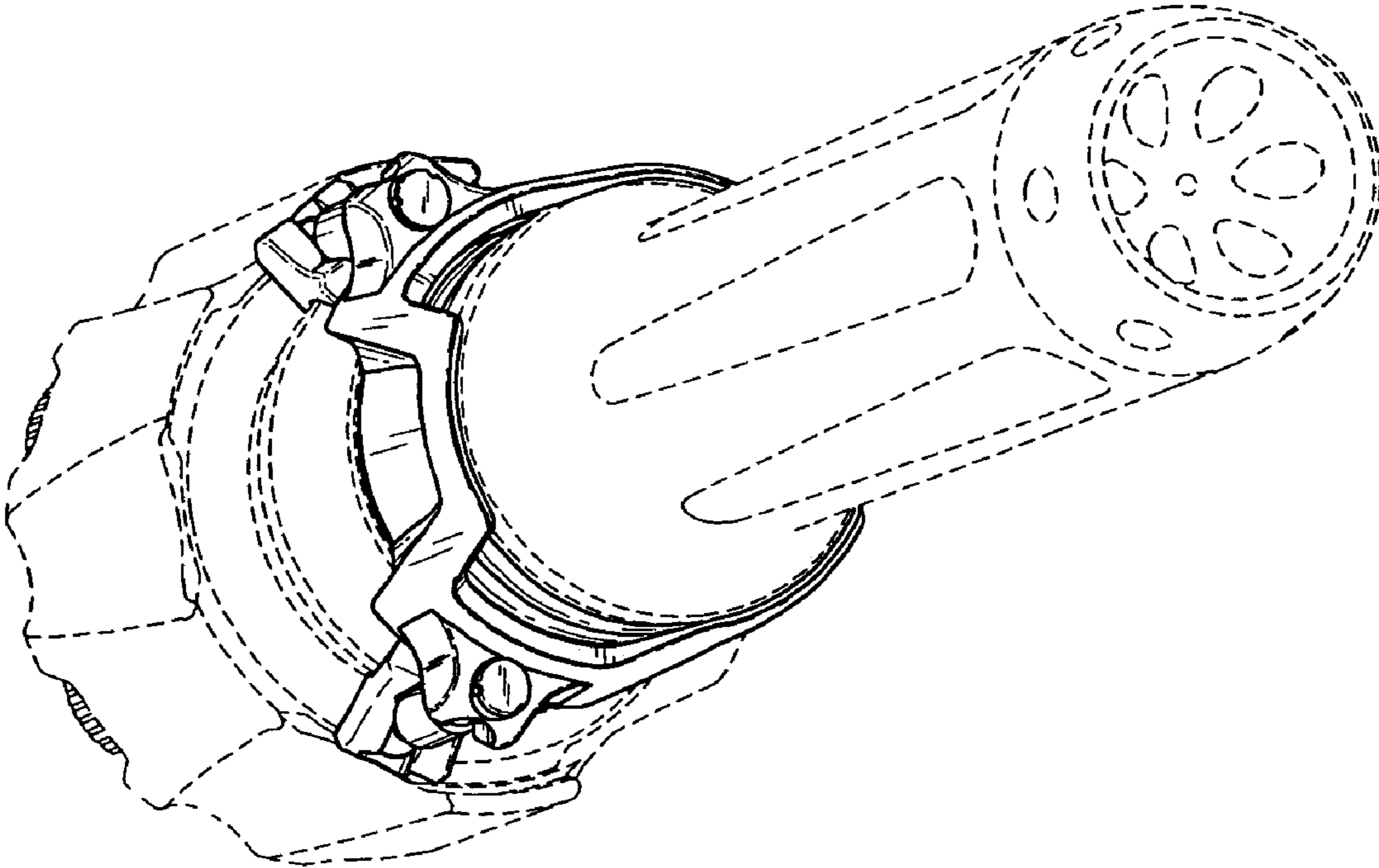

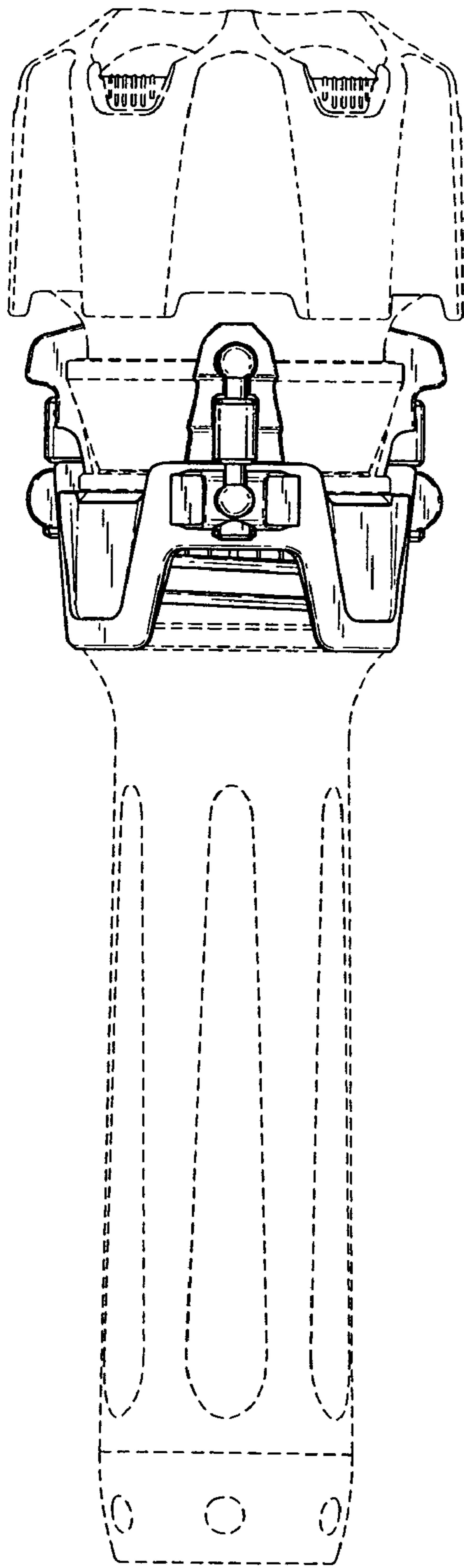

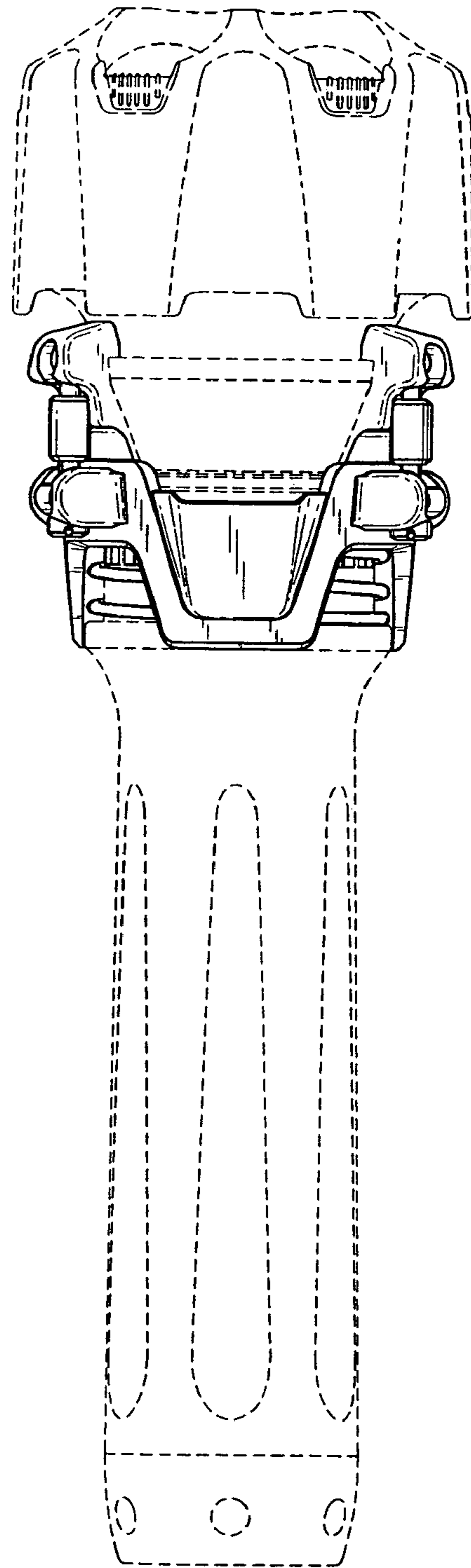

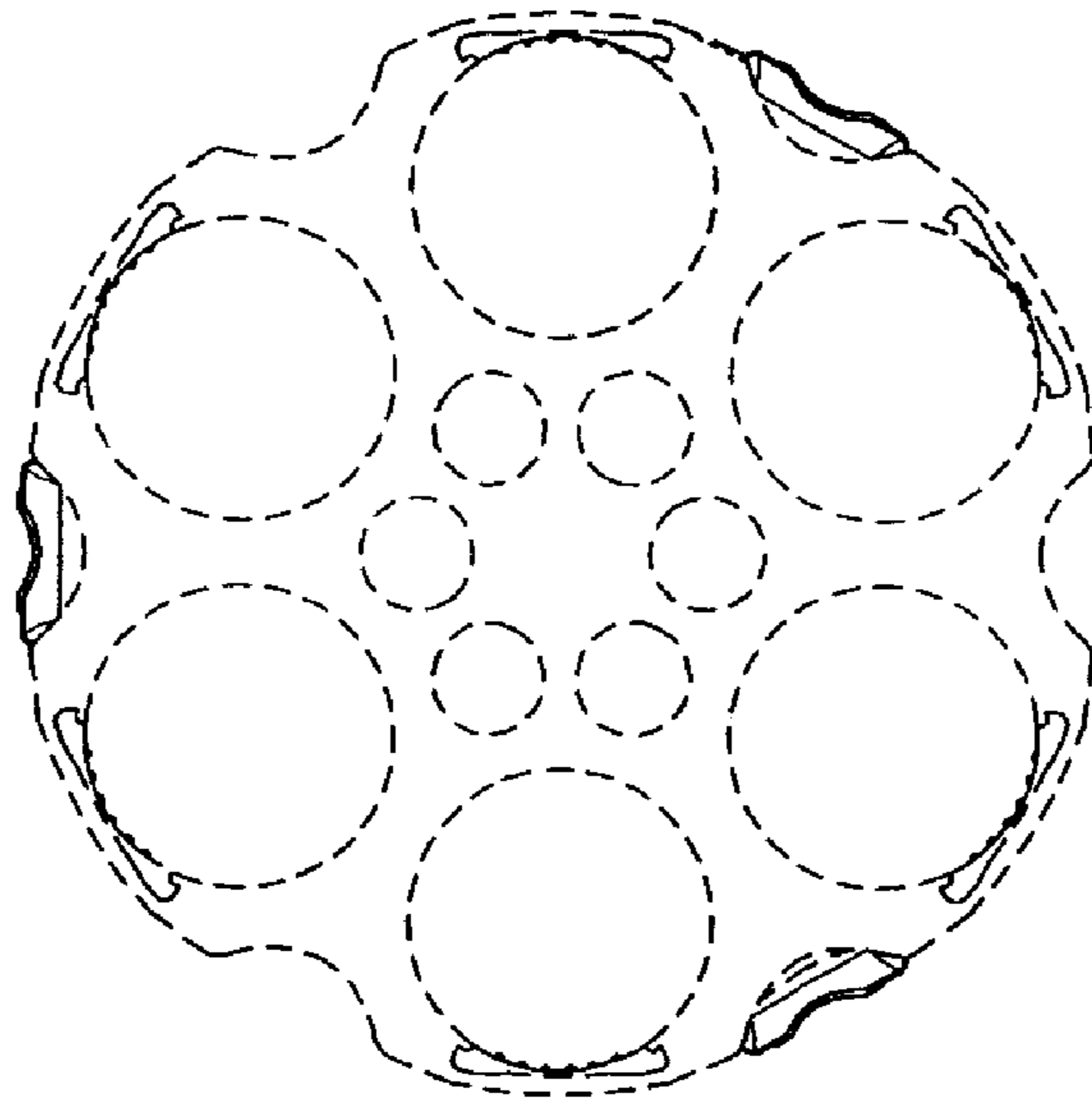

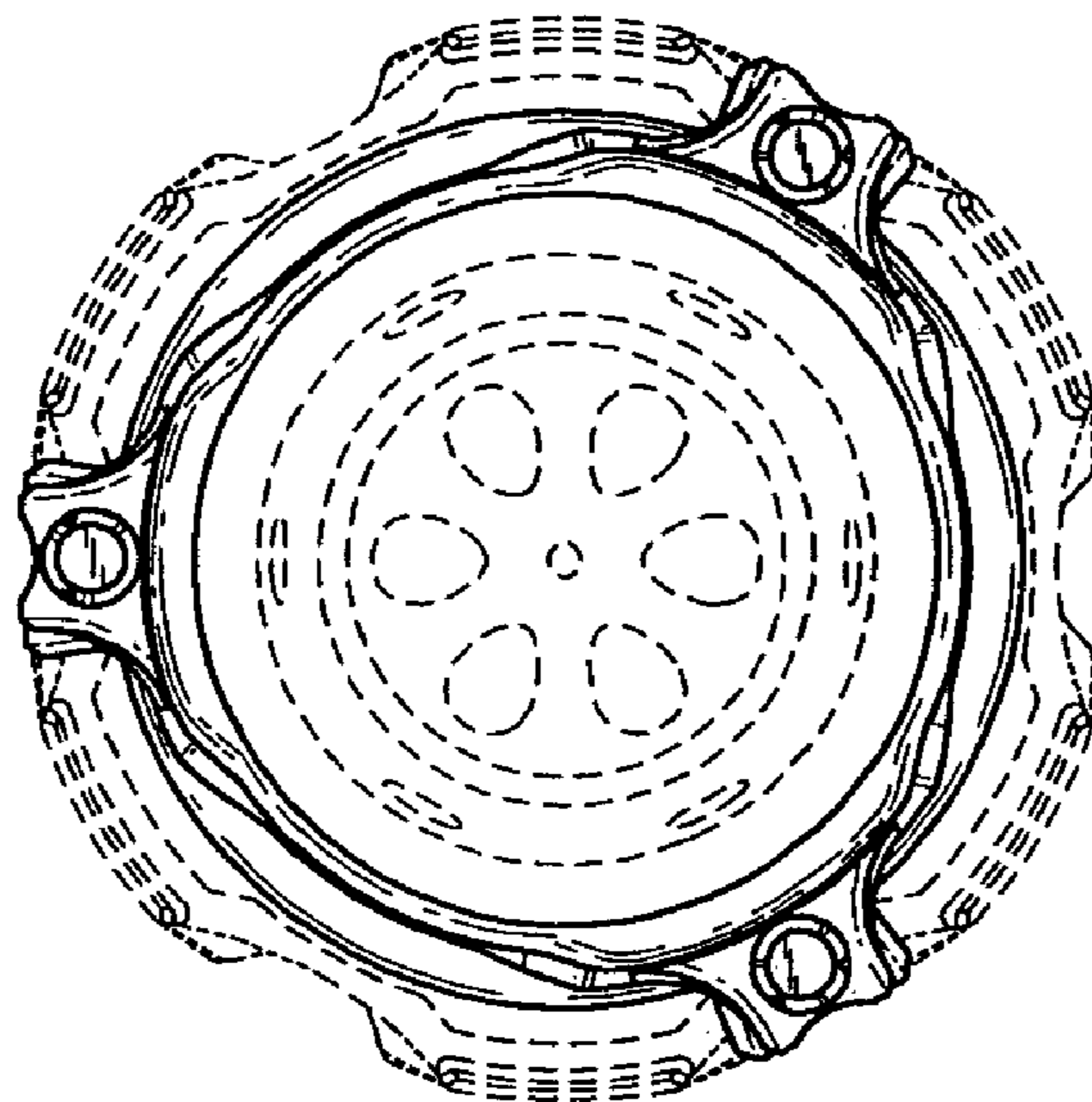
