(57) **CLAIM**

The ornamental design for a card holder for a round precious coin, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the card holder for a round precious coin showing my new design, with the bottom view being a mirror image;

FIG. 2 is a side elevational view of the card holder of FIG. 1, the opposite side elevational view being a mirror image; and,

FIG. 3 is a front elevational view of the card holder of FIG. 1, the rear elevational view being a mirror image.

The broken line showing of a round precious coin illustrates environmental structure and forms no part of the claimed design.

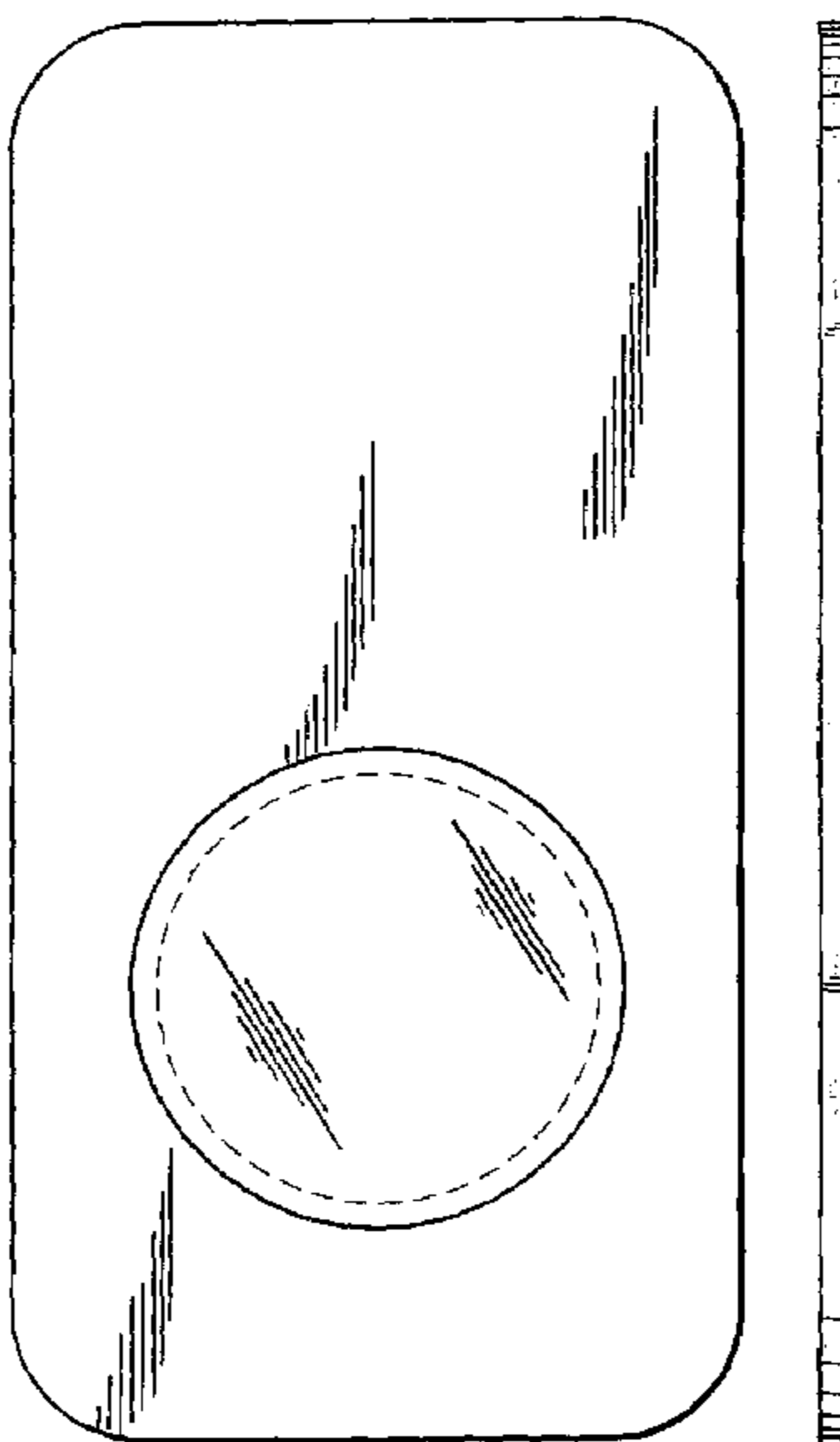

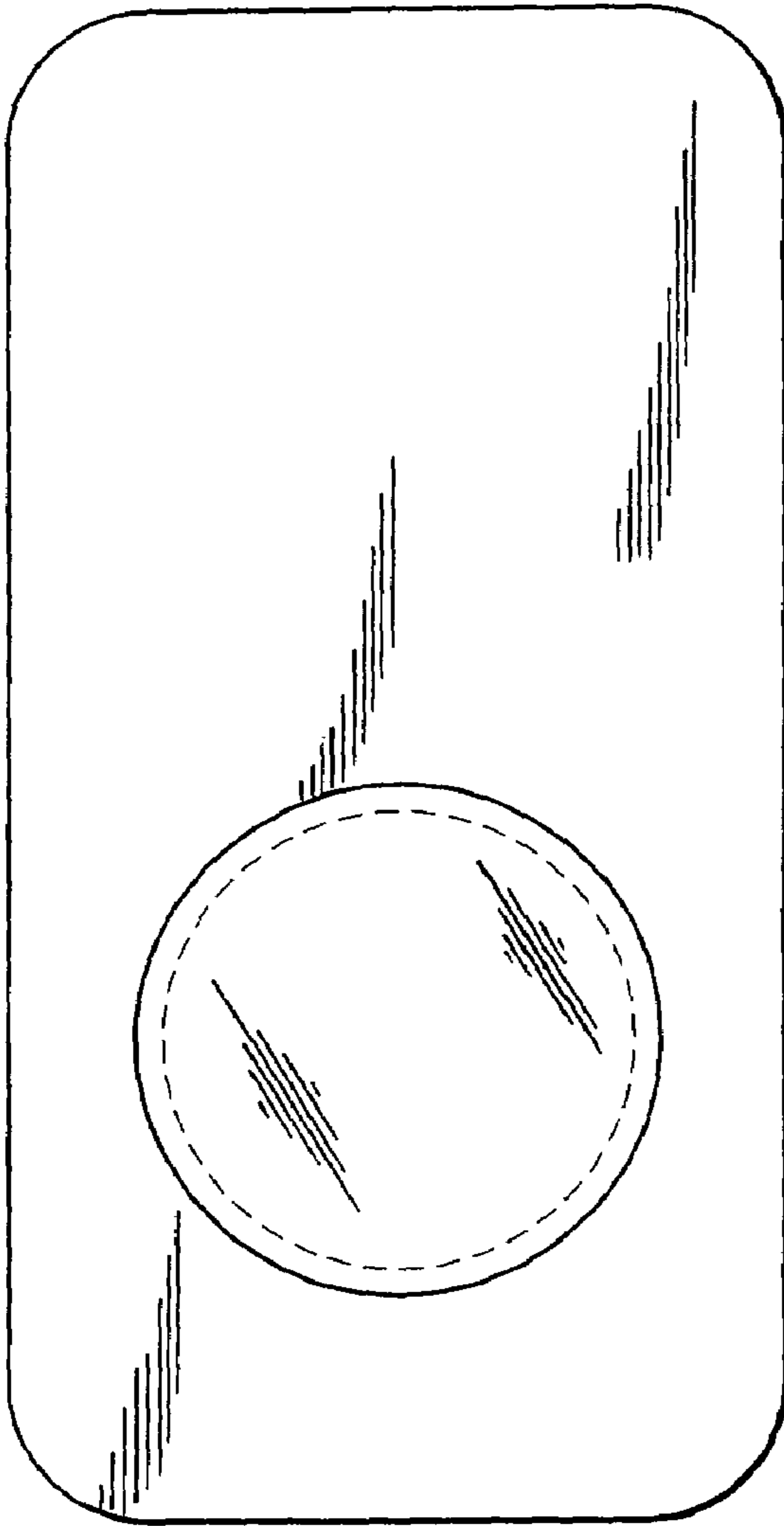
