The ornamental design for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new footwear design;

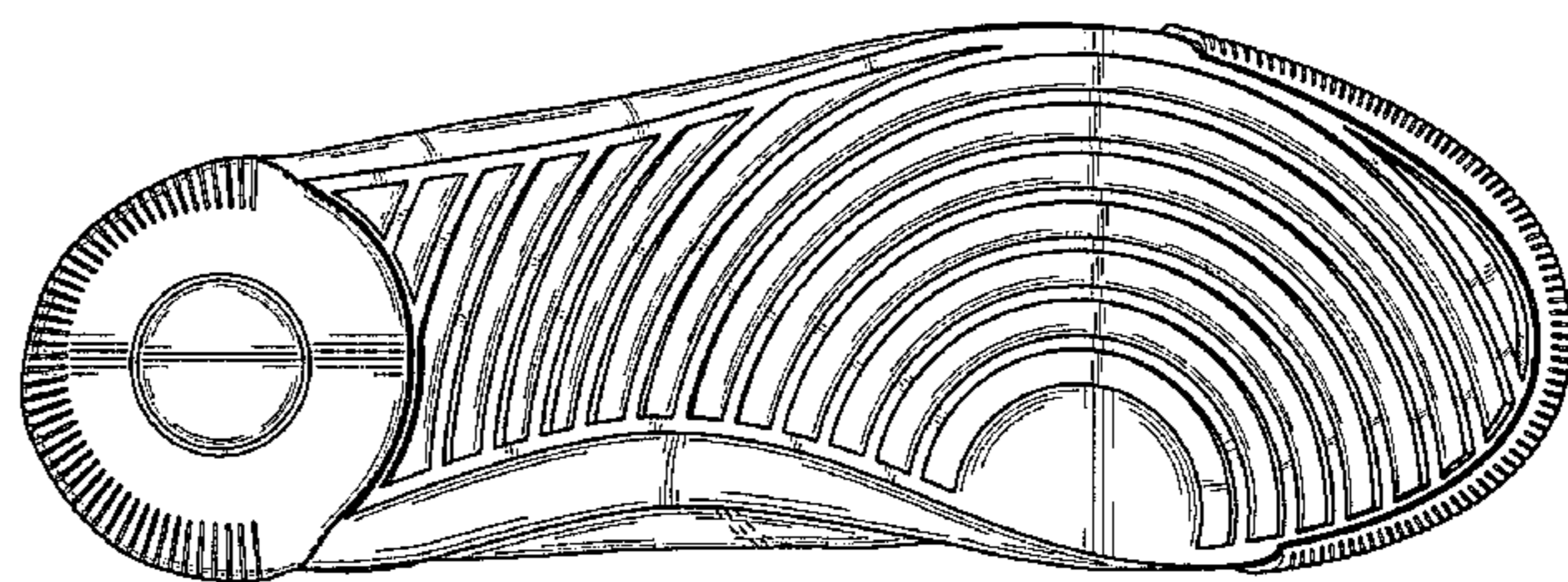
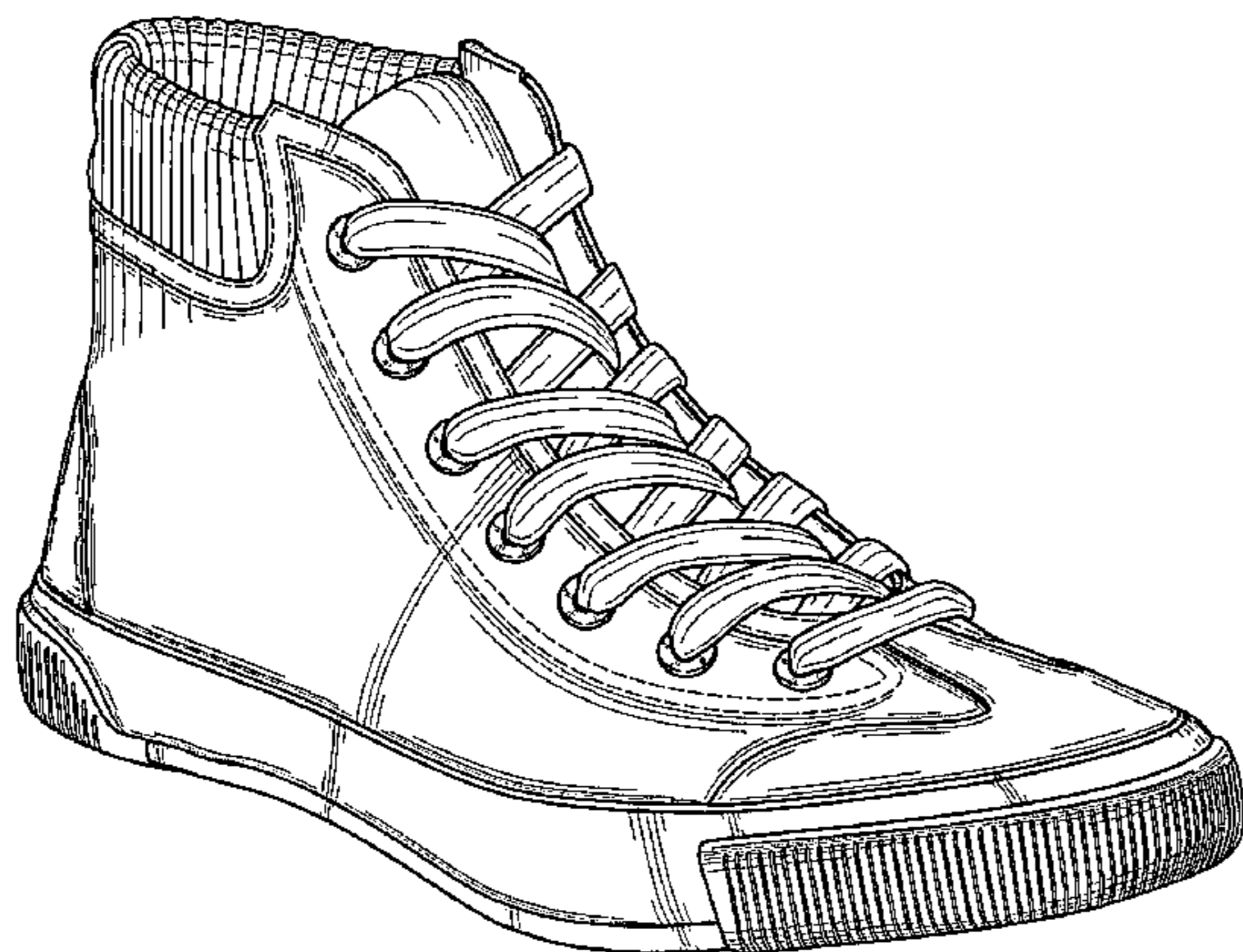

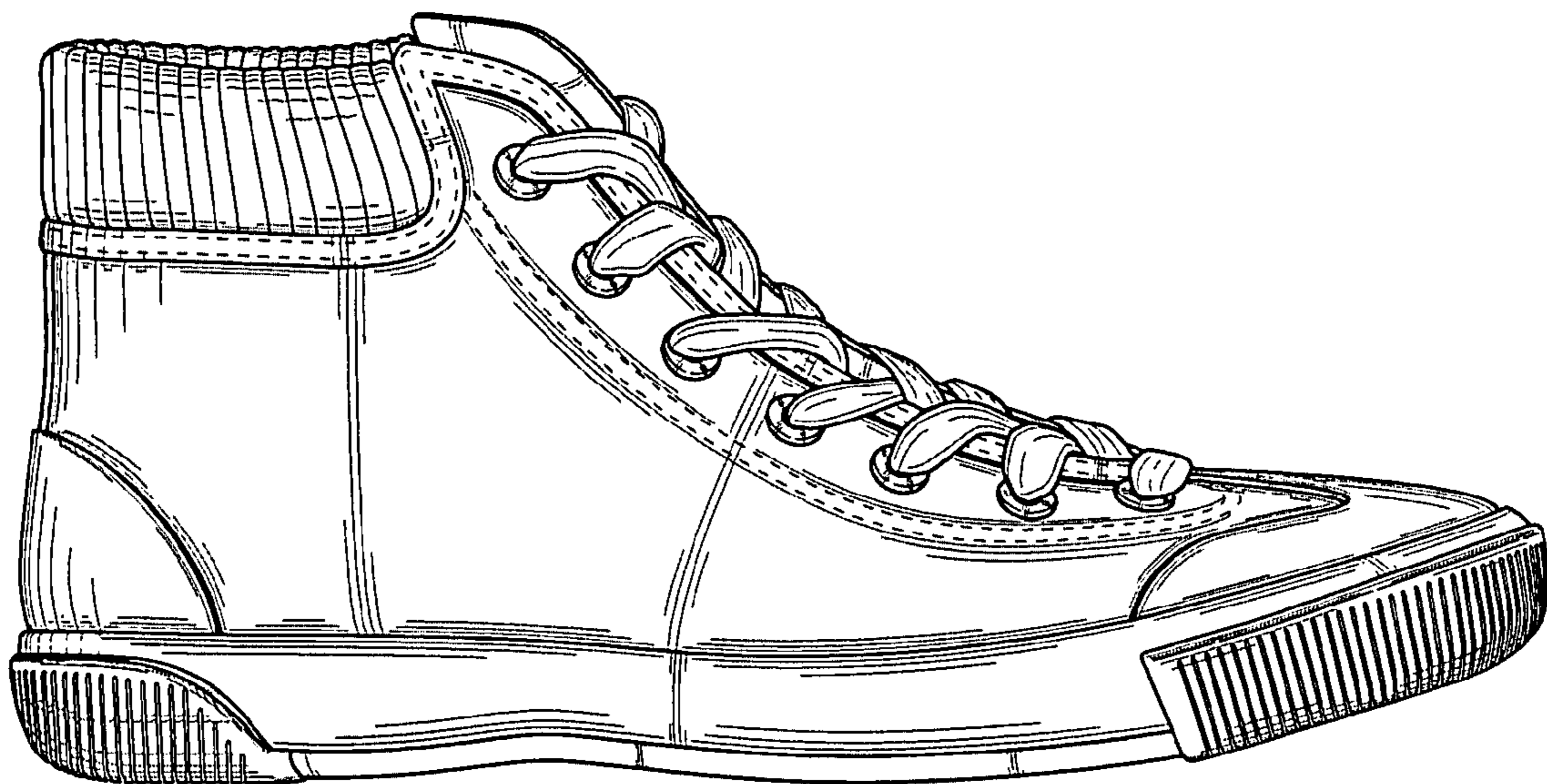

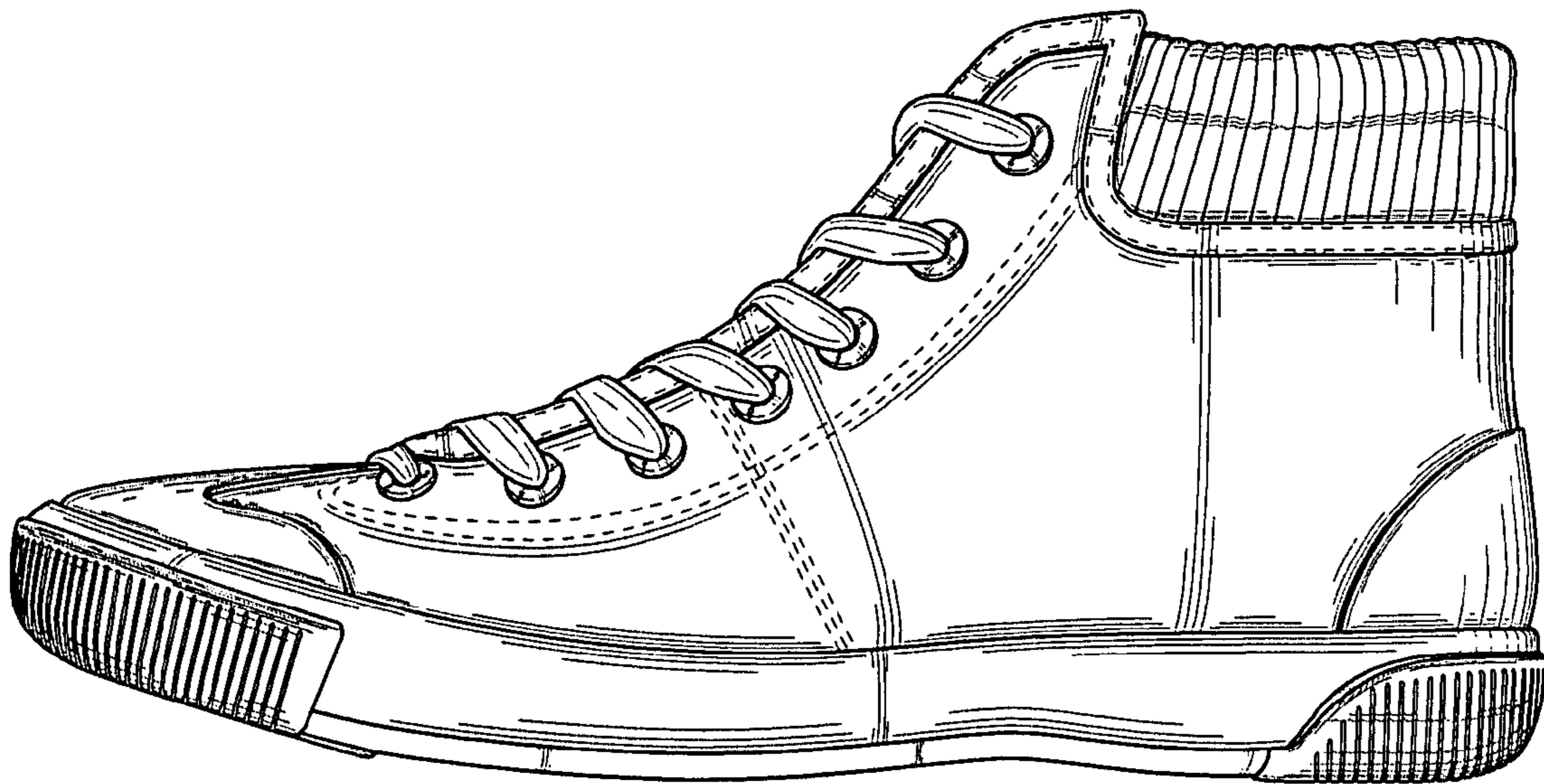

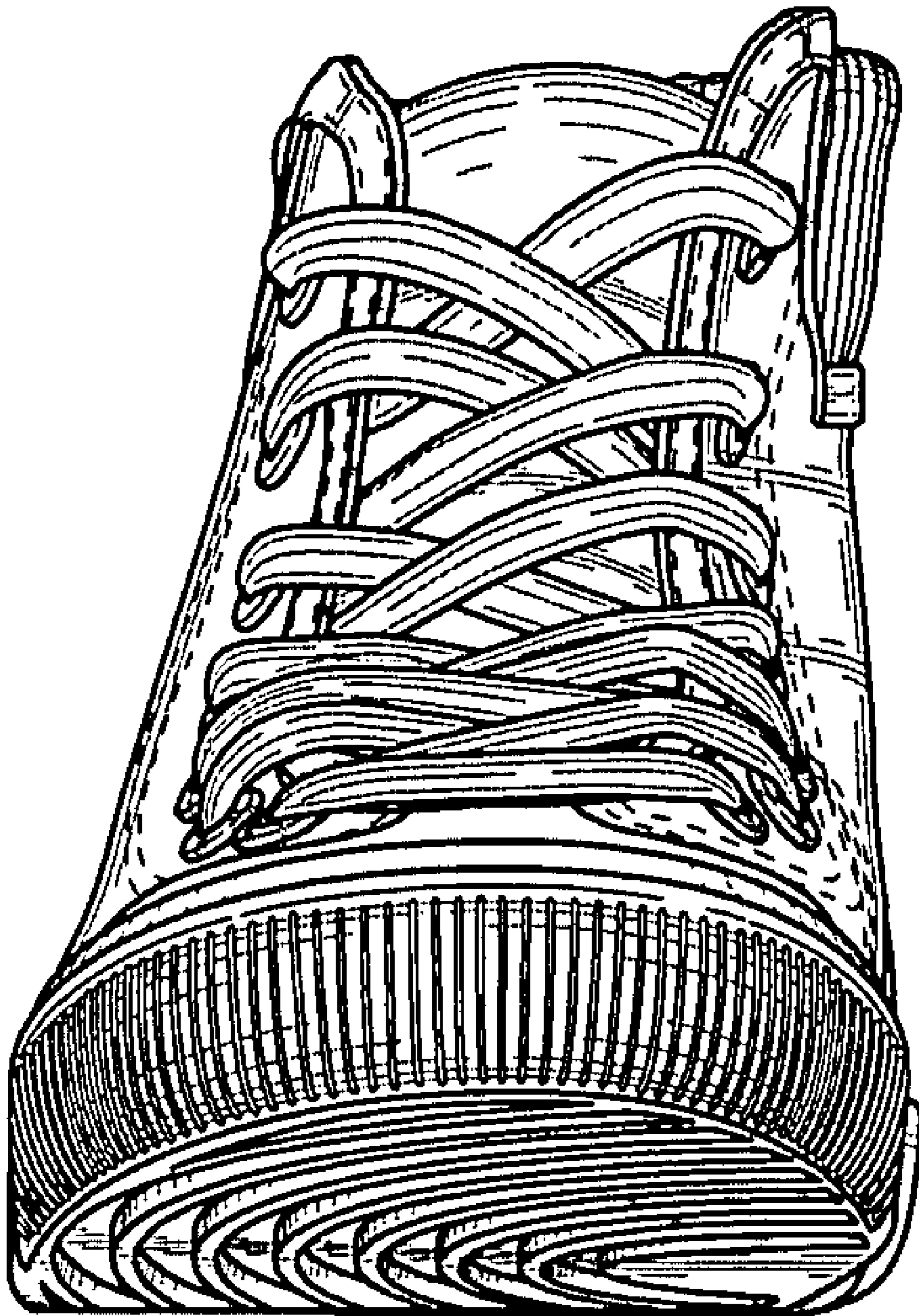

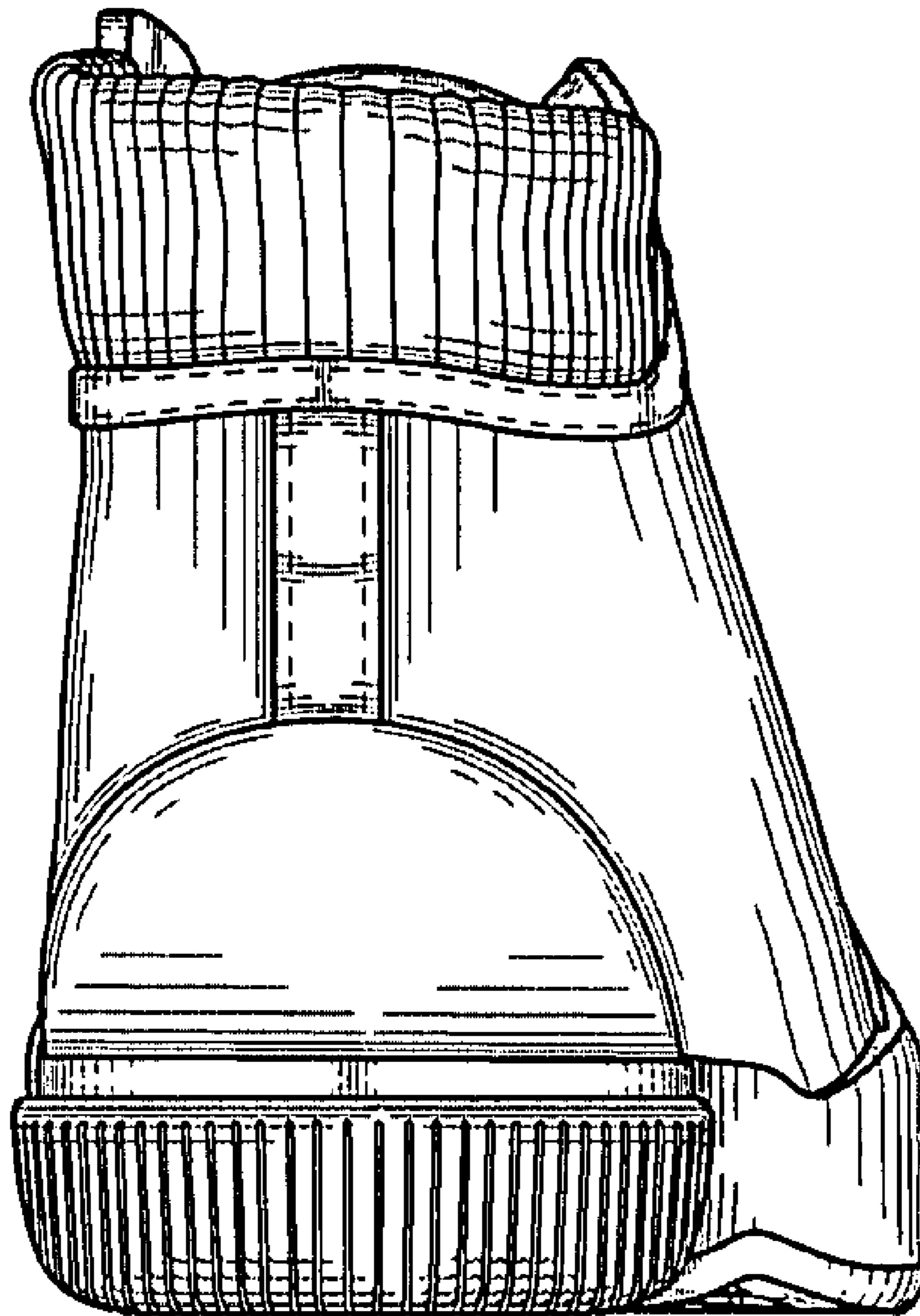

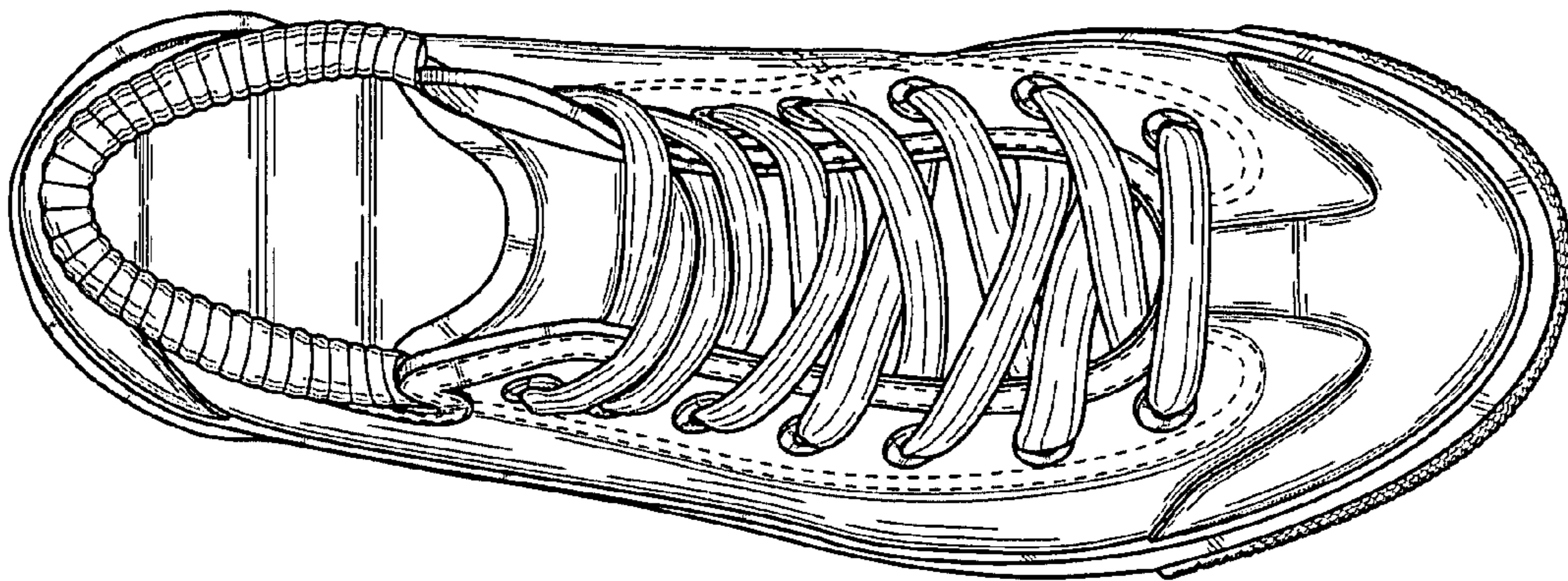

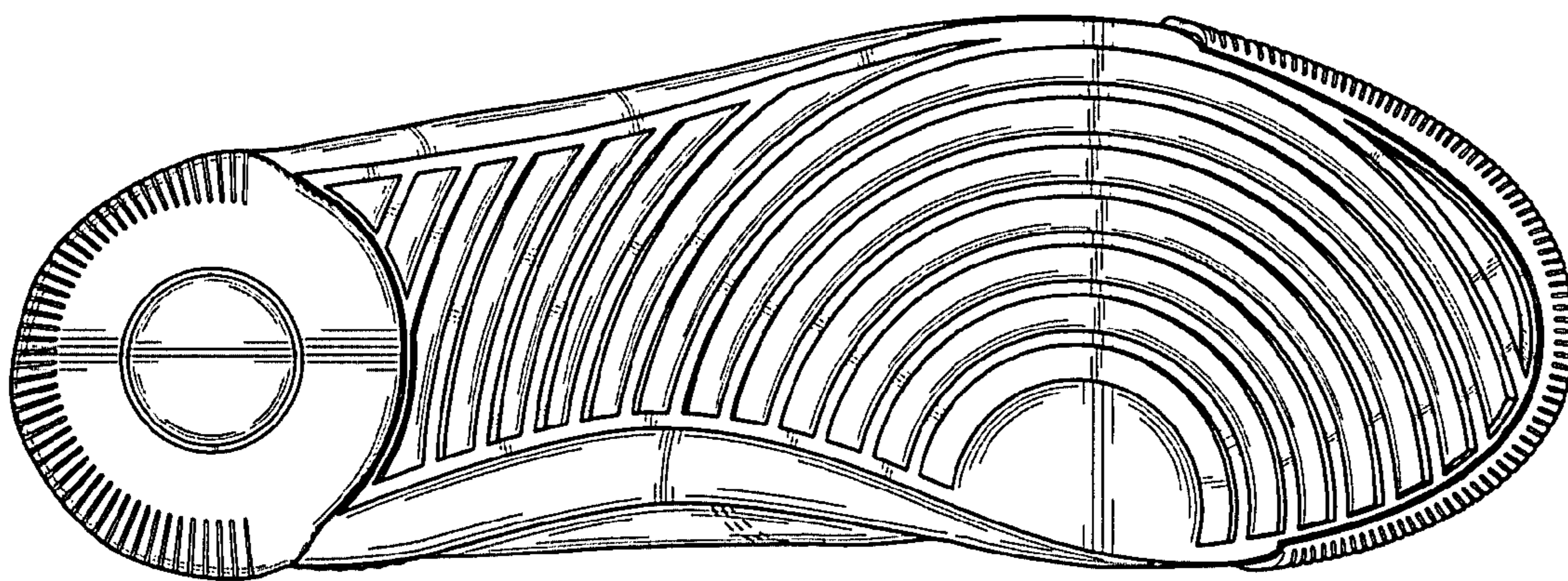
