(57) **CLAIM**

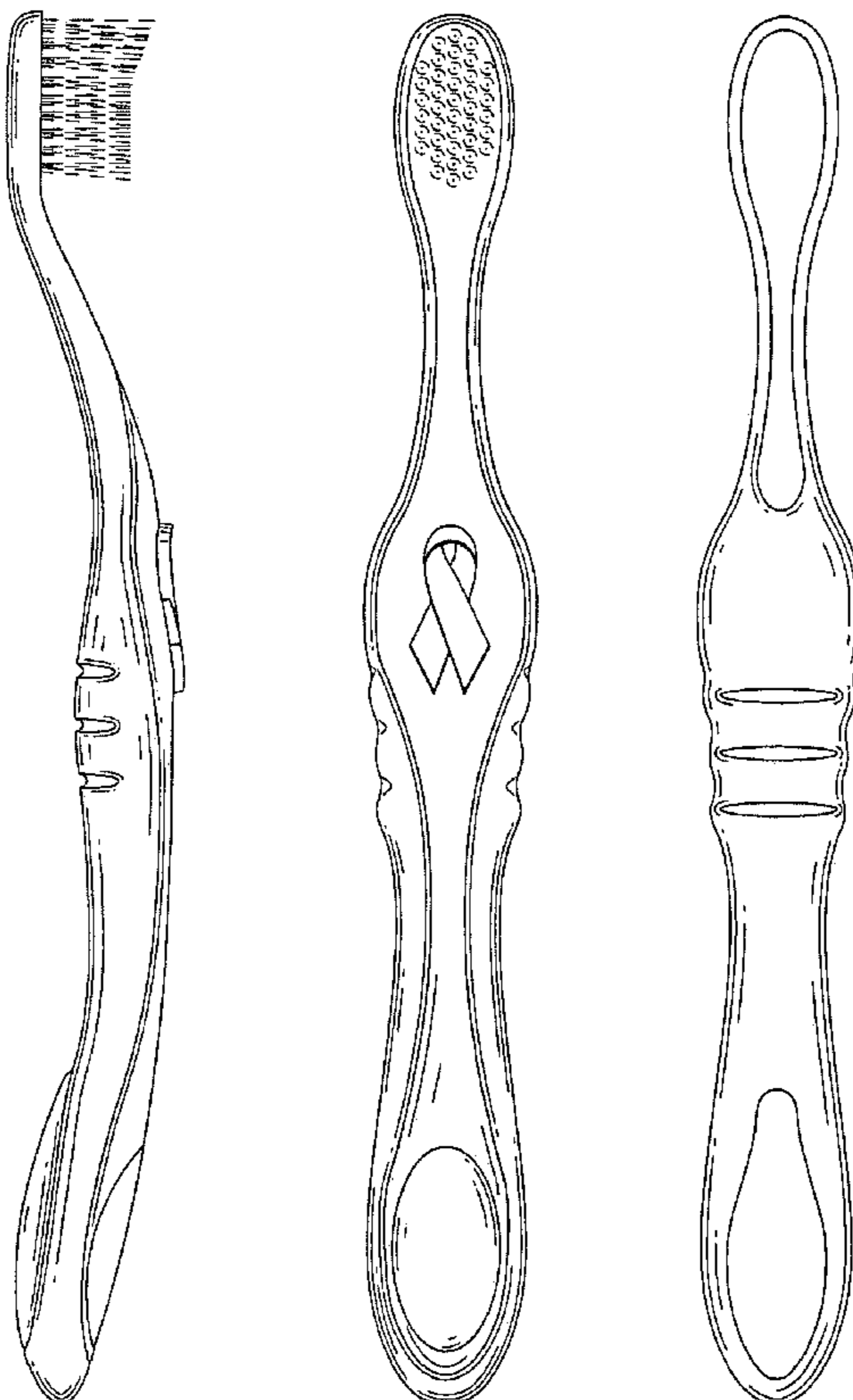
The ornamental design for a toothbrush with a ribbon handle, as shown and described.

**DESCRIPTION**

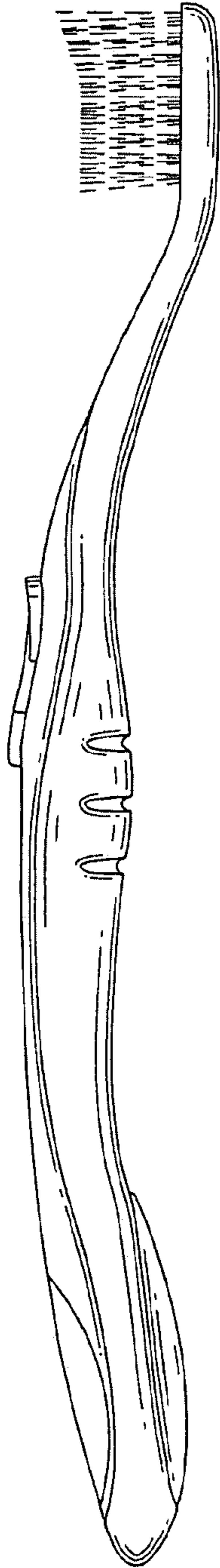

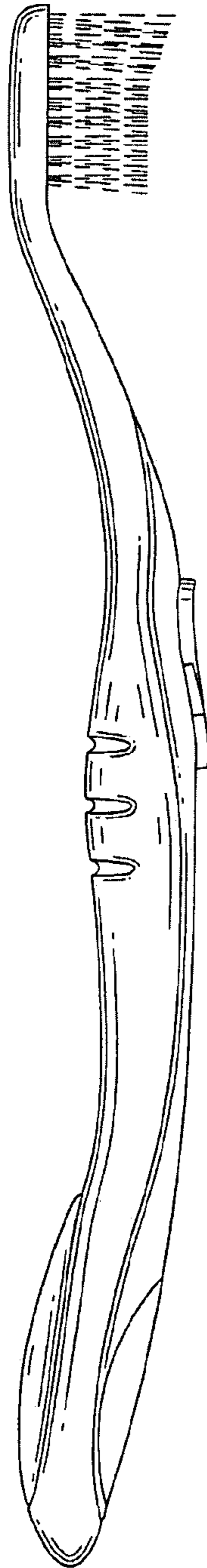

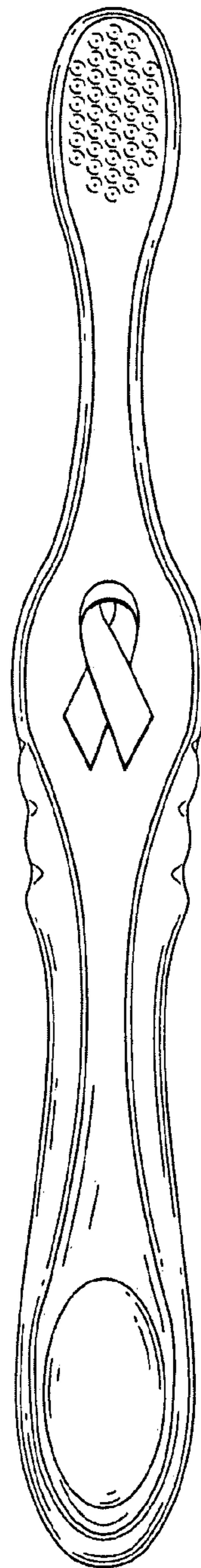

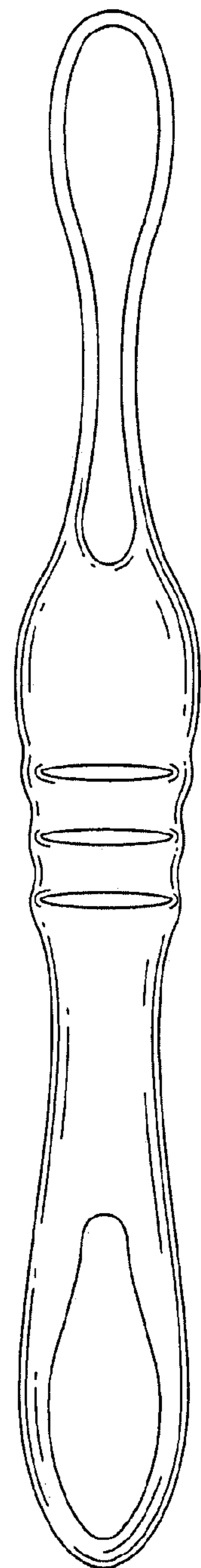
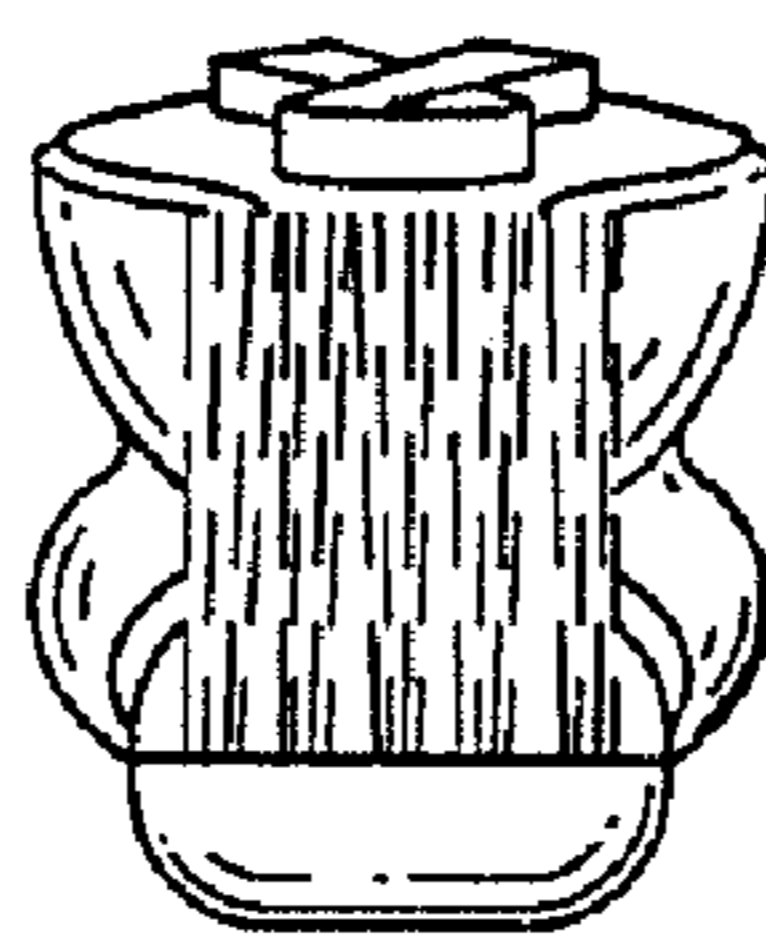
