**DESCRIPTION**

FIG. 6 is a front perspective view of the chair of FIG. 1 shown without cushion for ease of illustration.

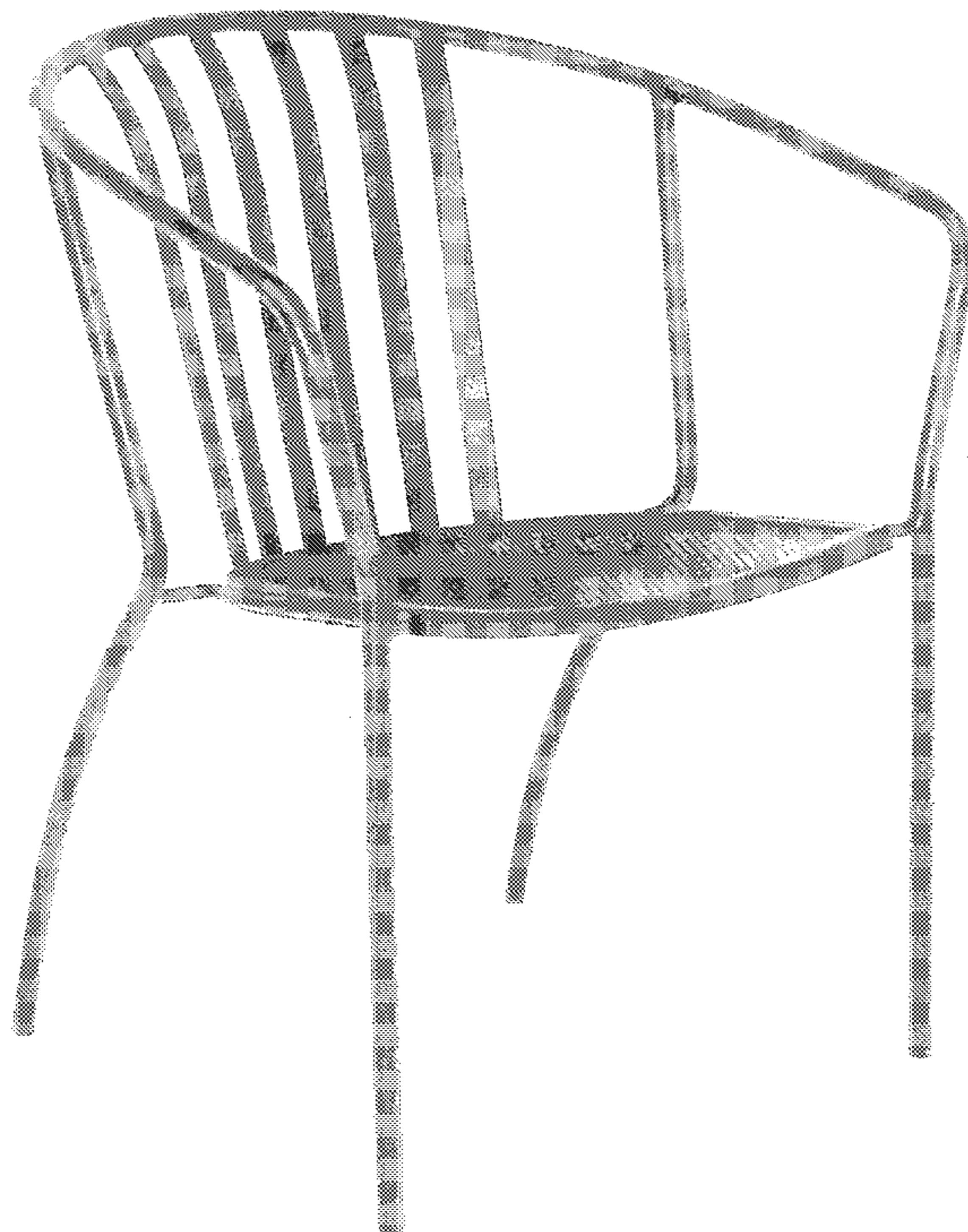
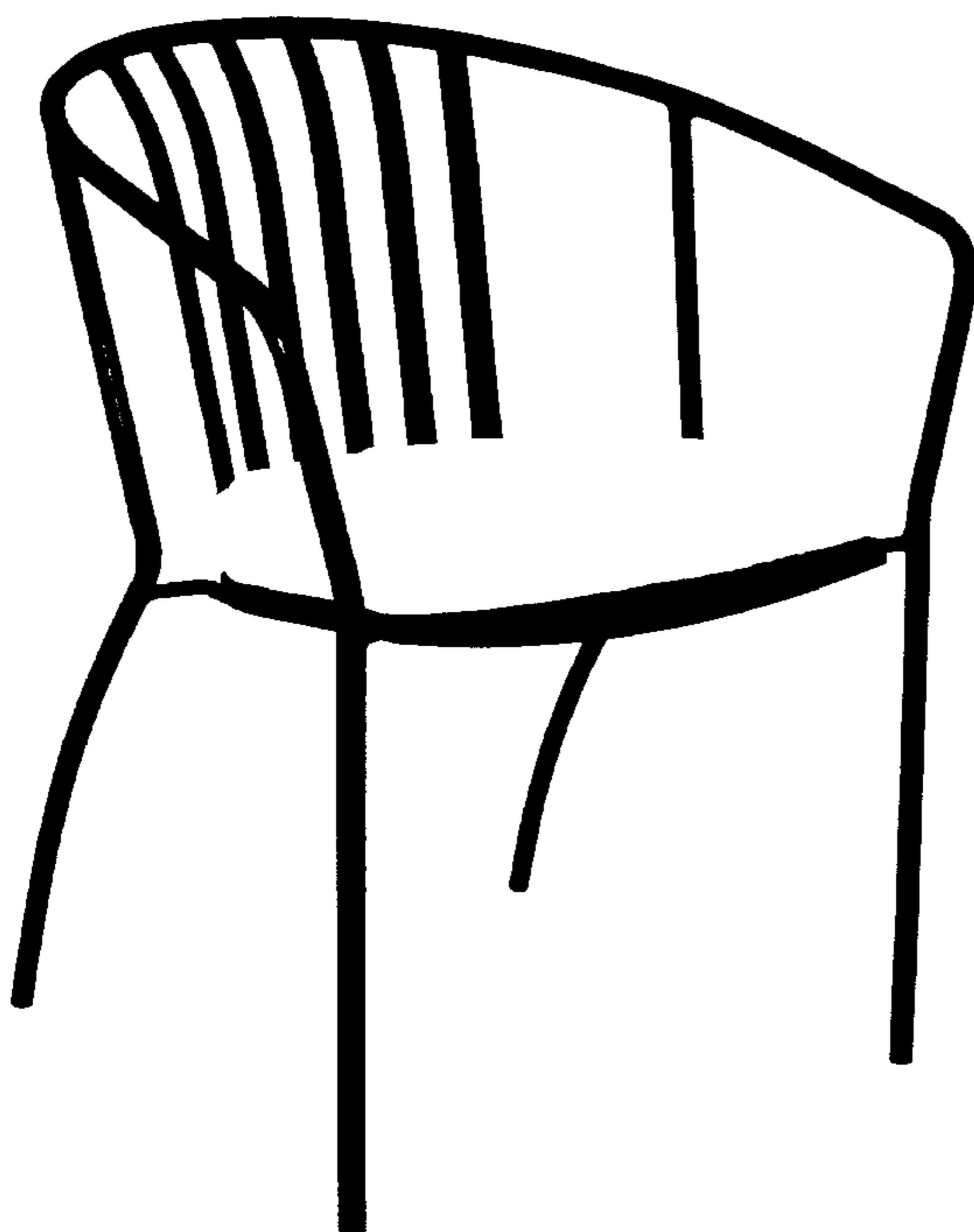
FIG. 7 is a side elevational view of the chair of FIG. 6.

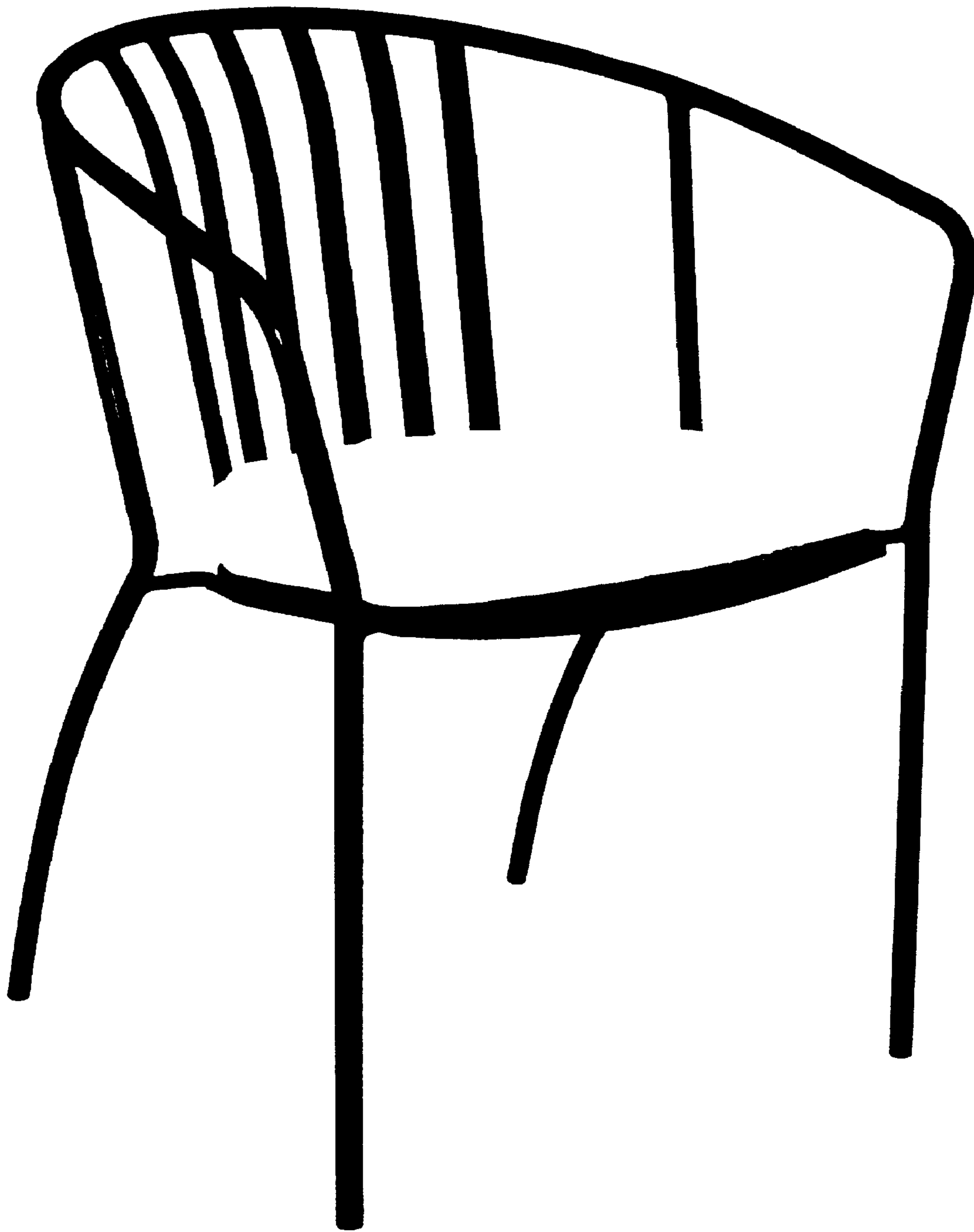

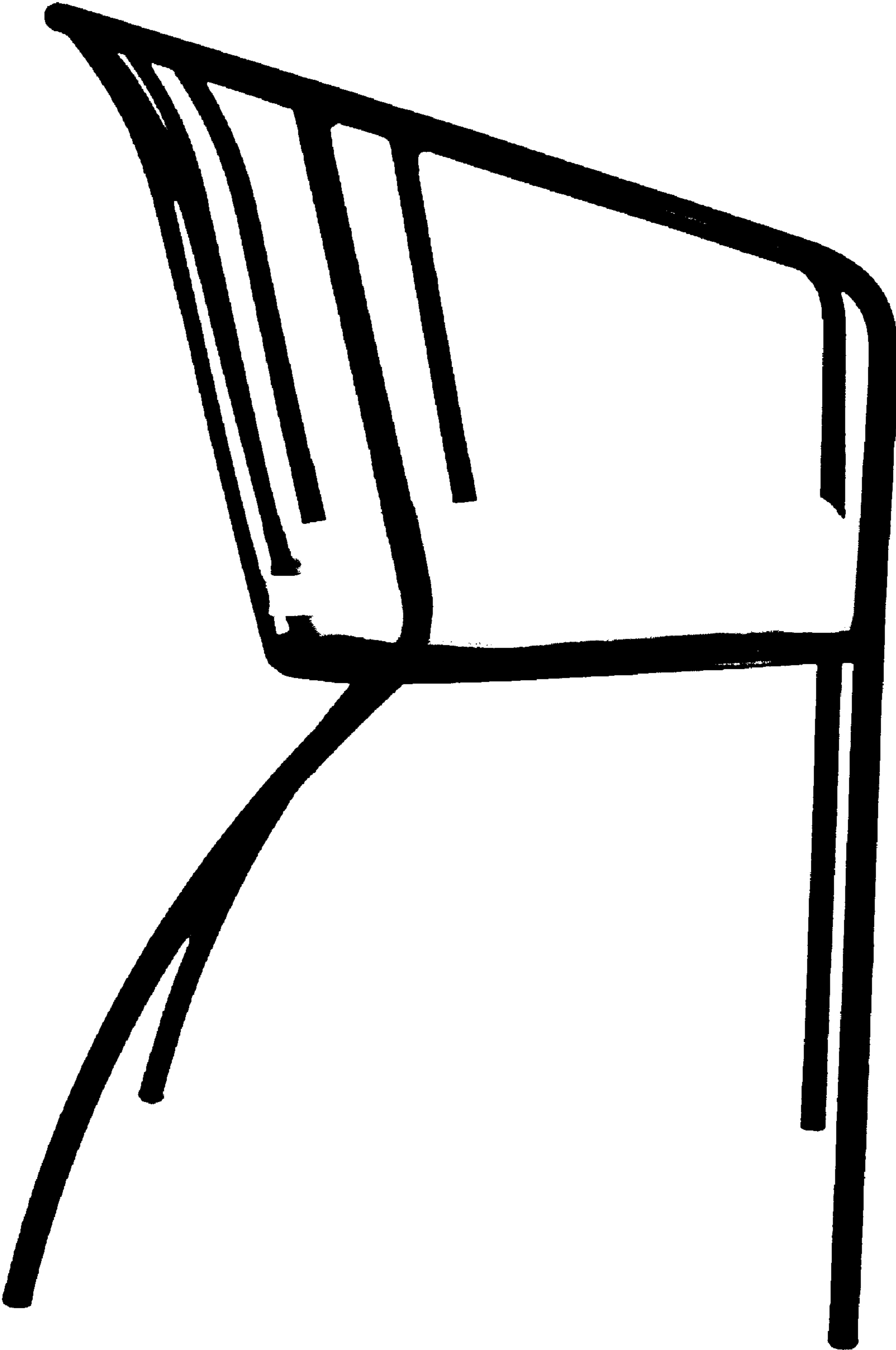

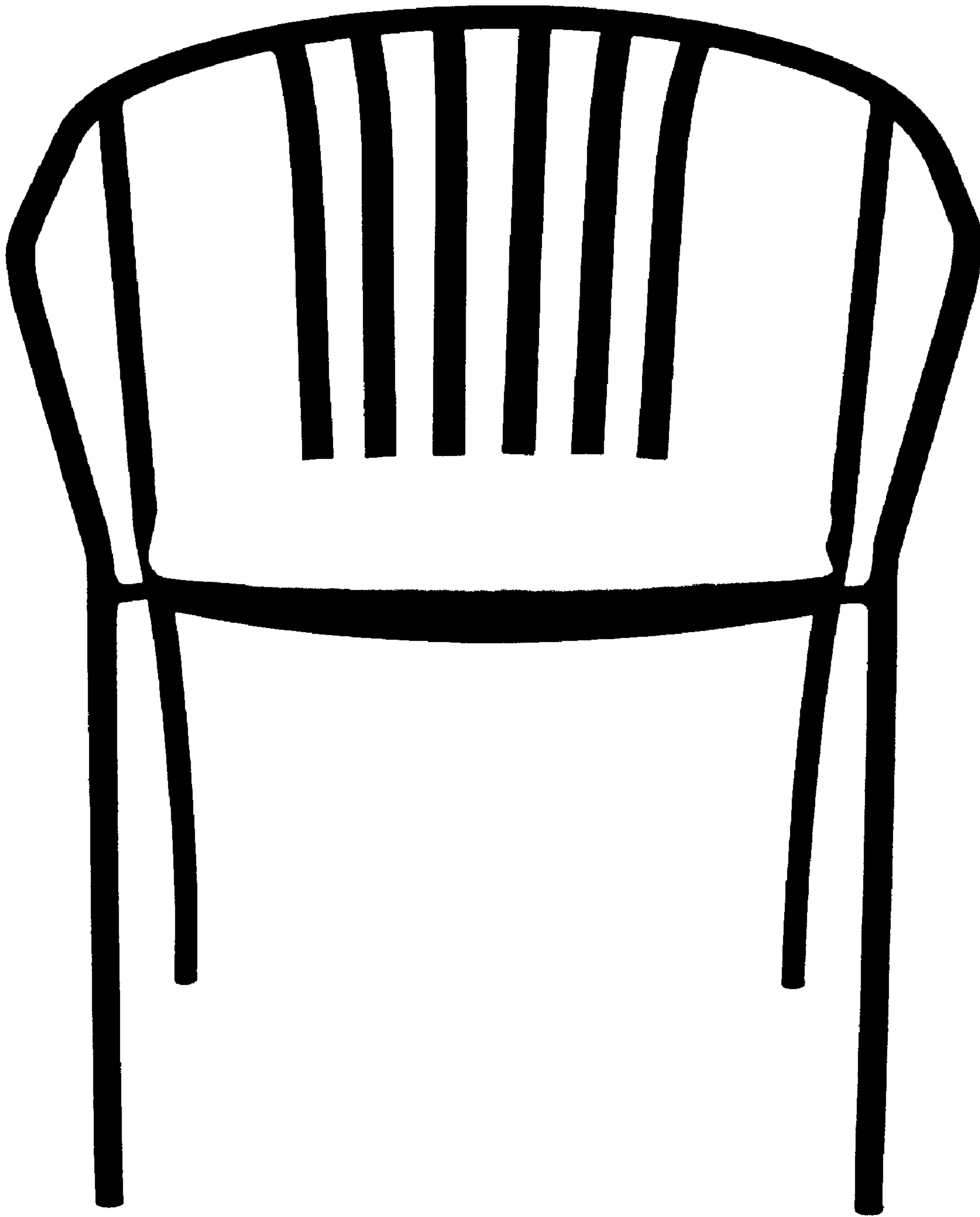

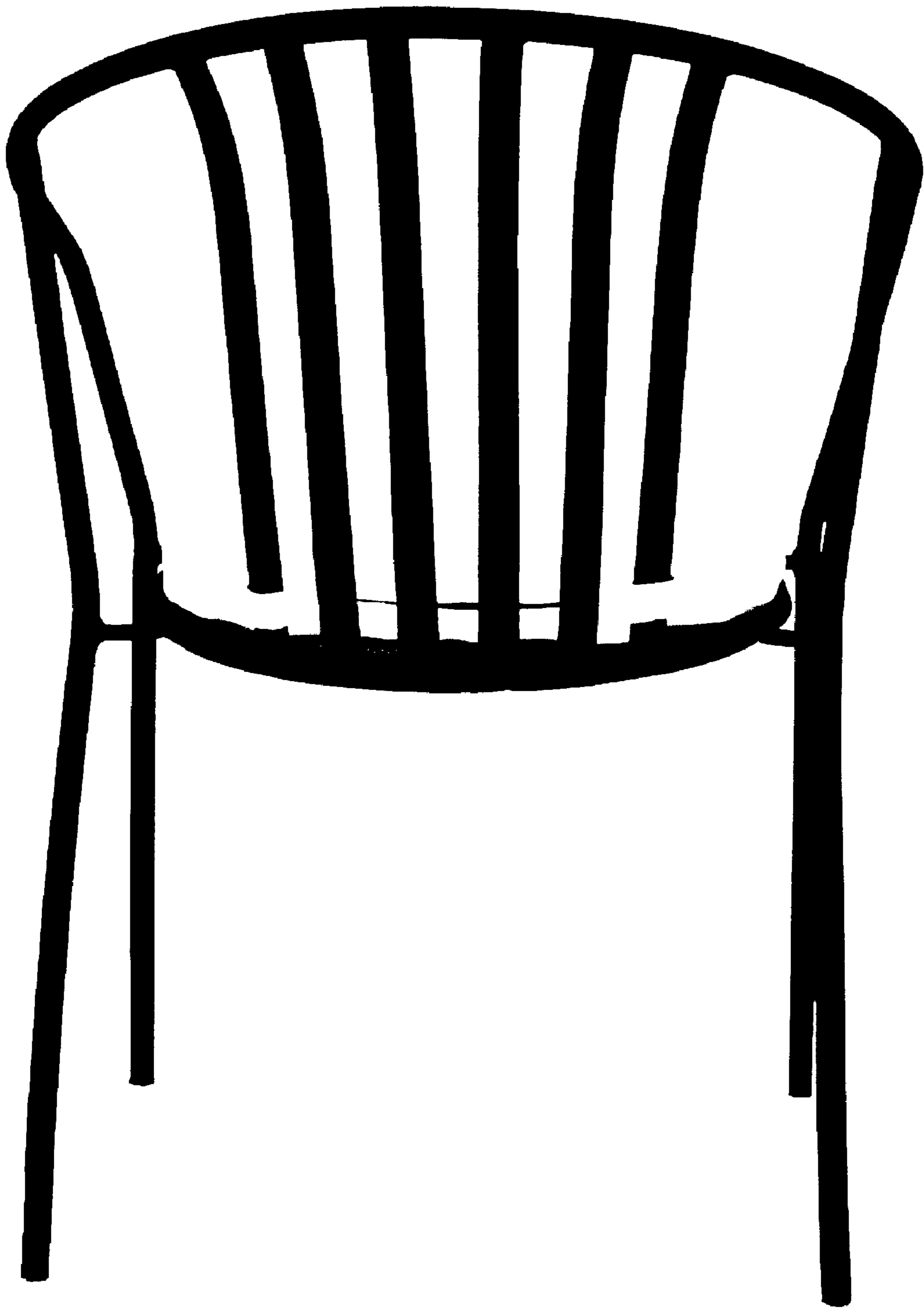

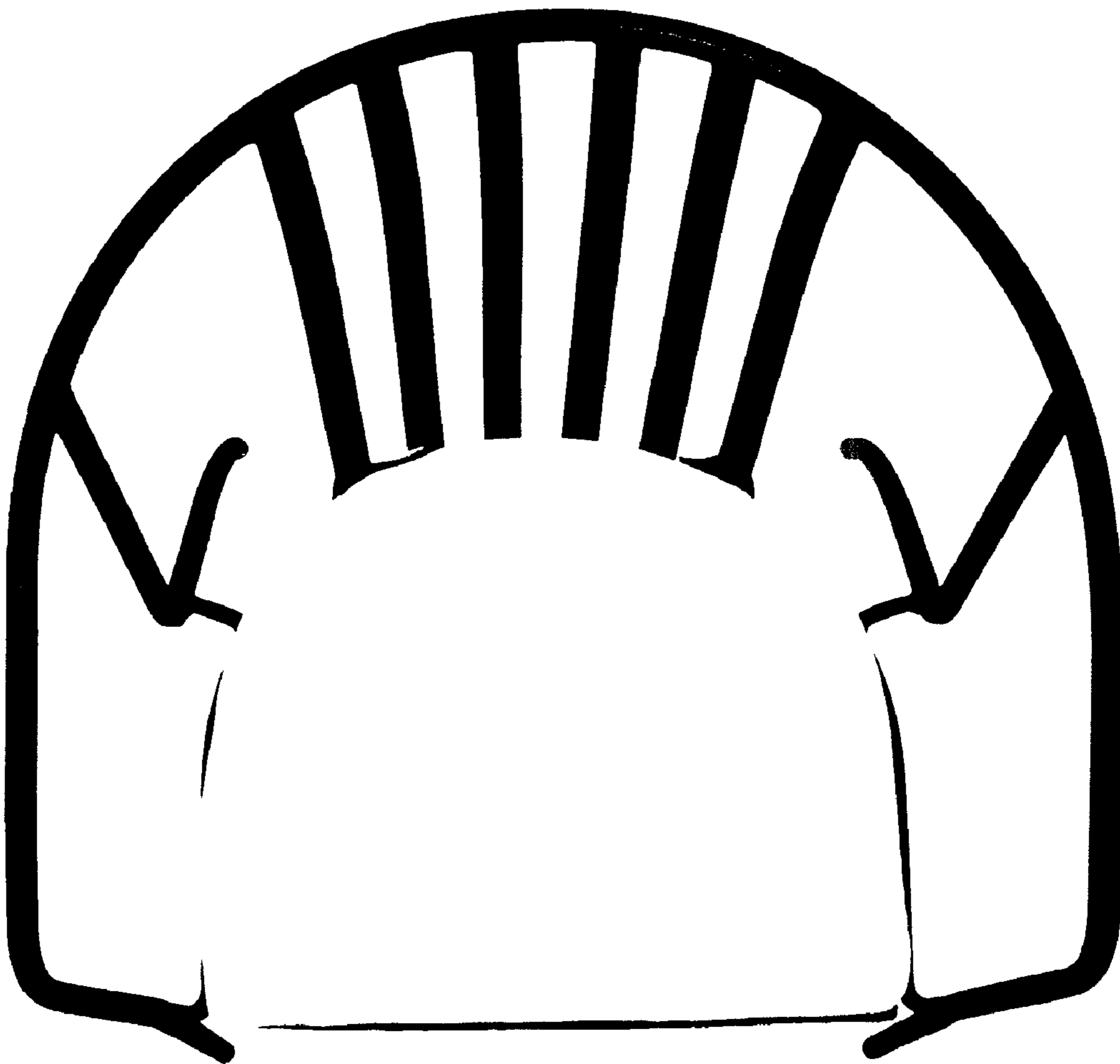

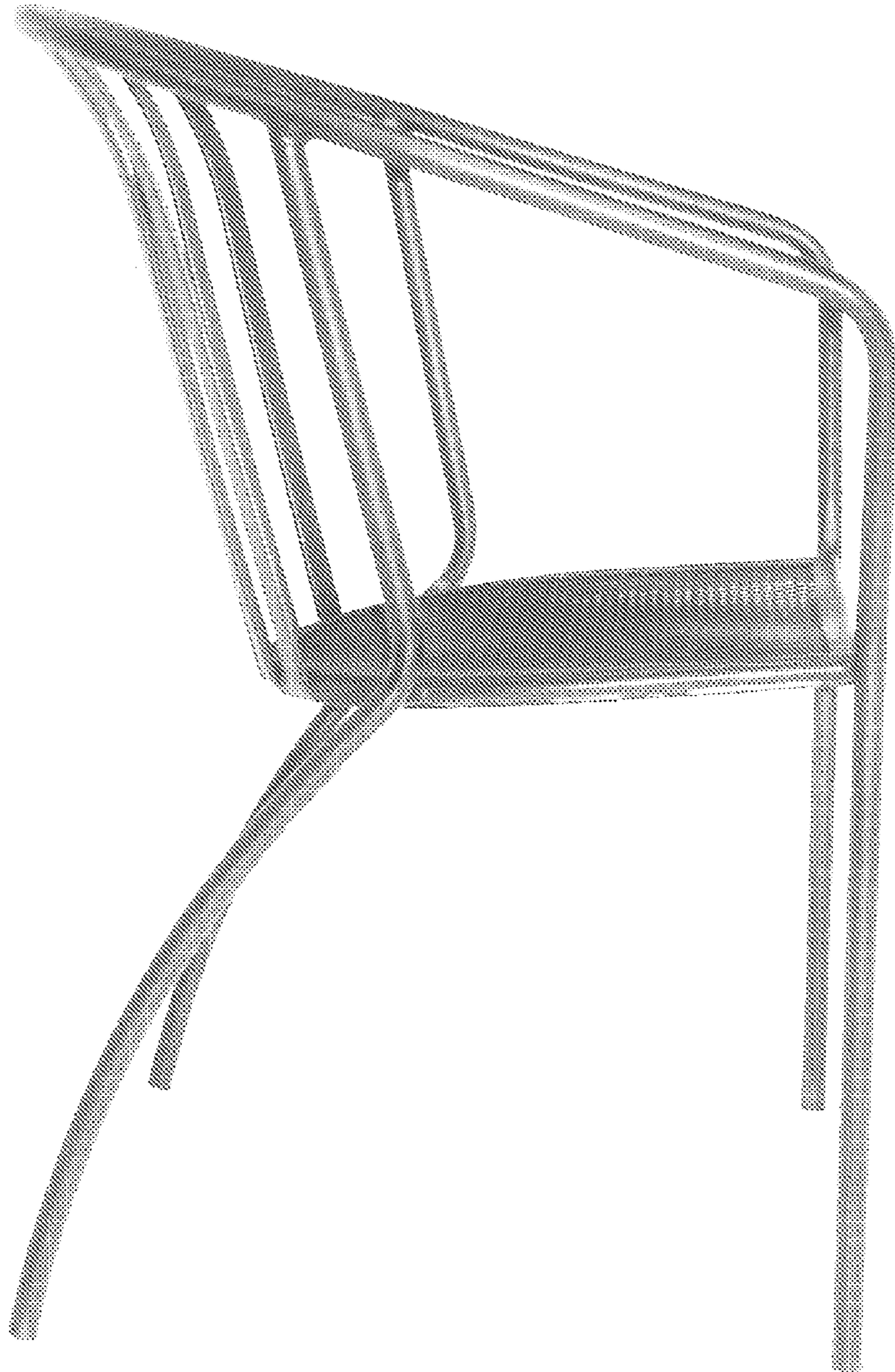

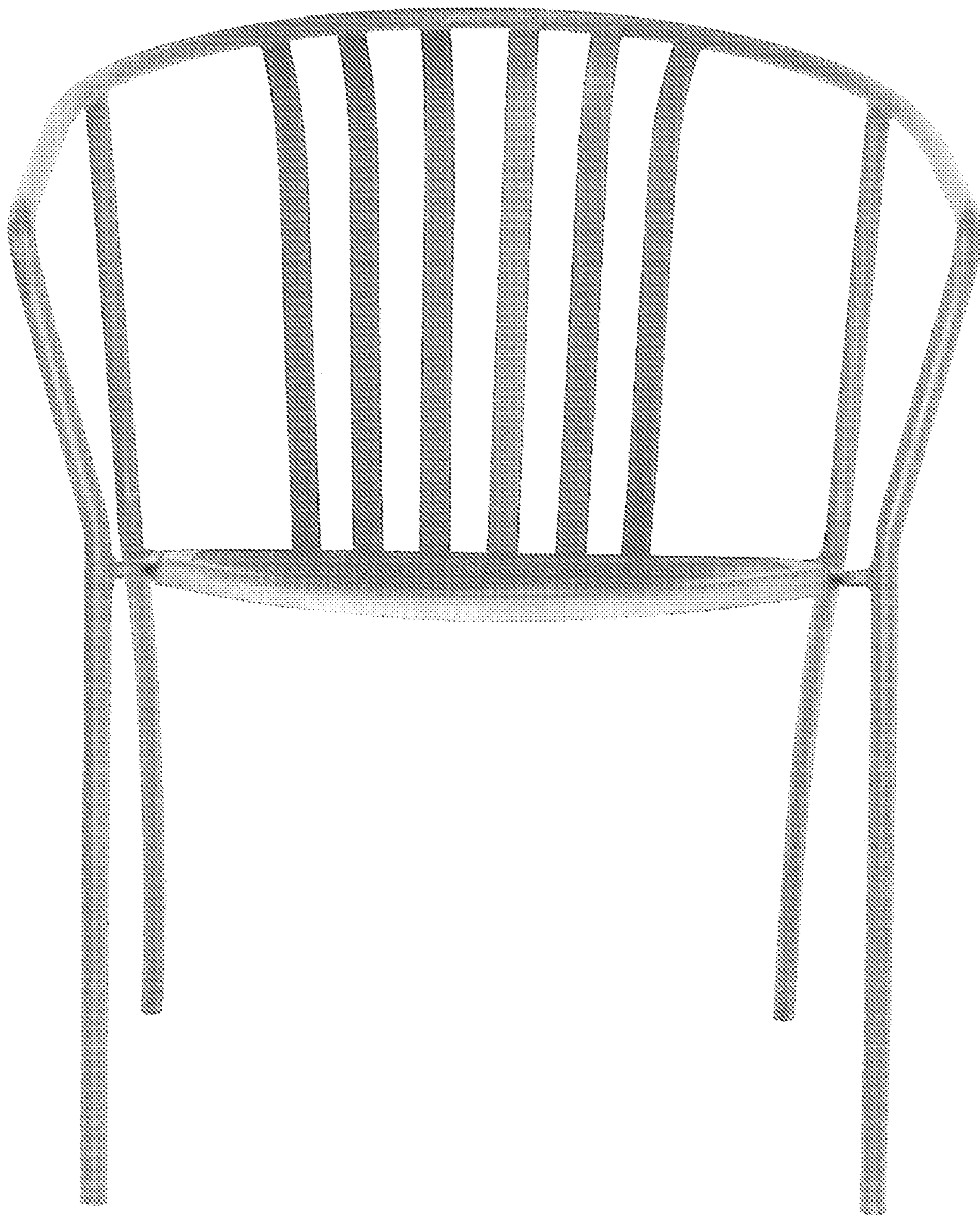

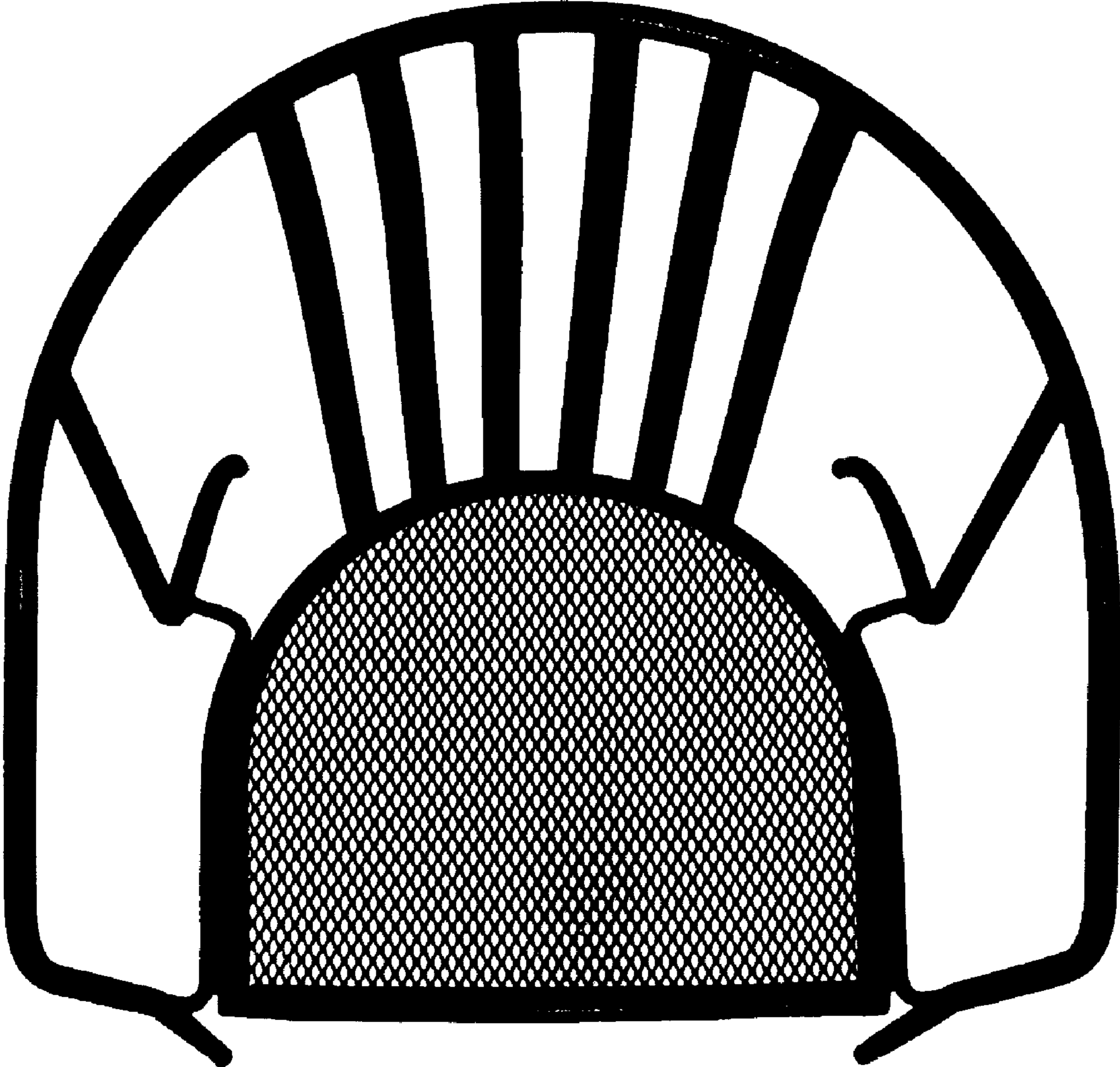
