DESCRIPTION

FIG. 1 is a front perspective view of a chair in accordance with the present invention.

FIG. 2 is a side elevational view of the chair of FIG. 1.

FIG. 3 is a front elevational view of the chair of FIG. 1.

FIG. 4 is a rear elevational view of the chair of FIG. 1.

FIG. 5 is a top plan view of the chair of FIG. 1.

FIG. 6 is a front perspective view of the chair of FIG. 1 shown without cushion for ease of illustration.

FIG. 7 is a side elevational view of the chair of FIG. 6.

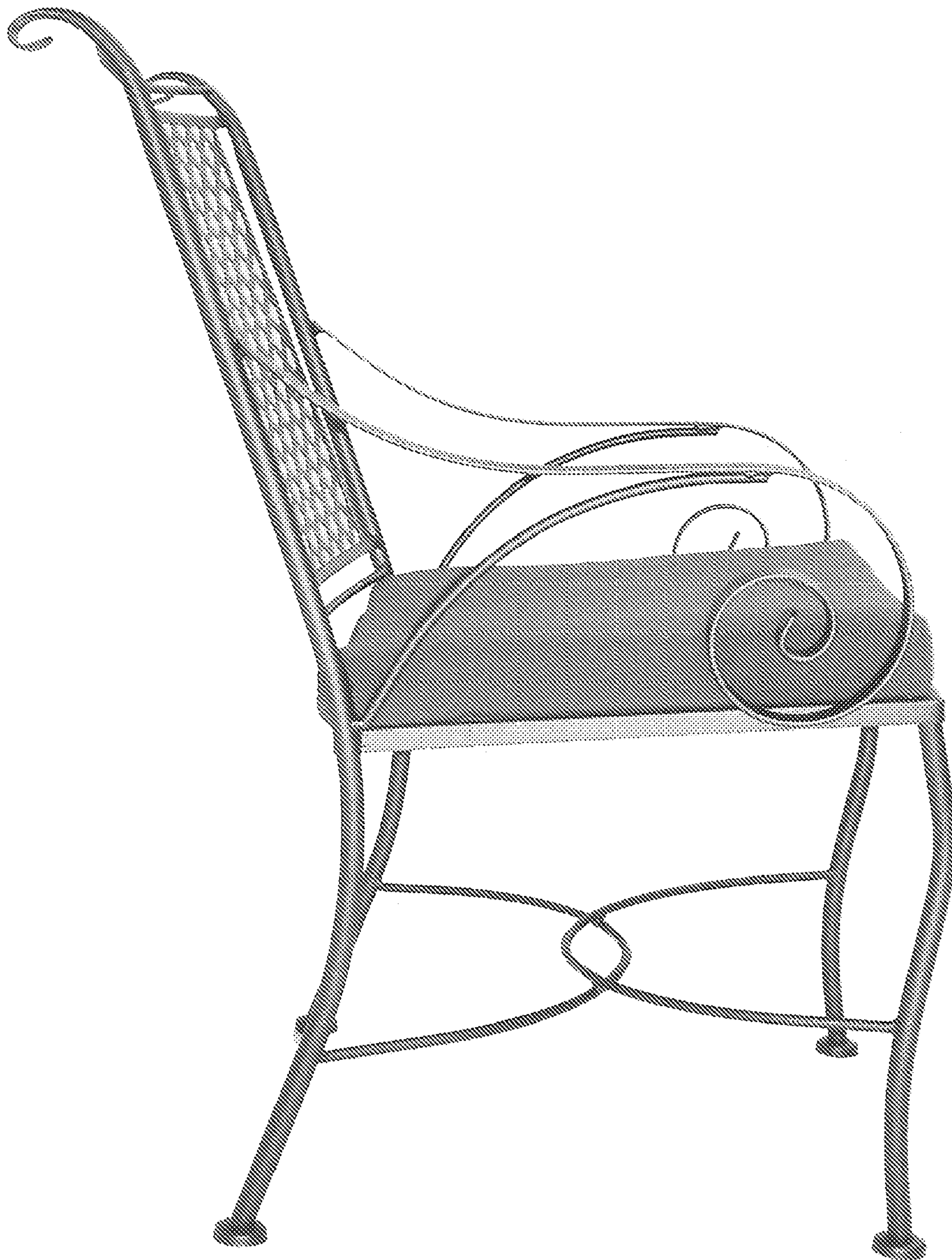

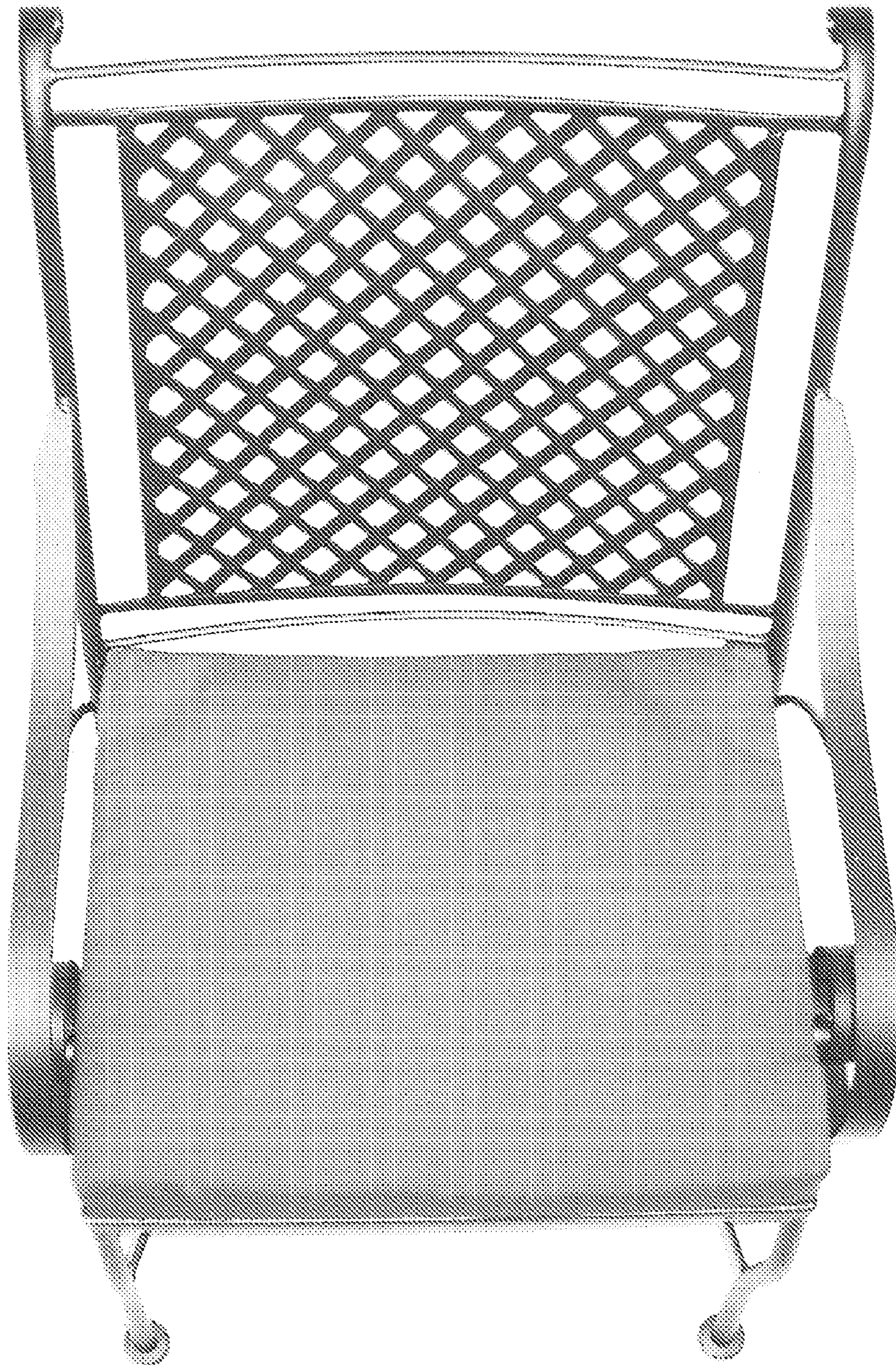

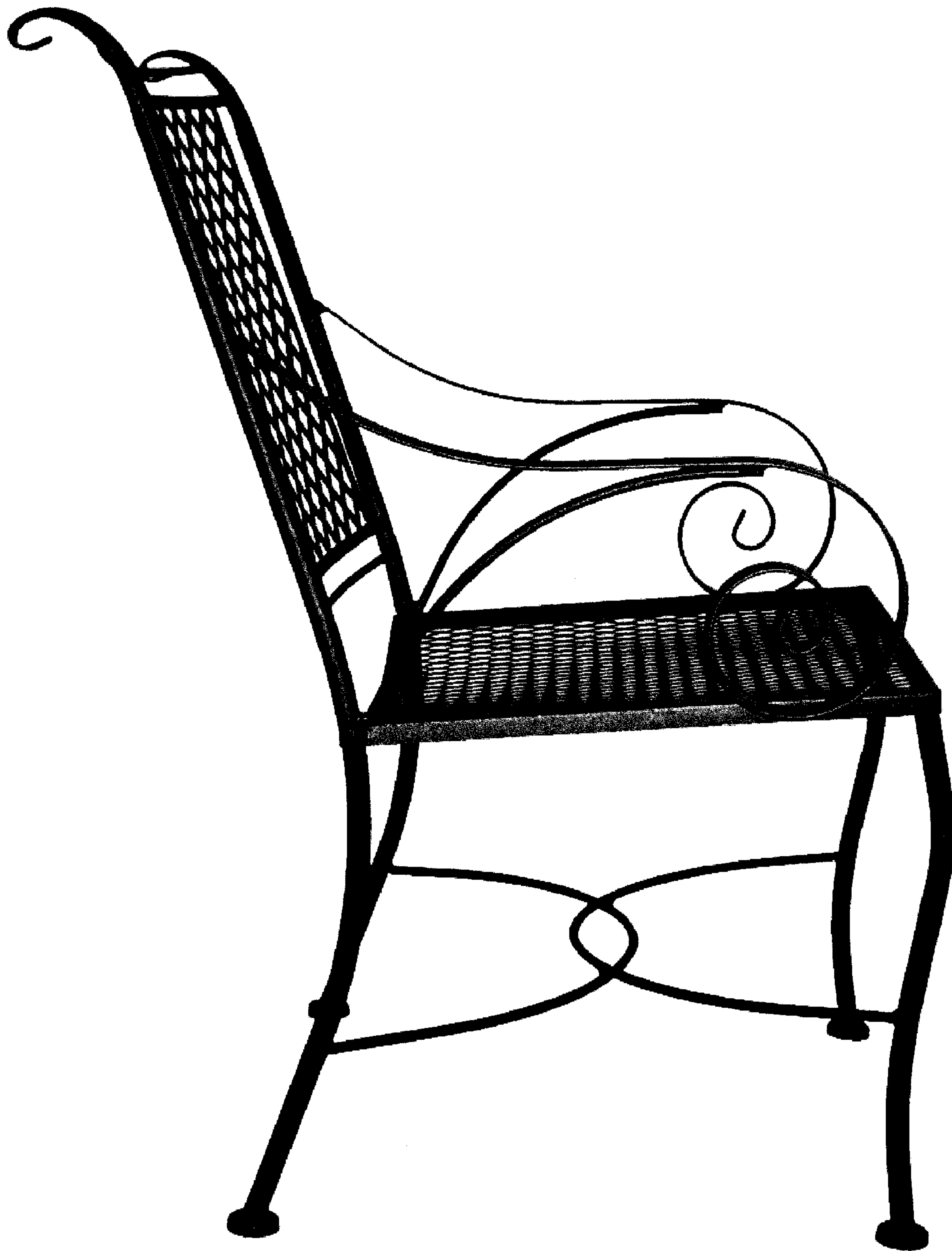

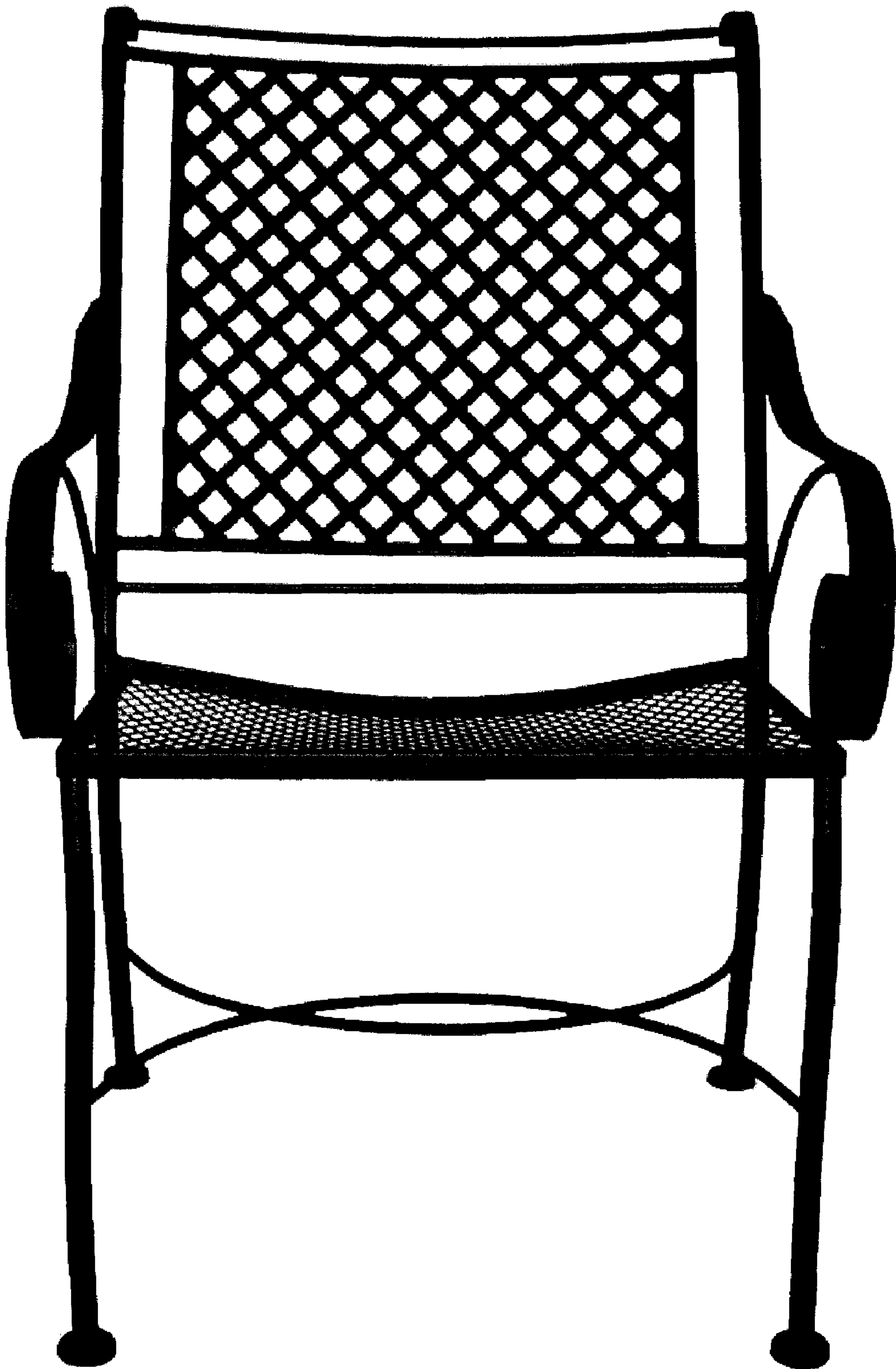

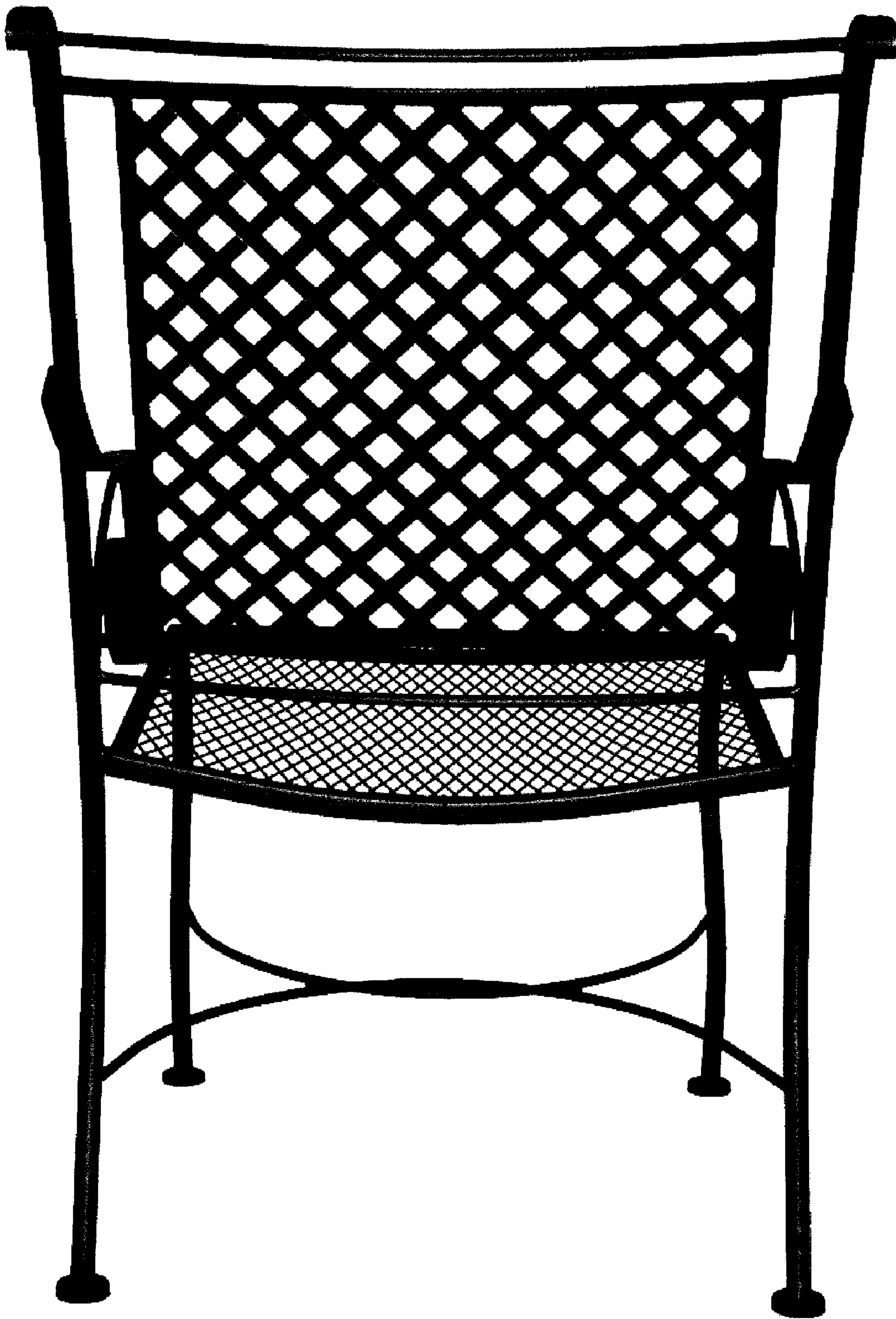
