(57) **CLAIM**

The ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above, in front, and to the left of the table according to the invention in closed condition;

FIGS. 2, 3, and 4 are elevational views of the closed table, taken respectively from the front, the right side, and the left side as shown in FIG. 1;

FIG. 5 is a bottom view of the closed table;

FIG. 6 is another side elevational view of the closed table taken from the rear;

FIG. 7 is a perspective view from above, in front, and to the left of the table according to the invention in open position;

FIG. 8 is a top view of the open table;

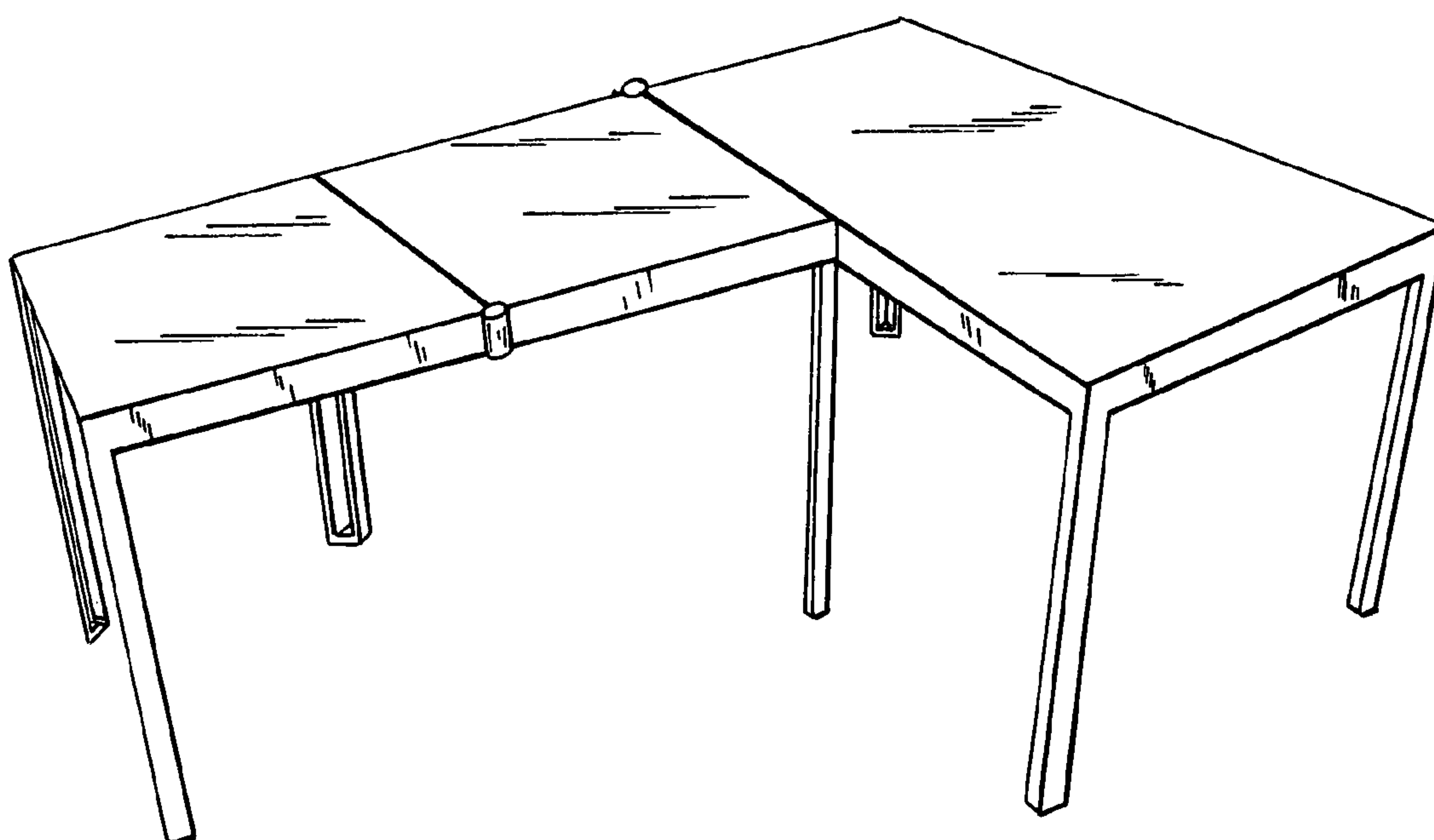
FIGS. 9, 10, and 11 are elevational views of the open table, taken respectively from the front, the right side, and the left side as shown in FIG. 7;

FIG. 12 is a bottom view of the open table;

FIG. 13 is another side elevational view of the open table taken from the rear; and,

FIGS. 14 is a large-scale perspective view of a hinge of the inventive table.

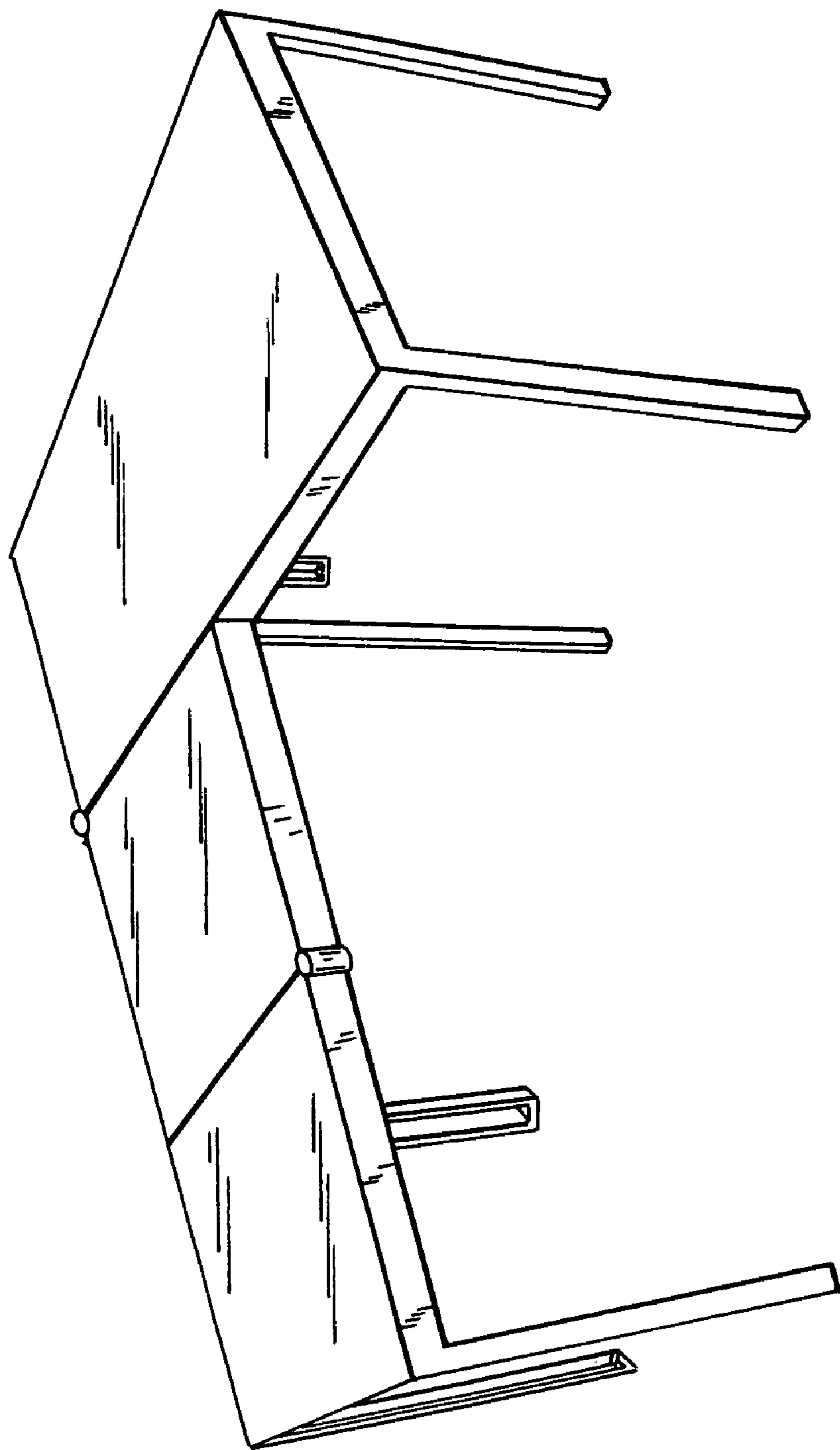

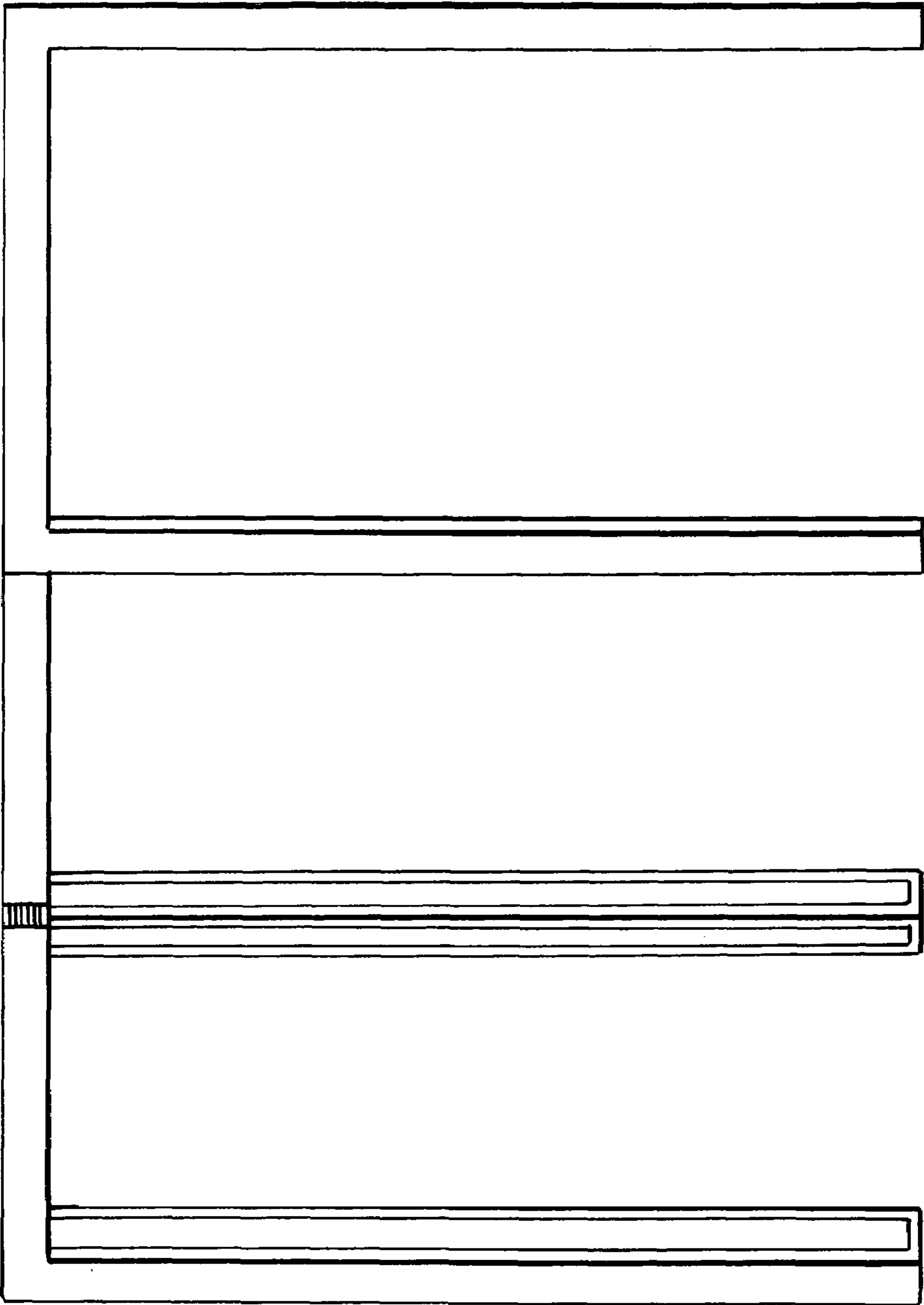

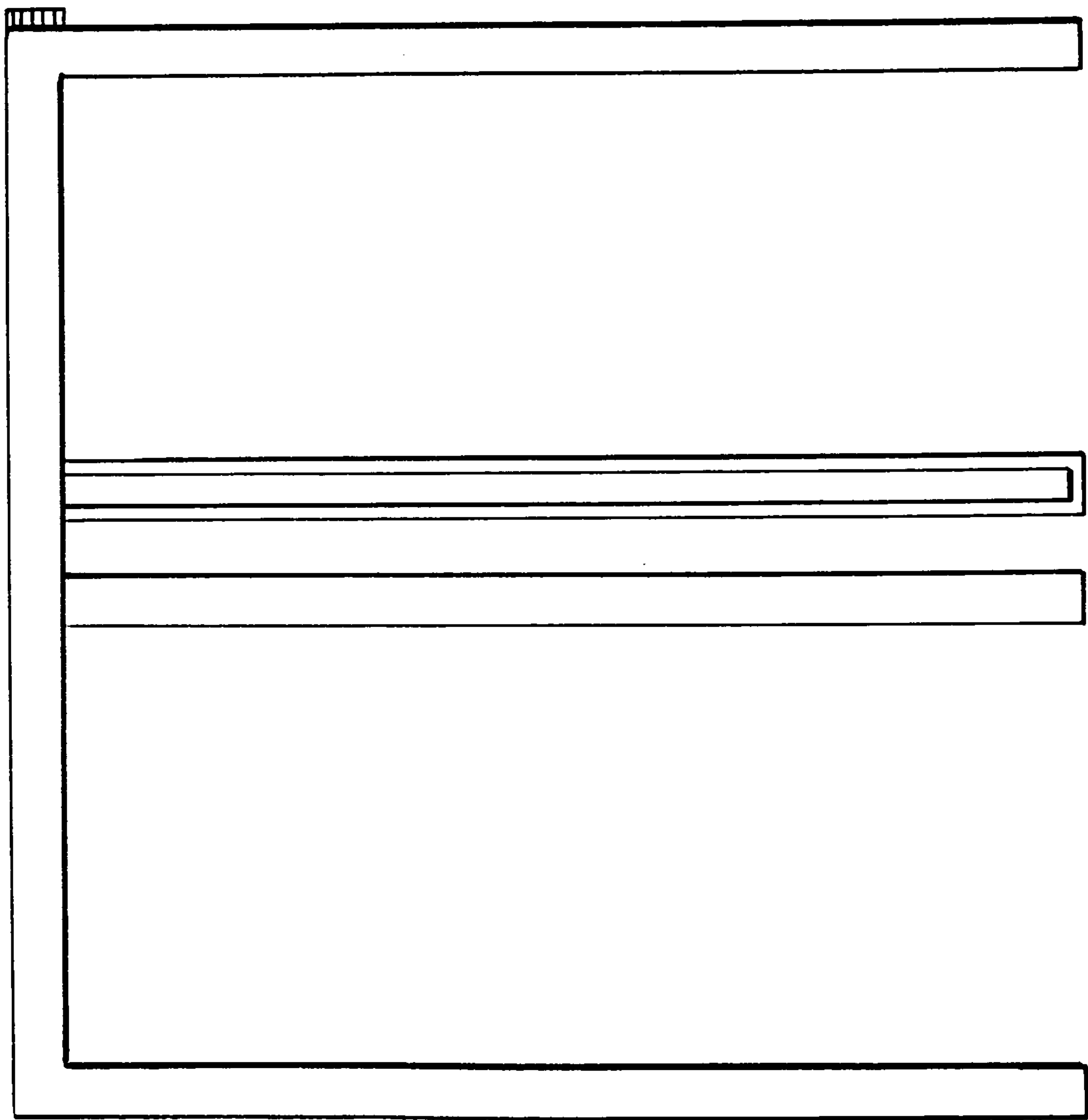
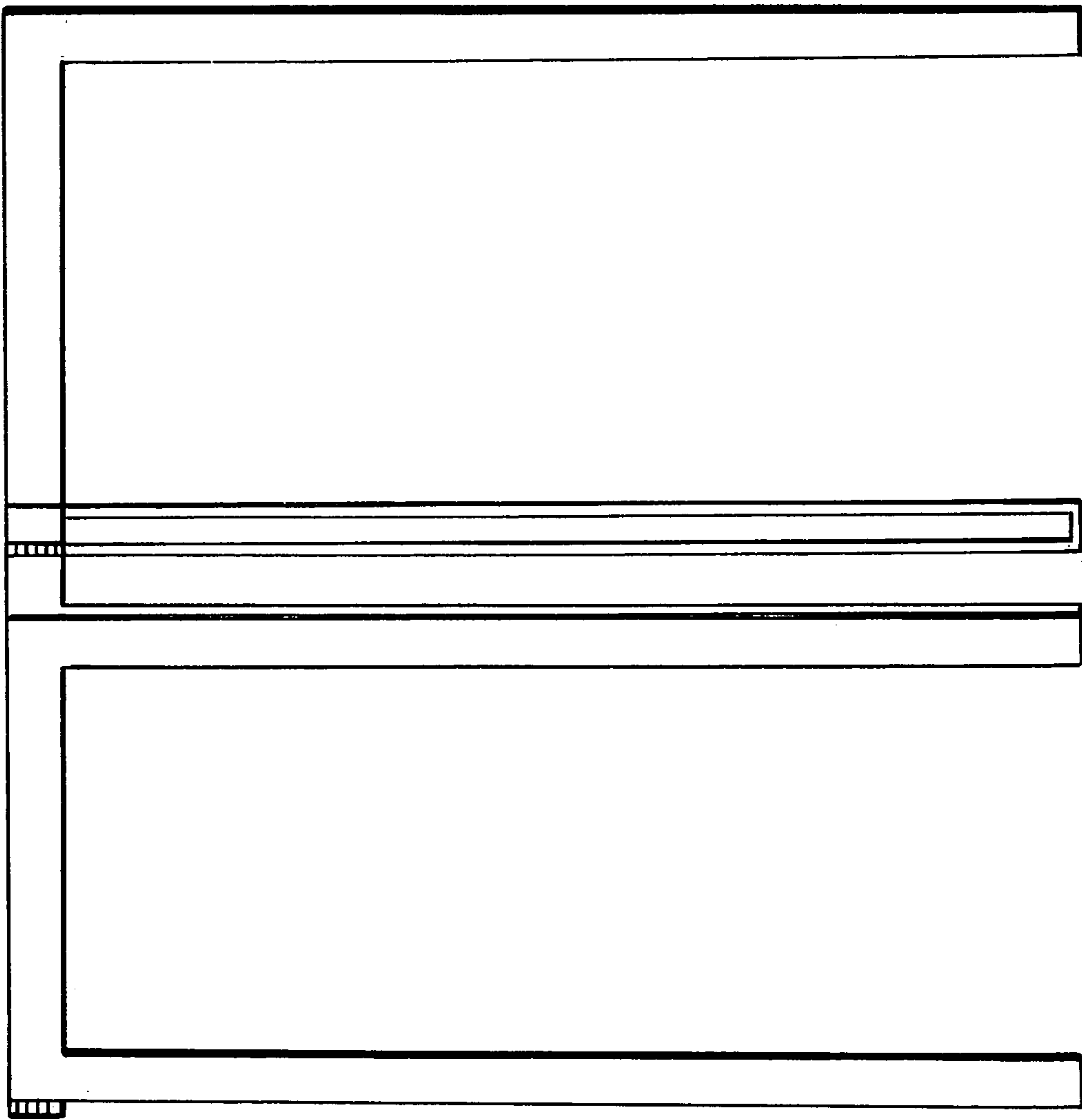

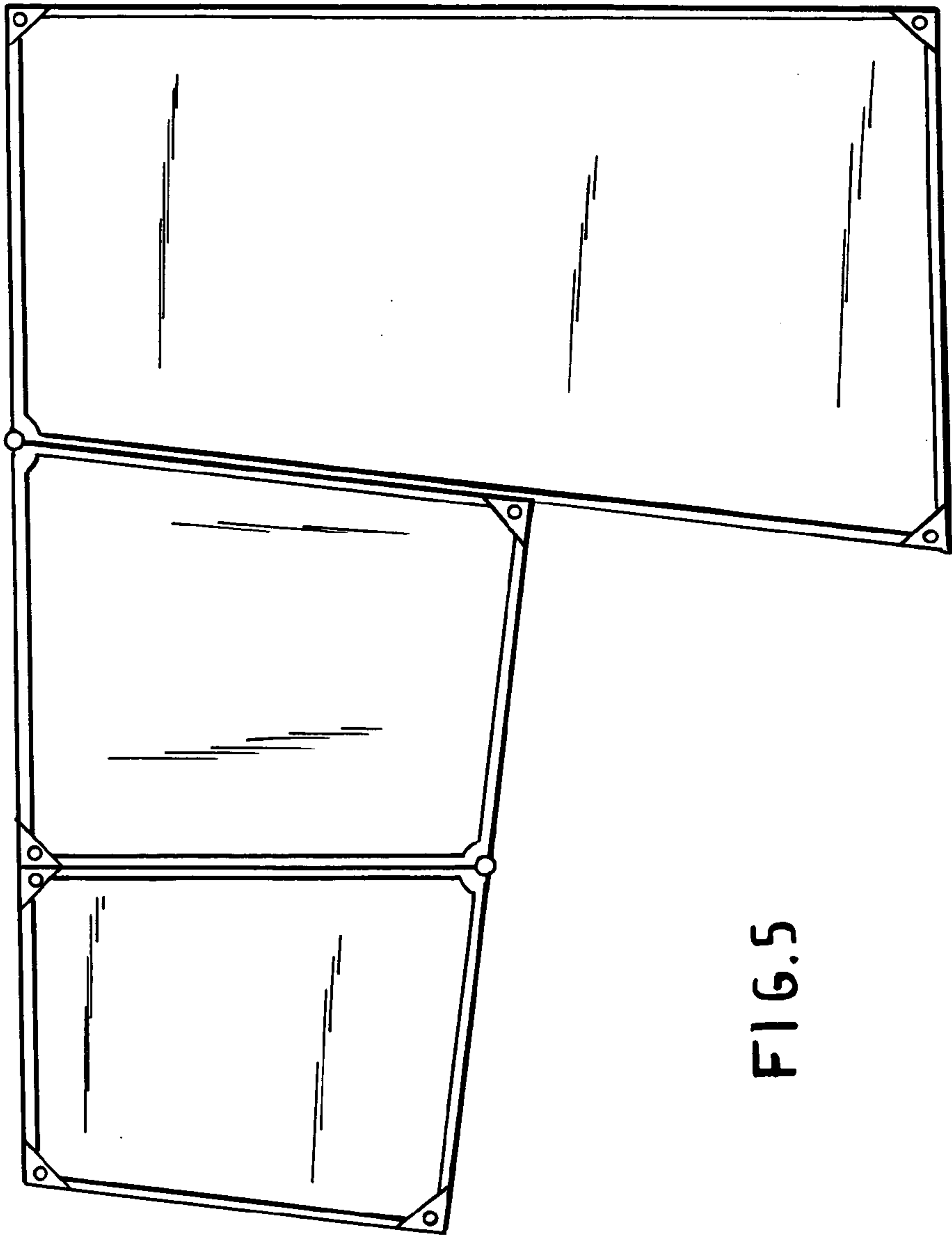
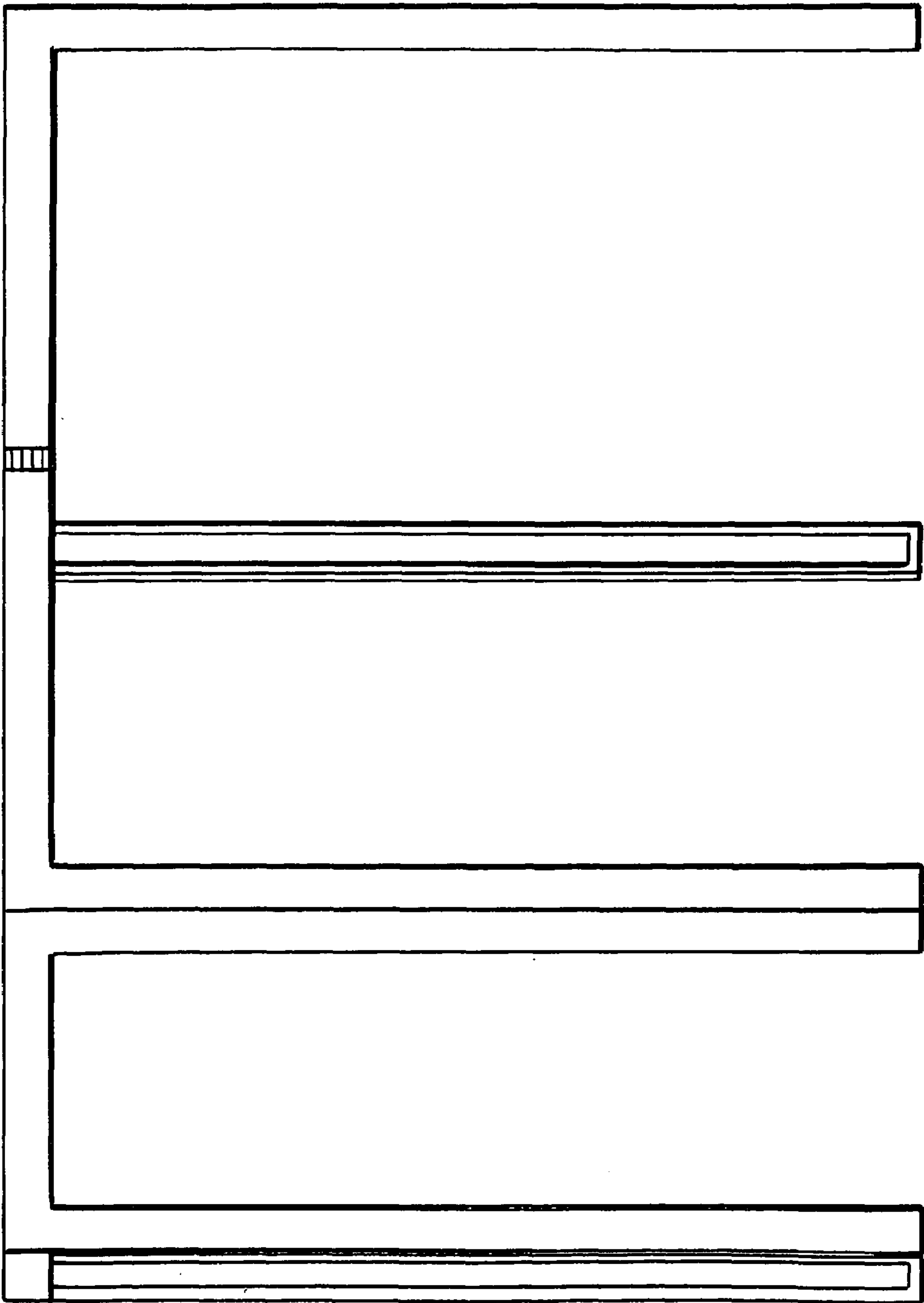

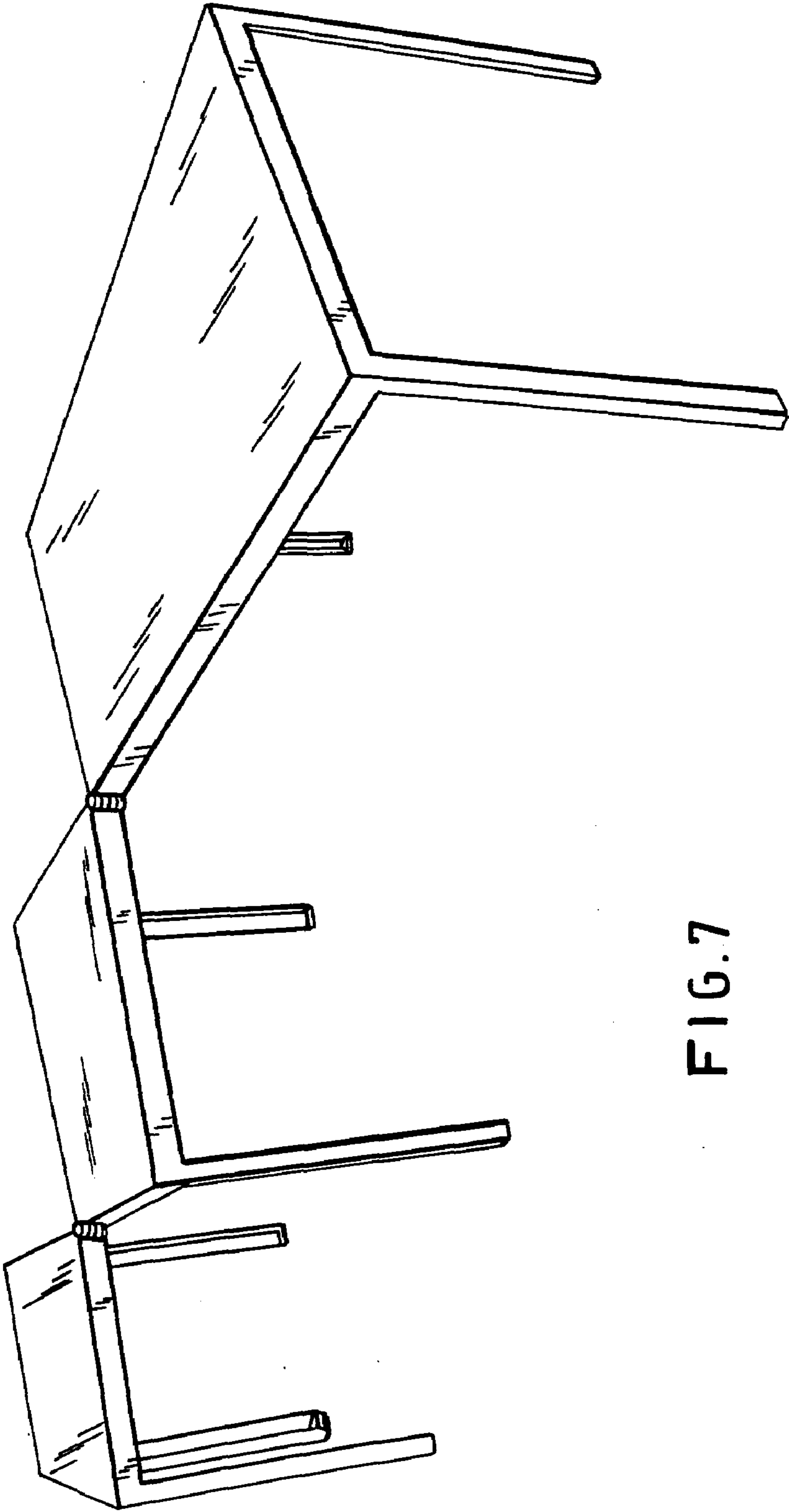

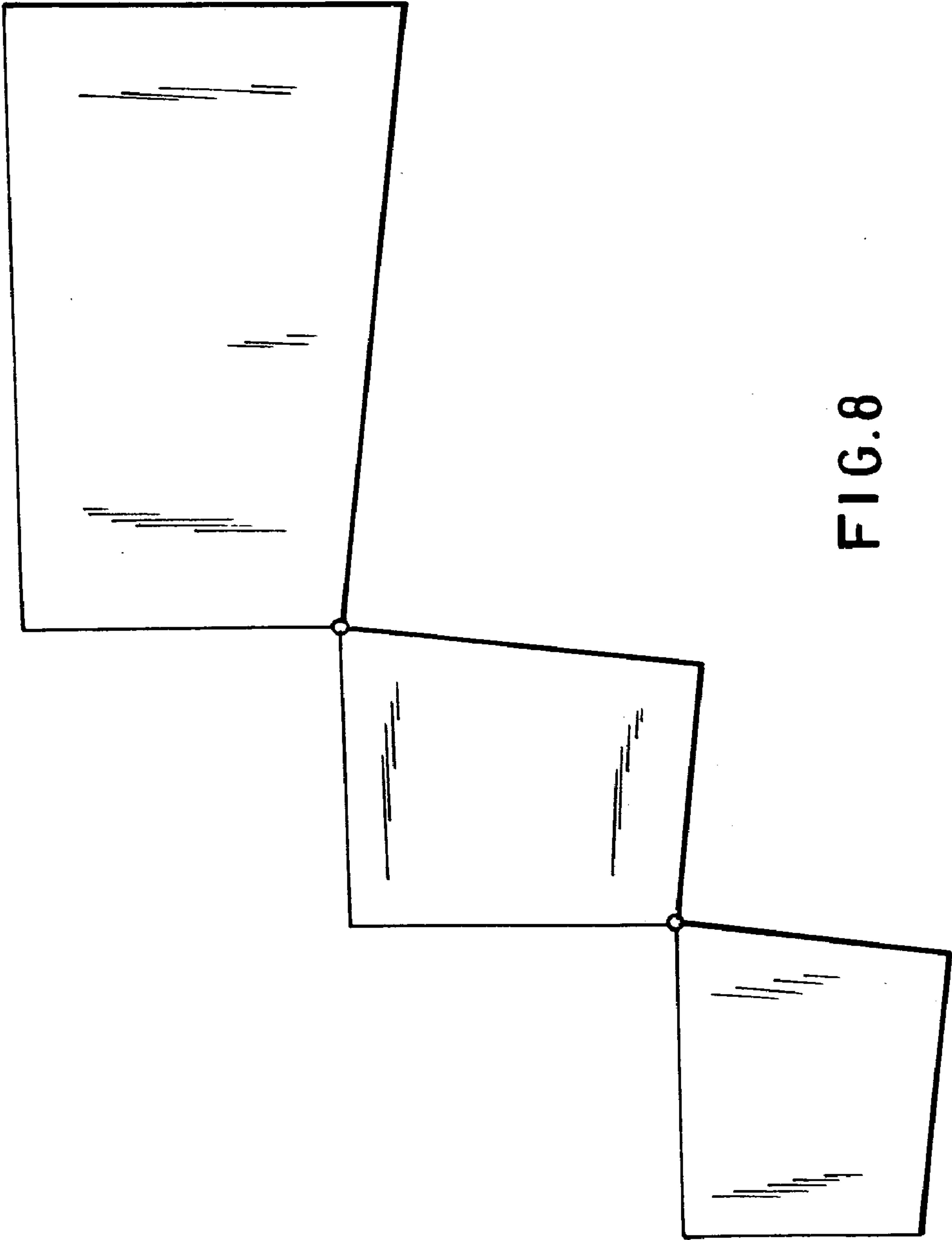

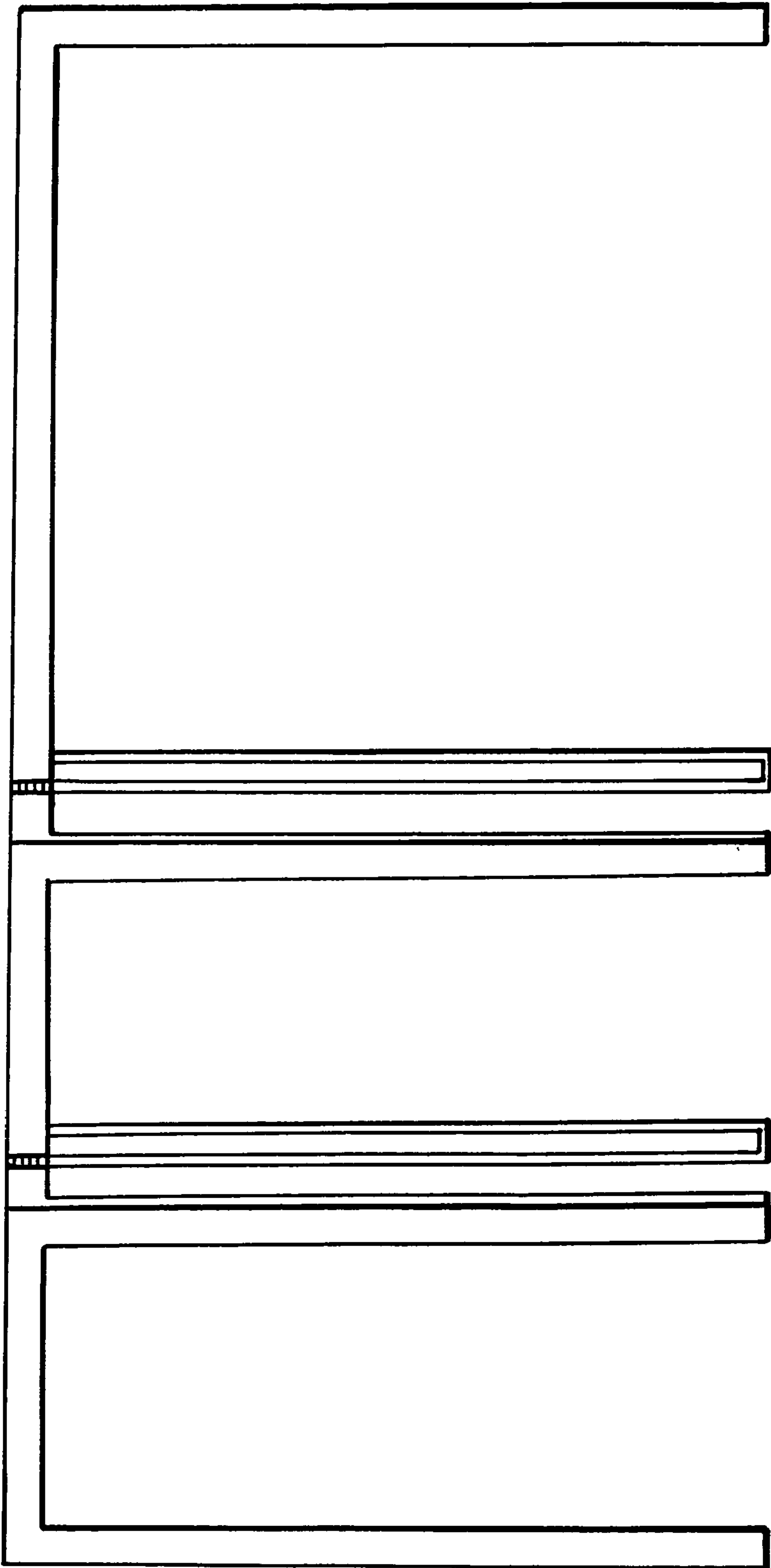

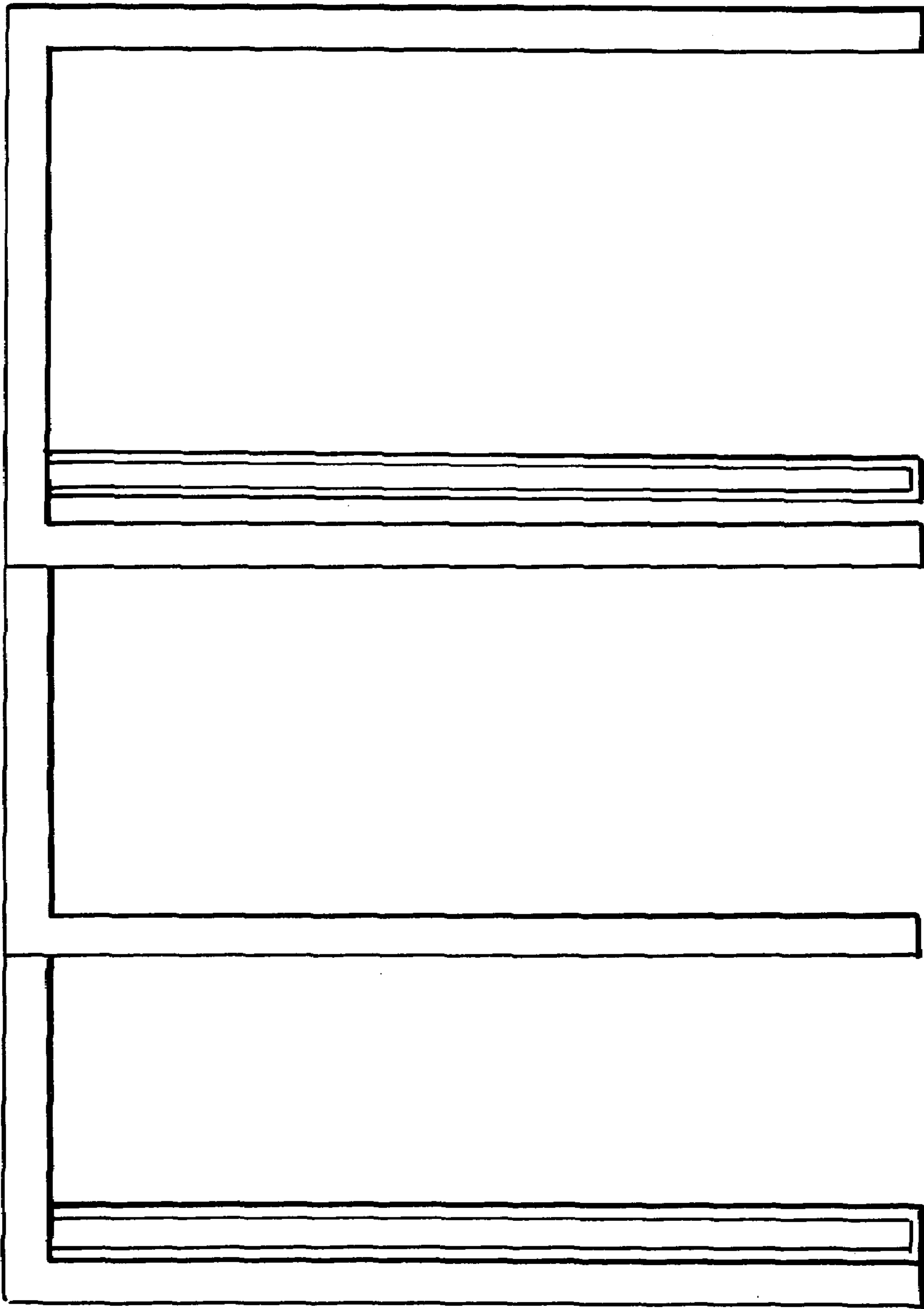
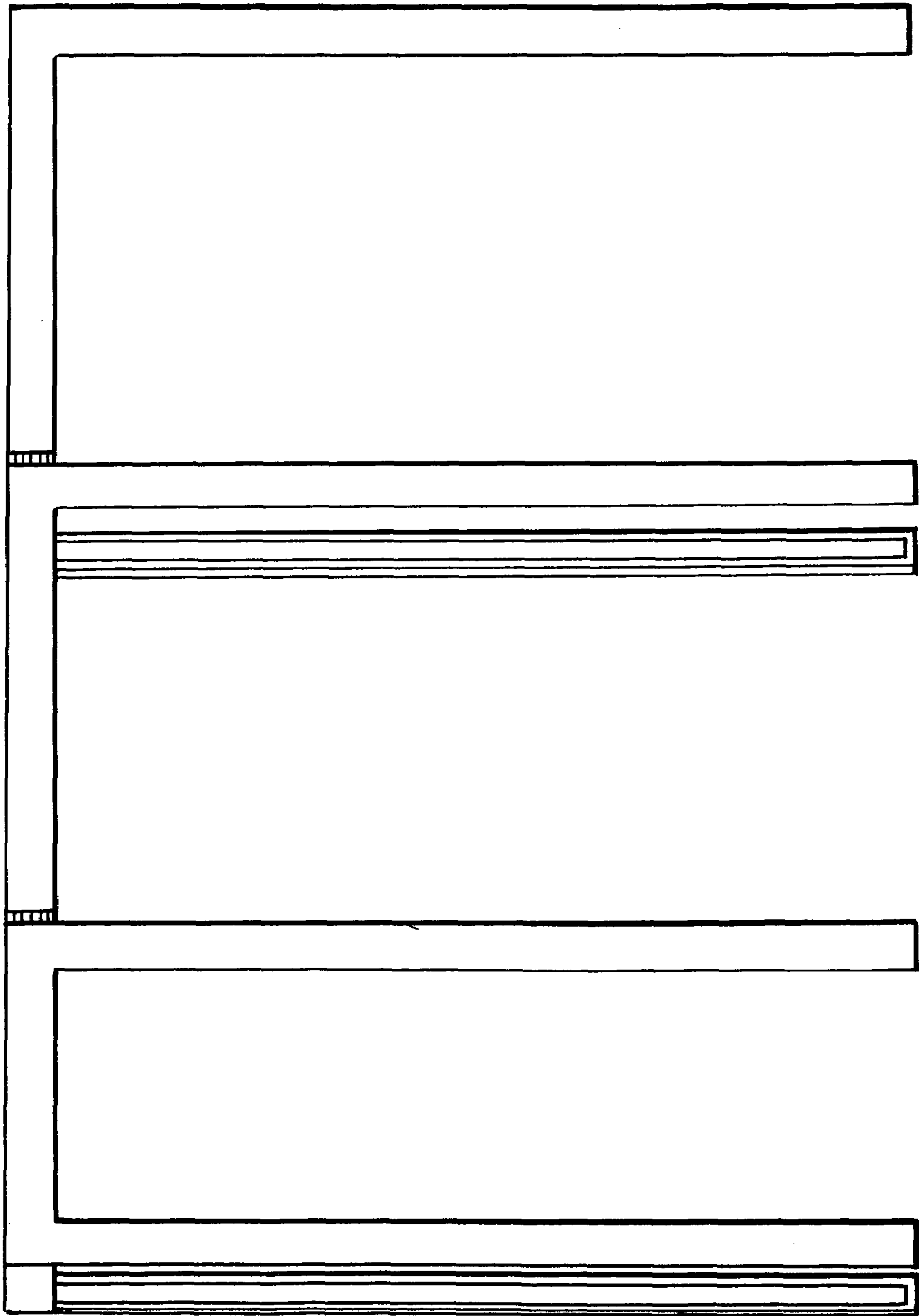

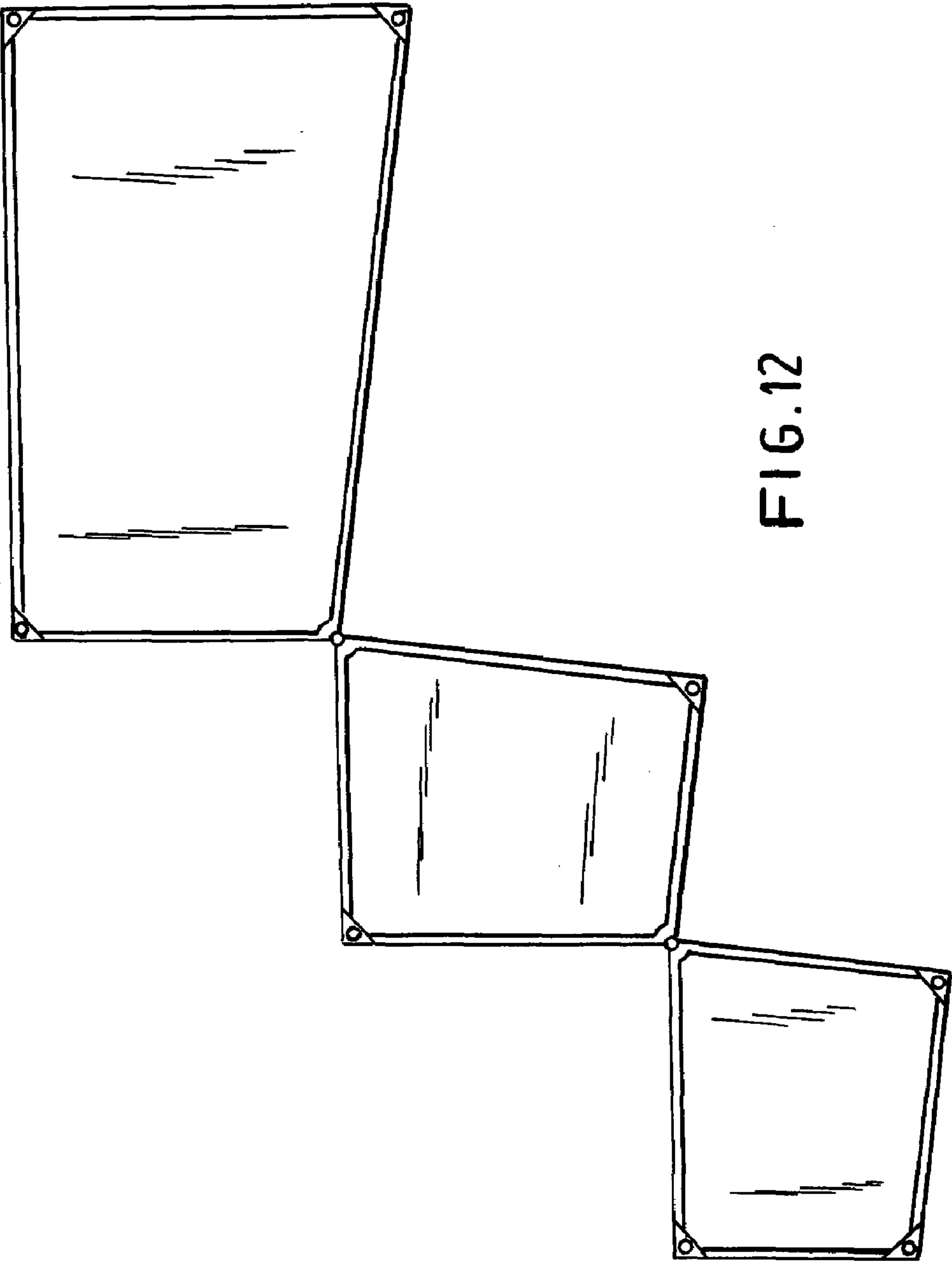

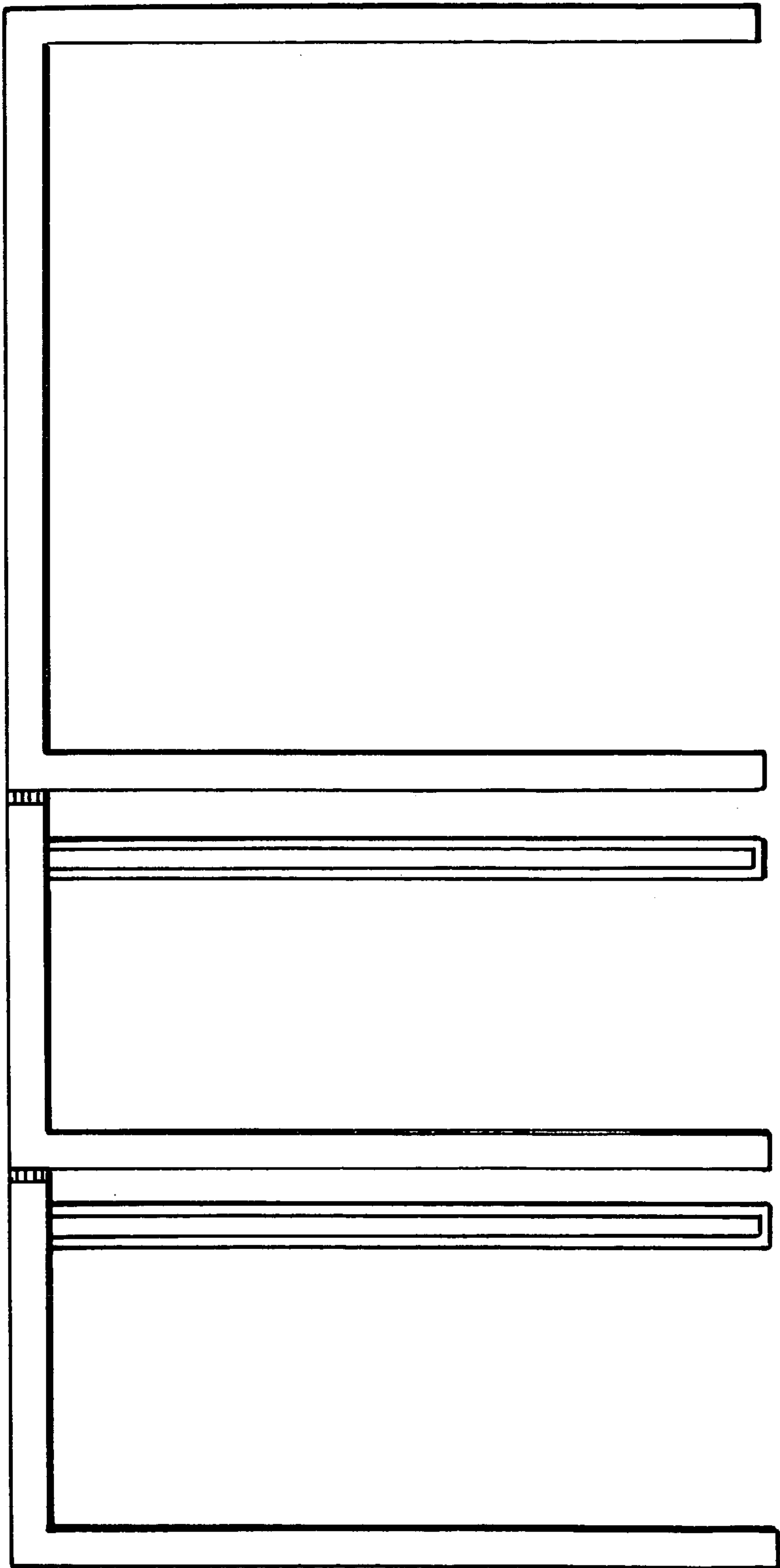

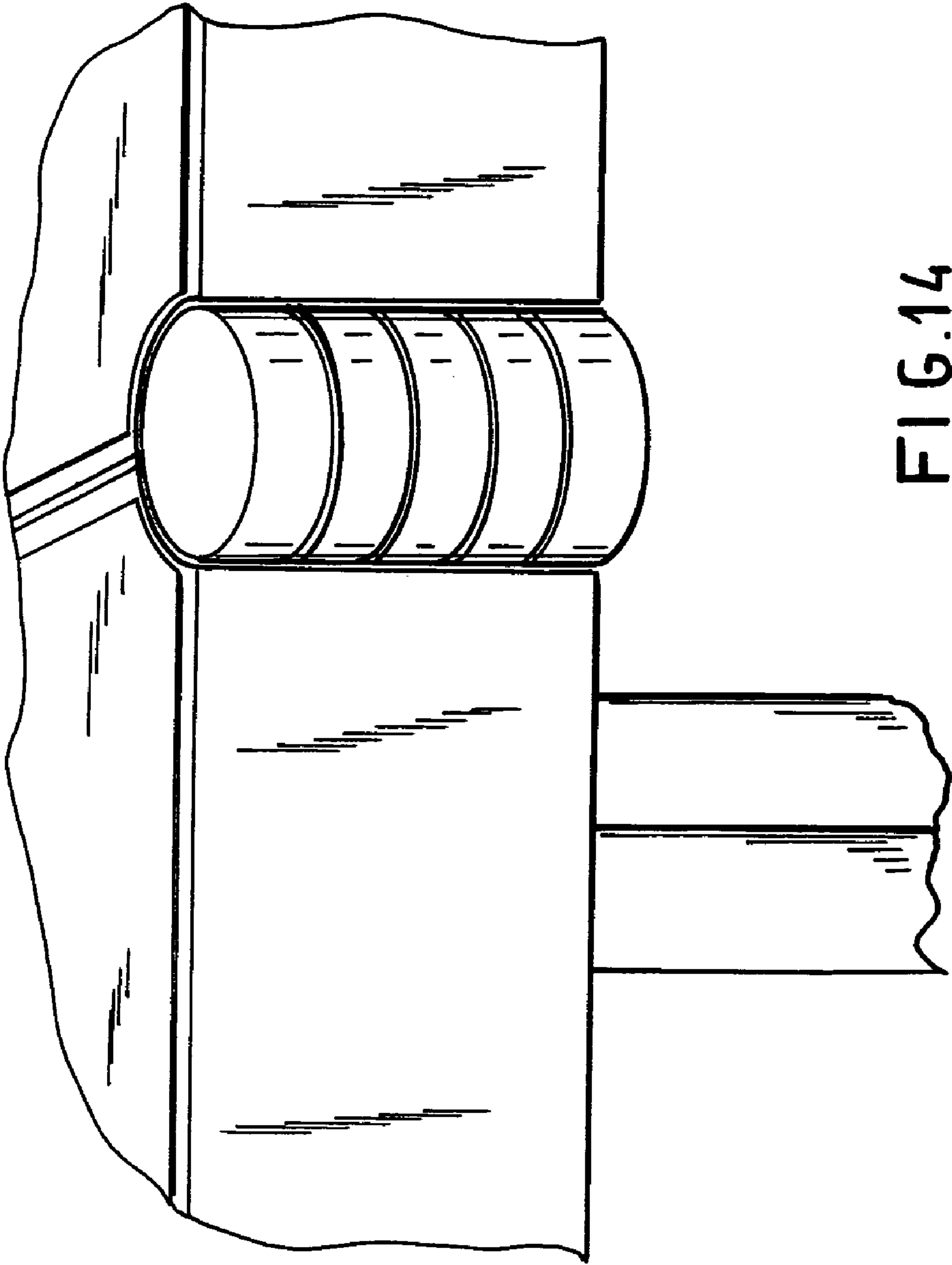
