The ornamental design for a disc case, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a disc case showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a perspective view of the design of FIG. 1 in an opened condition;

FIG. 8 is a perspective view of another embodiment of a disc case showing our new design;

FIG. 9 is a front elevational view thereof;

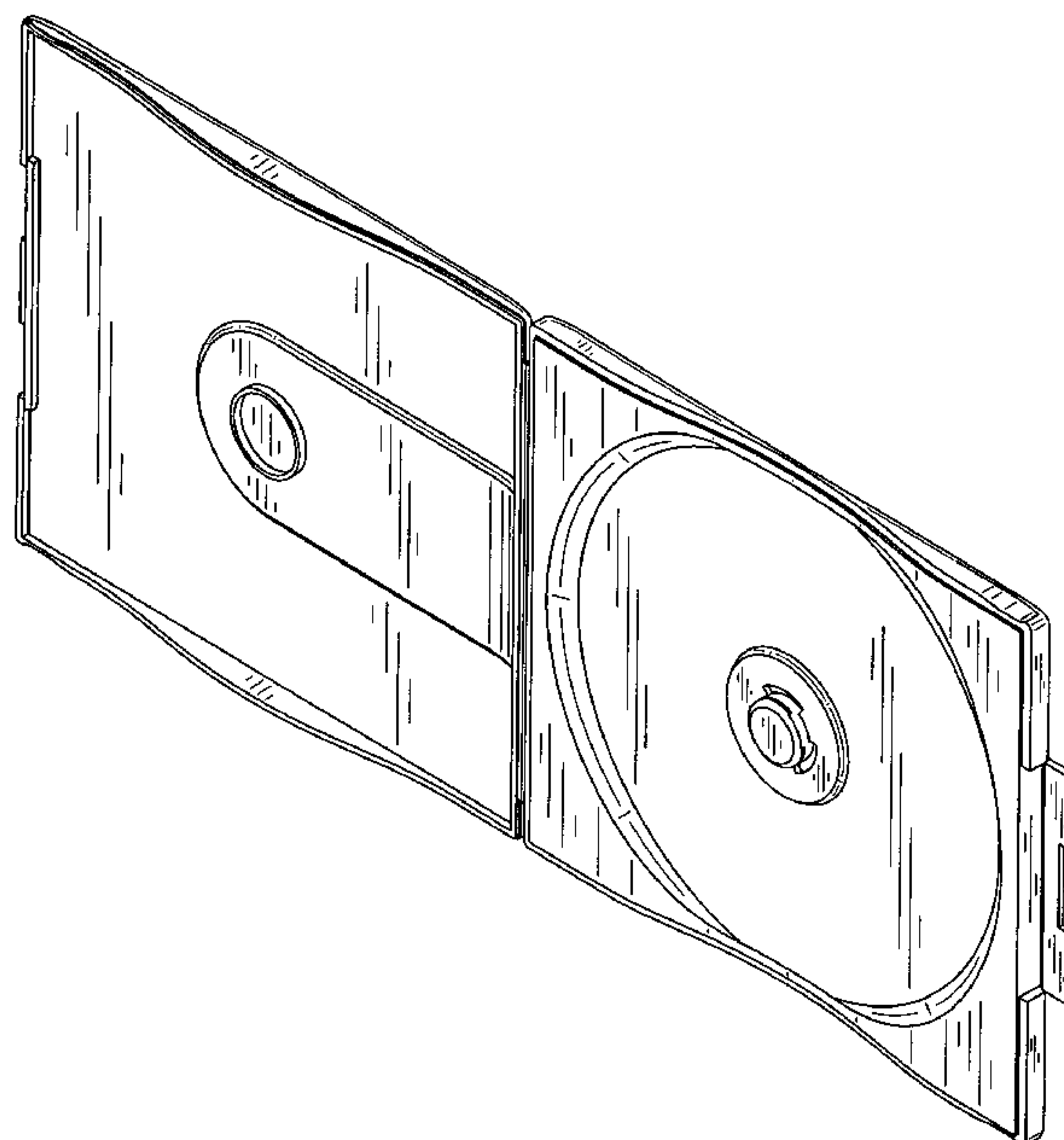

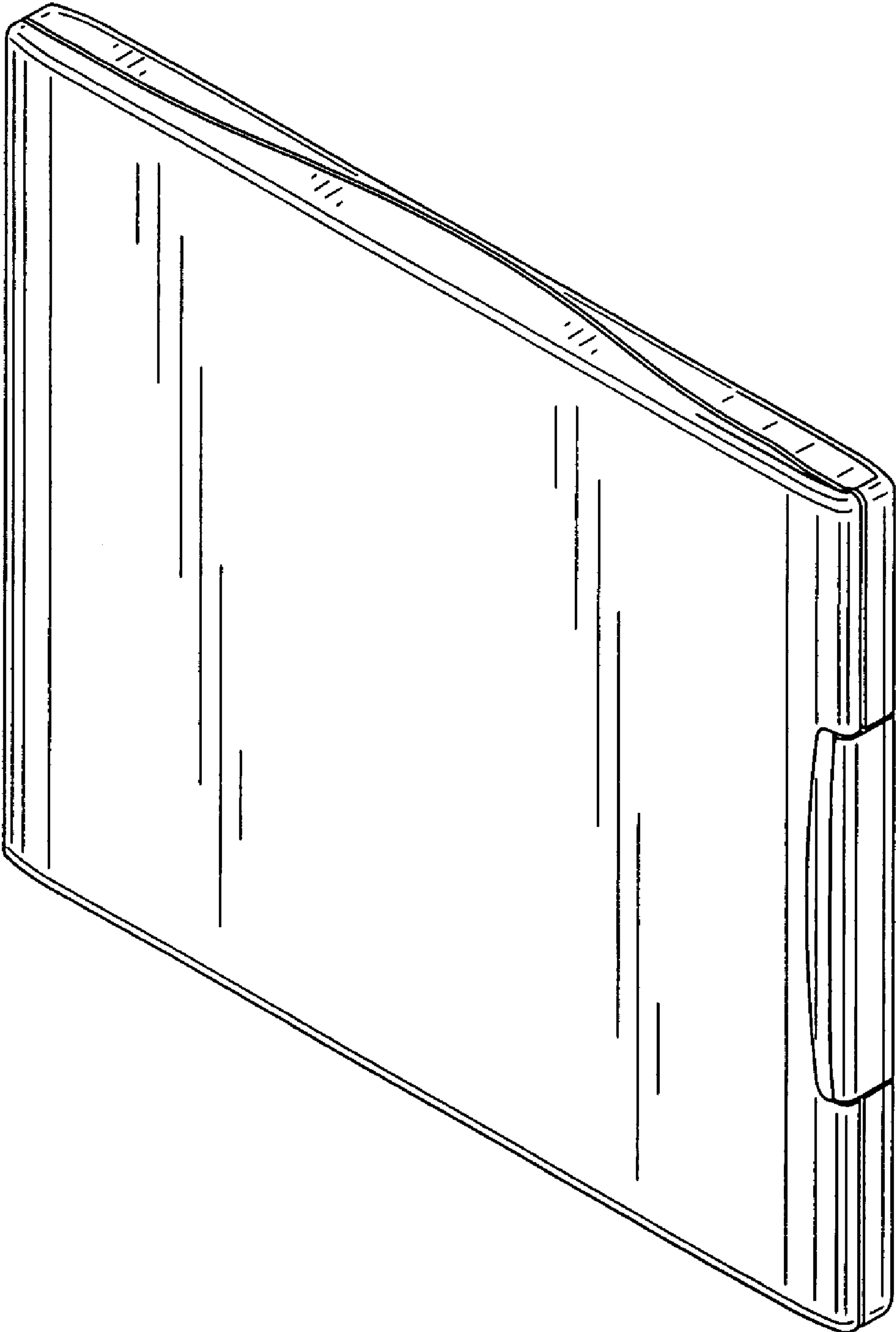

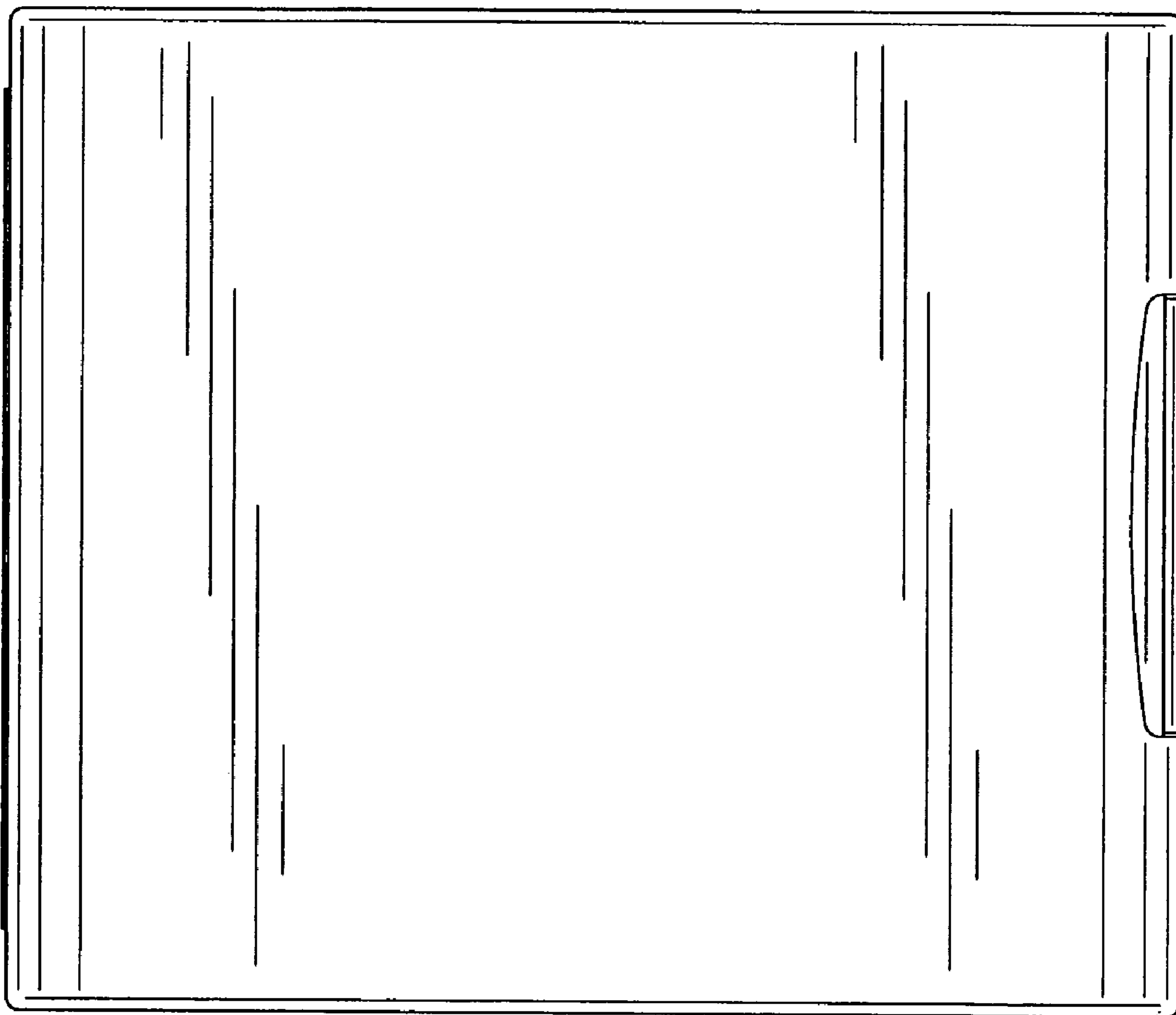

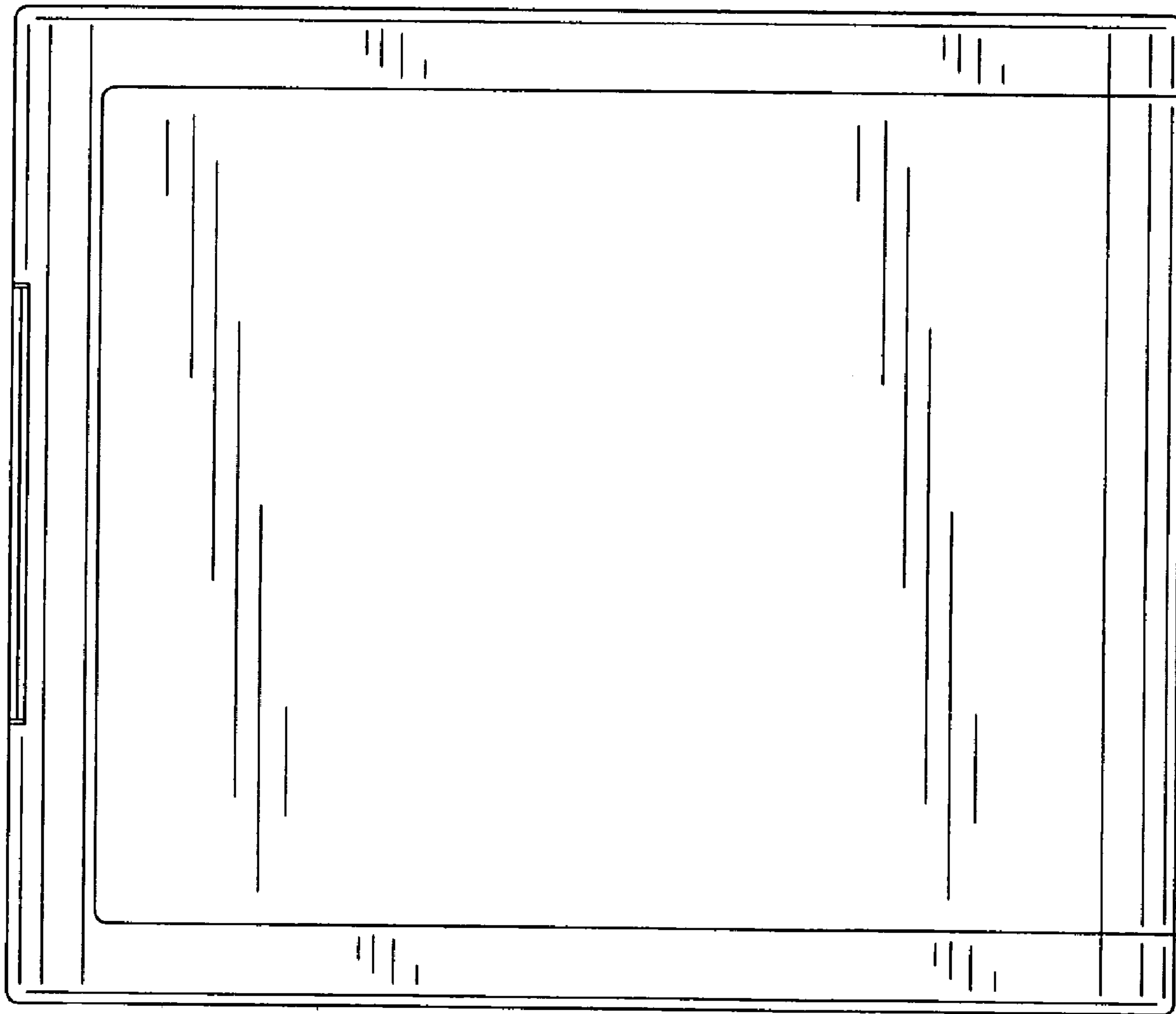

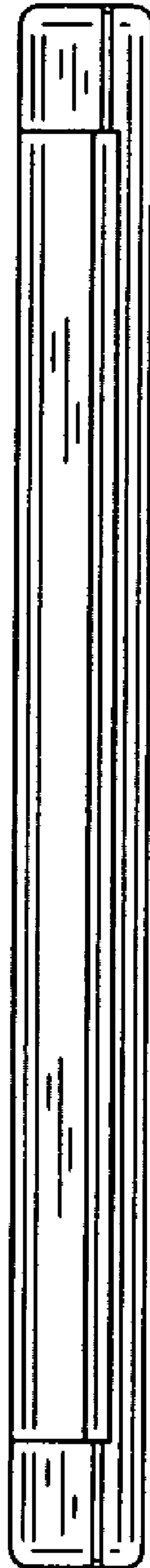

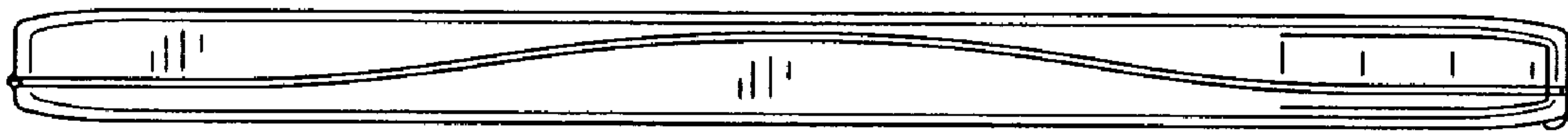

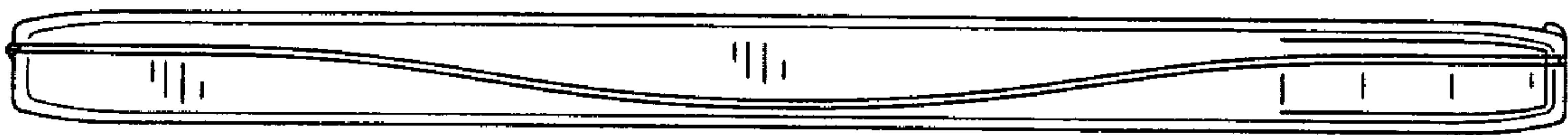
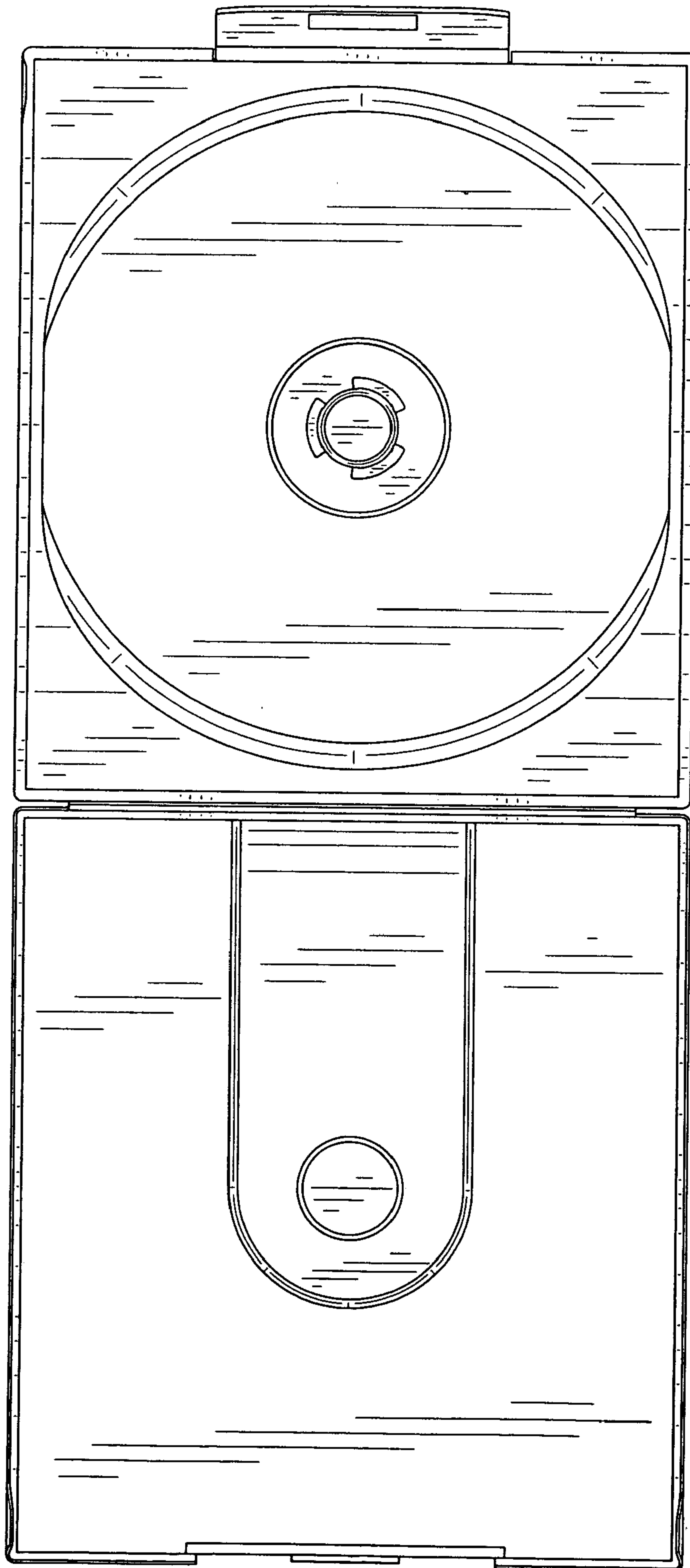

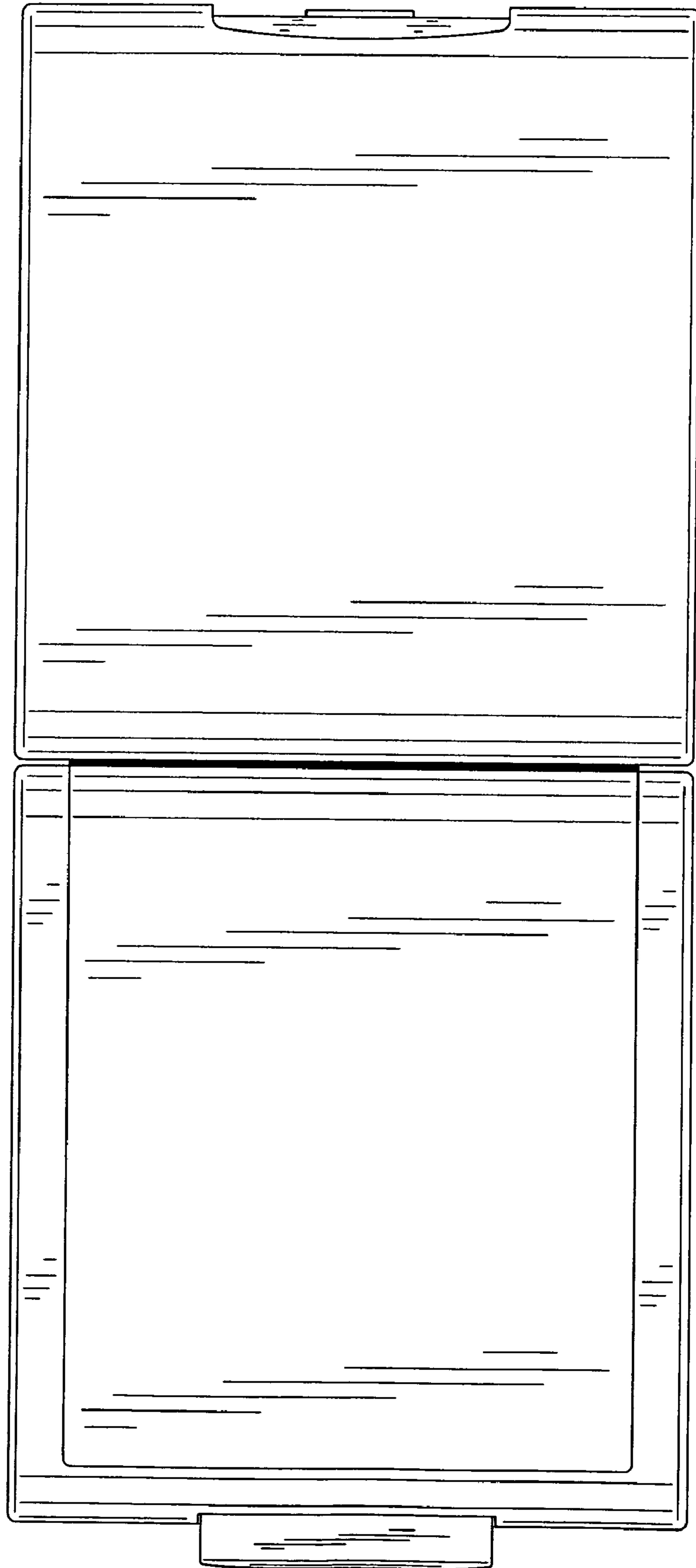

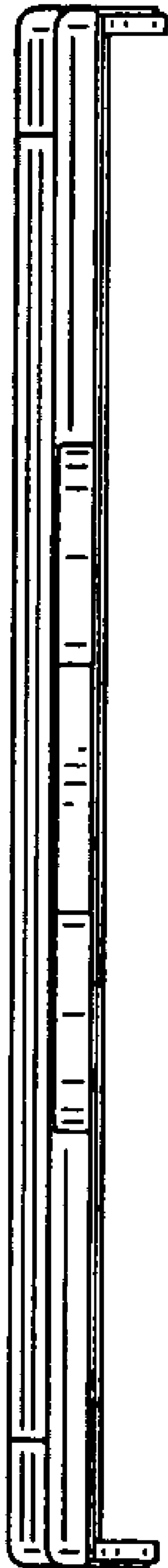

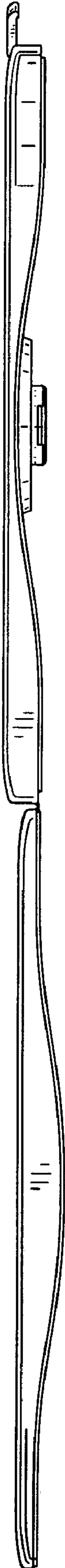
