(57) **CLAIM**

The ornamental design for a tire shaped handle, is as shown and described.

**DESCRIPTION**

The present tire shaped handle is mainly used as a handle for a container such as a cup or a kettle and the like, and is detachable from the container.

FIG. 4 is a right side view of the same;

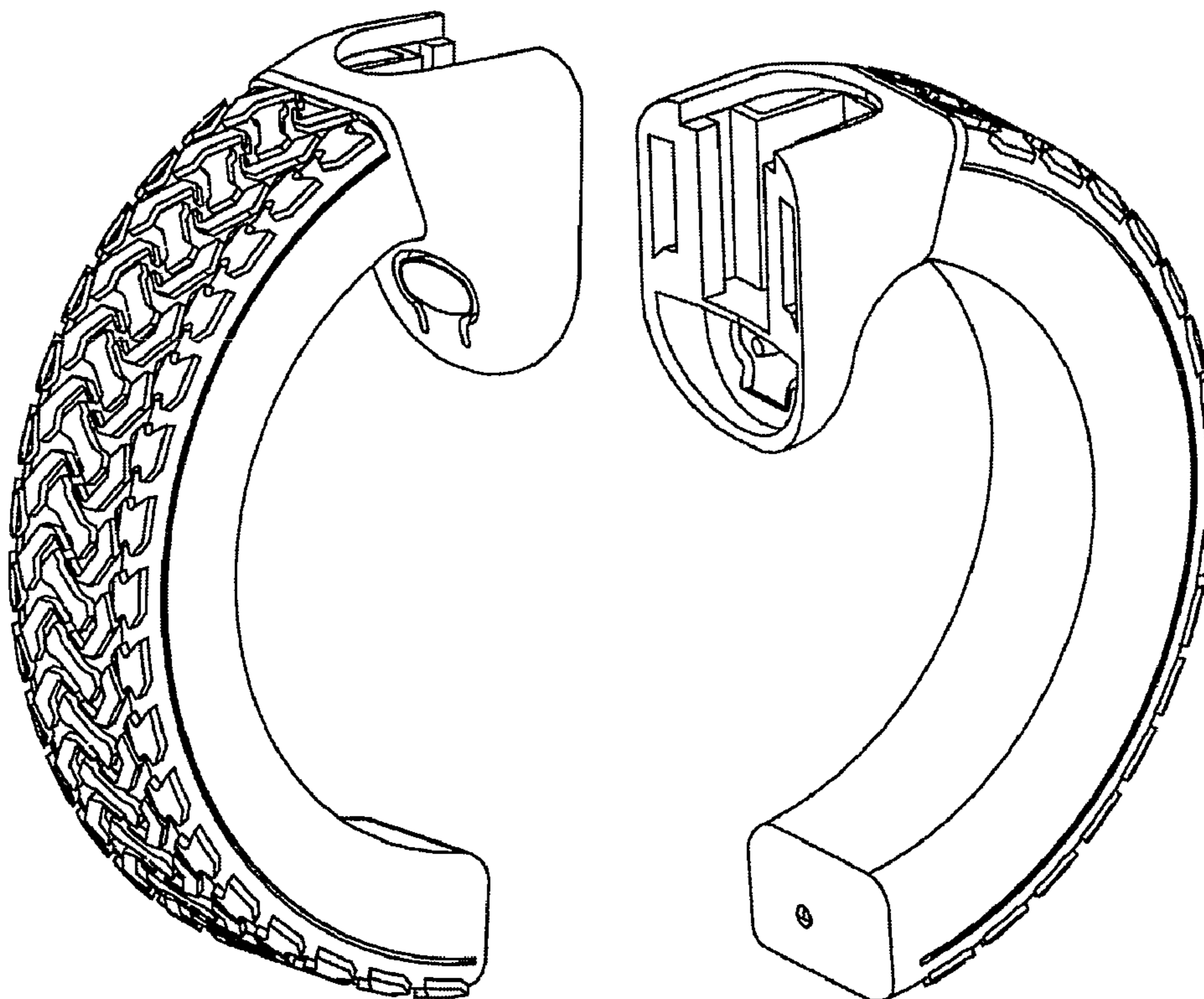
FIG. 5 is a top view of the same;

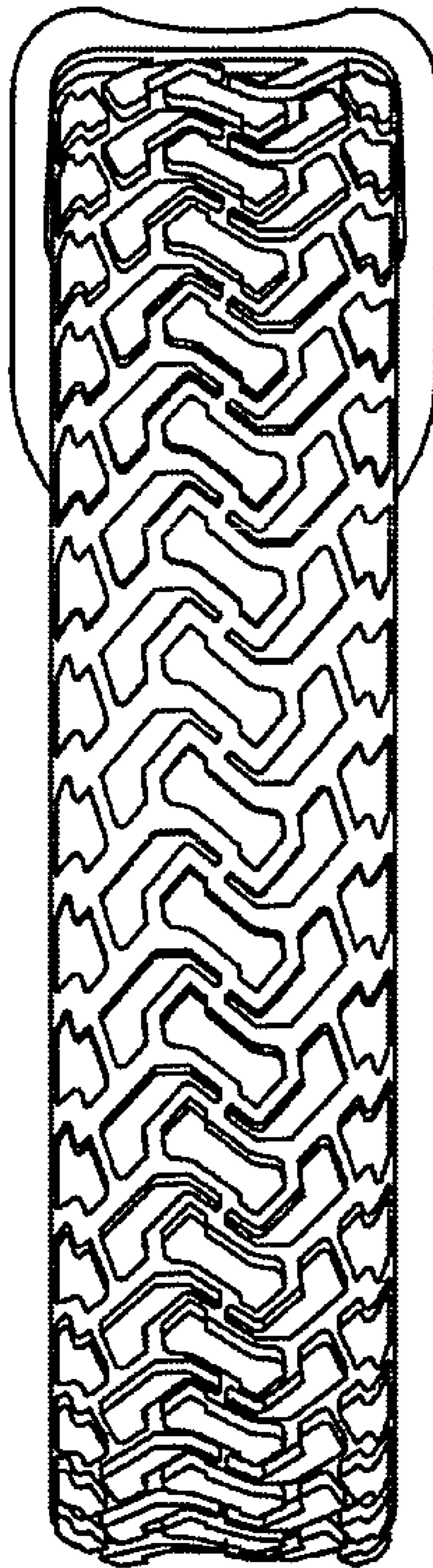

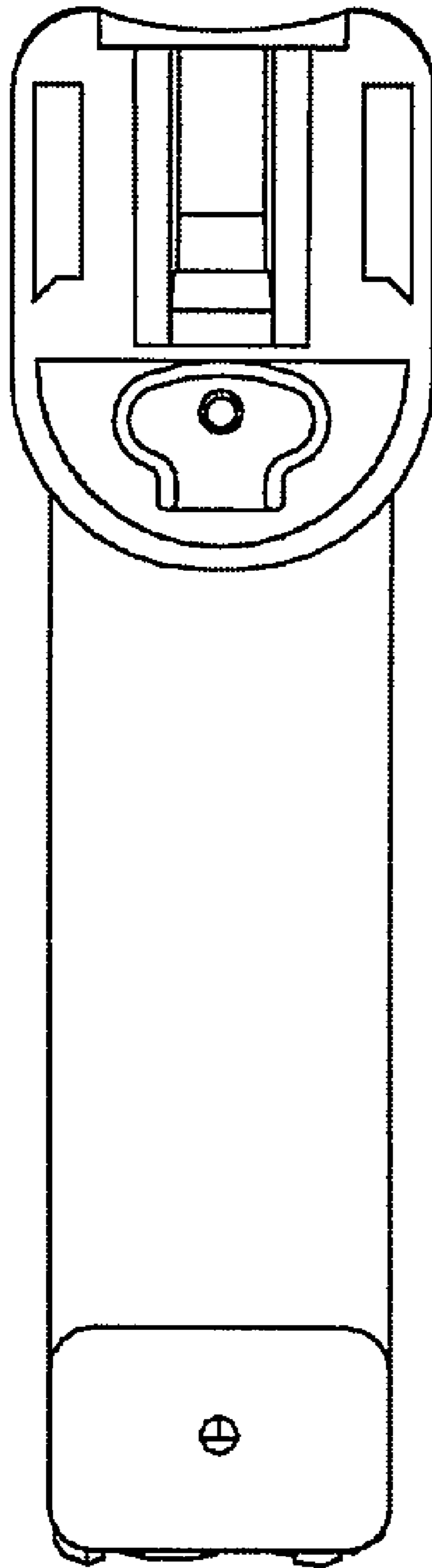

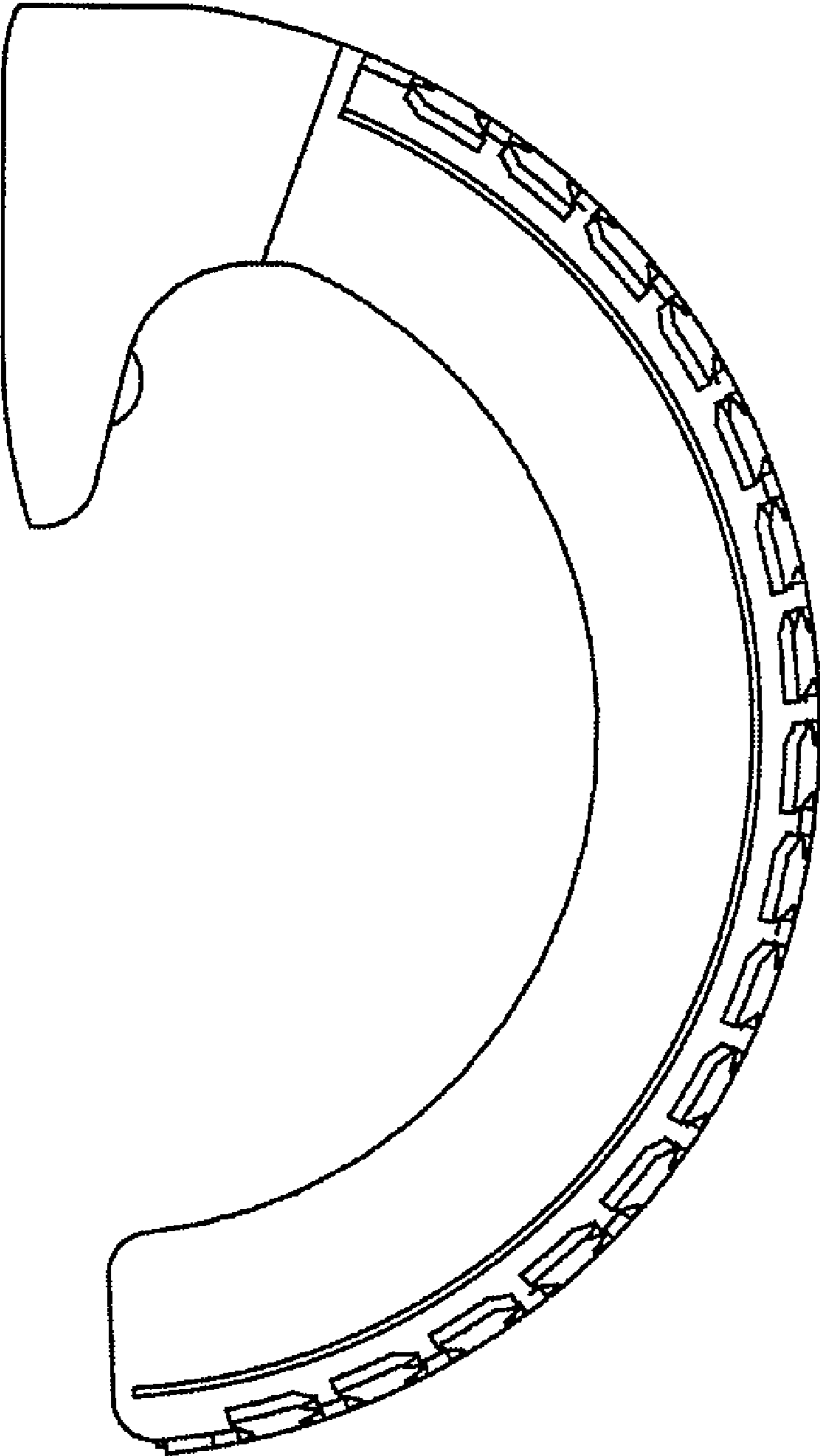

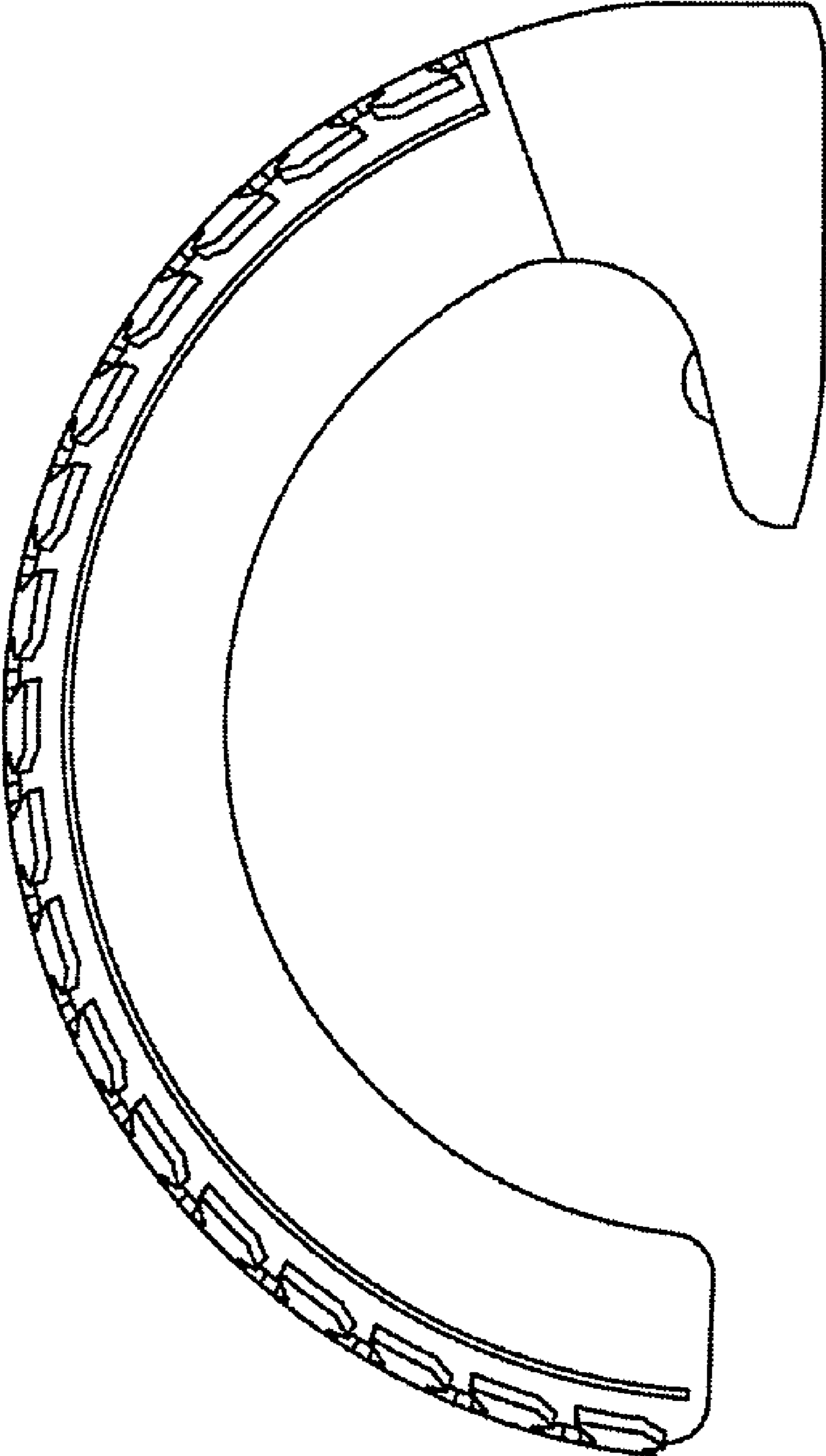

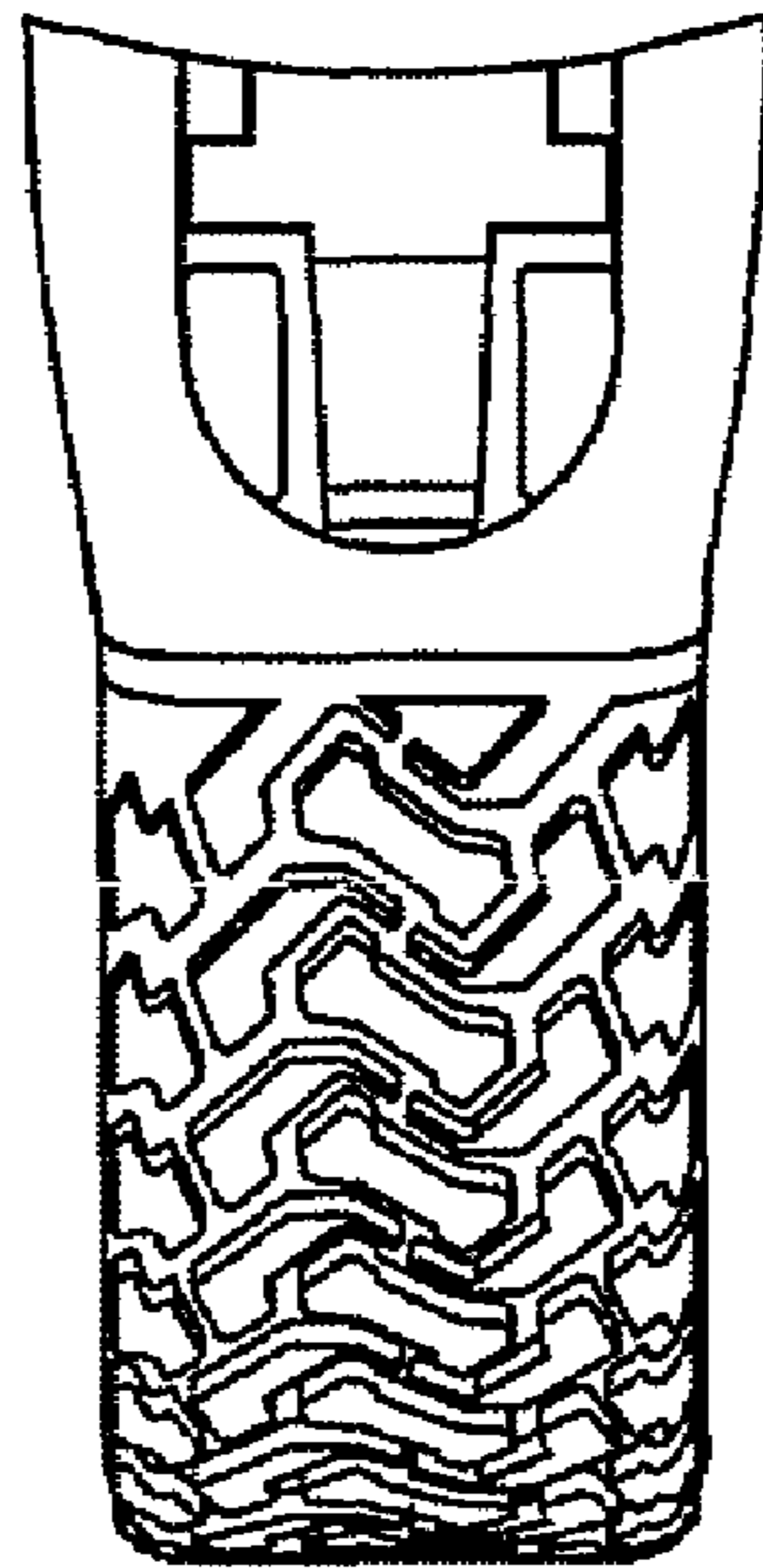

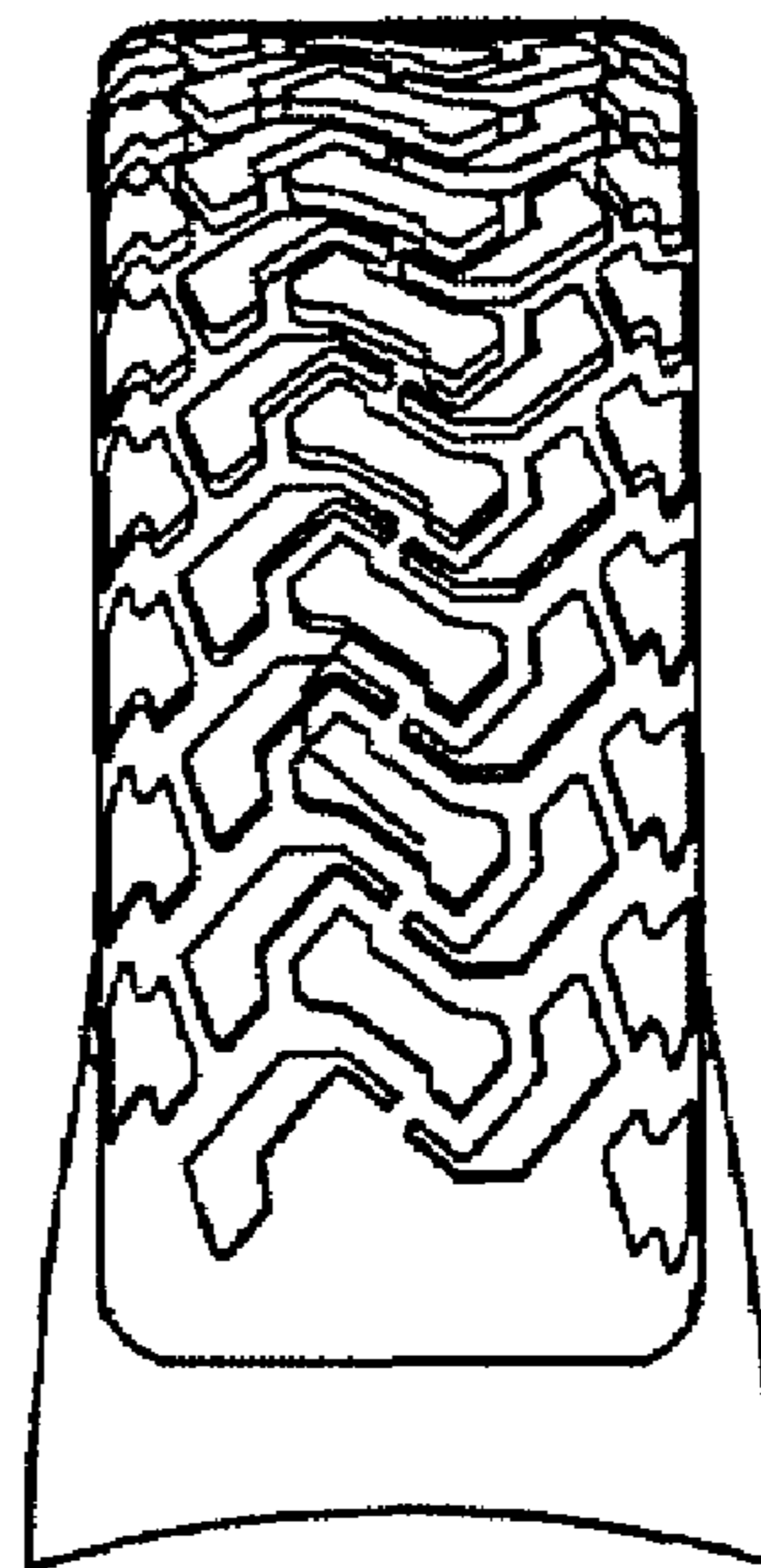

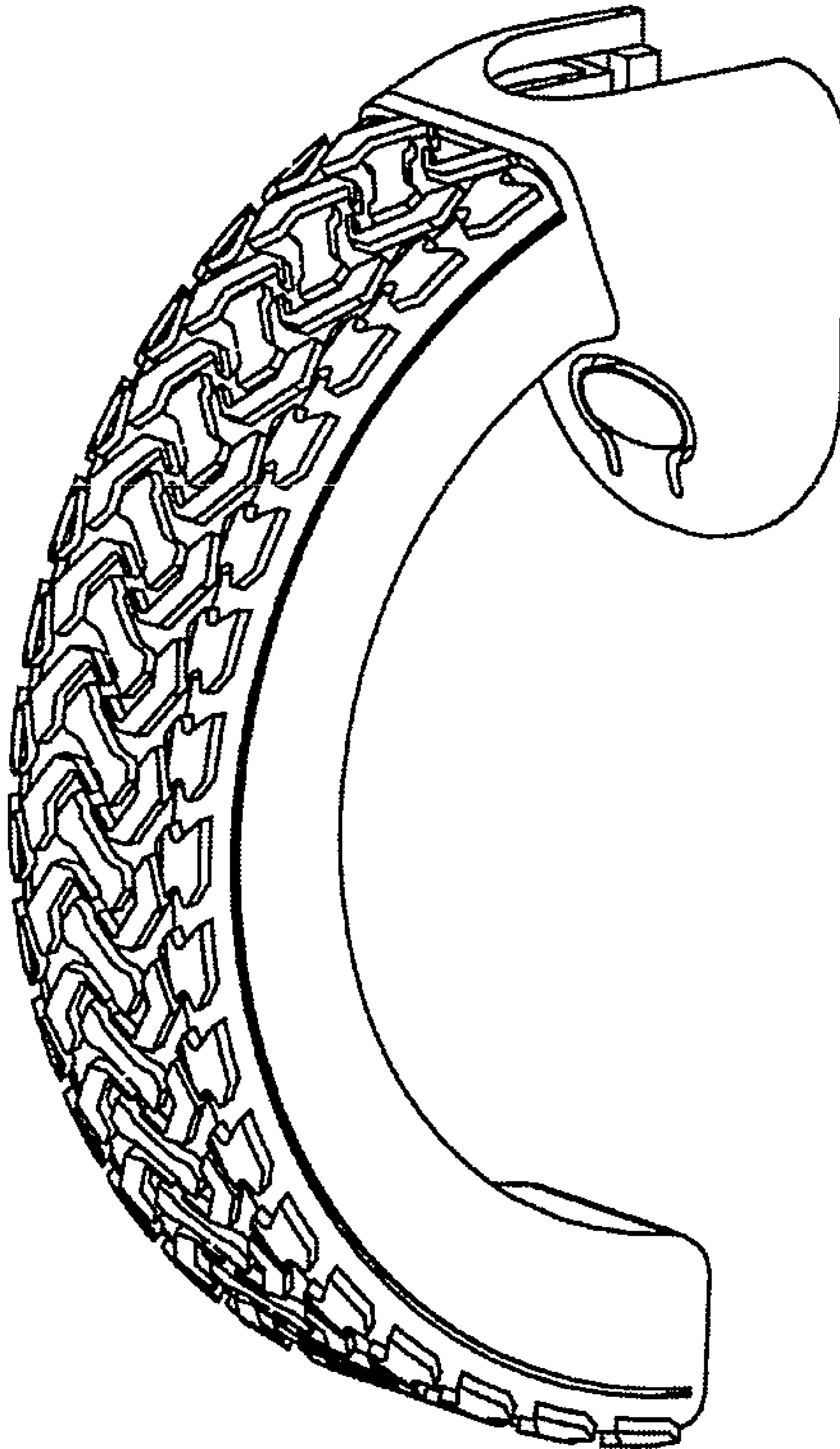

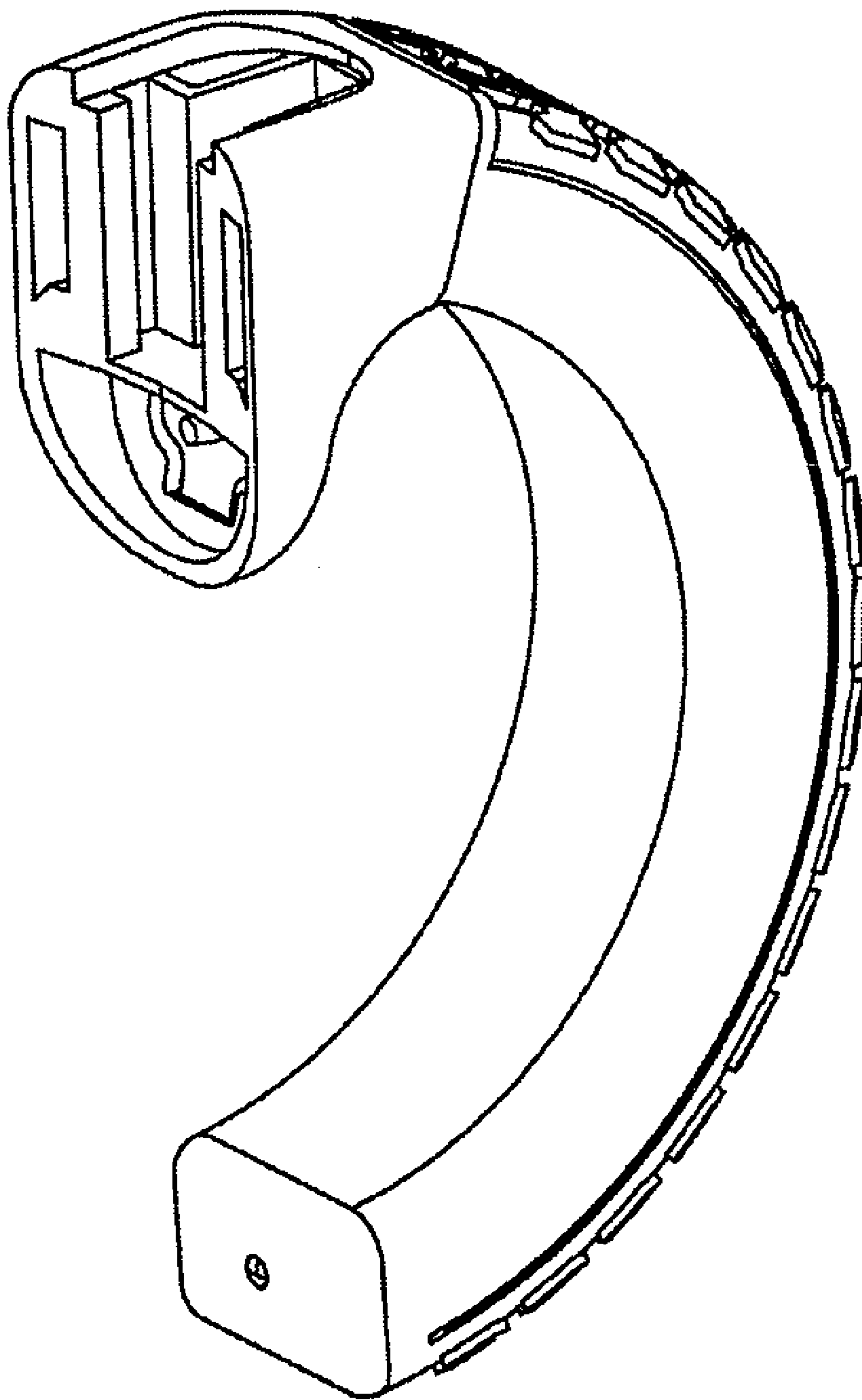
