(57) **CLAIM**

I claim the ornamental design for sash rail lock, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a sash rail lock according to a first embodiment of the invention;

FIG. 2 is a top plan view of the sash rail lock depicted in FIG. 1;

FIG. 3 is a side elevation view of the sash rail lock depicted in FIG. 1;

FIG. 4 is a rear elevation view of the sash rail lock depicted in FIG. 1;

FIG. 5 is an opposing side elevation view of the sash rail lock depicted in FIG. 1;

FIG. 6 is a front elevation view of the sash rail lock depicted in FIG. 1;

FIG. 7 is a front perspective view of a sash rail lock according to a second embodiment of the invention;

FIG. 8 is a top plan view of the sash rail lock depicted in FIG. 7;

FIG. 9 is a side elevation view of the sash rail lock depicted in FIG. 7;

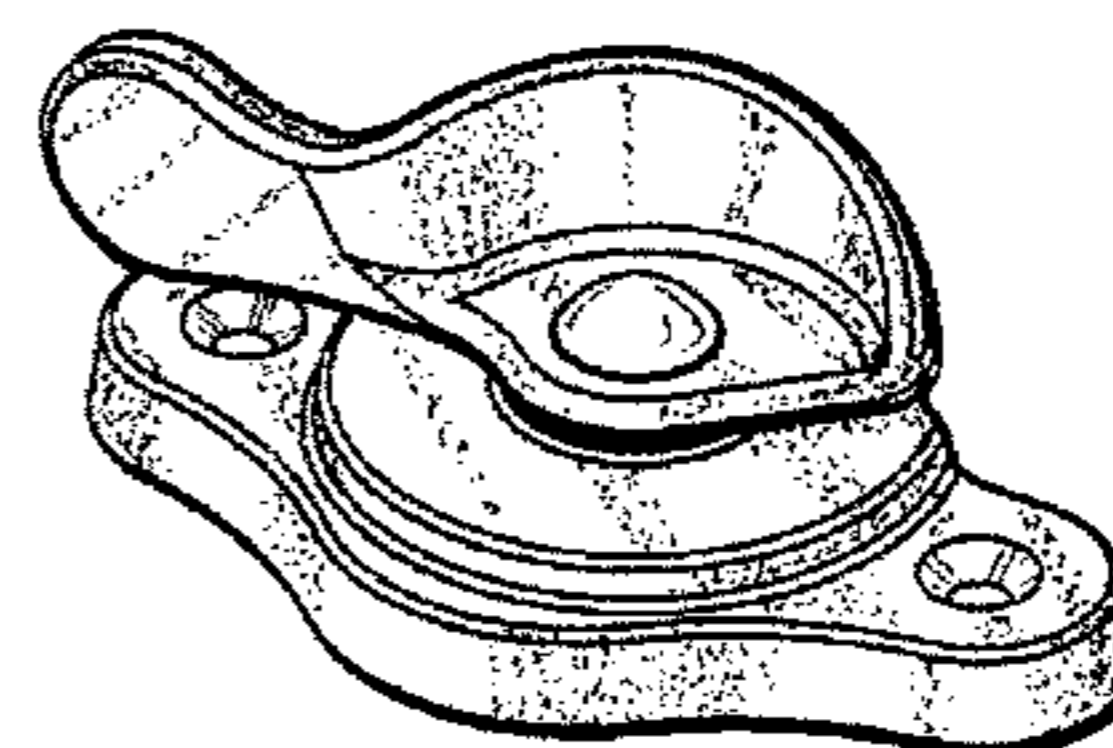
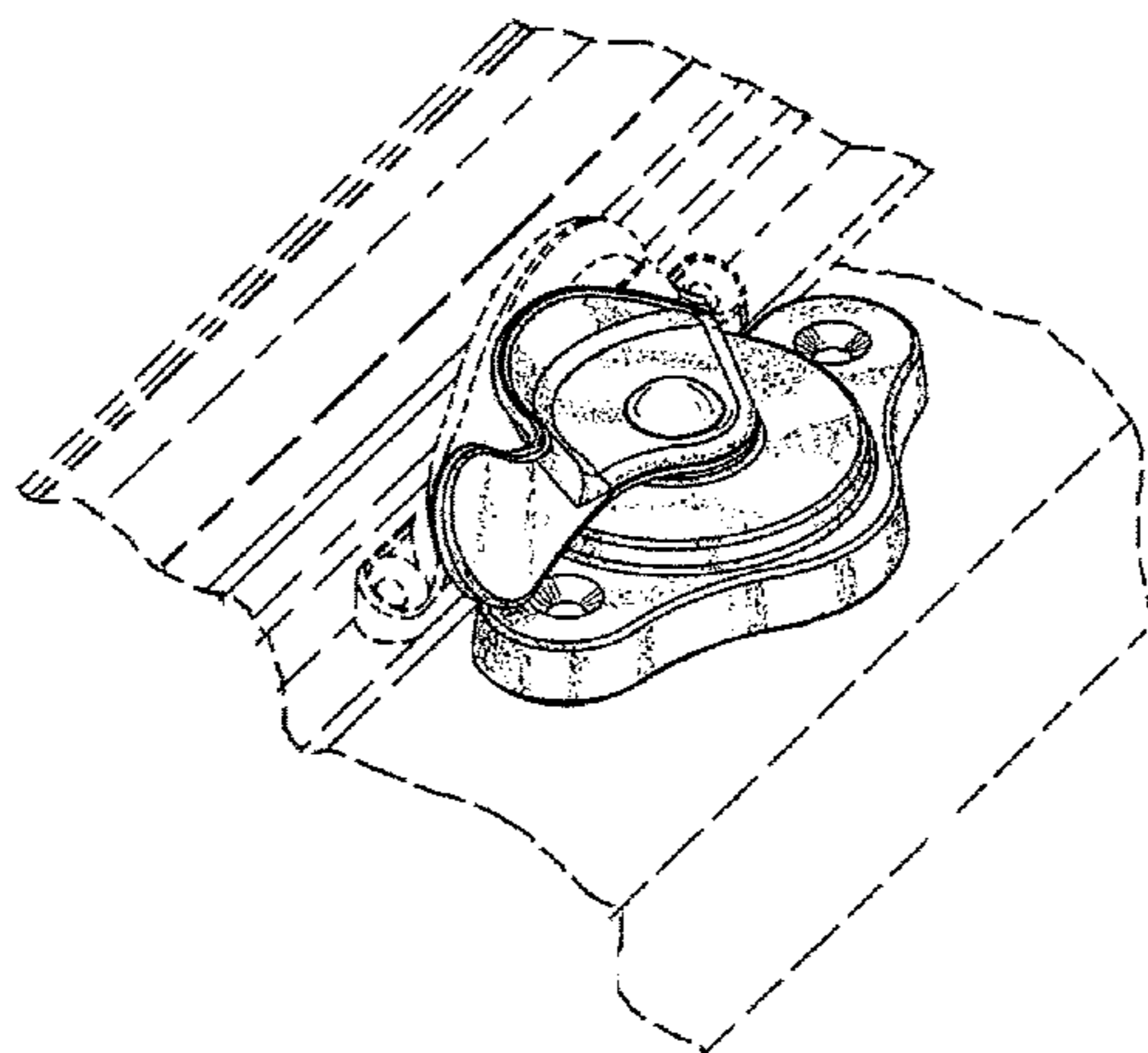
FIG. 10 is a rear elevation view of the sash rail lock depicted in FIG. 7;

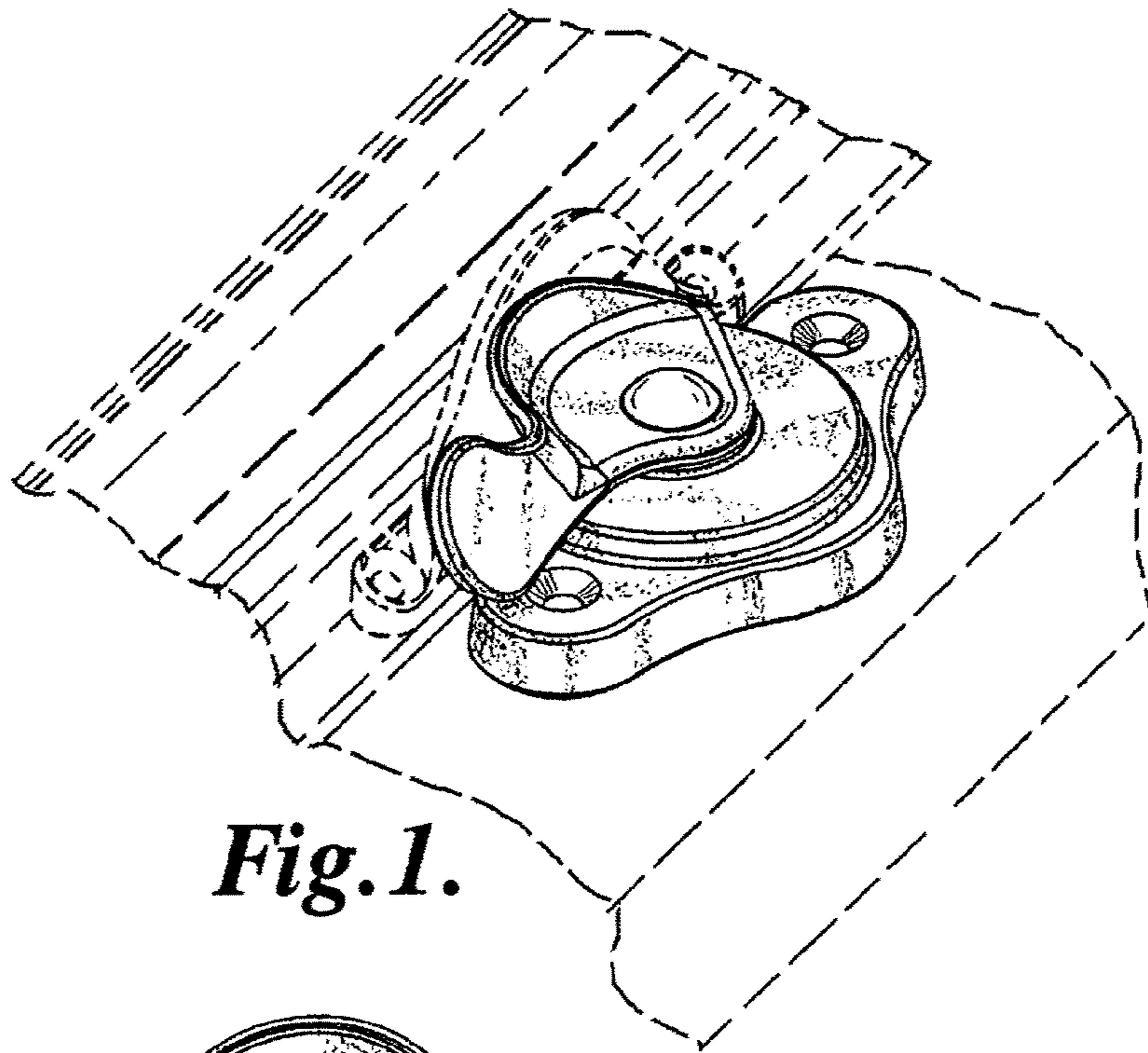

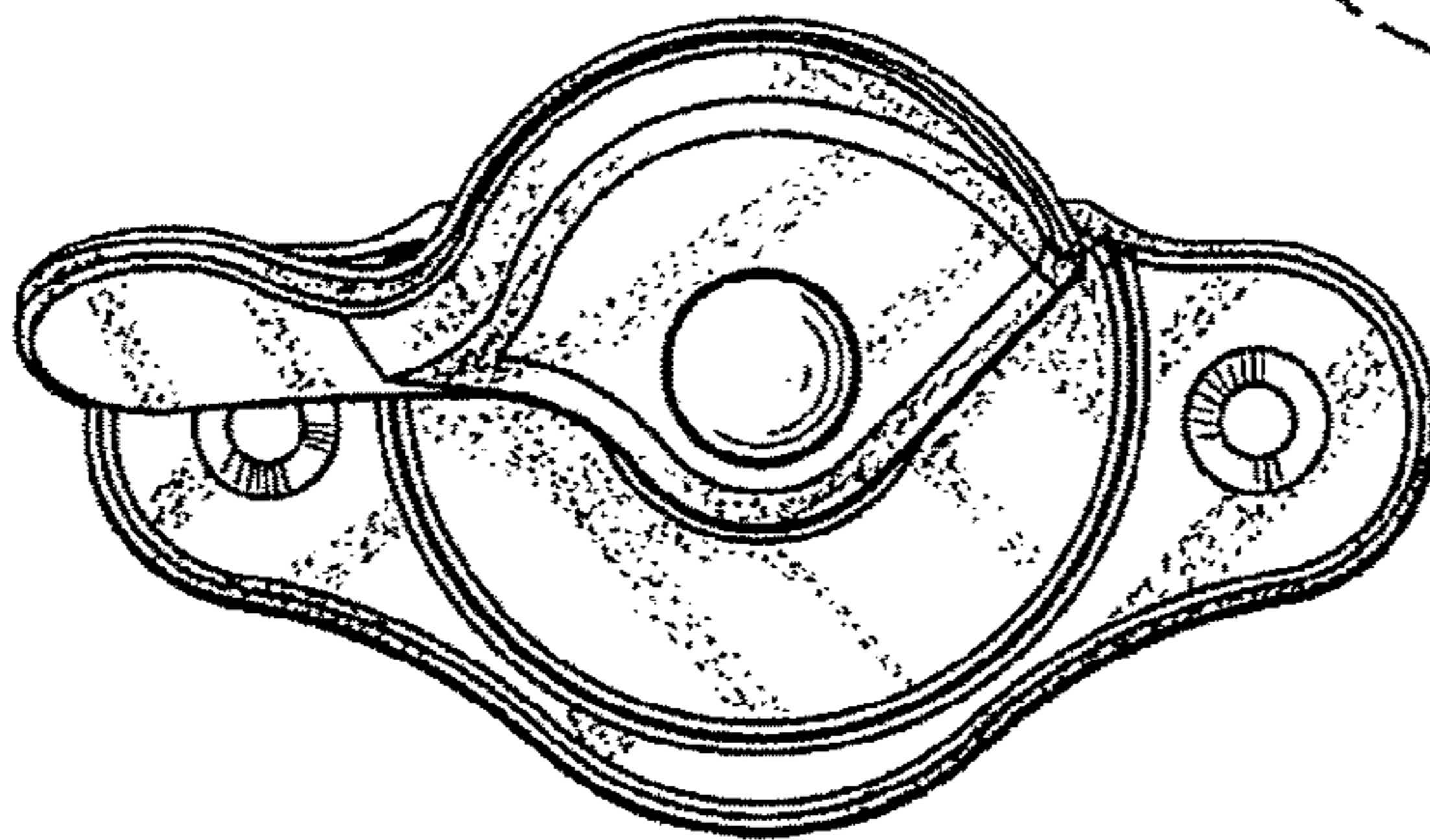

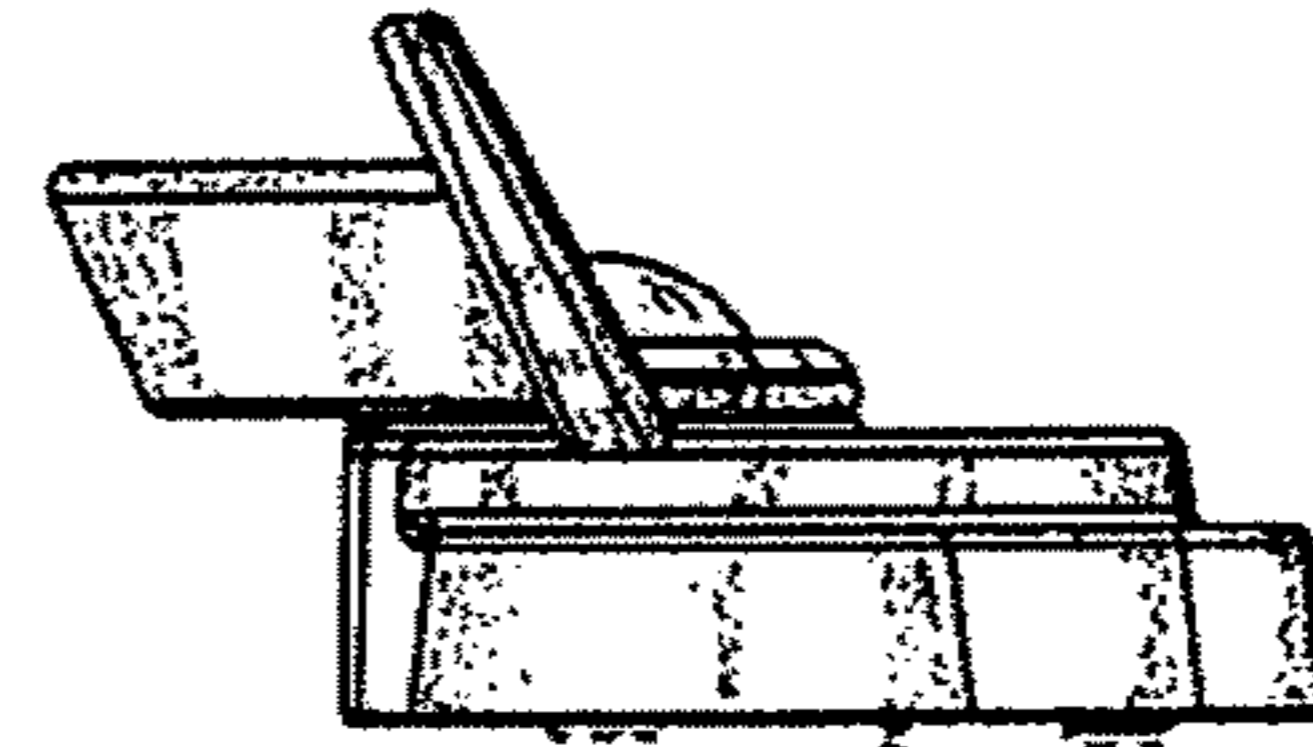

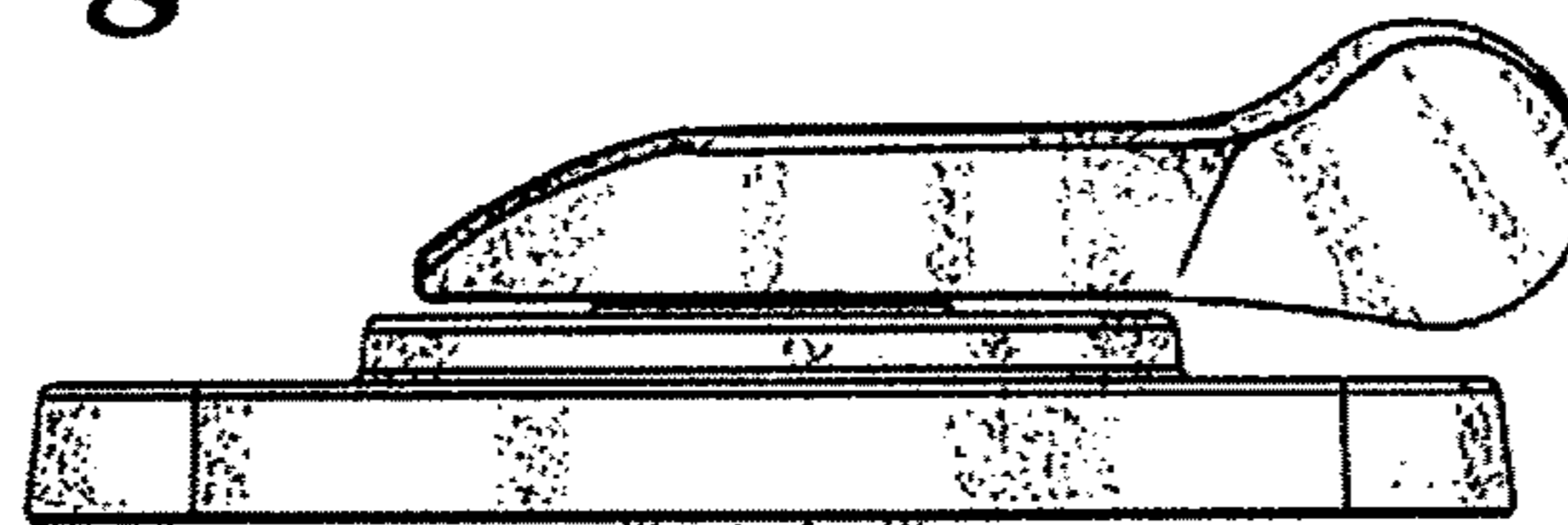

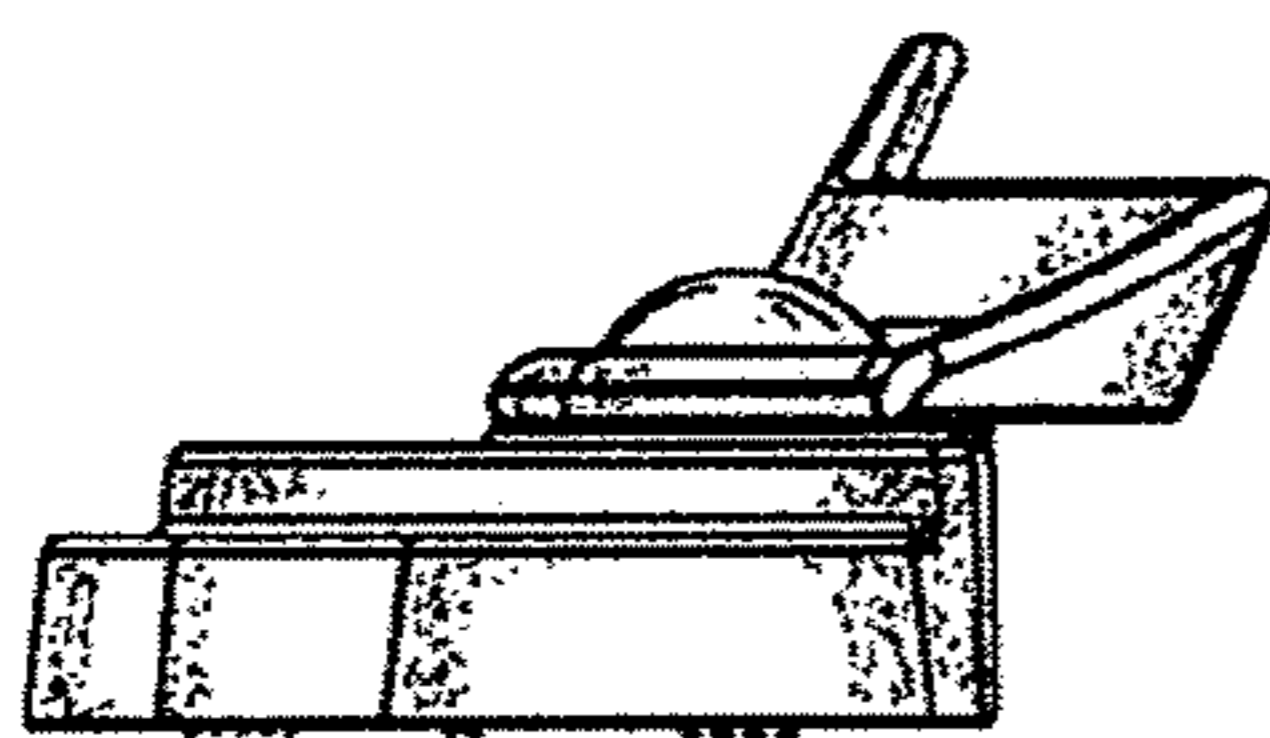

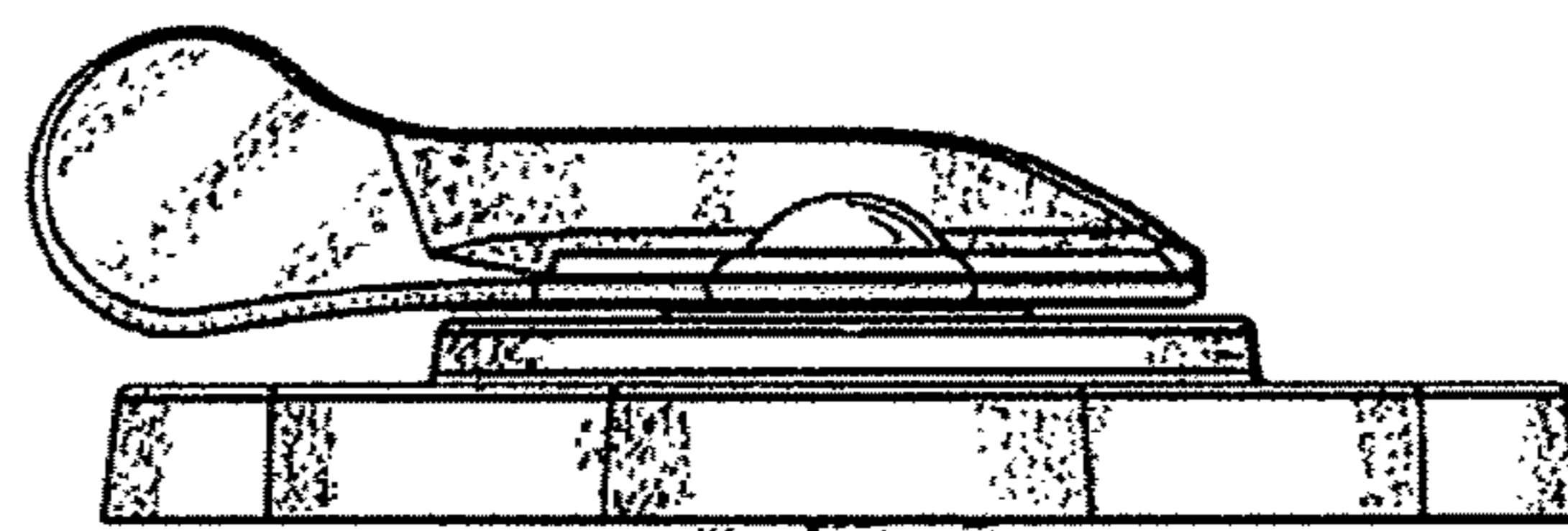

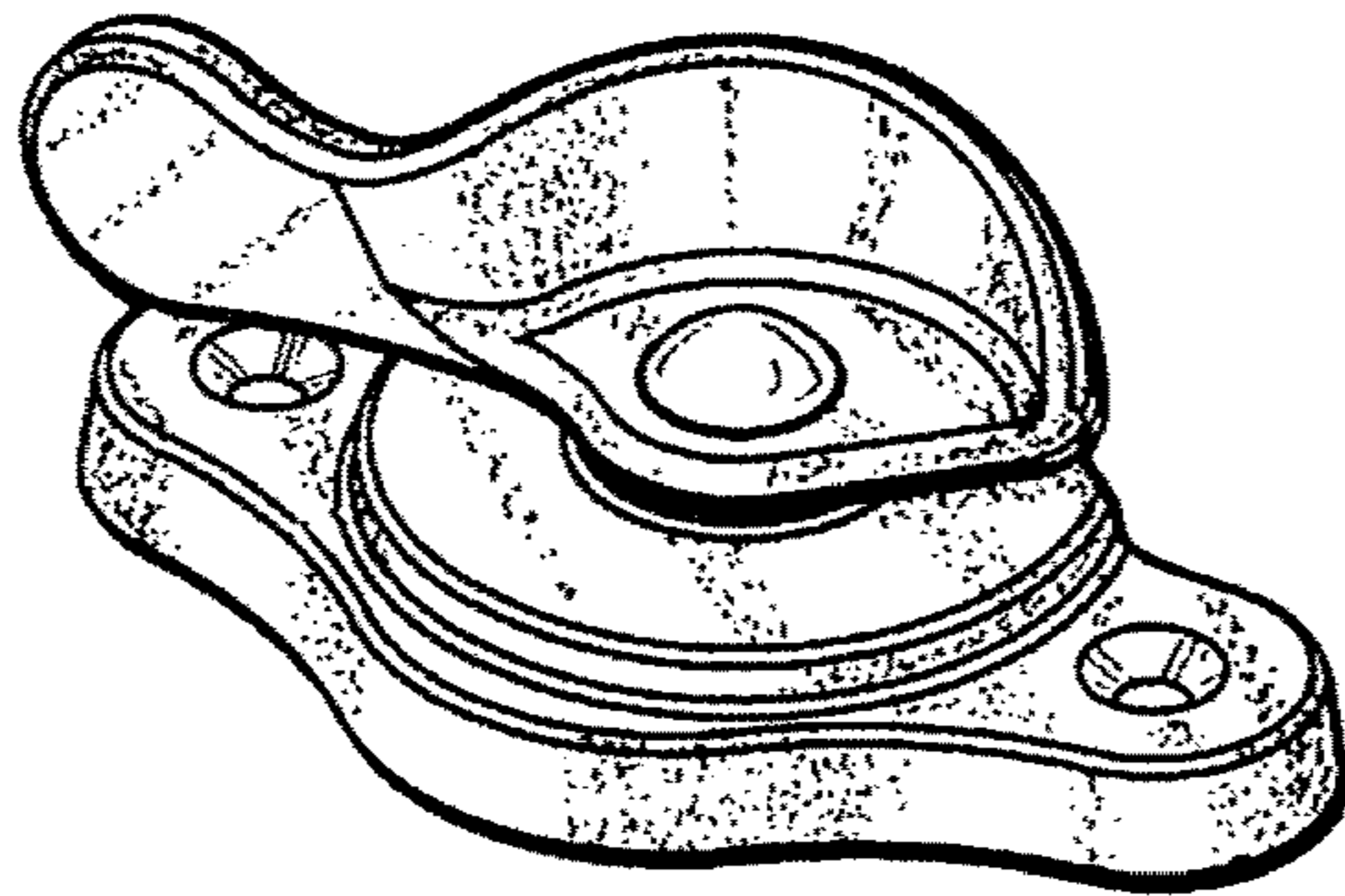

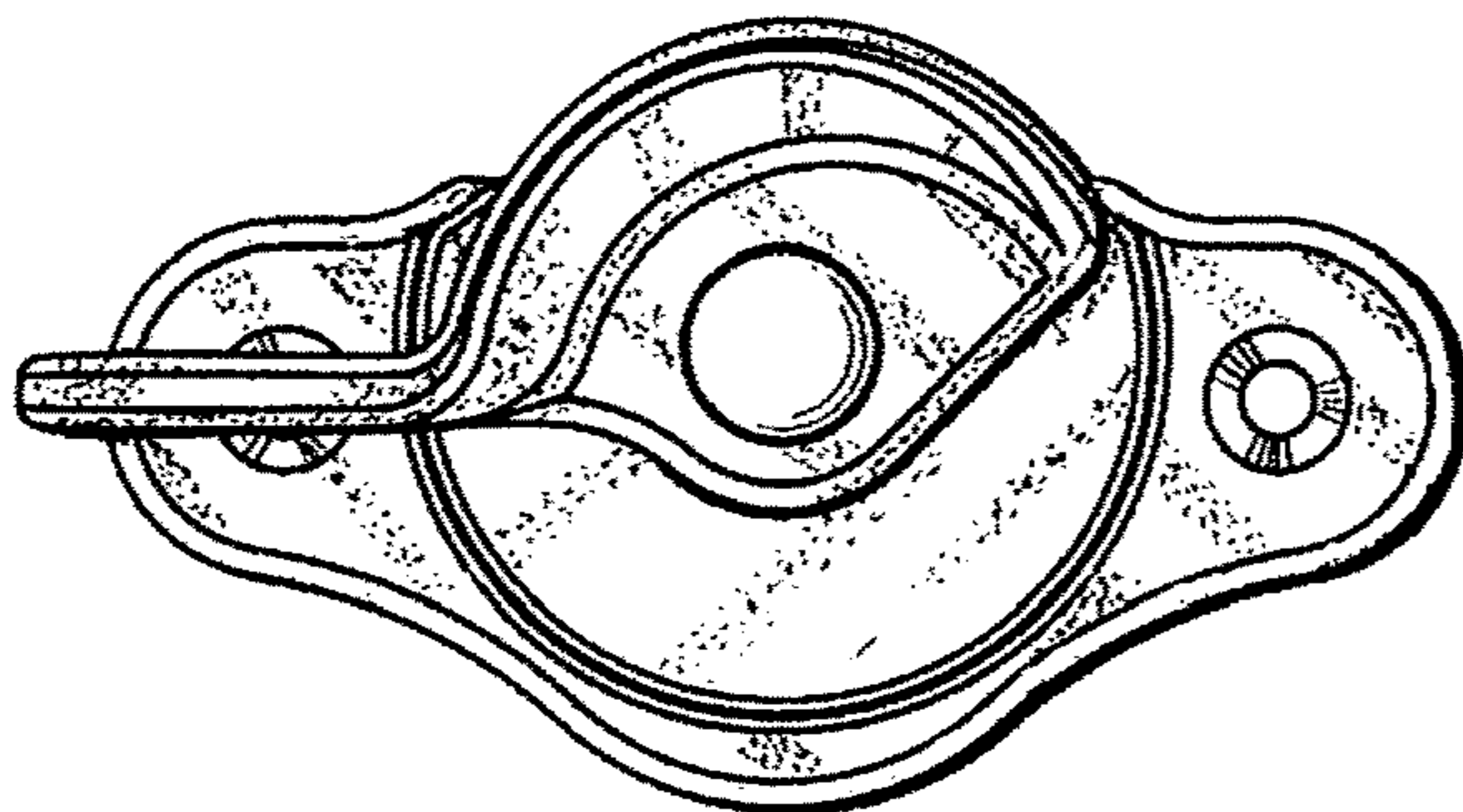

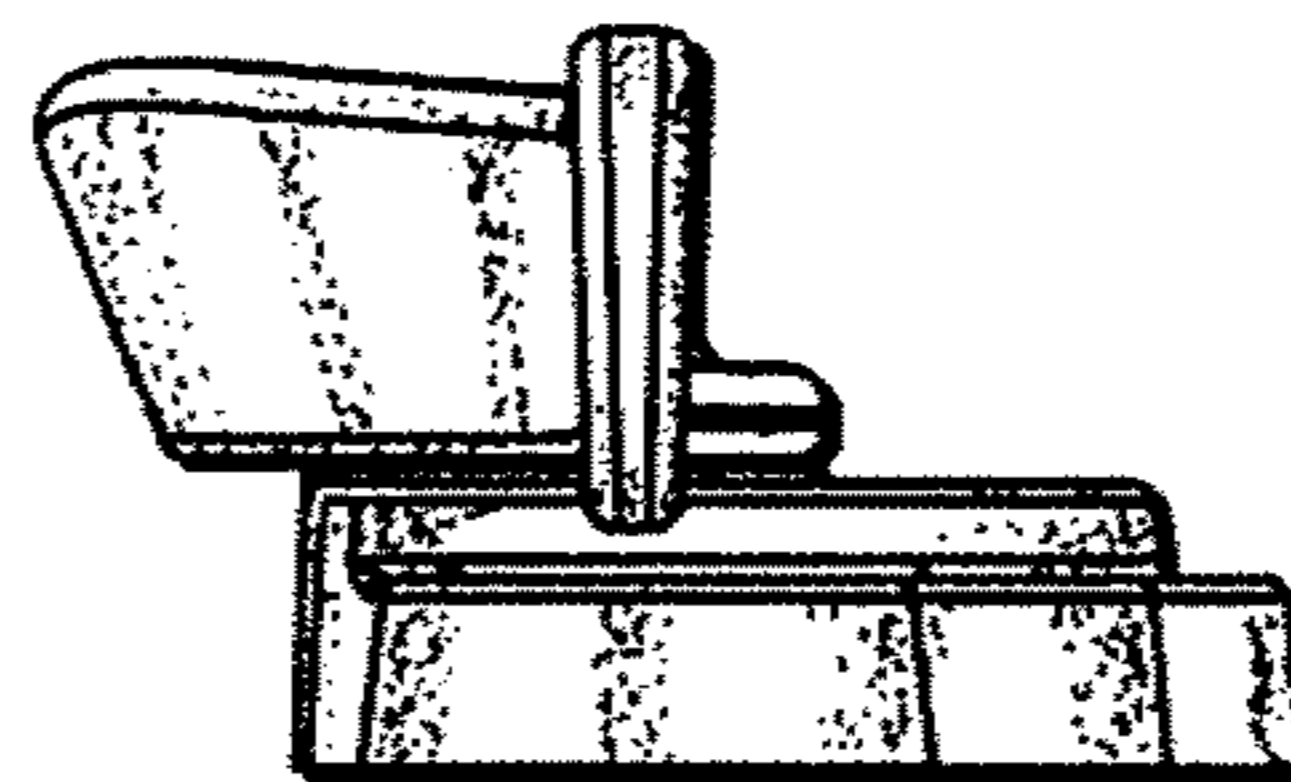

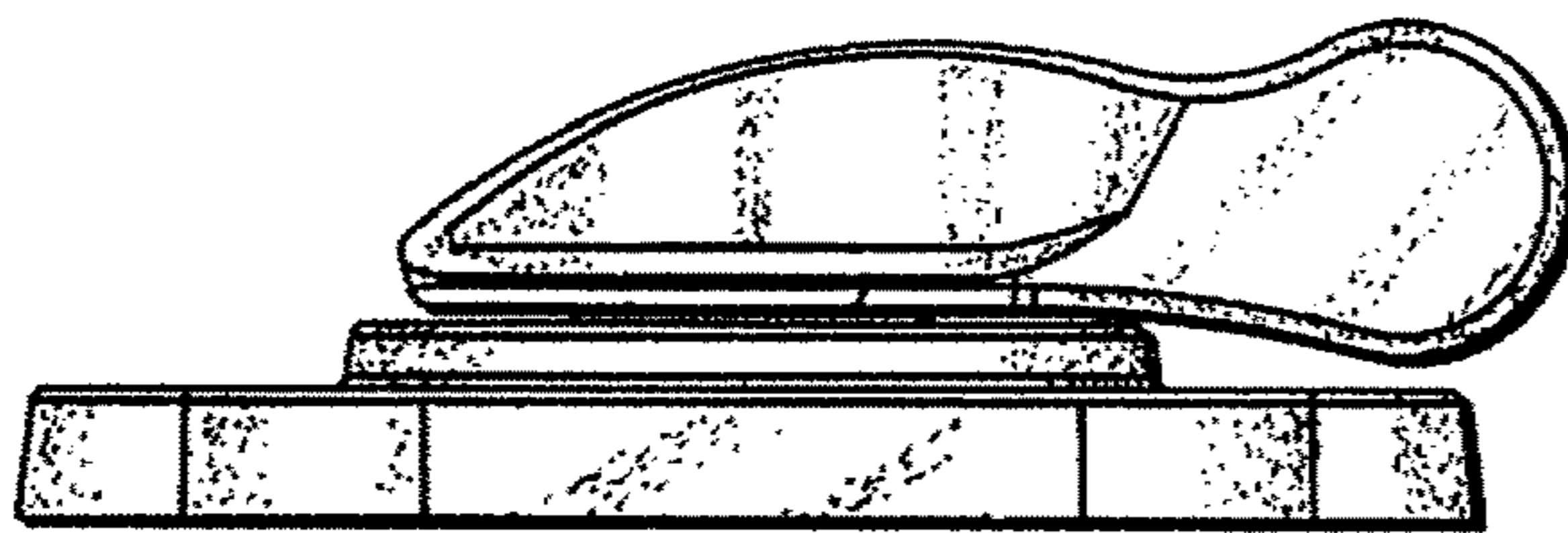

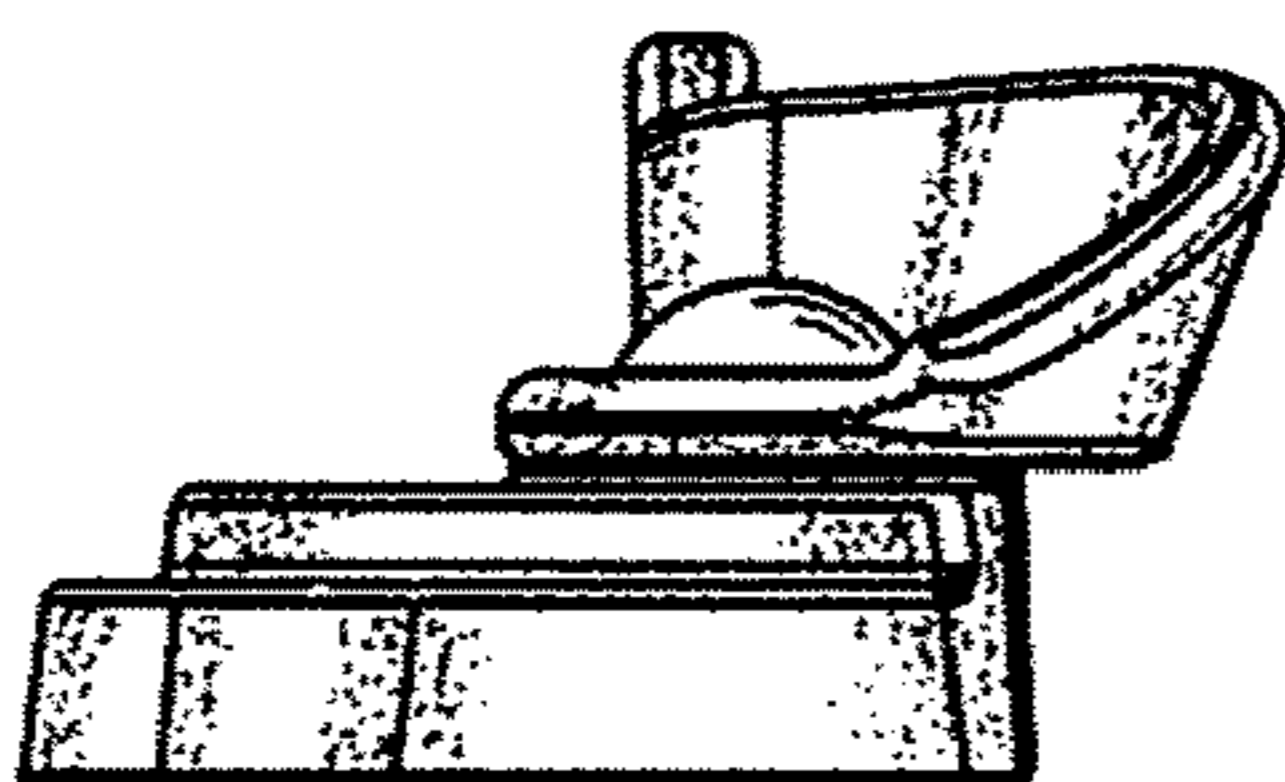

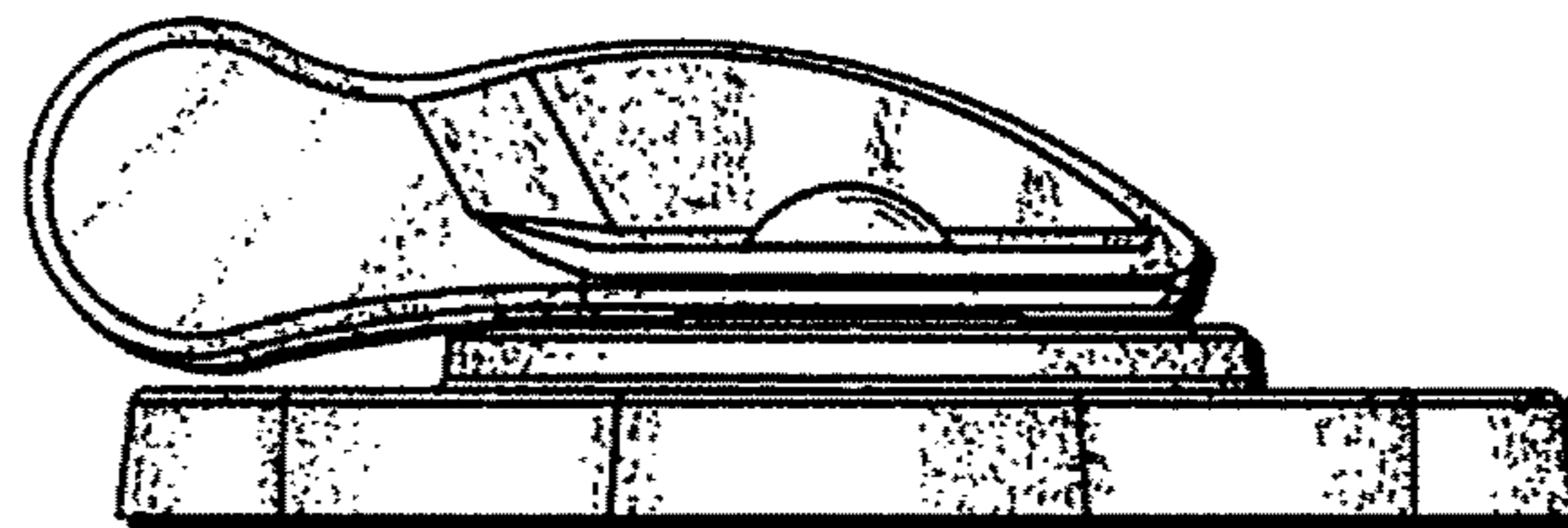
