I claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a container showing my new design;

FIG. 6 is a top, front, right side perspective view of a second embodiment of a container showing my new design;

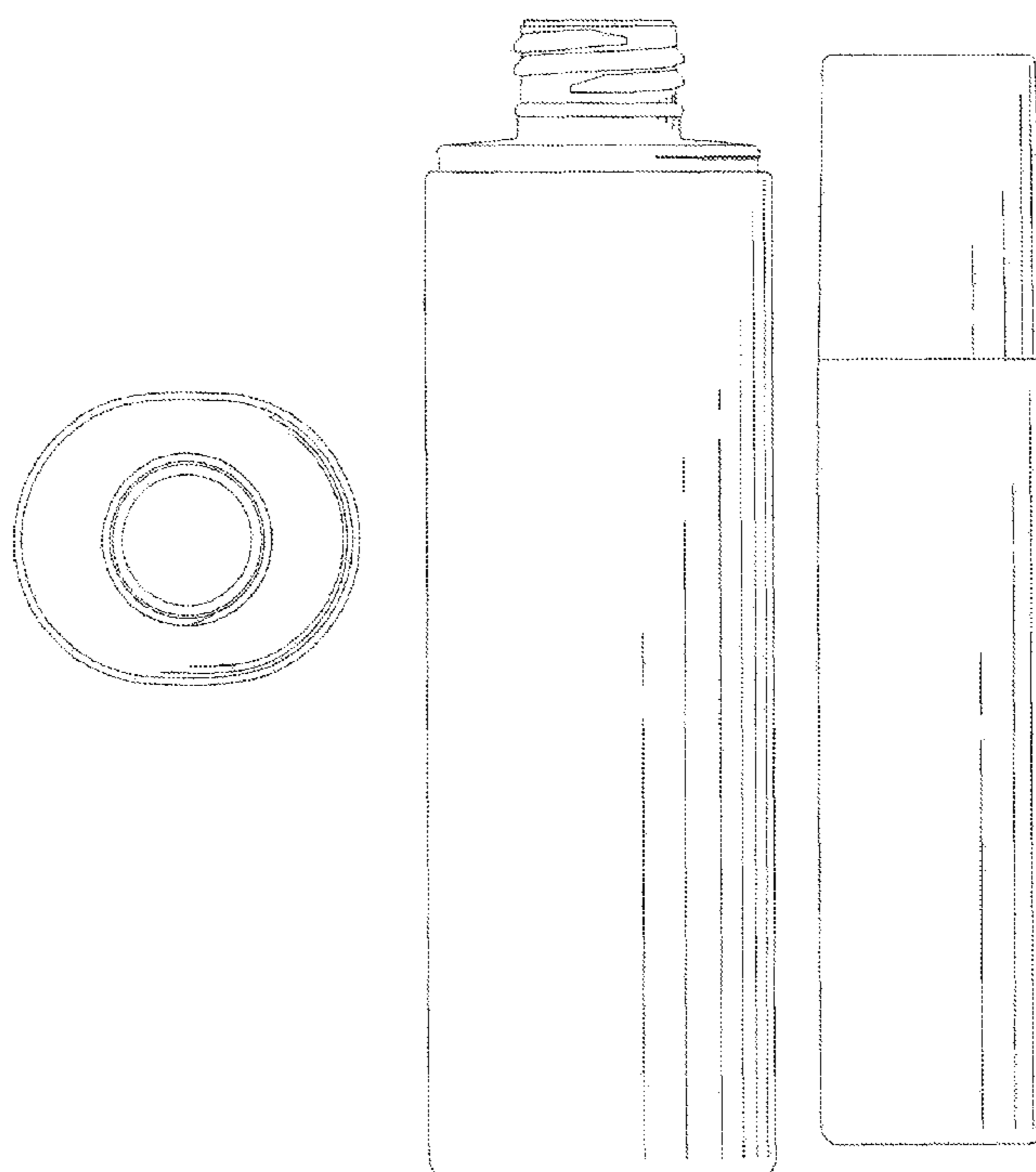
FIG. 7 is a top plan view thereof;

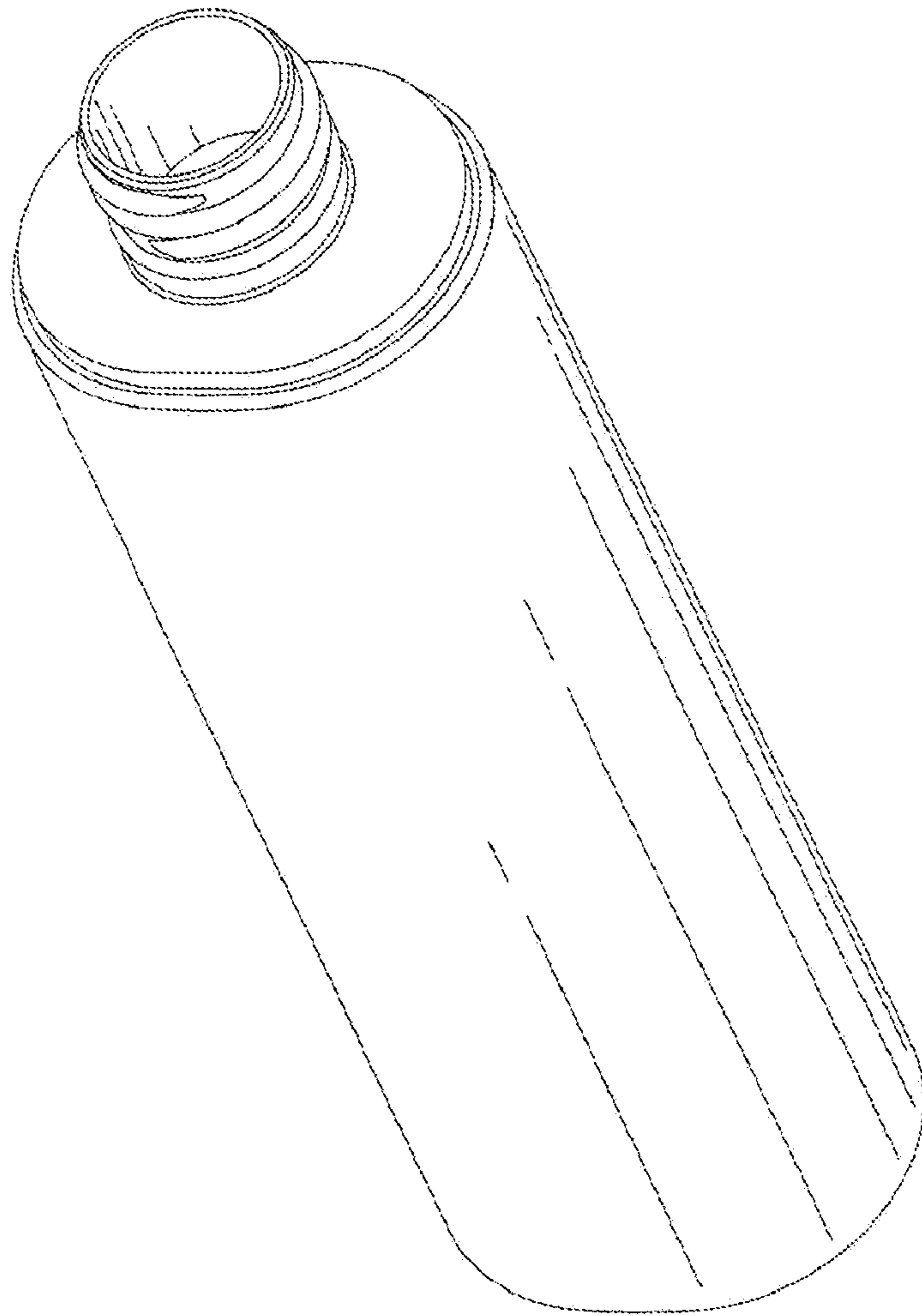

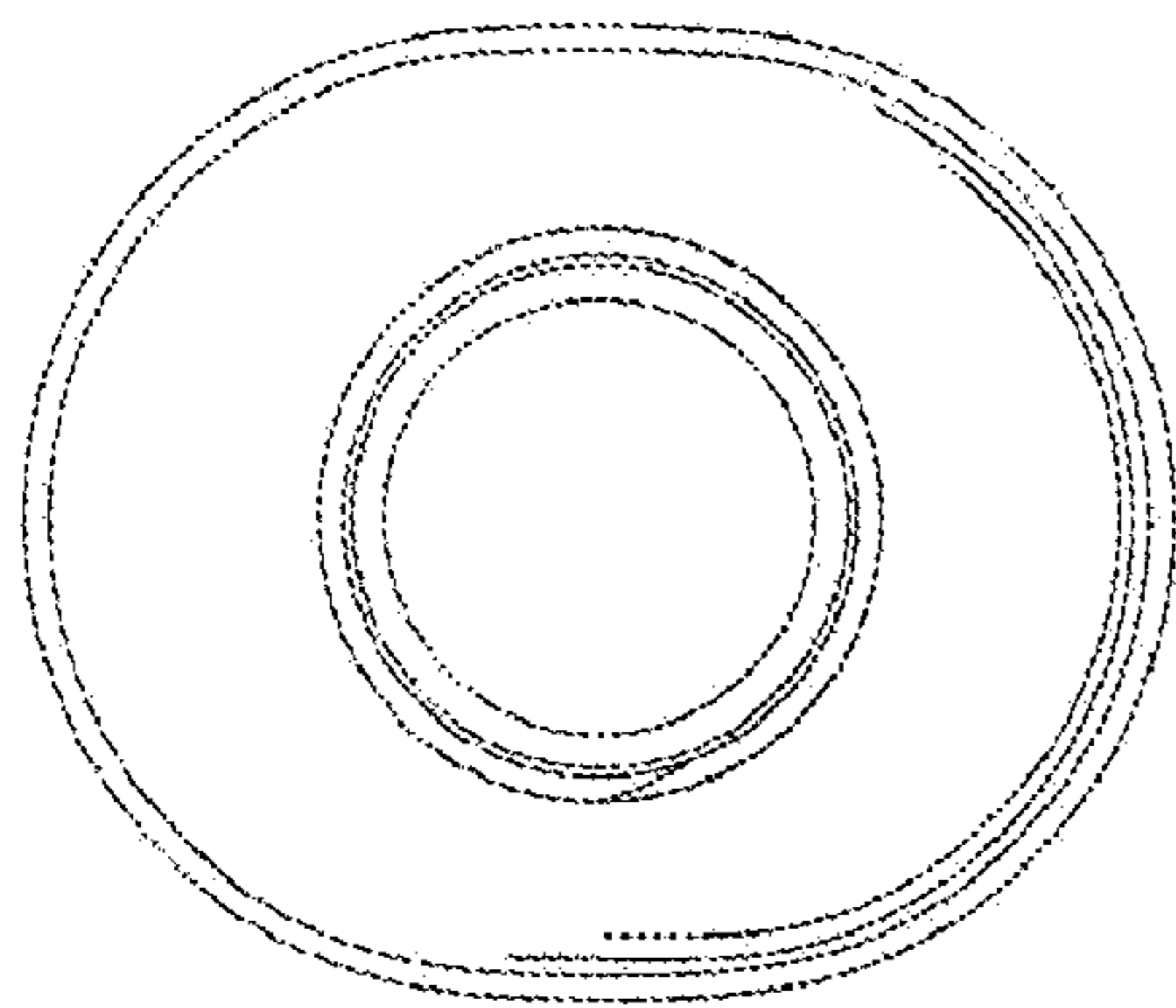

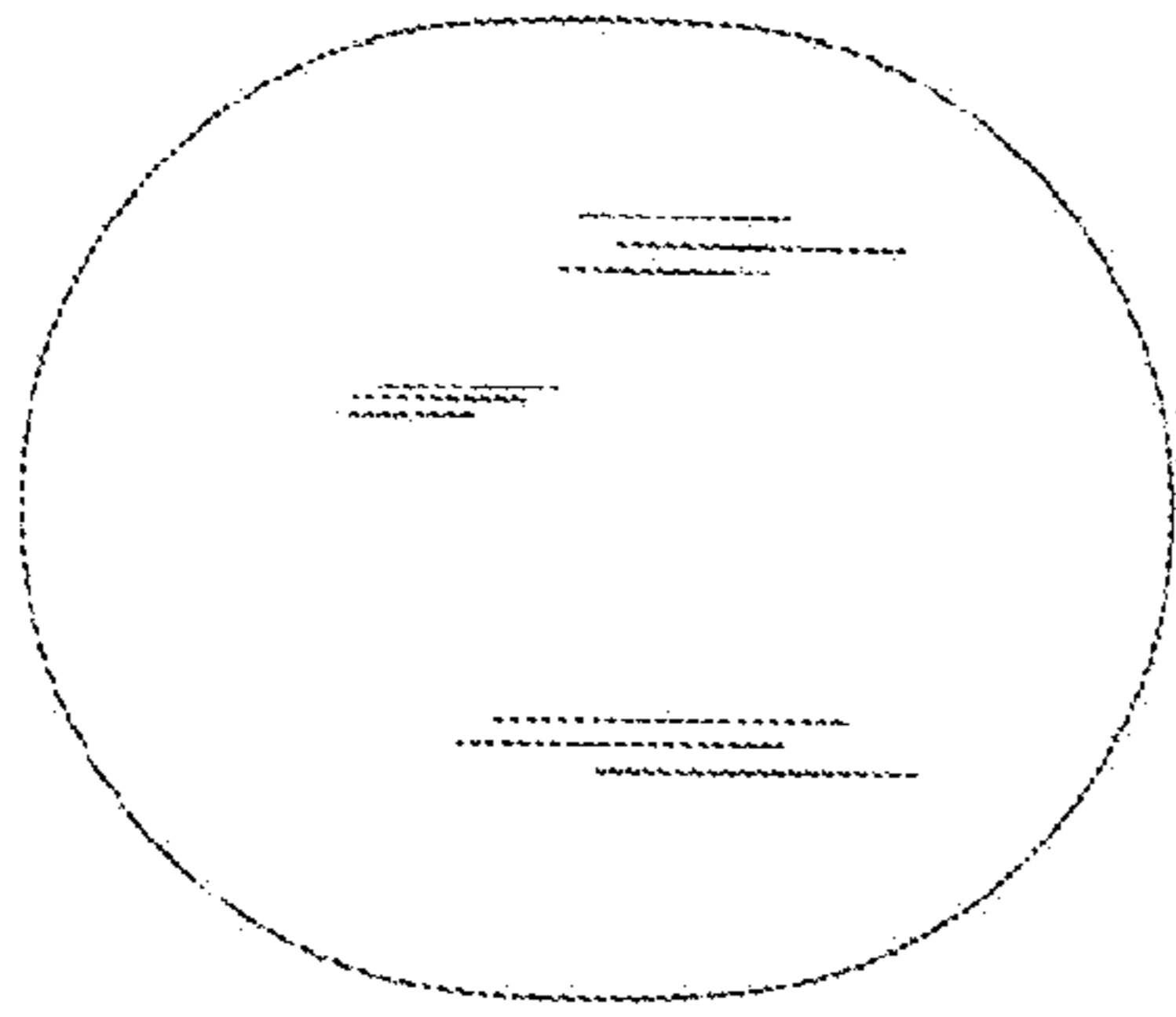

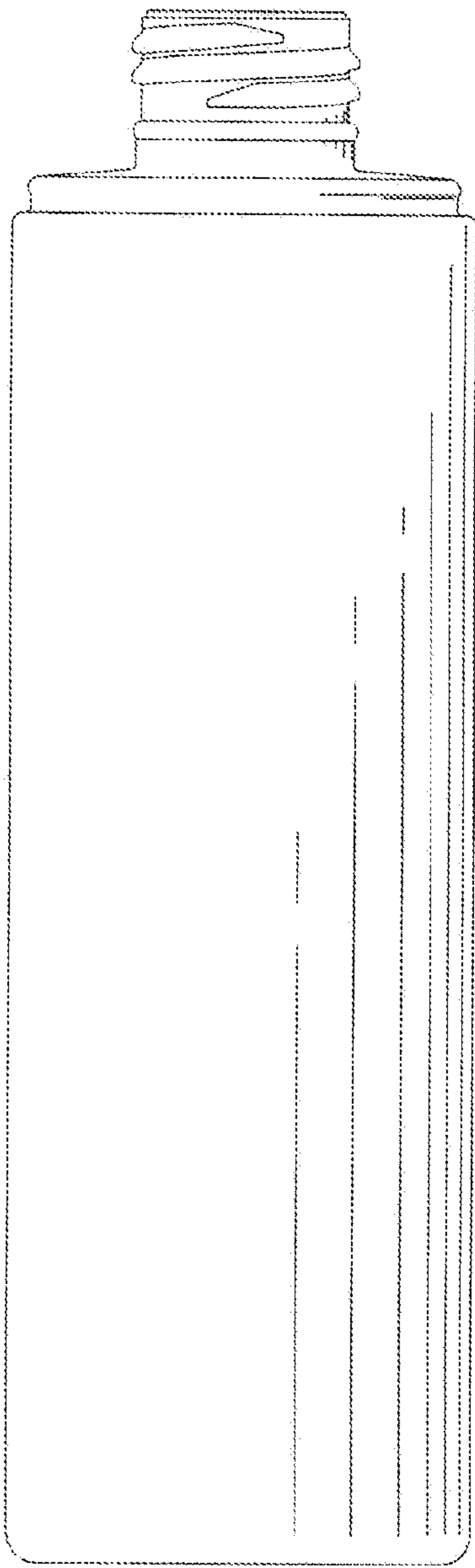

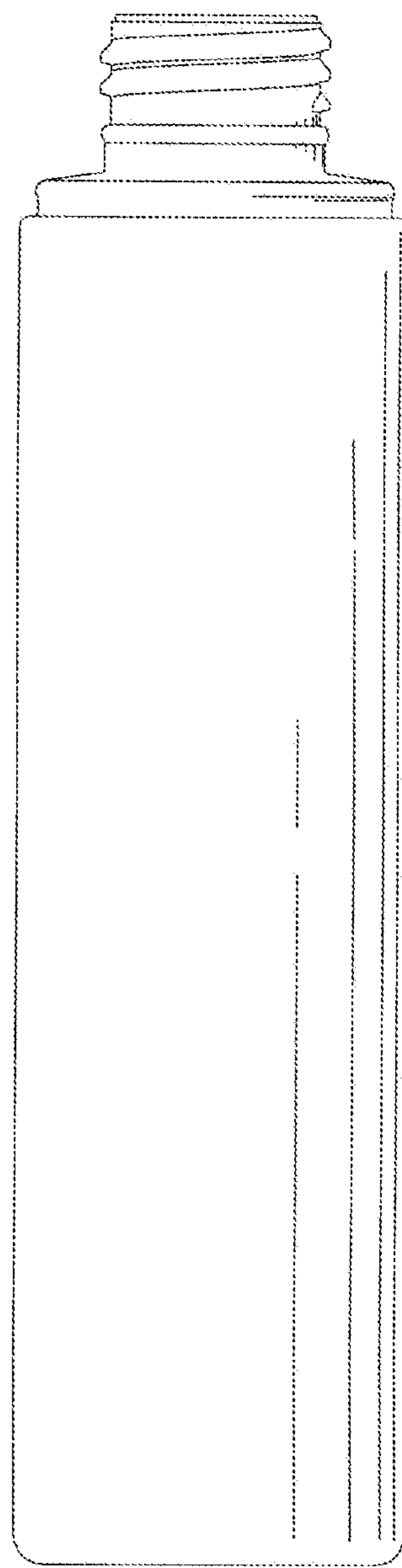

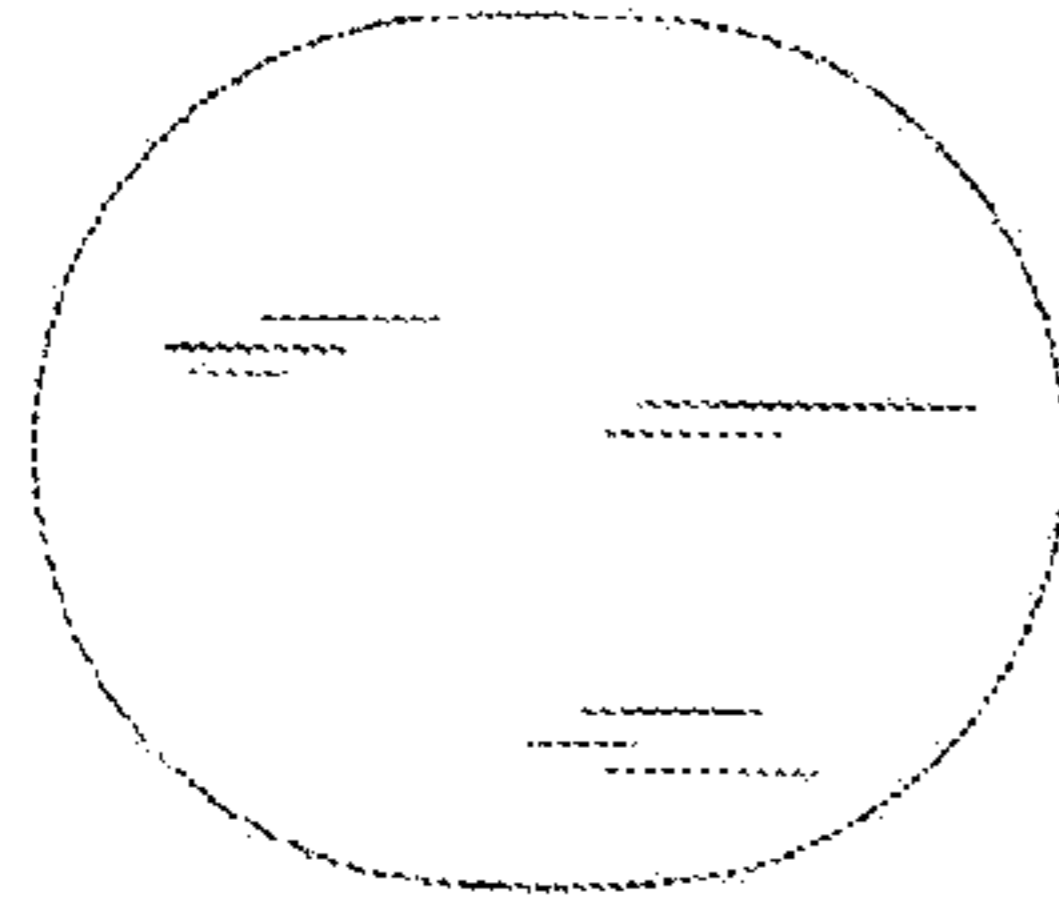

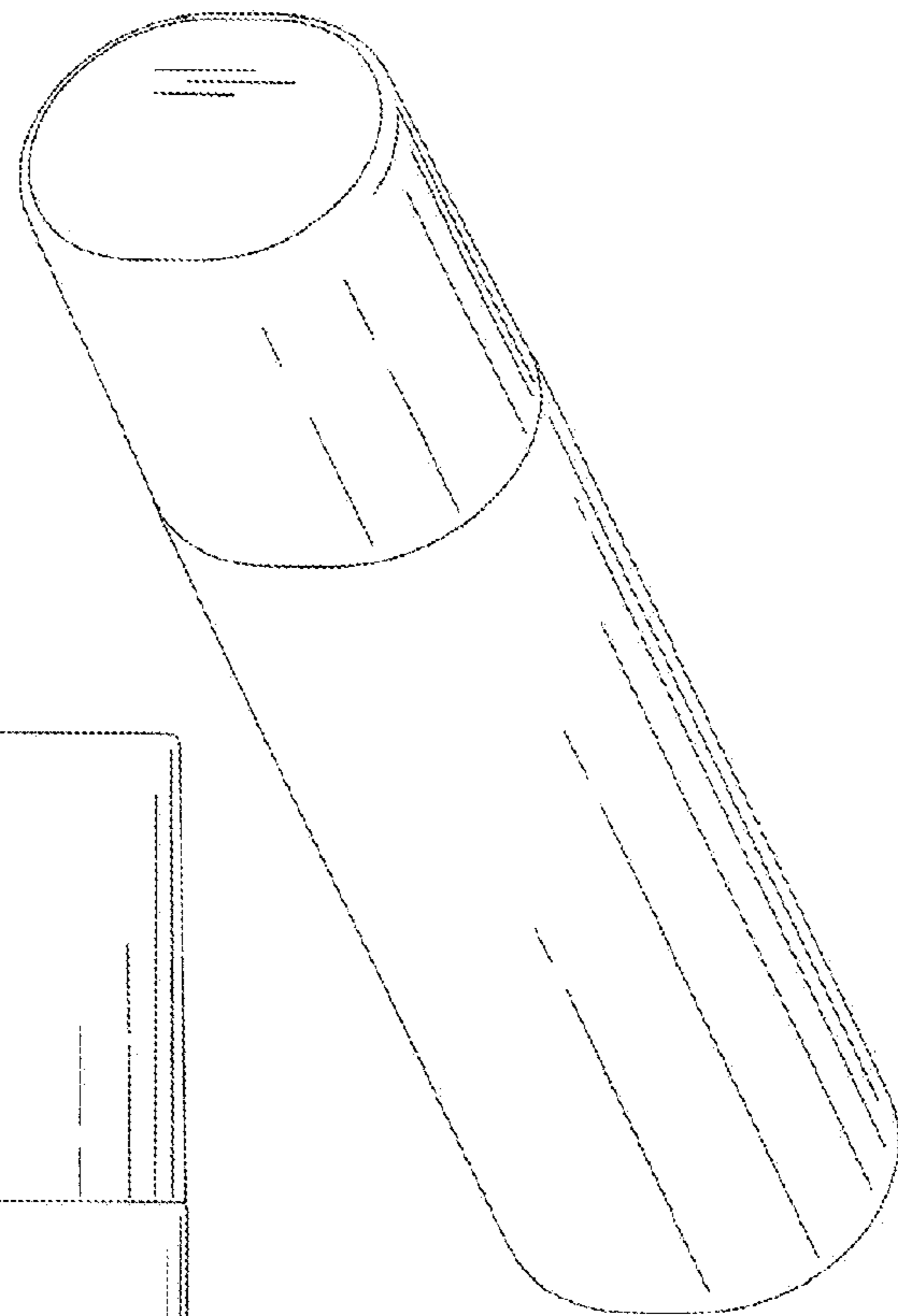

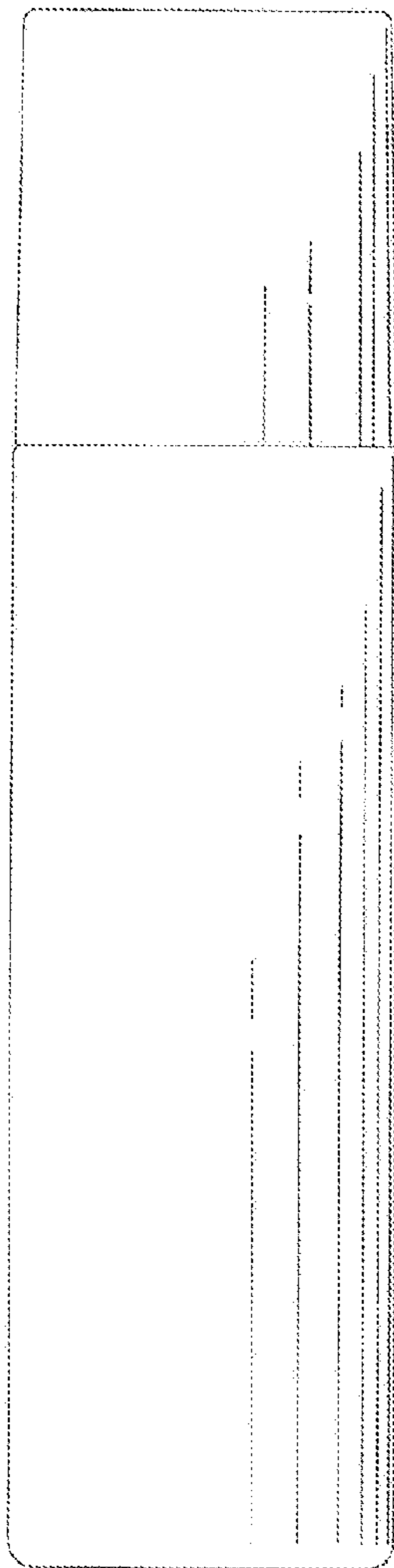

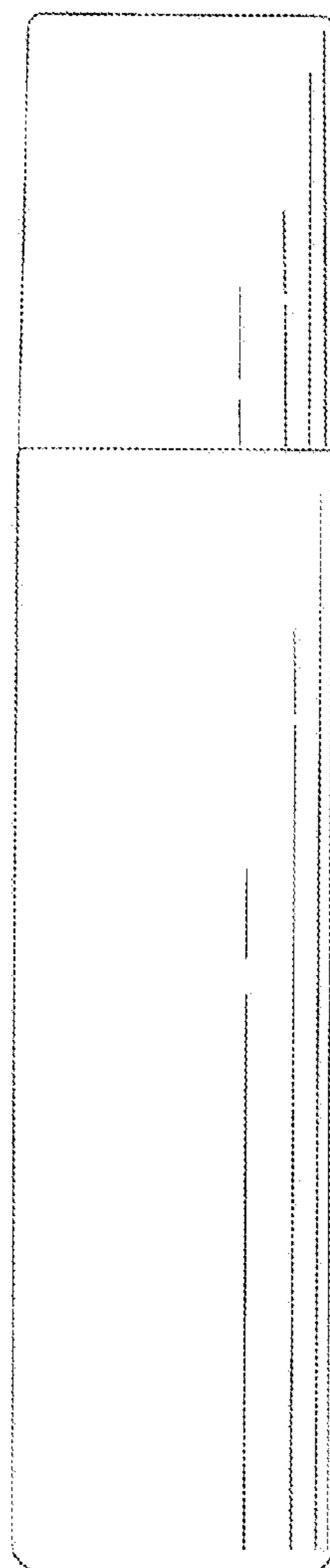

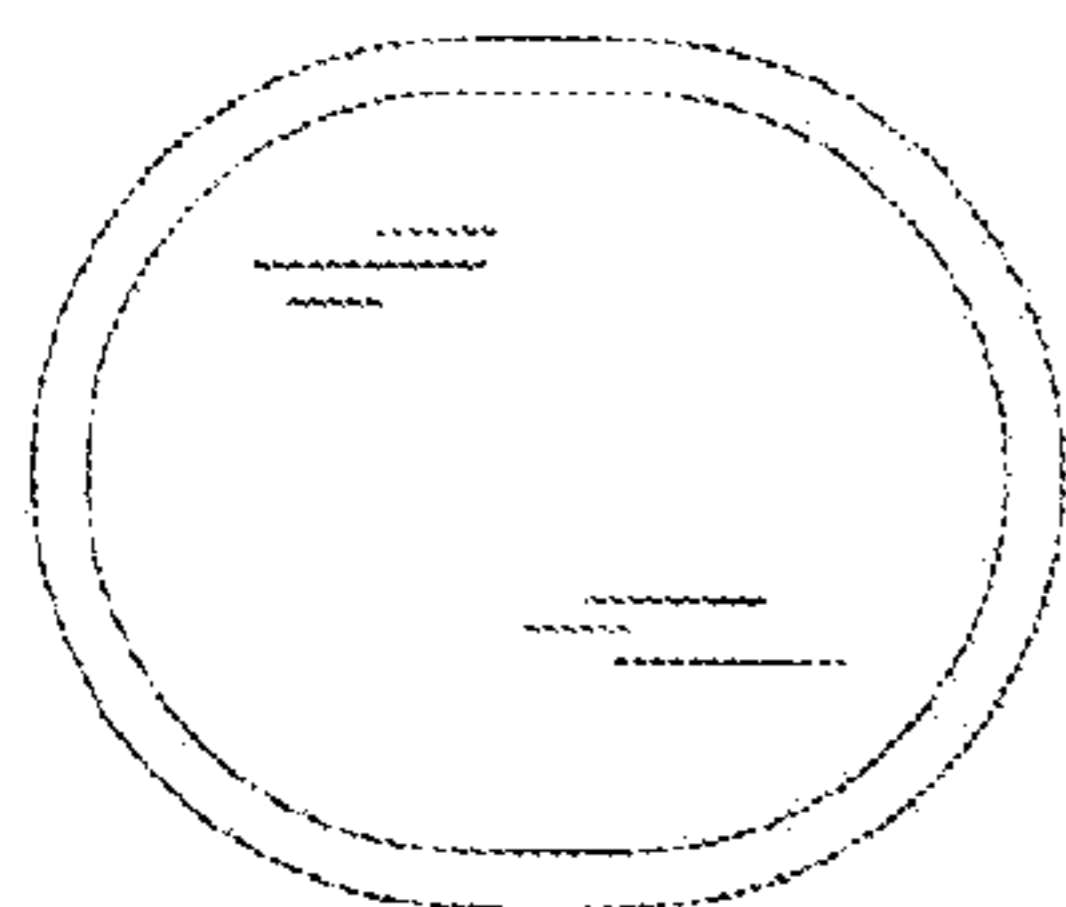
