(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the first embodiment of a bottle which embodies our design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof, the left side view thereof being a mirror image of the right side view thereof;

FIG. 5 is a top view thereof;

The bottom is unornamented;

FIG. 6 is a front perspective view of the second embodiment of a bottle which embodies our design;

FIG. 7 is a front view thereof;

FIG. 8 is a rear view thereof;

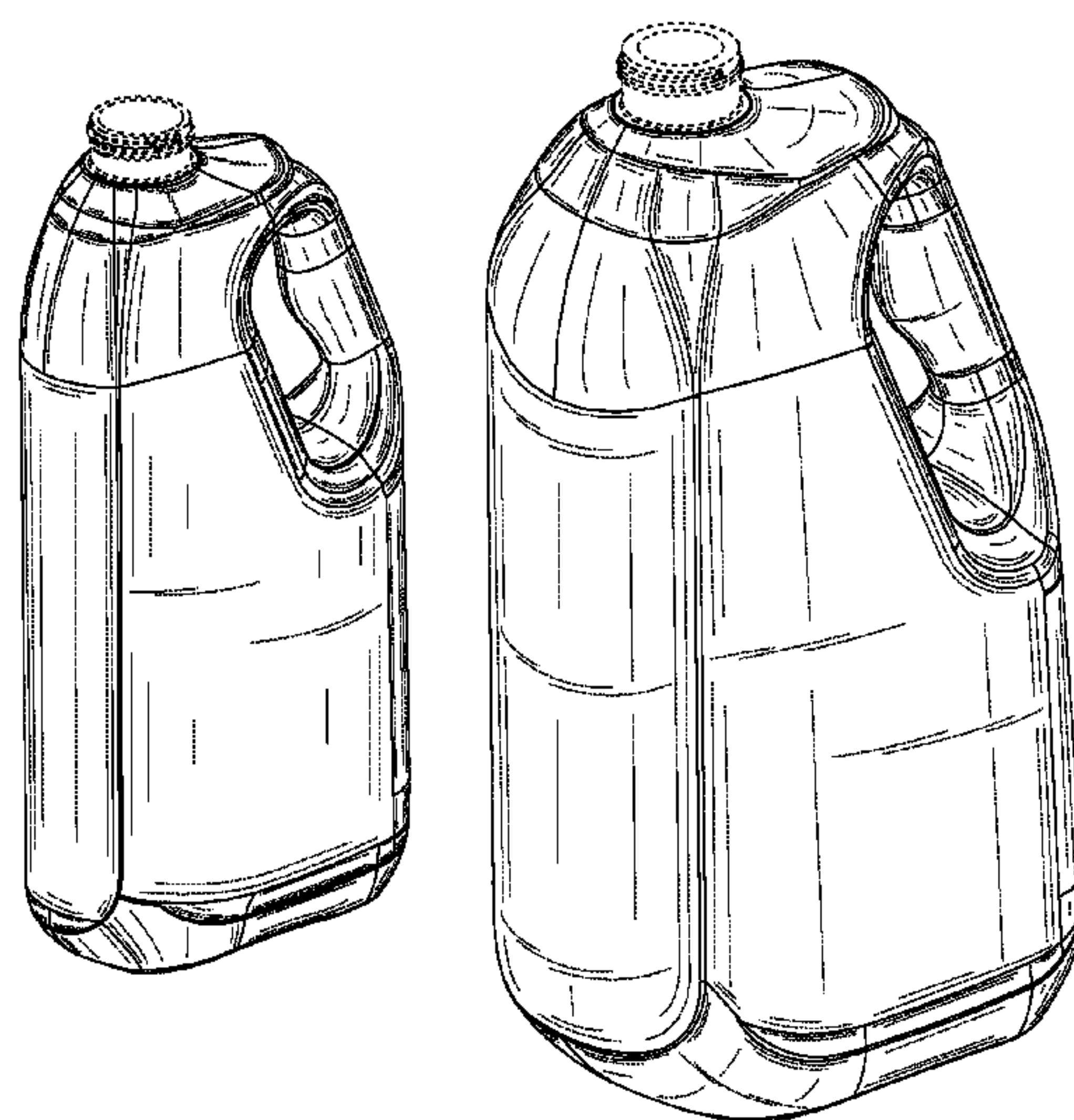
FIG. 9 is a right side view thereof, the left side view thereof being a mirror image of the right side view thereof; and,

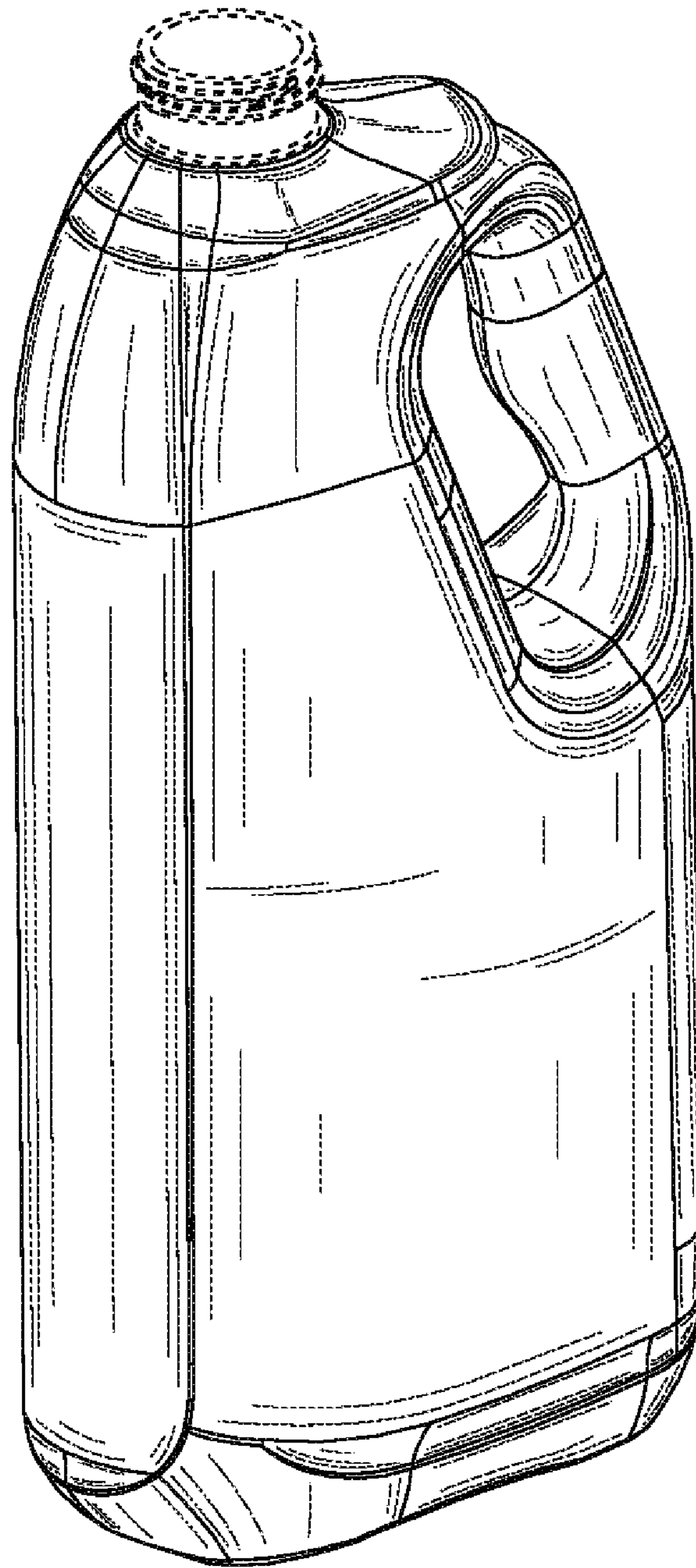

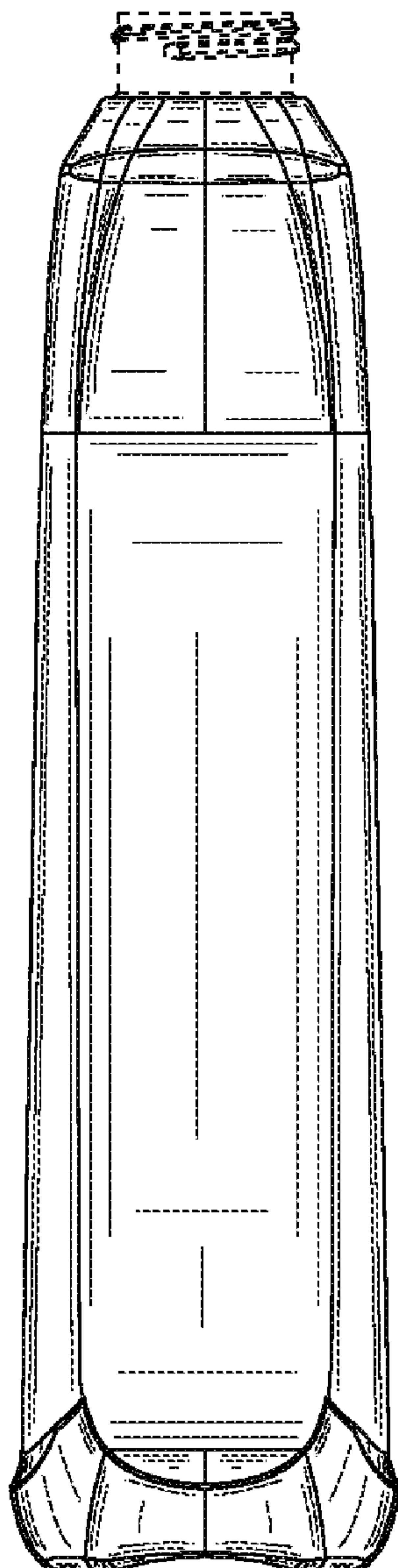

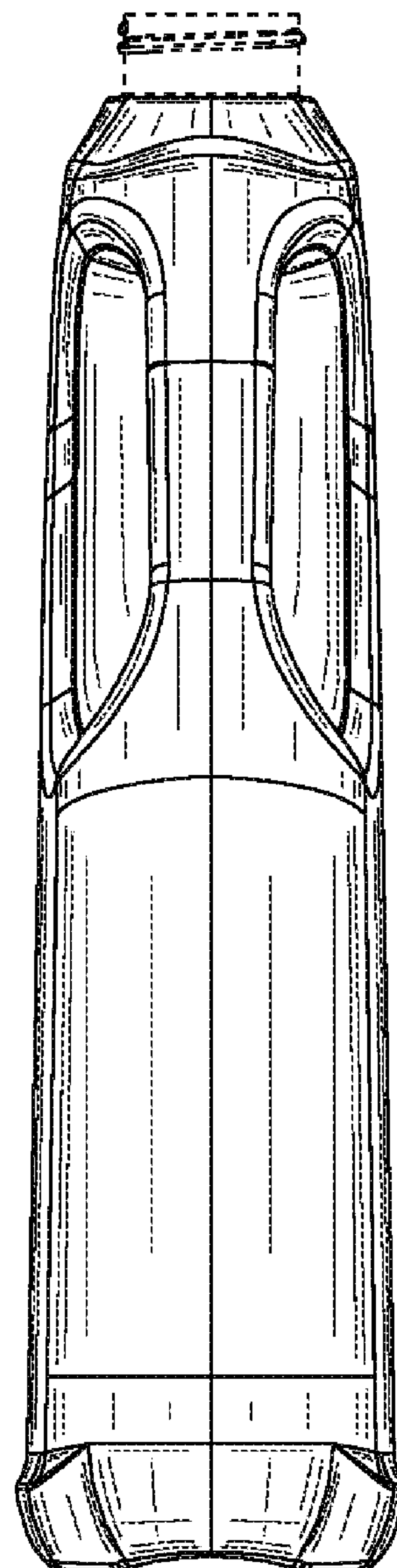

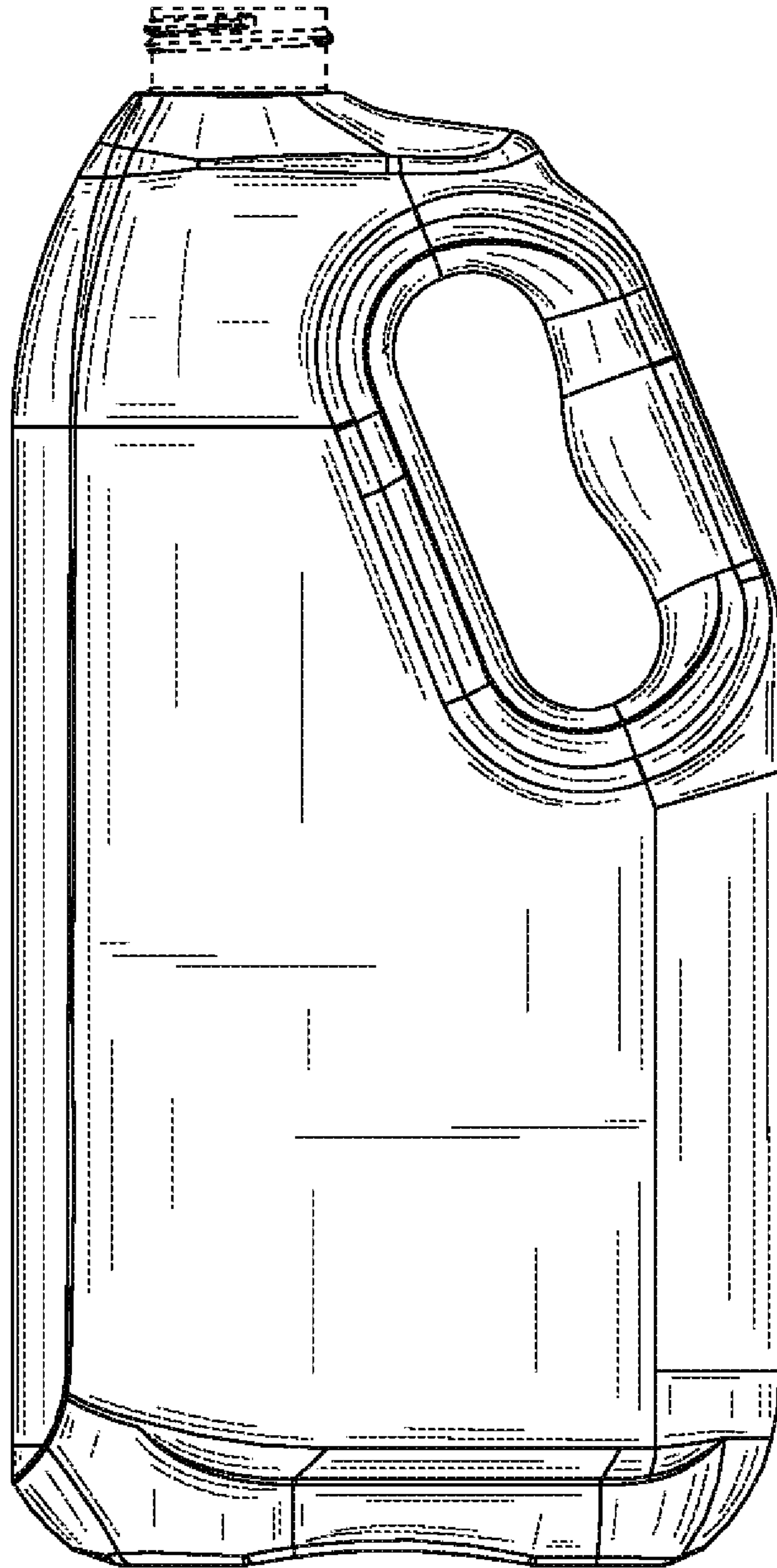

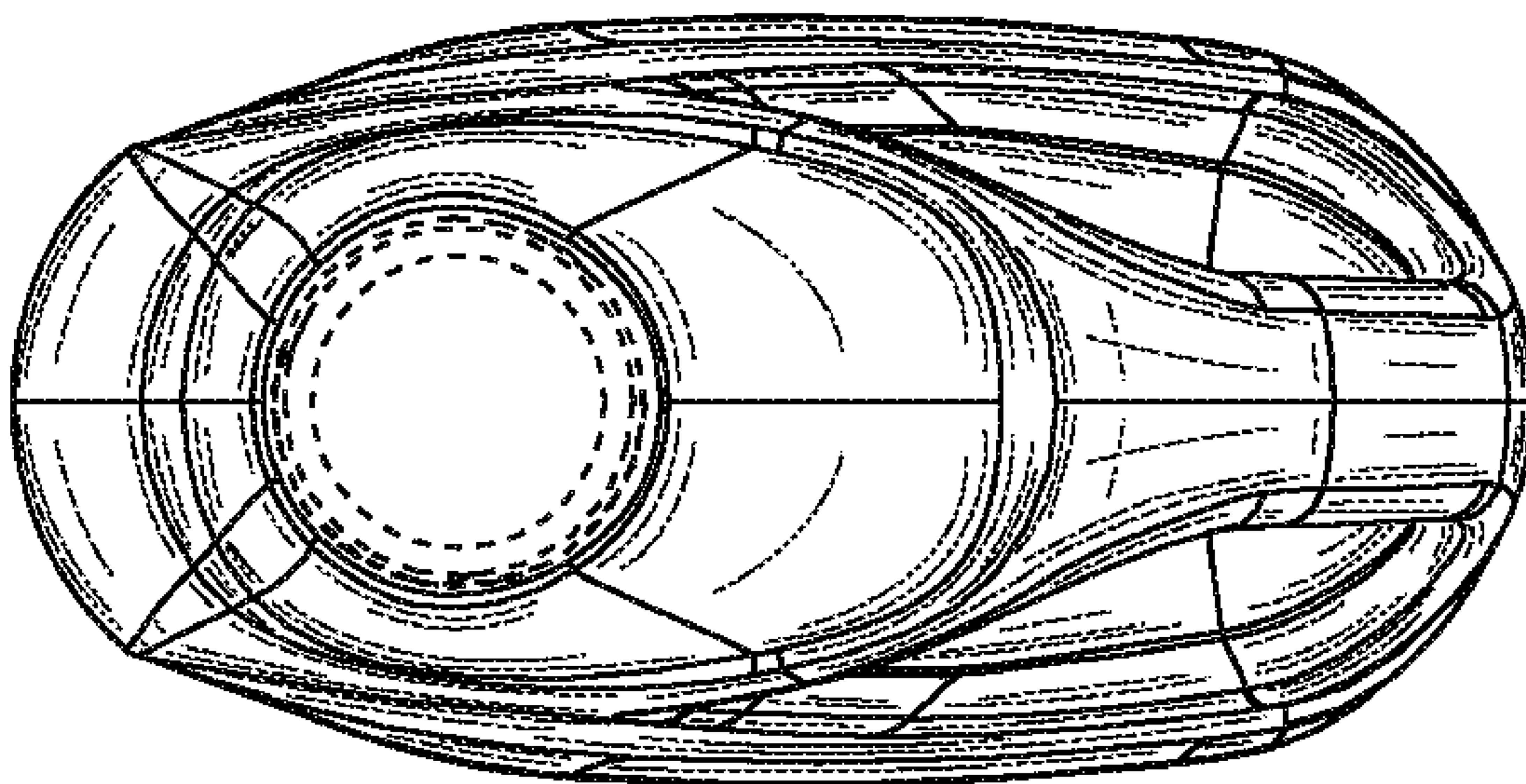

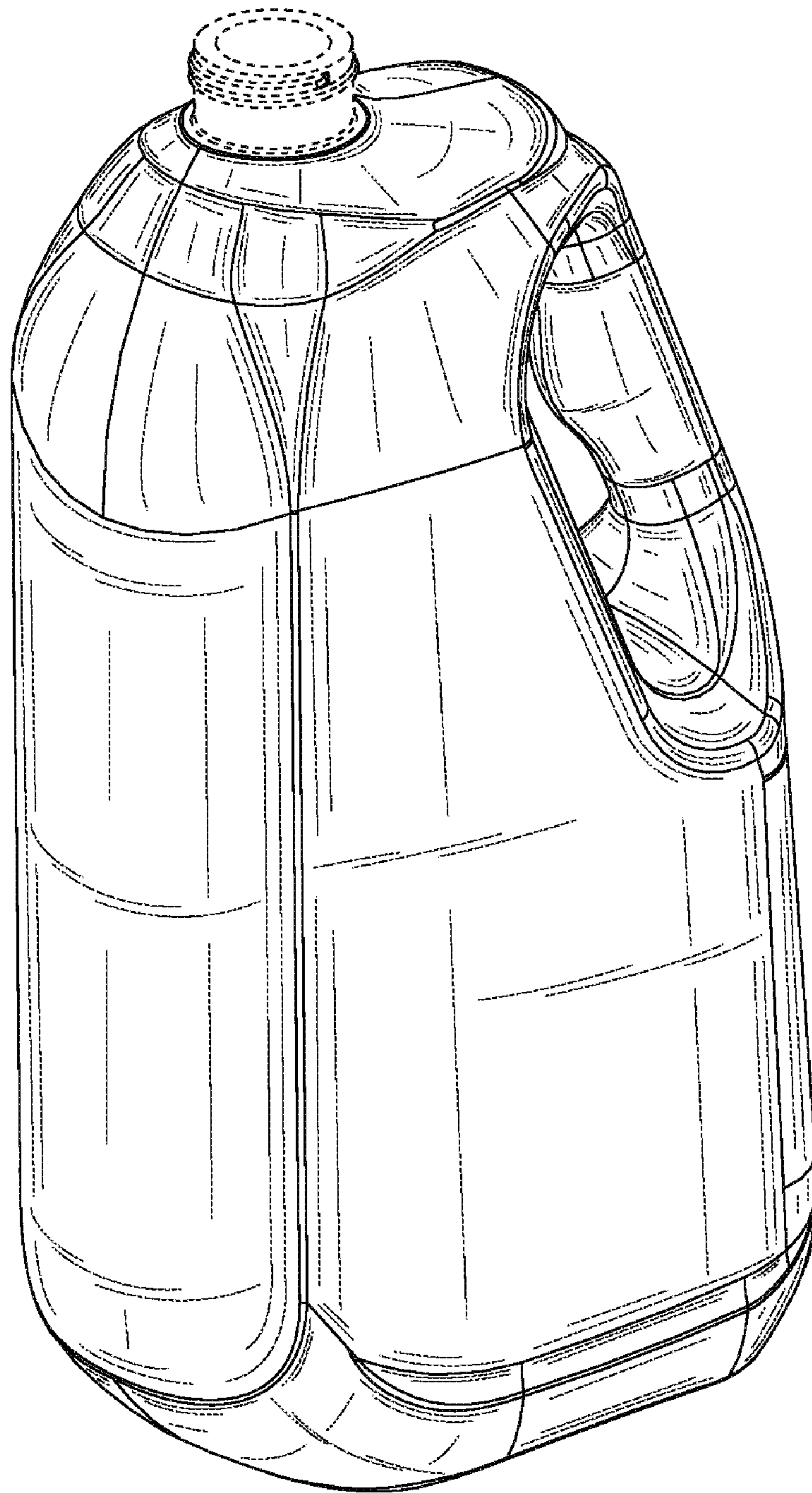

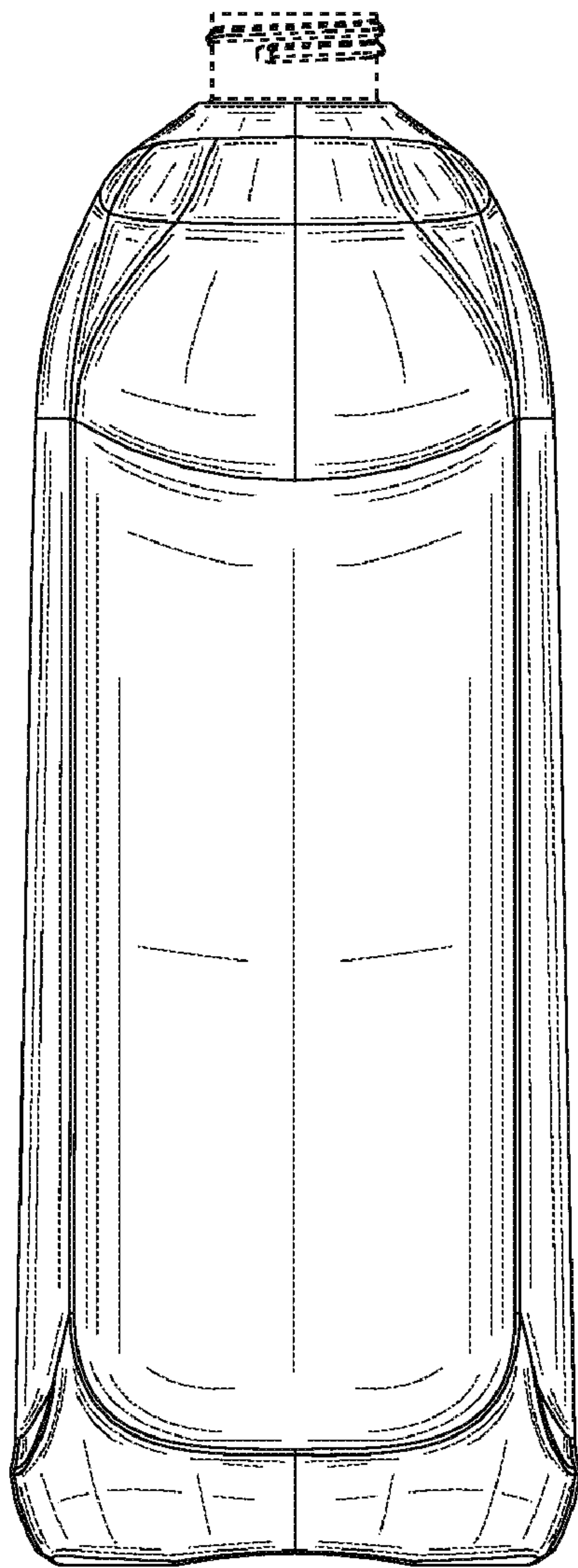

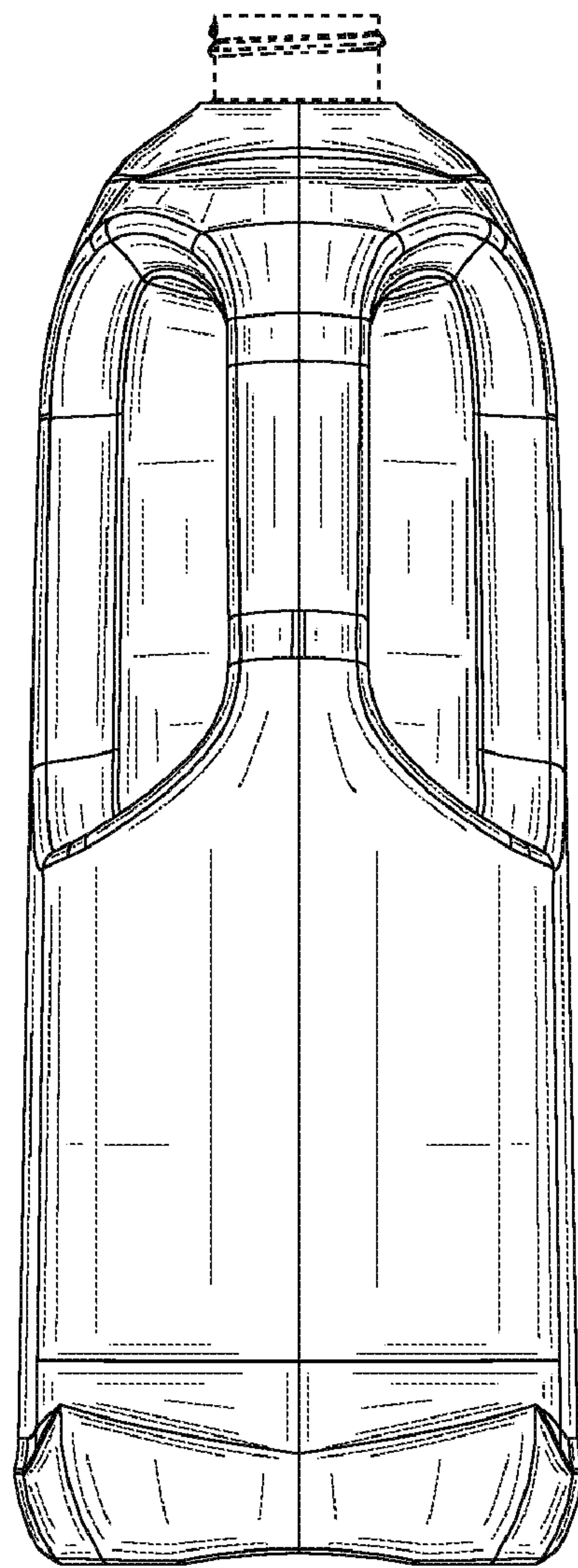

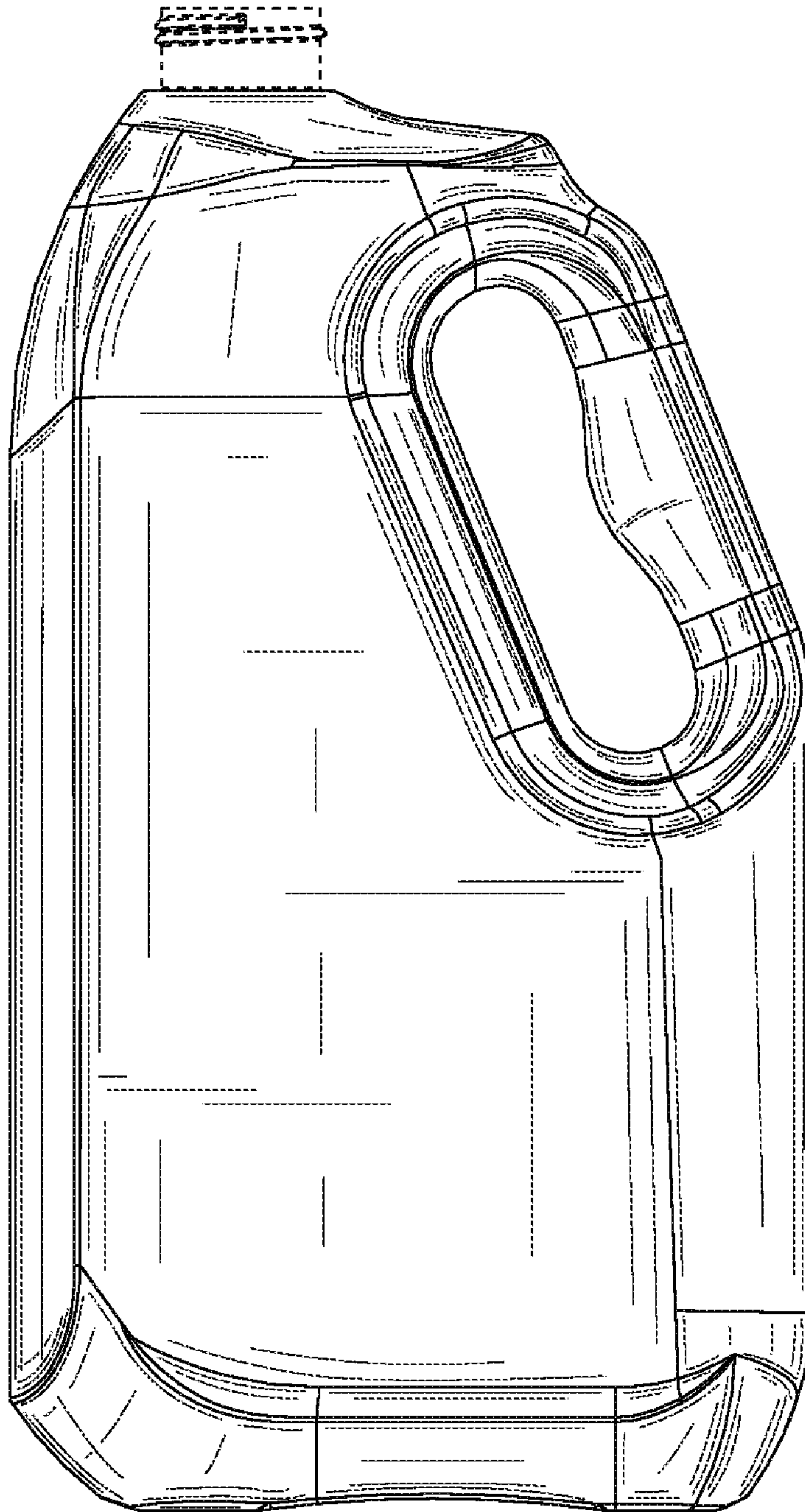

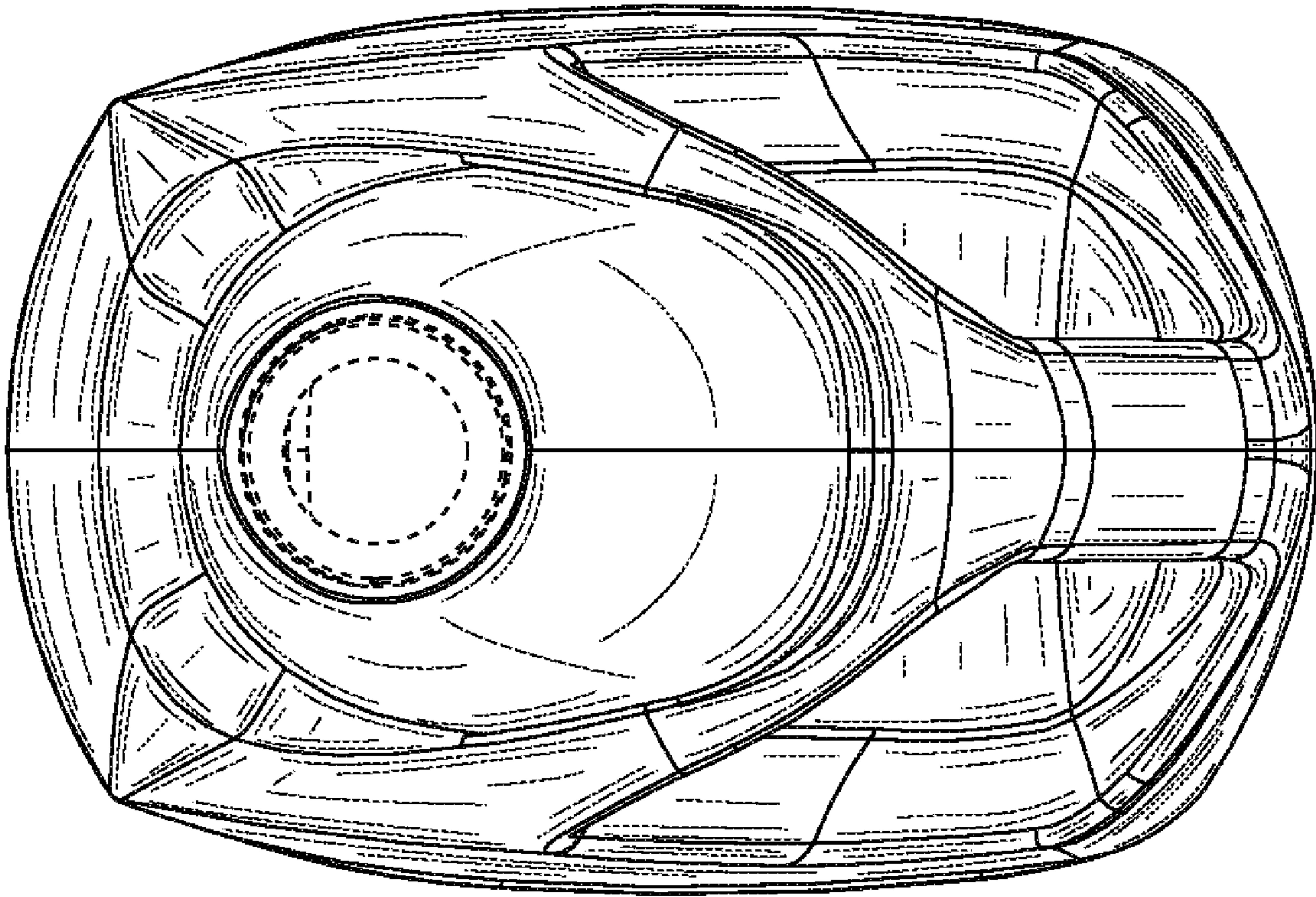
