FIG. 1 is a perspective view of an antiseptic solution bottle, showing our new design;

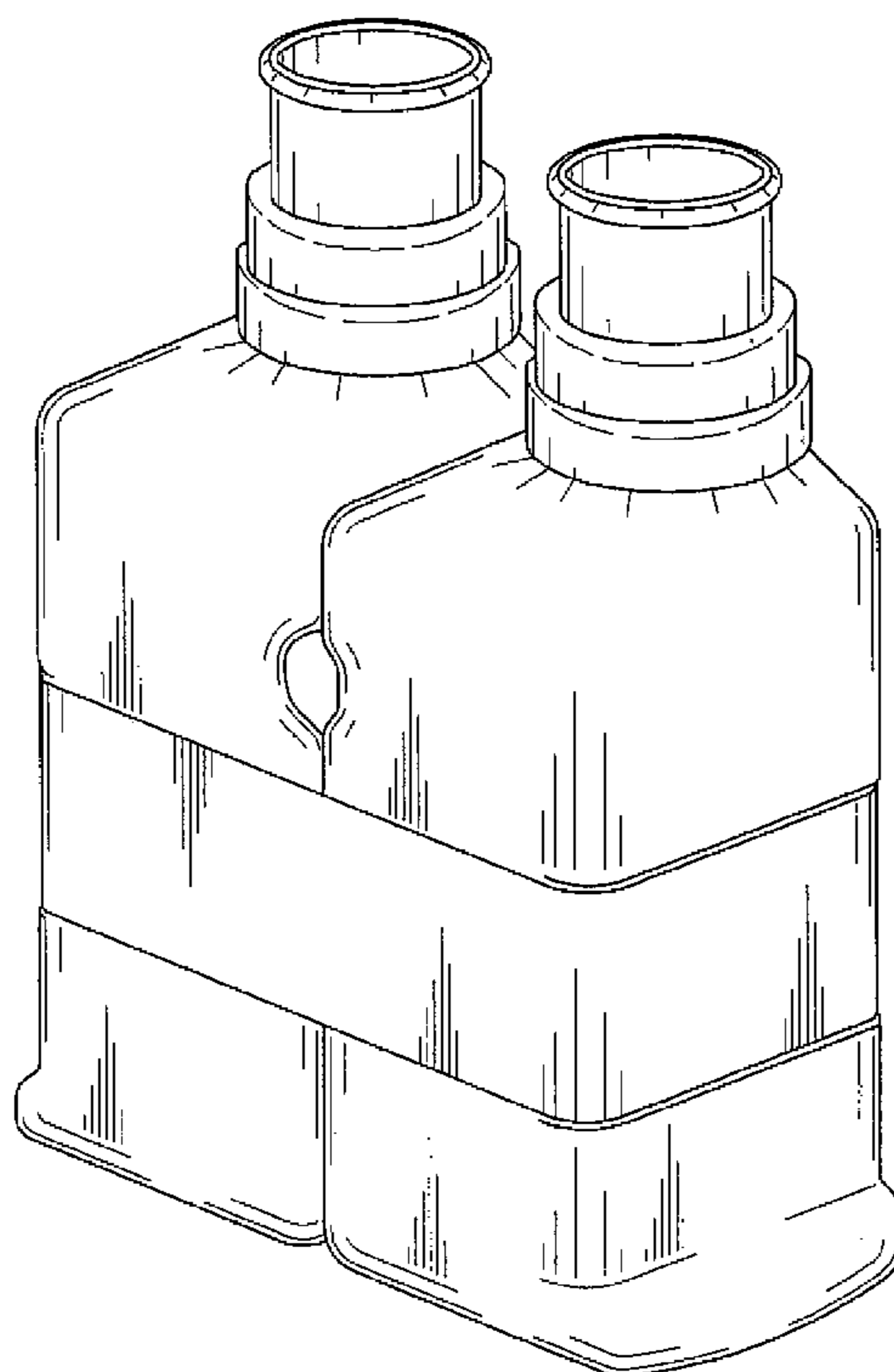
FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof;

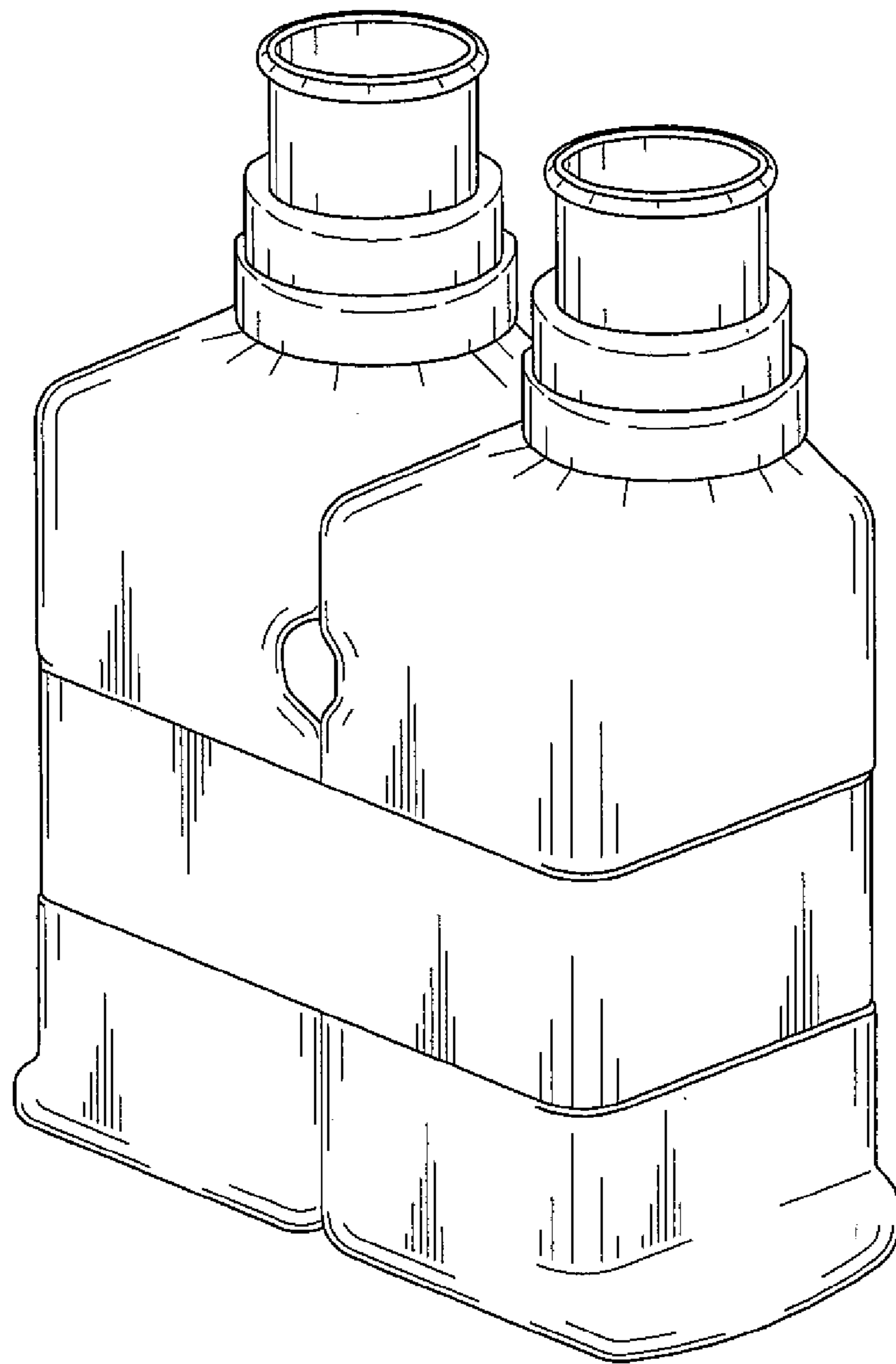

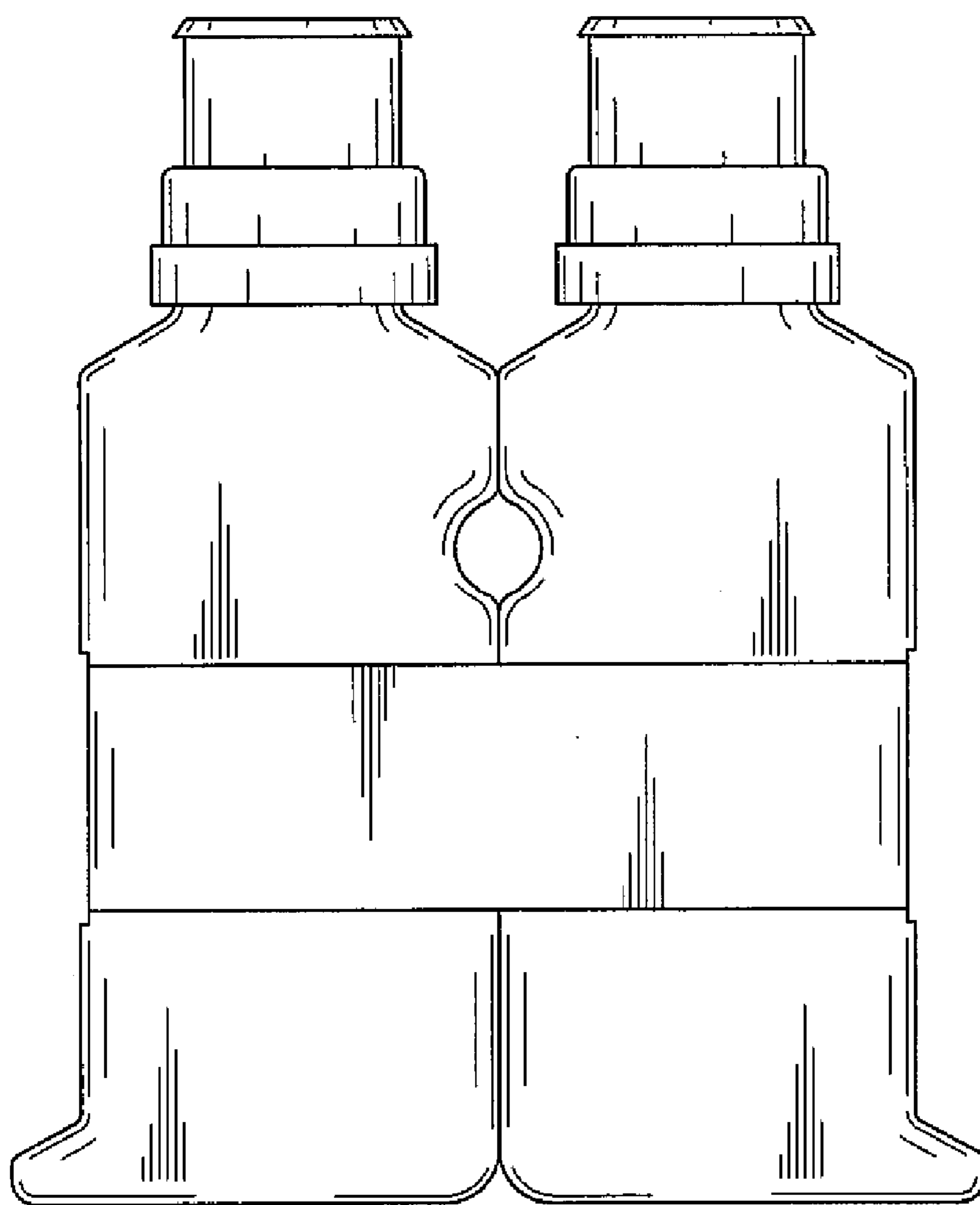

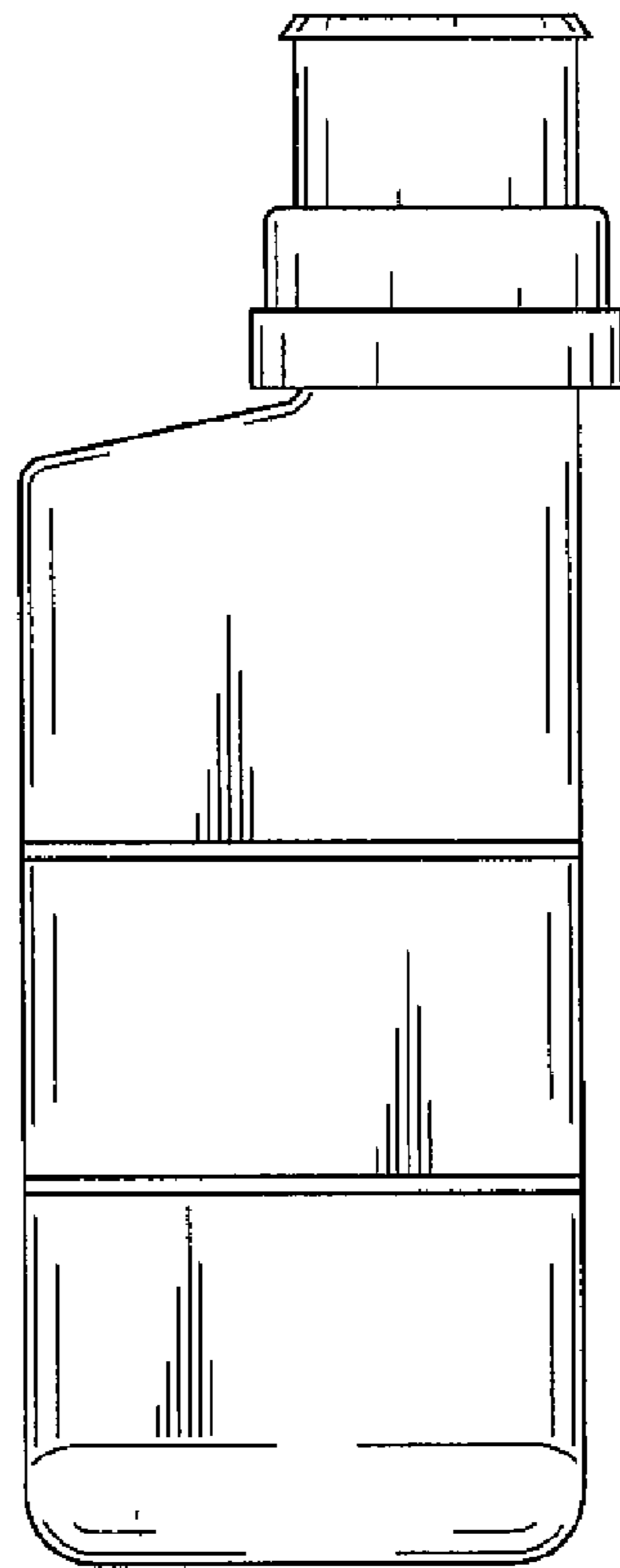

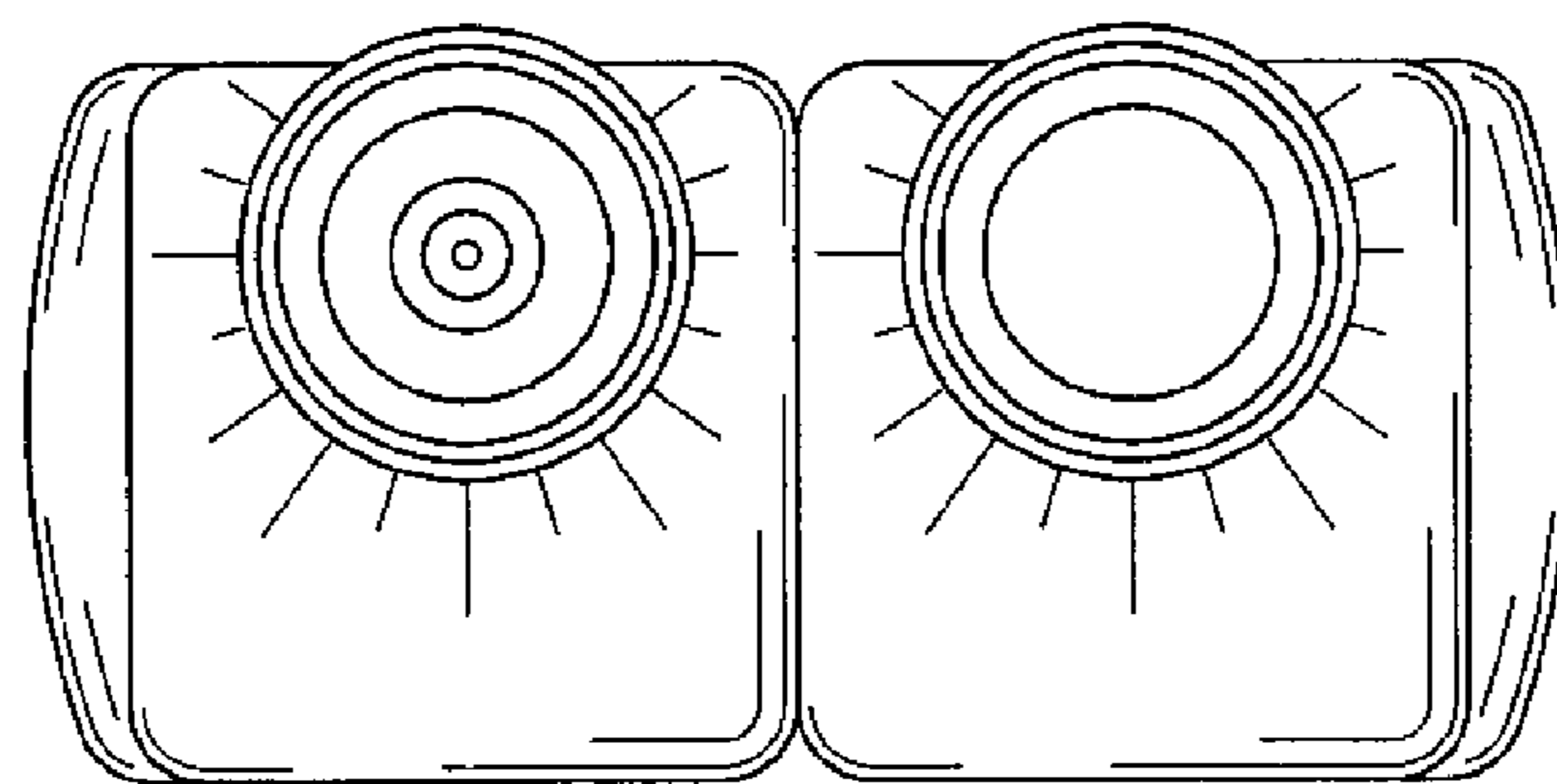

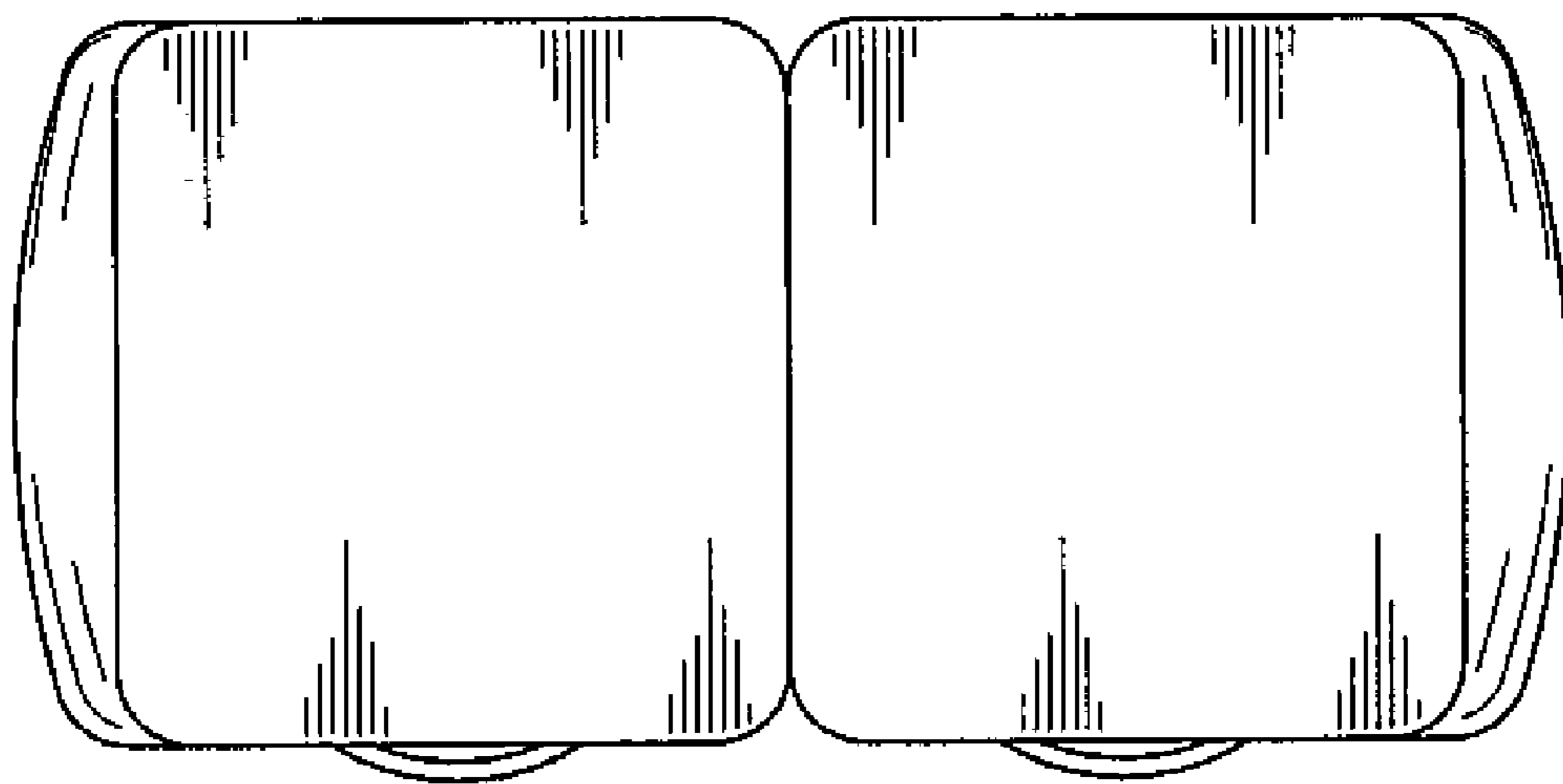
