FIG. 7 is plan view rotated 45° counter-clockwise from FIG. 6 thereof;

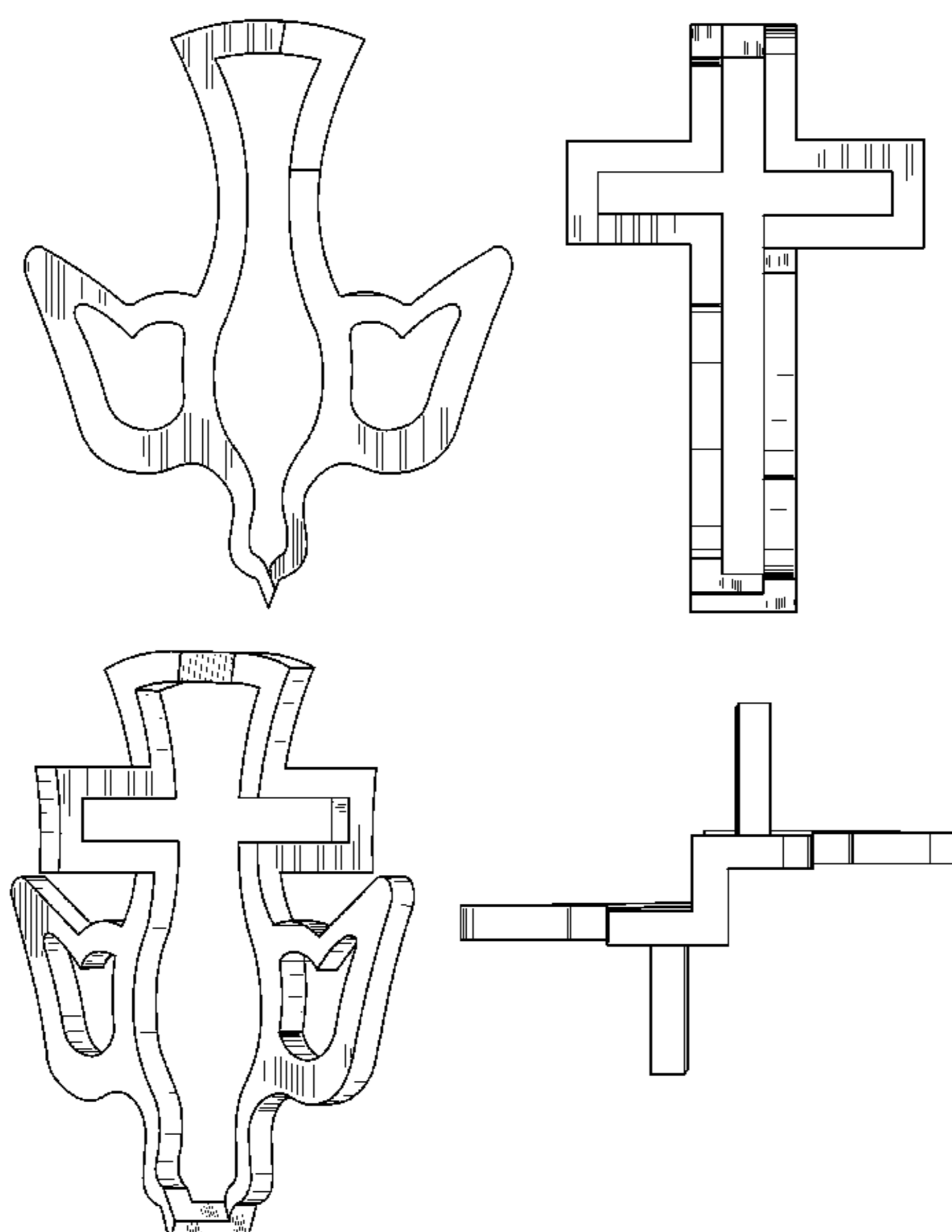
FIG. 8 is plan view rotated 45° counter-clockwise from FIG. 7 thereof;

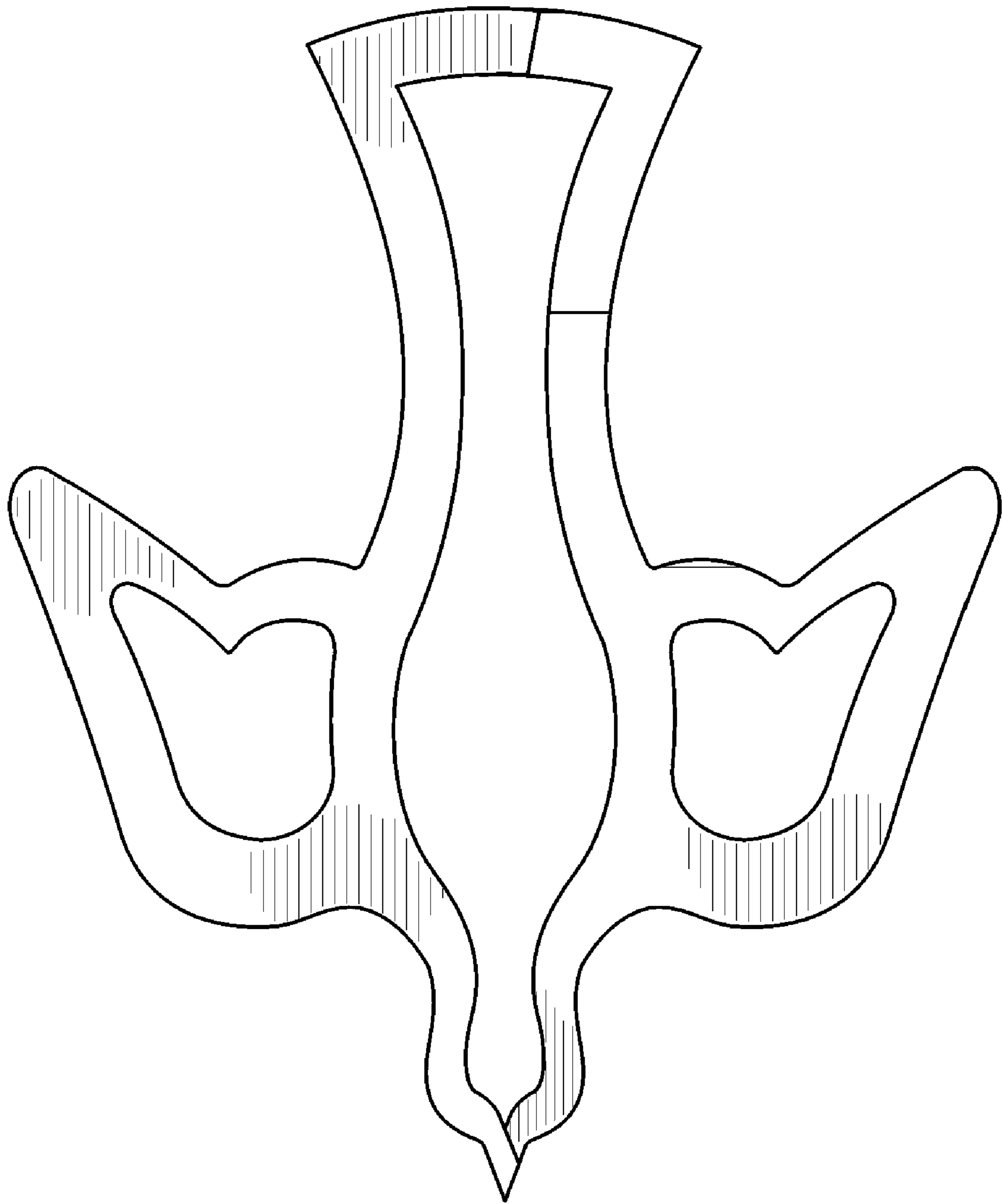
FIG. 9 is a top view thereof; and,

FIG. 10 is a bottom view thereof.

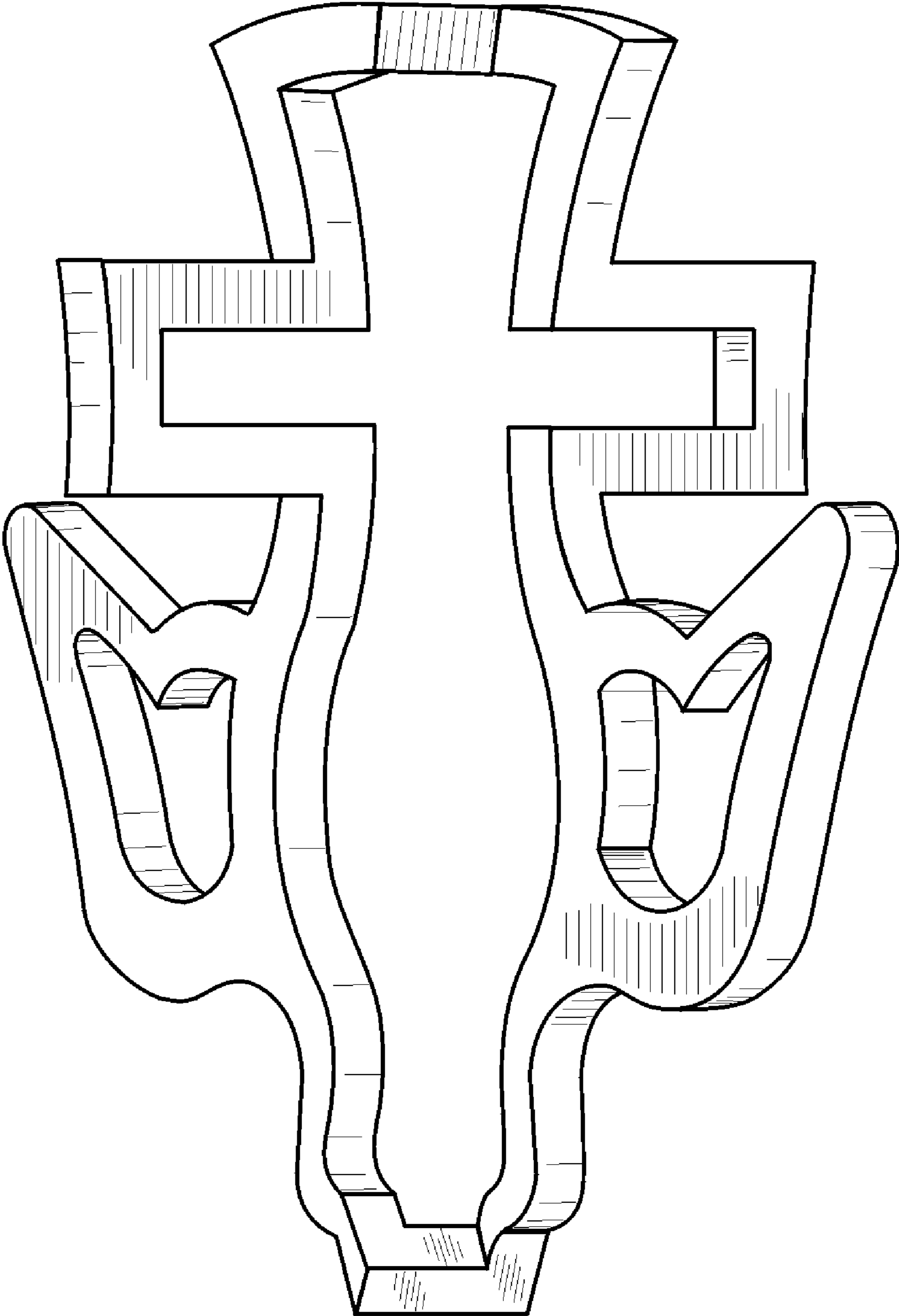

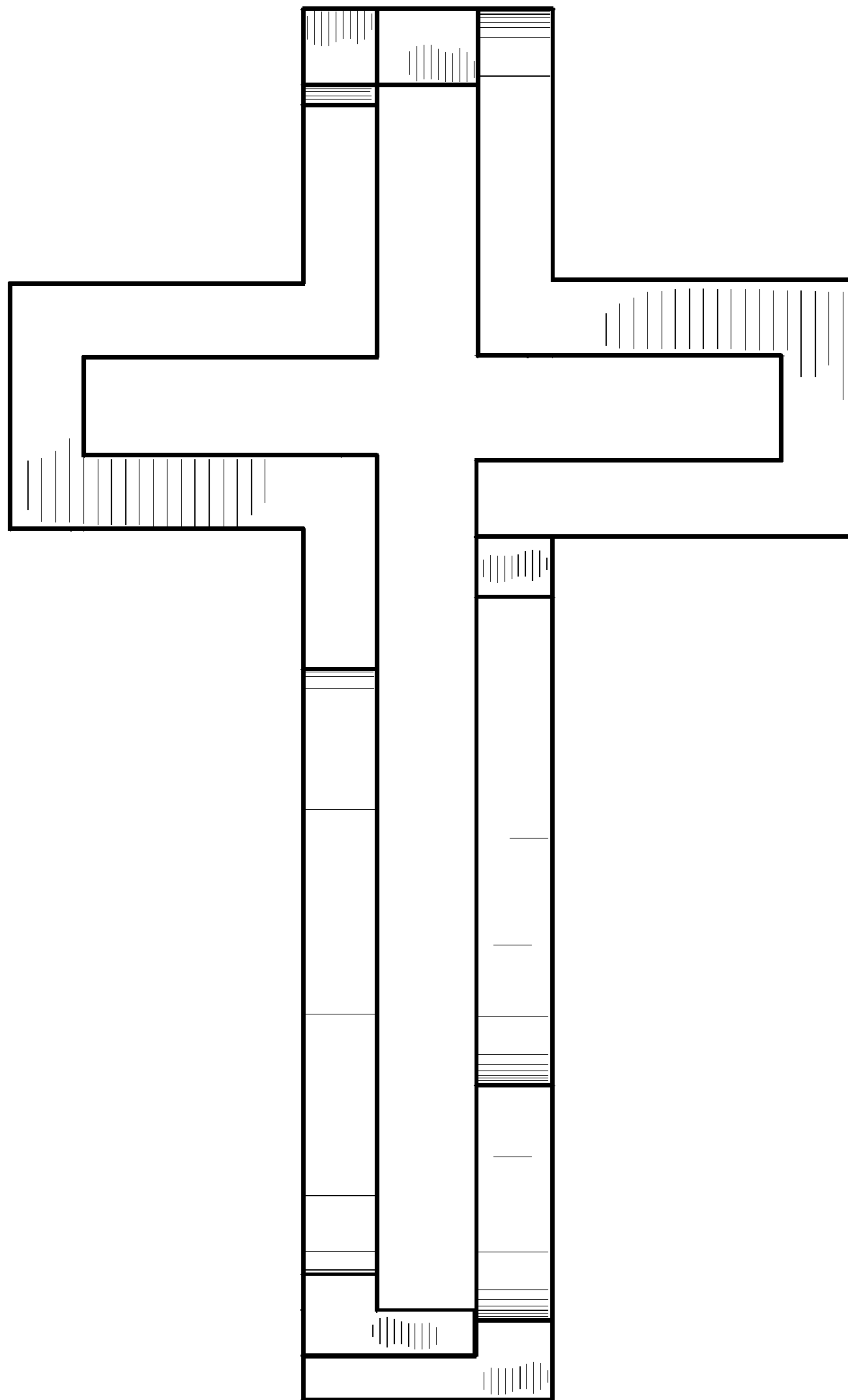




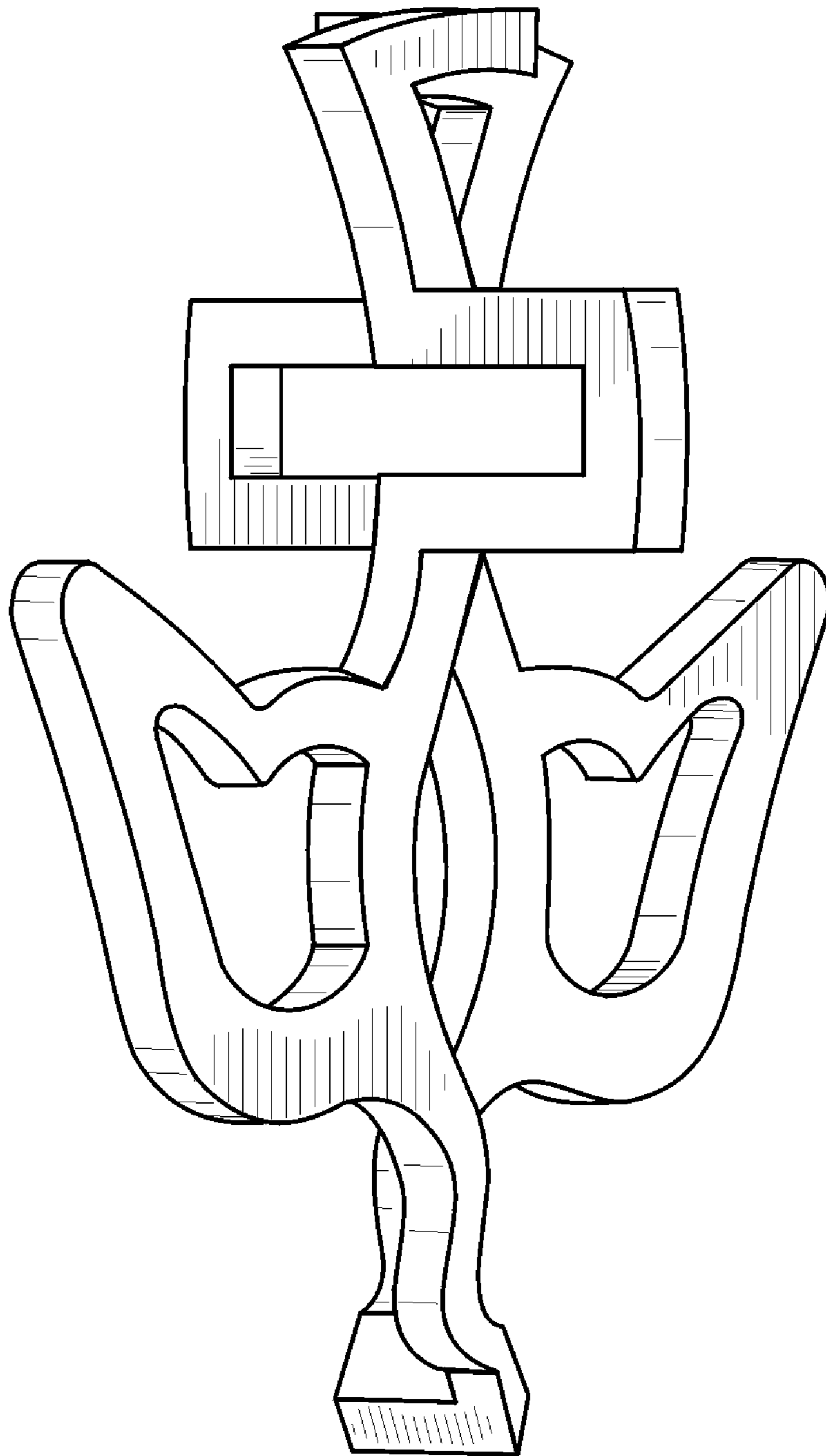

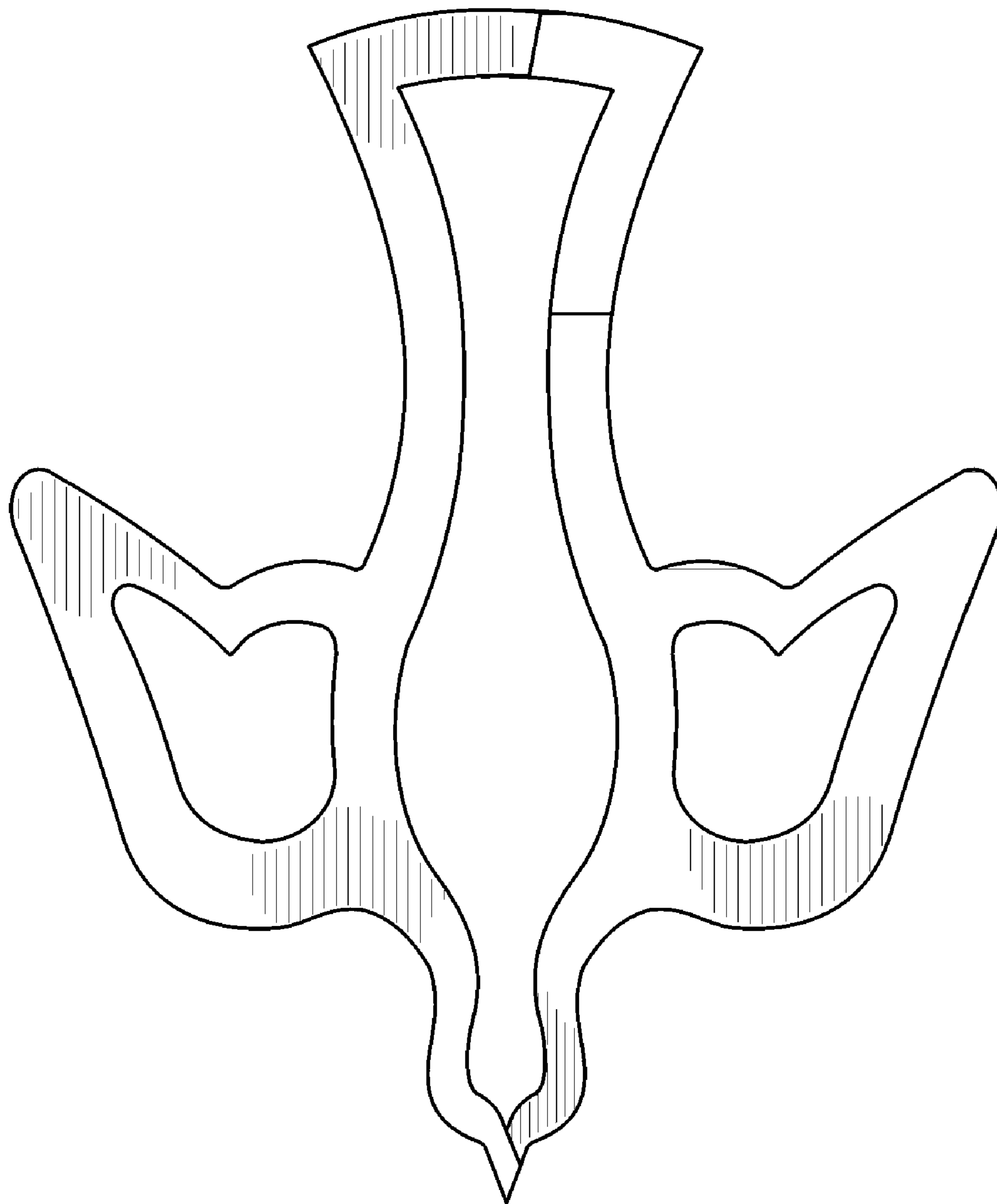

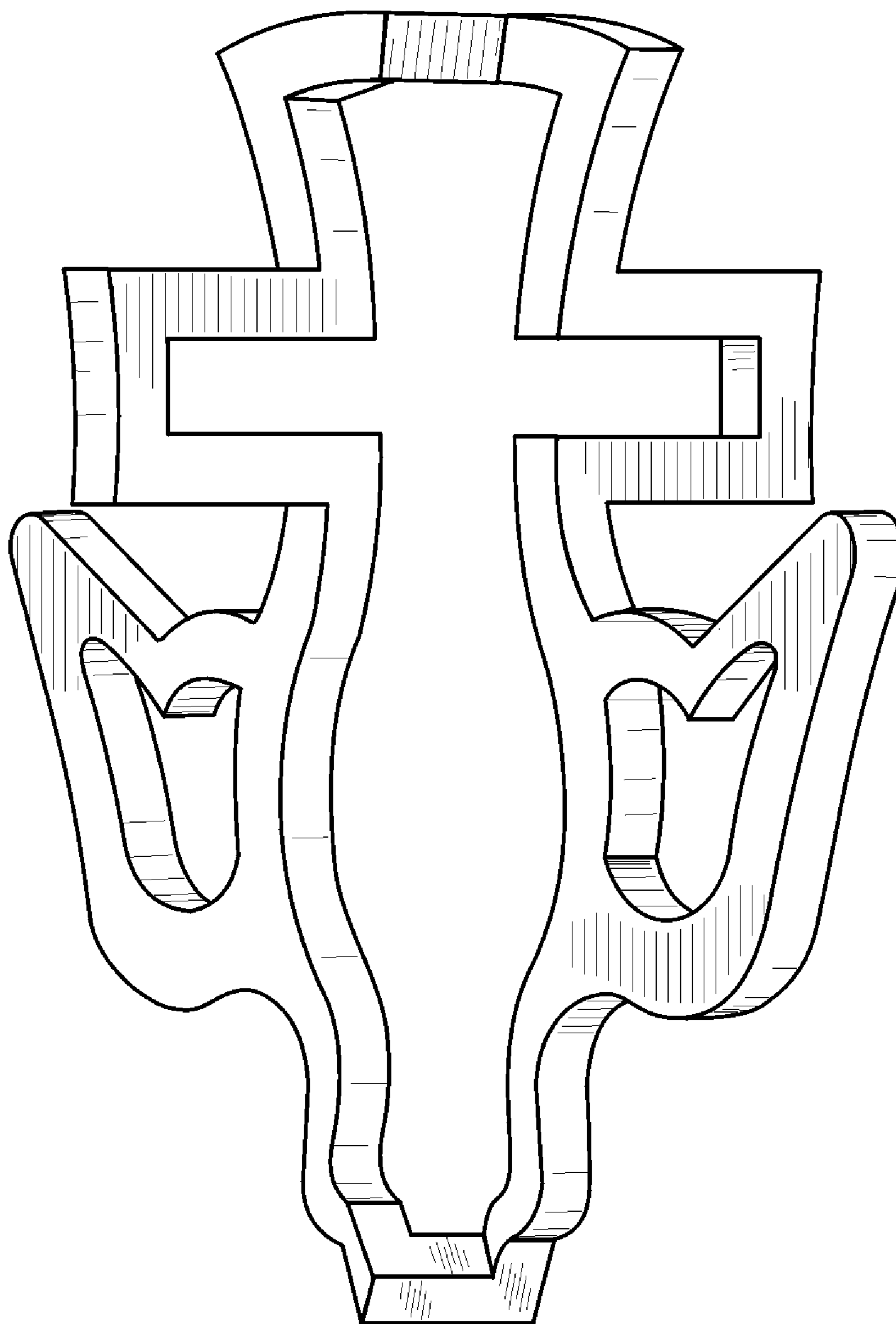

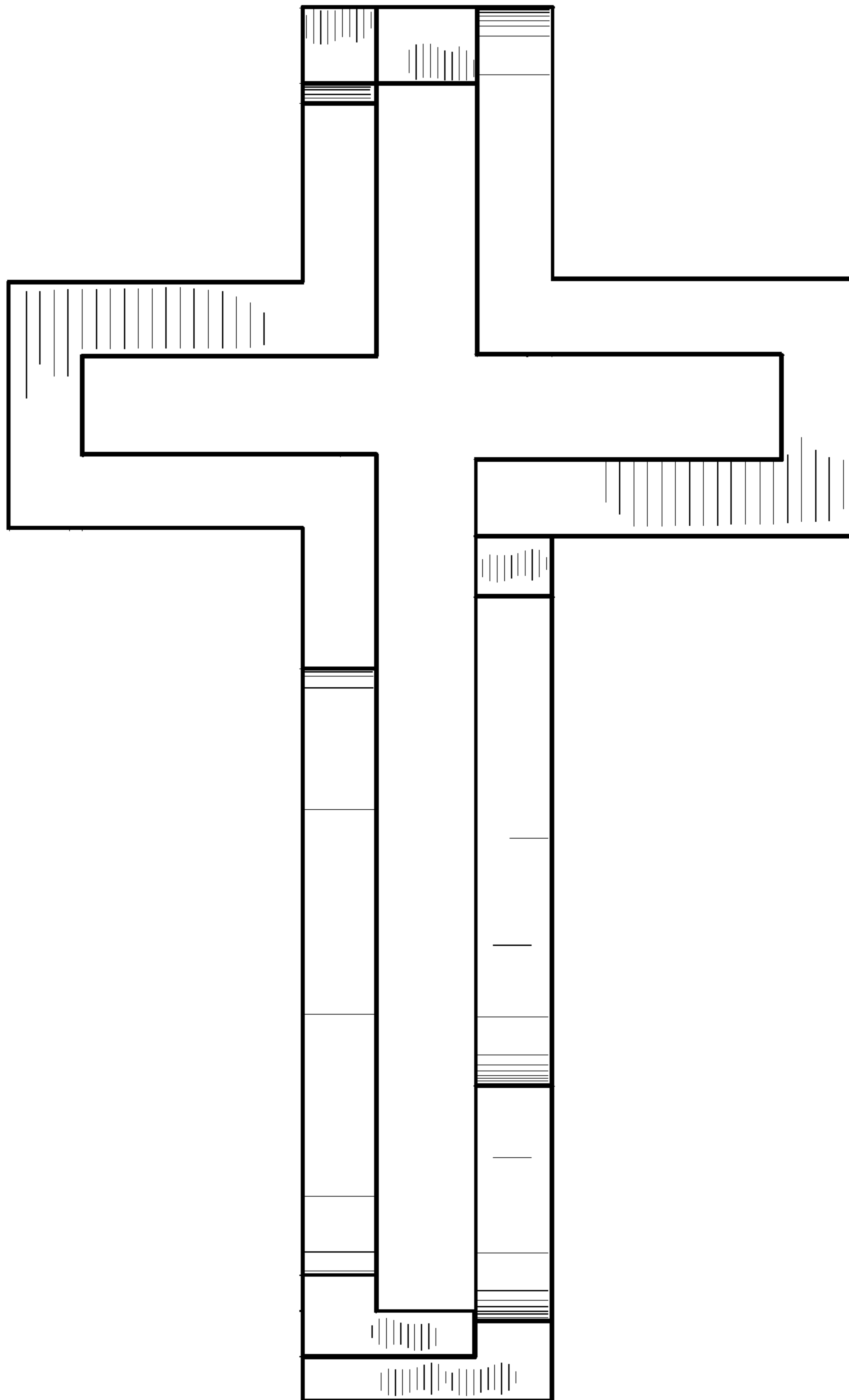

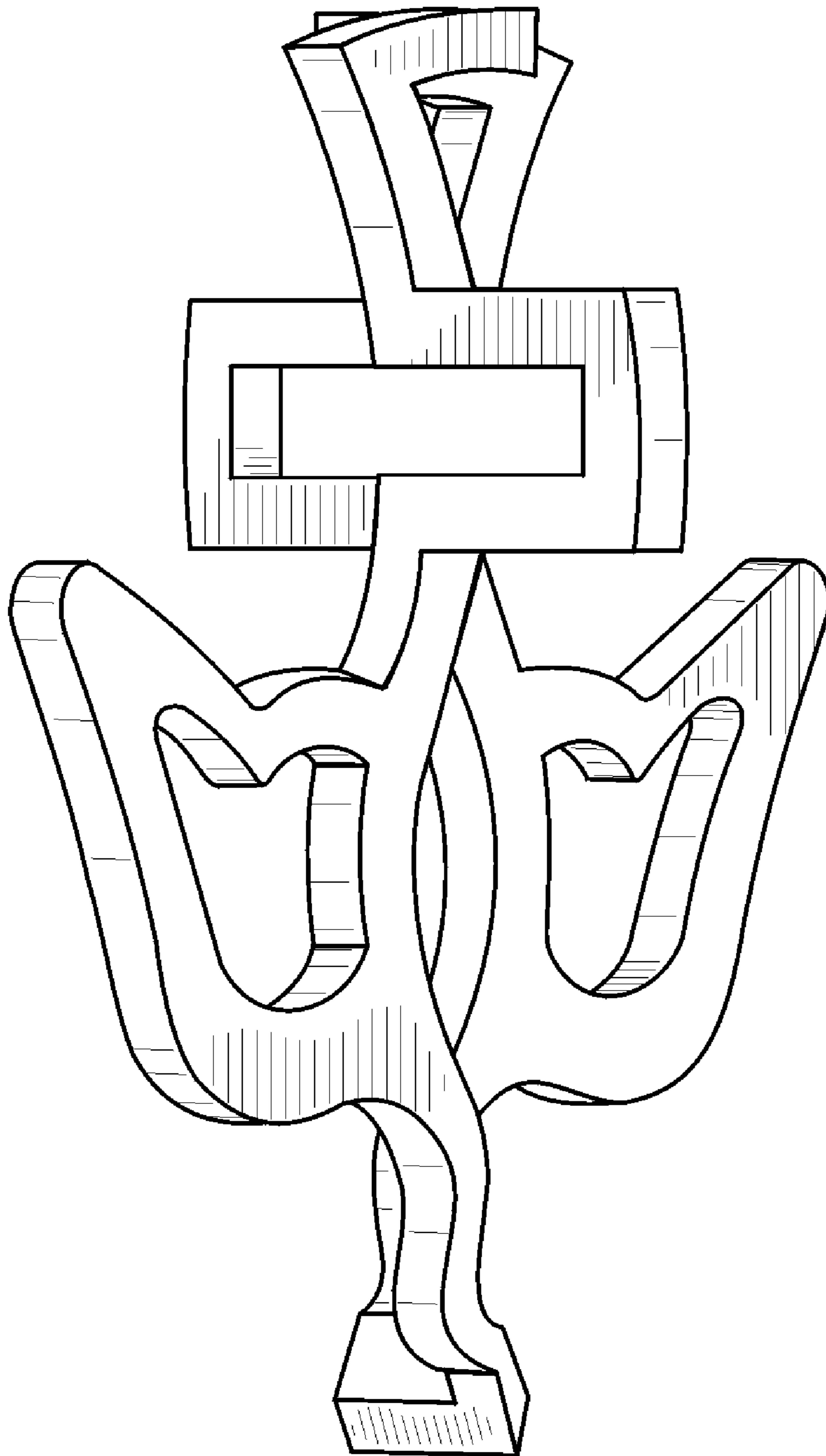

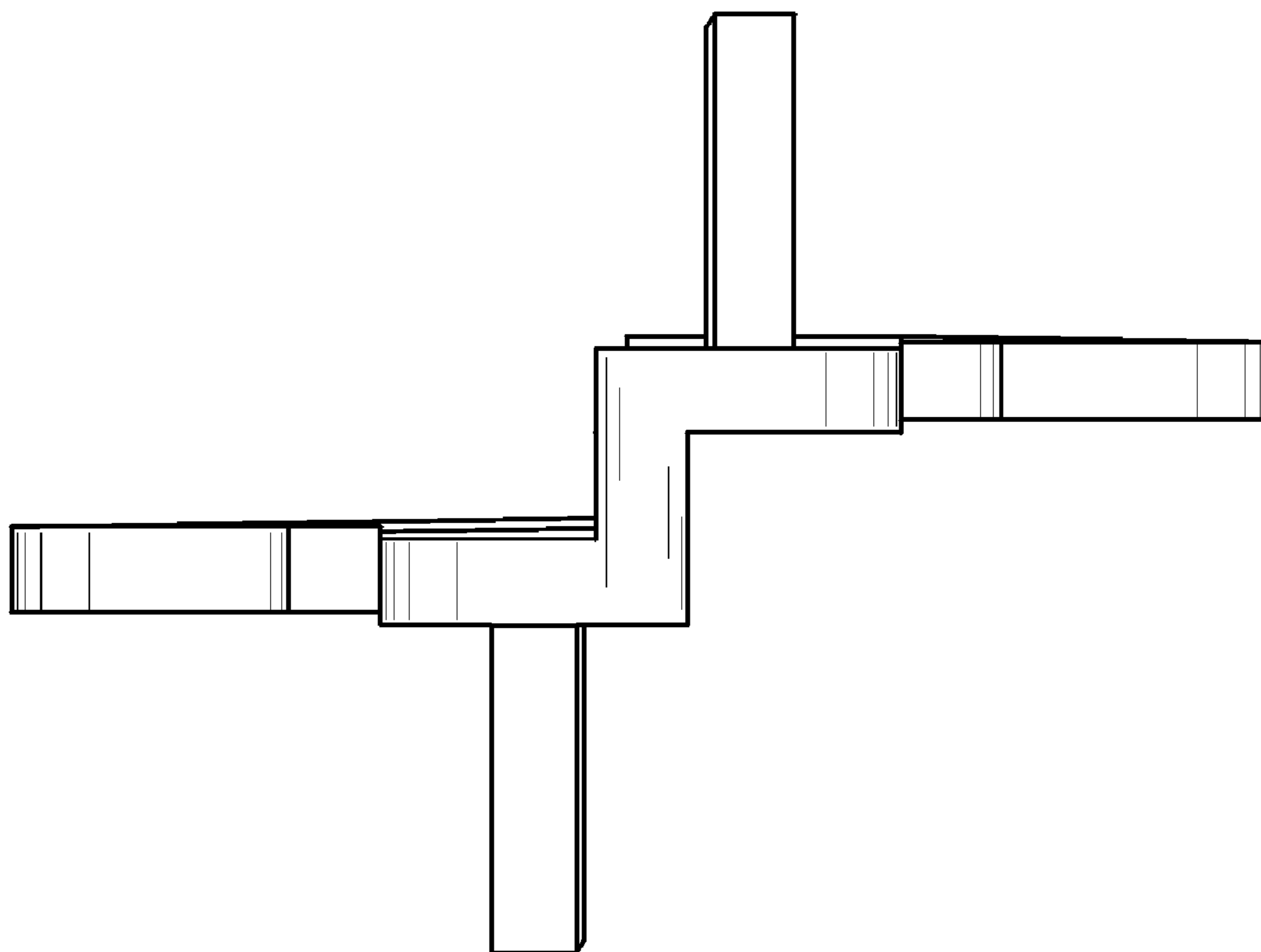

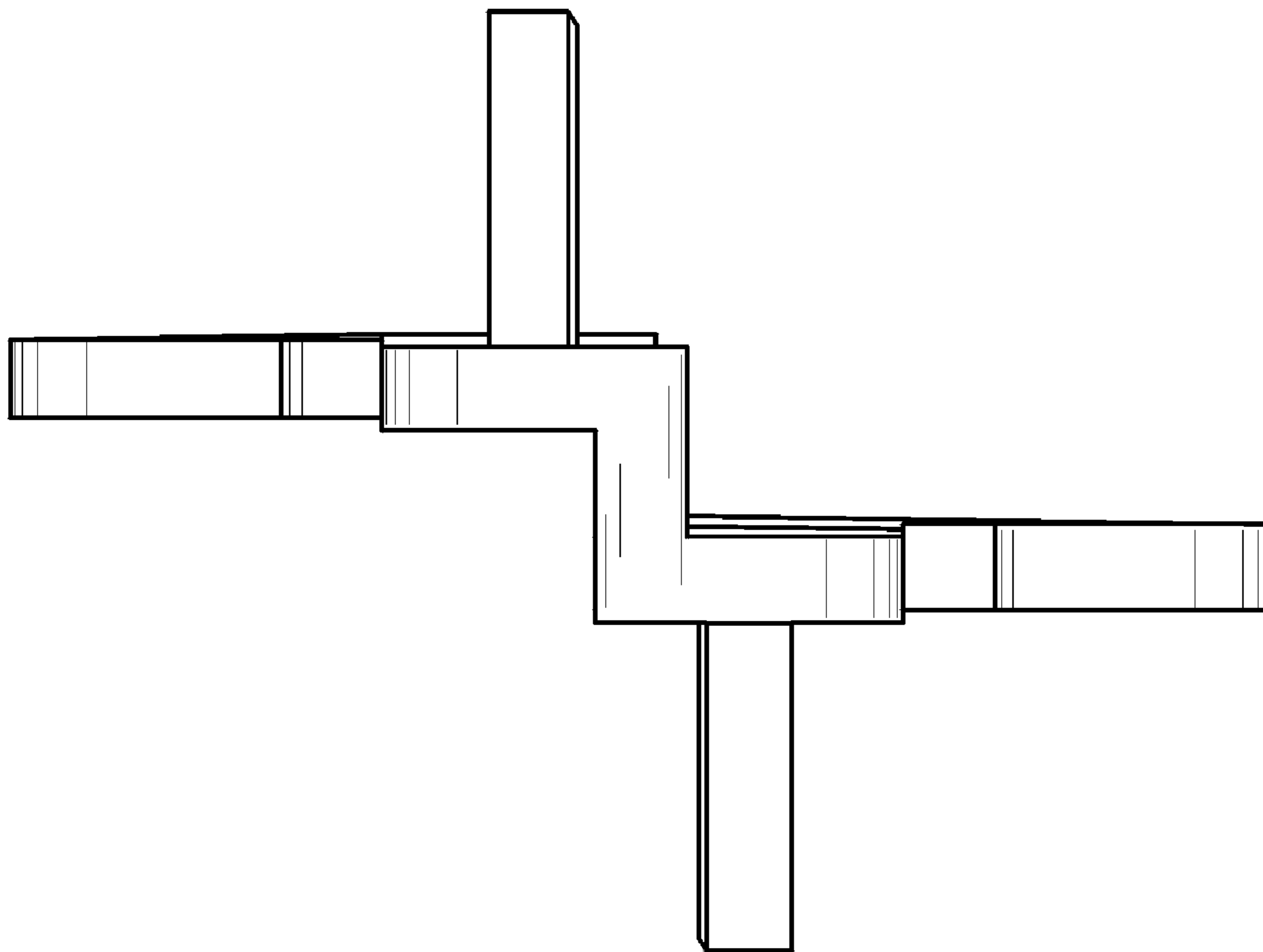
