FIG. 6 is a rear view thereof;

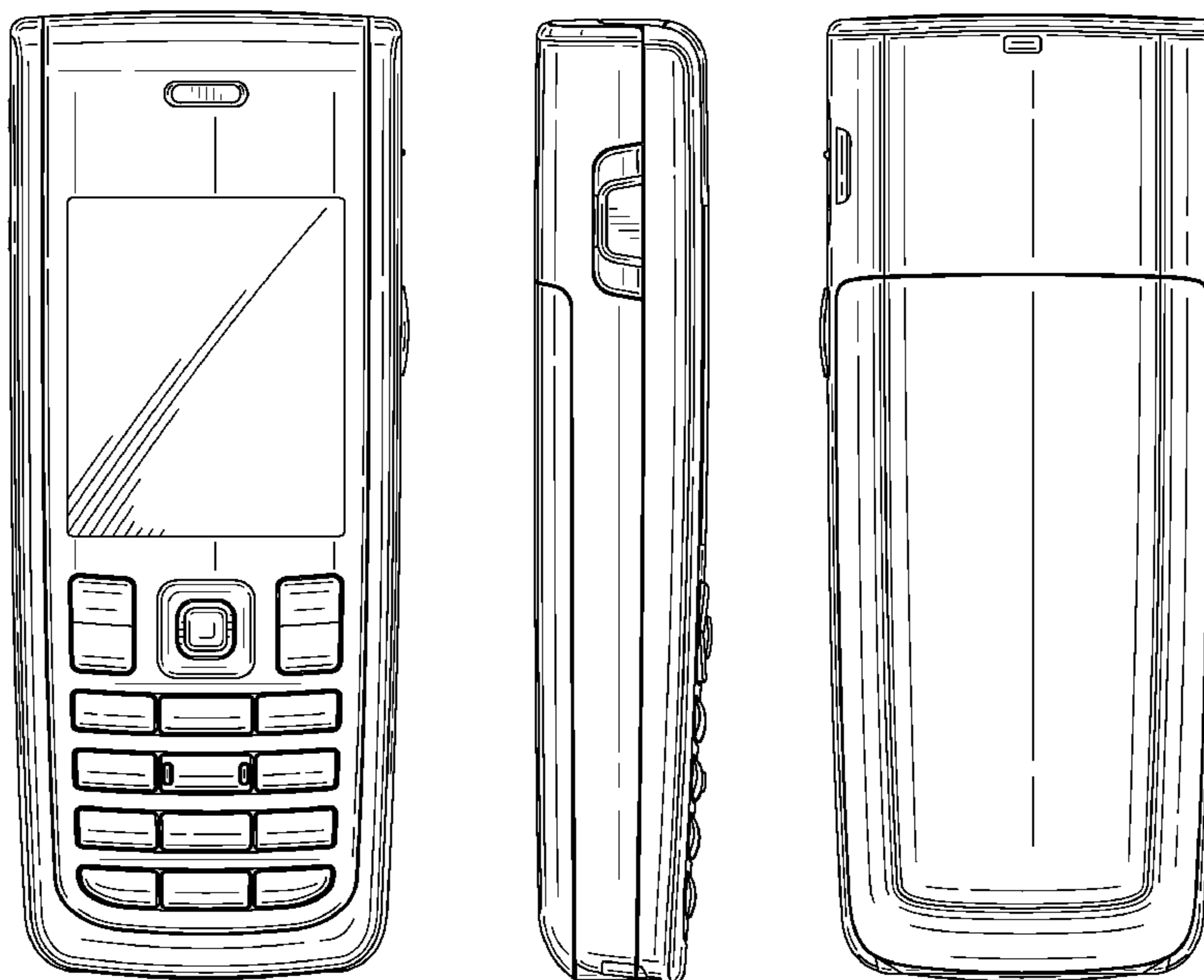
FIG. 7 is a perspective front view thereof; and,

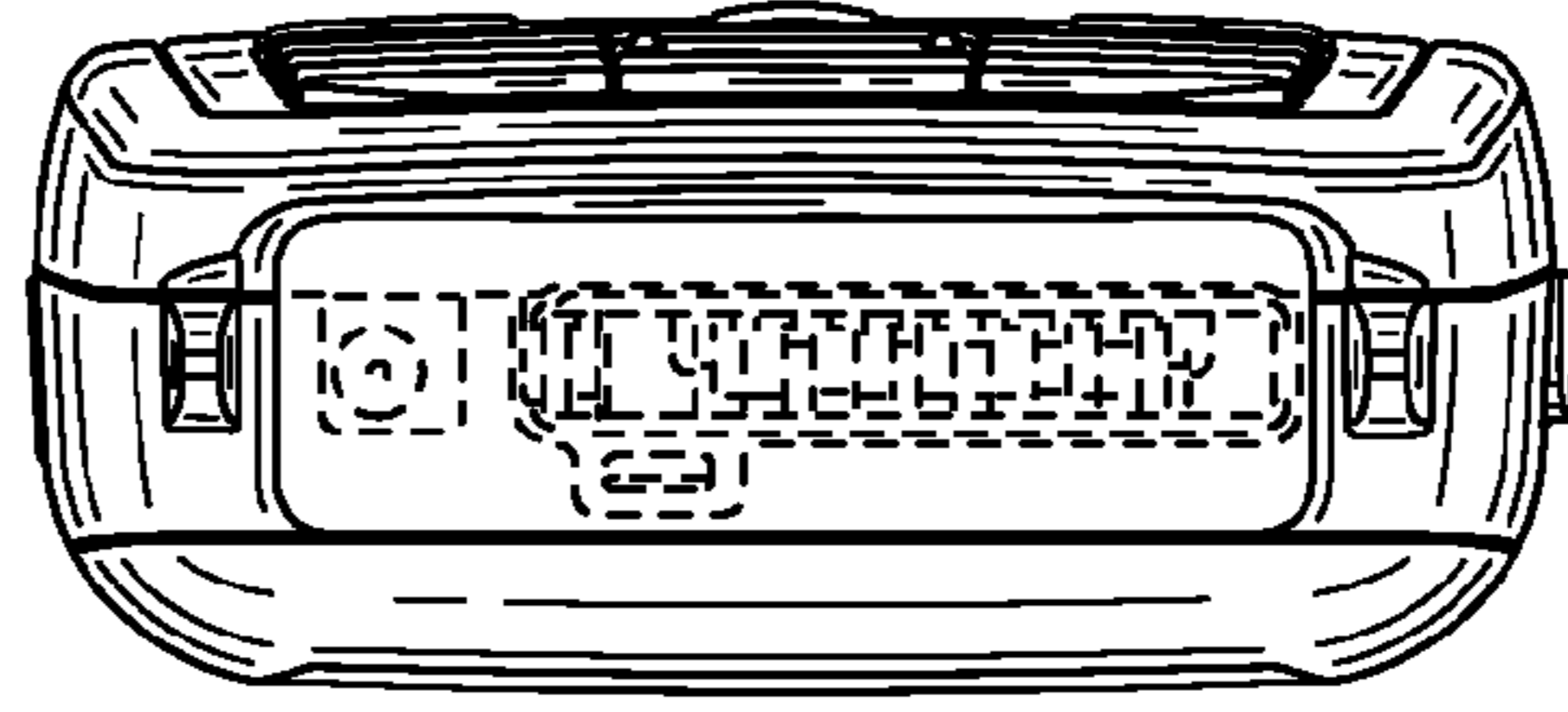

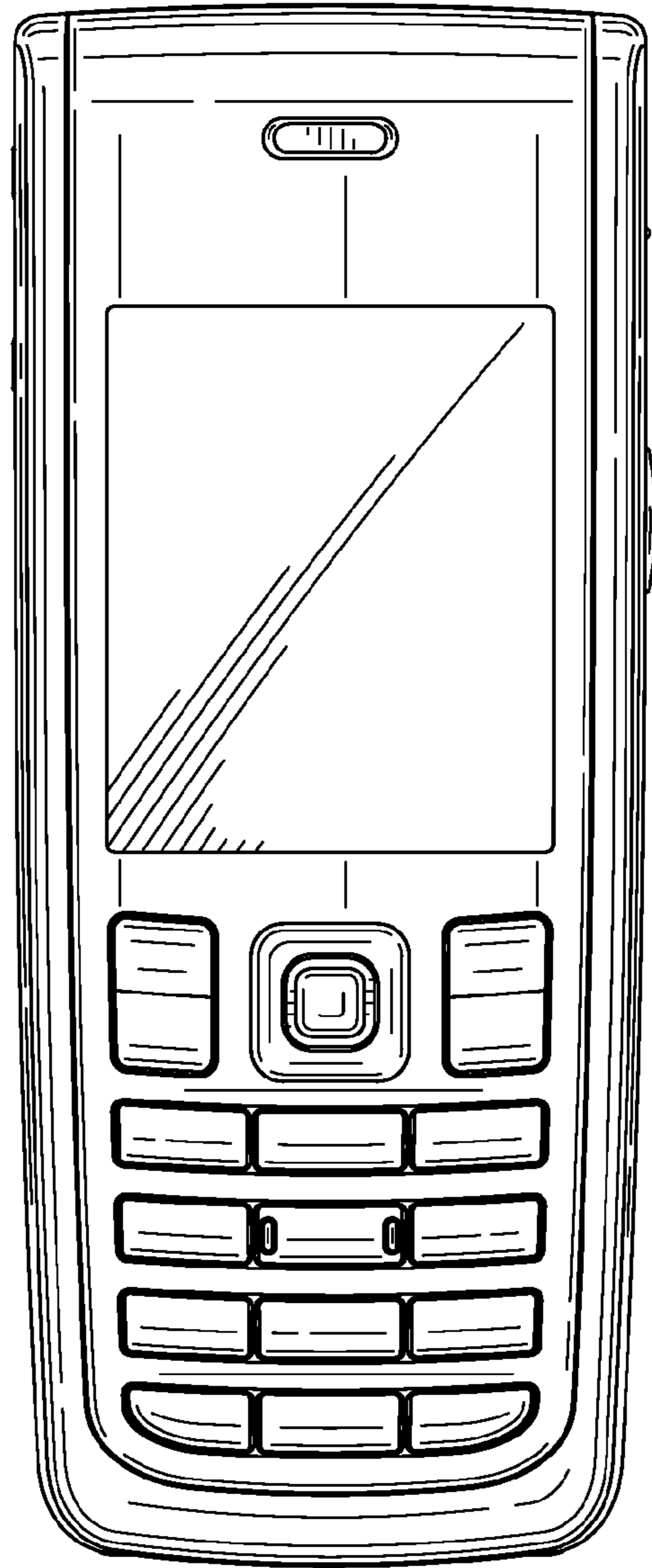

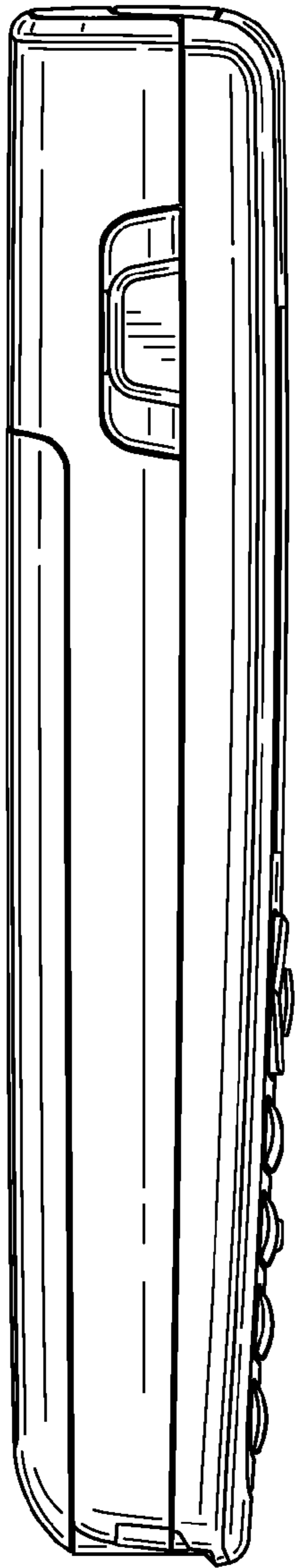

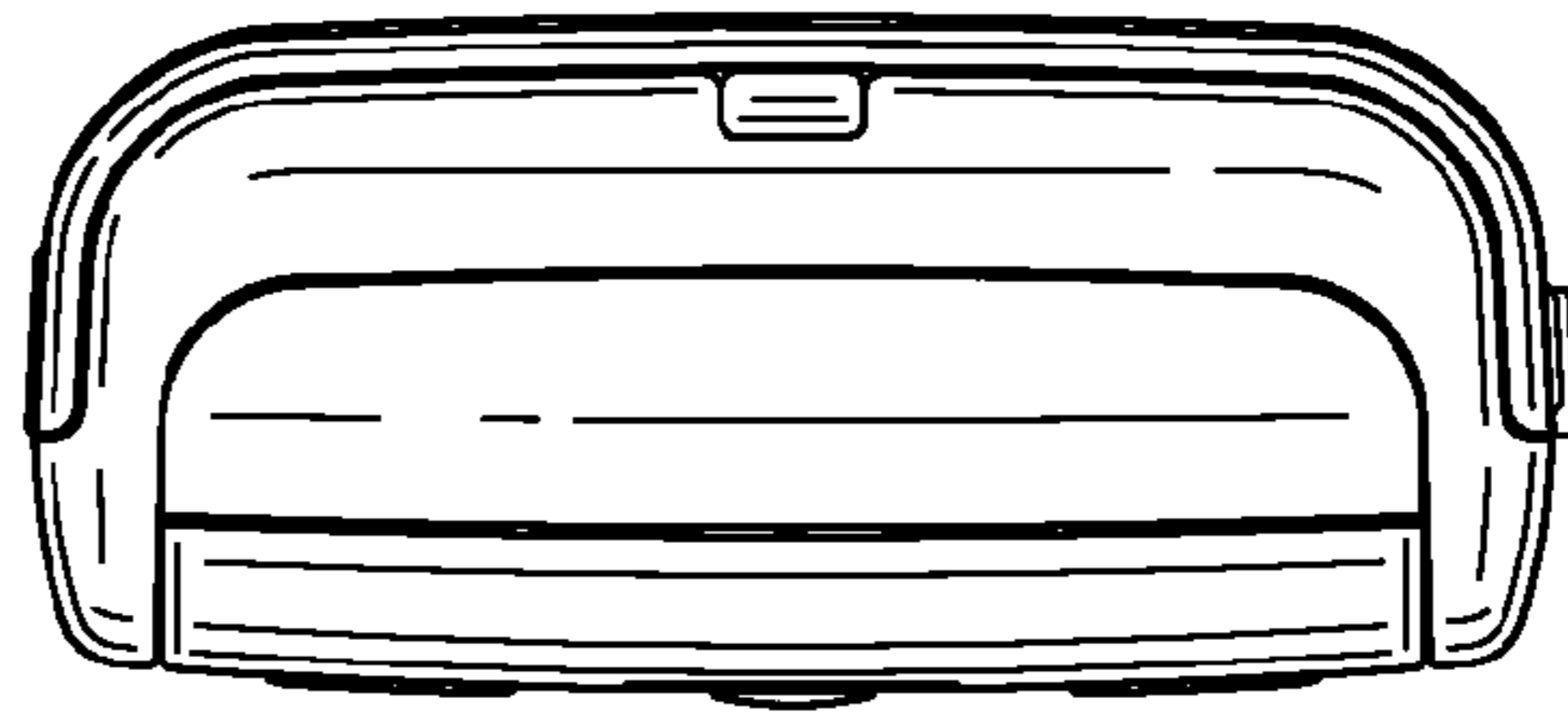

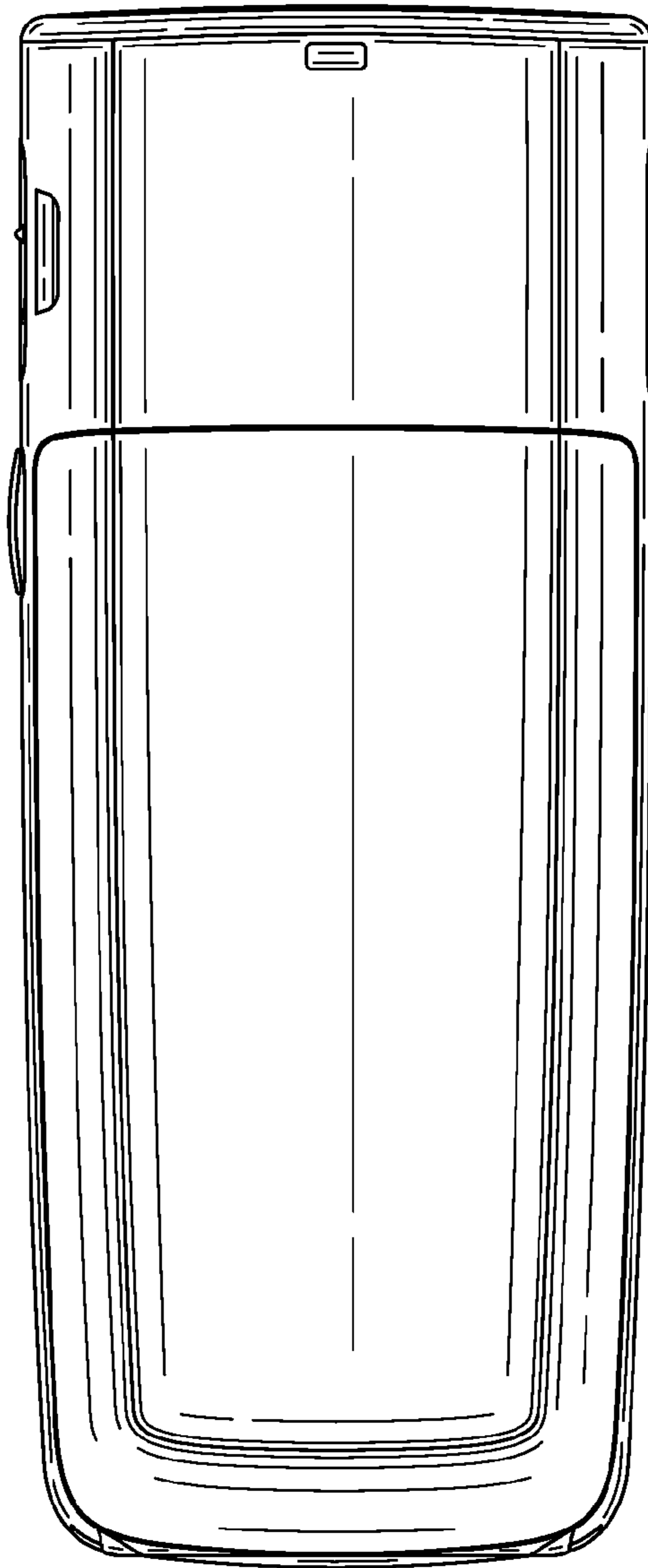

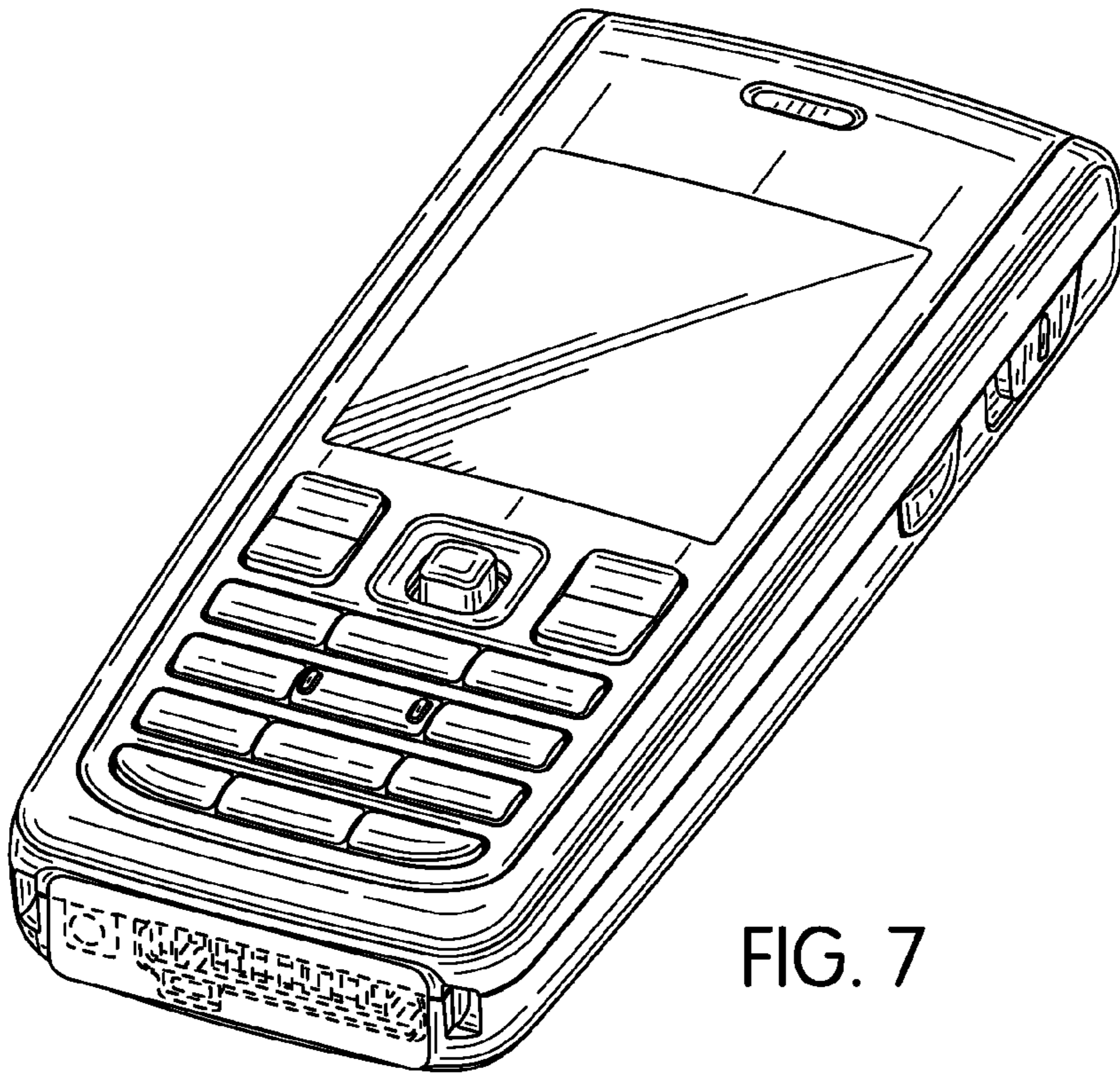

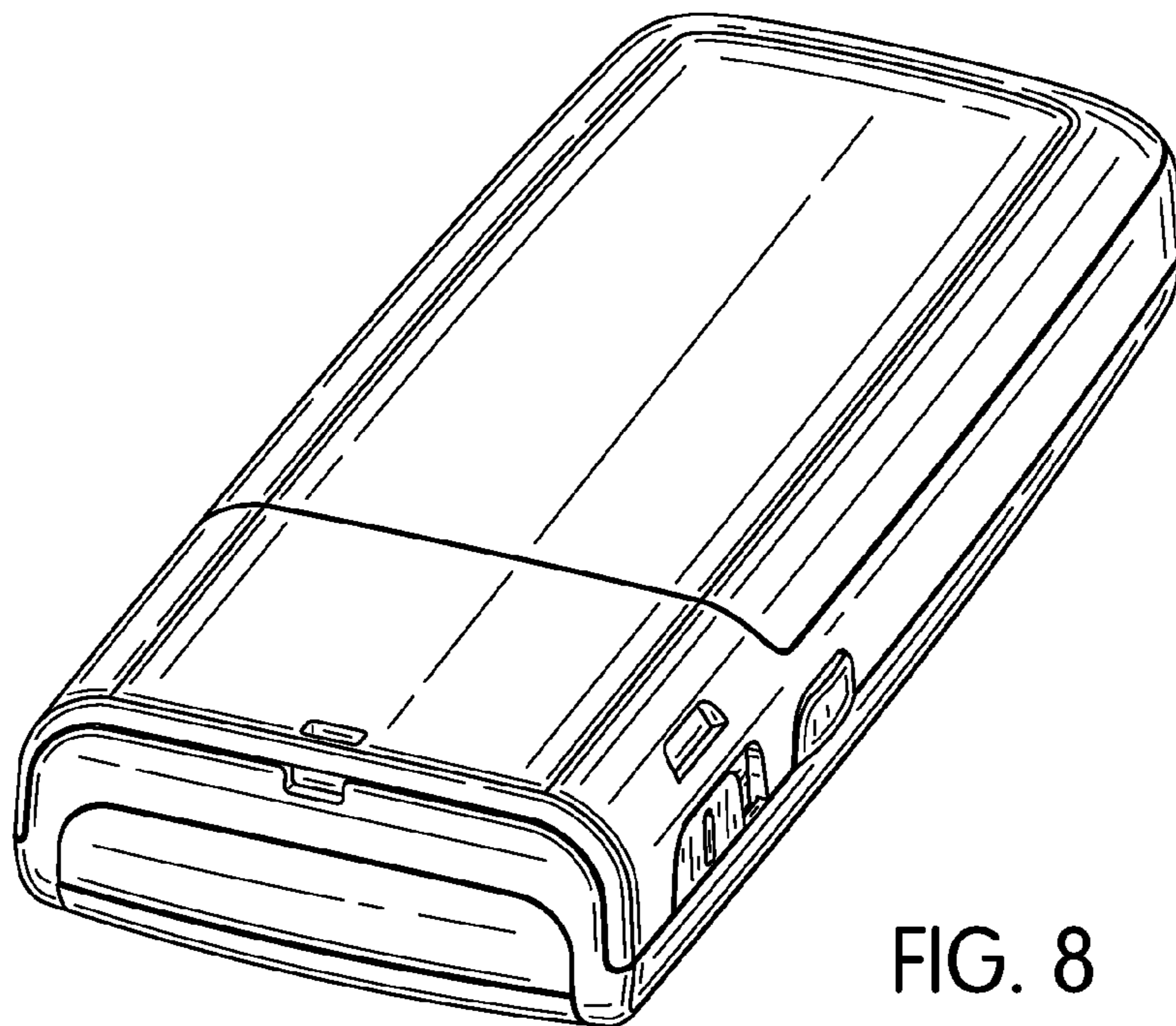
