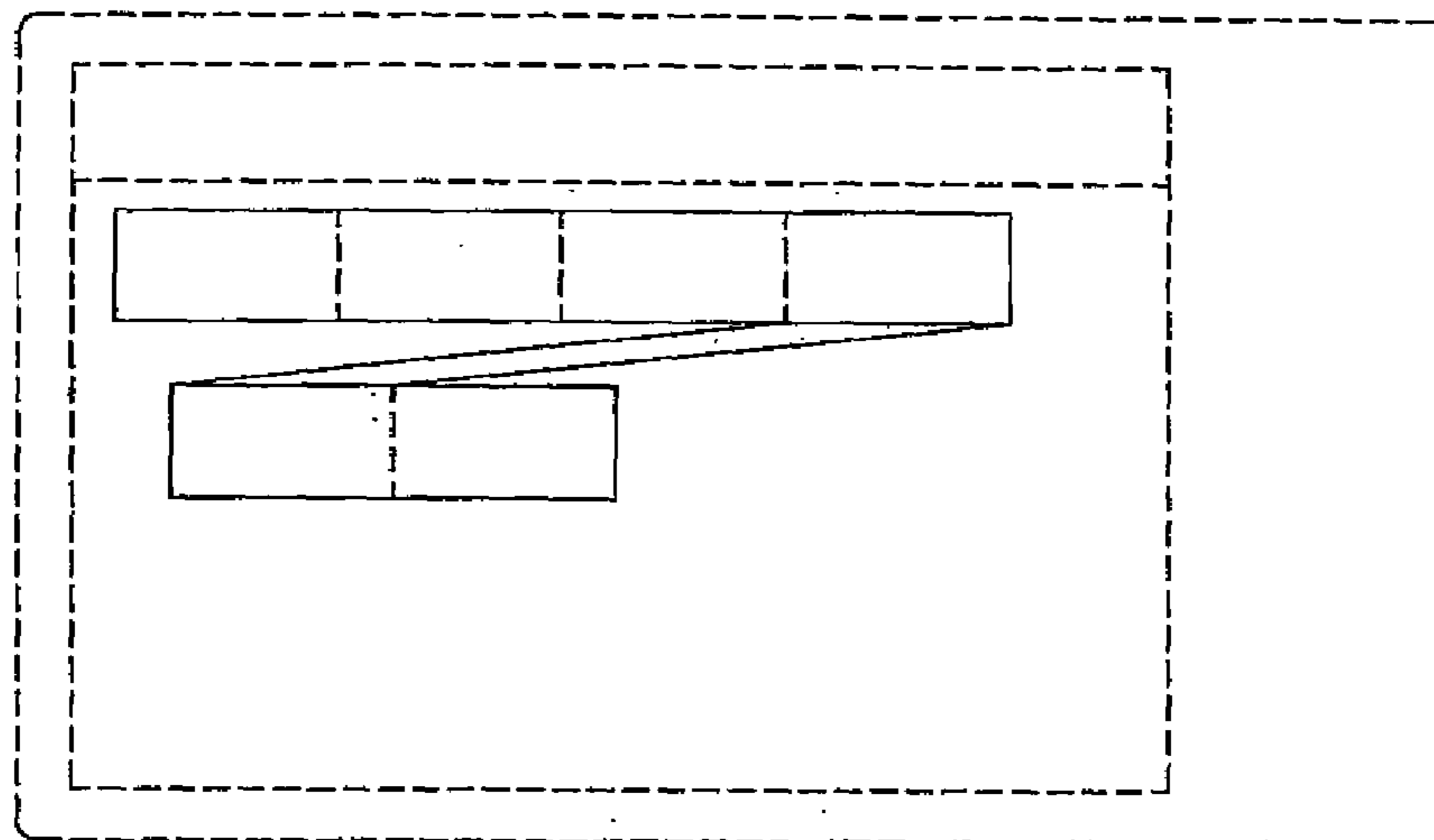
The ornamental design for a interface for a digital camera having multiple selection icons, as shown and described.

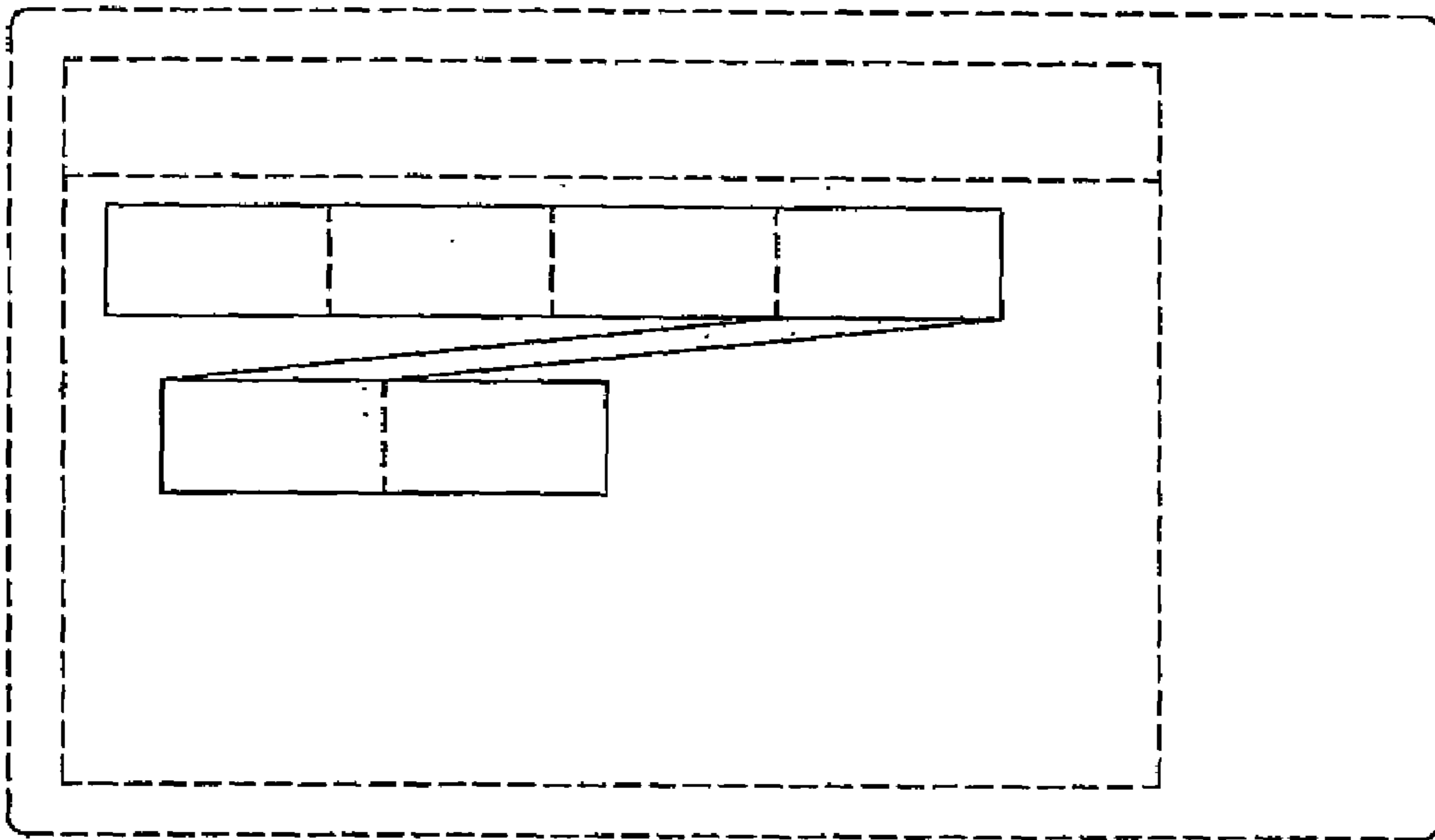
**DESCRIPTION**
