The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 17 is a front view of the golf club head with a 60° loft;

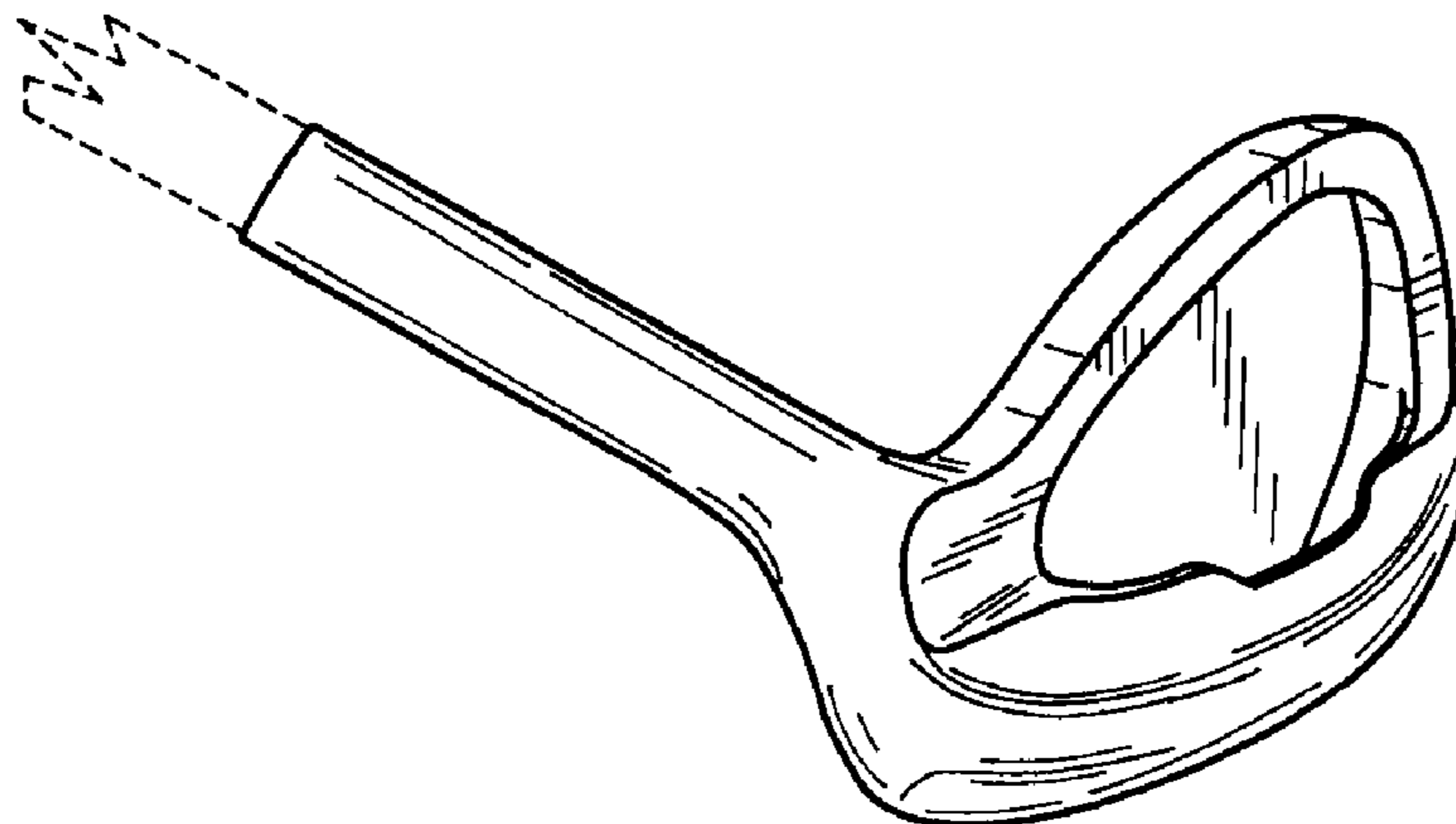
FIG. 18 is a side view of the golf club head with a 60° loft;

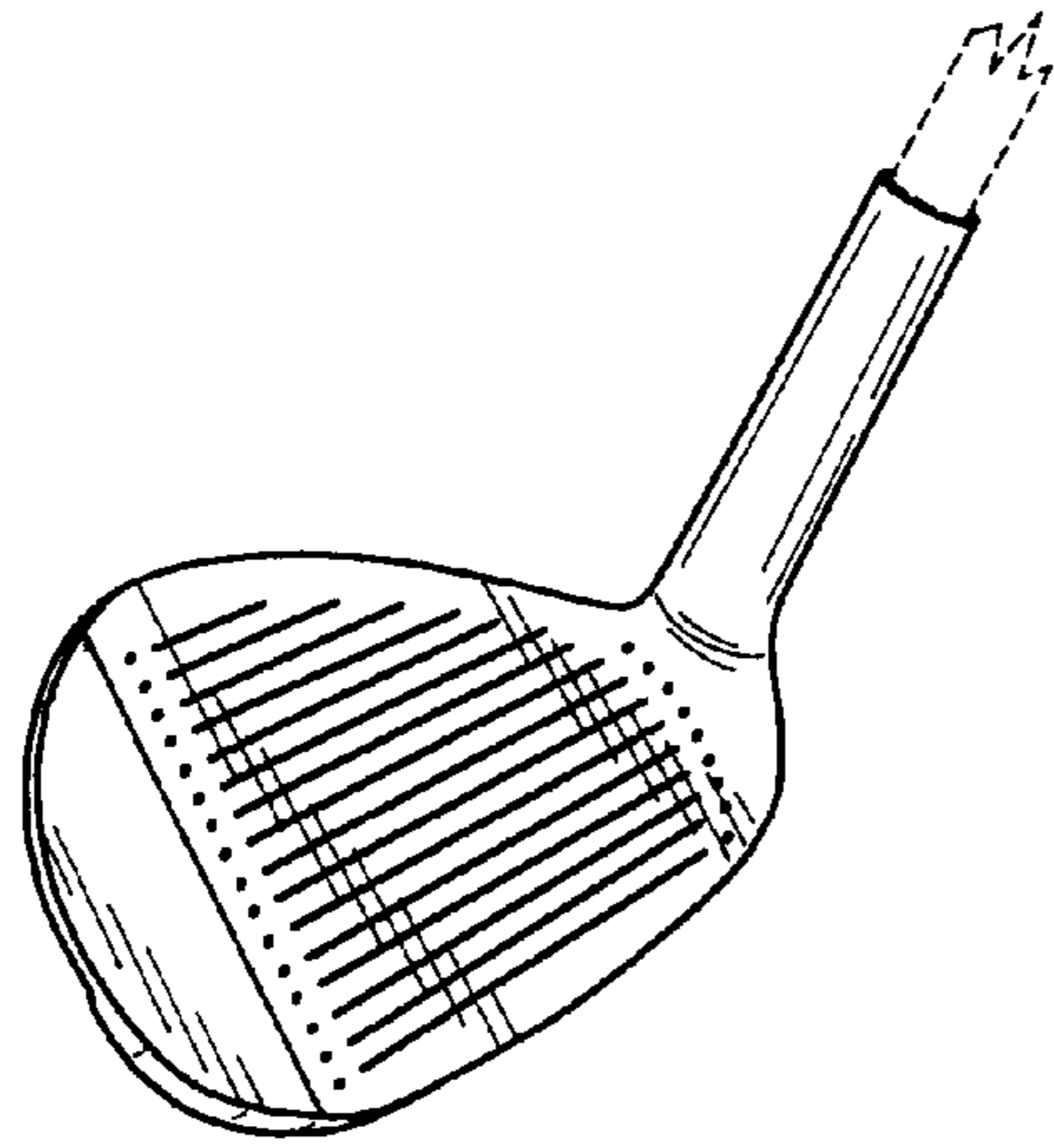

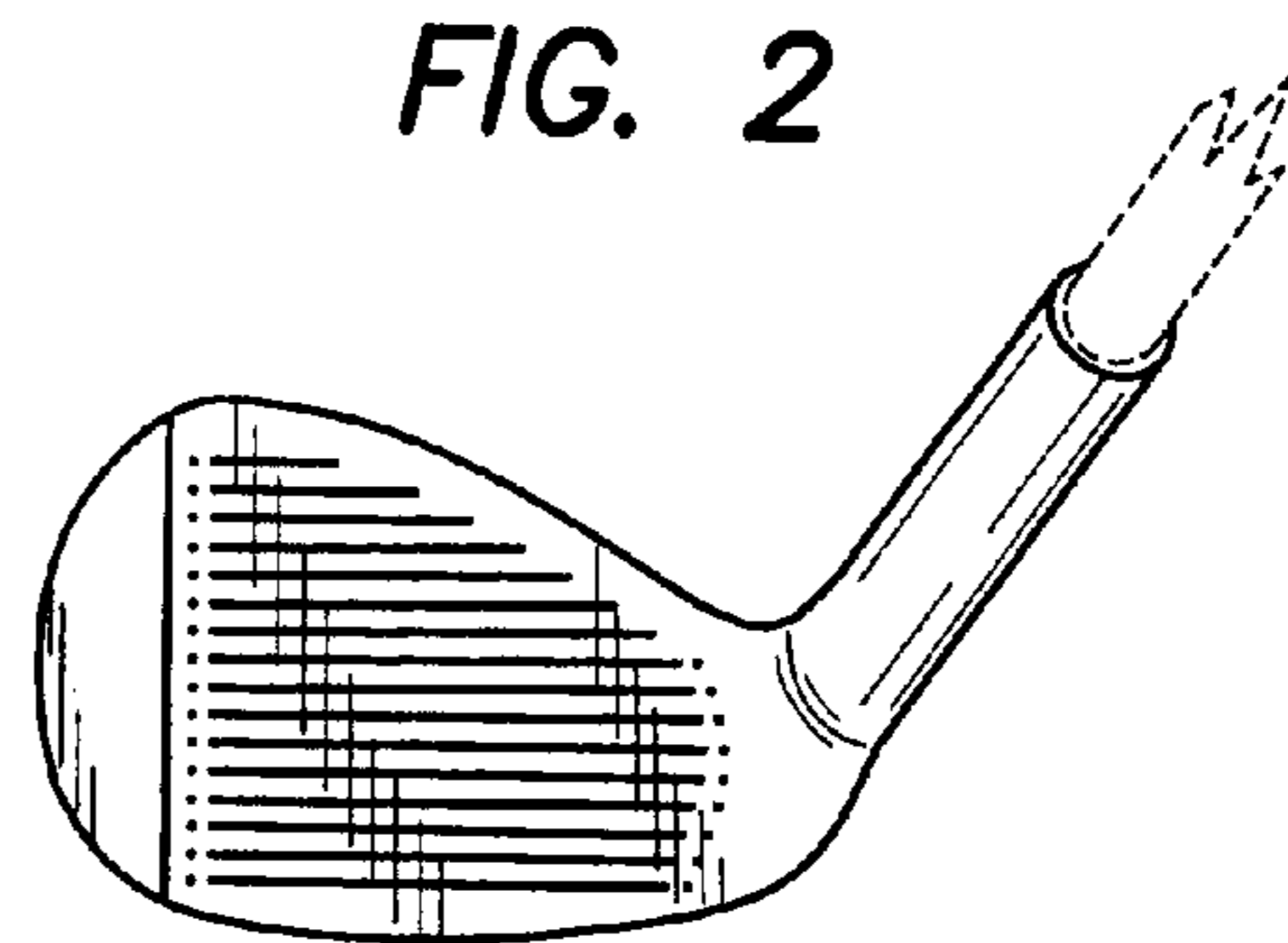

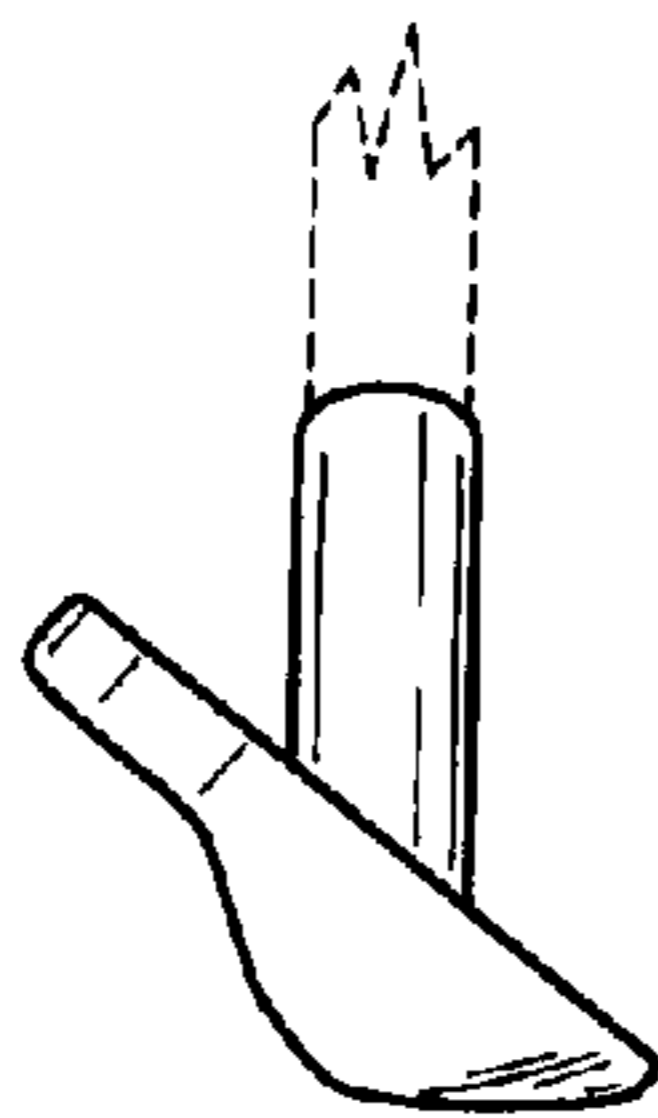

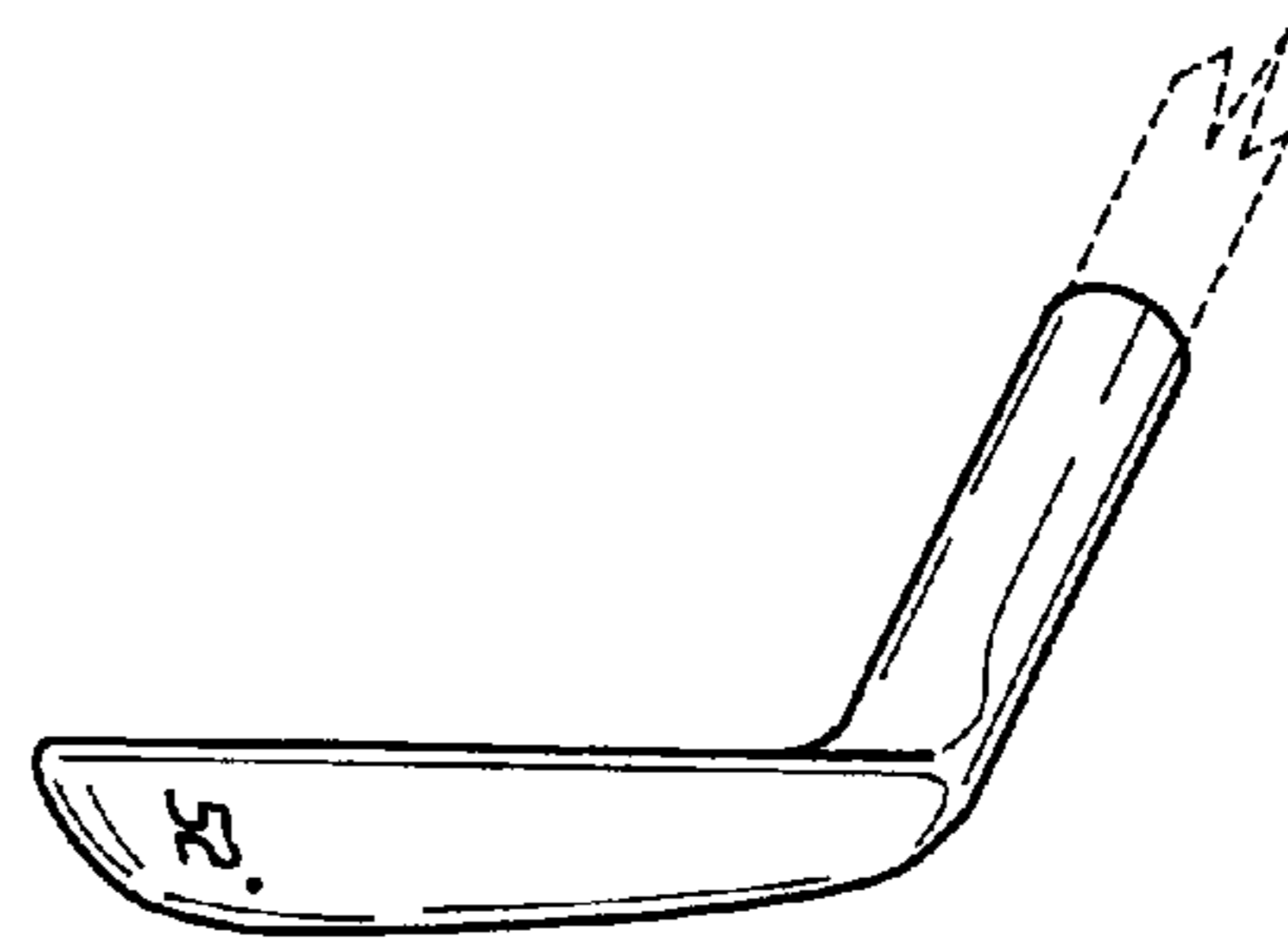

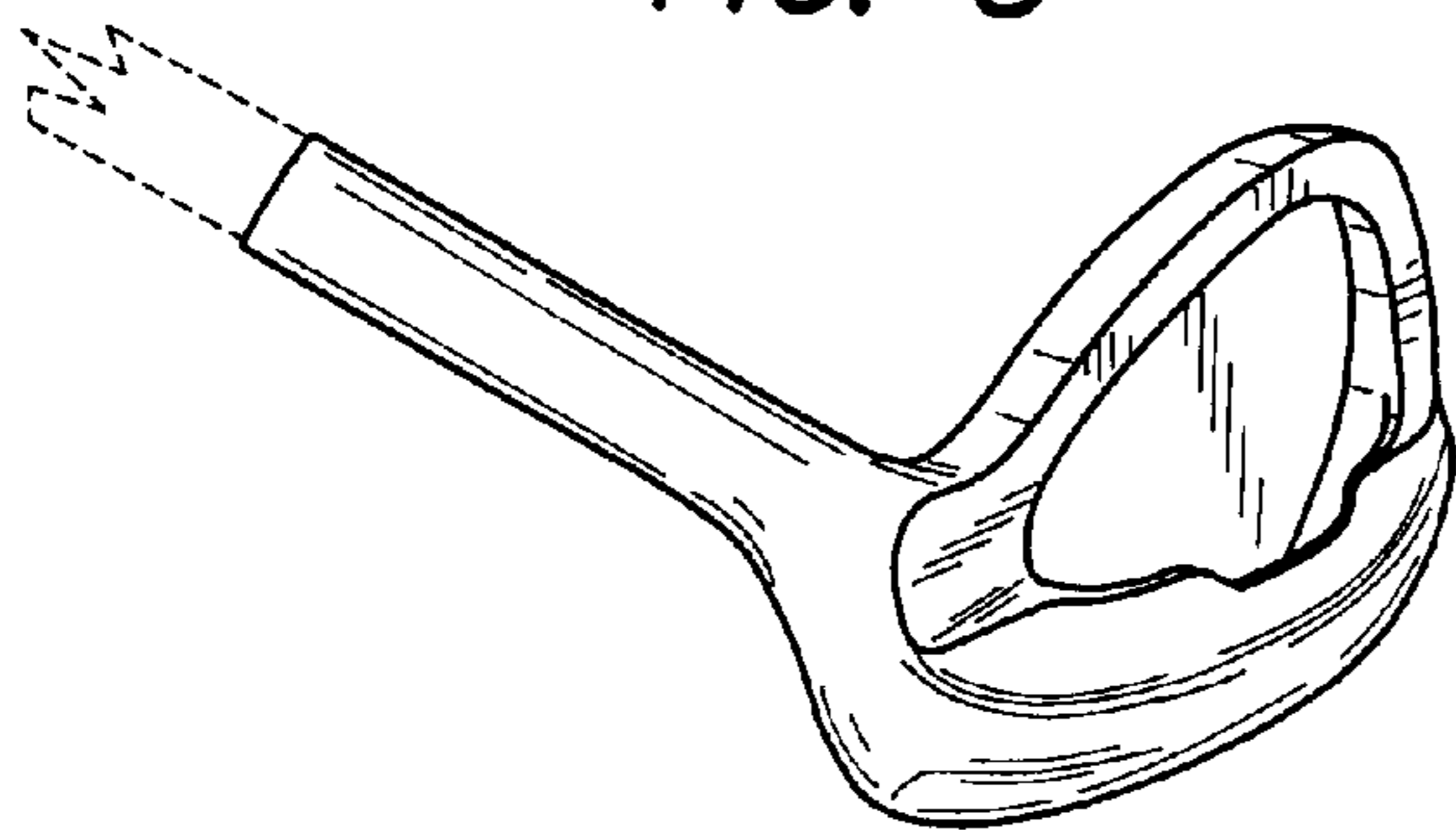

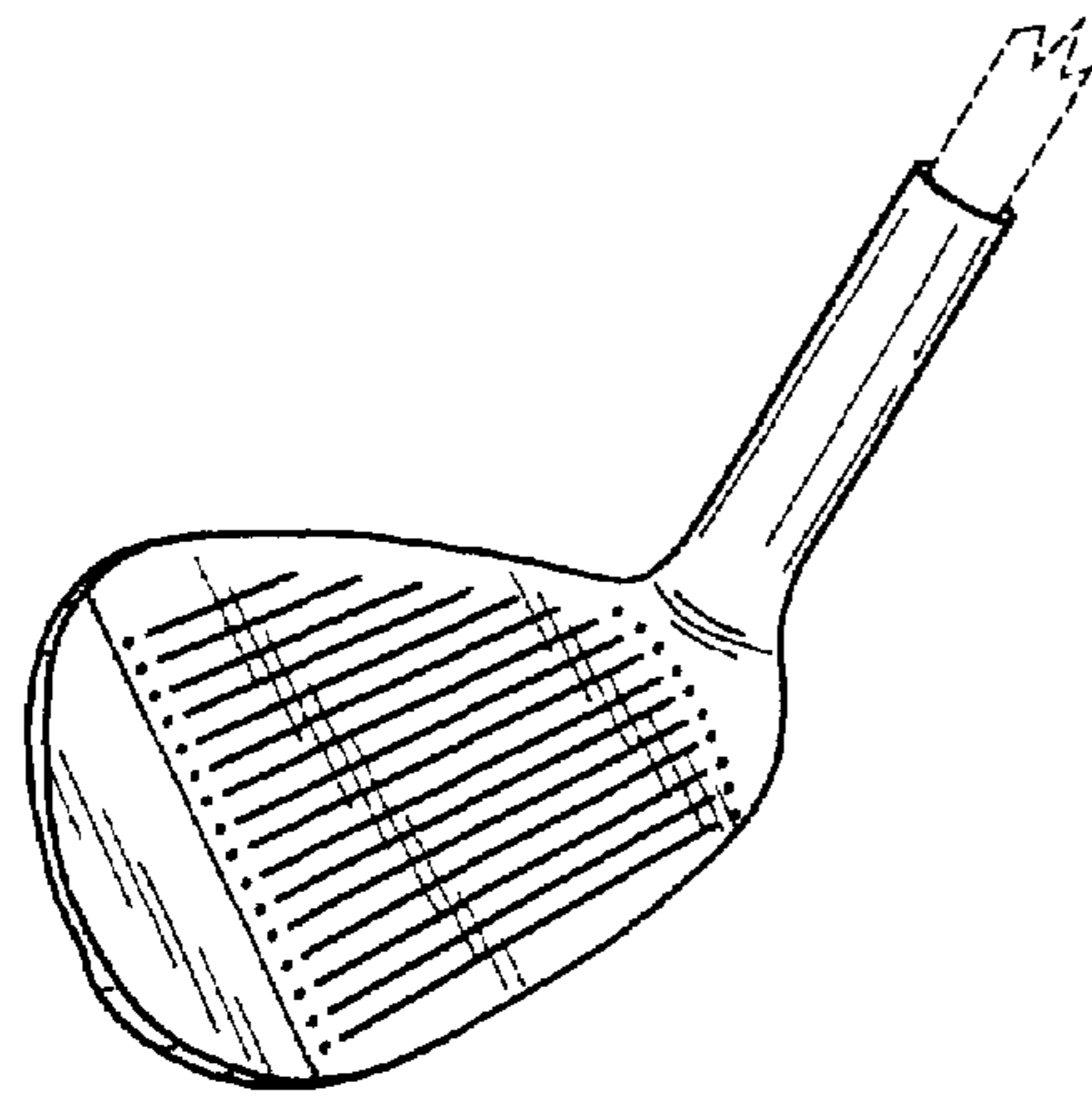

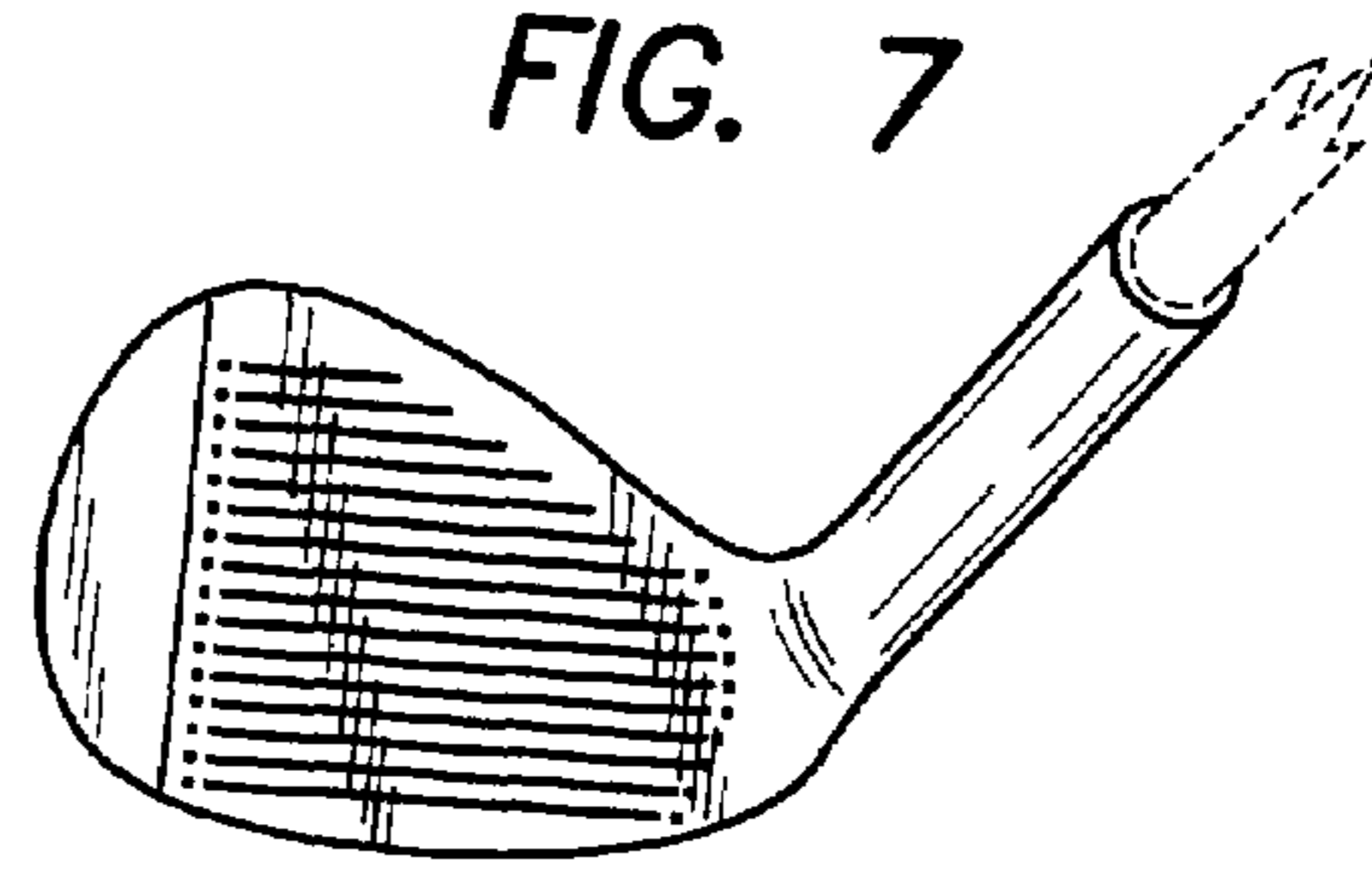

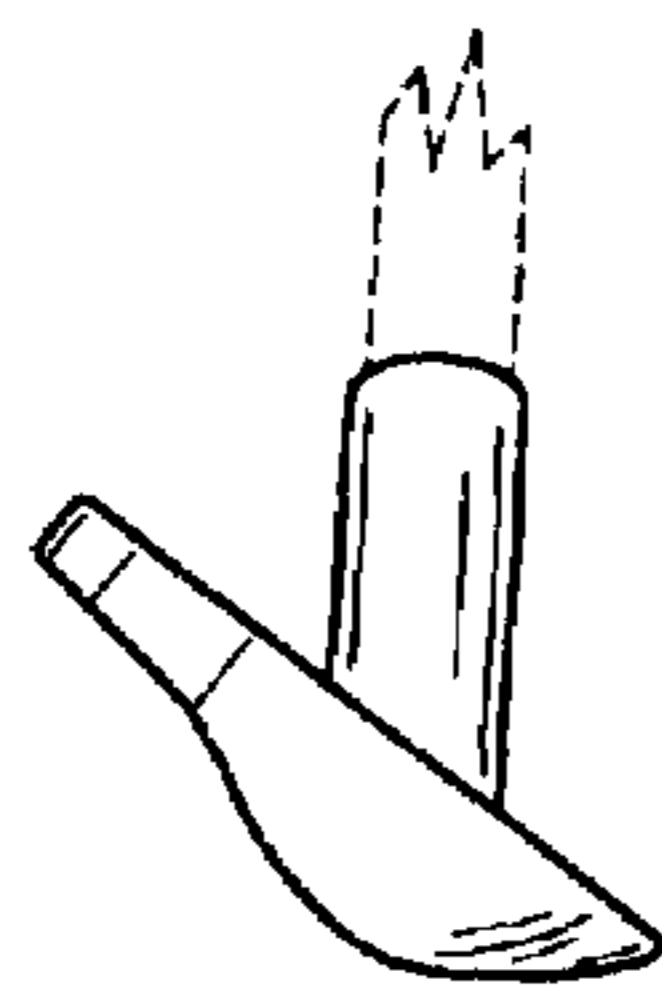

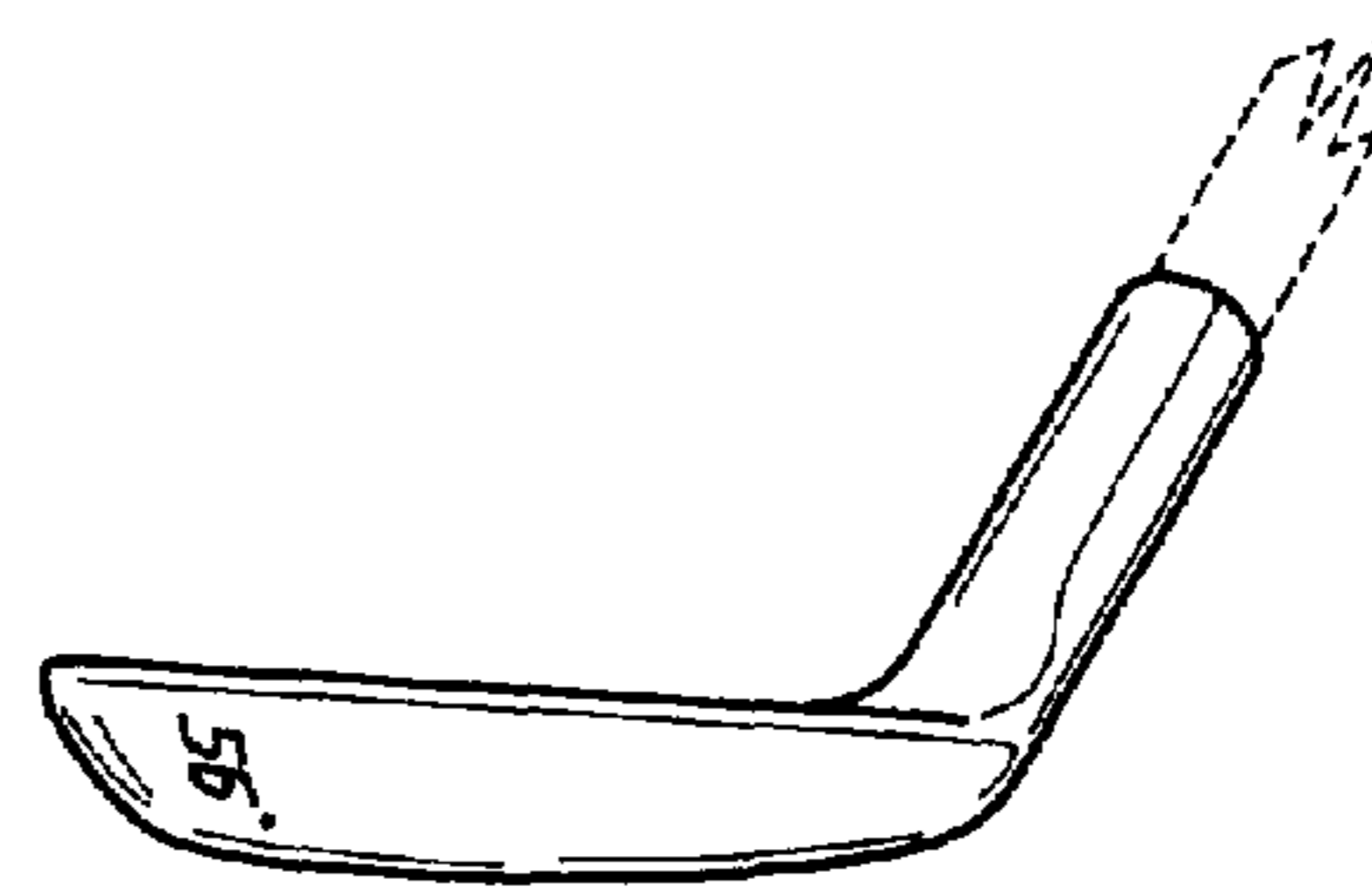

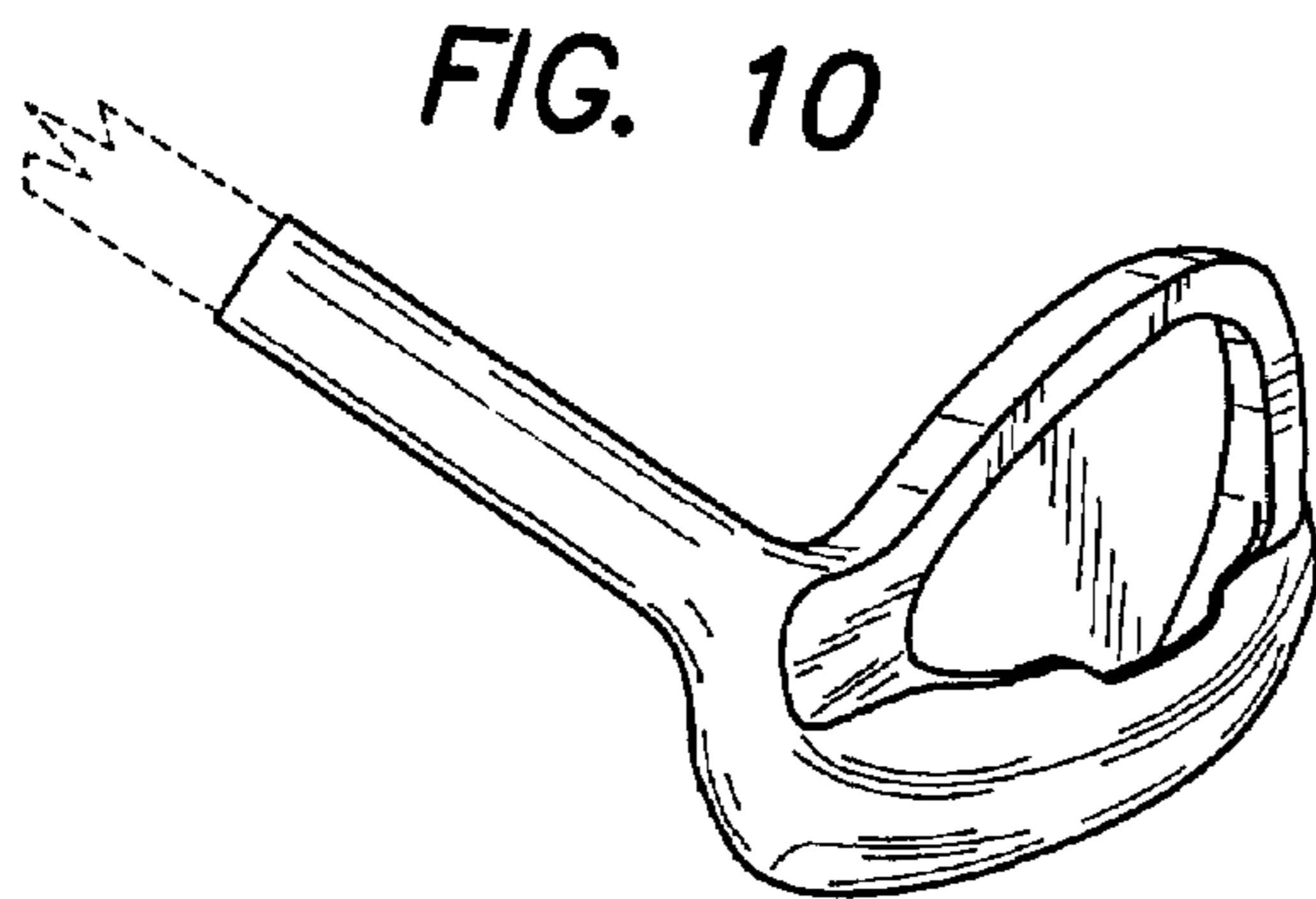

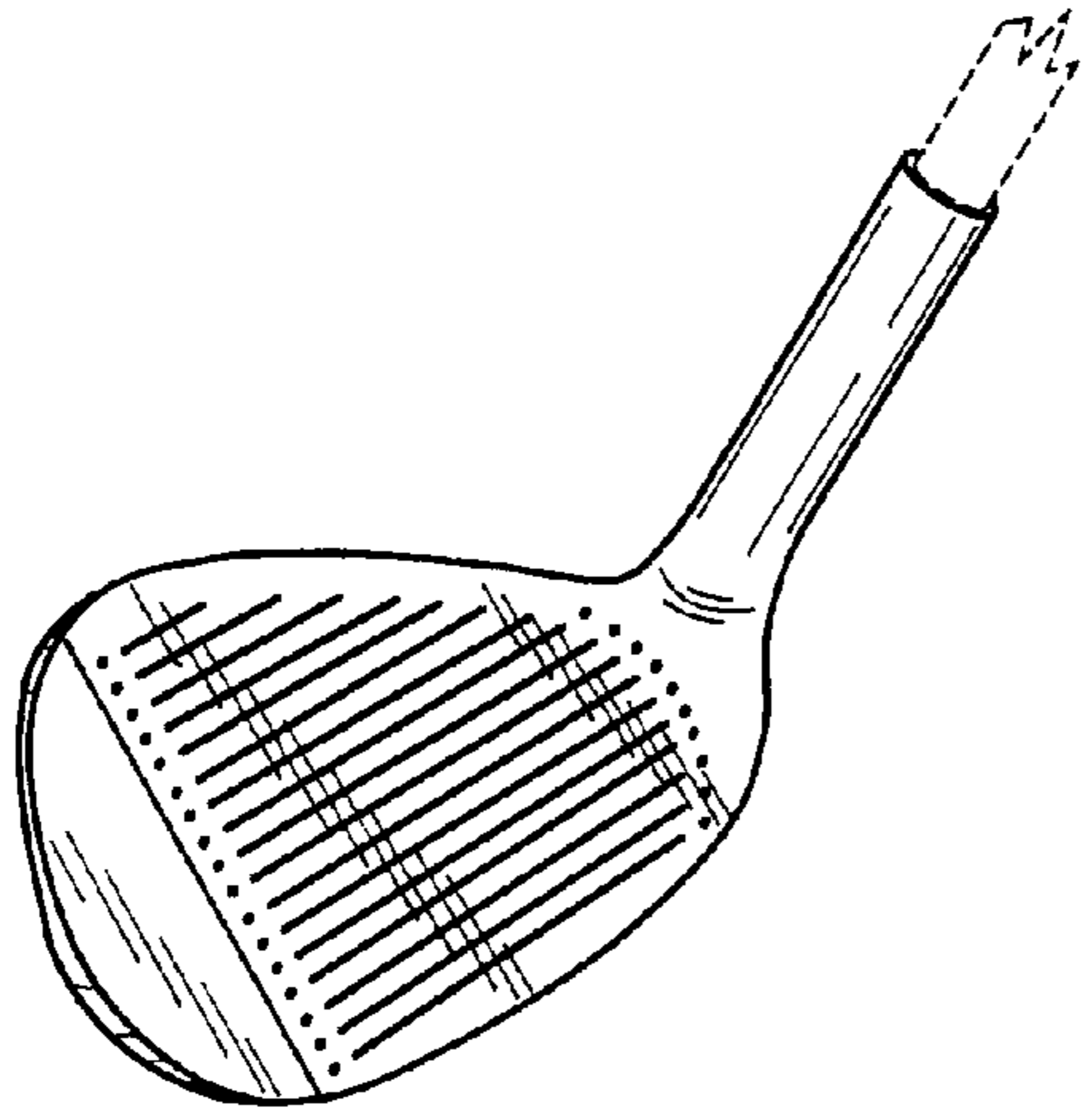

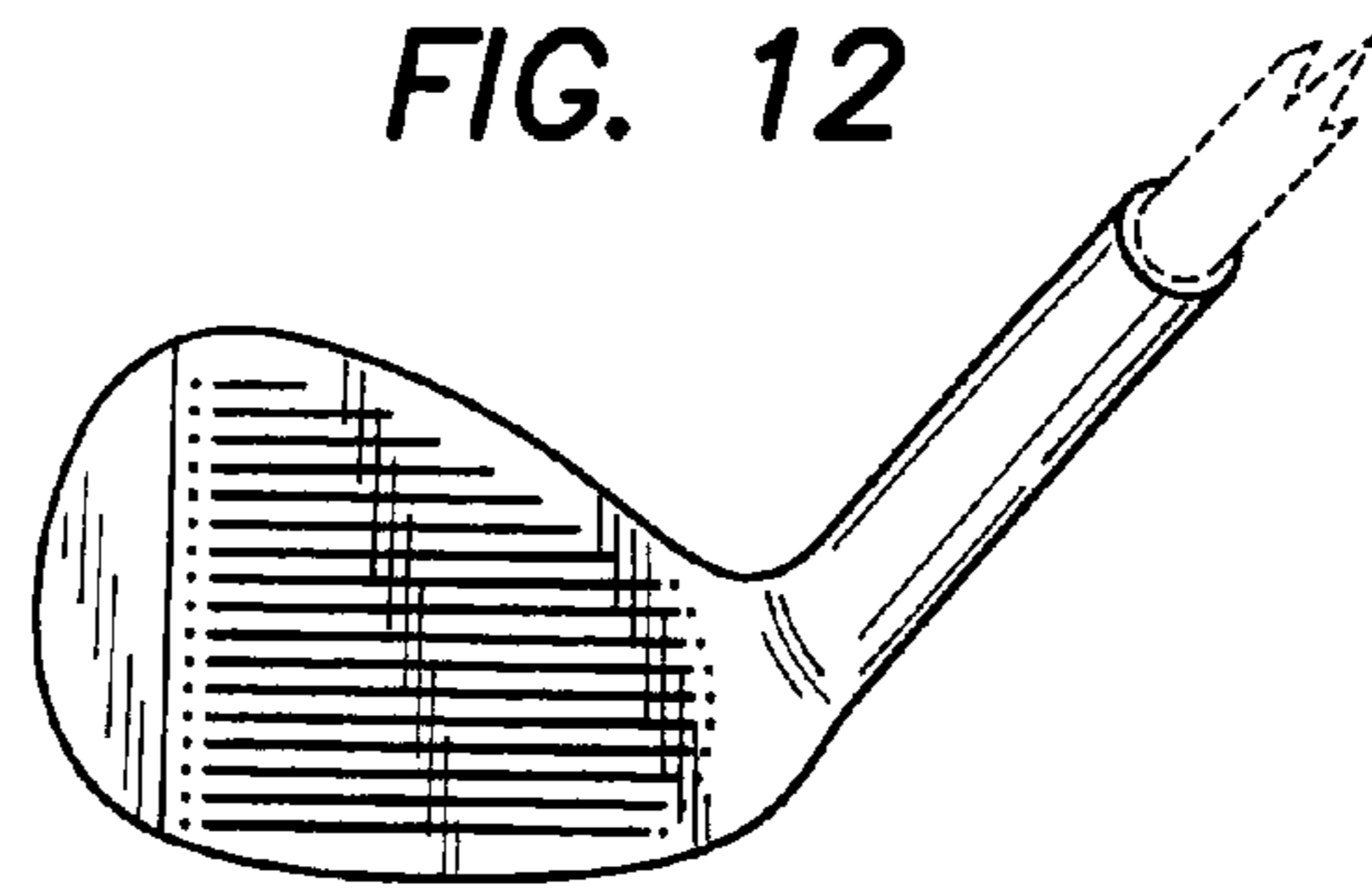

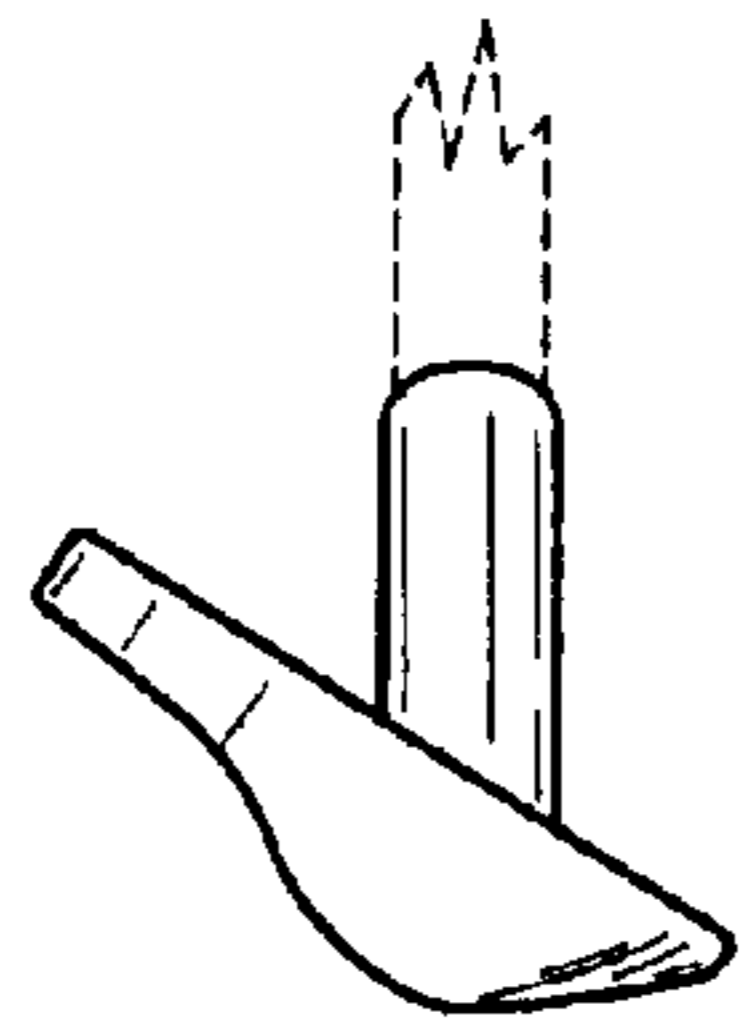

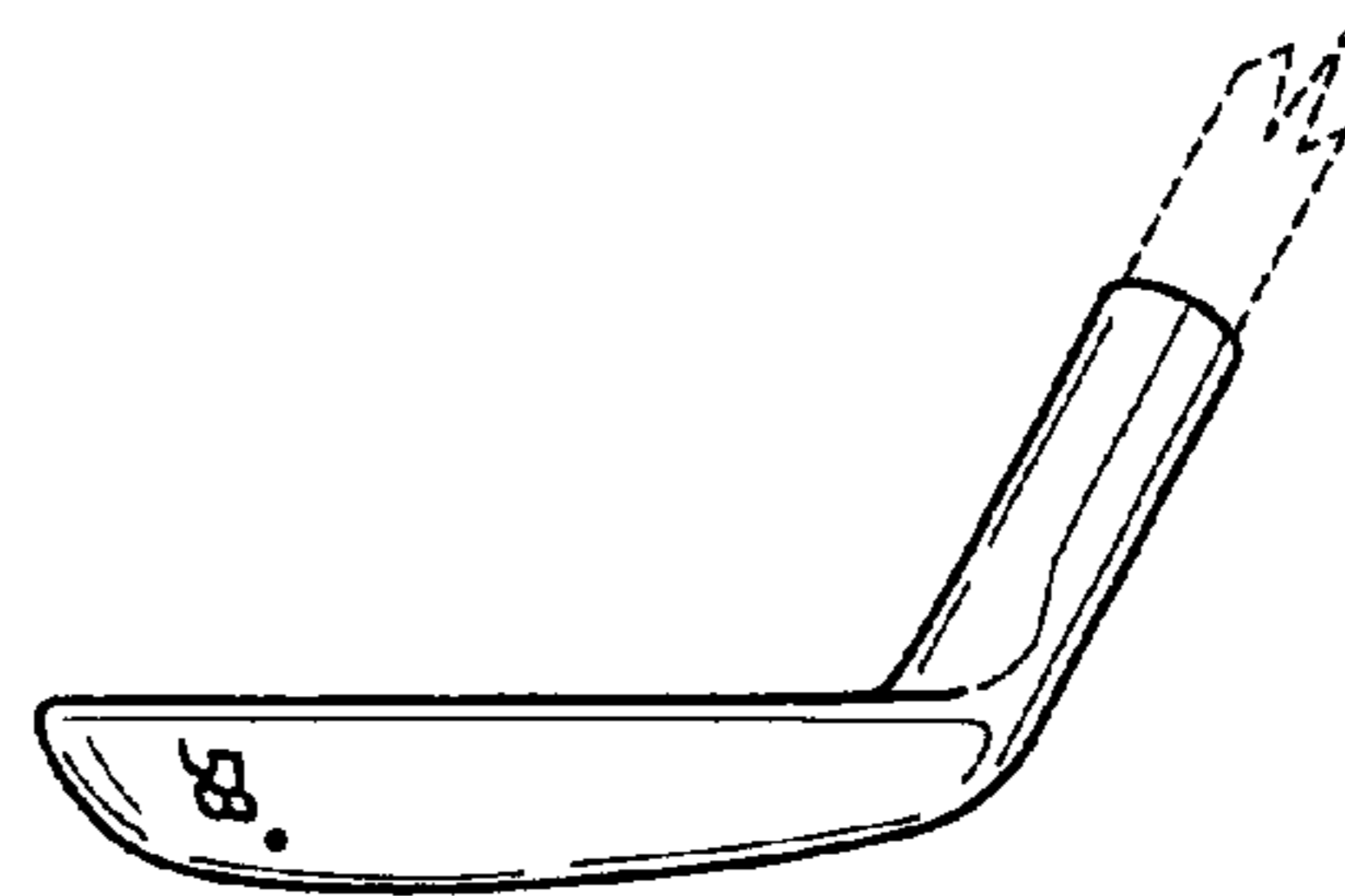
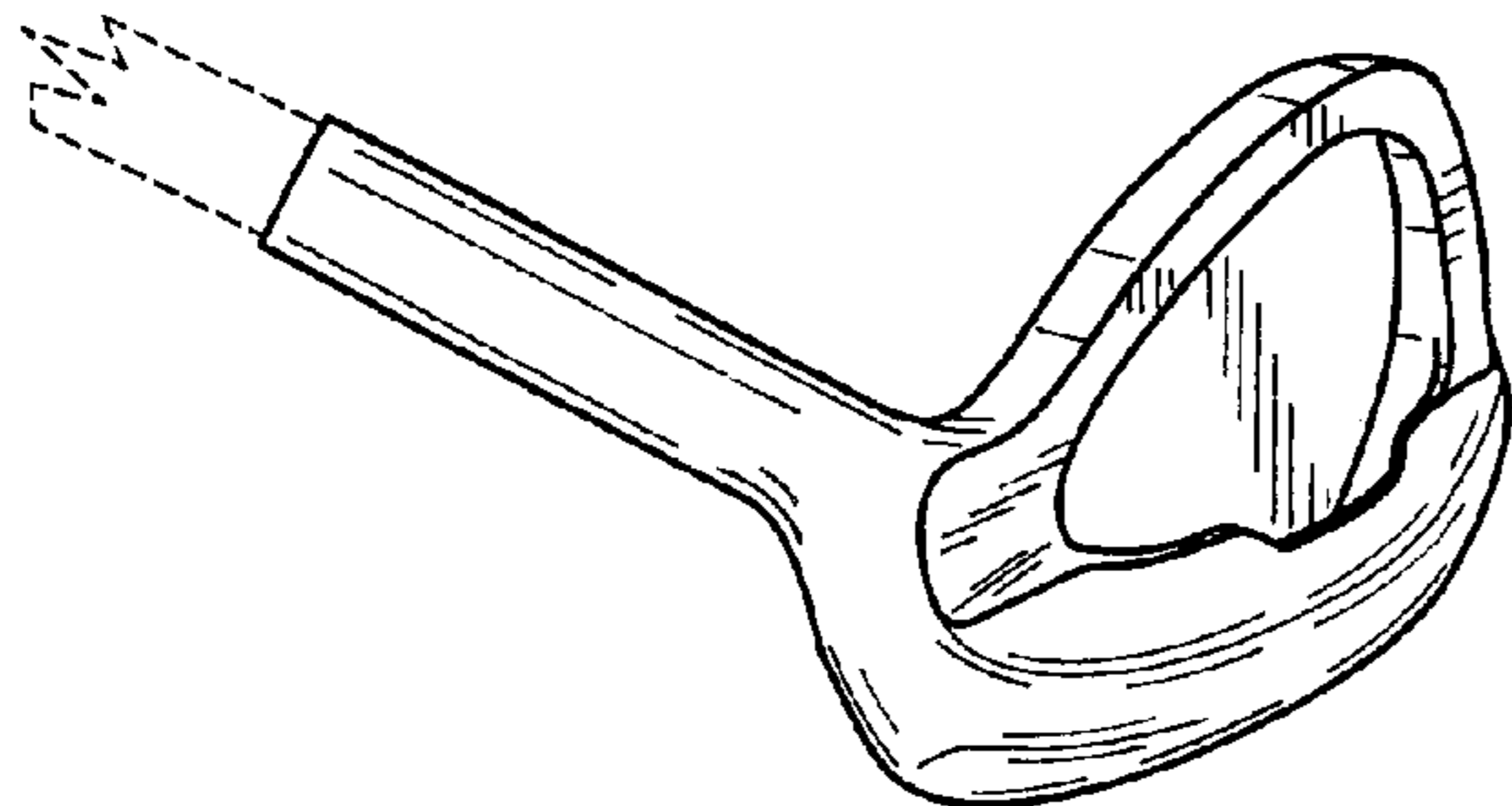

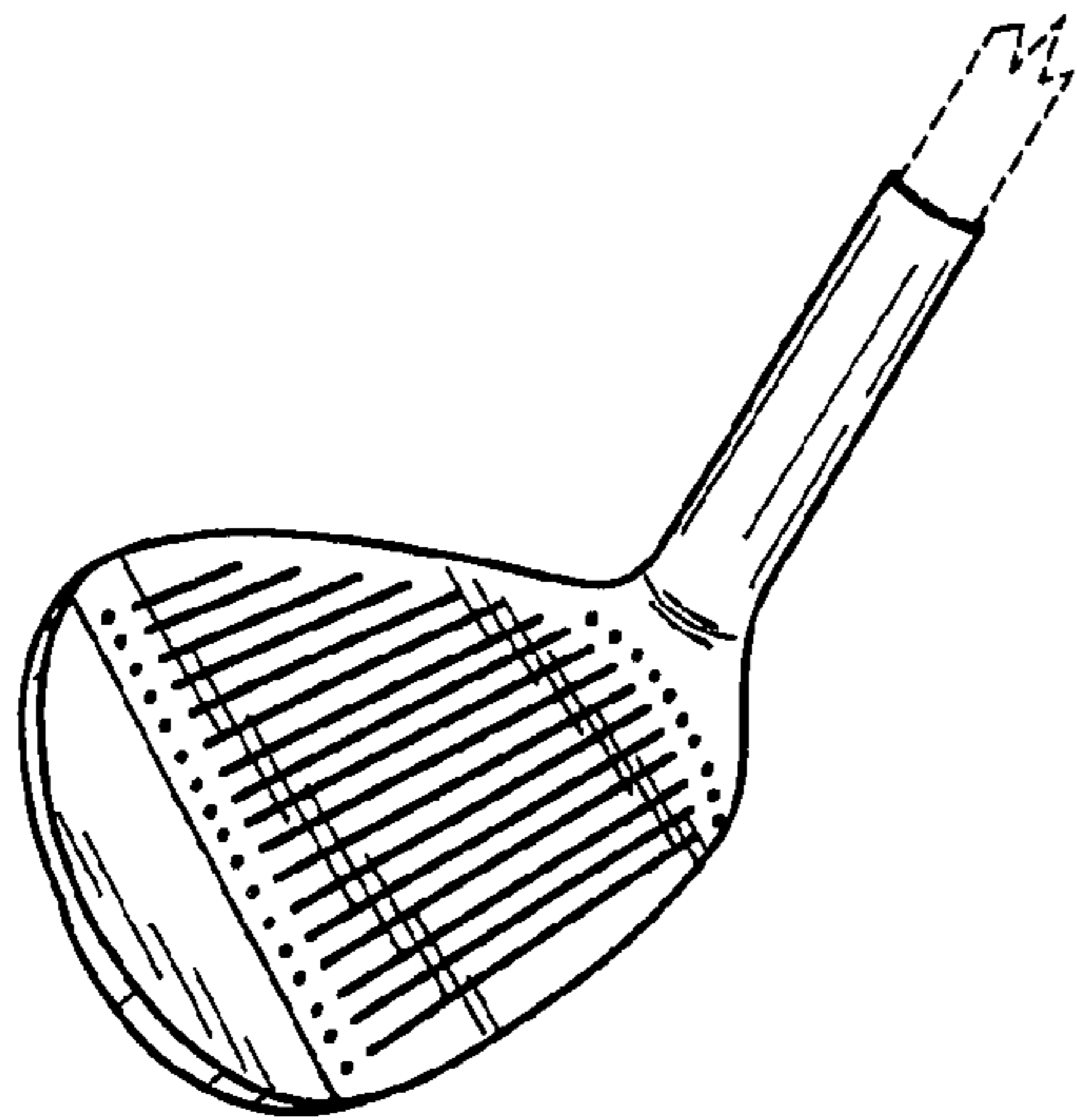

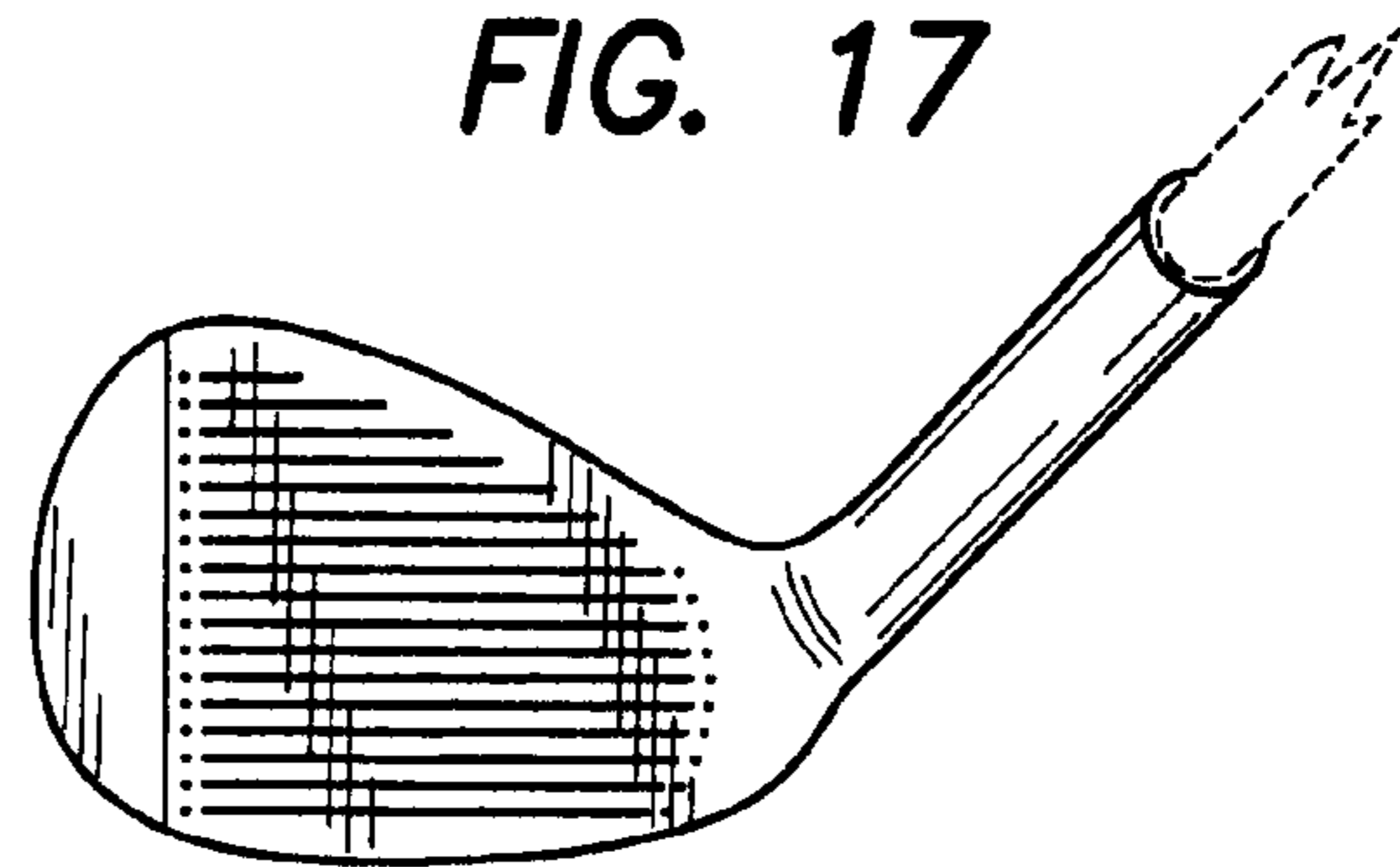

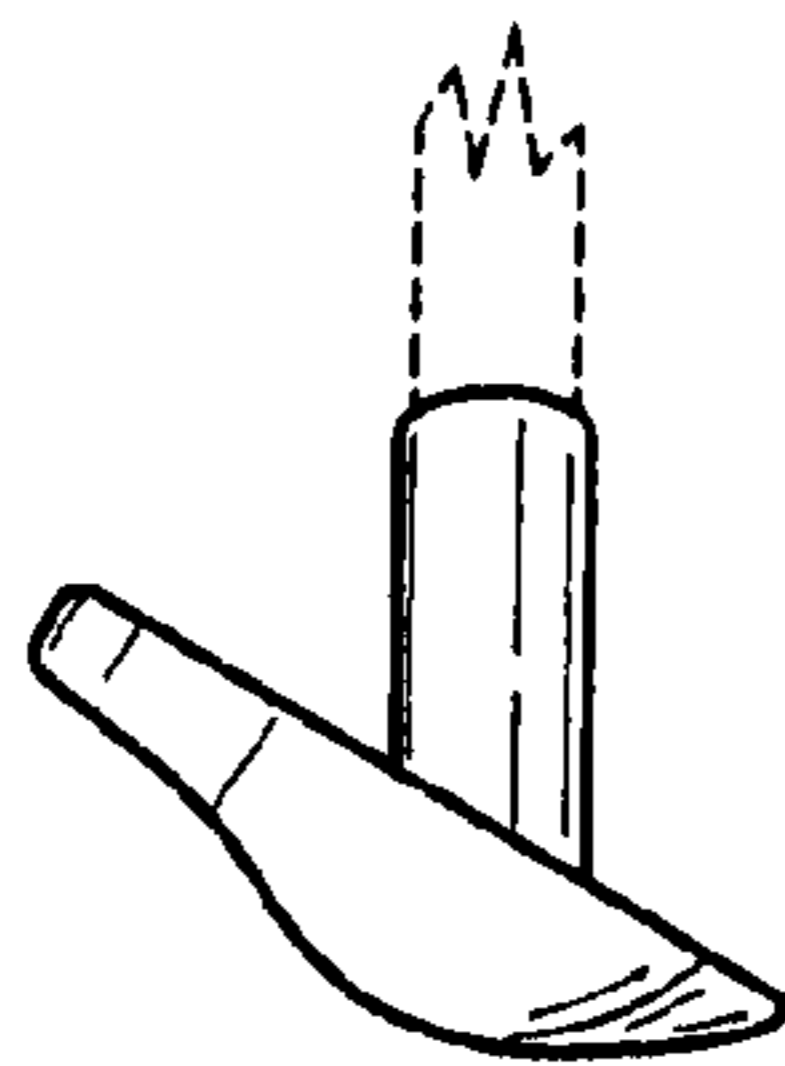

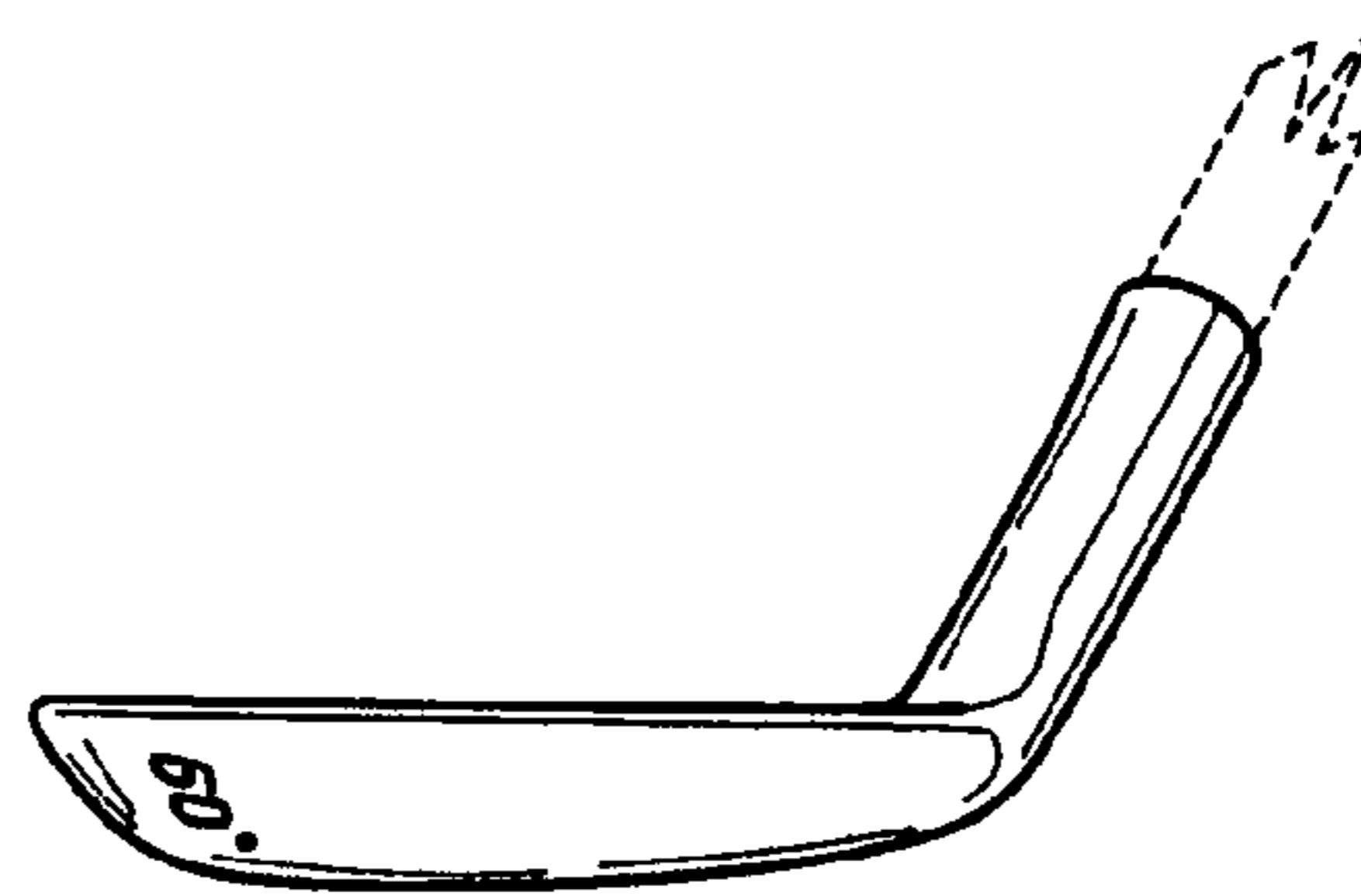

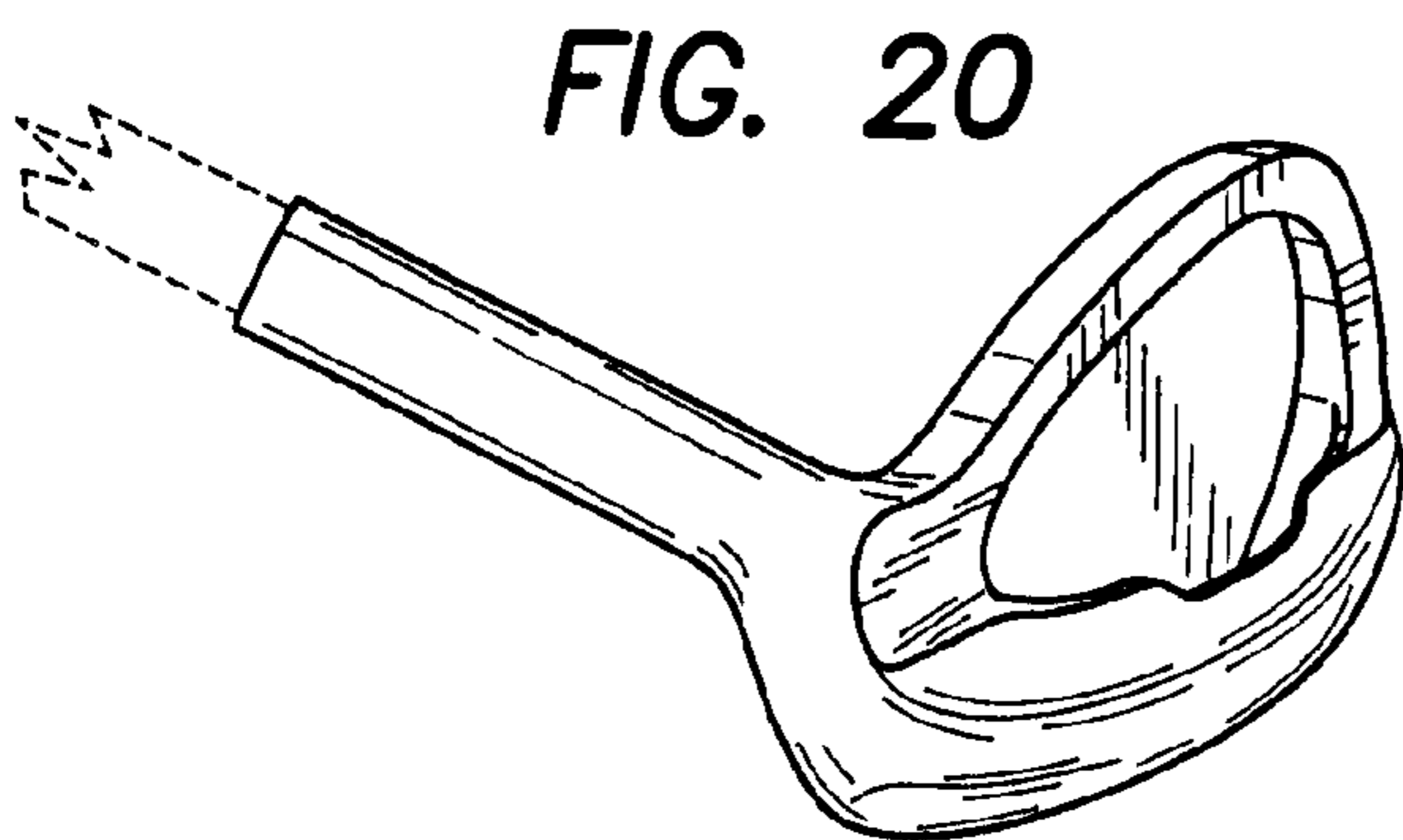
