FIG. 1 is a perspective view of a faucet handle hub showing my new design;

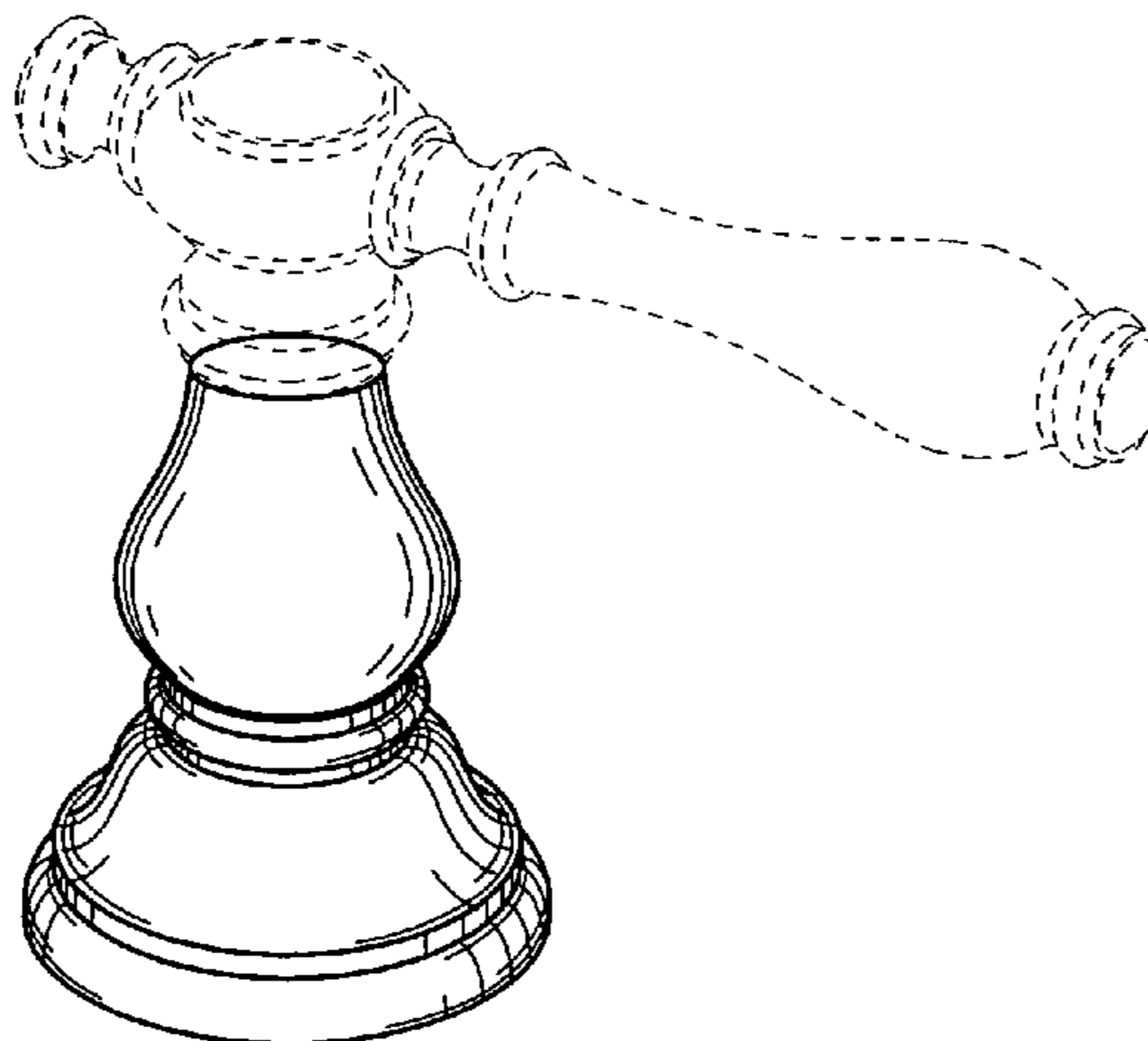
FIG. 2 is a front elevational view thereof;

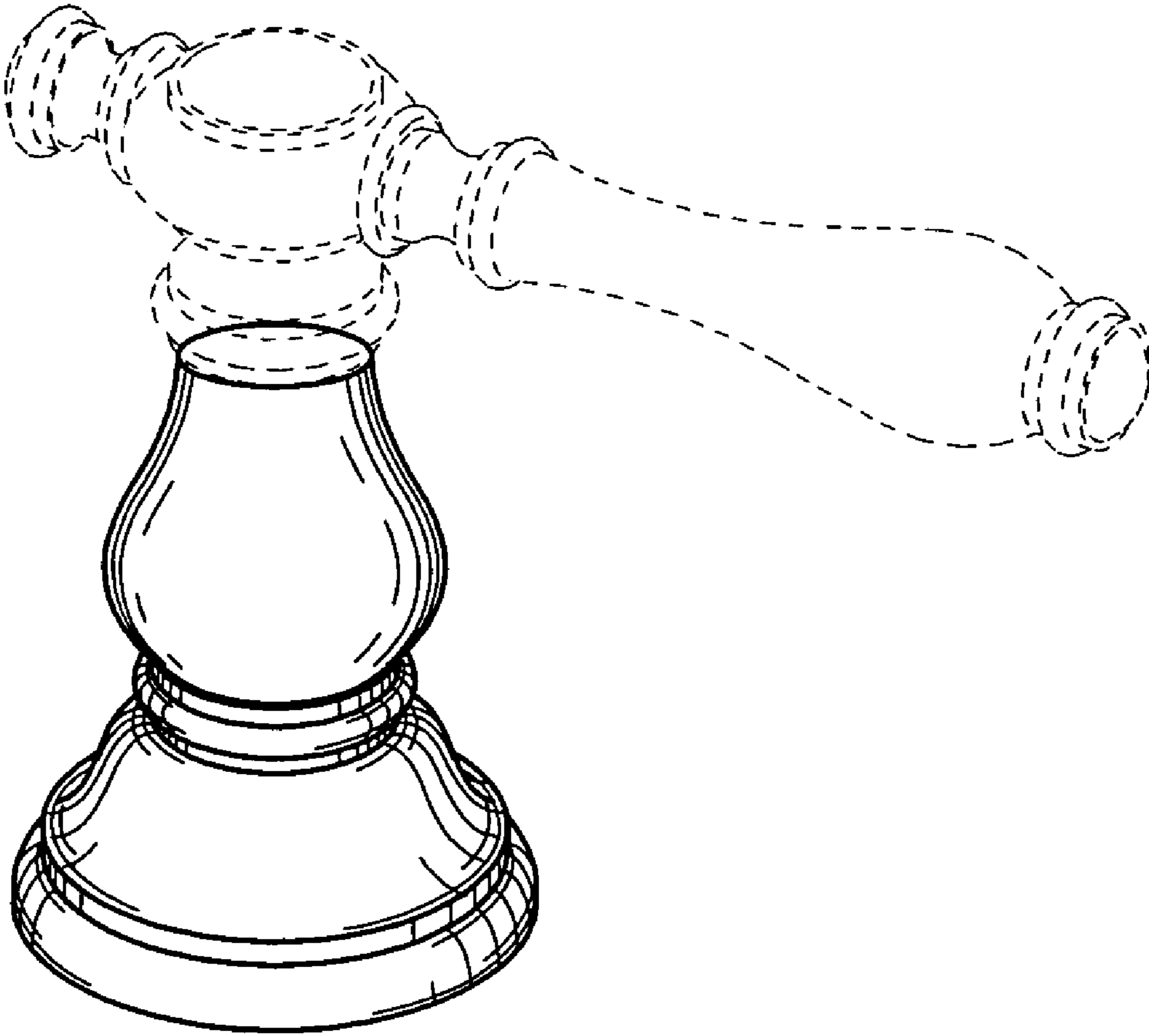
FIG. 3 is a right side view, the left side view being a mirror image thereof; and,

FIG. 4 is a top plan view thereof.

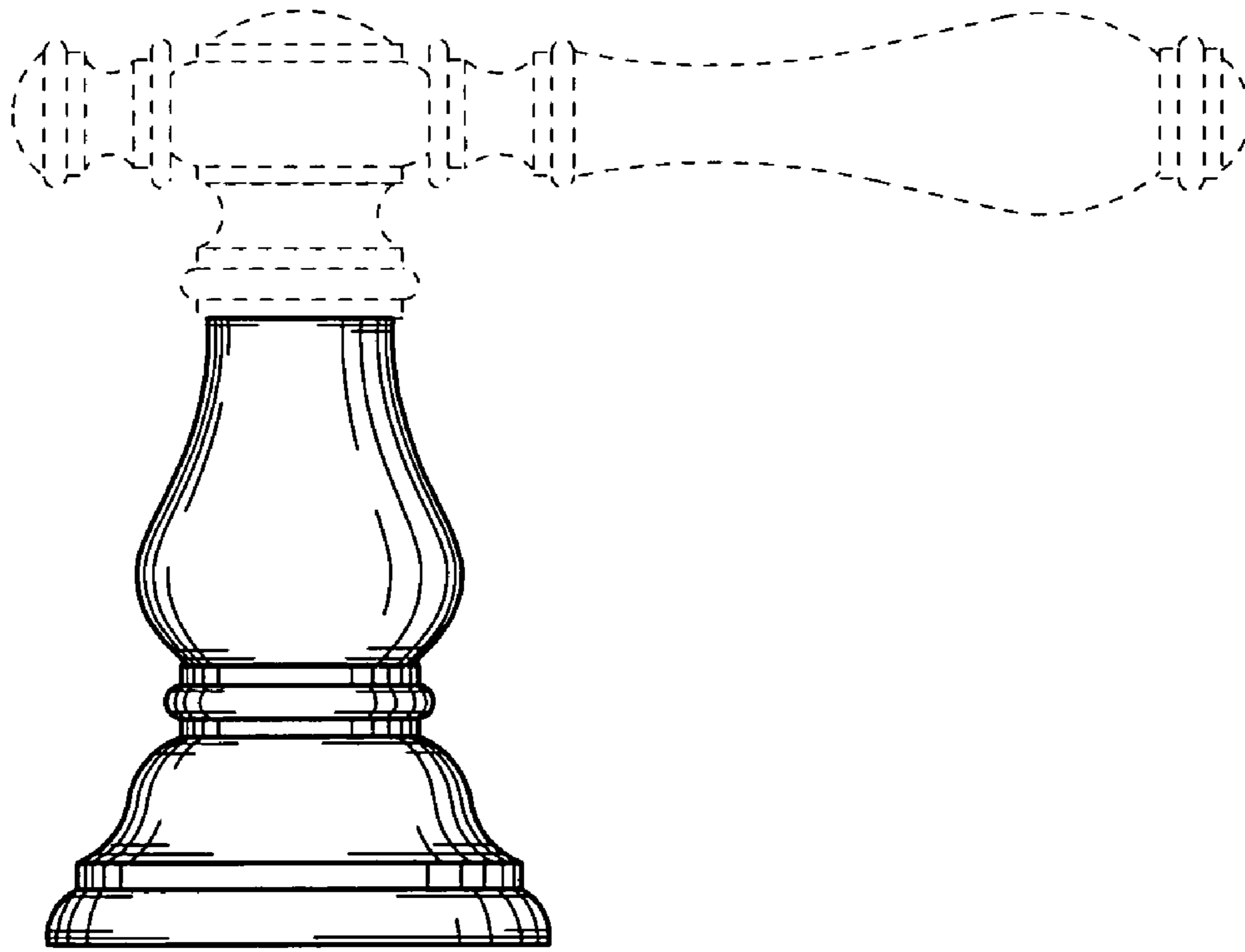
The broken line showing of environmental structure is for illustrative purposes only and forms no part of the claimed design.

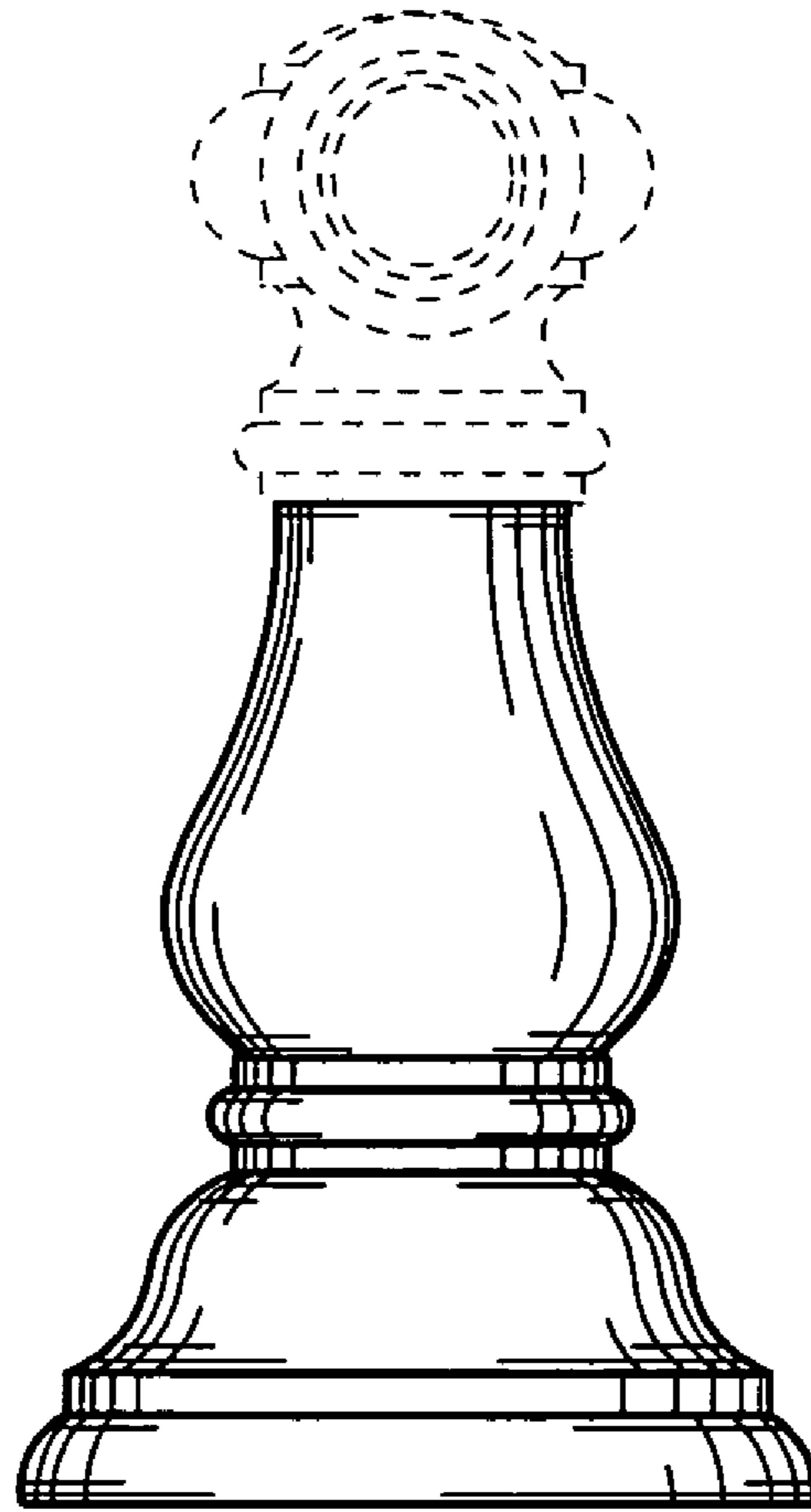




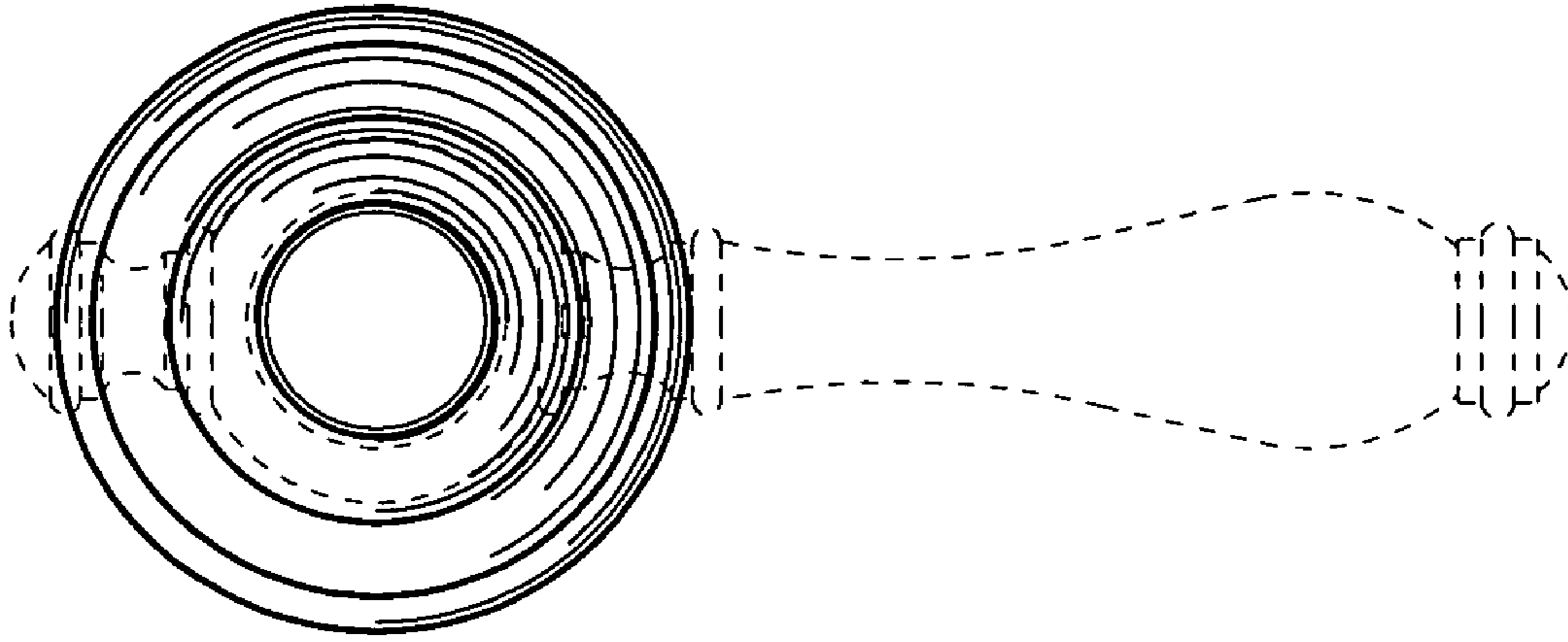
