(57) **CLAIM**

The ornamental design for a joint pad with stitching pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a joint pad with stitching pattern of our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side view elevational thereof;

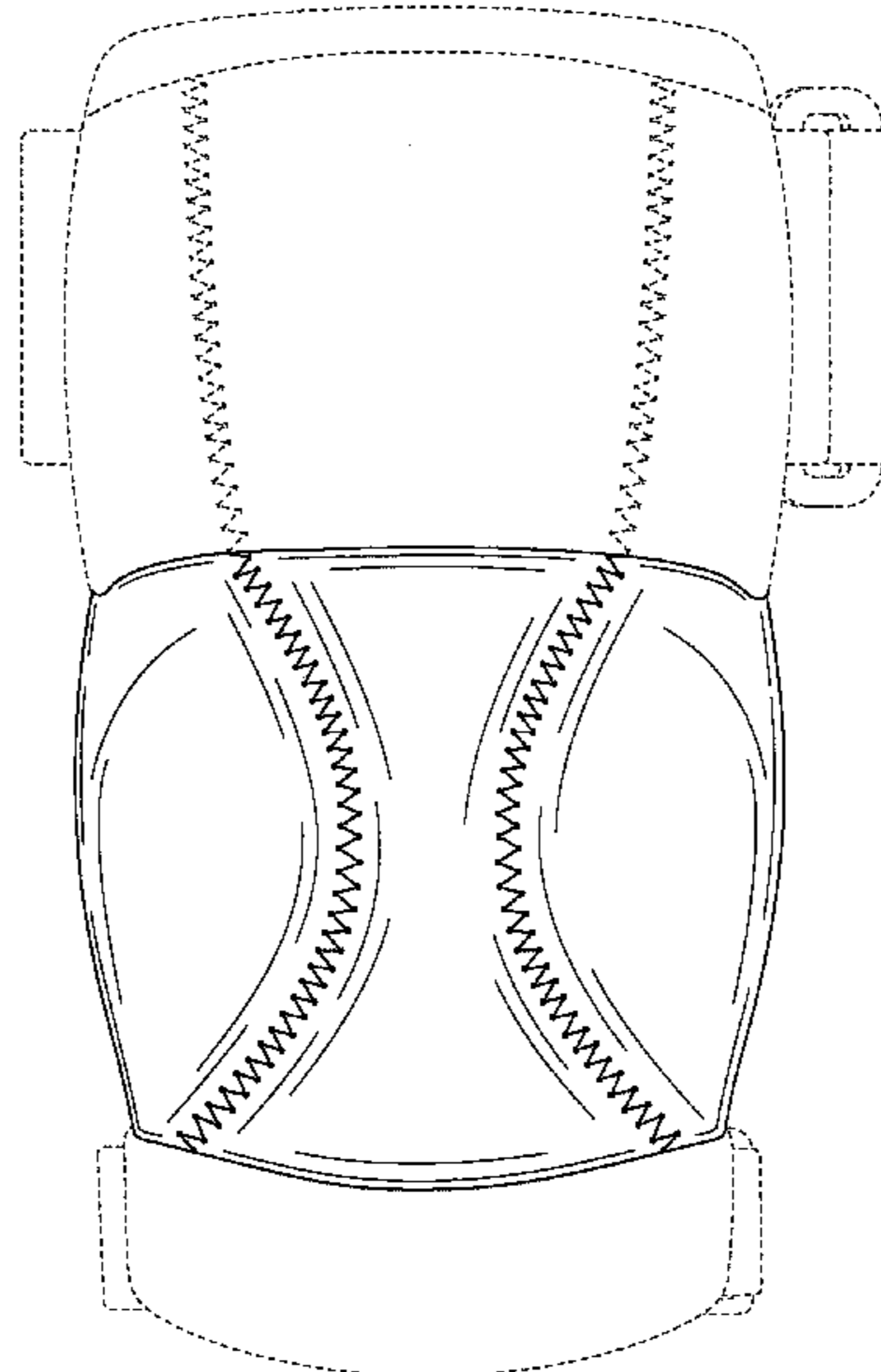
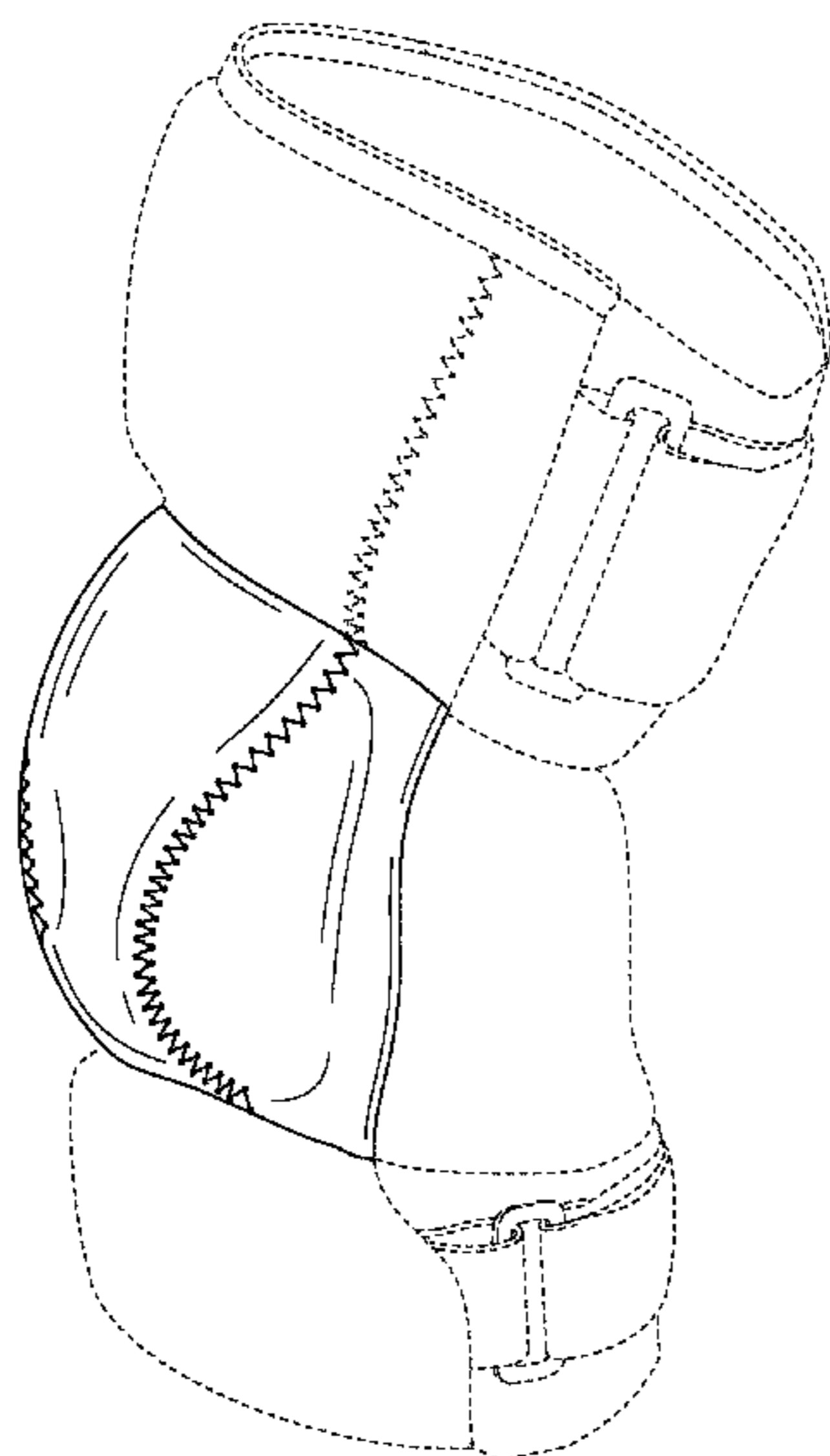
FIG. 4 is a right side elevational view thereof;

FIG. 6 is a bottom plan view thereof.

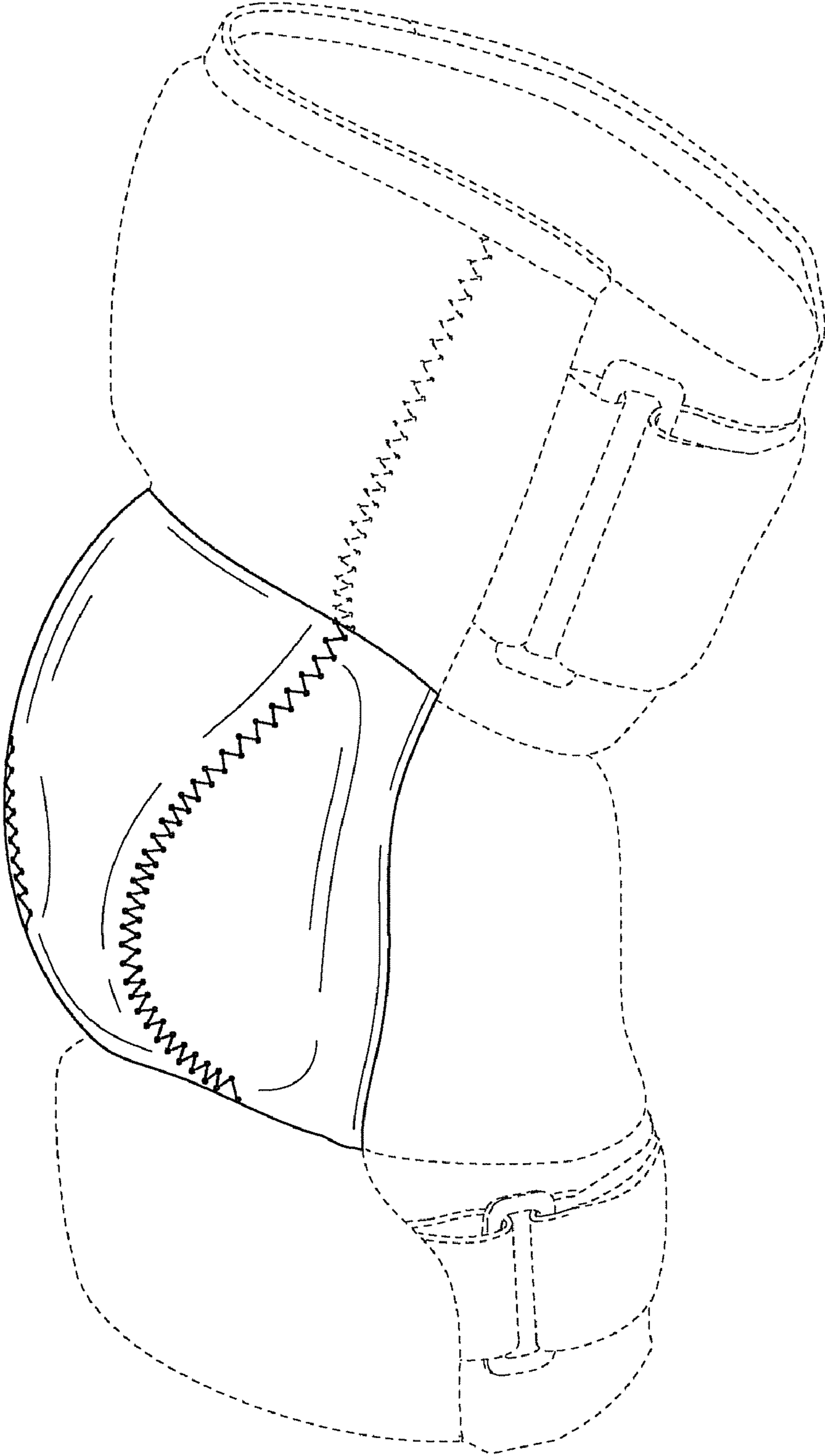

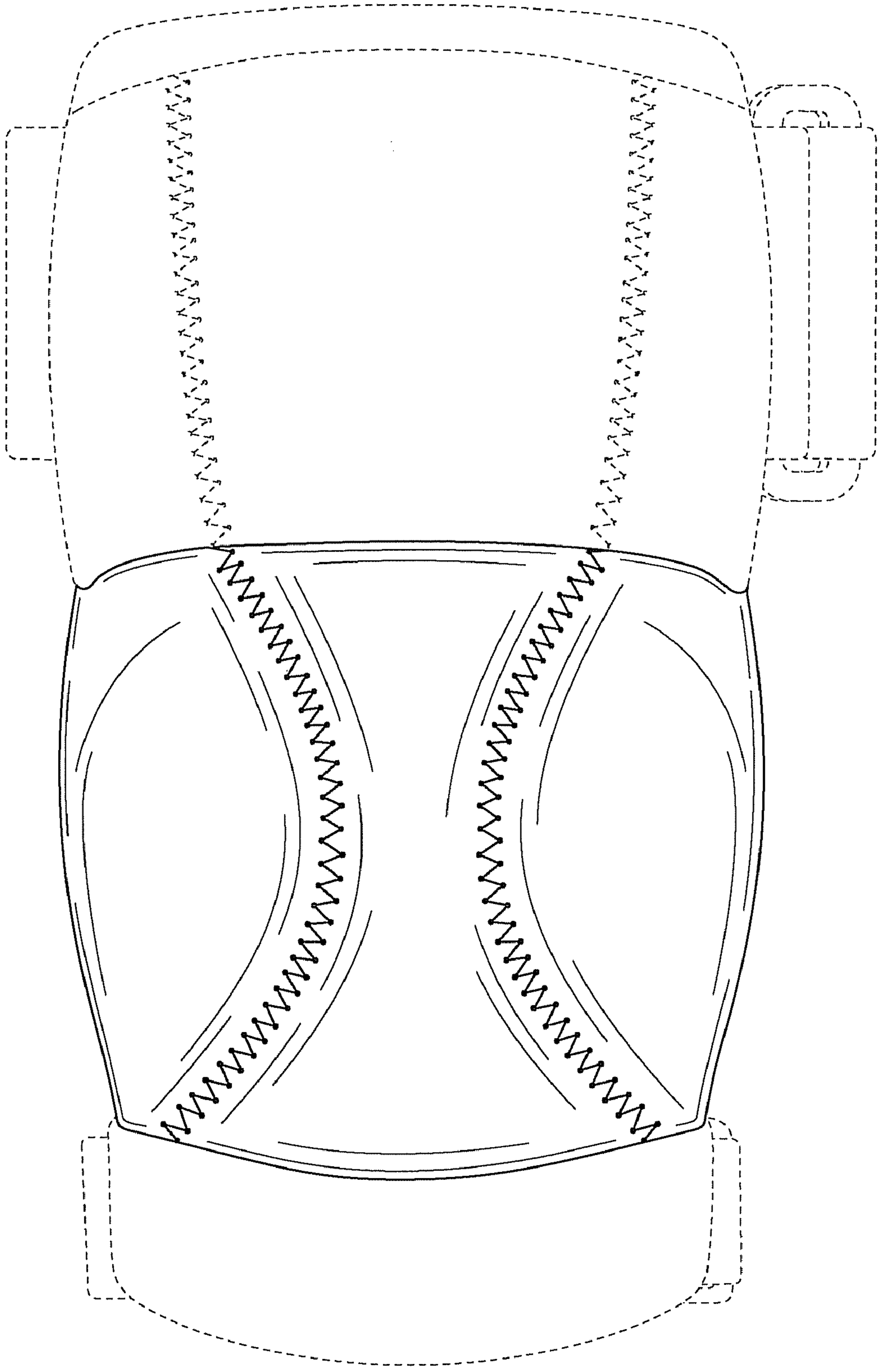

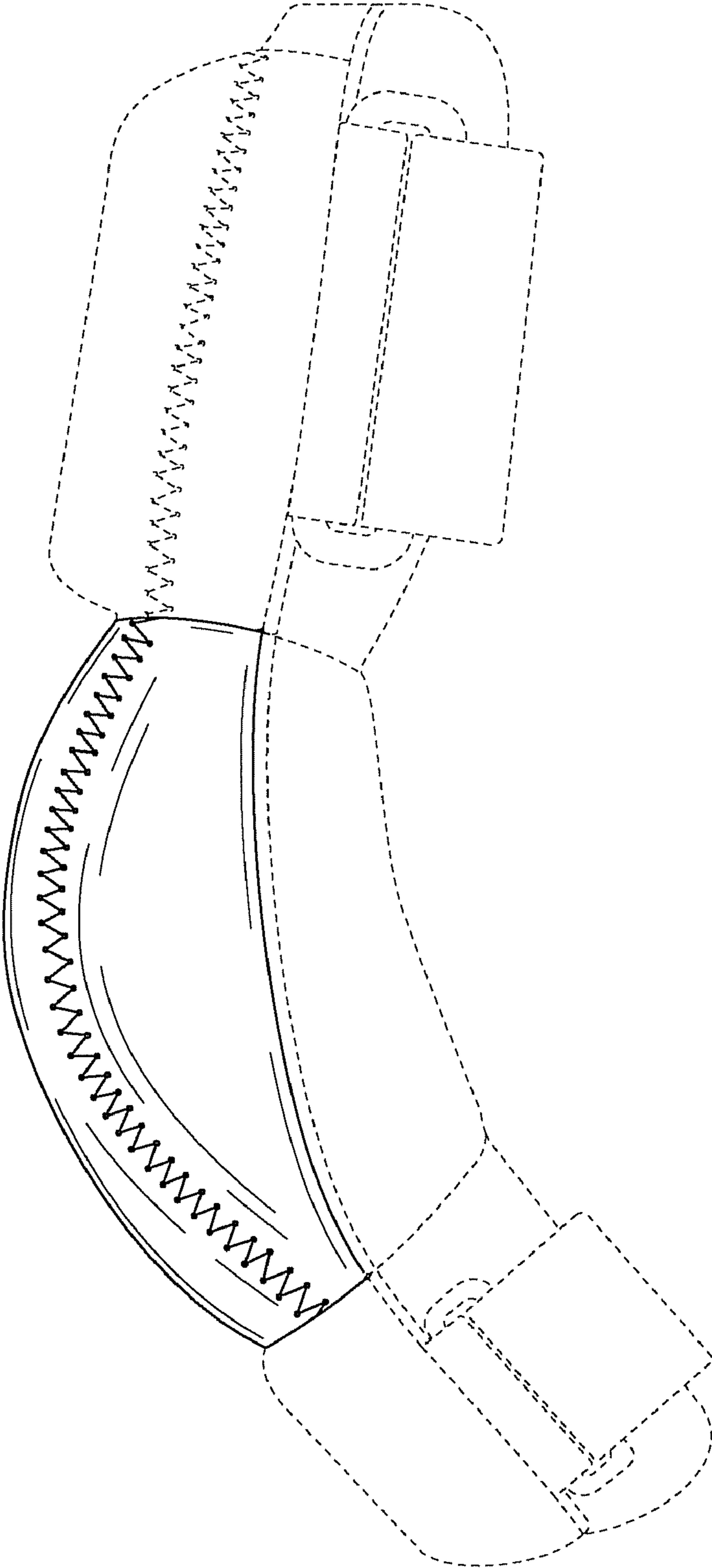

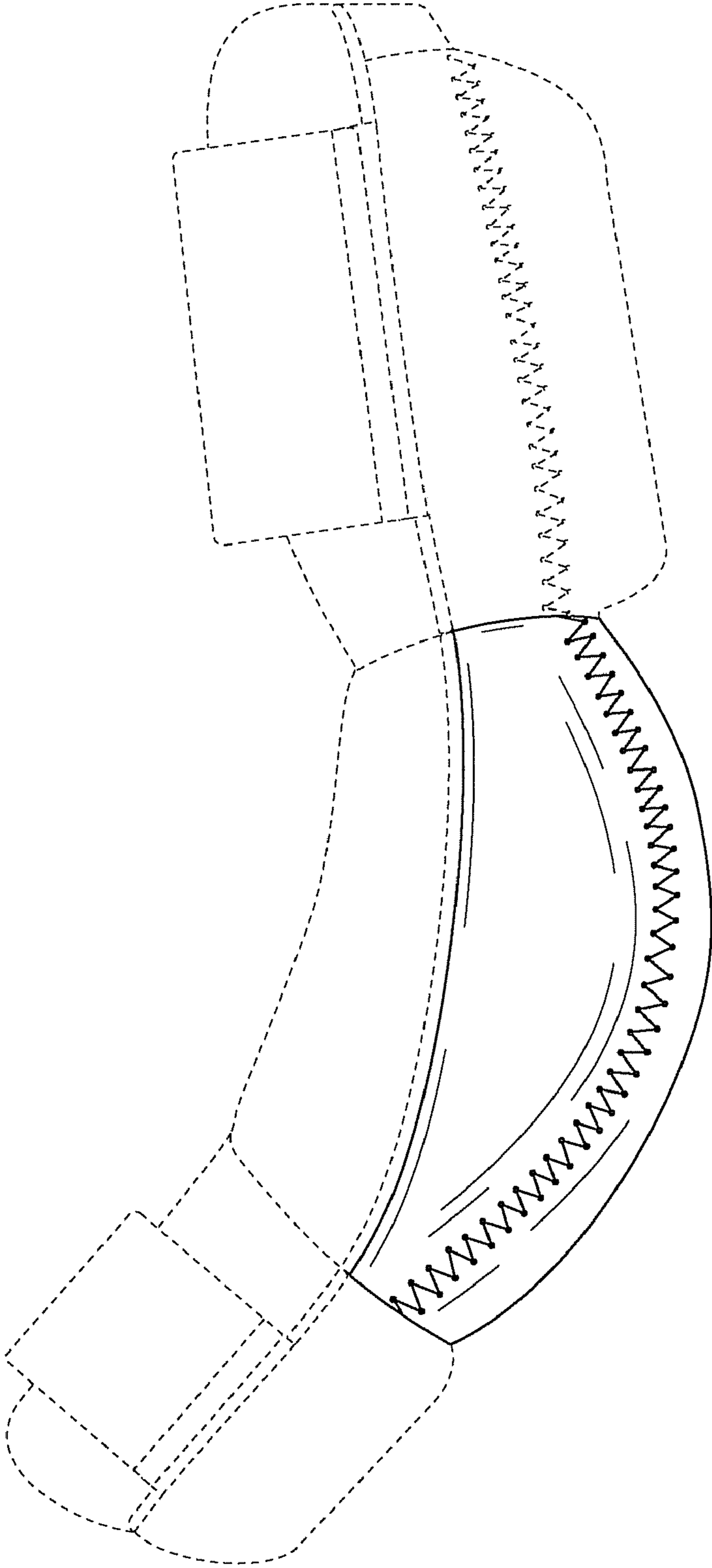

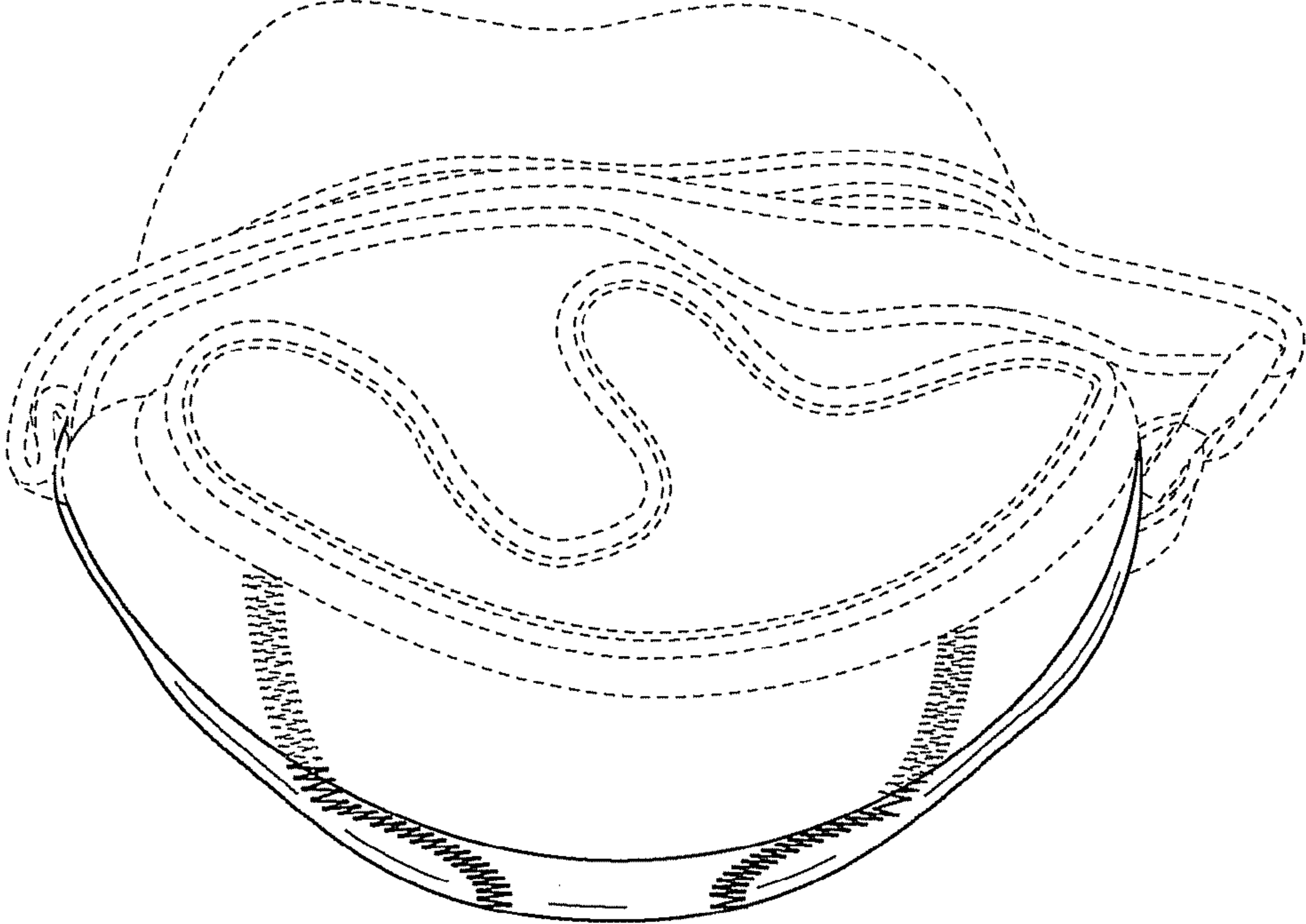

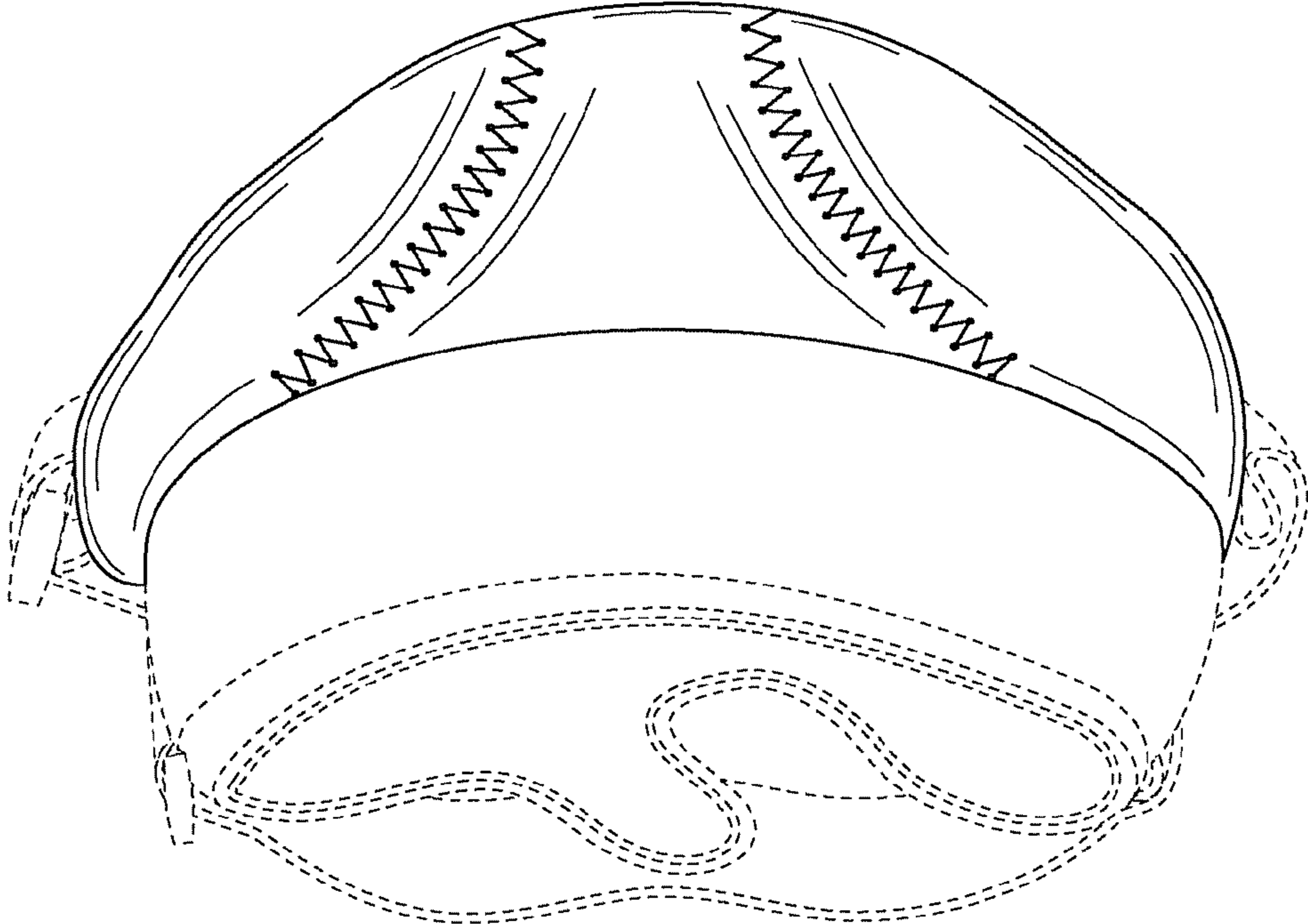
